DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the stand for pen or pens of the present invention;

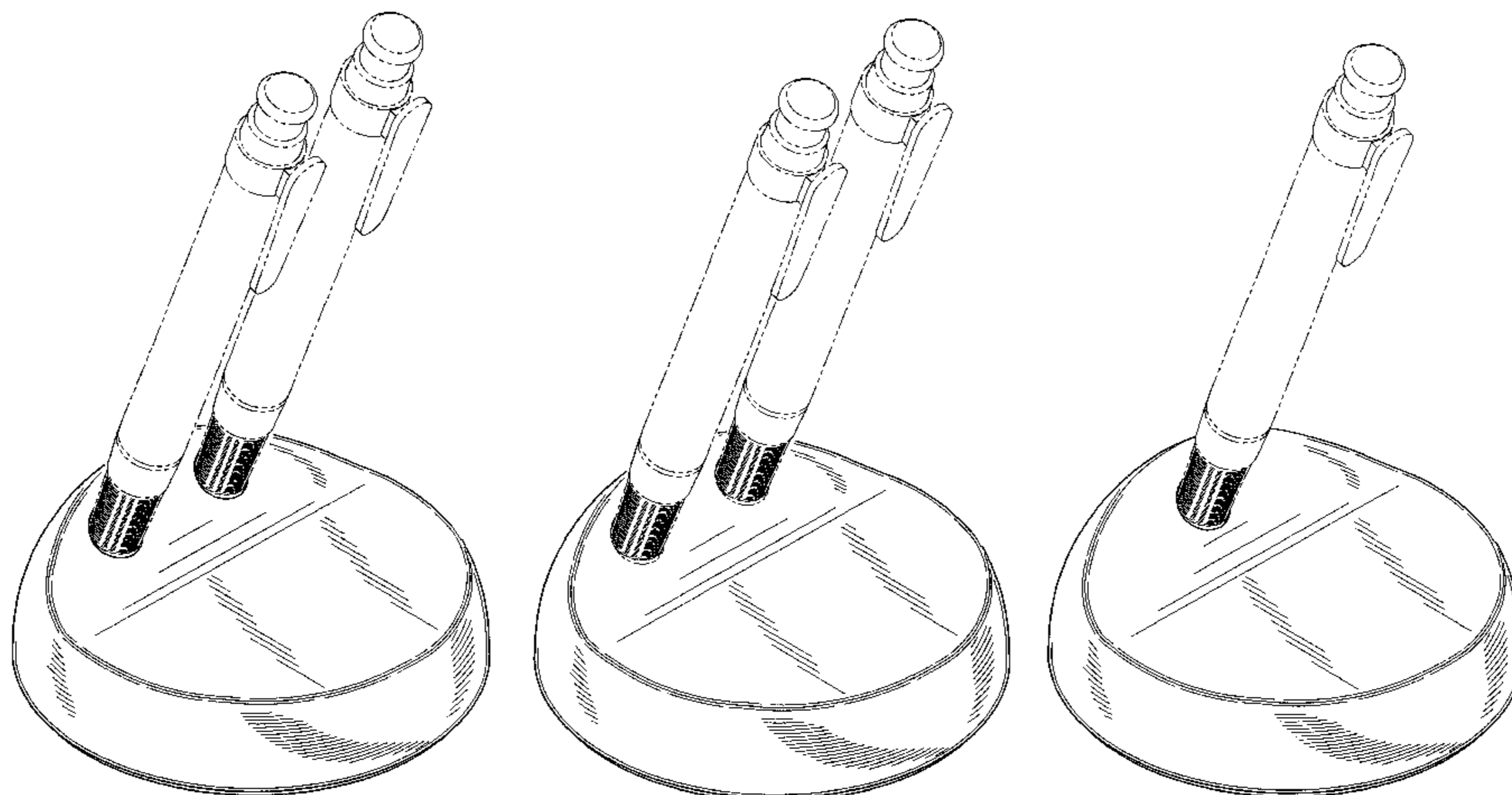

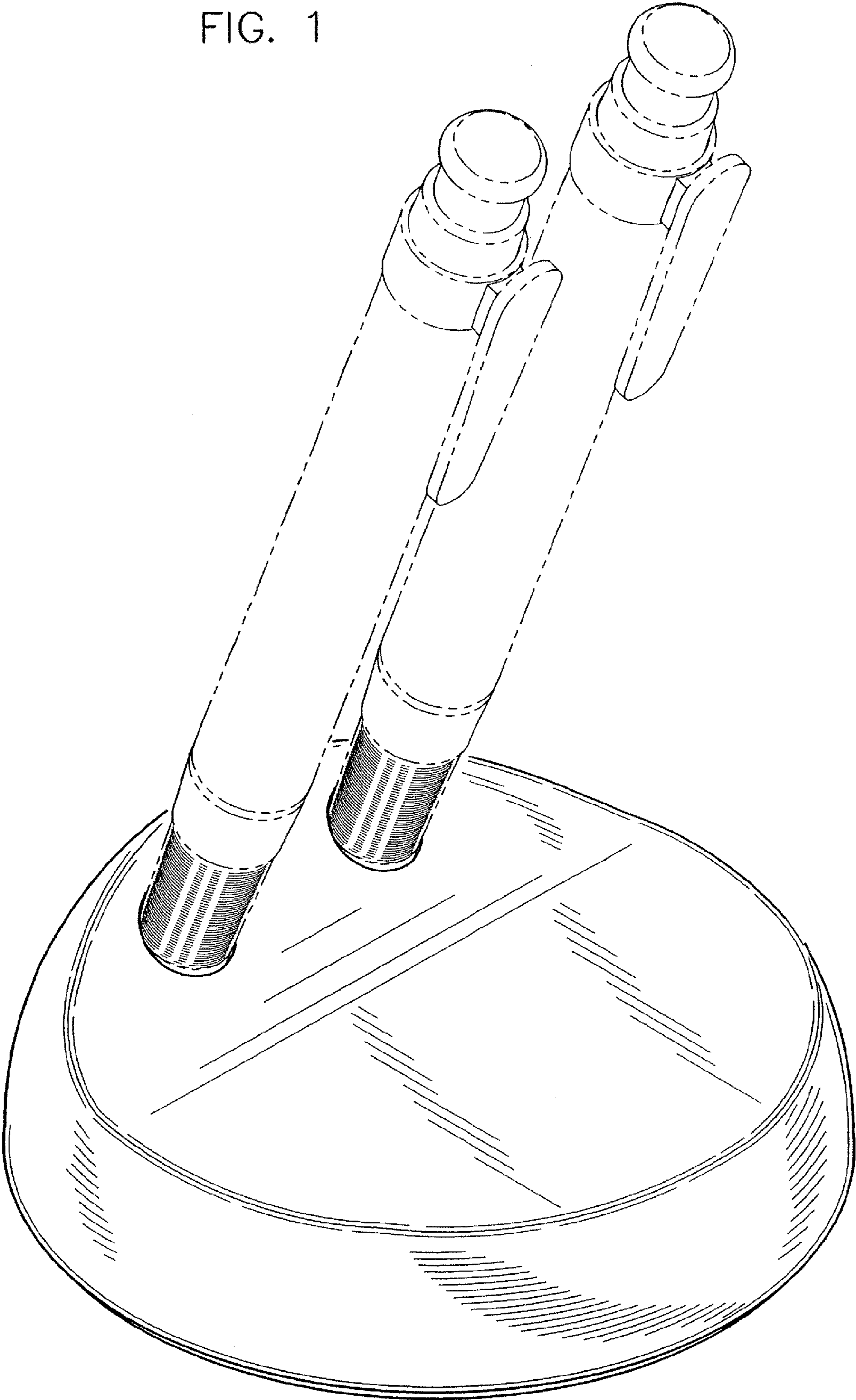

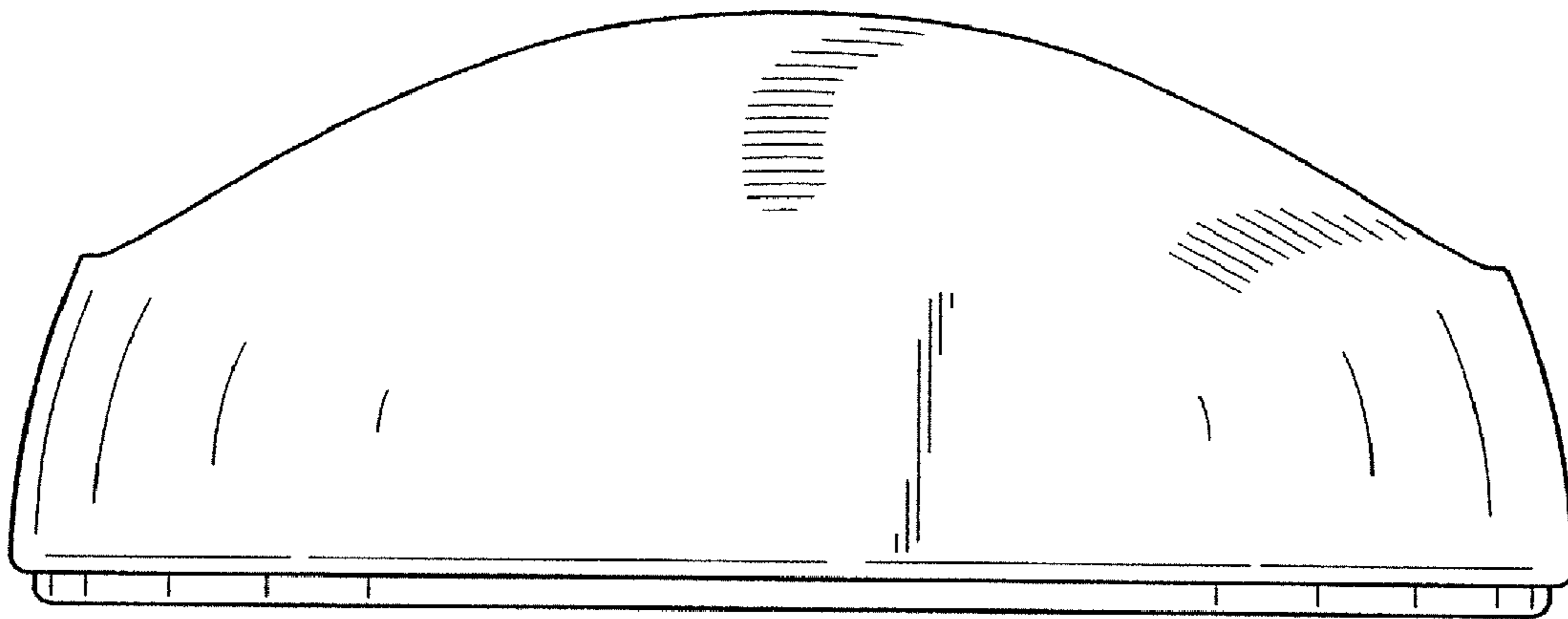

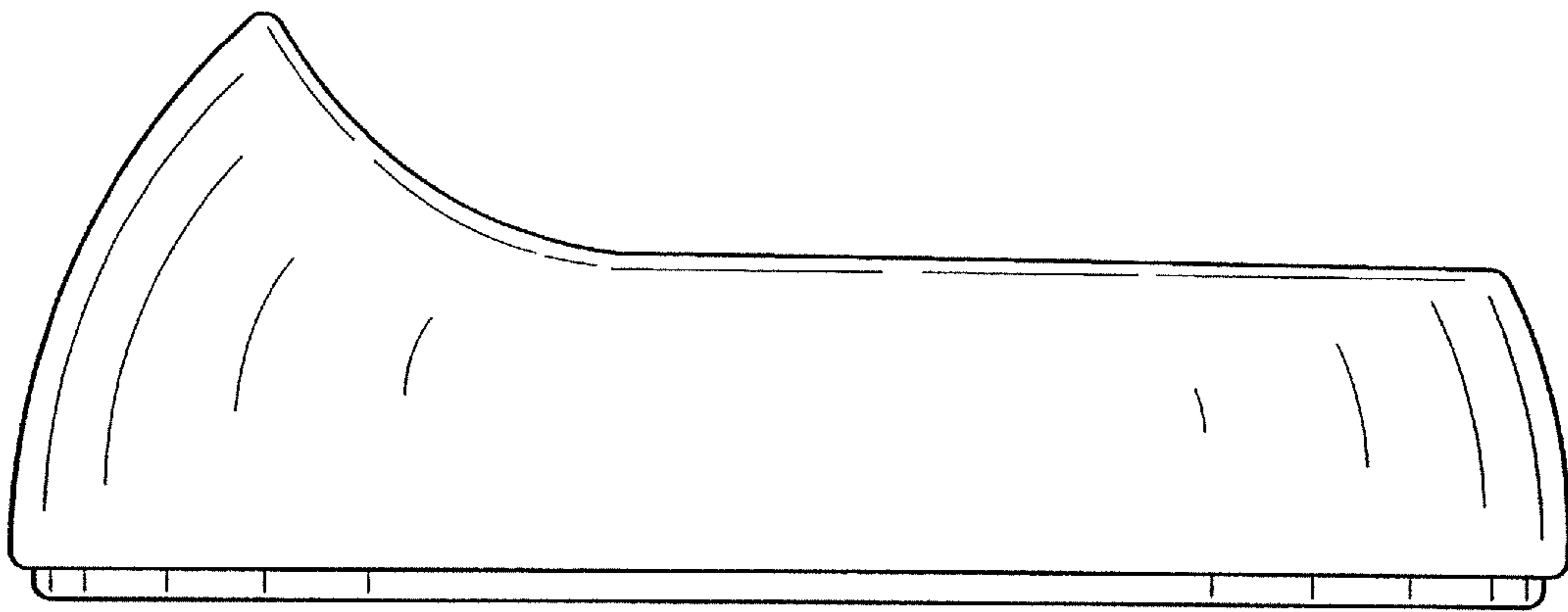

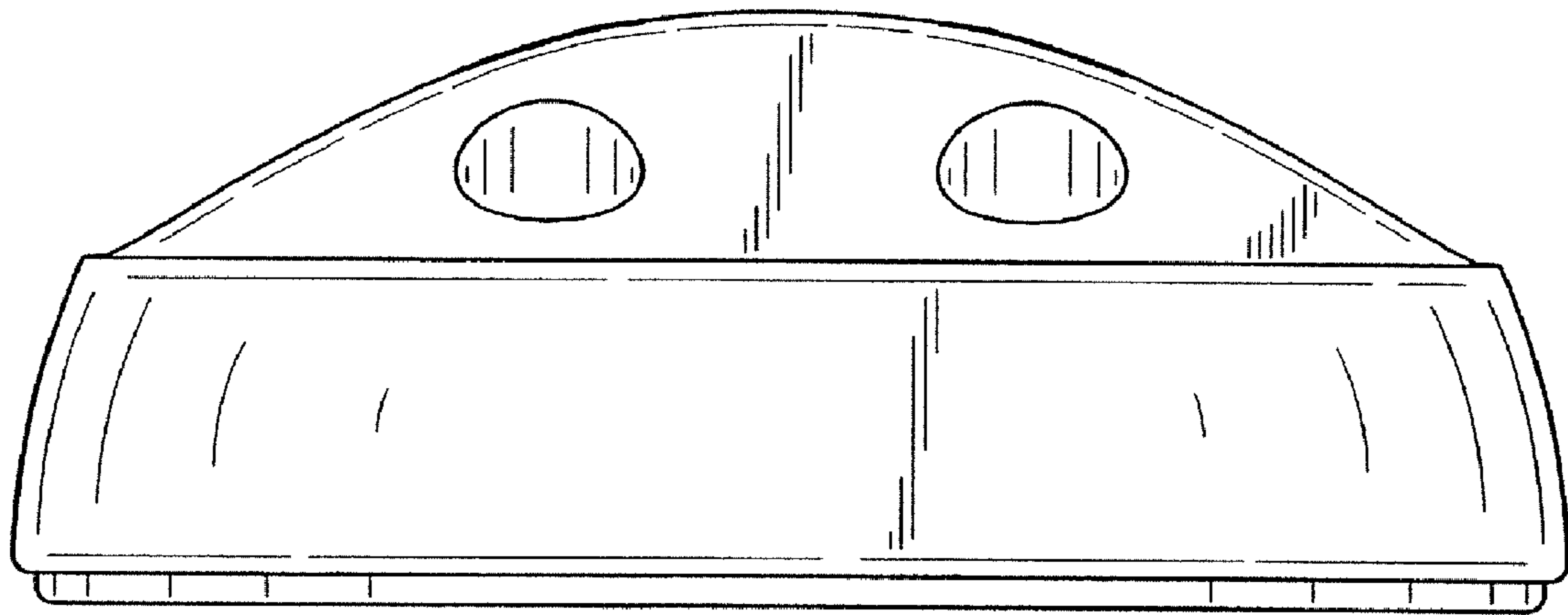

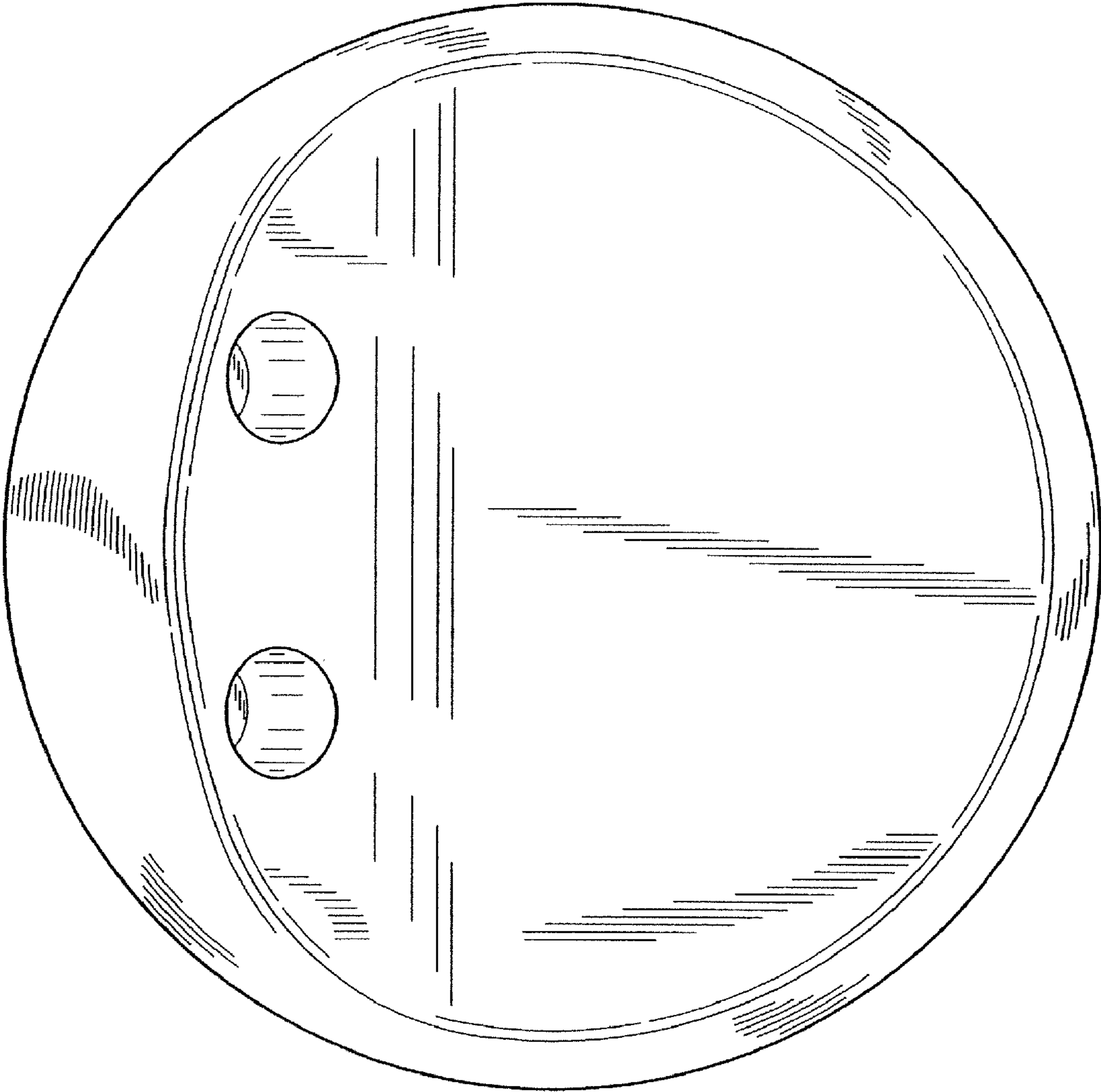

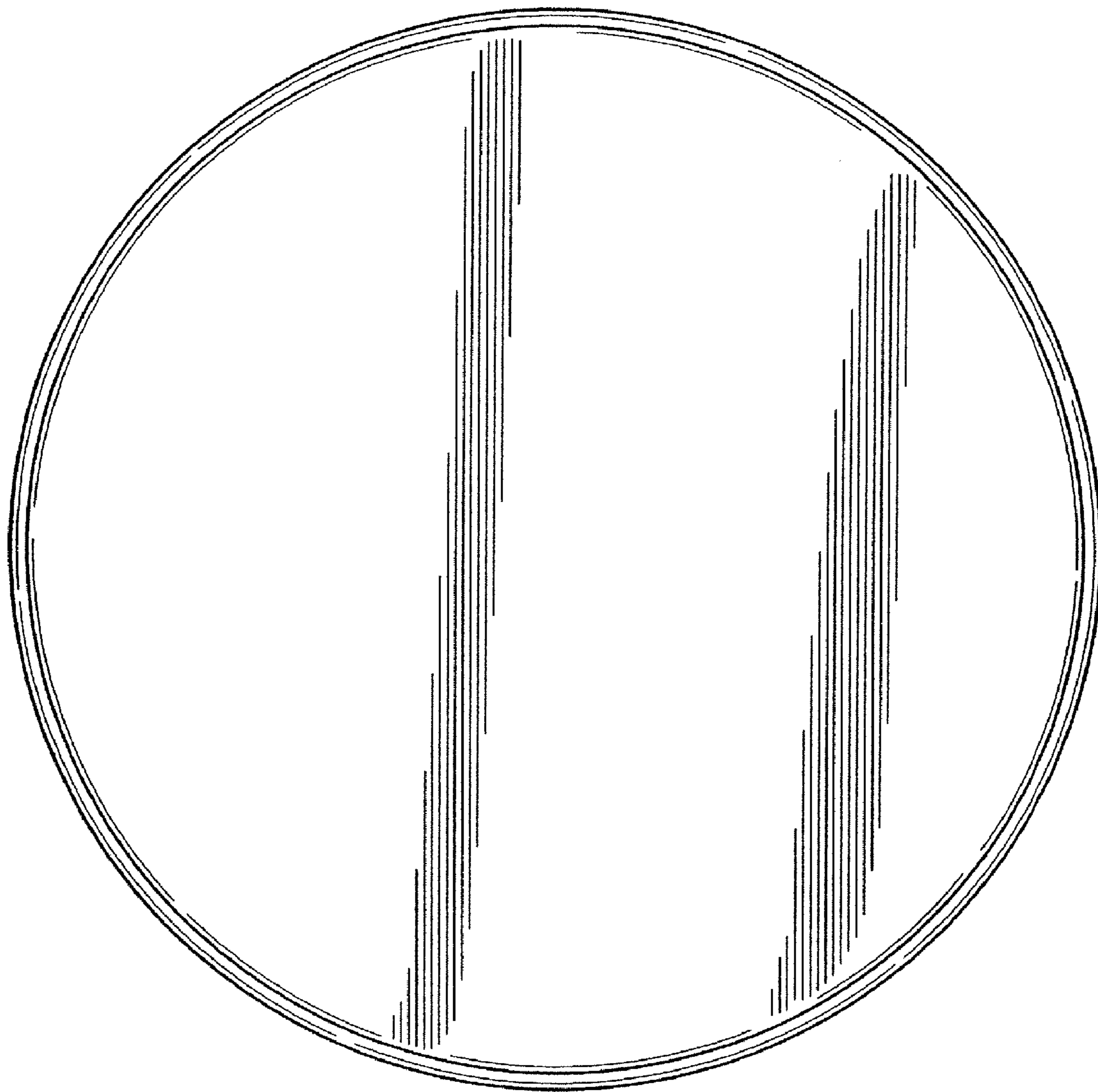

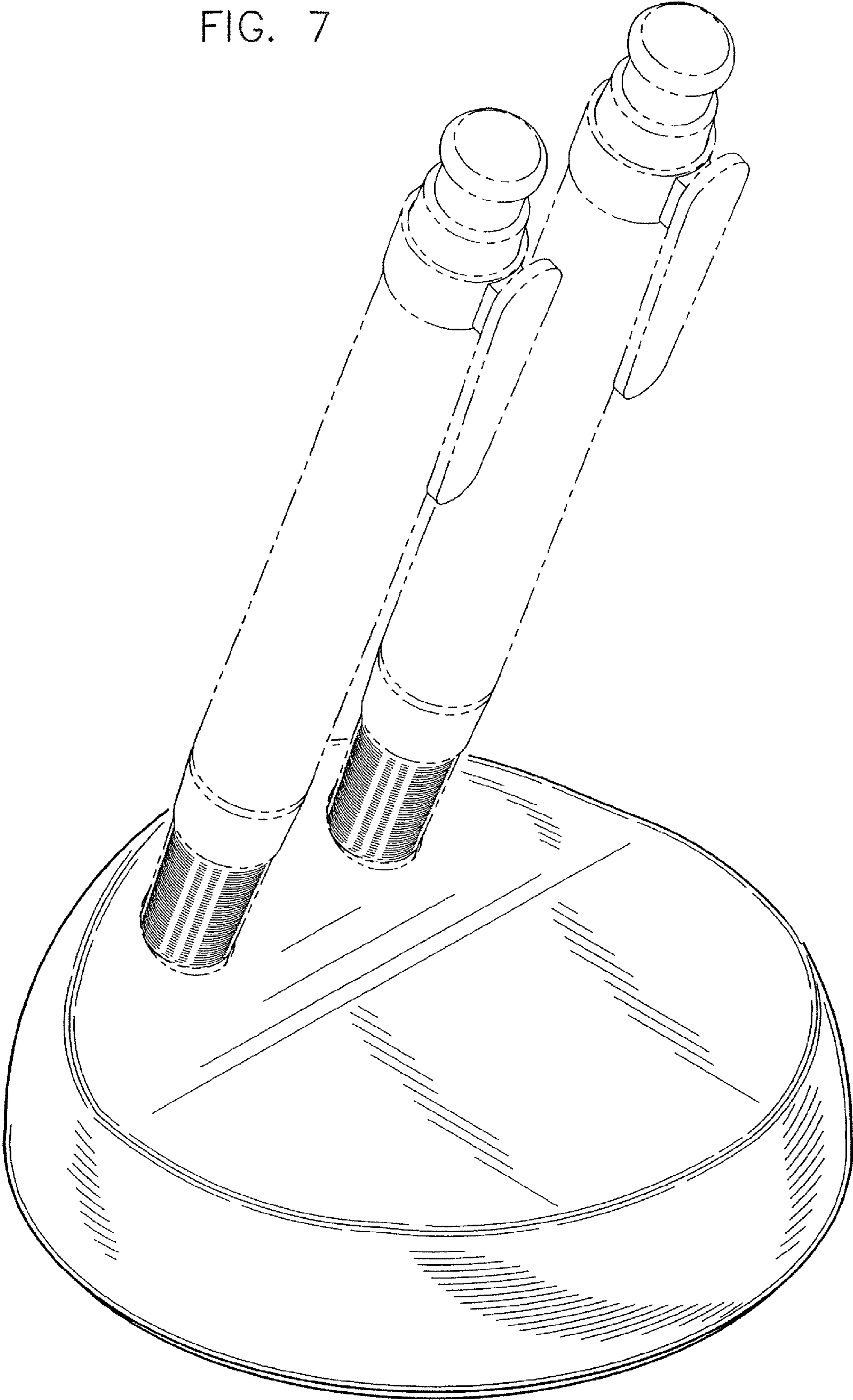

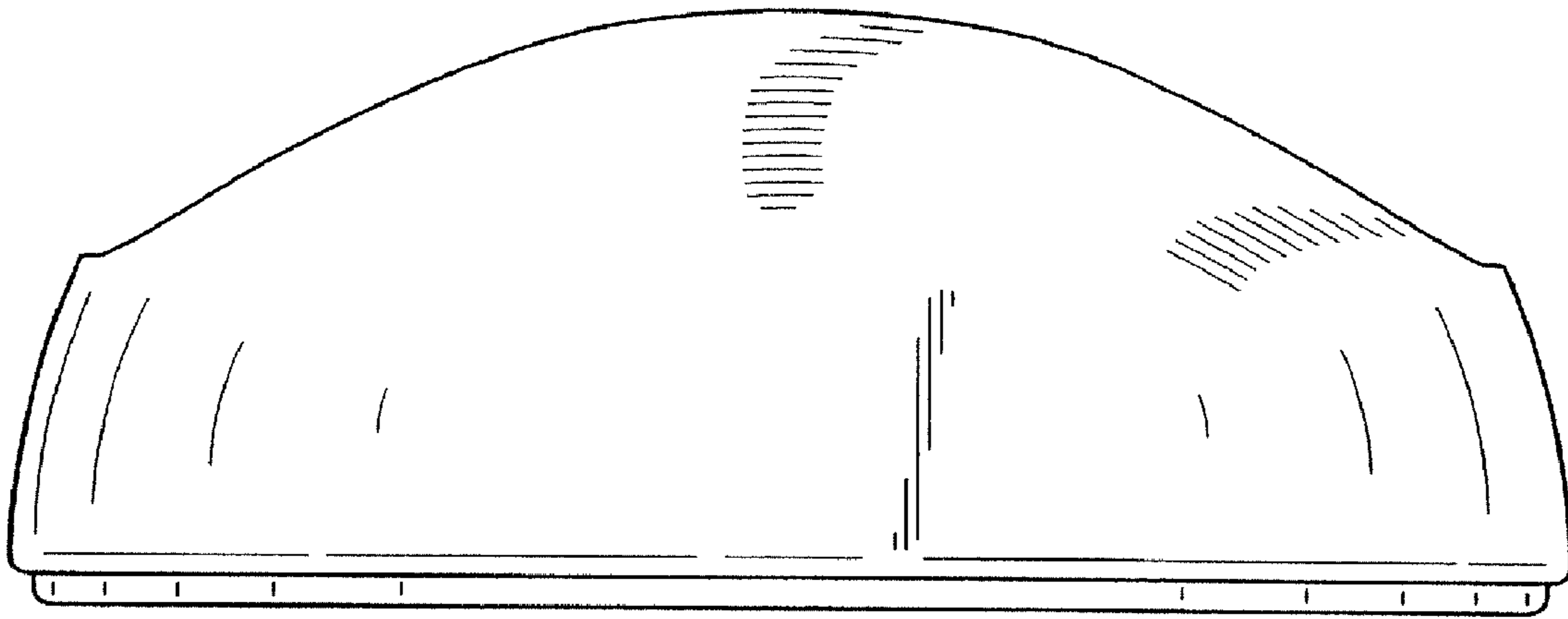

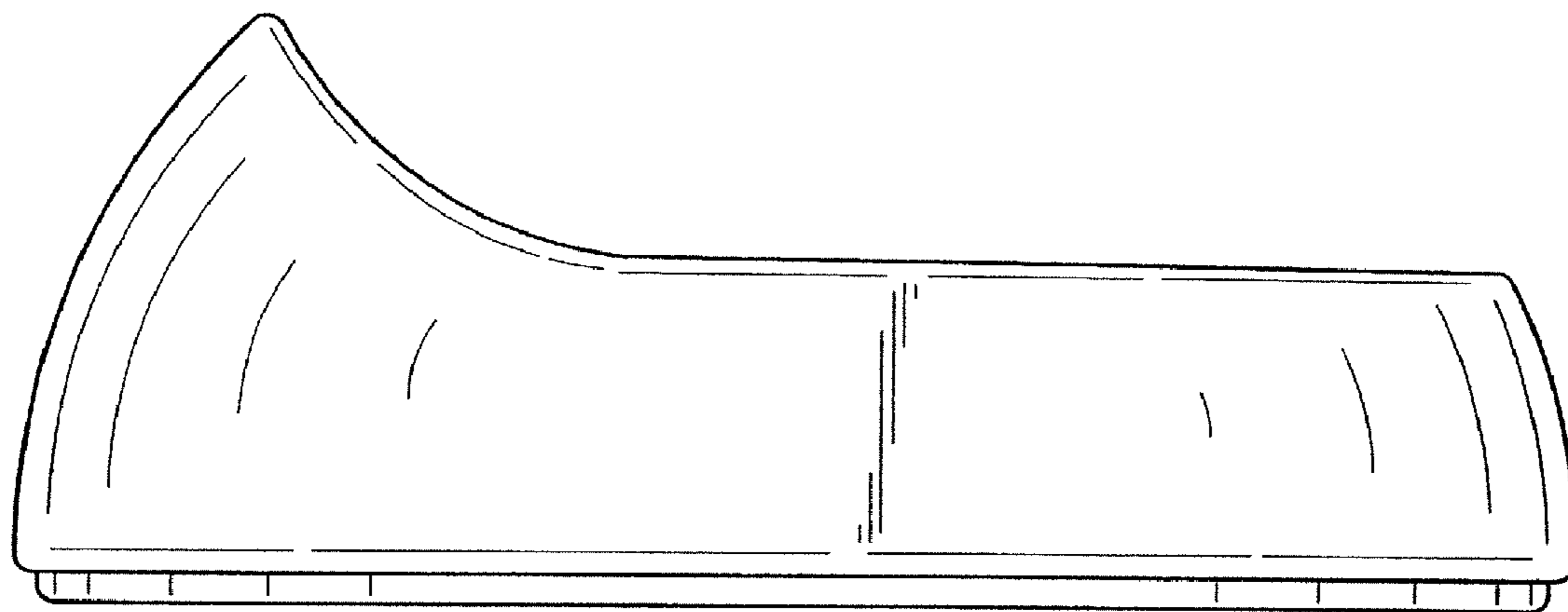

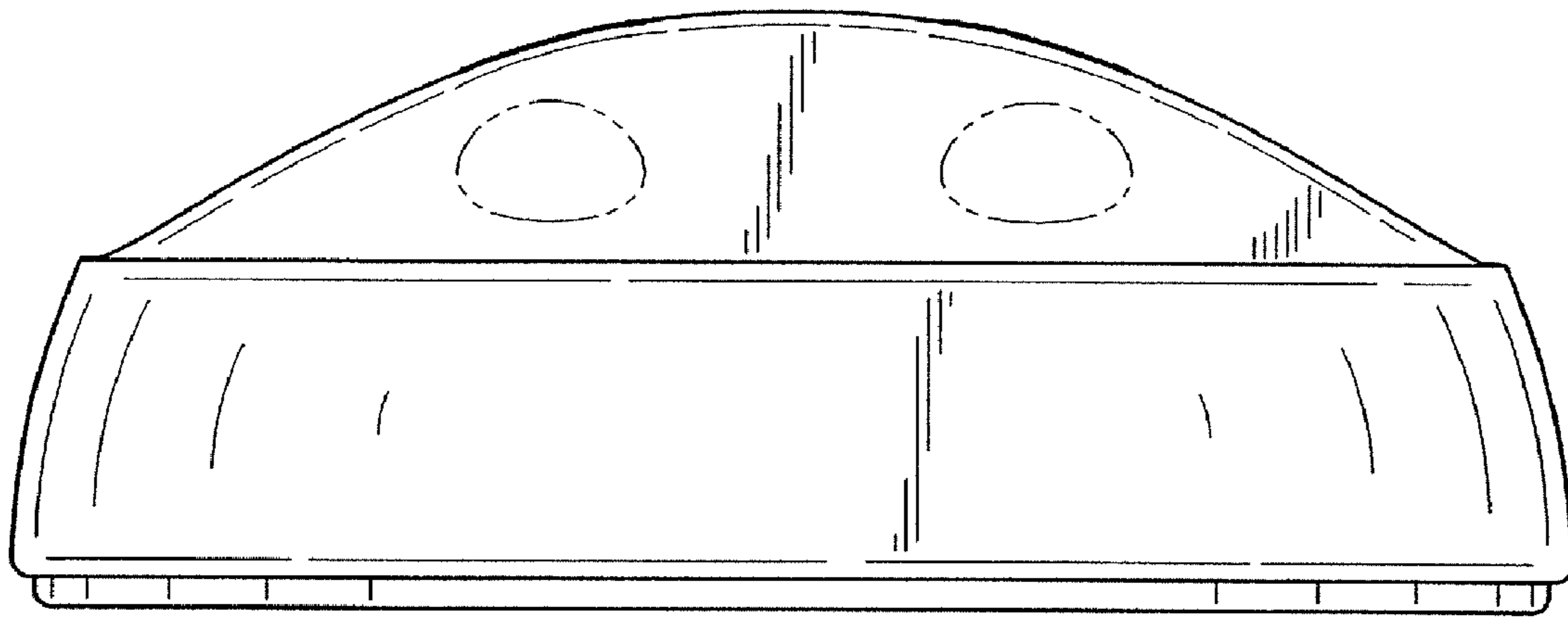

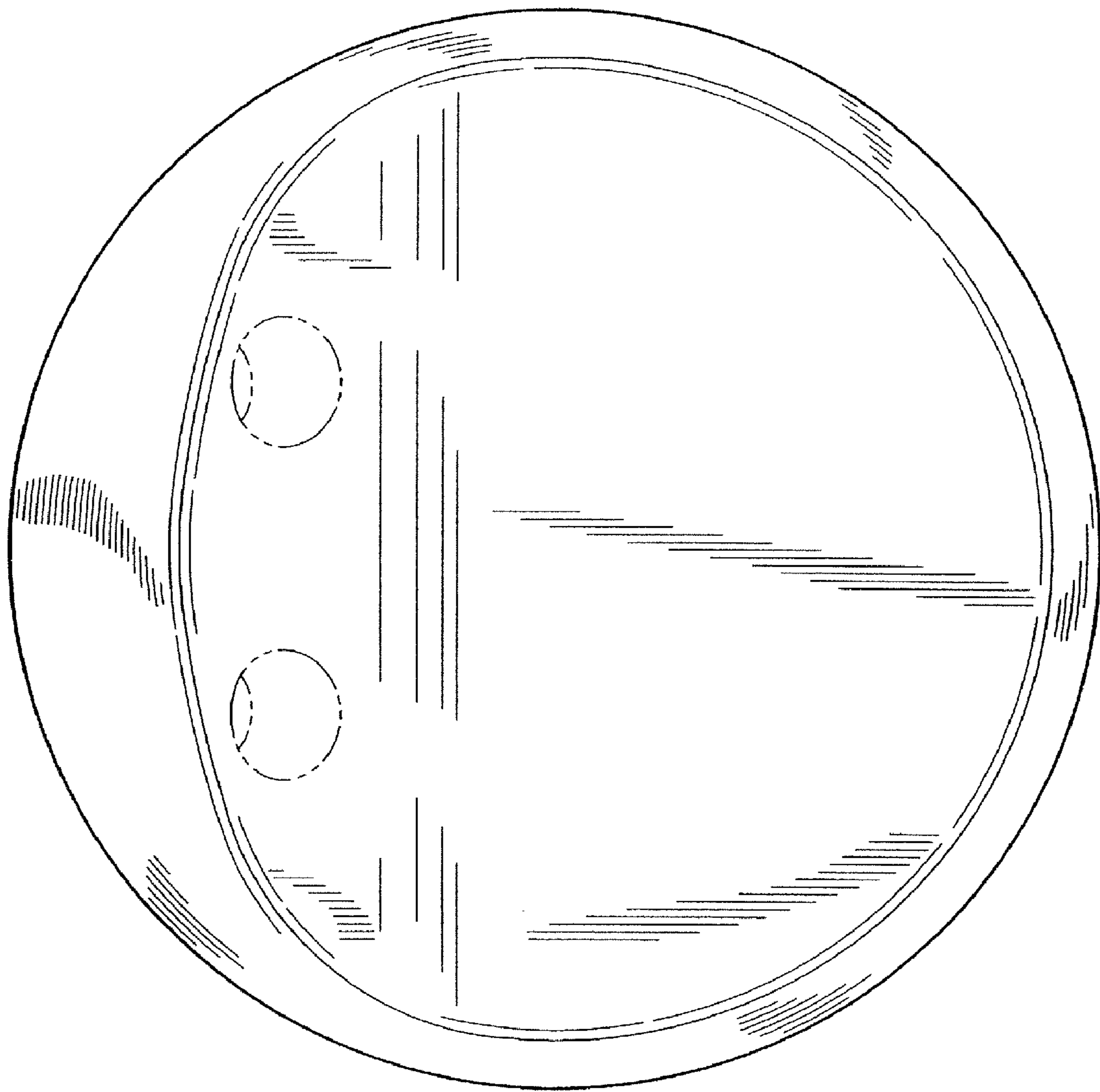

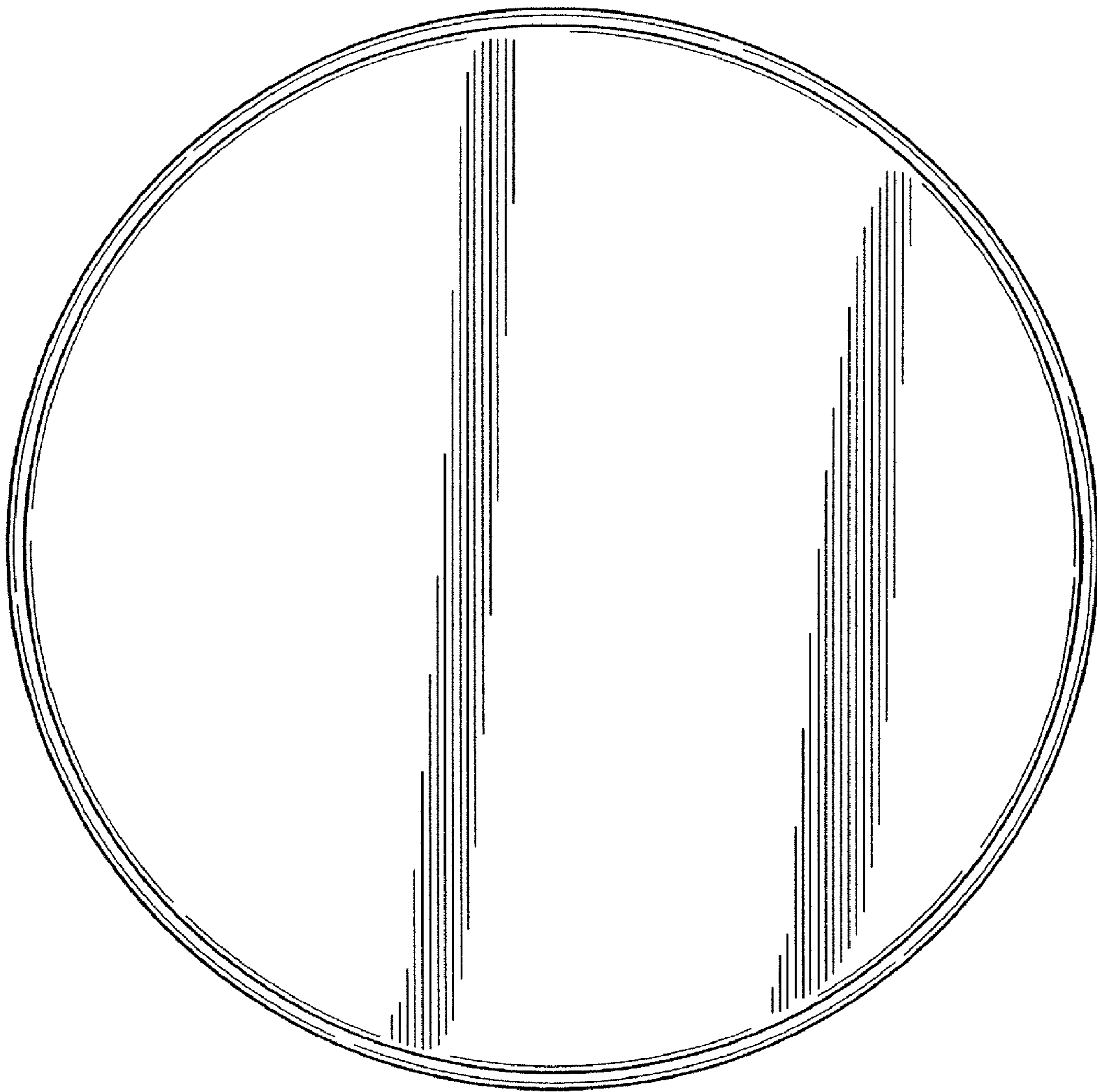

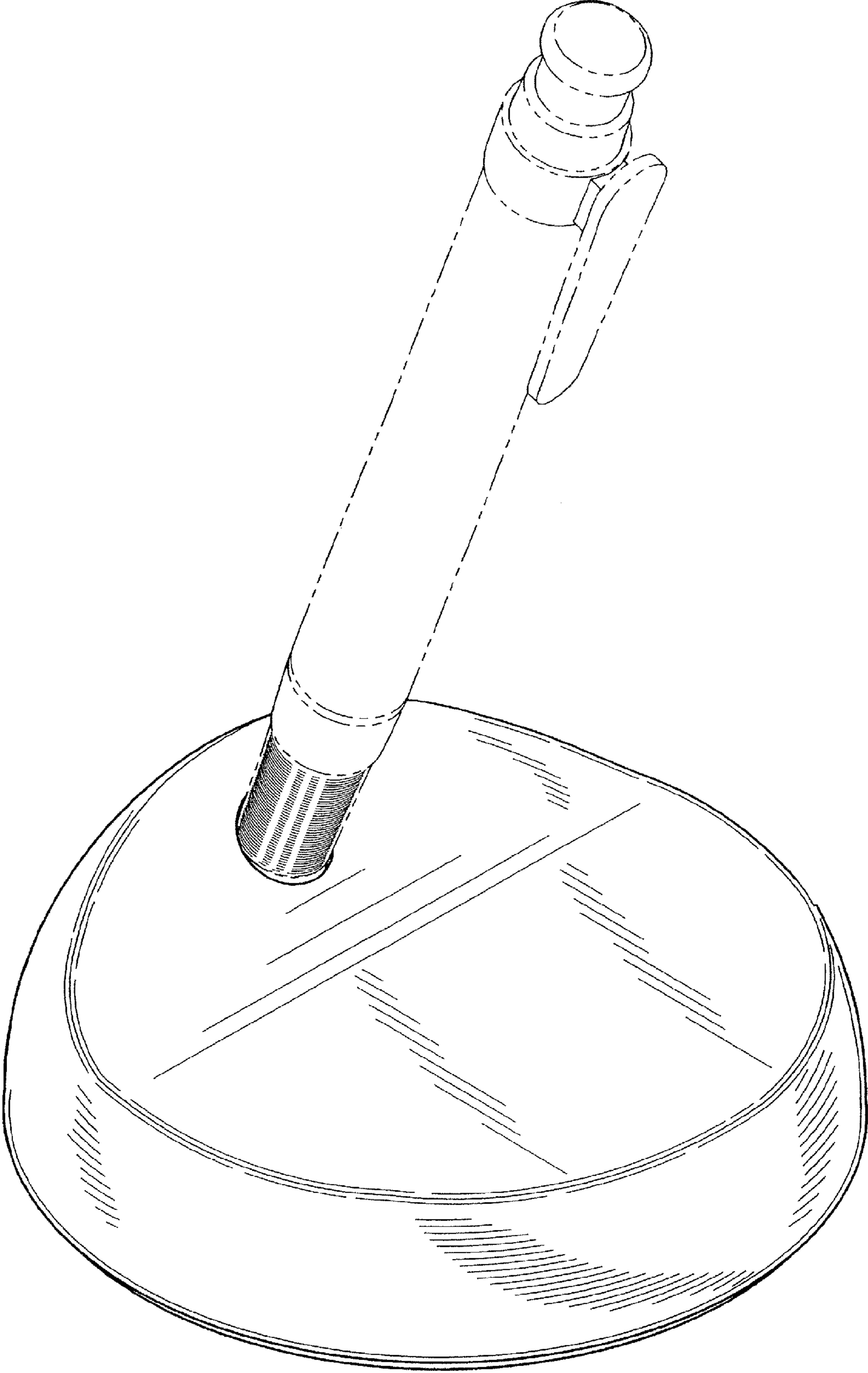

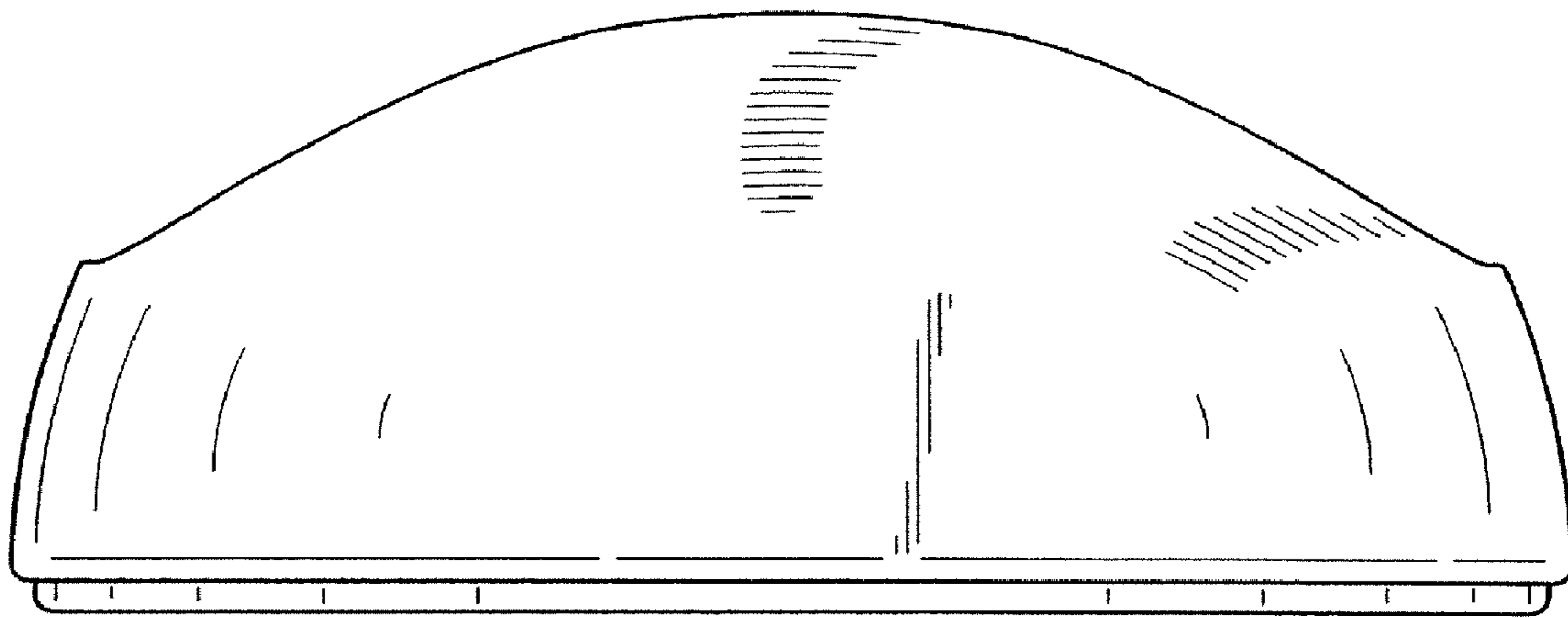

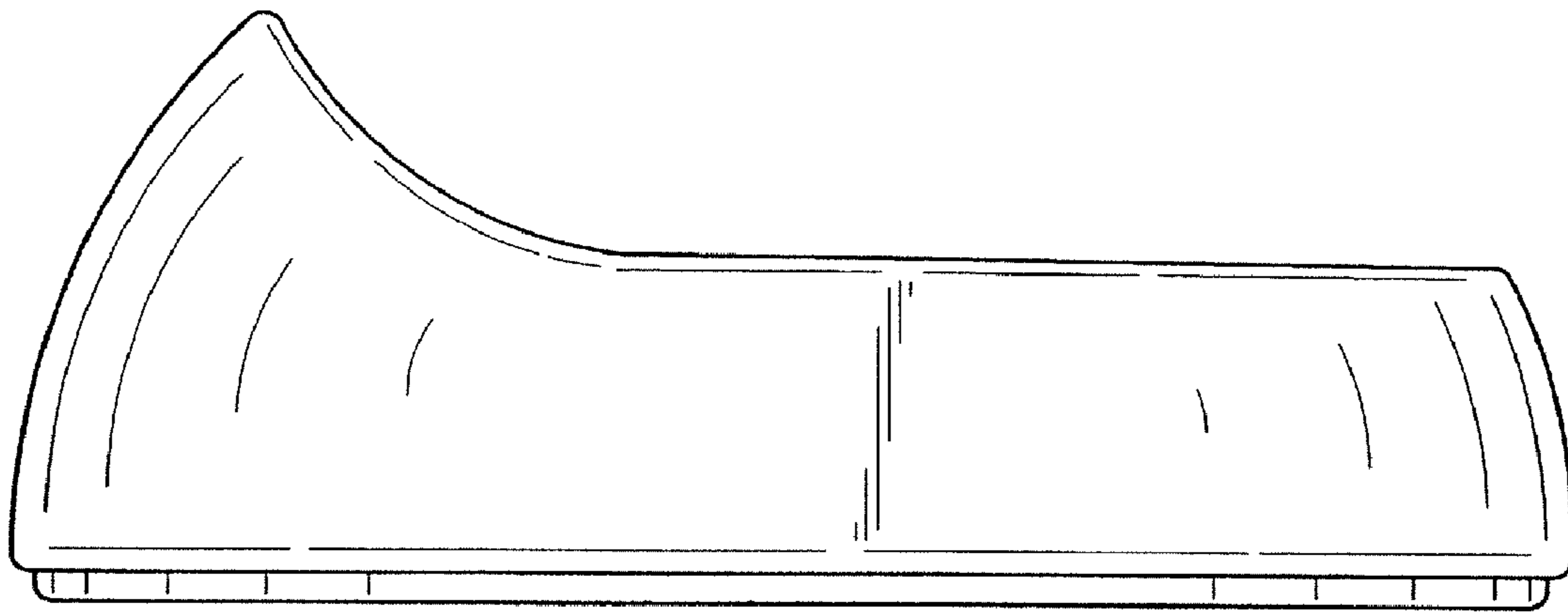

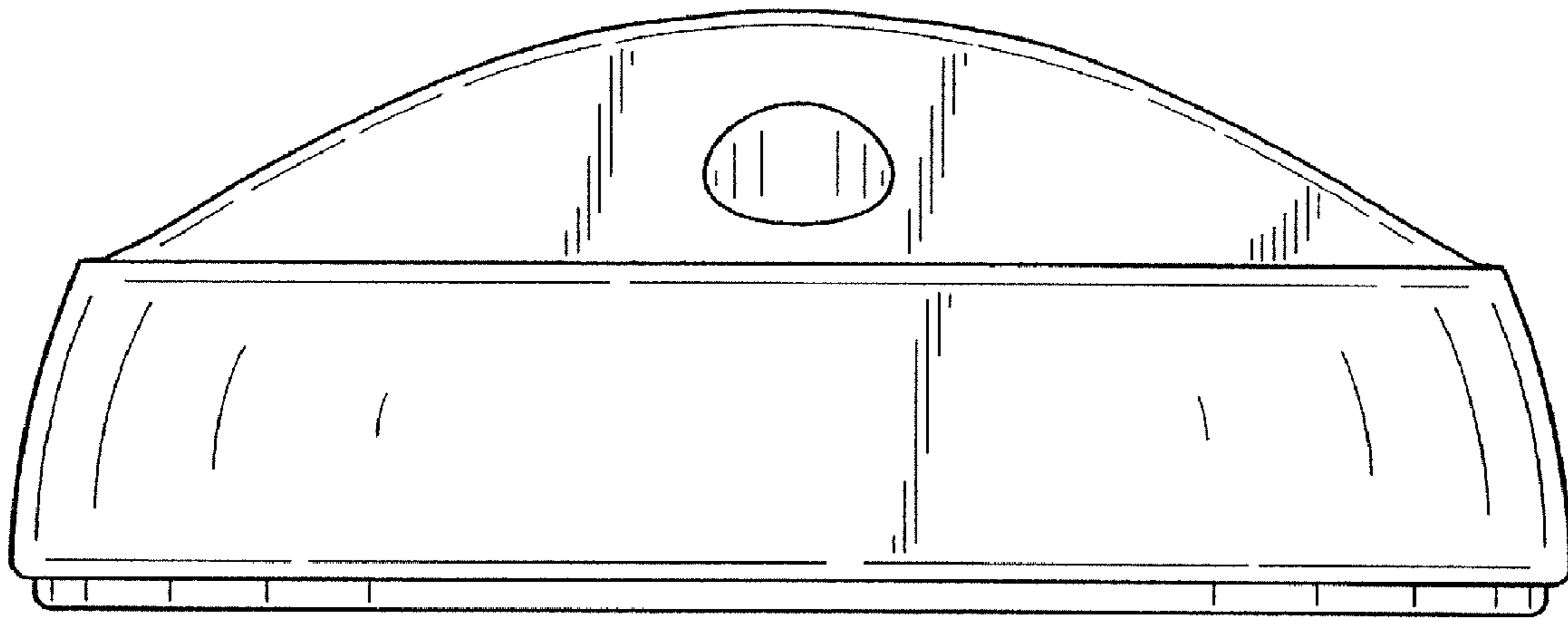

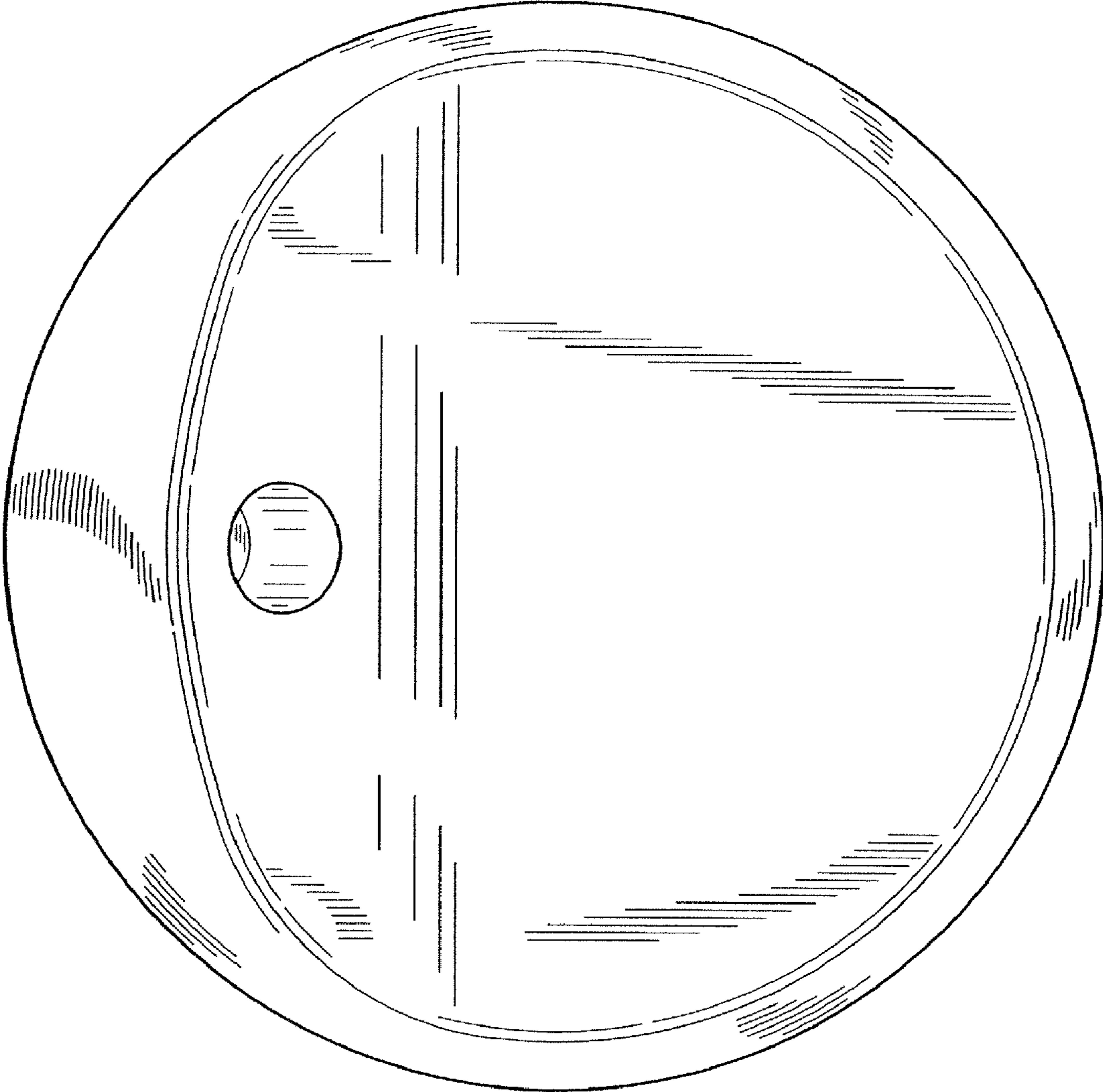
