FIG. 2 is an elevation view showing the rear side of our design.

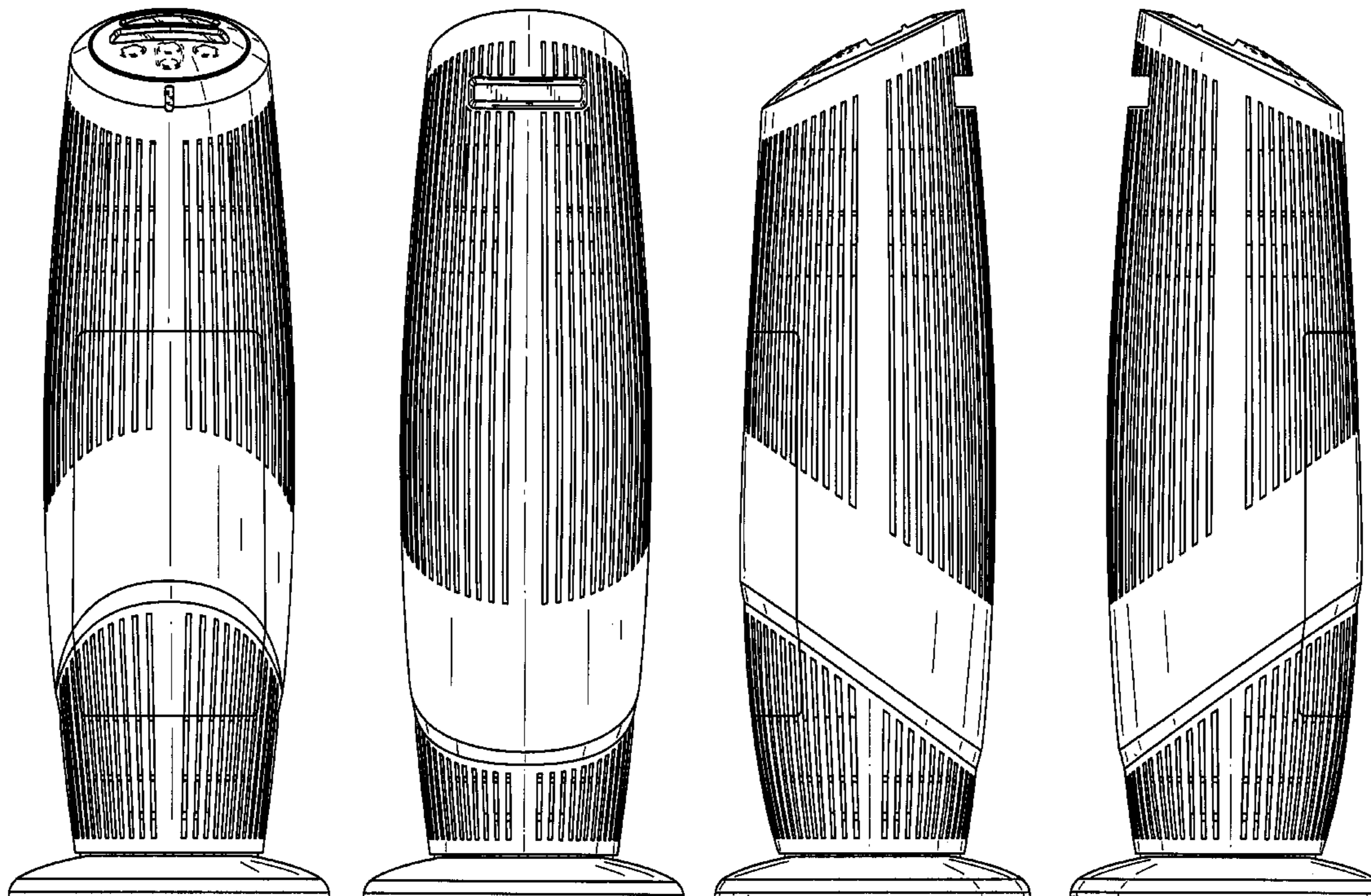
FIG. 3 is an elevation view showing the left side of our design.

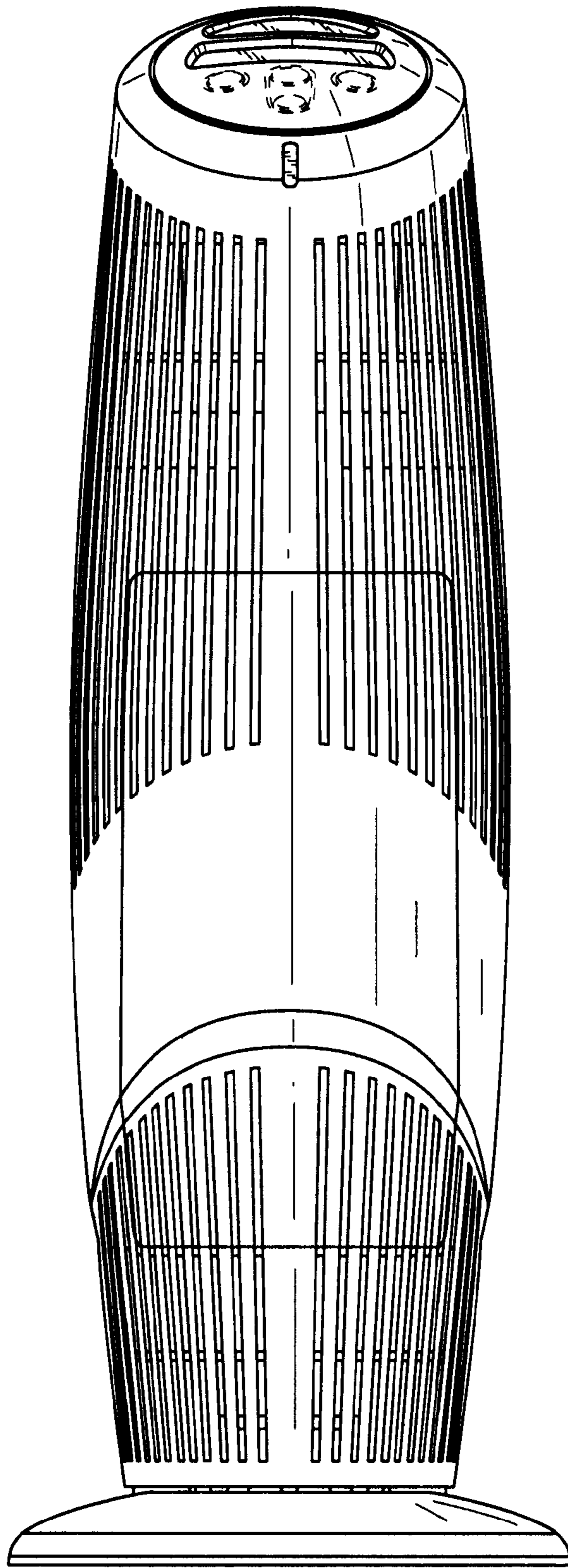

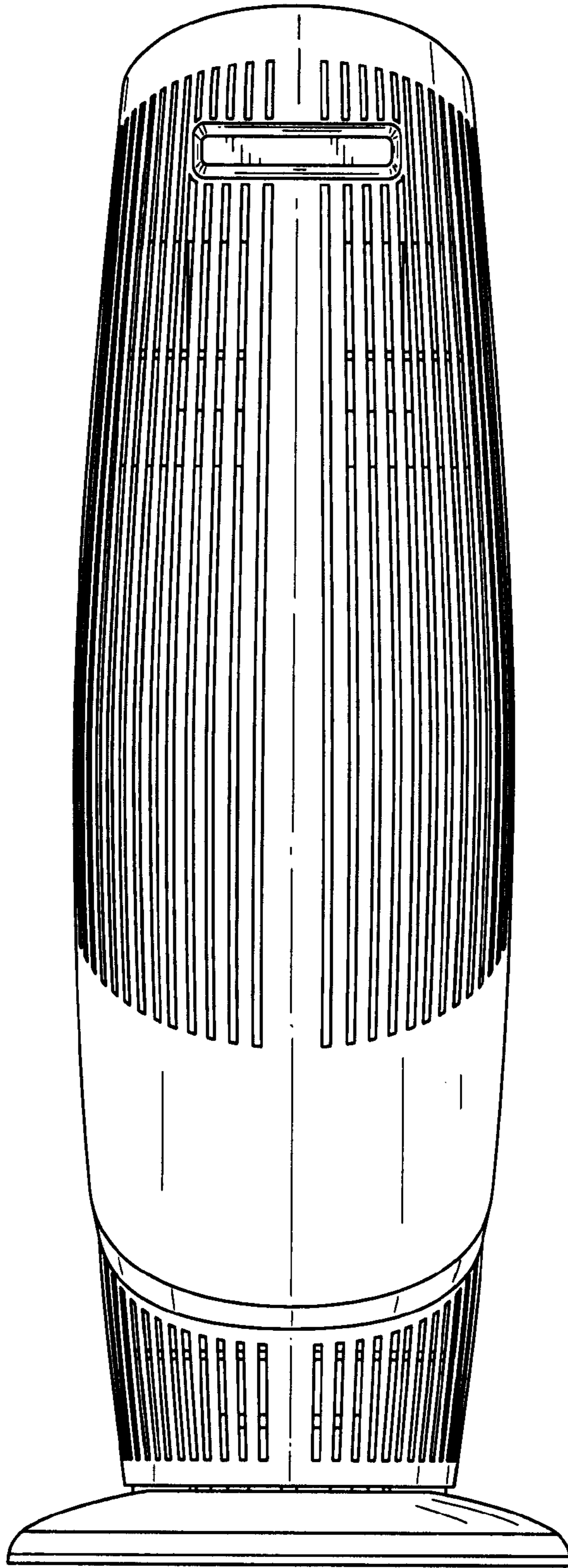

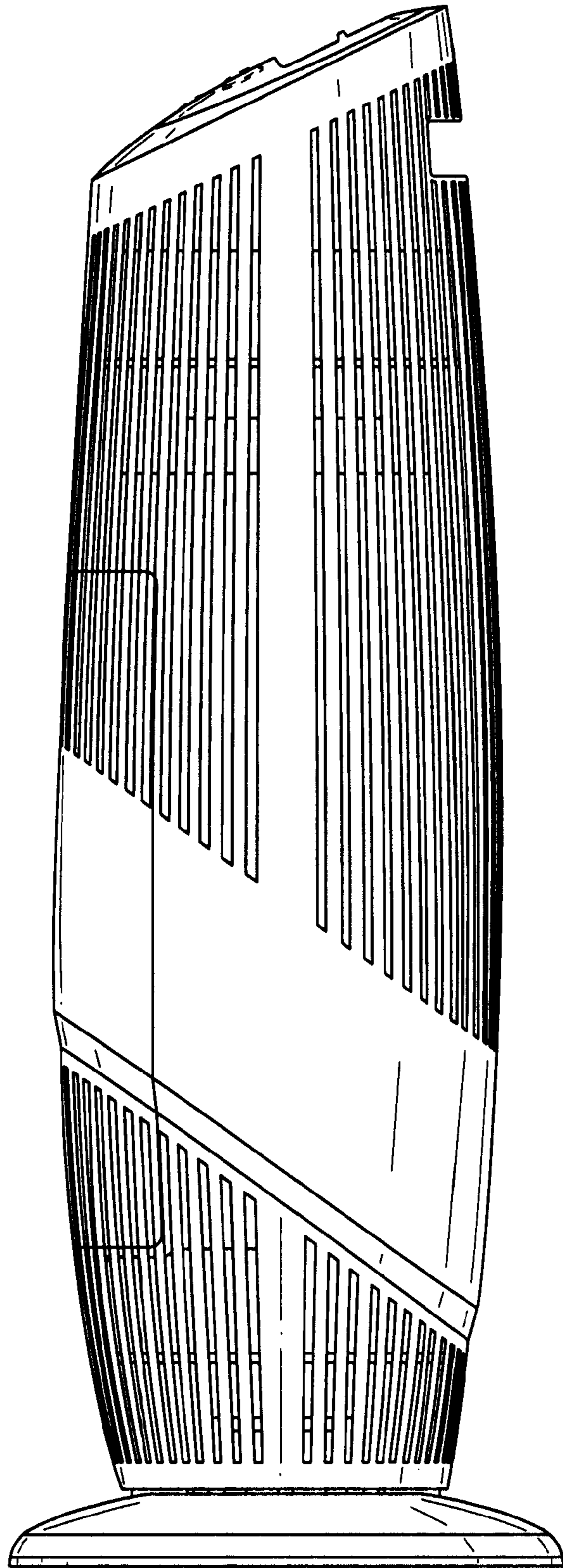

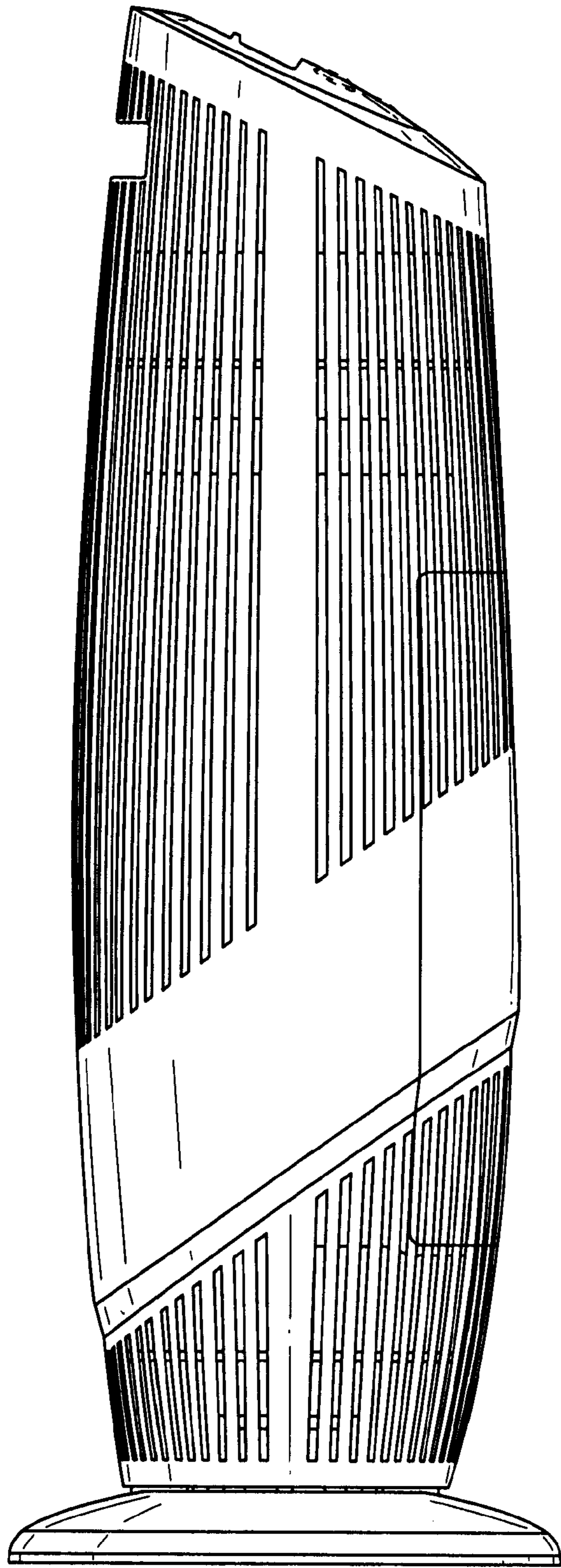

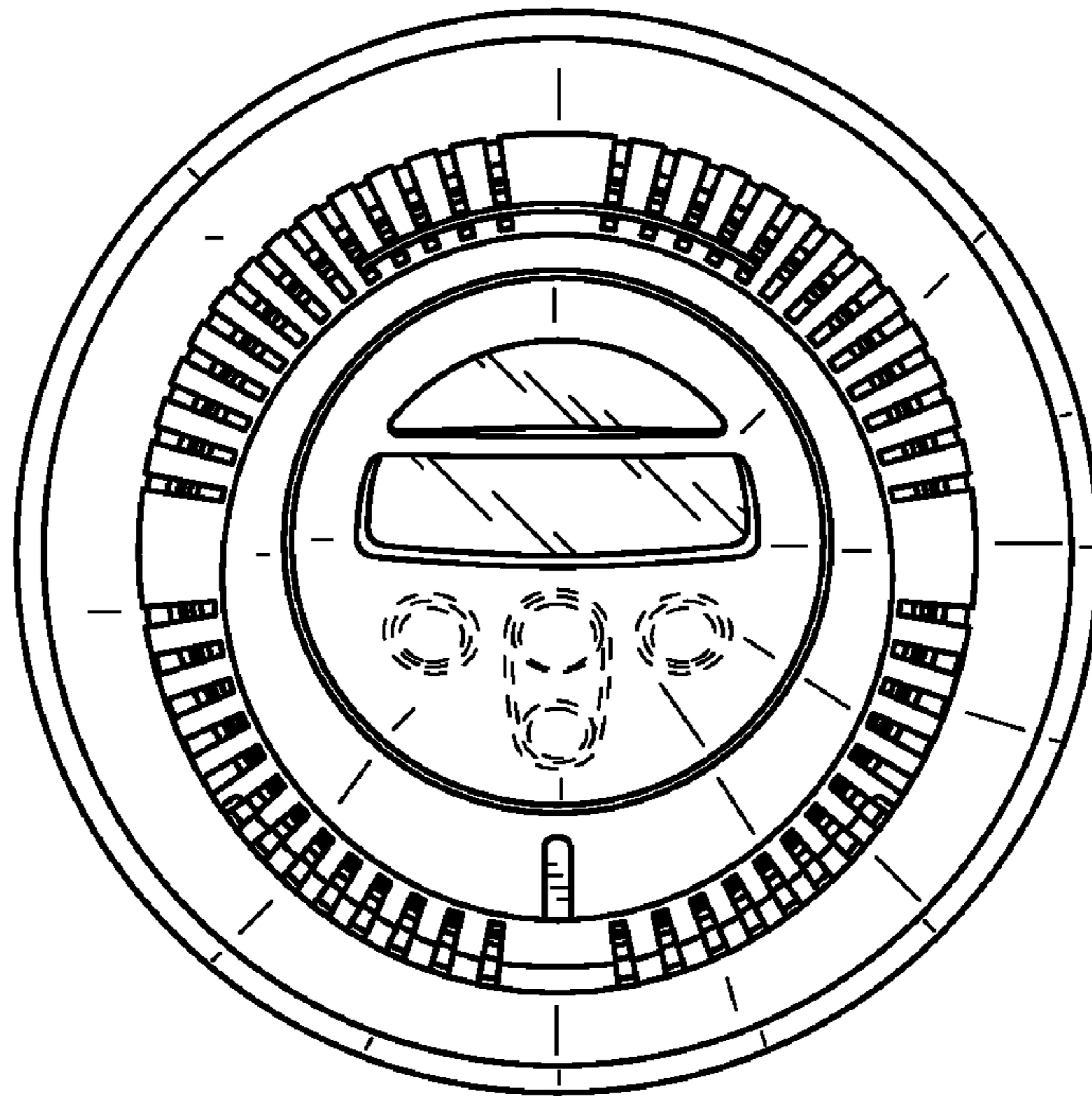

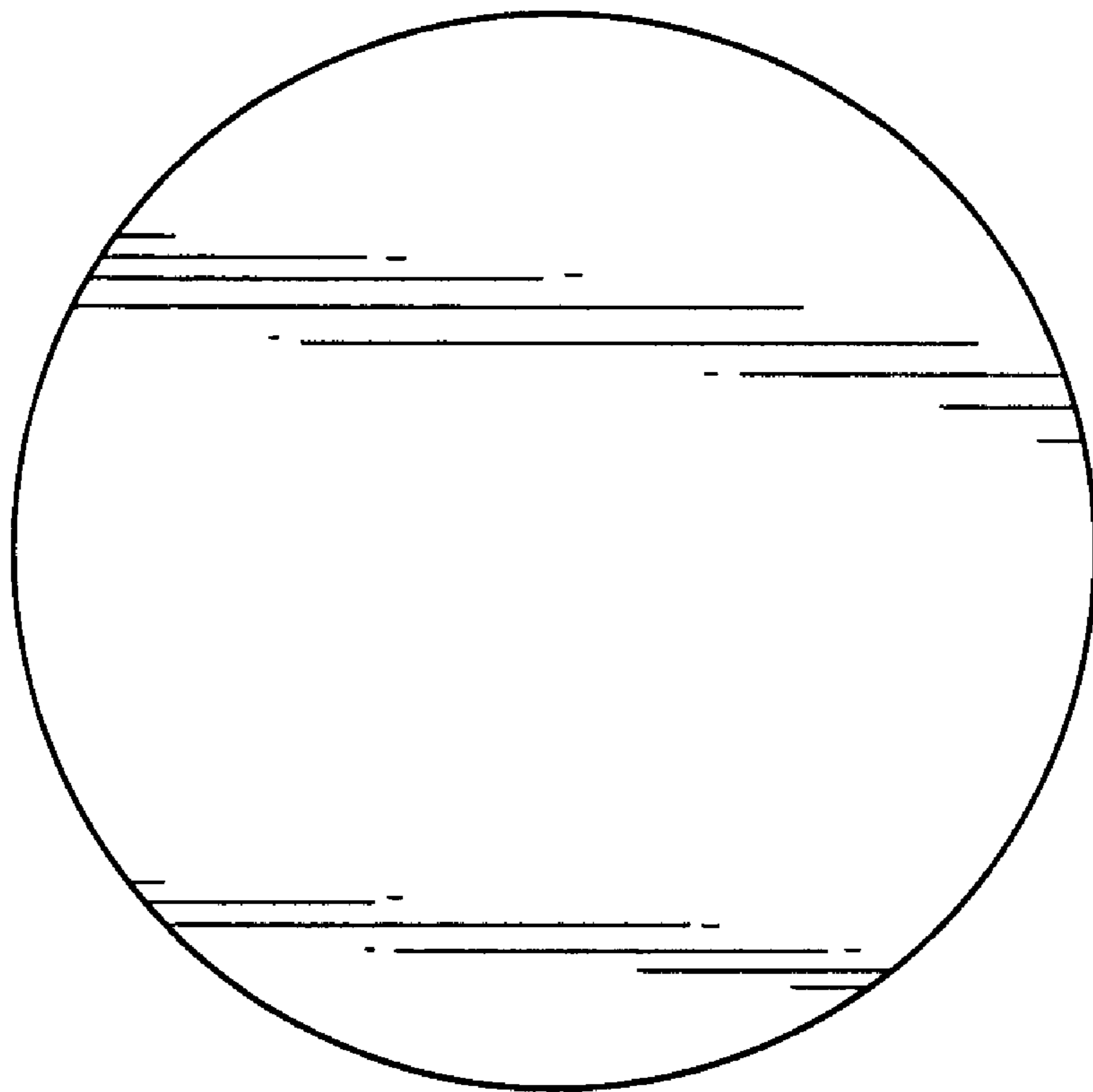
