according to my new design.

FIG. 2 is a top plan view thereof.

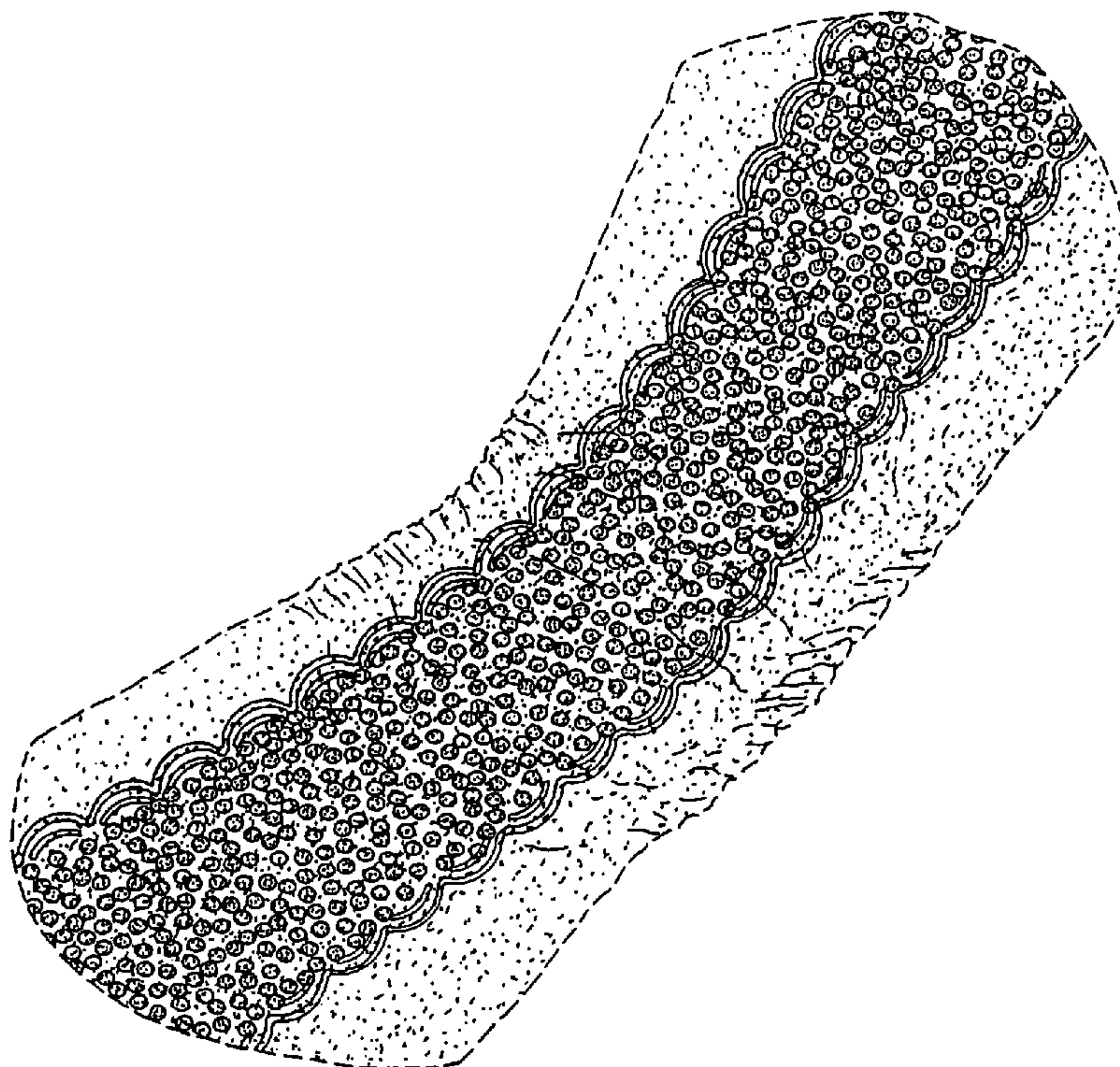
FIG. 3 is a right side perspective view thereof, the left side

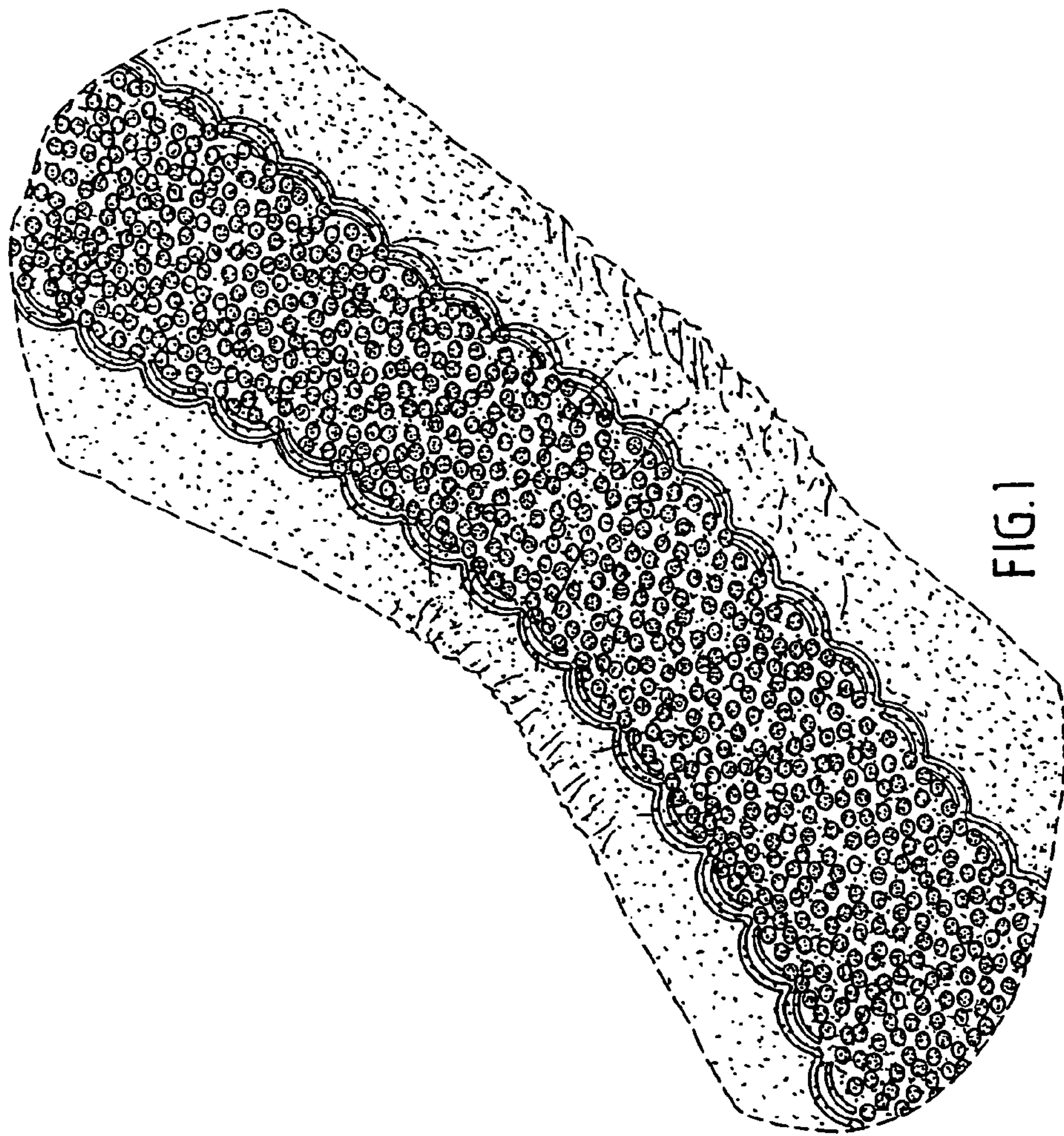

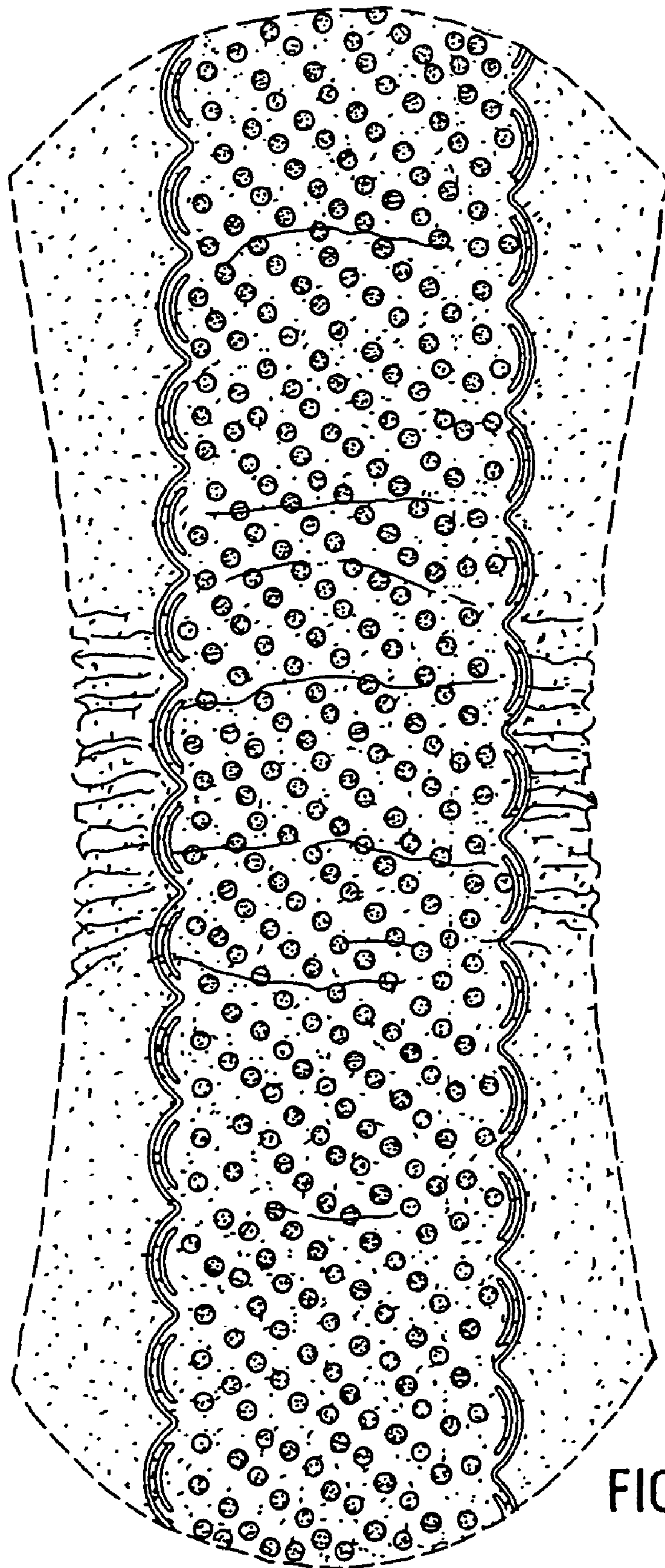

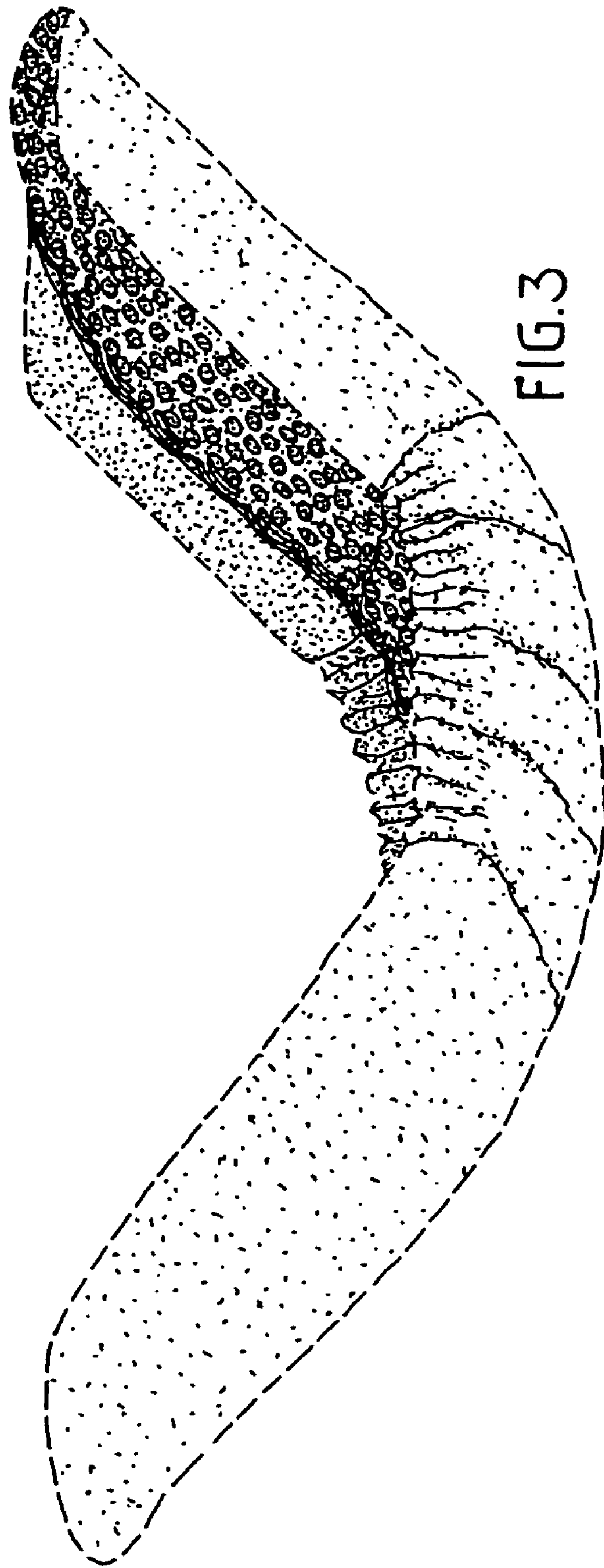
