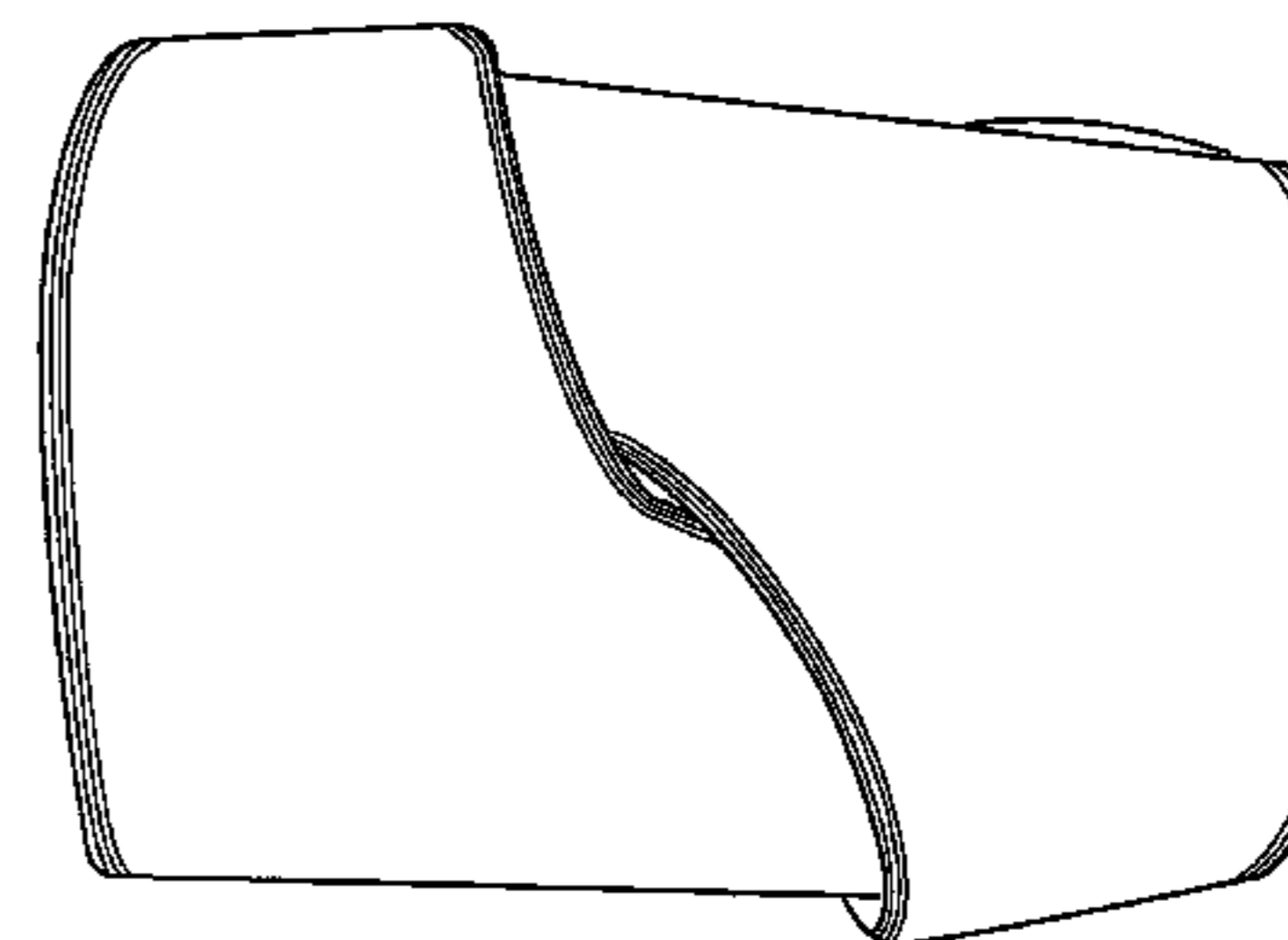
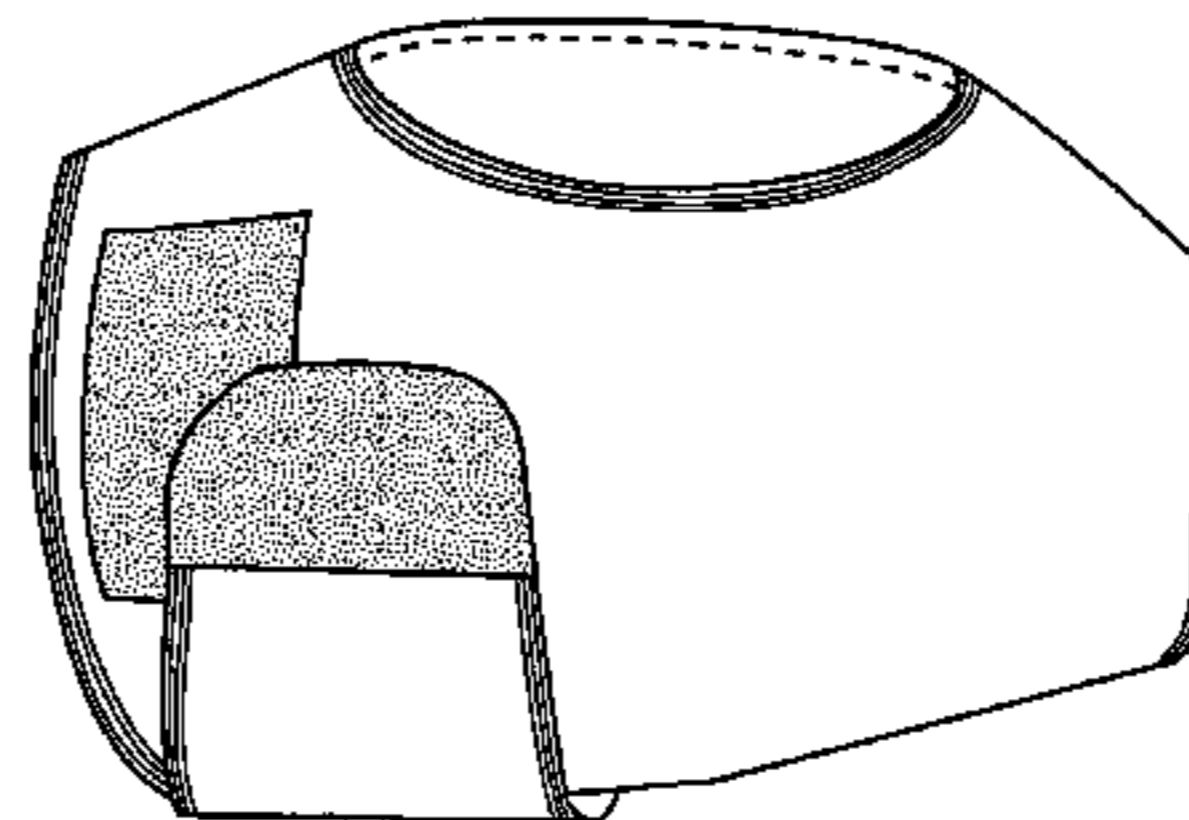
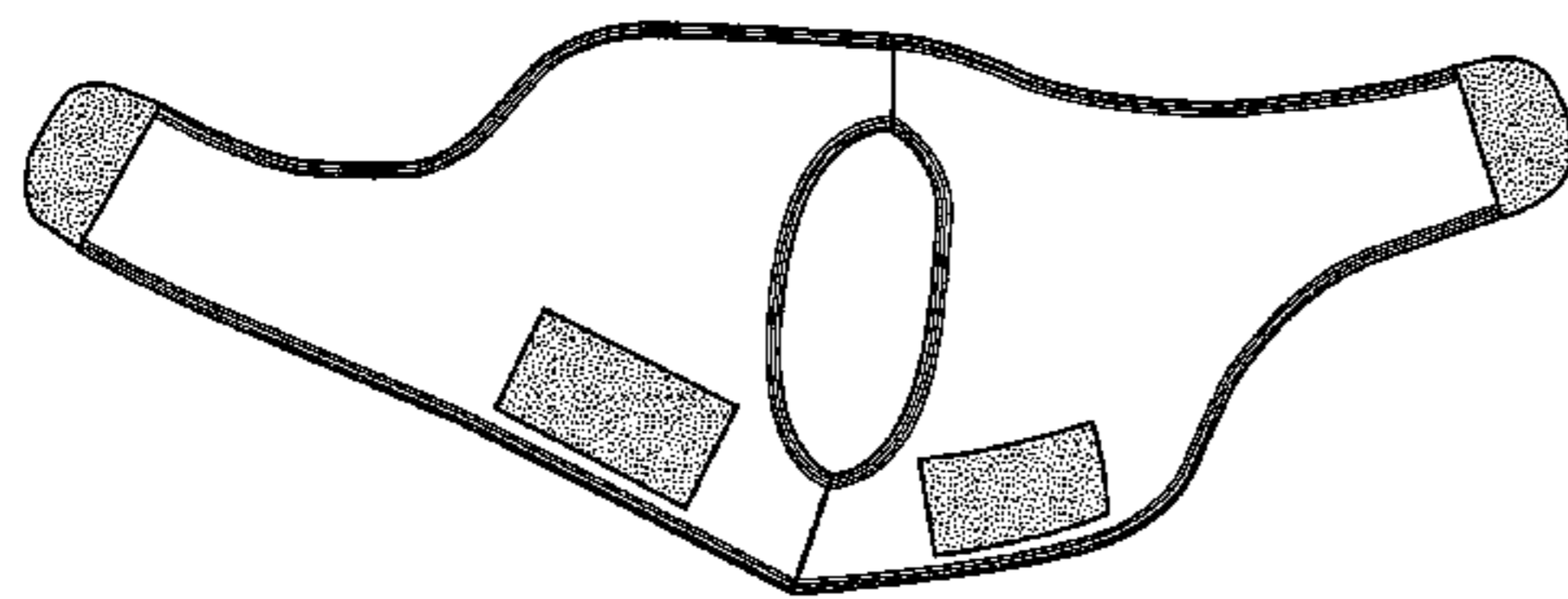
FIG. 5 is a bottom view showing the textile bandage in a wrapped configuration.

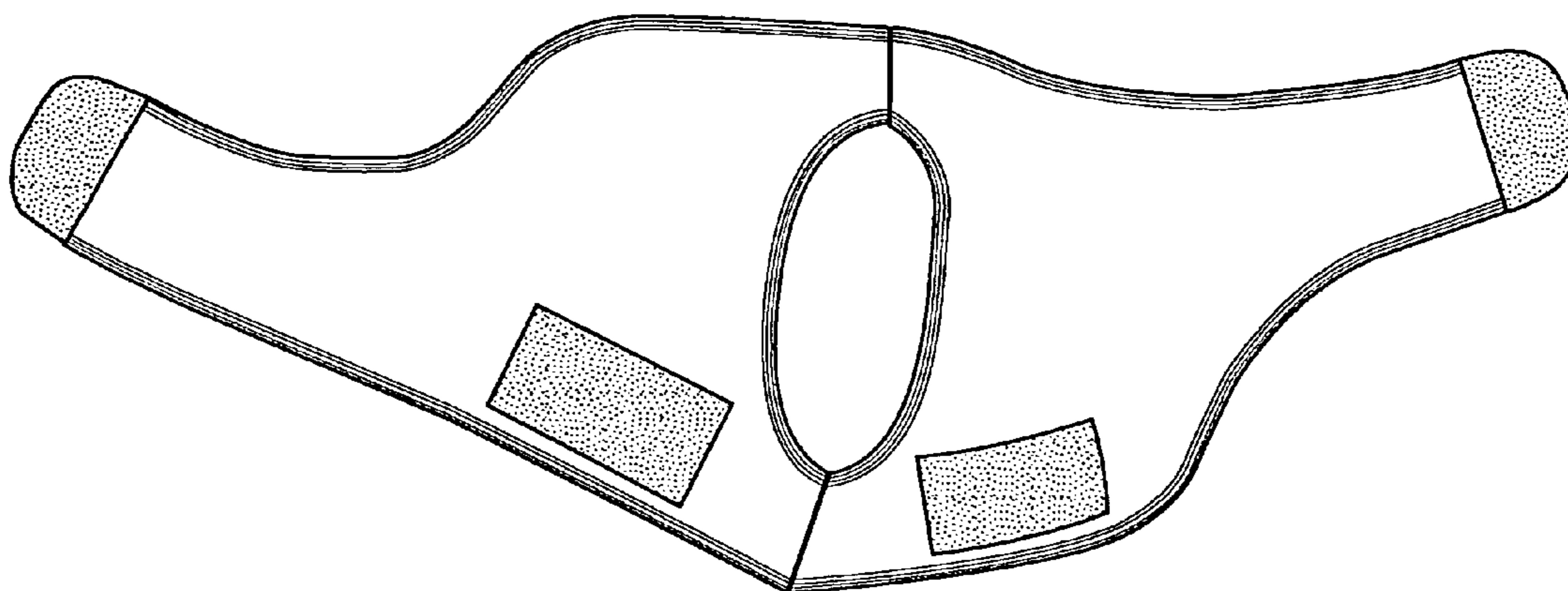

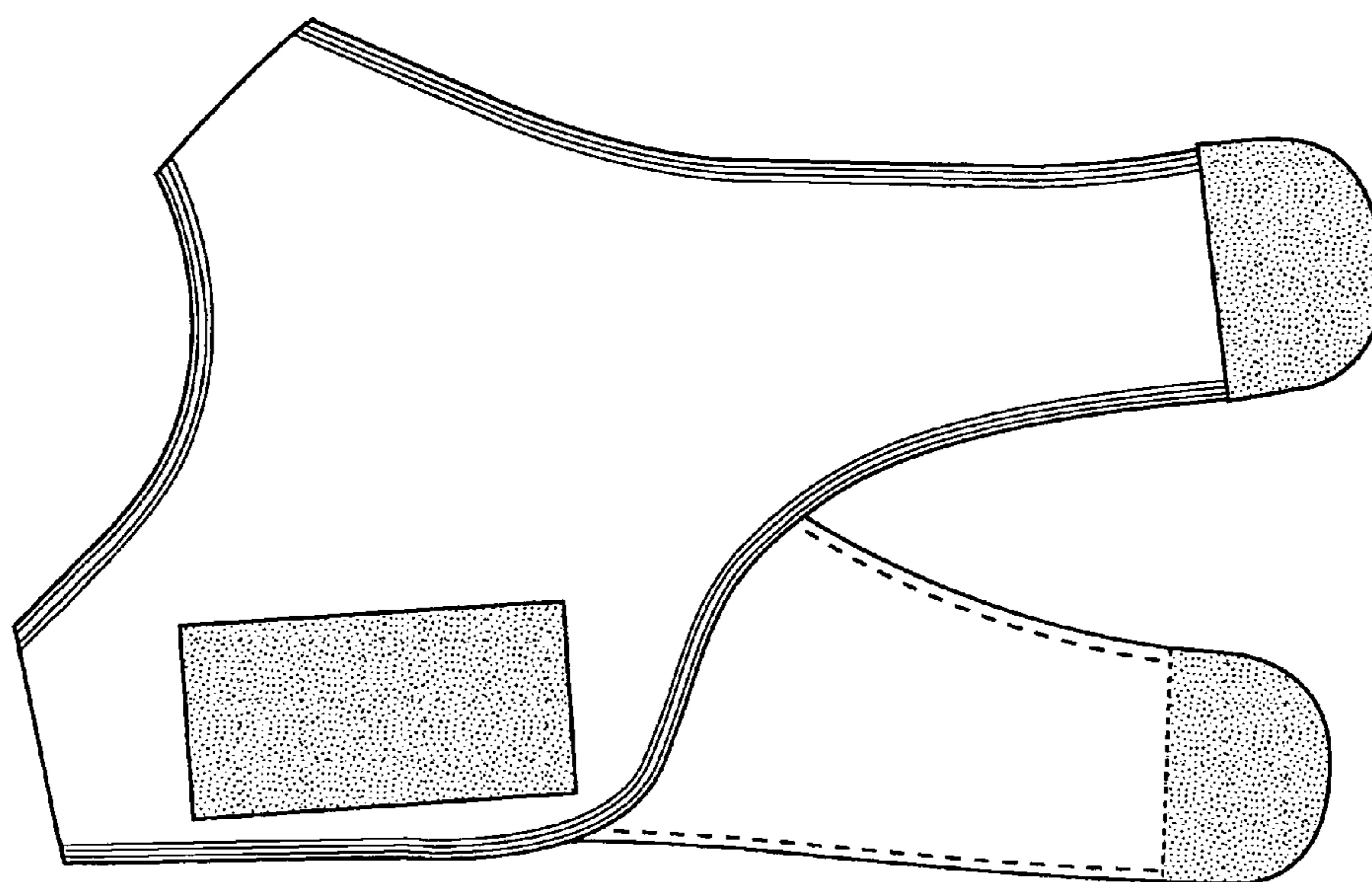

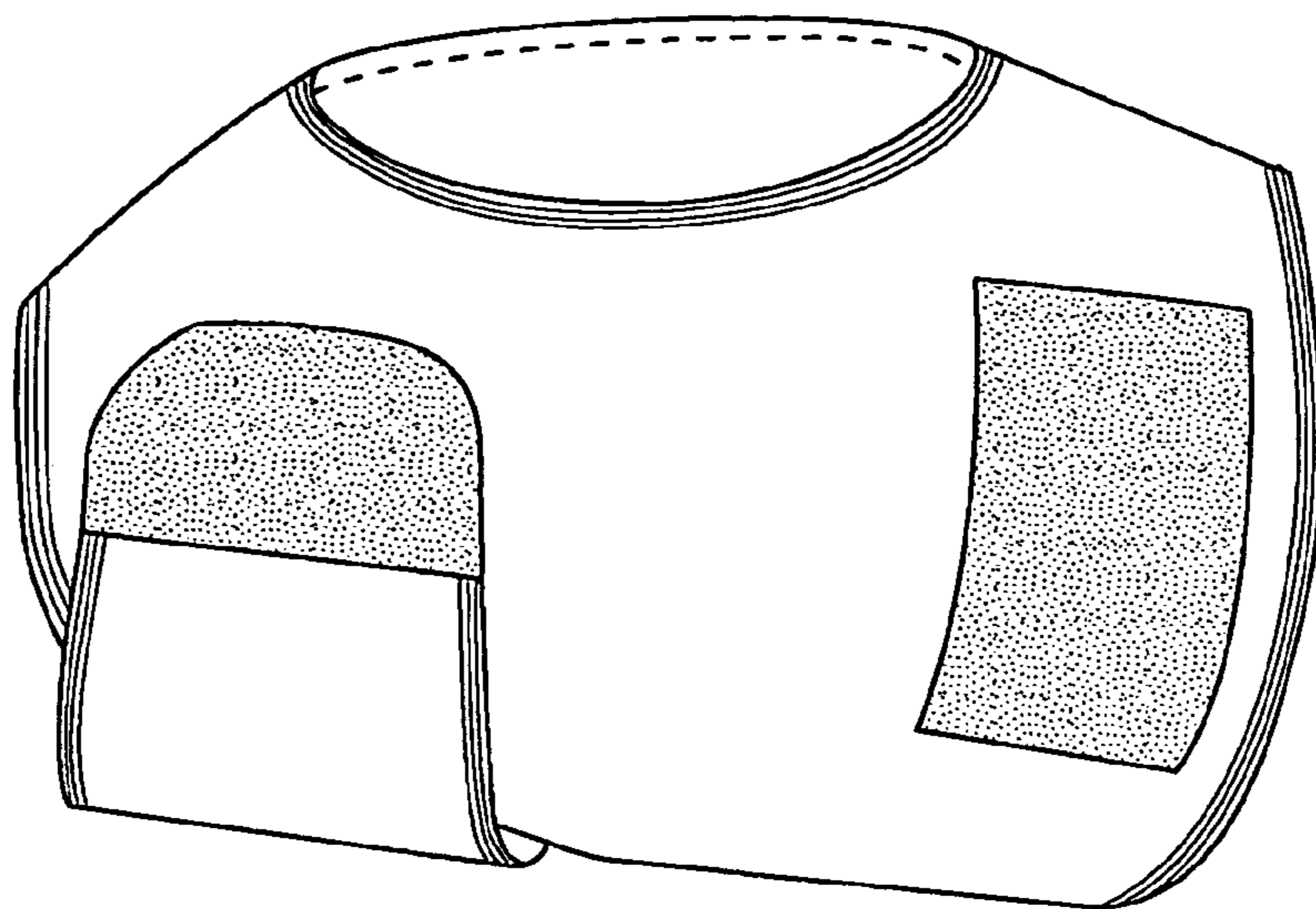




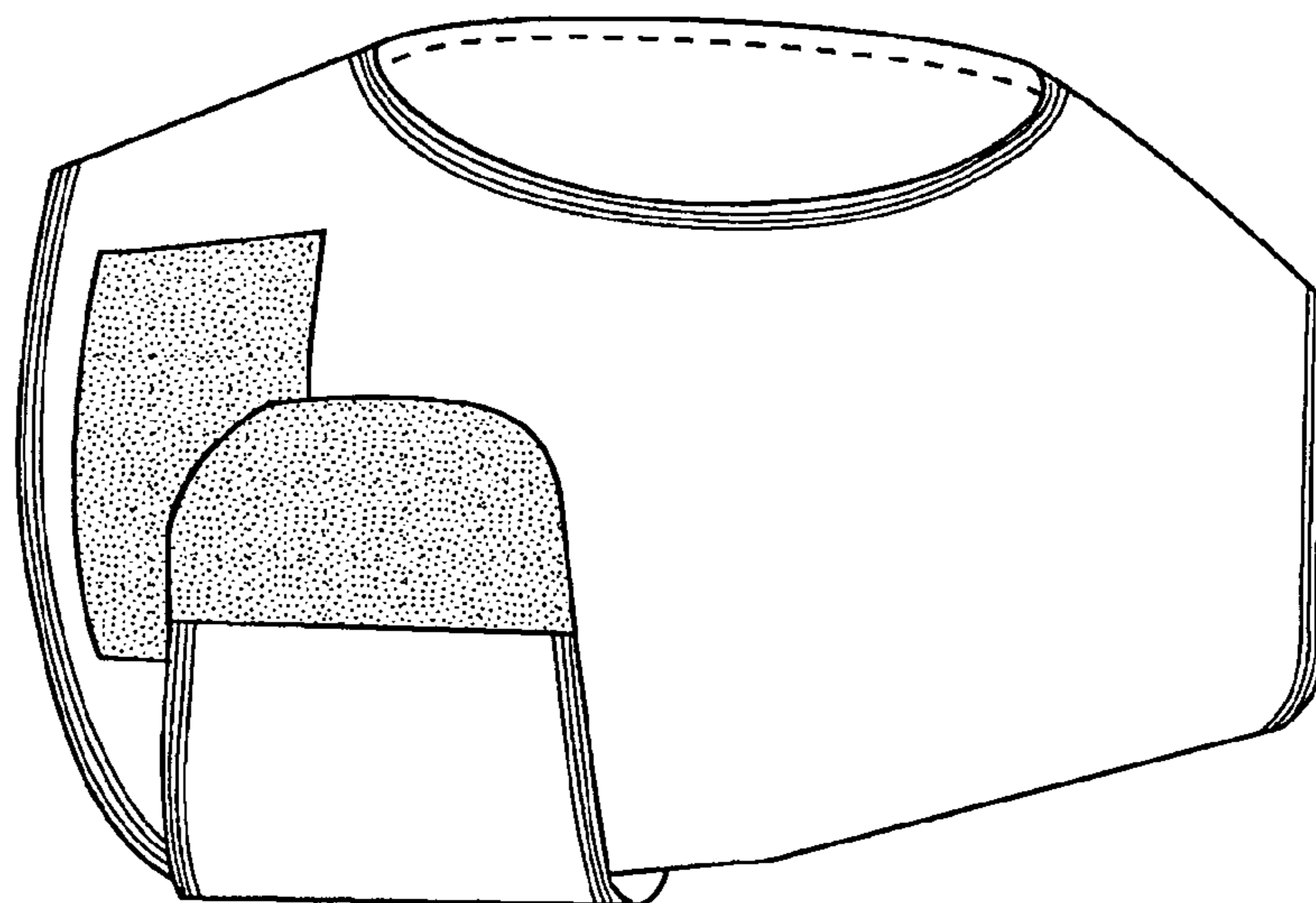

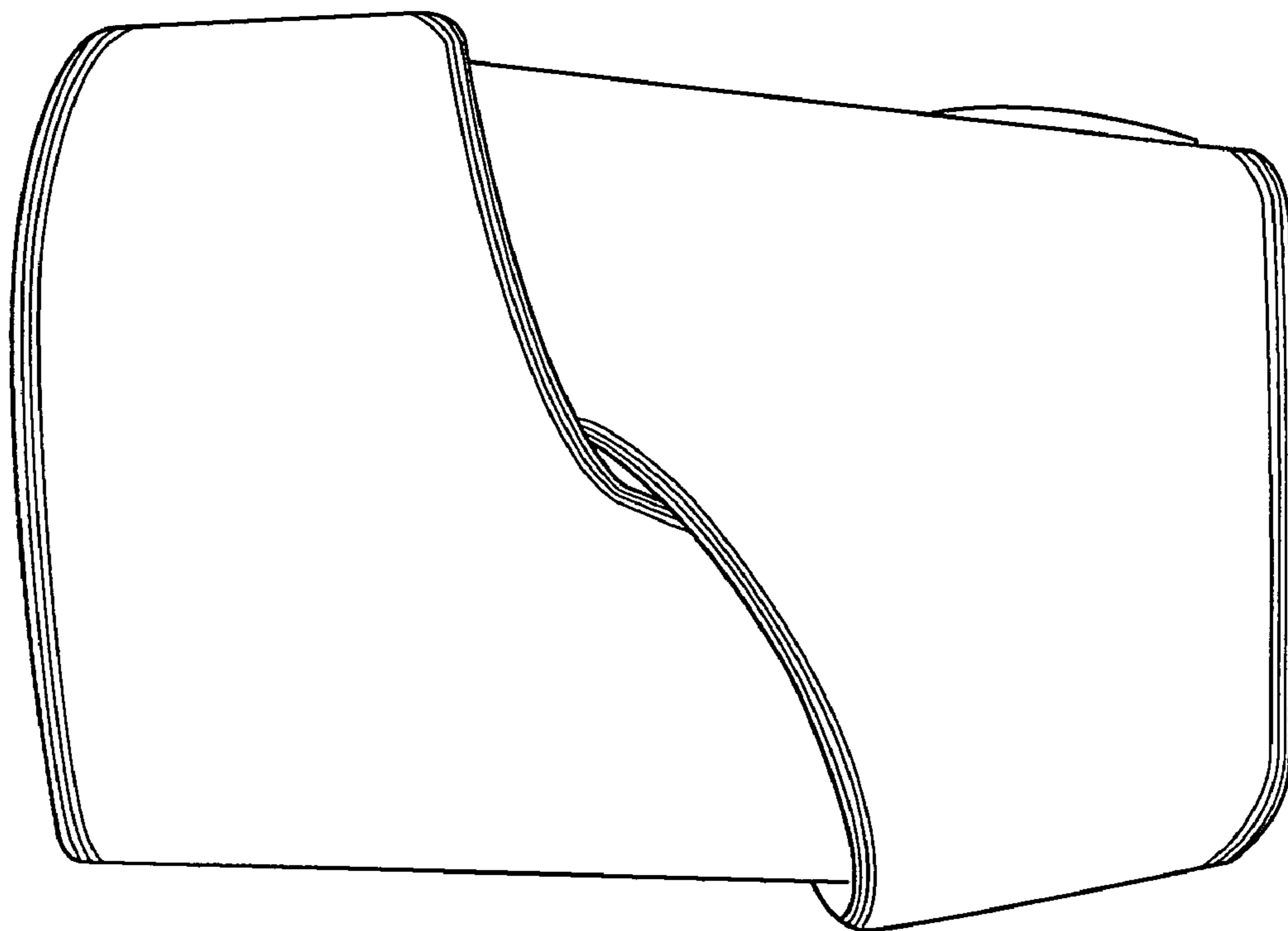
