**DESCRIPTION**

FIG. 1 is a front elevational view of the present invention;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a left elevational view thereof, the right elevational view being the mirror image thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof; and,

FIG. 6 is a perspective view thereof.

Wherein the broken lines shown in FIGS. 1-6 represent conventional stitching.

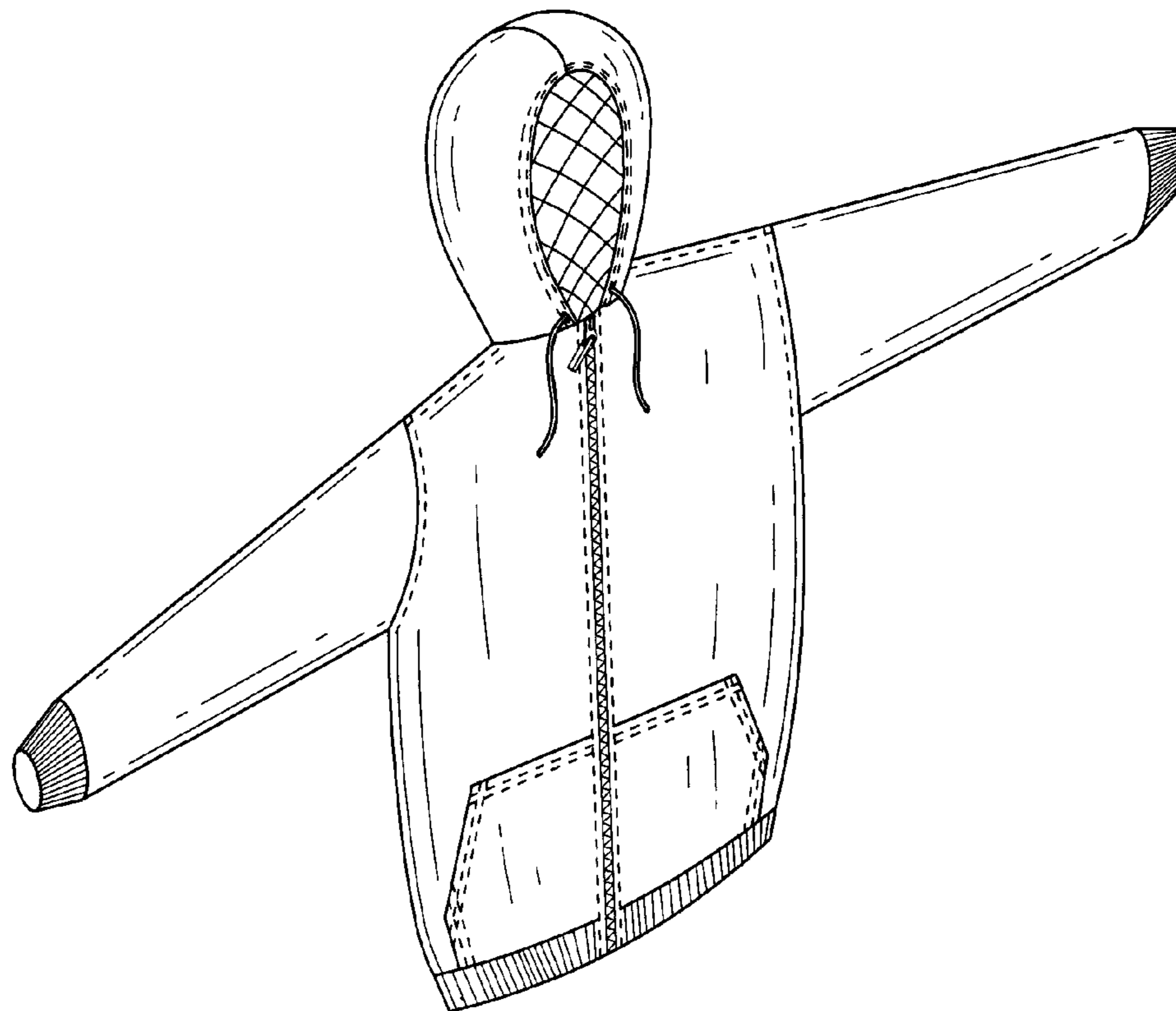

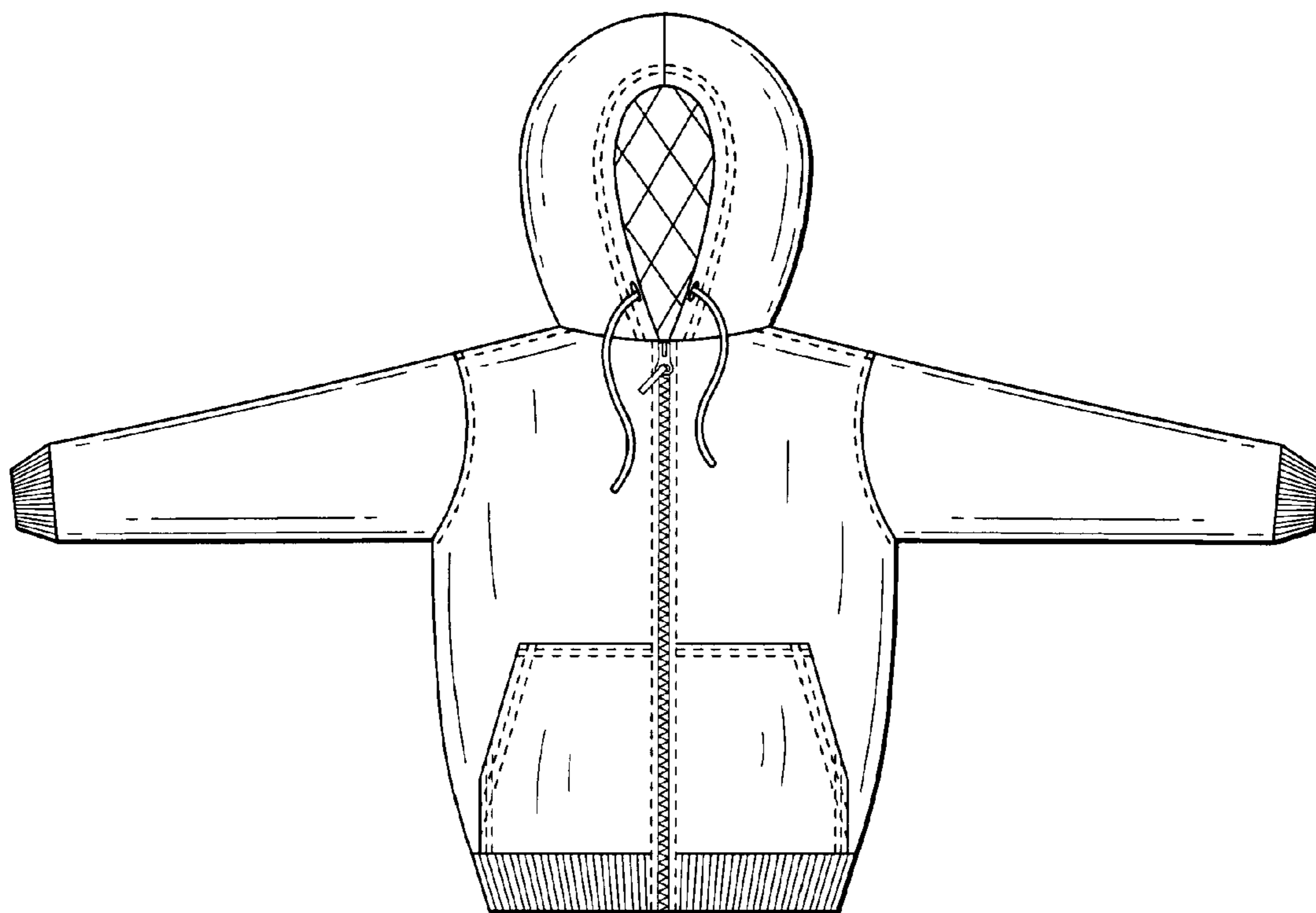
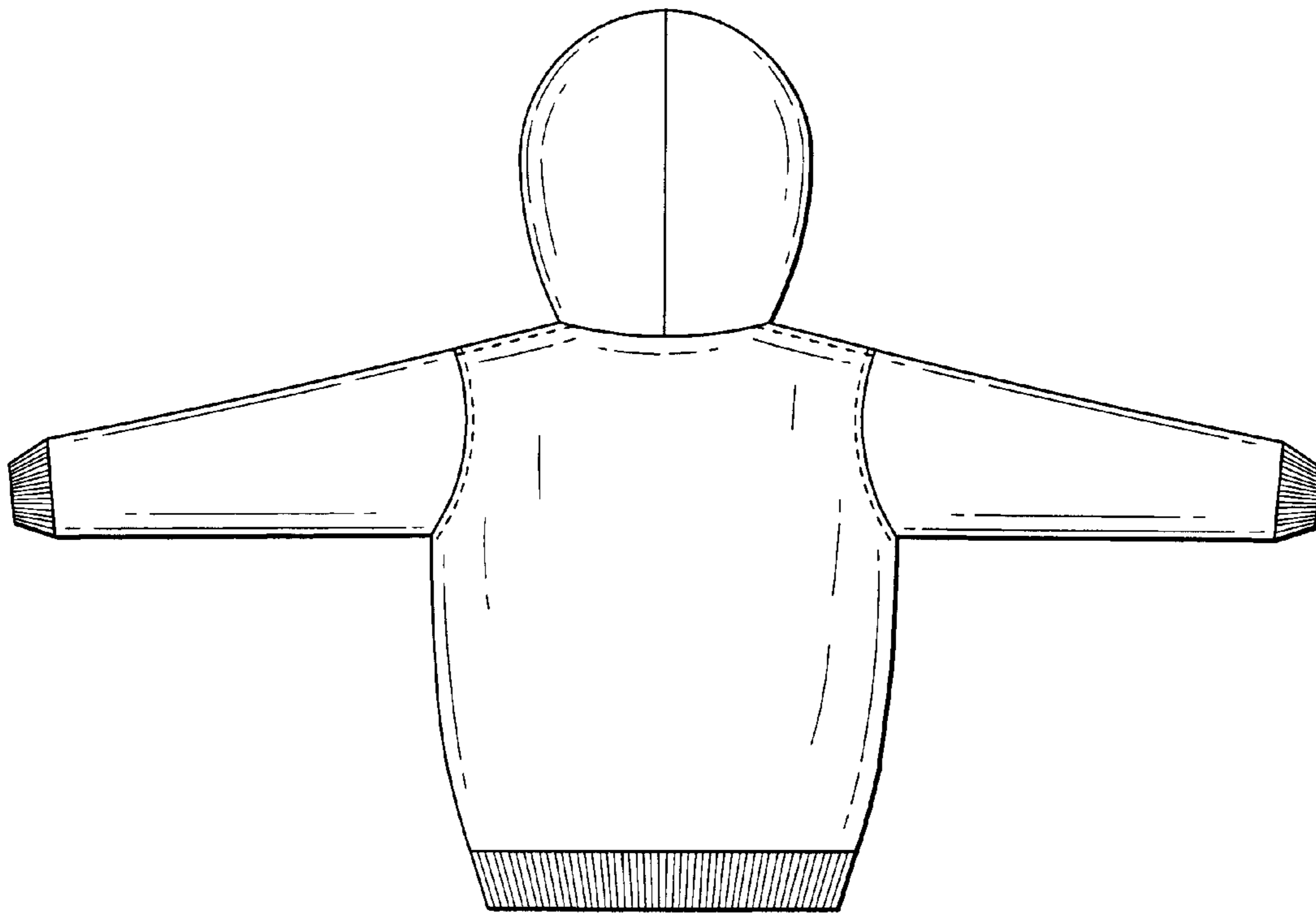

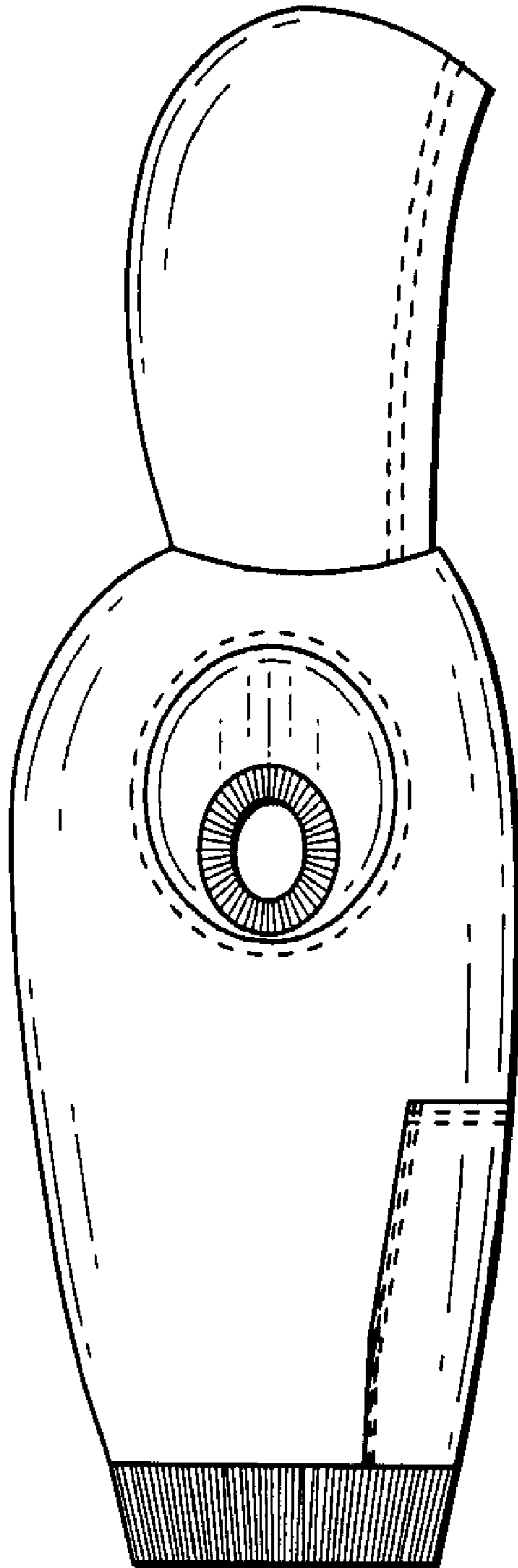

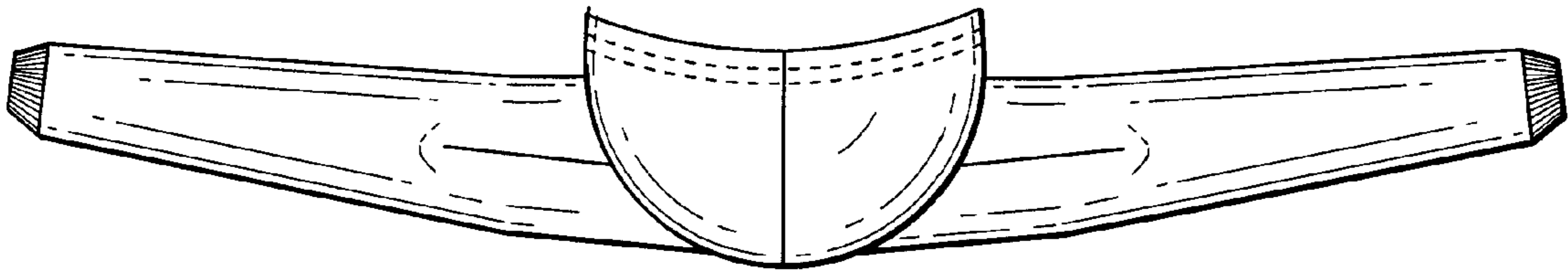
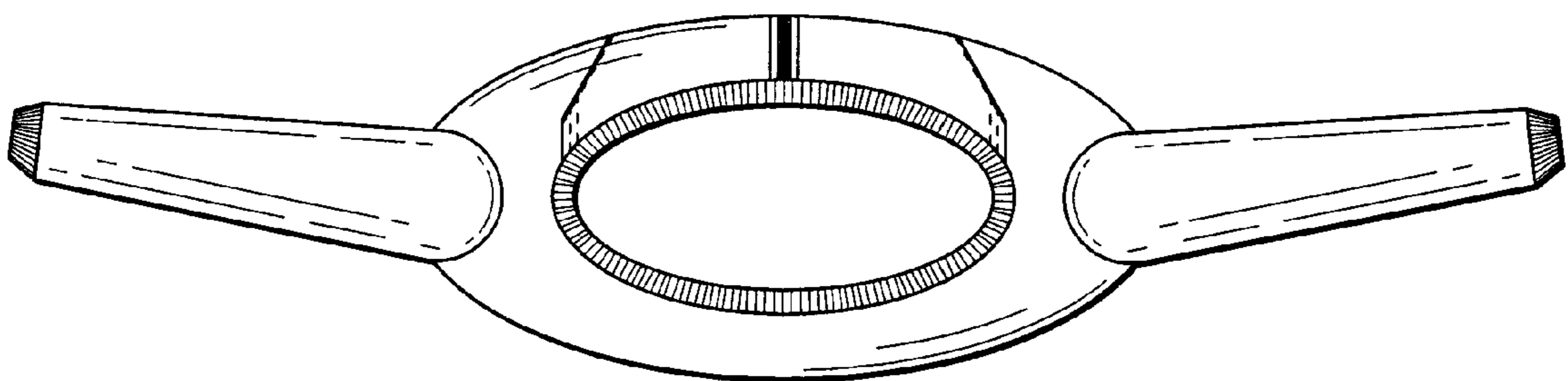
