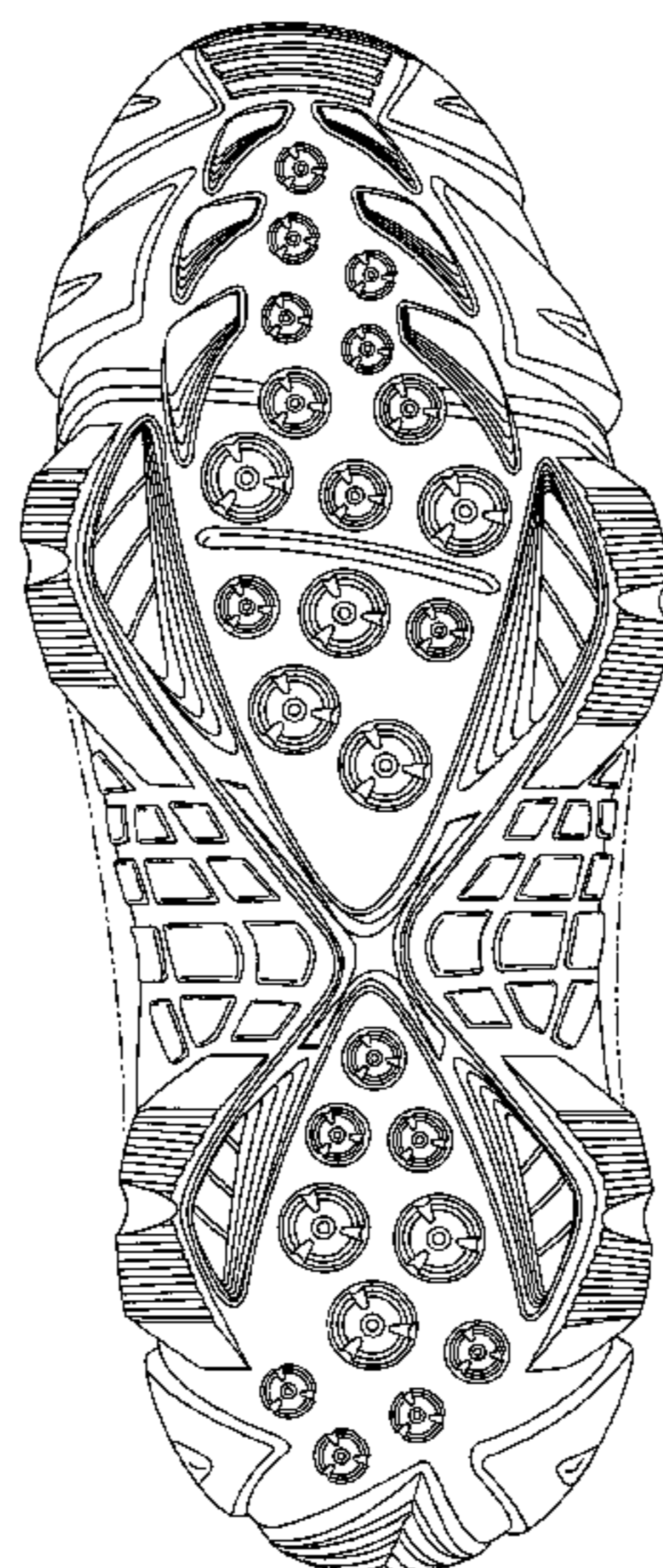

Further, the phantom lines immediately adjacent the solid-  
line portions of the design form the boundary of the design,  
with the phantom lines forming no part of the claimed  
design.

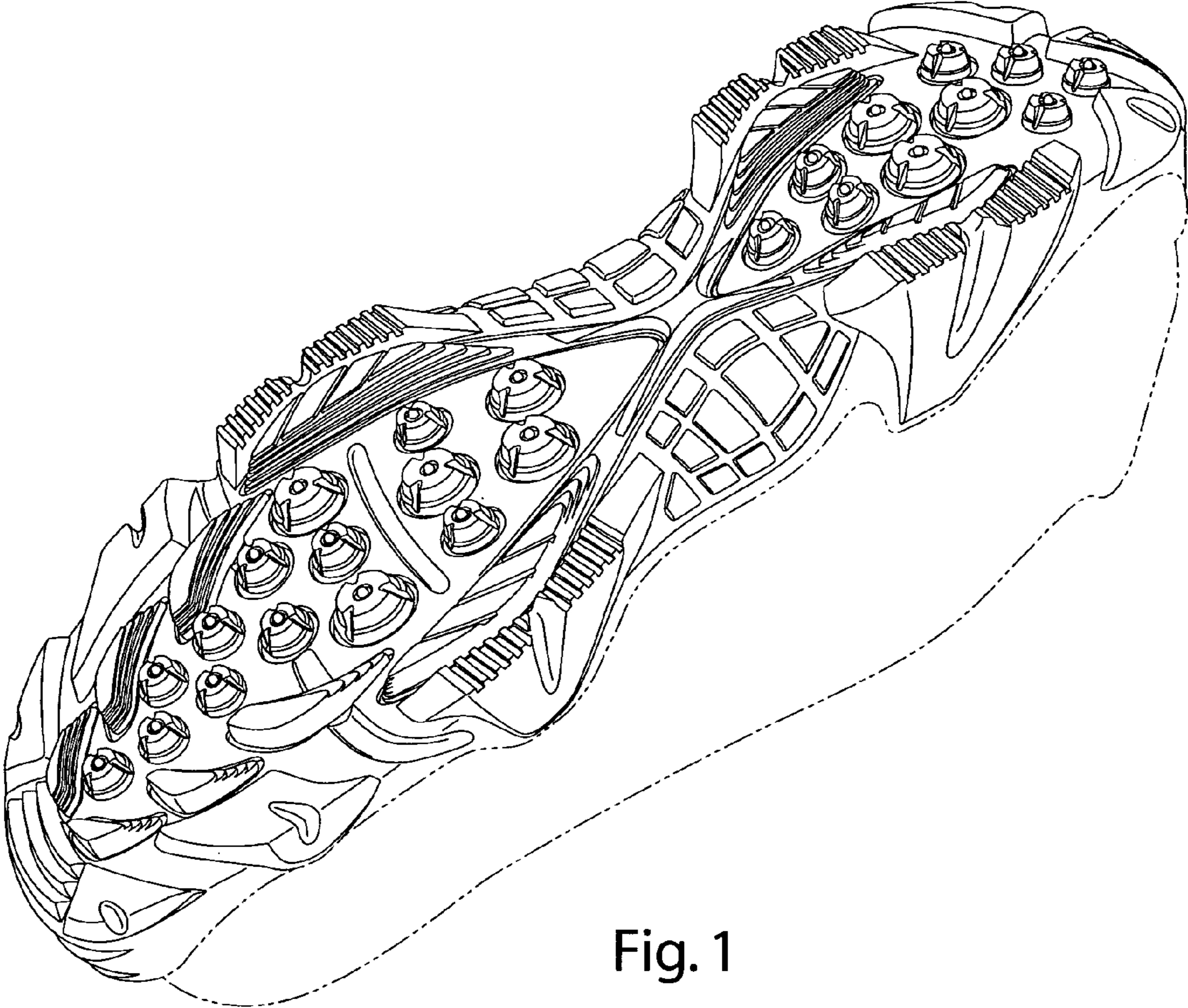

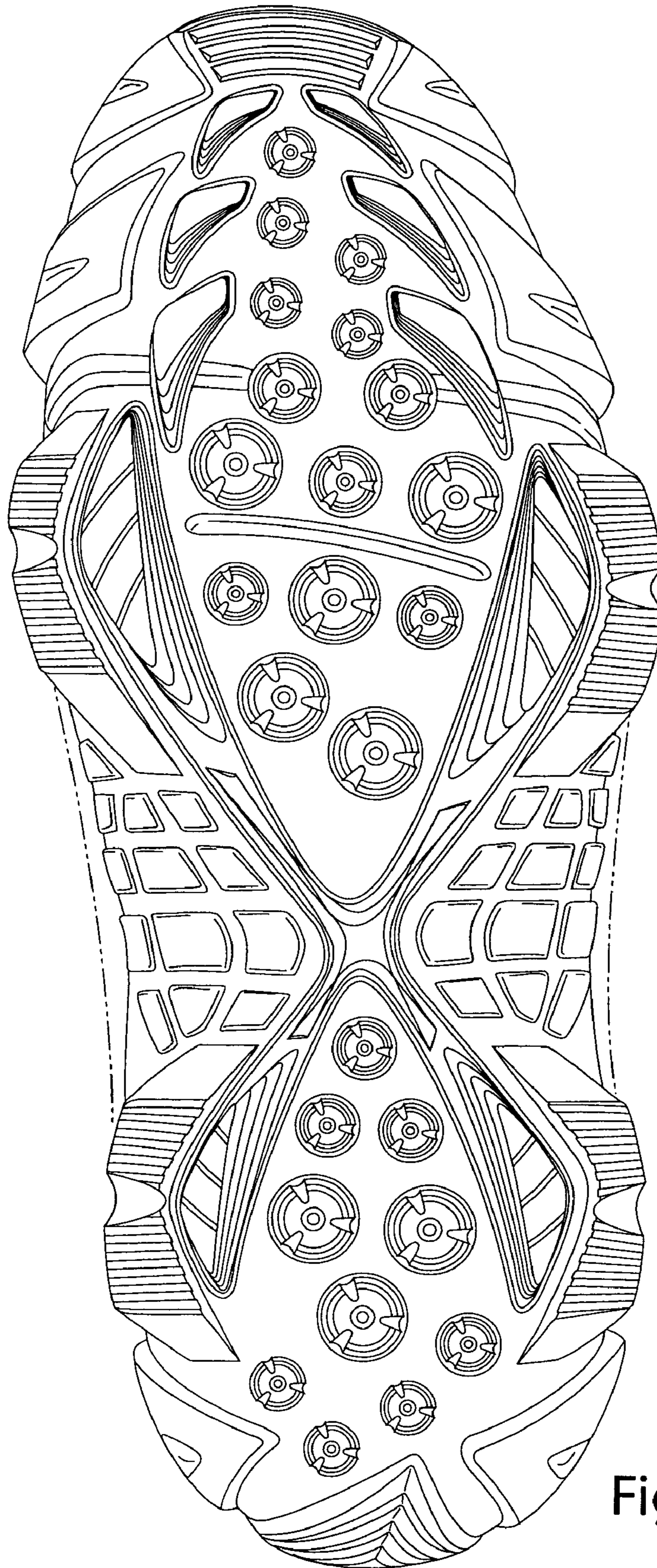

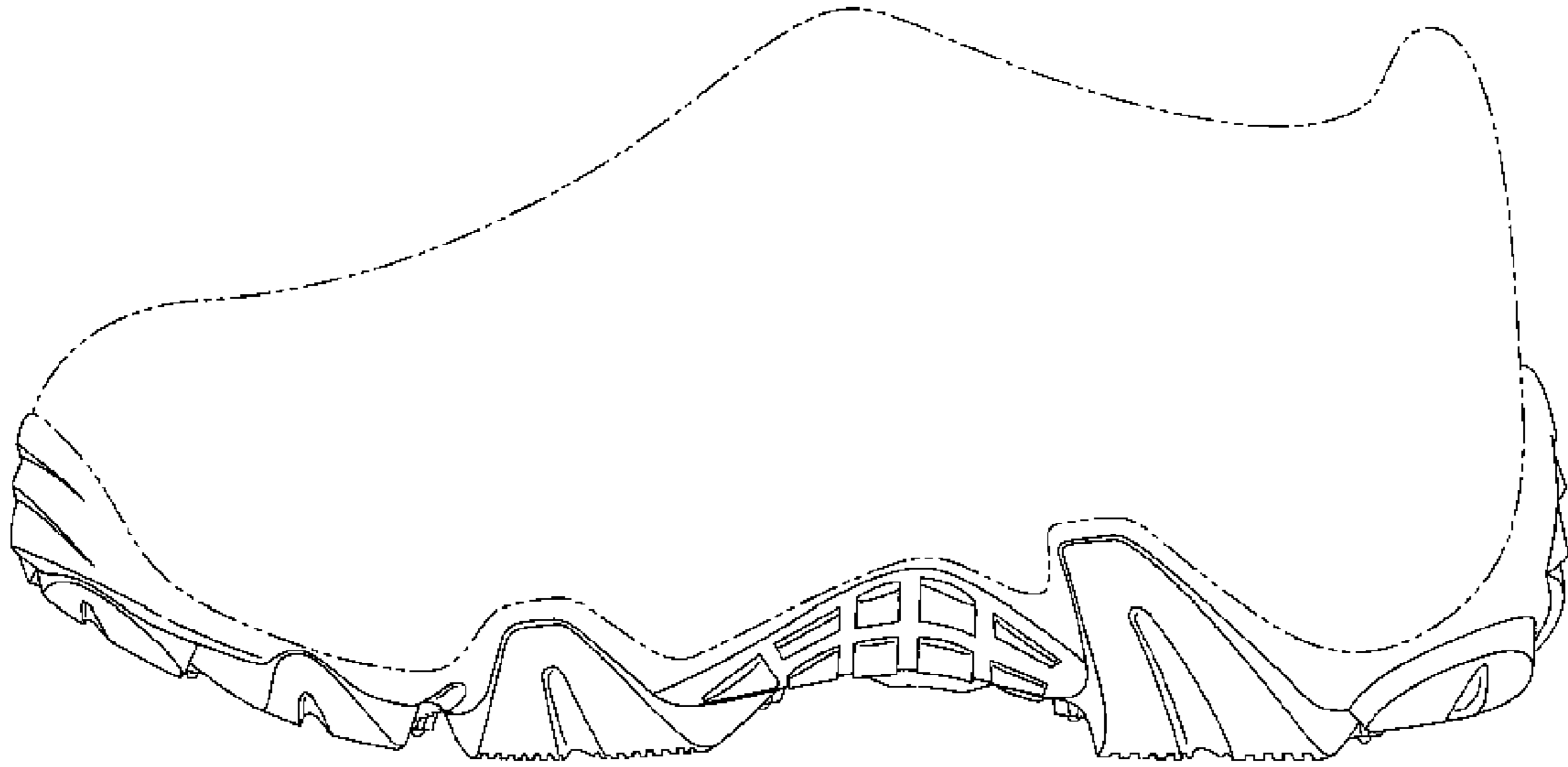

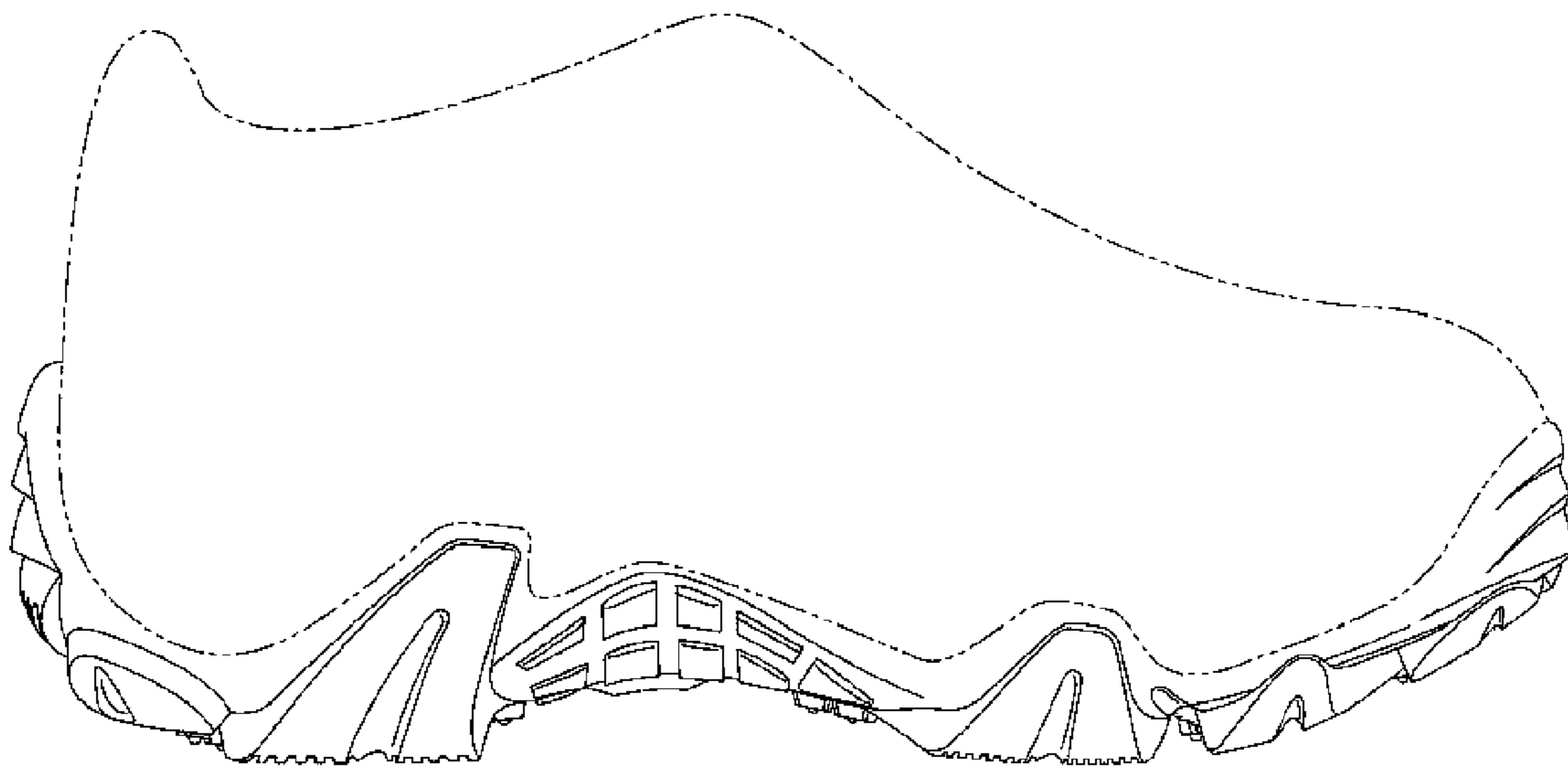

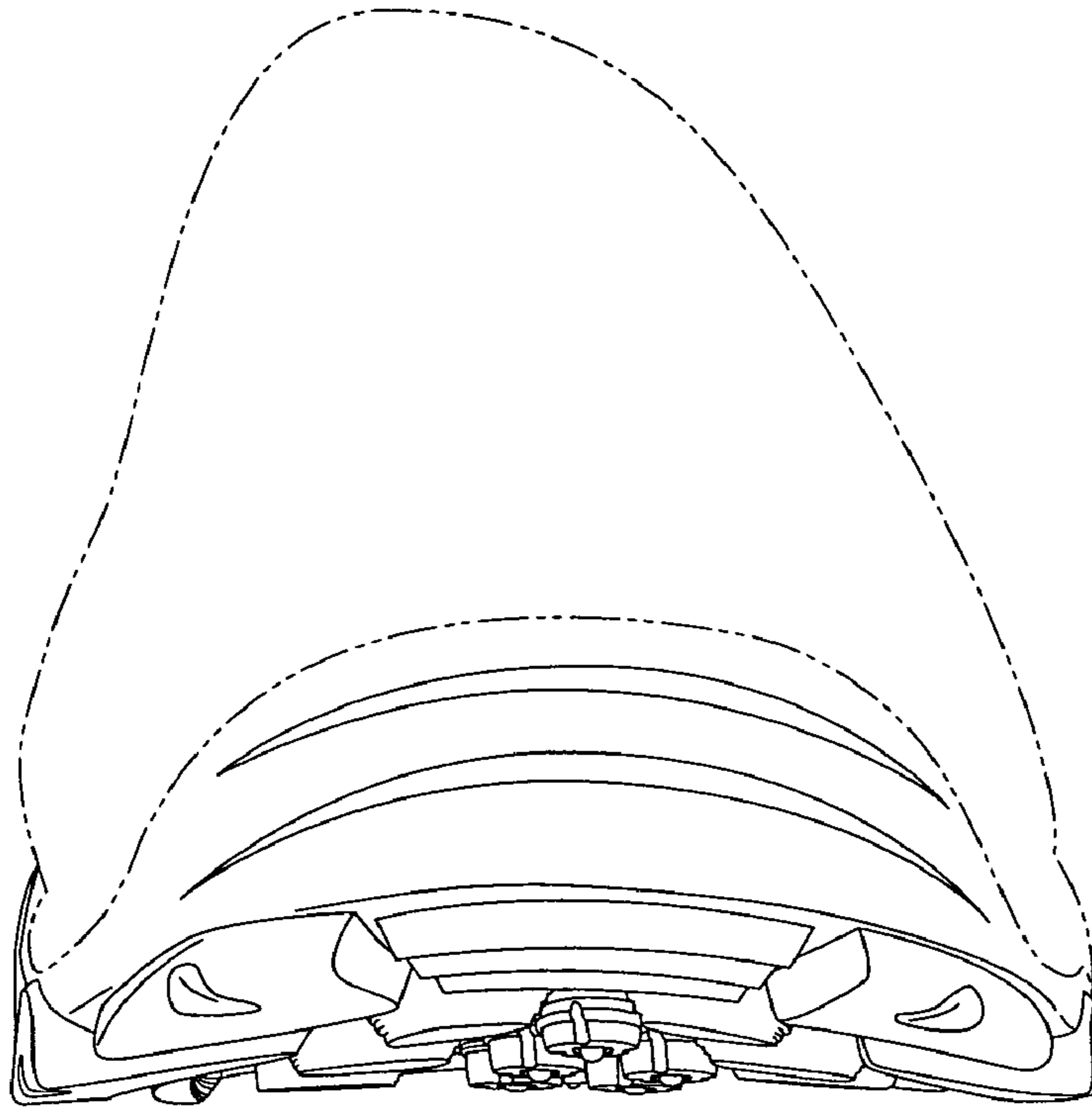

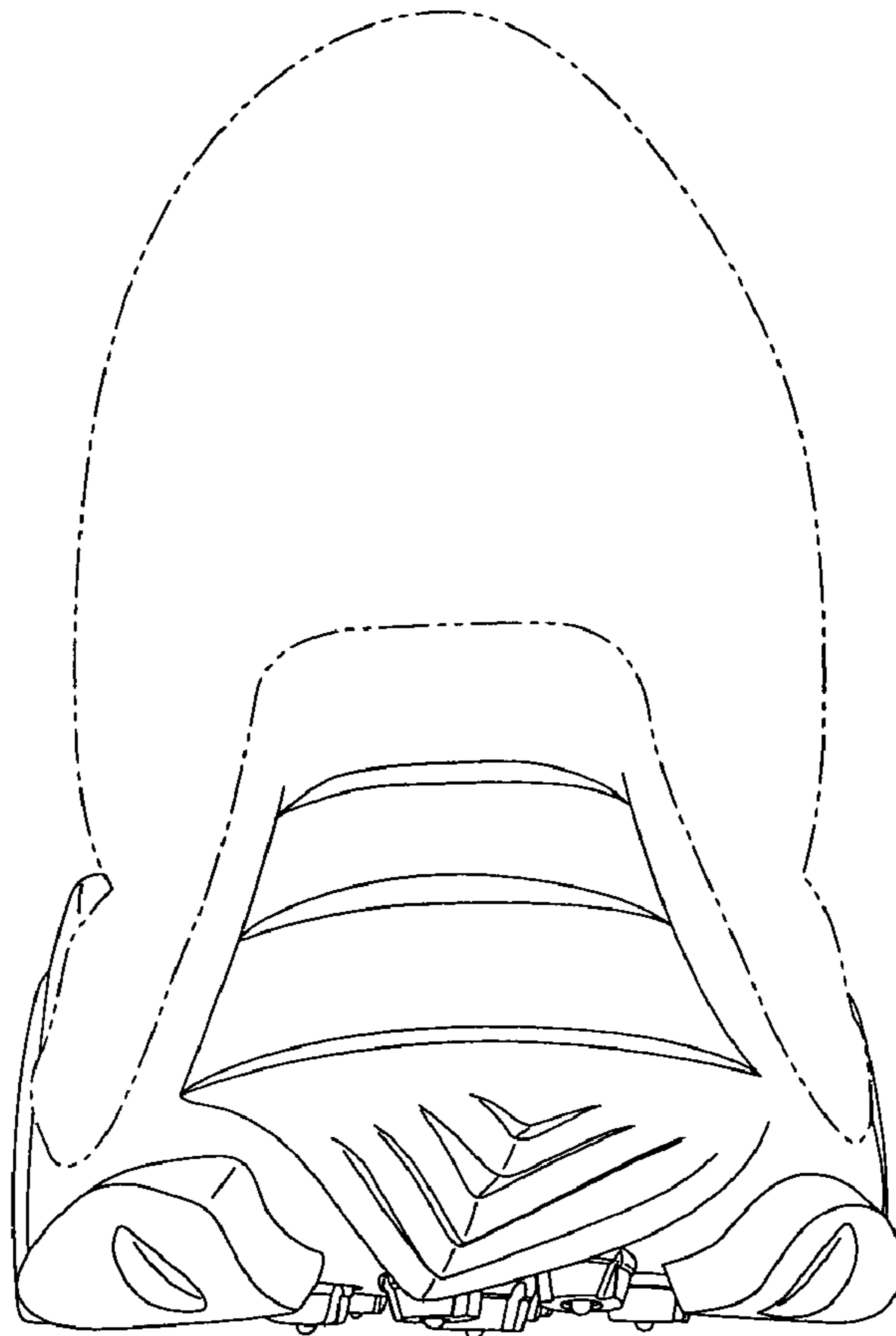
