(57) **CLAIM**

I claim the ornamental design for an article of footwear, as
shown and described.

DESCRIPTION

FIG. 1 is a front and side perspective view of an article of
footwear, showing my new design; and,

FIG. 2 is a side elevation view thereof.

The broken line showing in the drawing figures of the sole
of the article of footwear, and of other features and contour
of the article of footwear, is for illustrative purposes only
and forms no part of the claimed design.

Any surface of the article of footwear not shown, or any part
of any such surface not shown, is not part of the claimed
design.

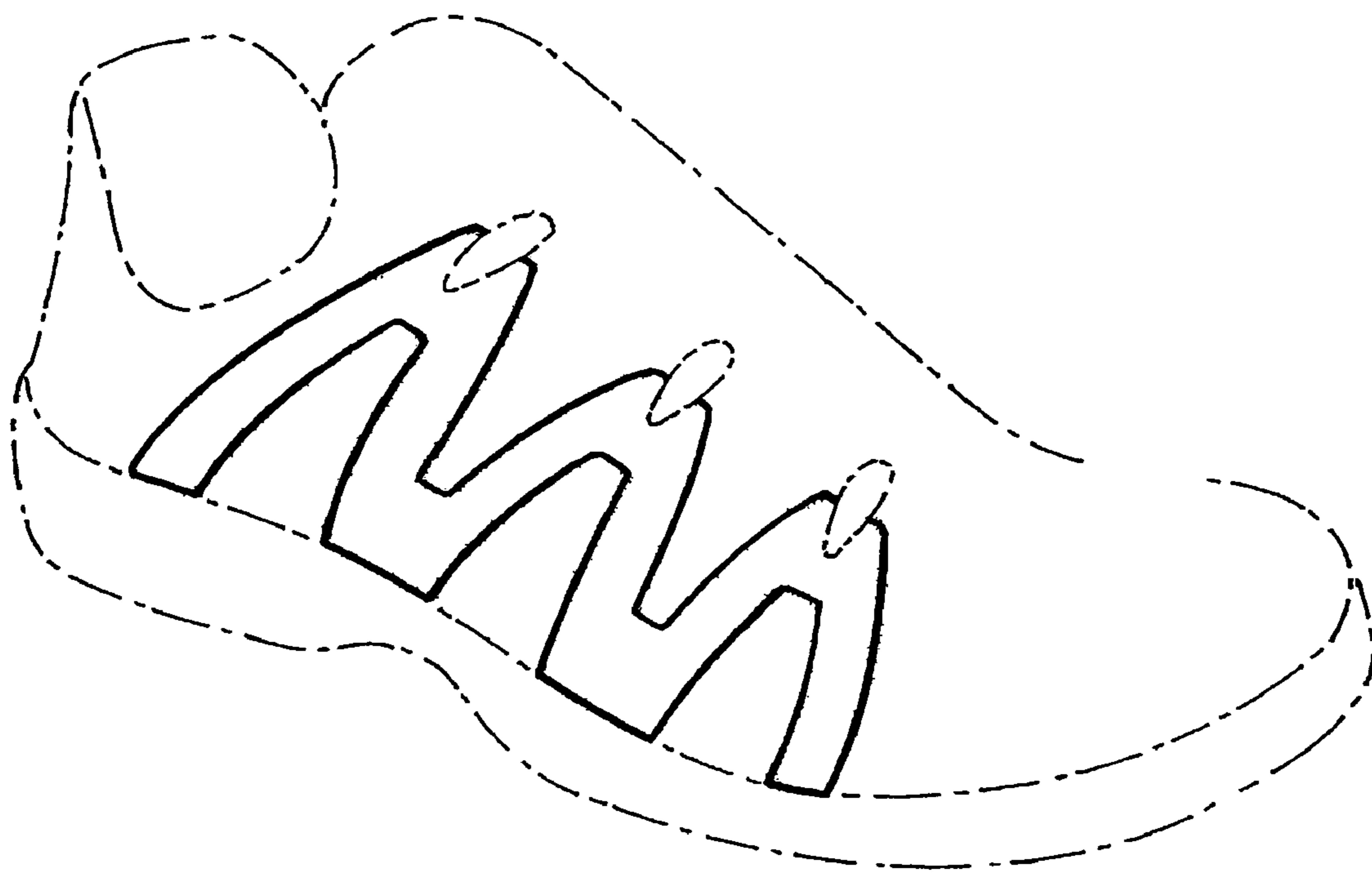
