FIG. 4 is a front view thereof;

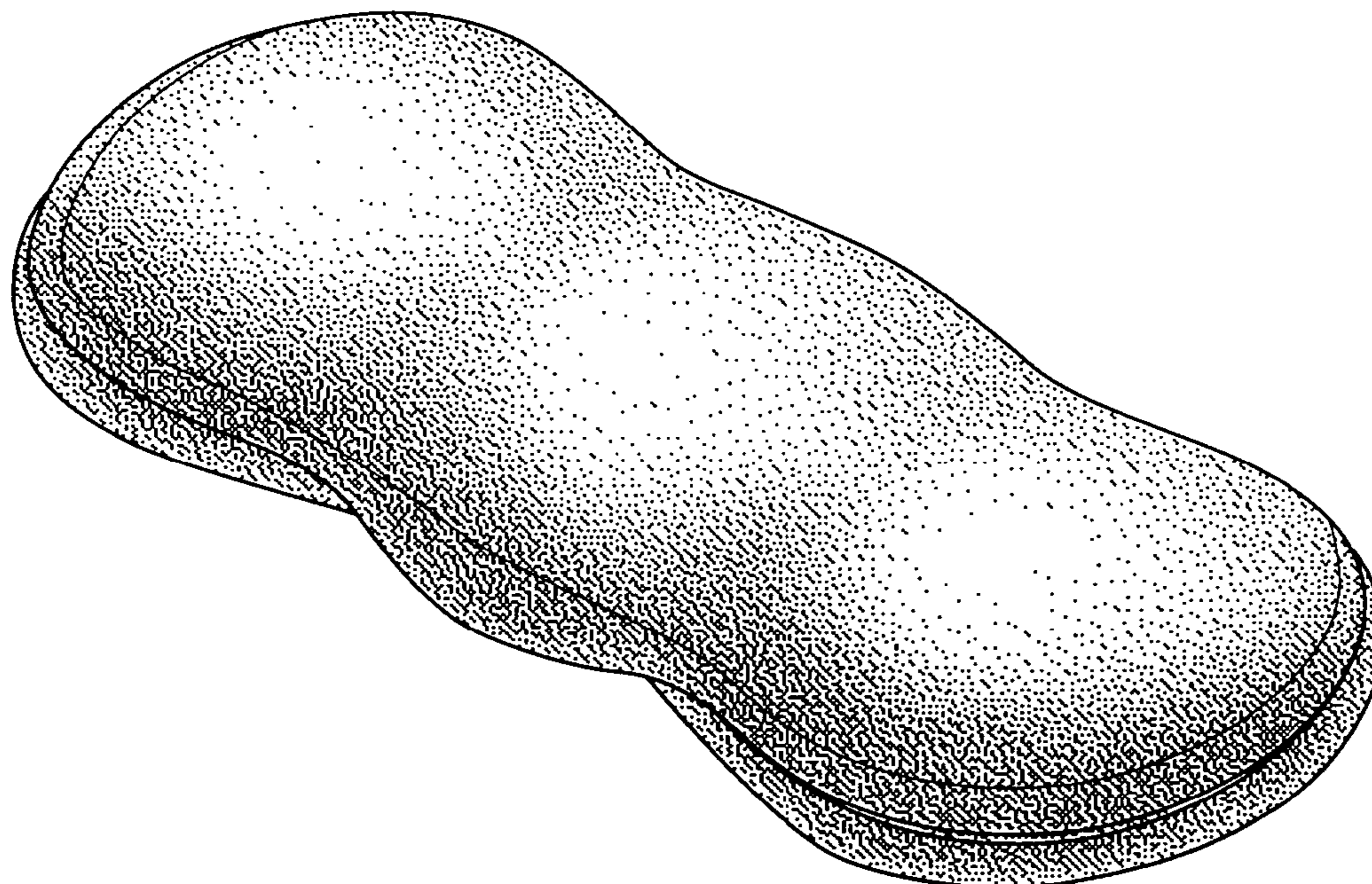
FIG. 5 is a rear view thereof;

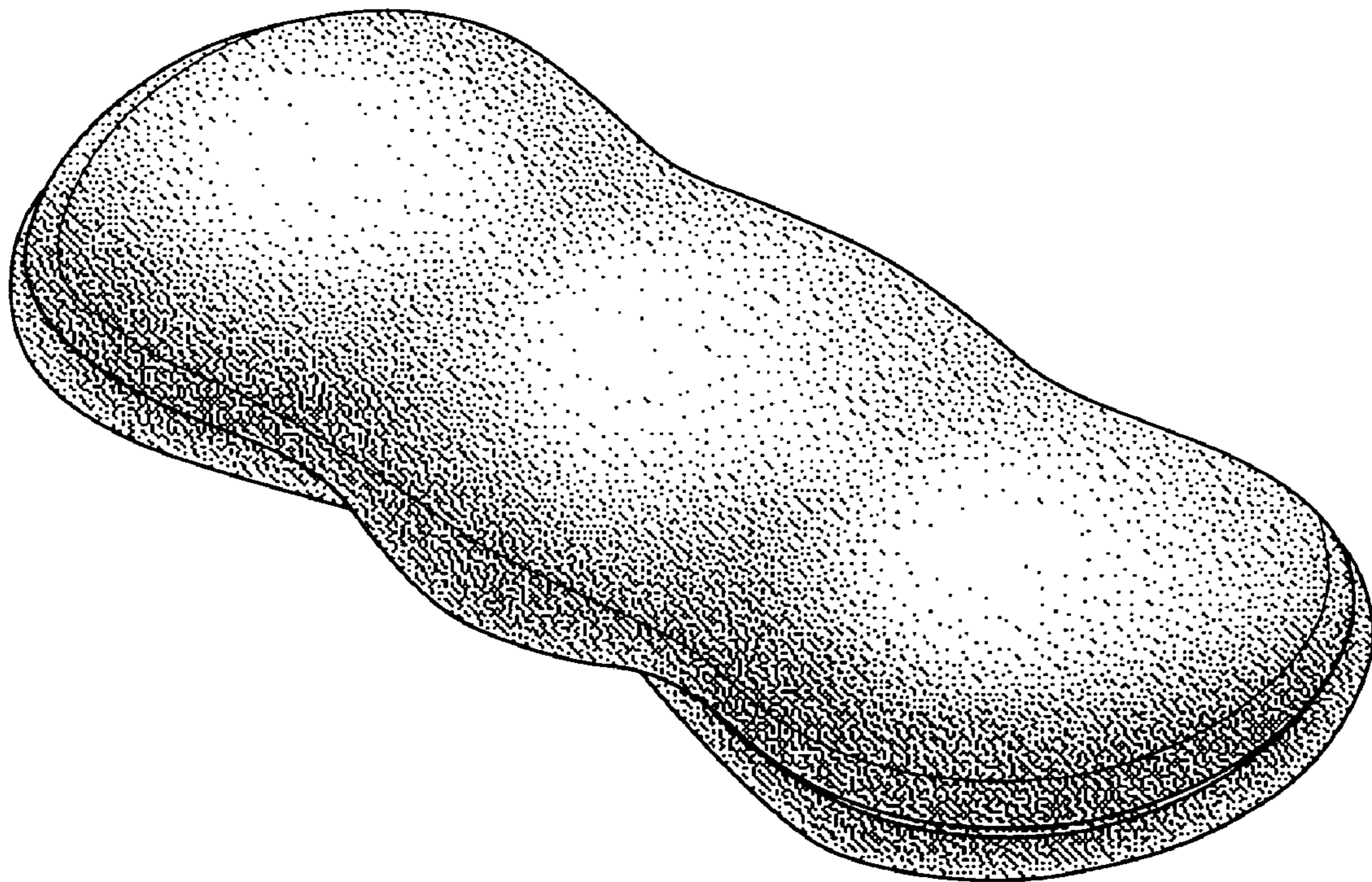
FIG. 6 is a left-side view thereof;

FIG. 7 is a right-side view thereof; and,

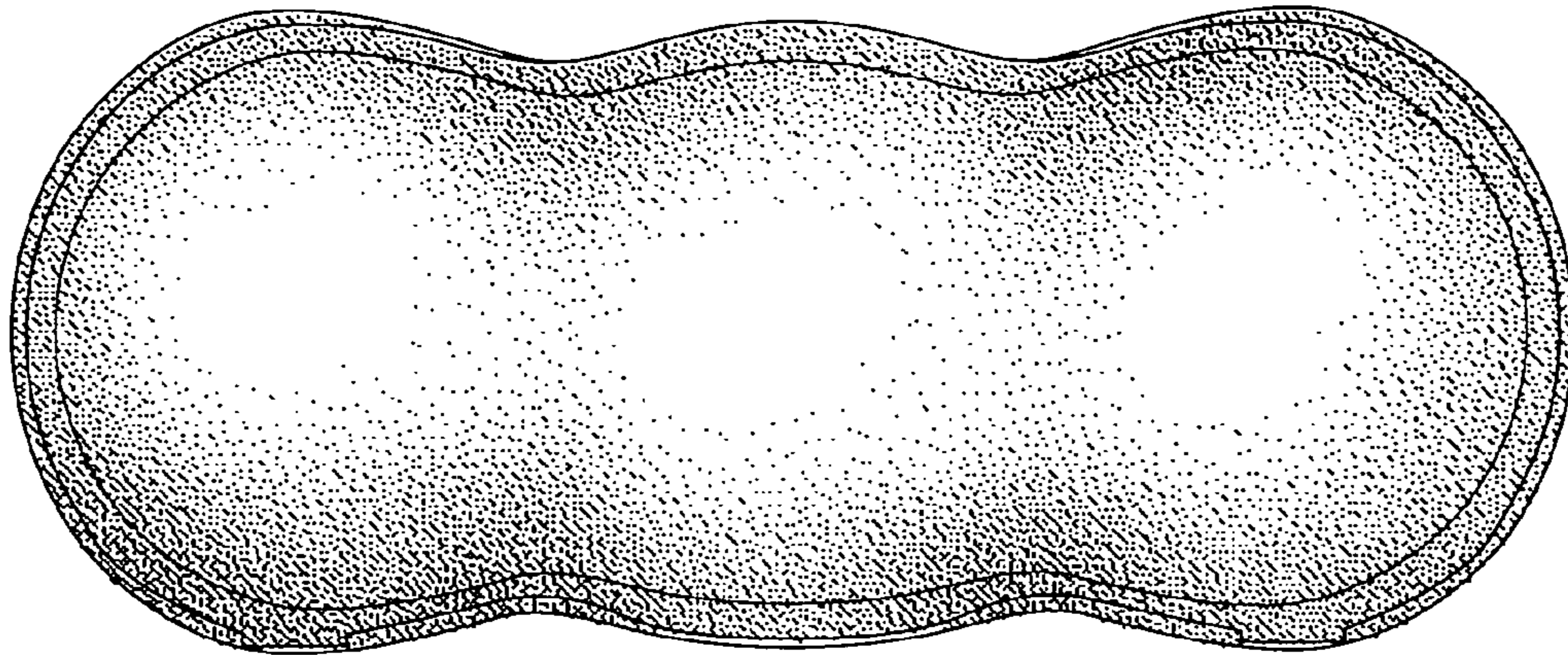
FIG. 8 is a right-front perspective view of a pill case of our new design in a partially closed configuration.

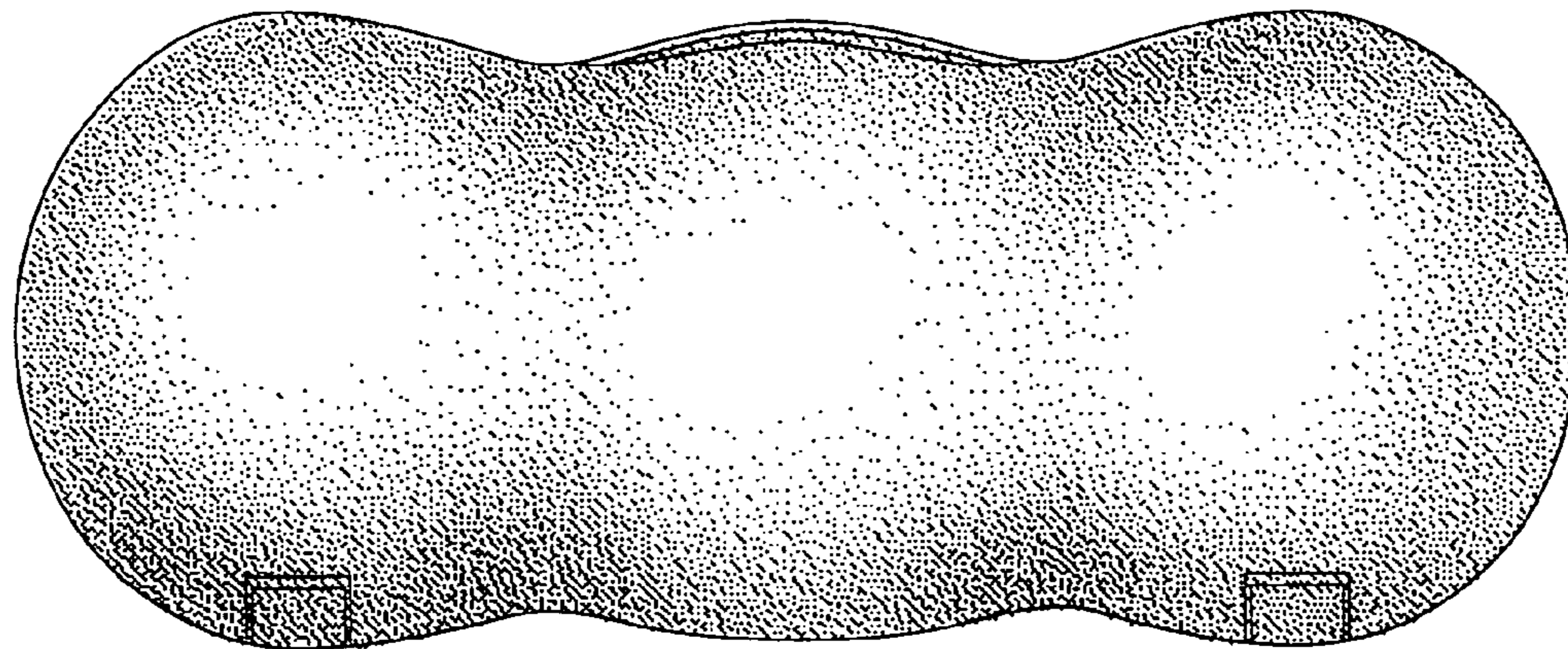




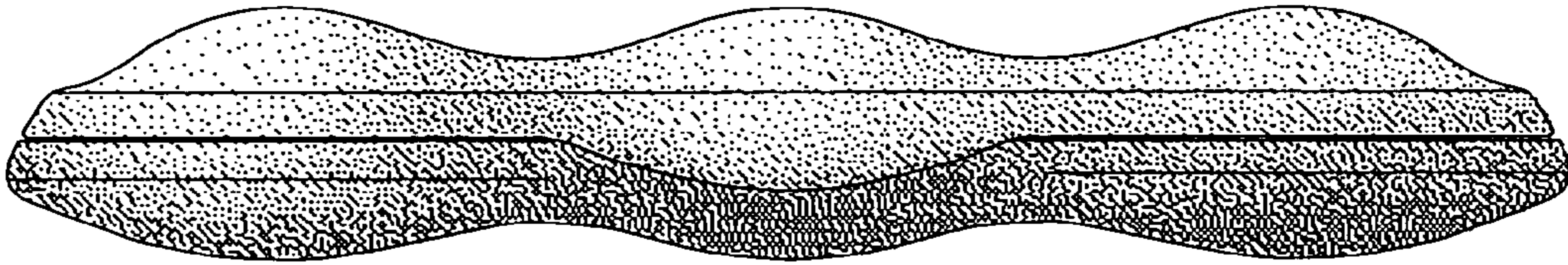

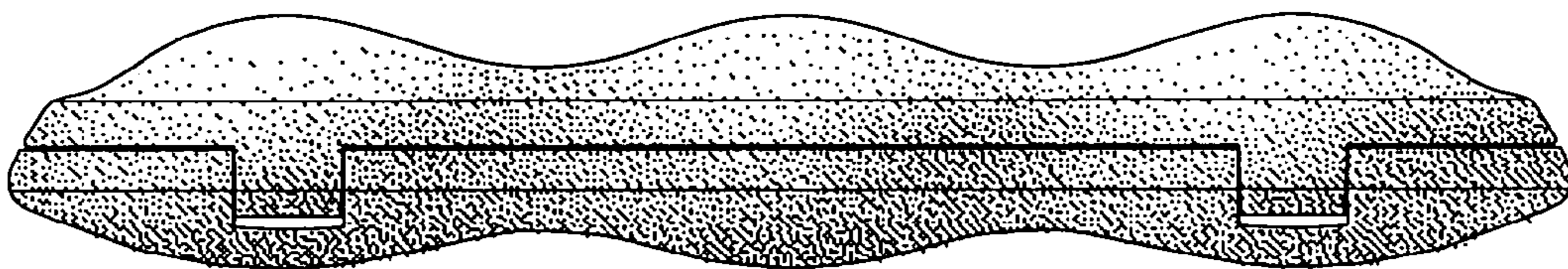

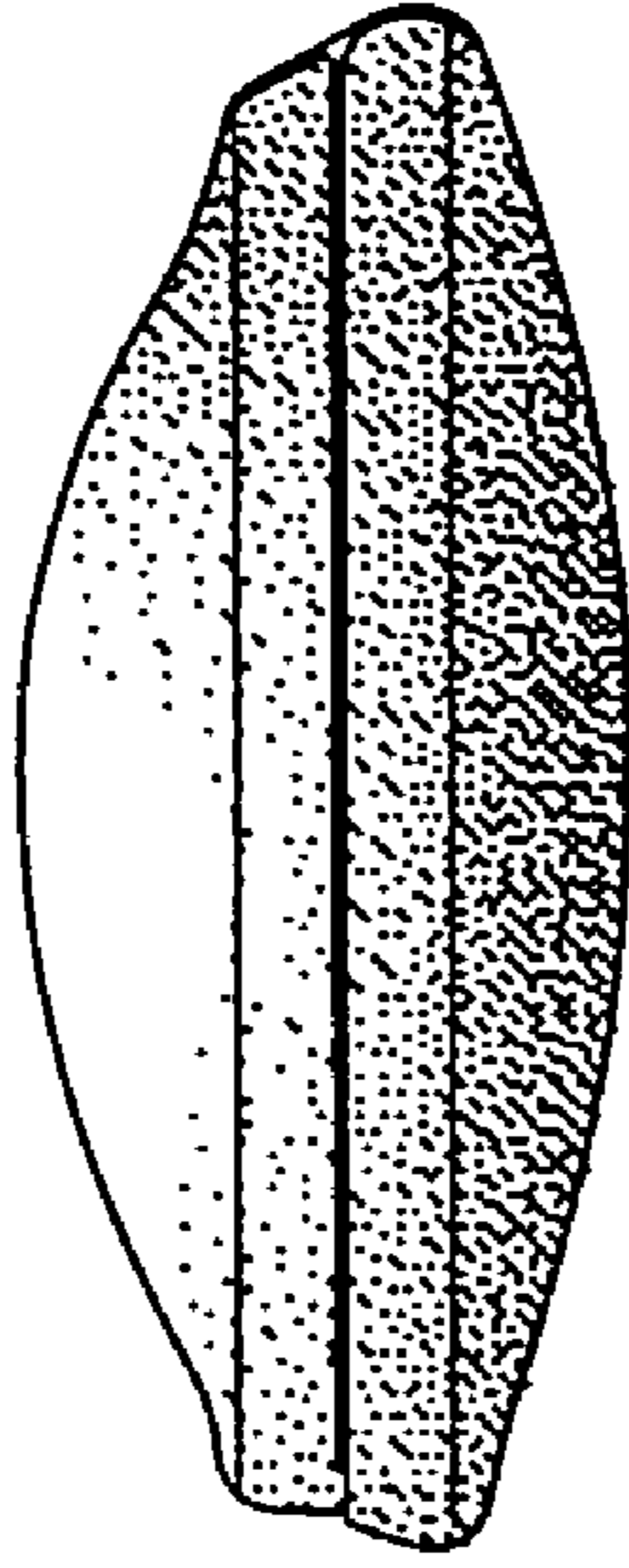

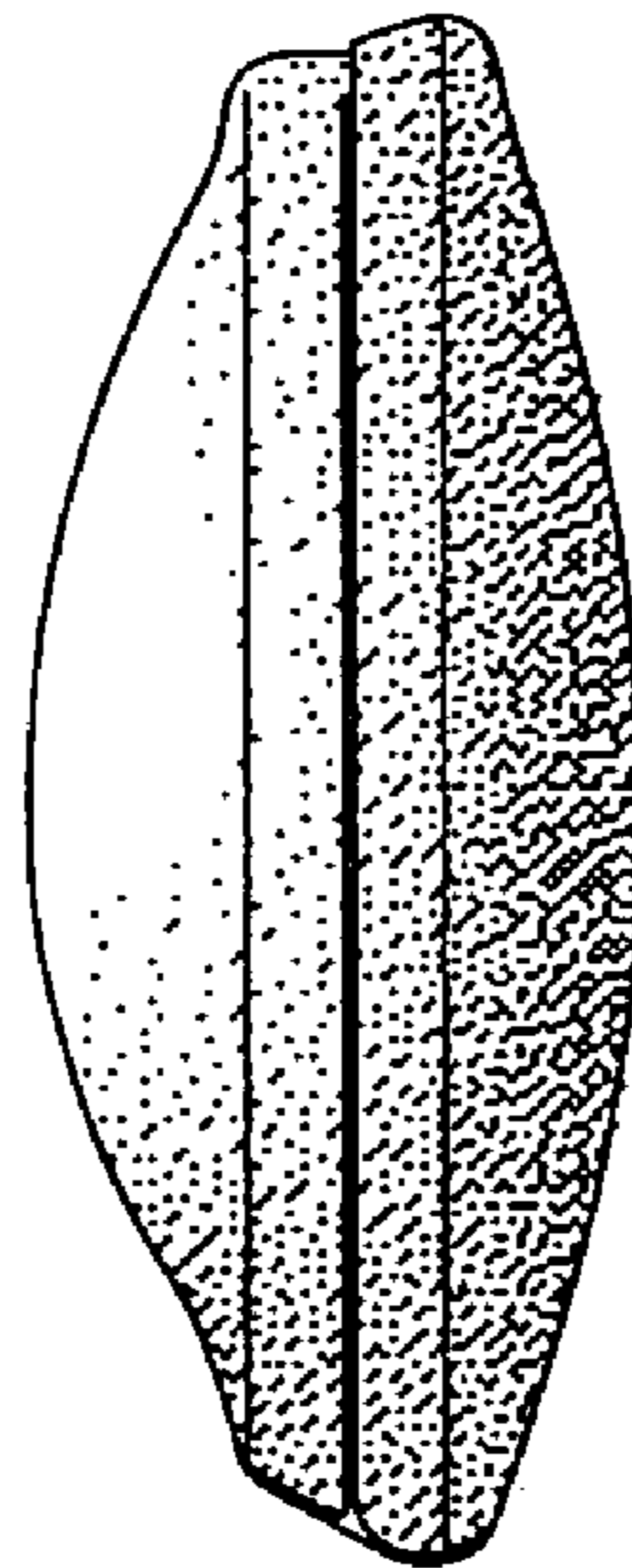

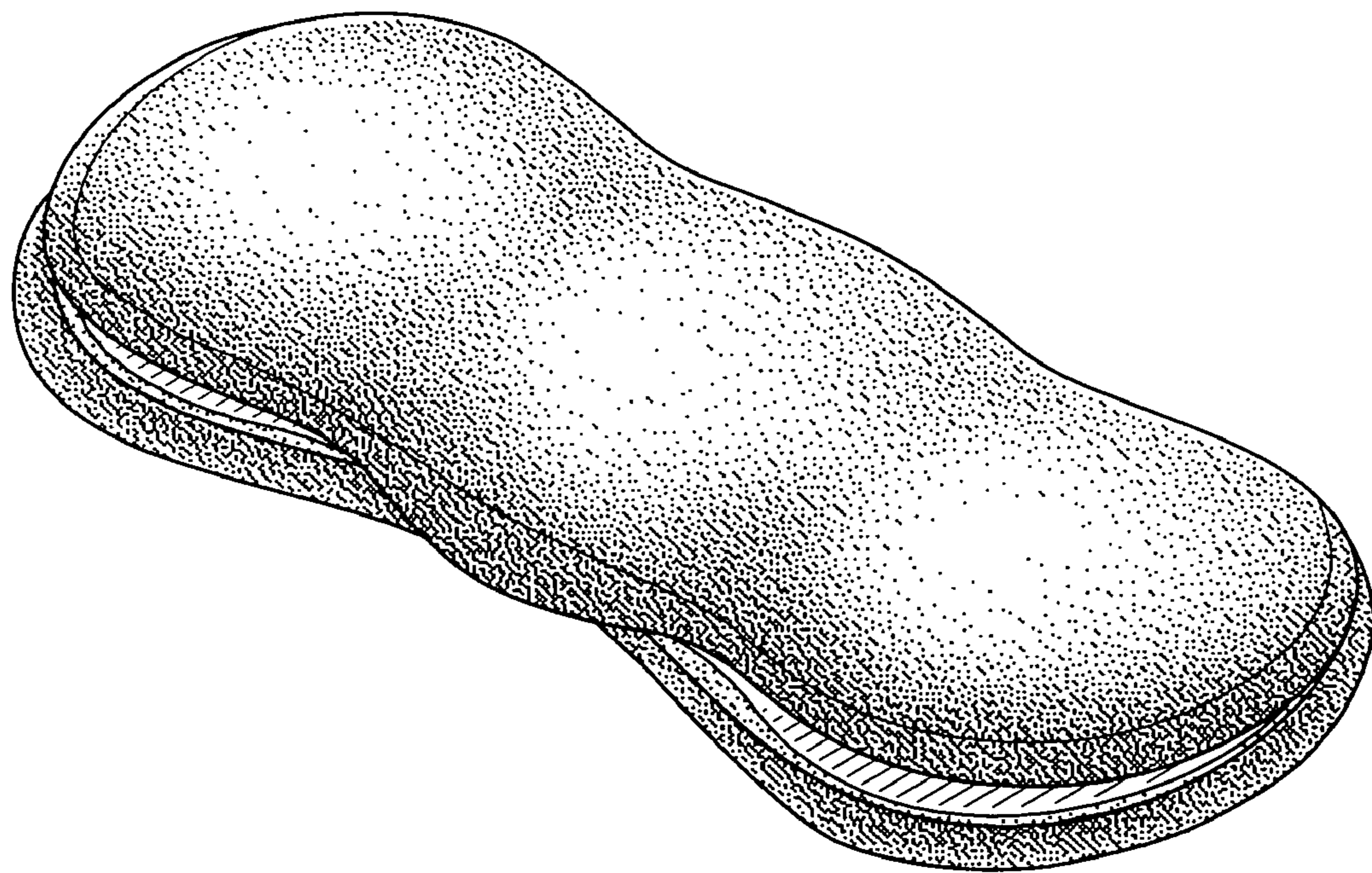
