FIG. 5 is a top plan view of the dispenser unit of the dispenser/receptacle system;

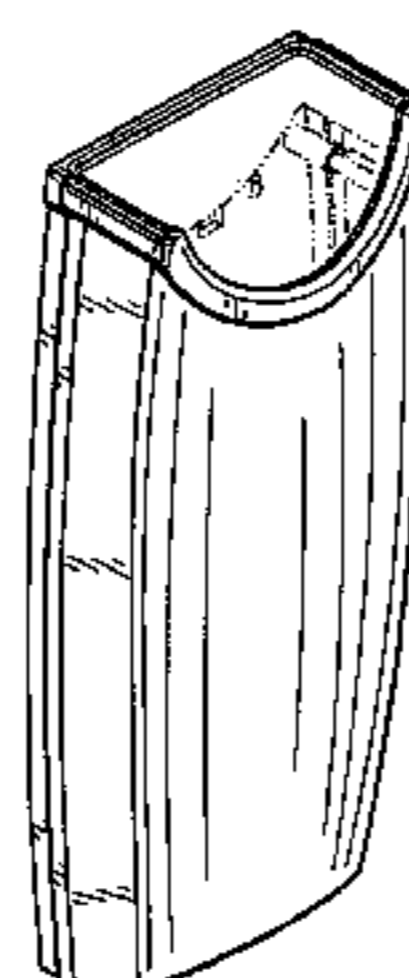
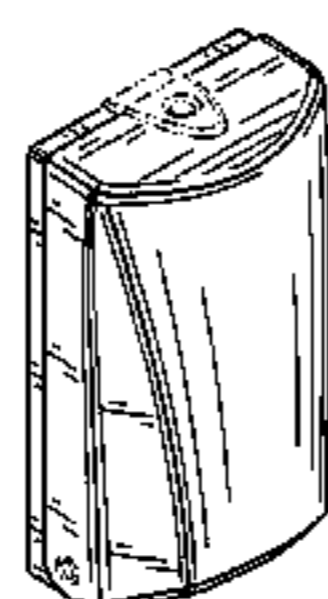
FIG. 6 is a bottom plan view of the dispenser unit of the dispenser/receptacle system;

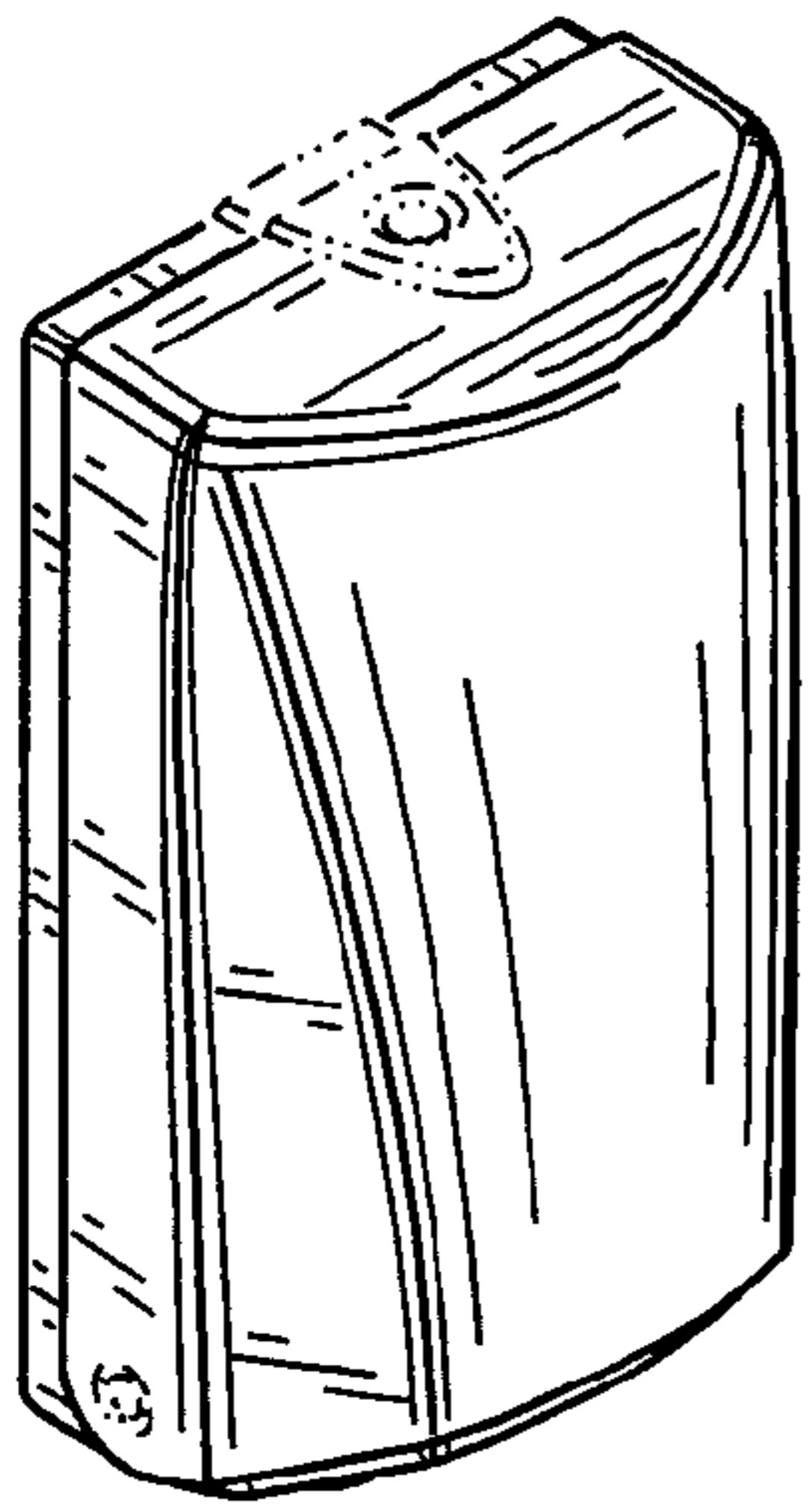

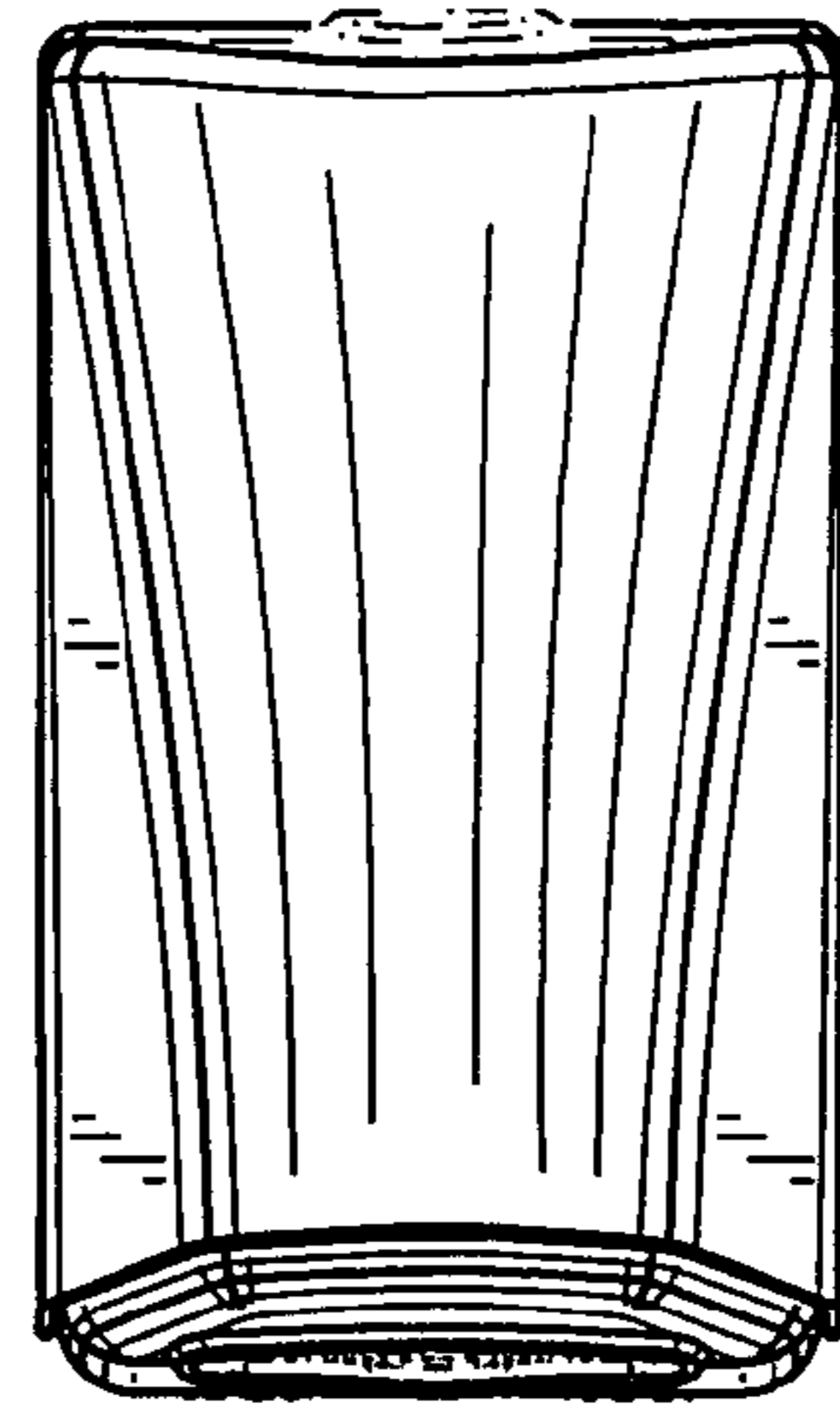
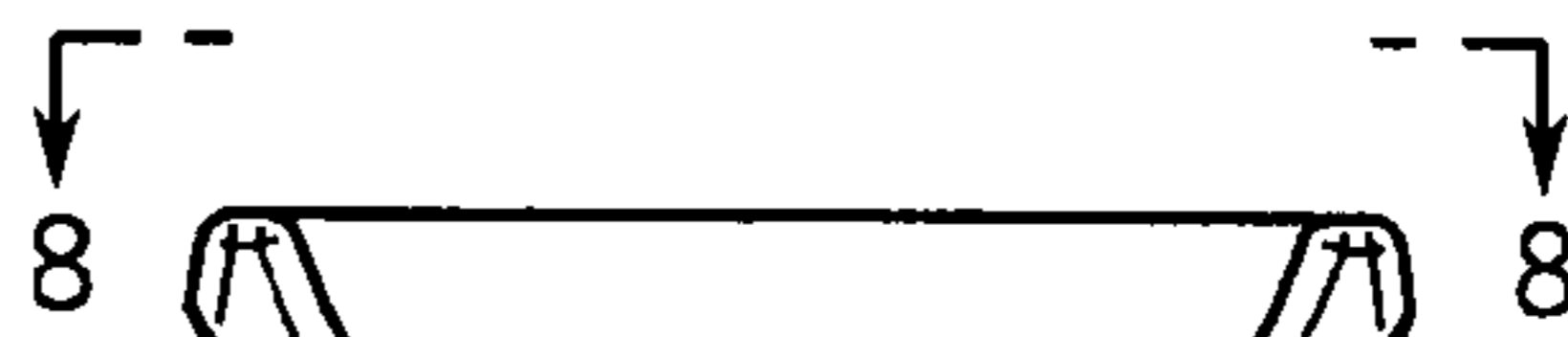
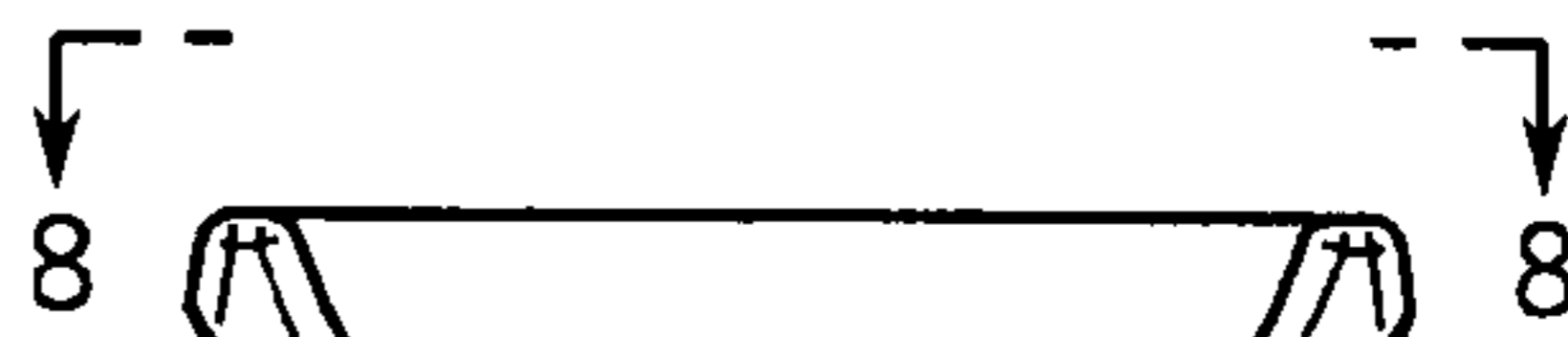
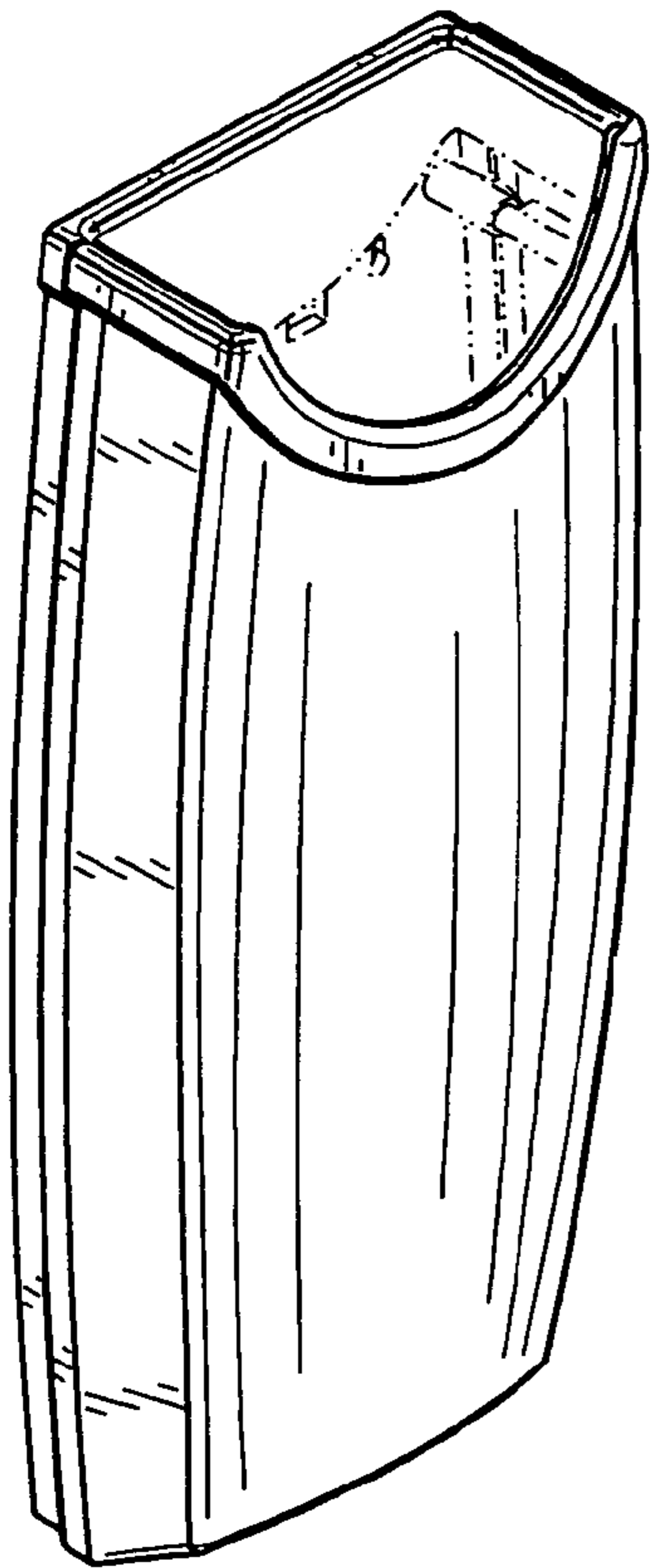

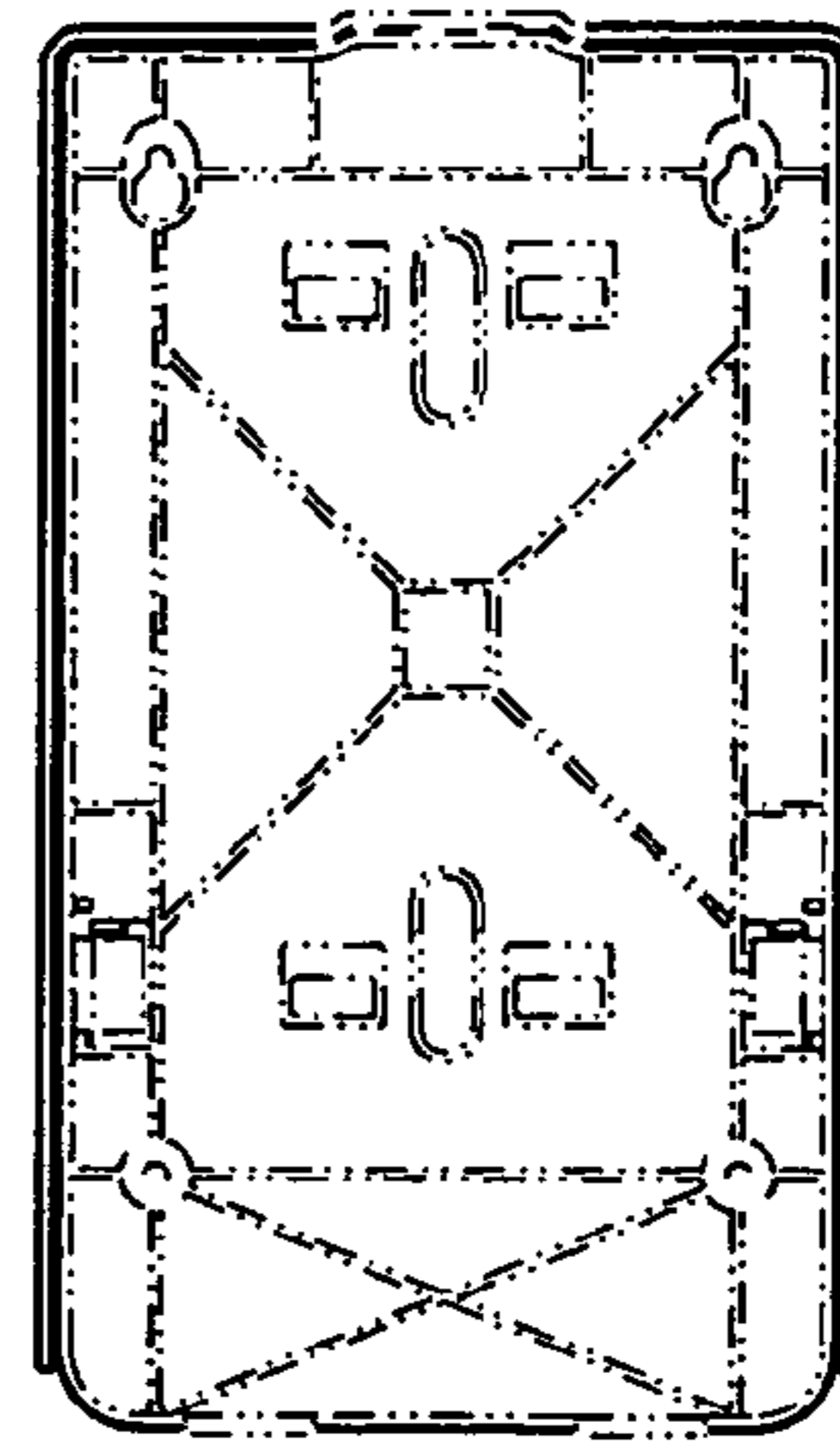
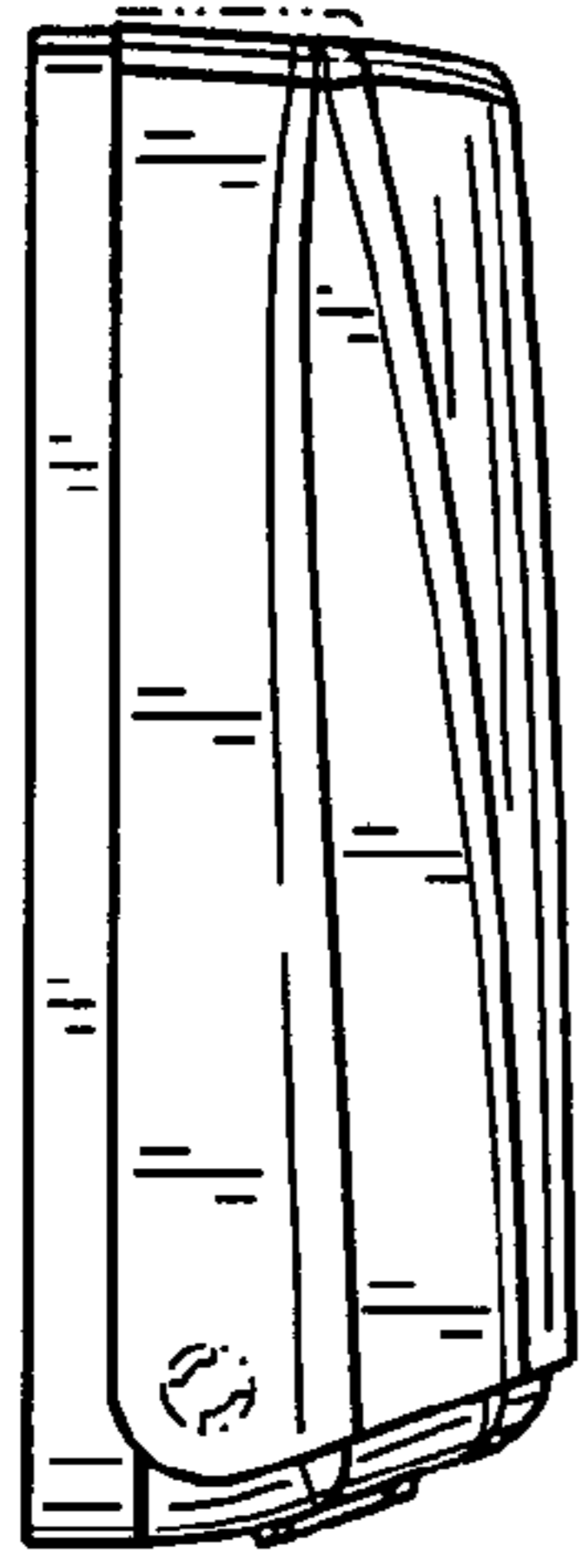

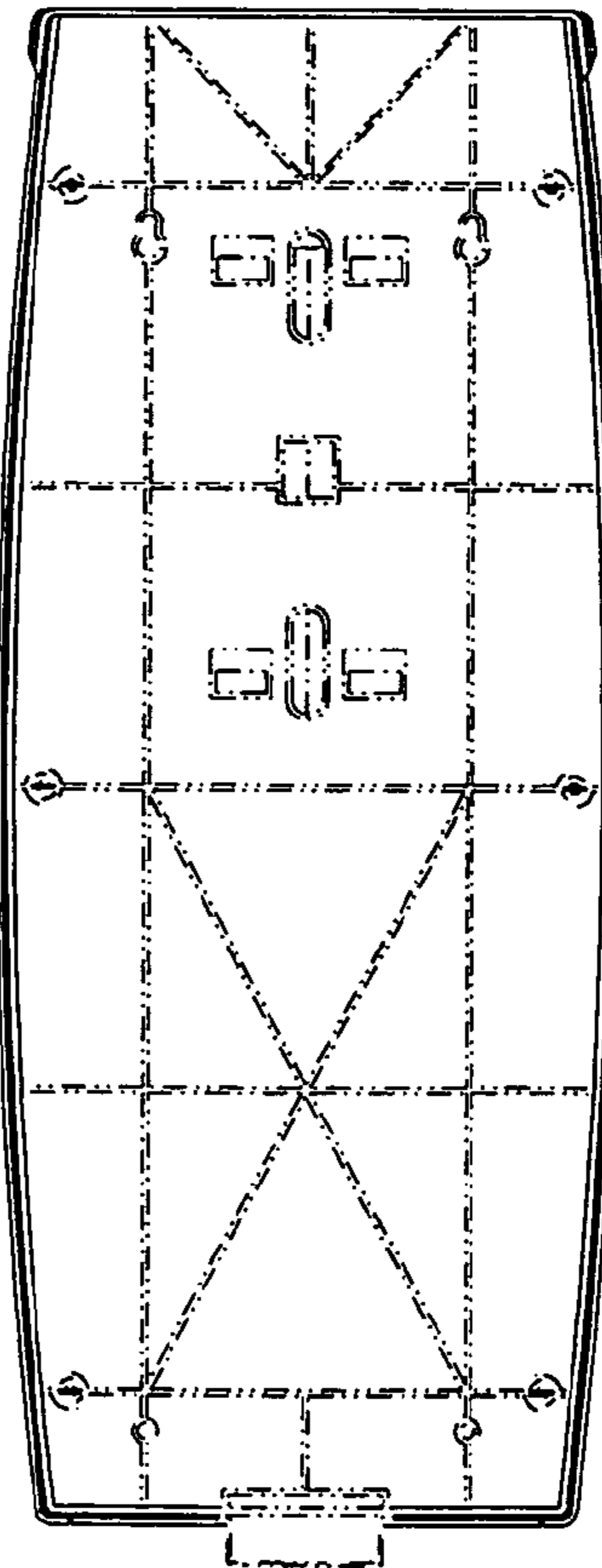
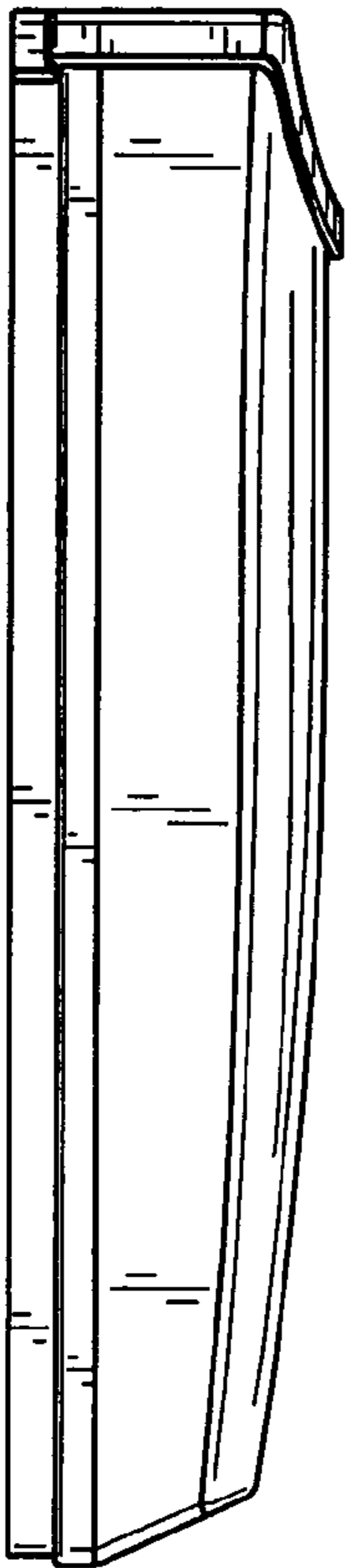

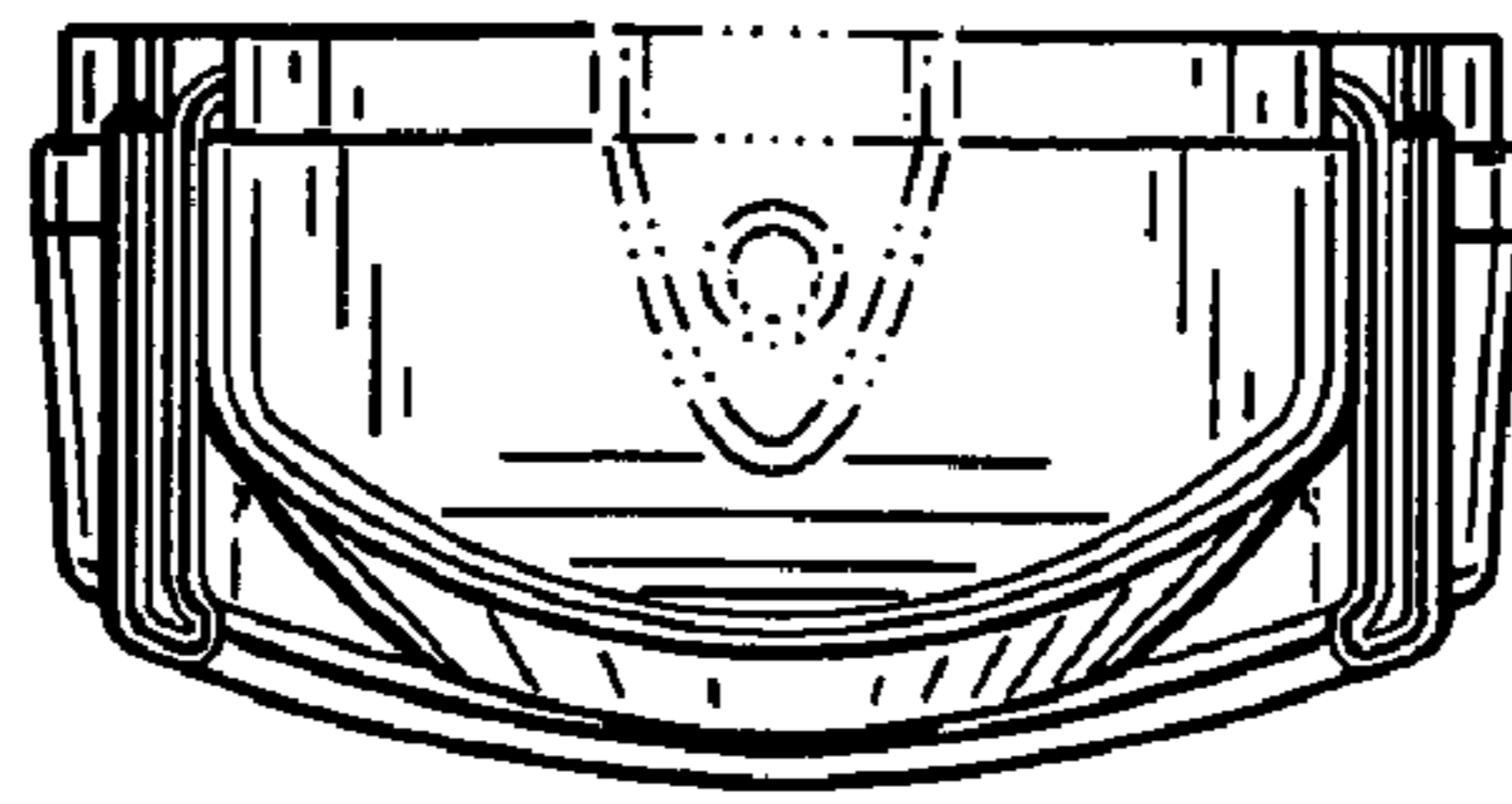

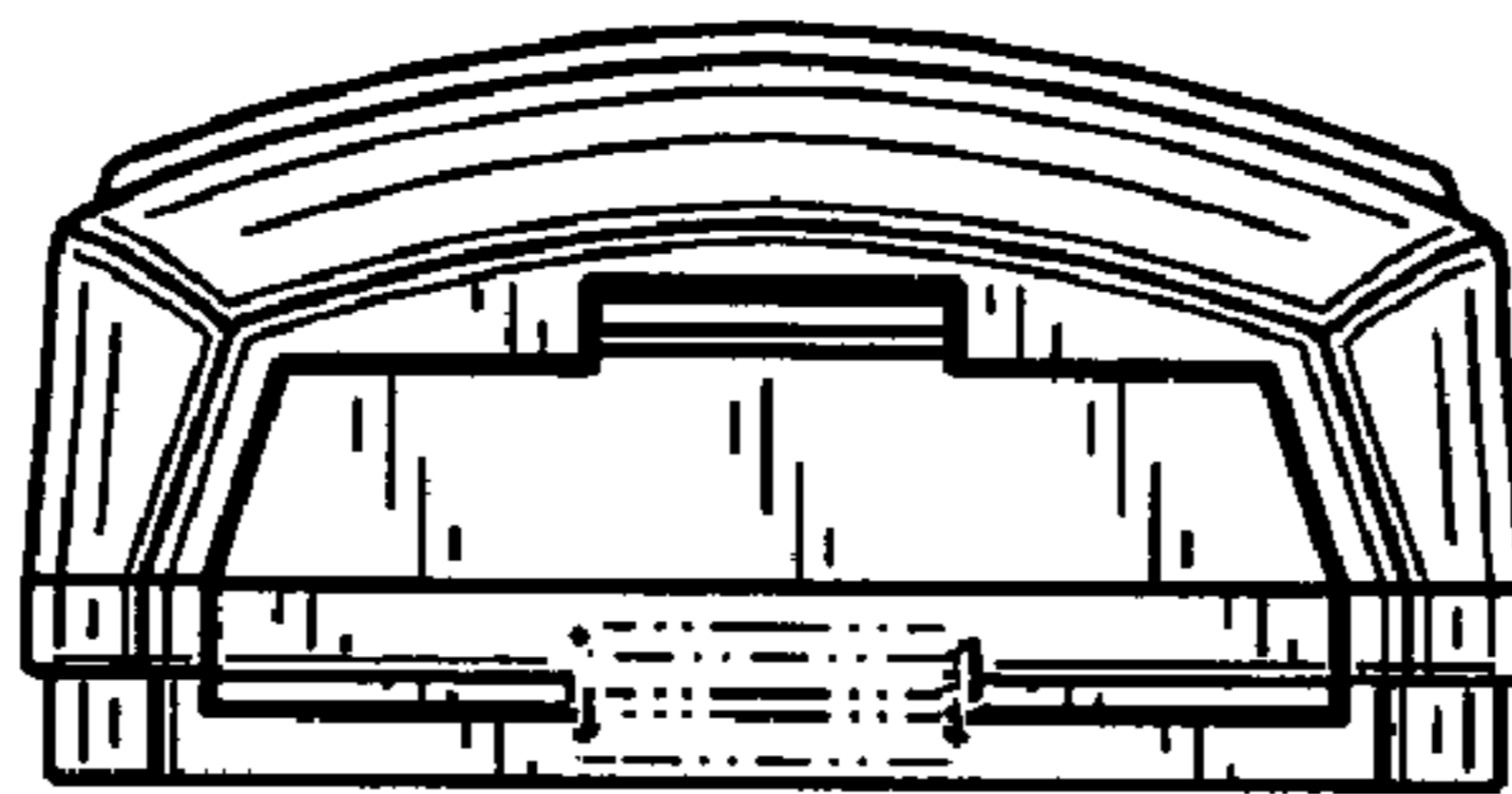

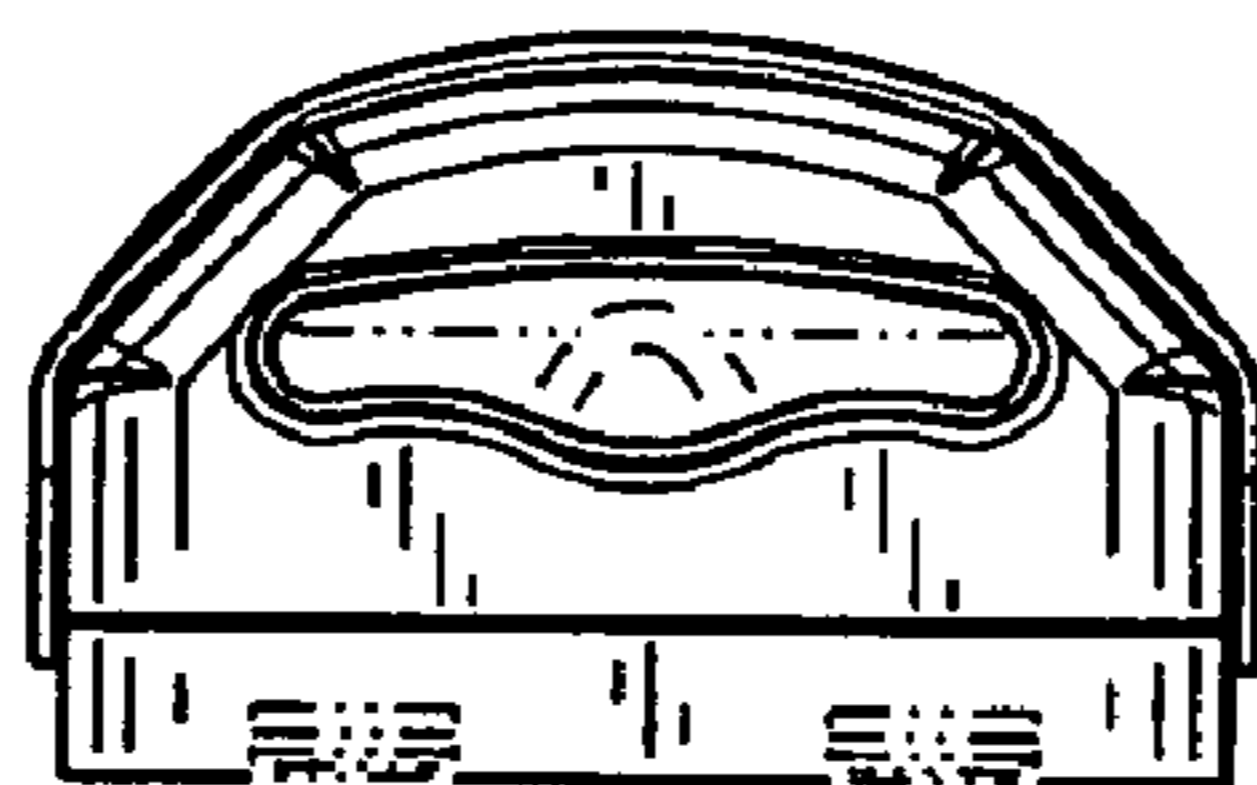

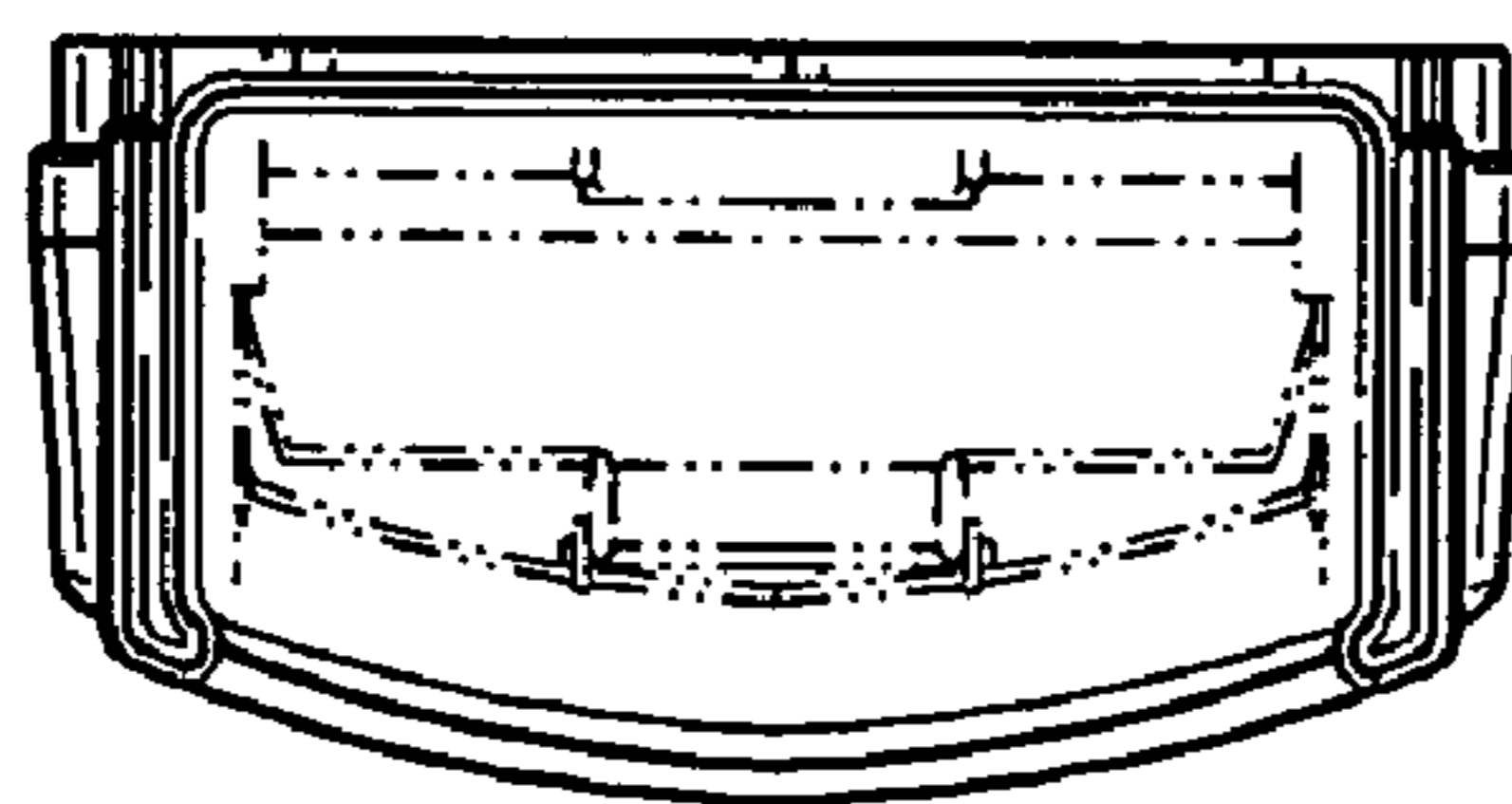
