The ornamental design for a beverage dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a beverage dispenser showing my new design with the dispensing hose removed for ease of illustration;

FIG. 2 is a bottom plan view of the beverage dispenser illustrated in FIG. 1.

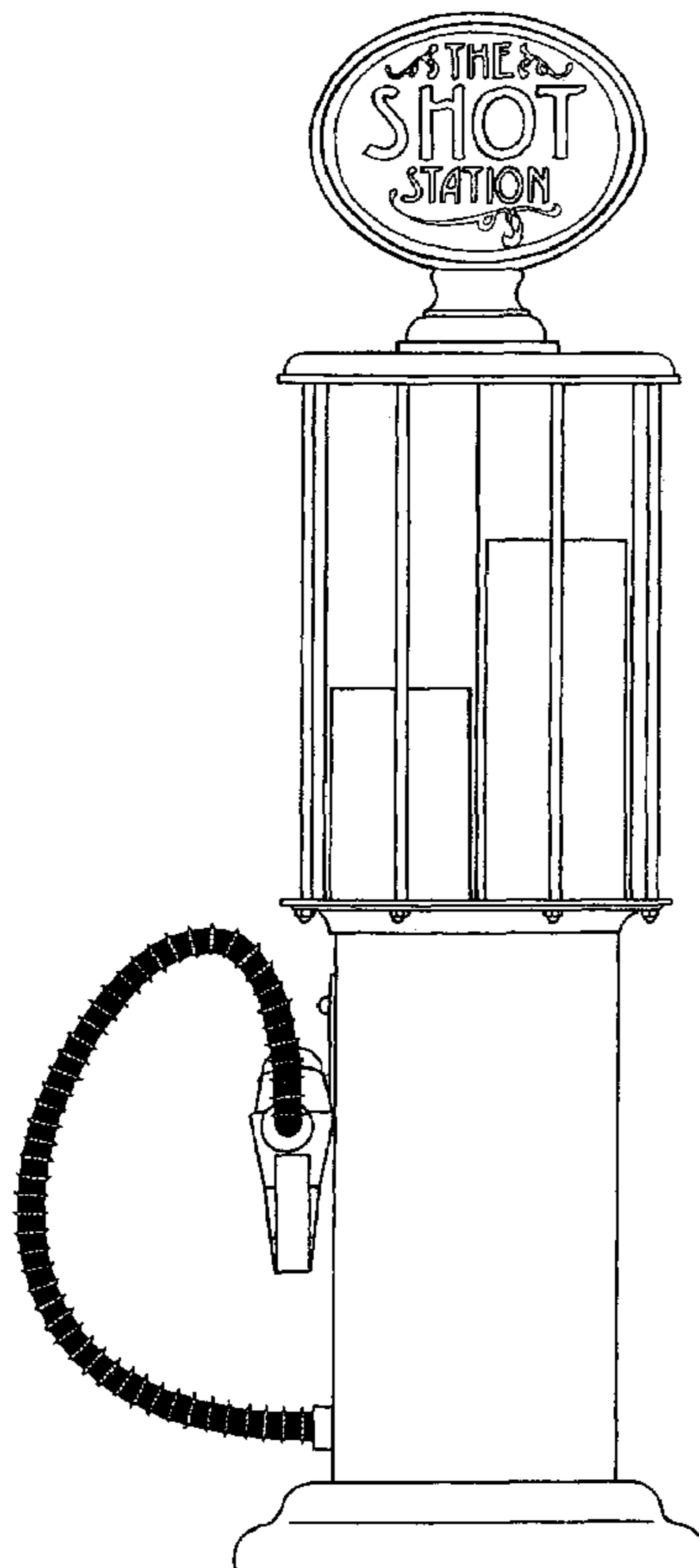
FIG. 3 is a rear view of the beverage dispenser illustrated in FIGS. 1 and 2, but with the dispensing hose attached.

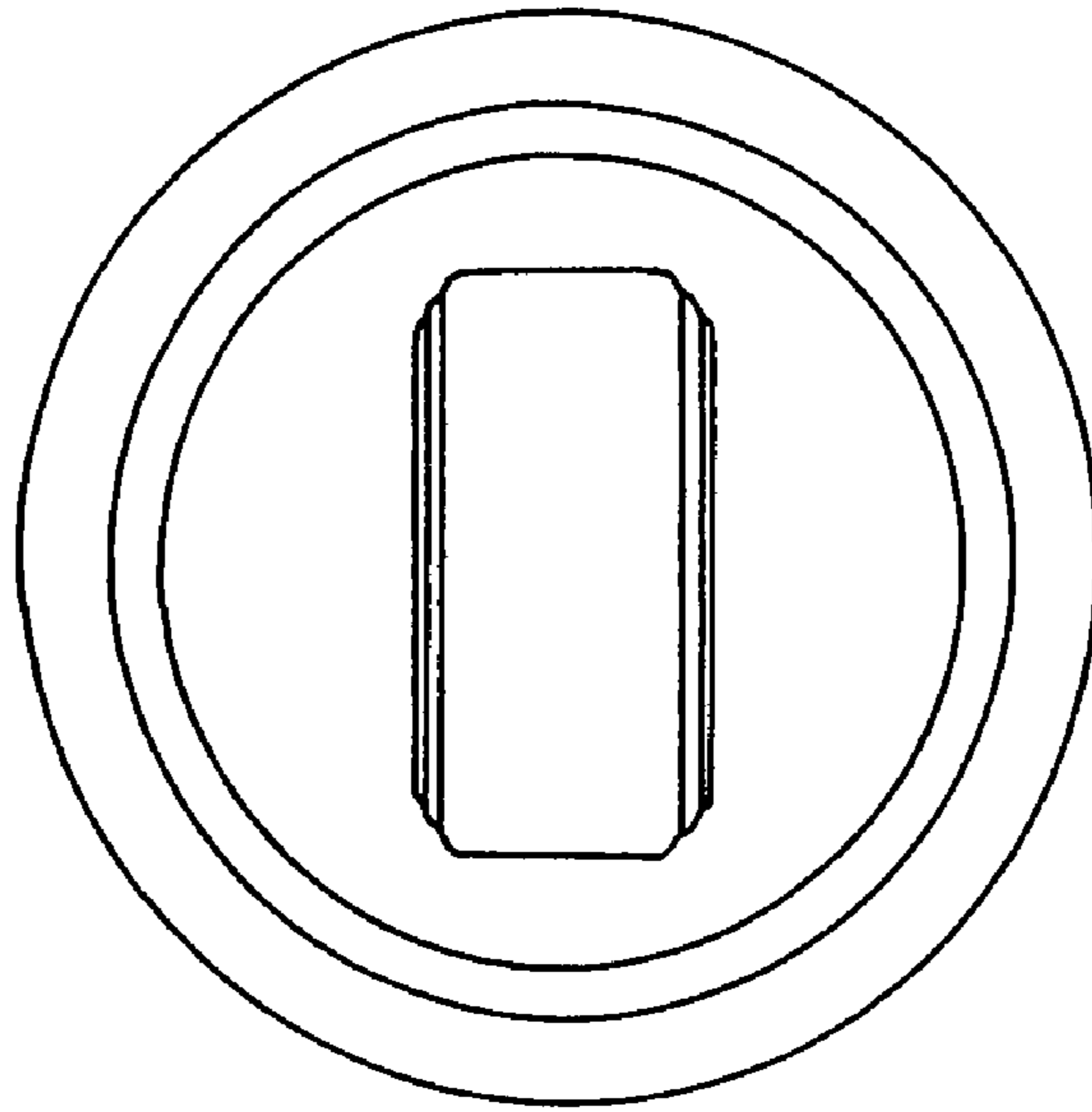

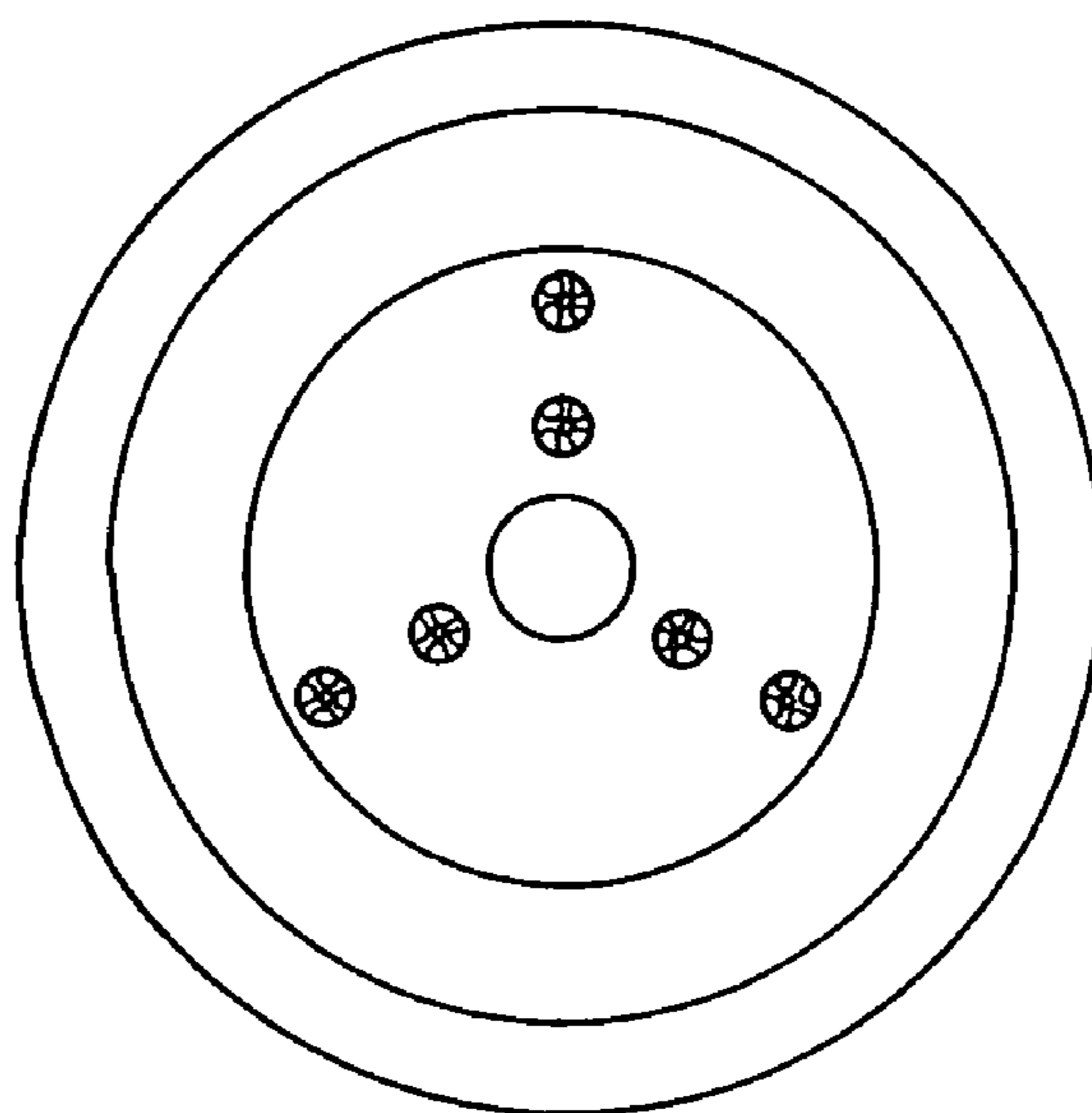

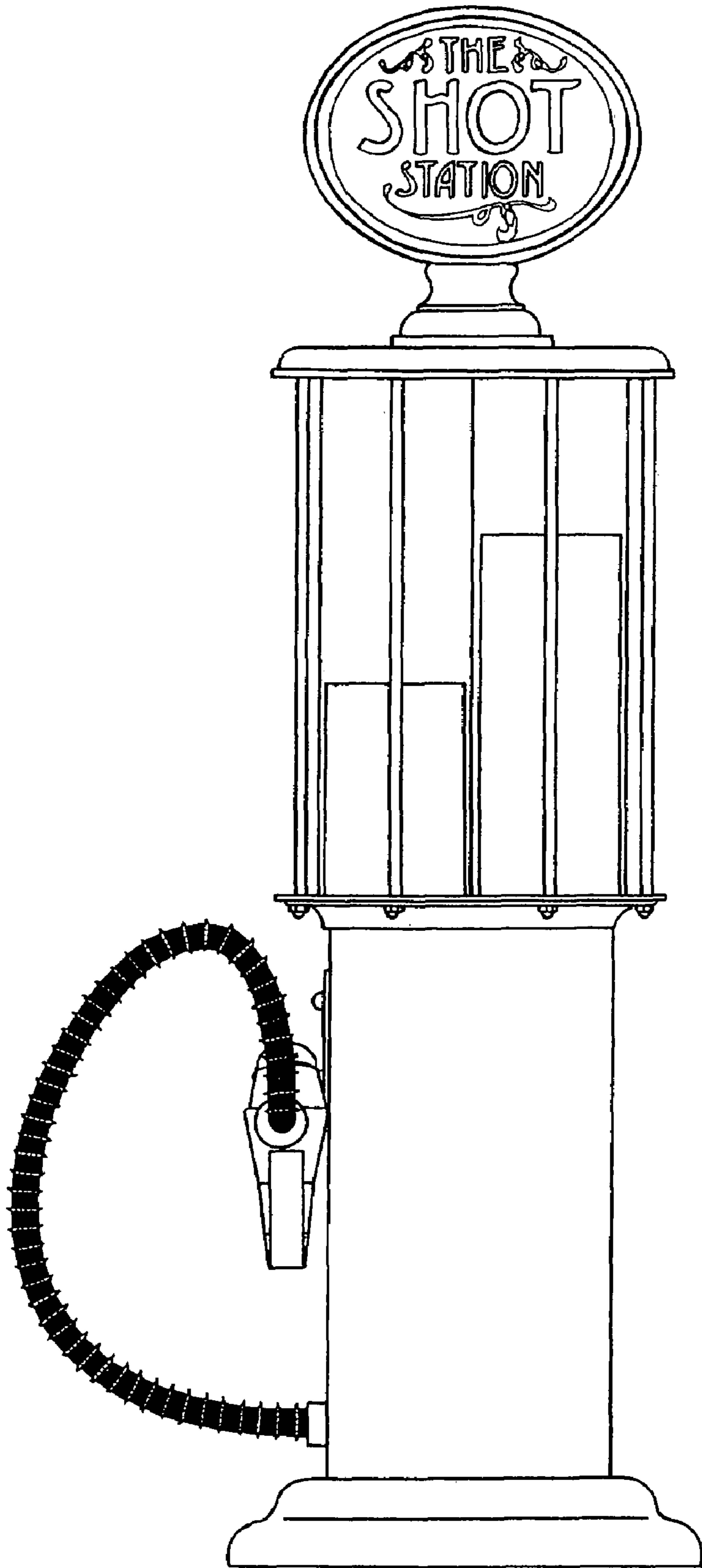

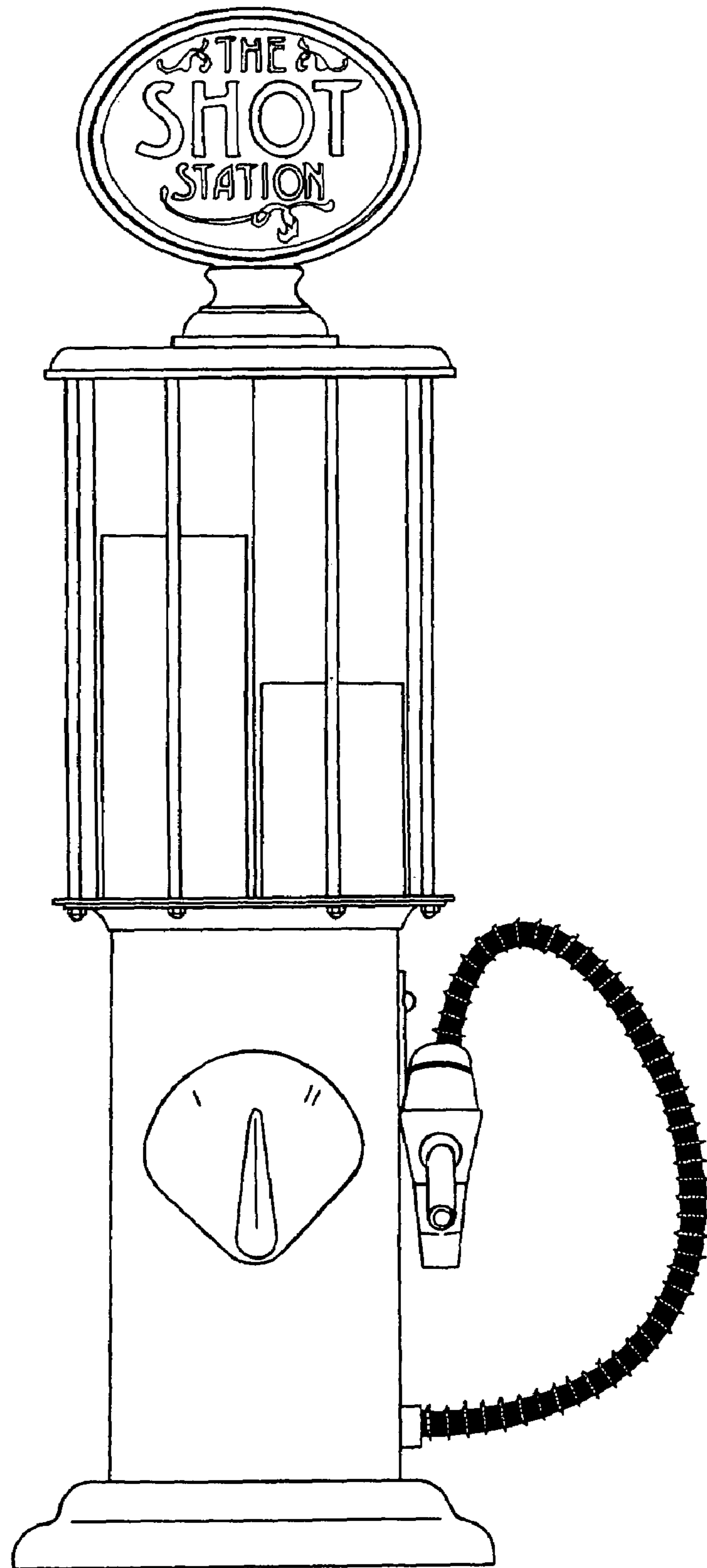

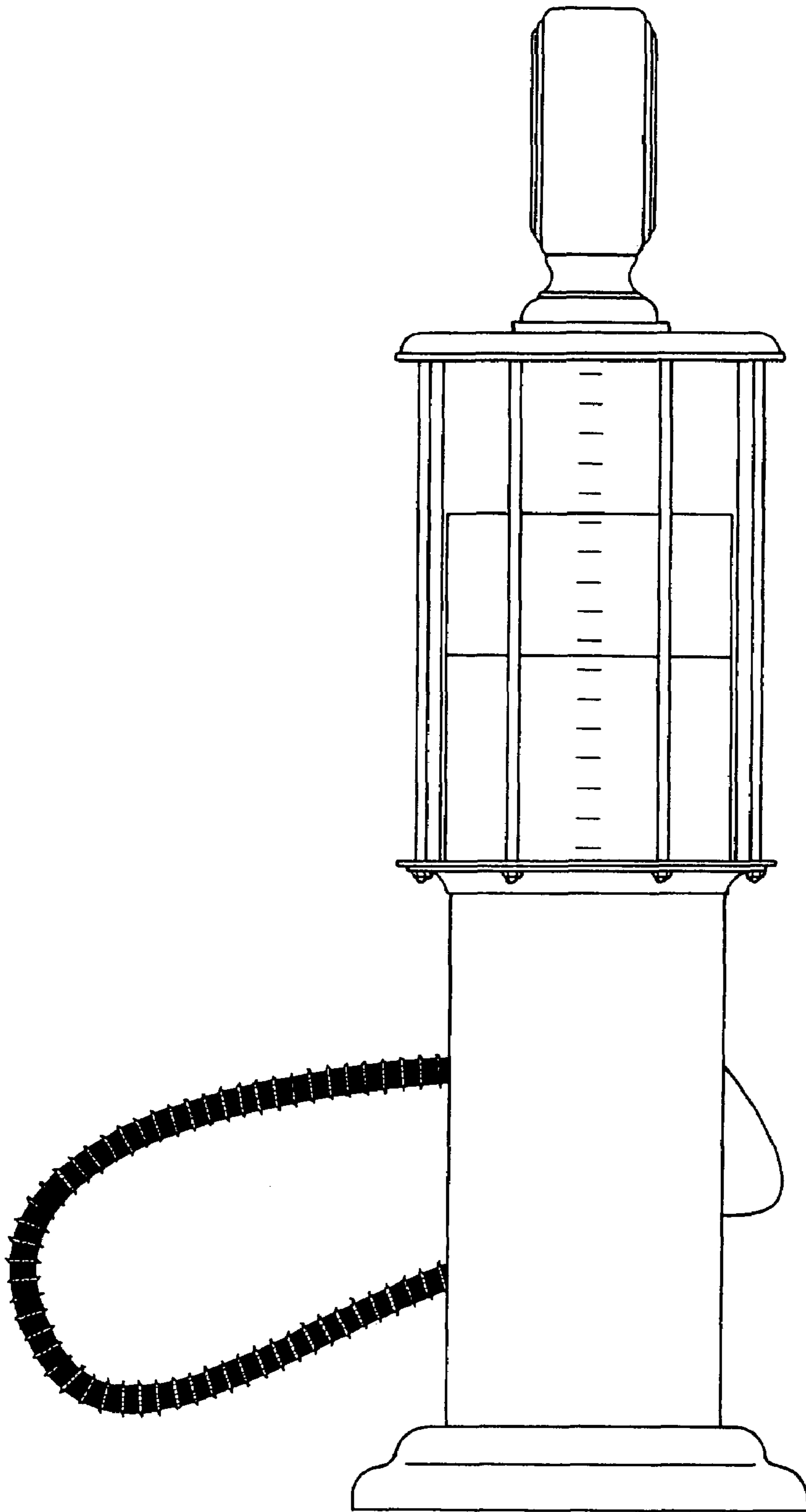

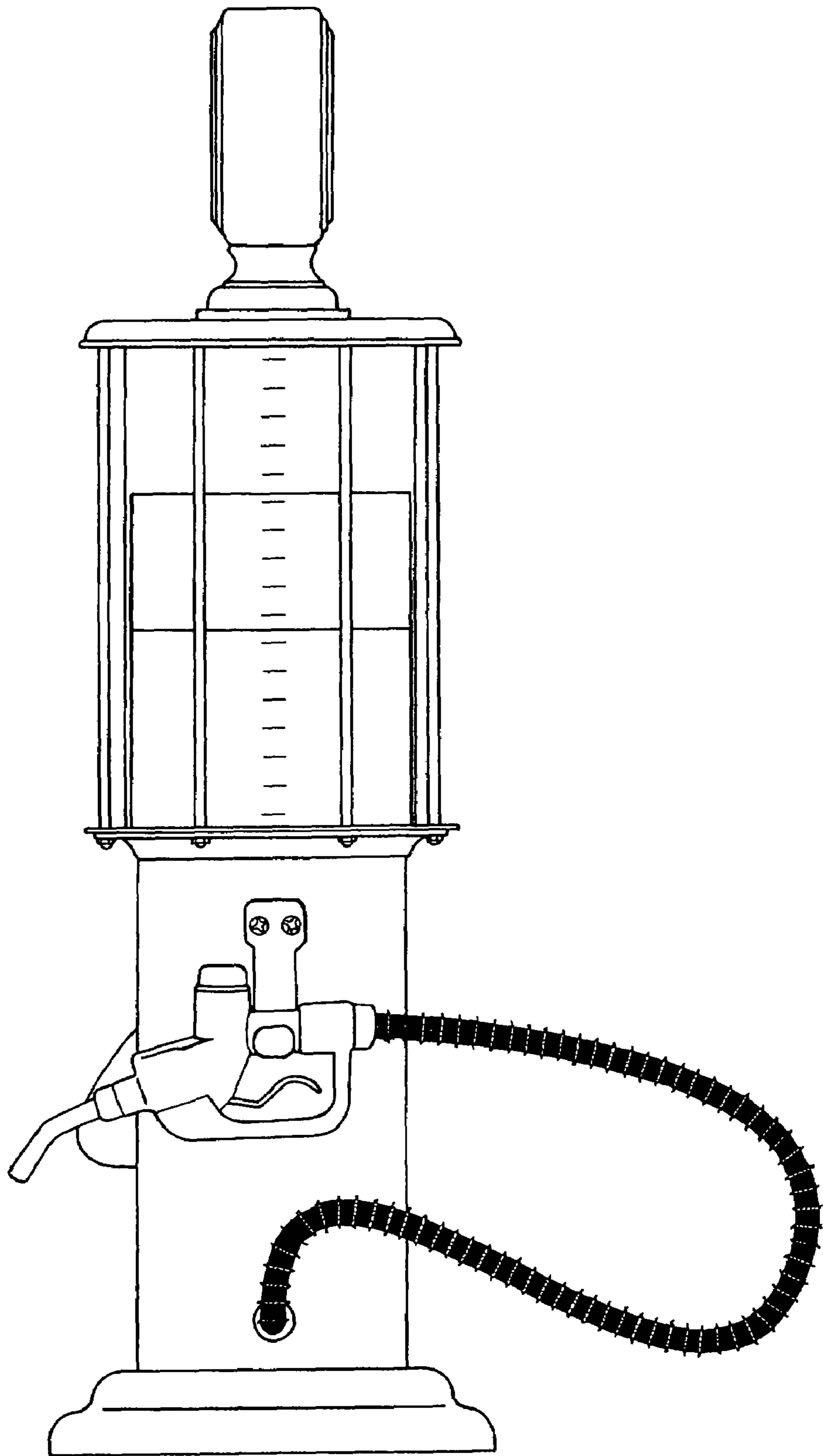
