(57) **CLAIM**

The ornamental design for a round baking pan, as shown and described.

DESCRIPTION

FIG. 1 is a front, right perspective view of a first embodiment of the round baking pan showing my new design with a tab on one hand grip;

FIG. 2 is a top view thereof;

FIG. 3 is a bottom view thereof;

FIG. 4 is a front view thereof, the rear view being a mirror image thereof;

FIG. 5 is a right side view thereof, the left side view being a mirror image thereof;

FIG. 6 is a front, right perspective view of a second embodiment of the round baking pan showing my new design with a tab on both hand grips;

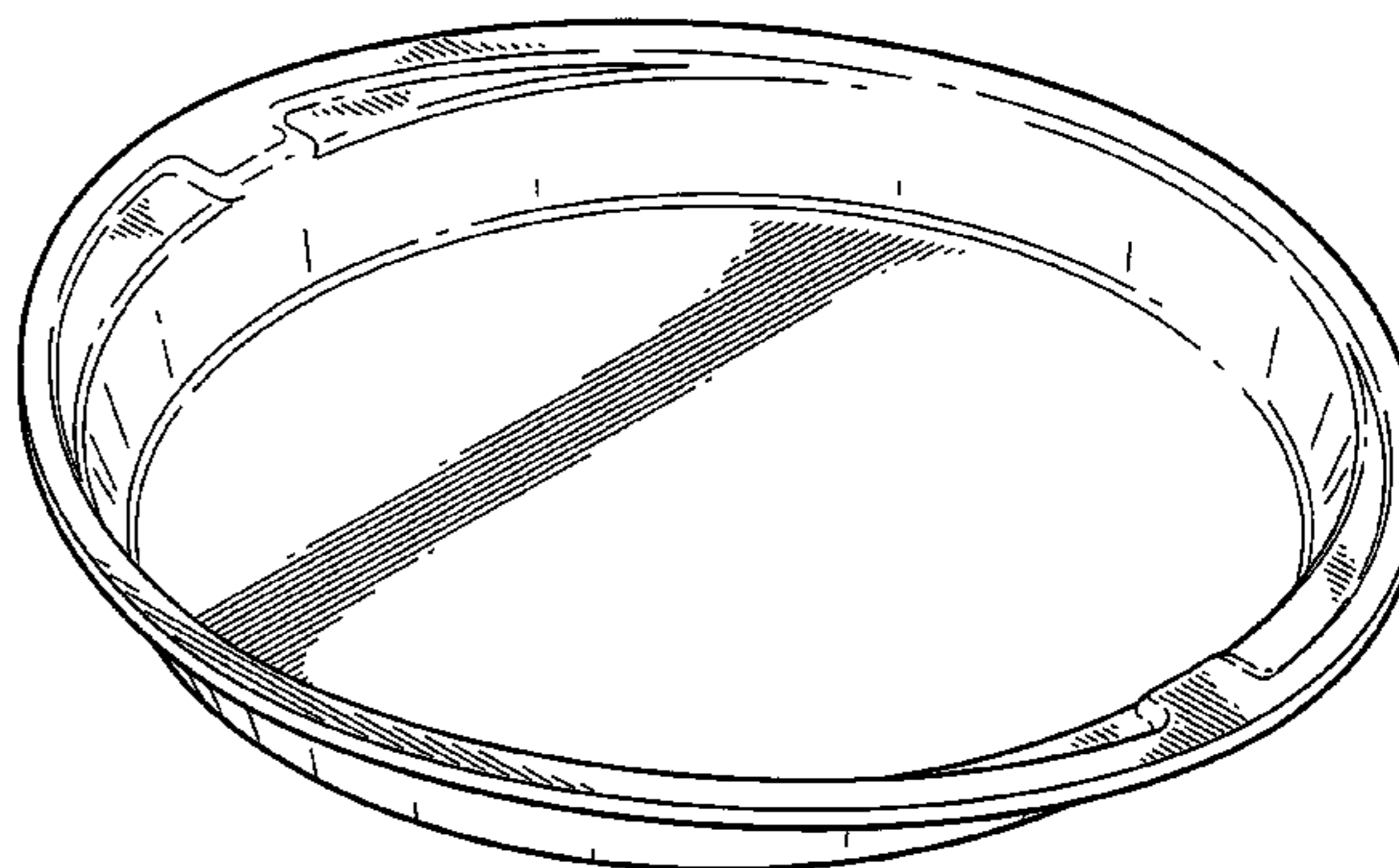
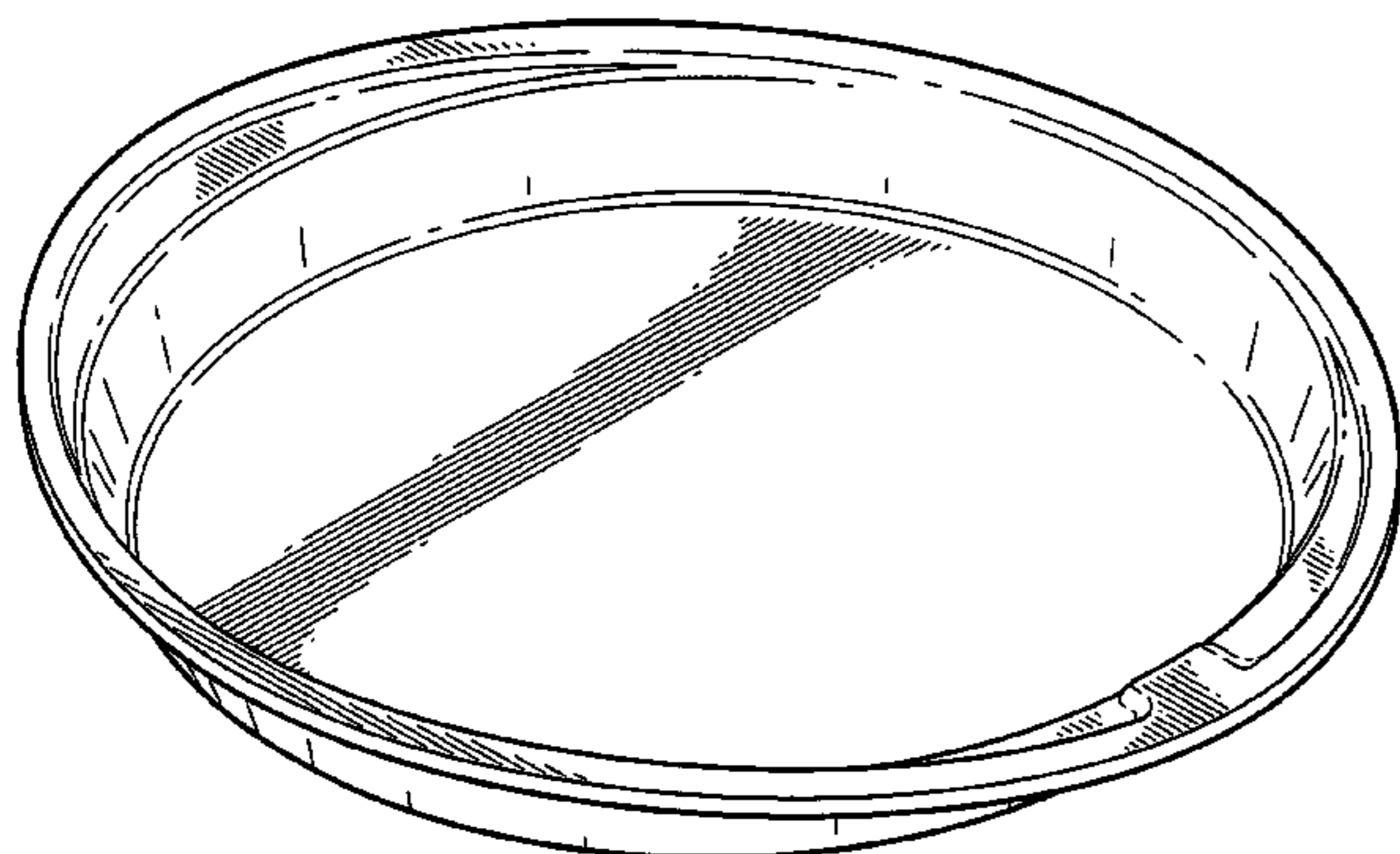
FIG. 7 is a top view thereof;

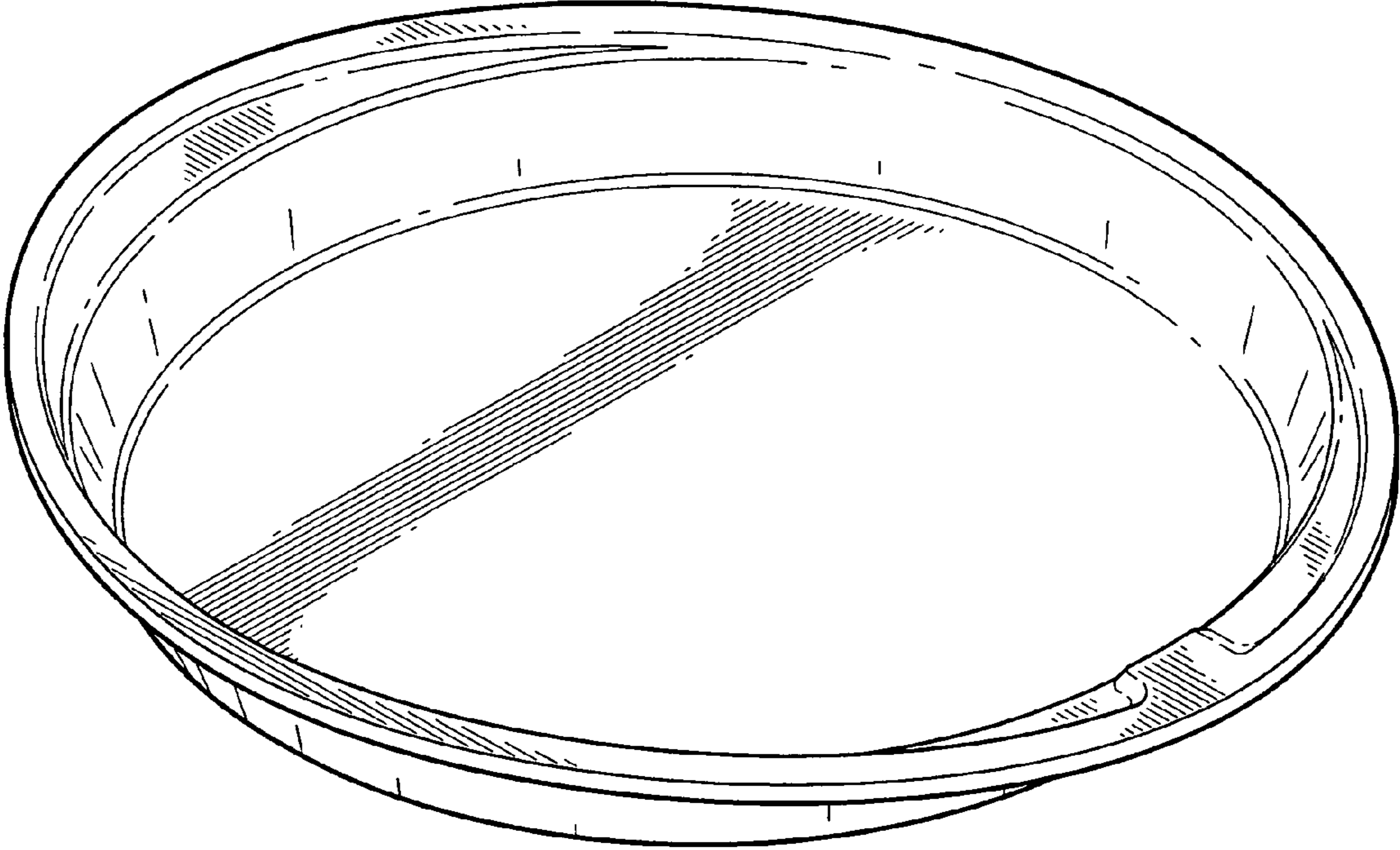

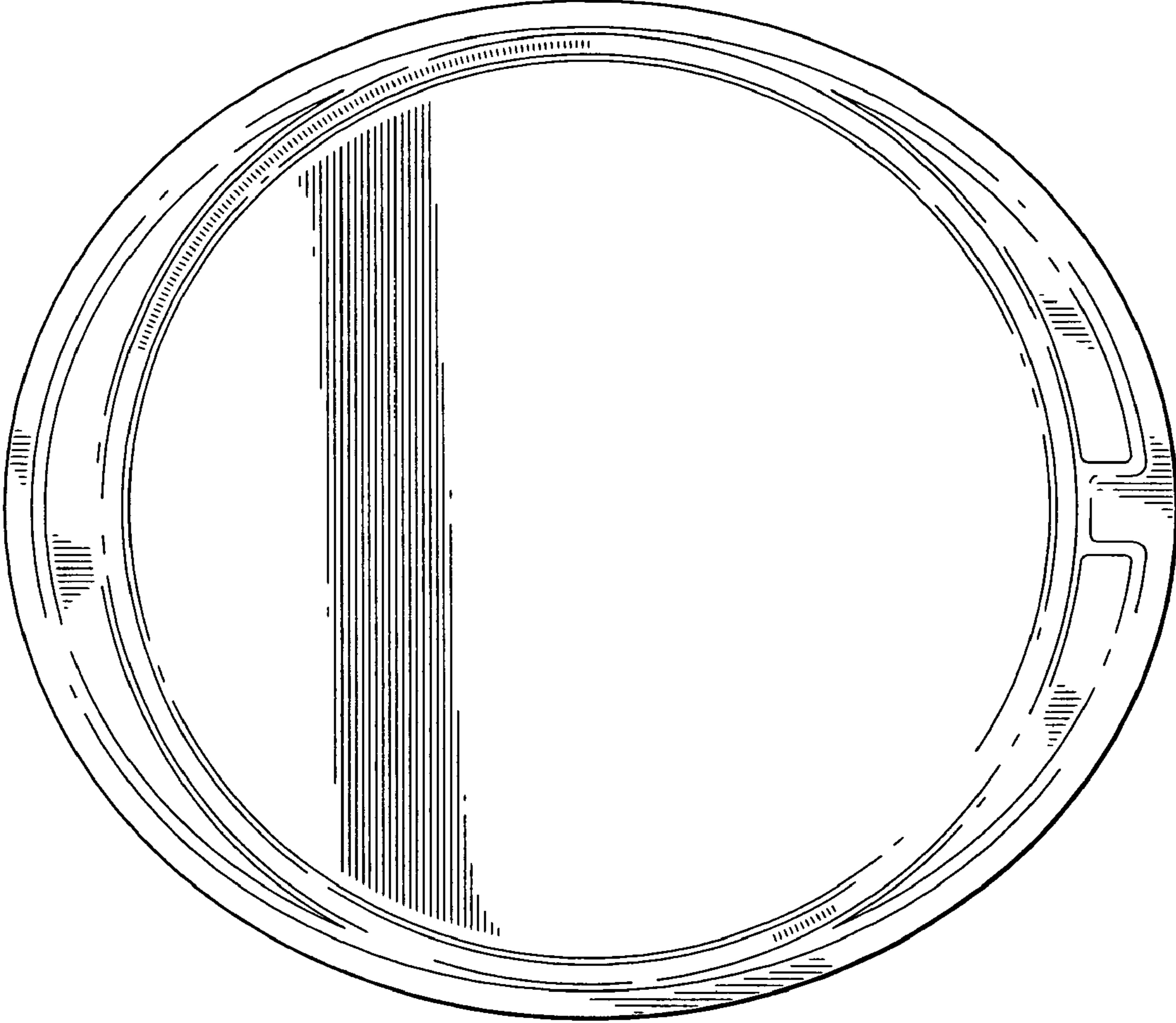

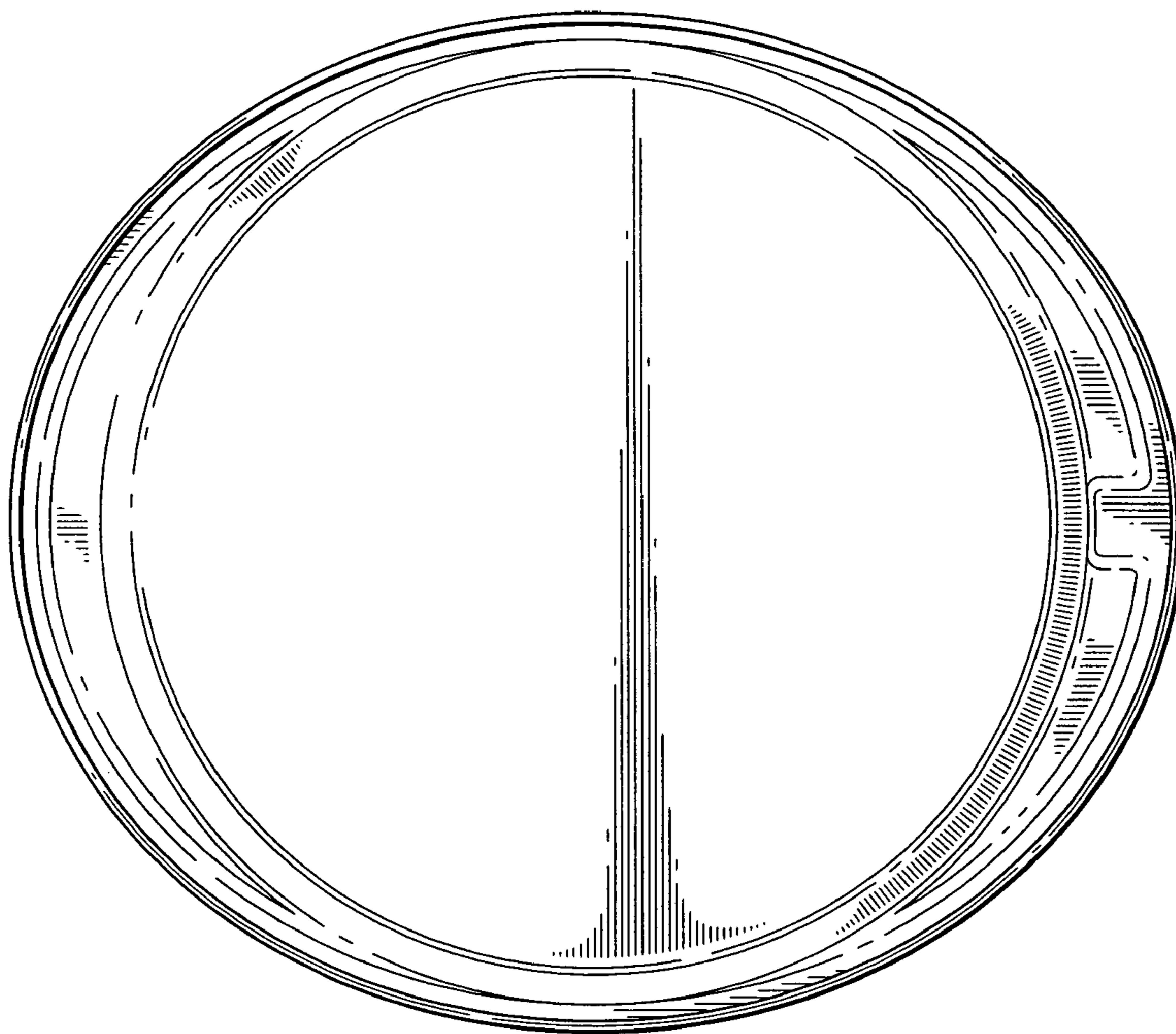

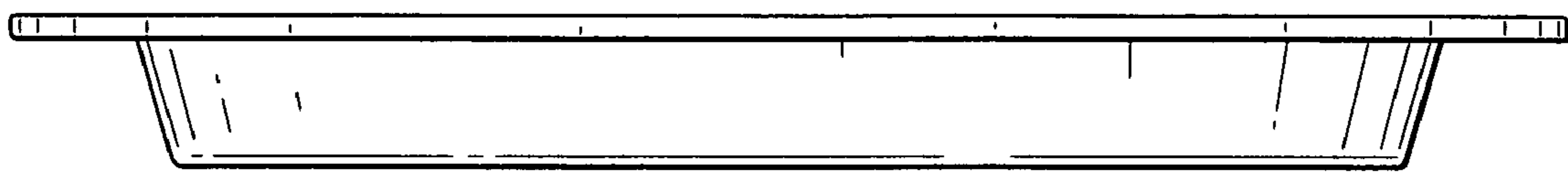

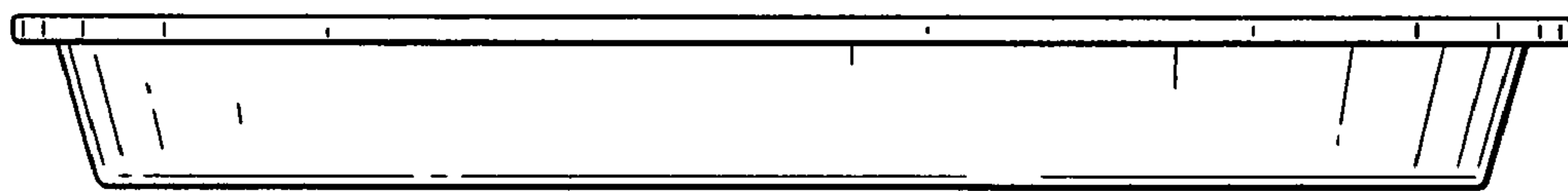

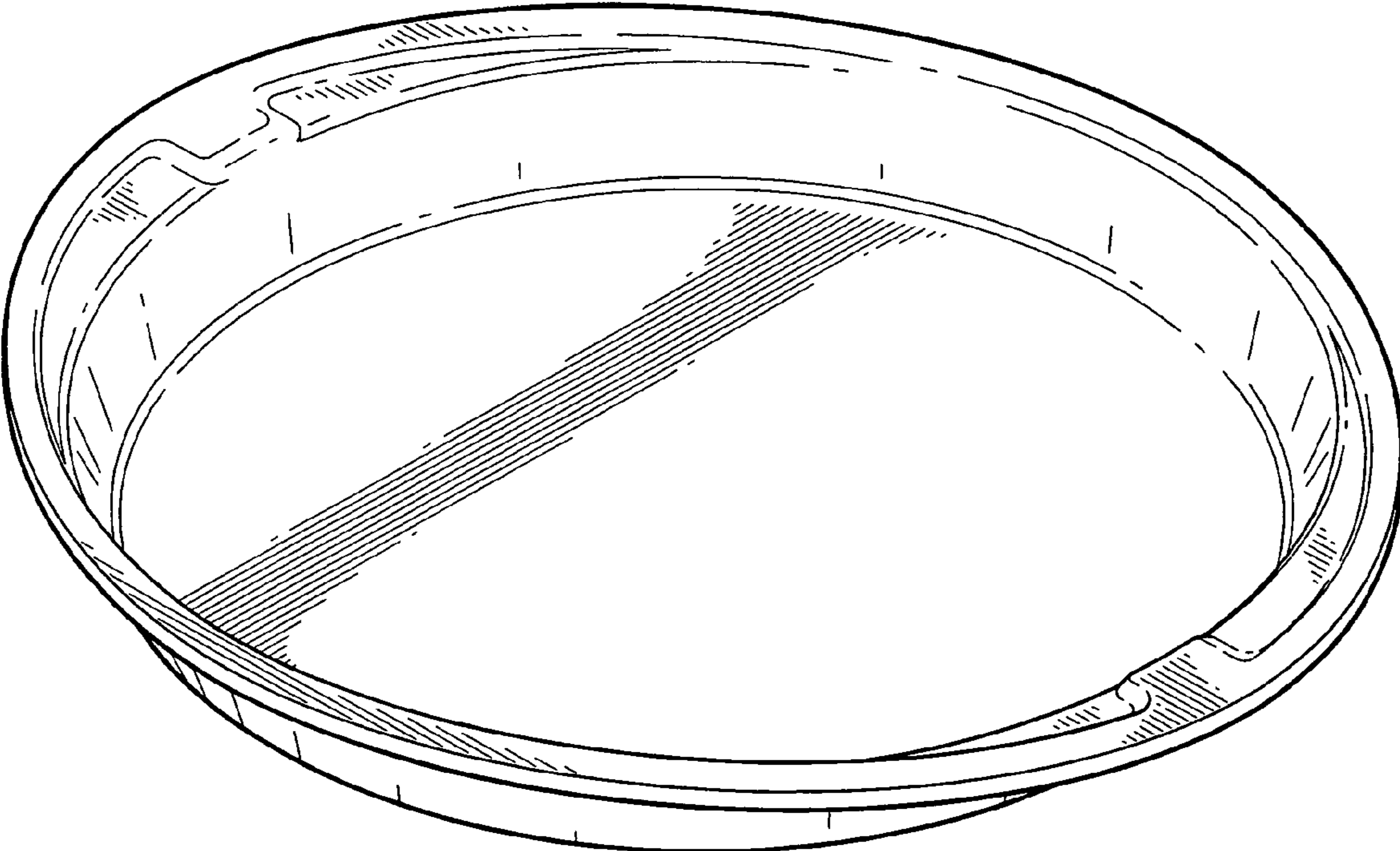

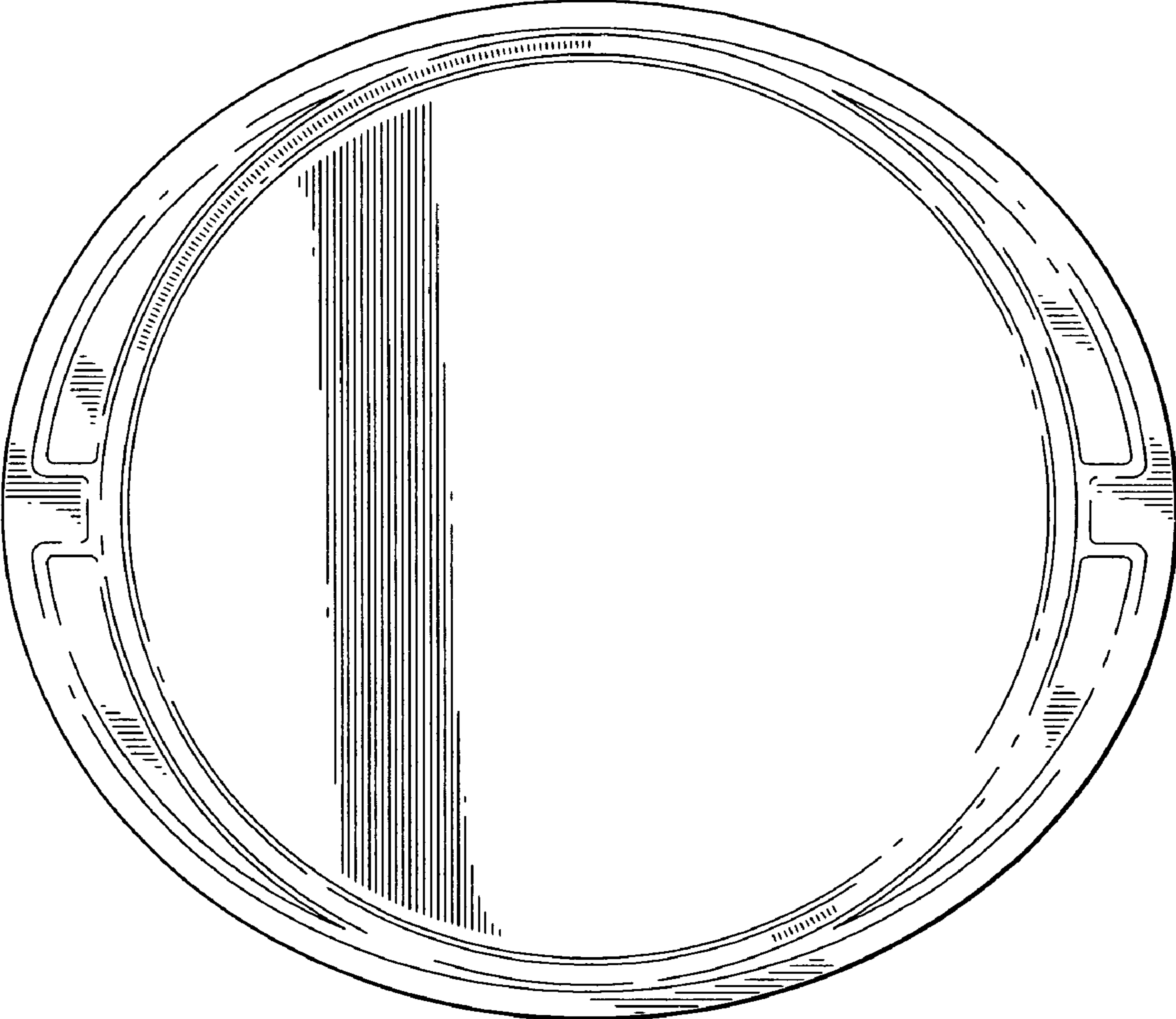

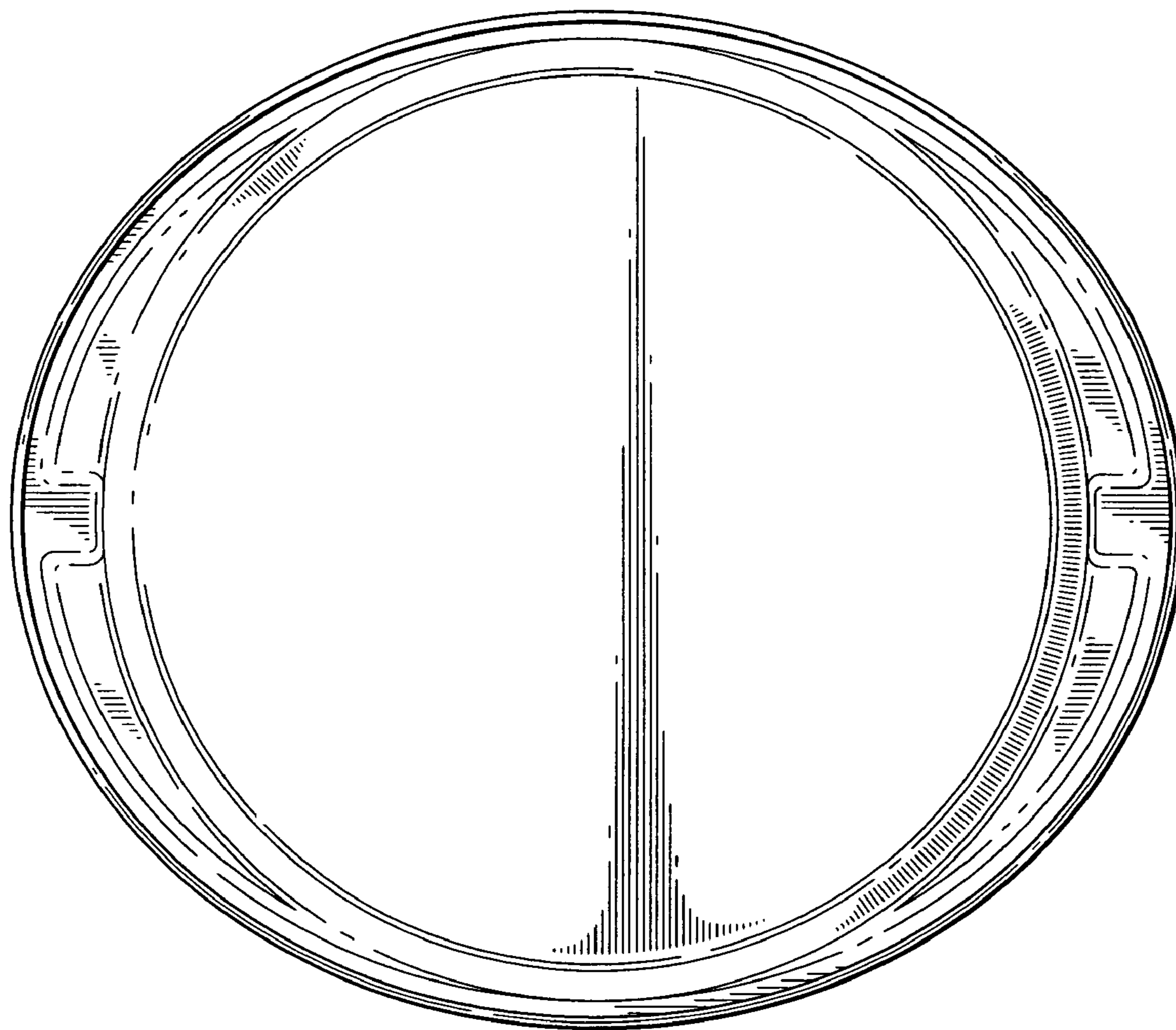

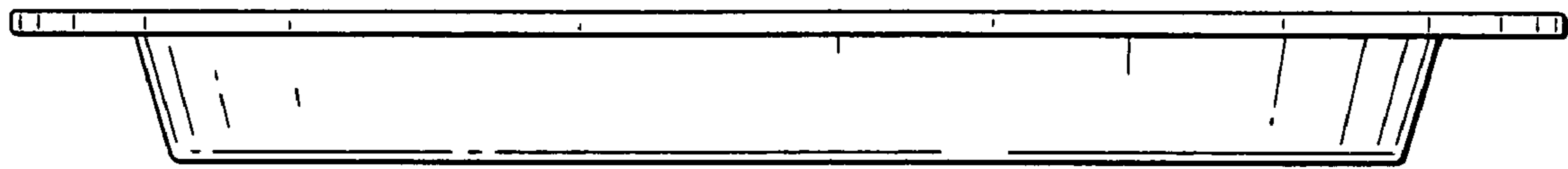

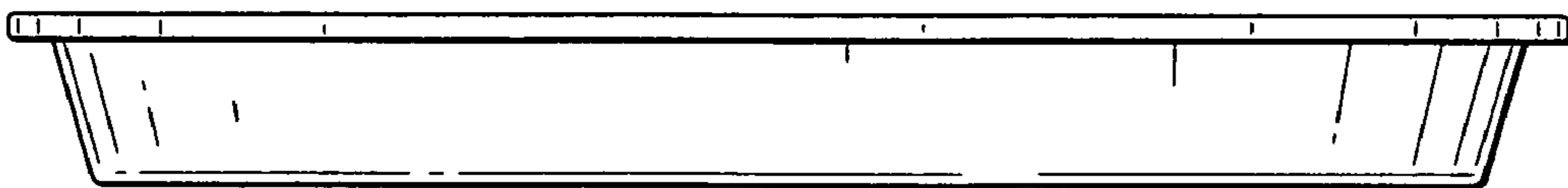
