(57) **CLAIM**

The ornamental design for a sifting tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, left side perspective view of a sifting tool embodying my design, the handle shown by dashed lines forms no part of the design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

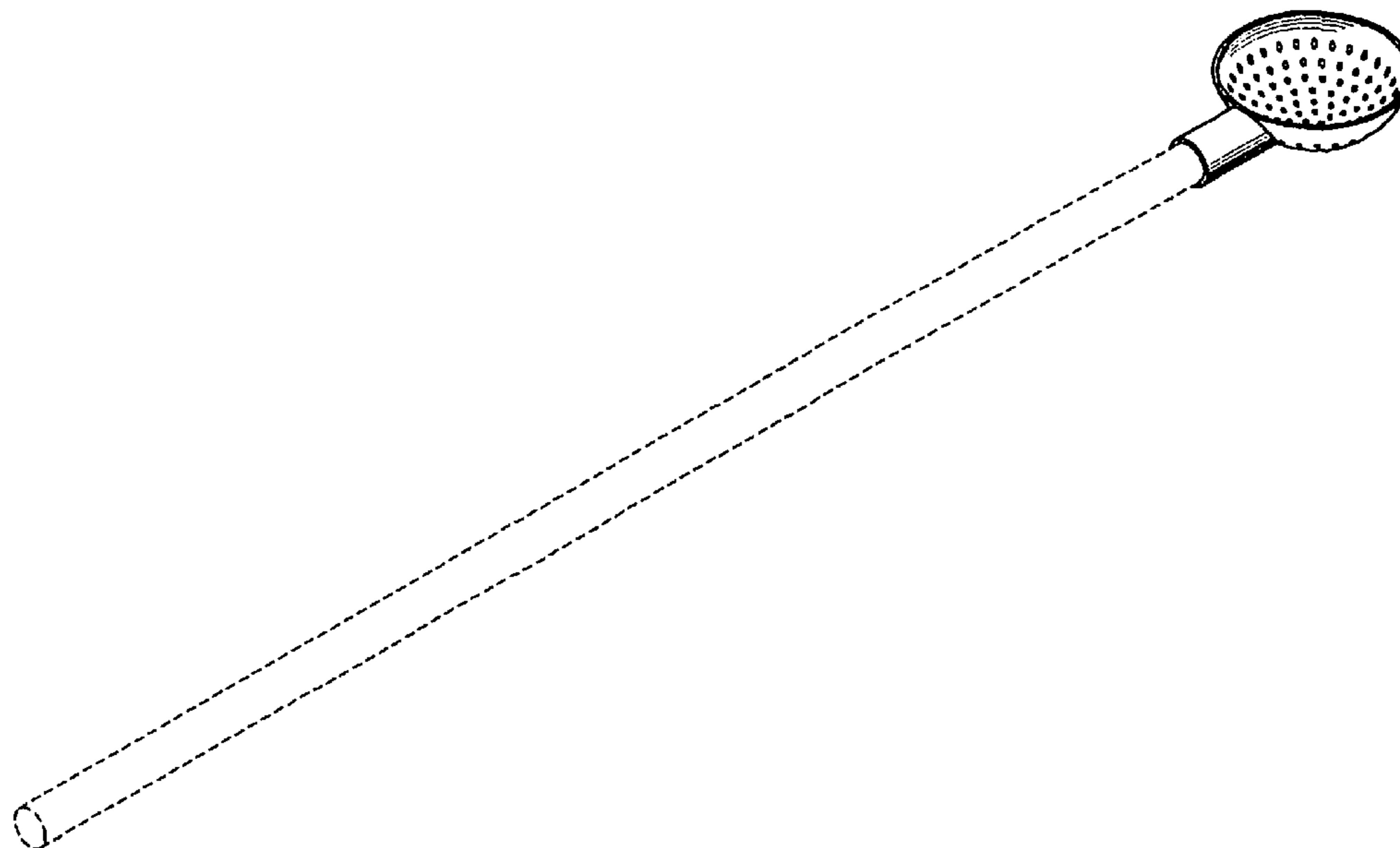
FIG. 4 is a rear elevational view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a right side elevational view thereof, the left side being a mirror image thereof; and,

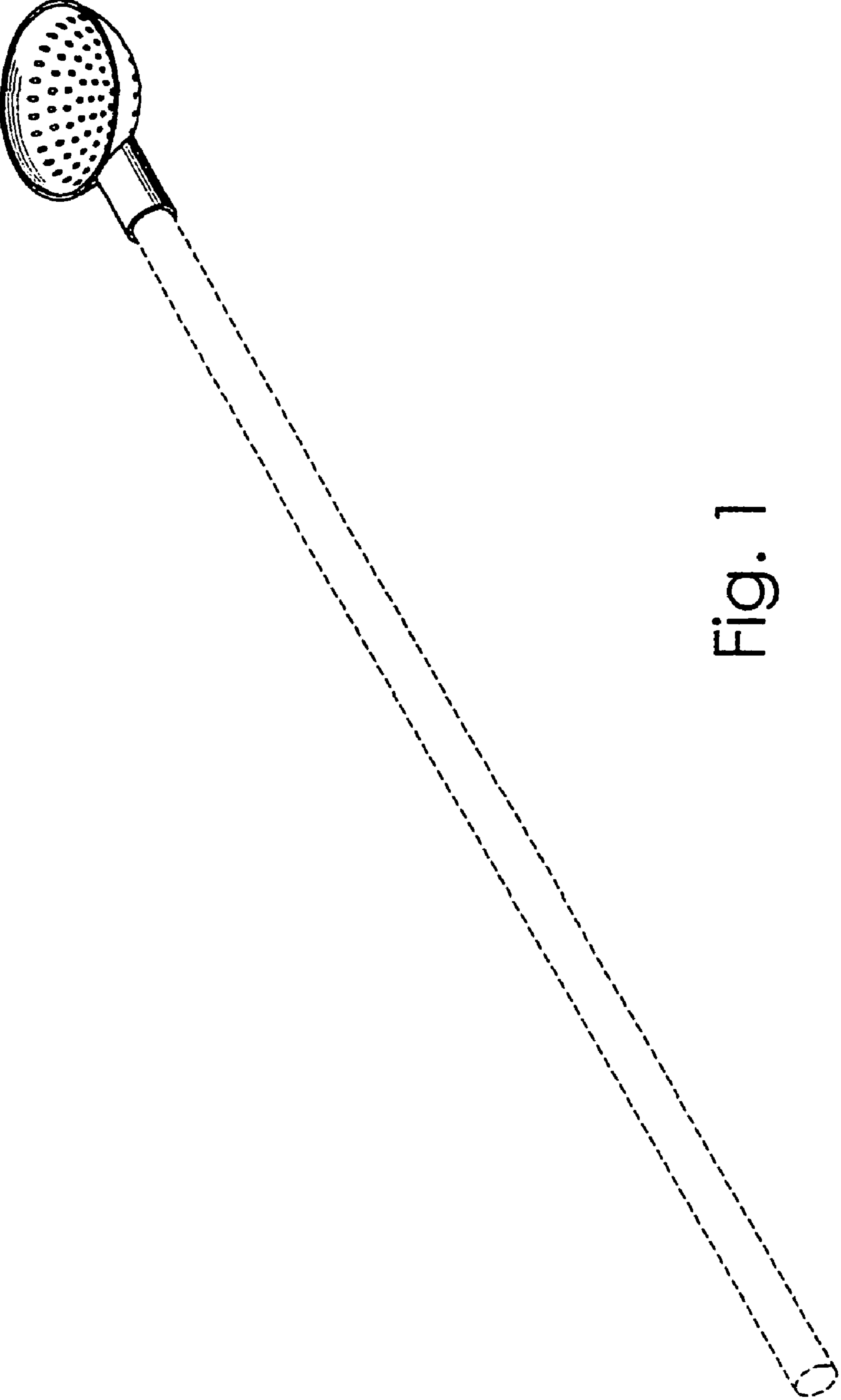

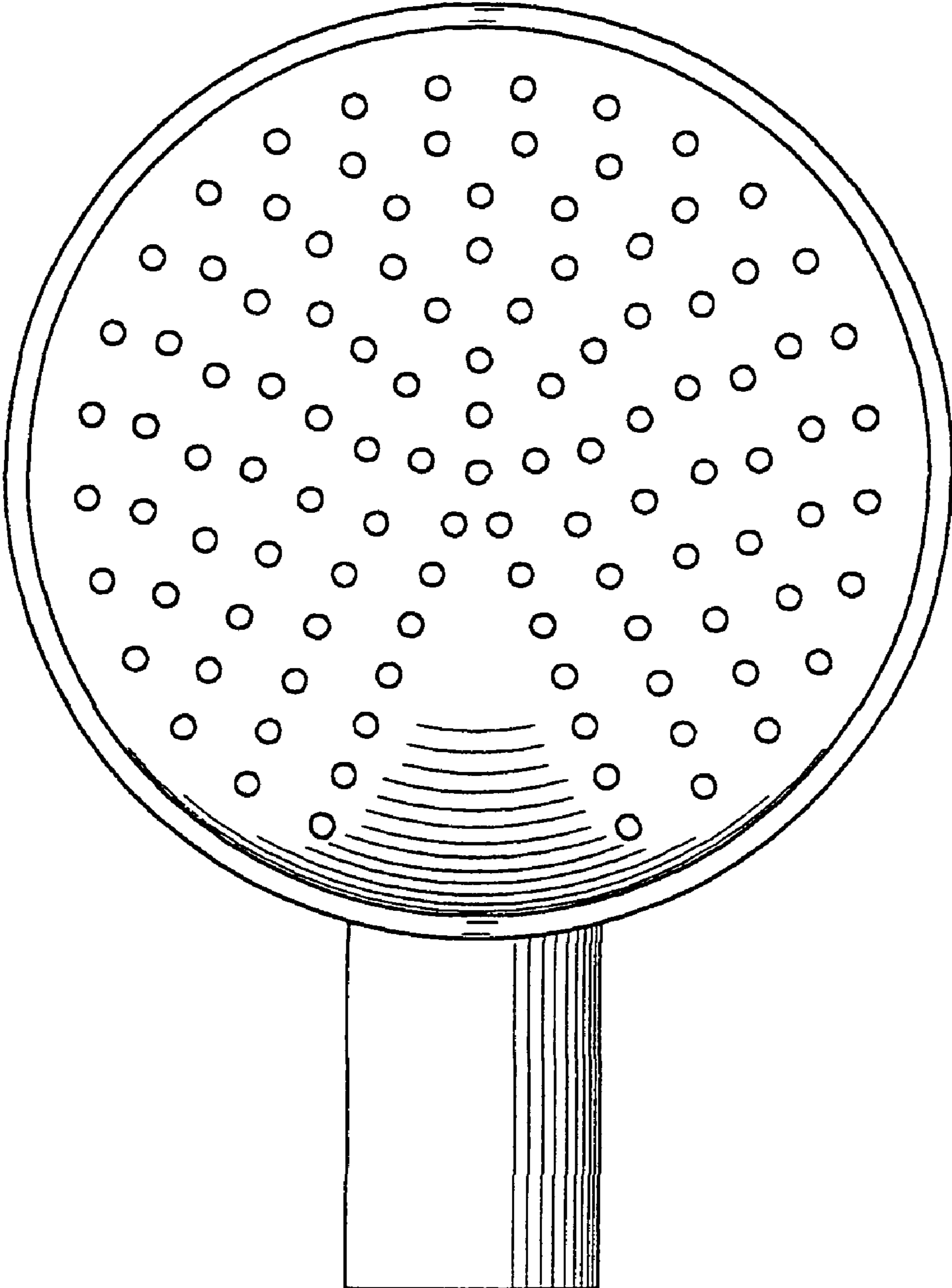

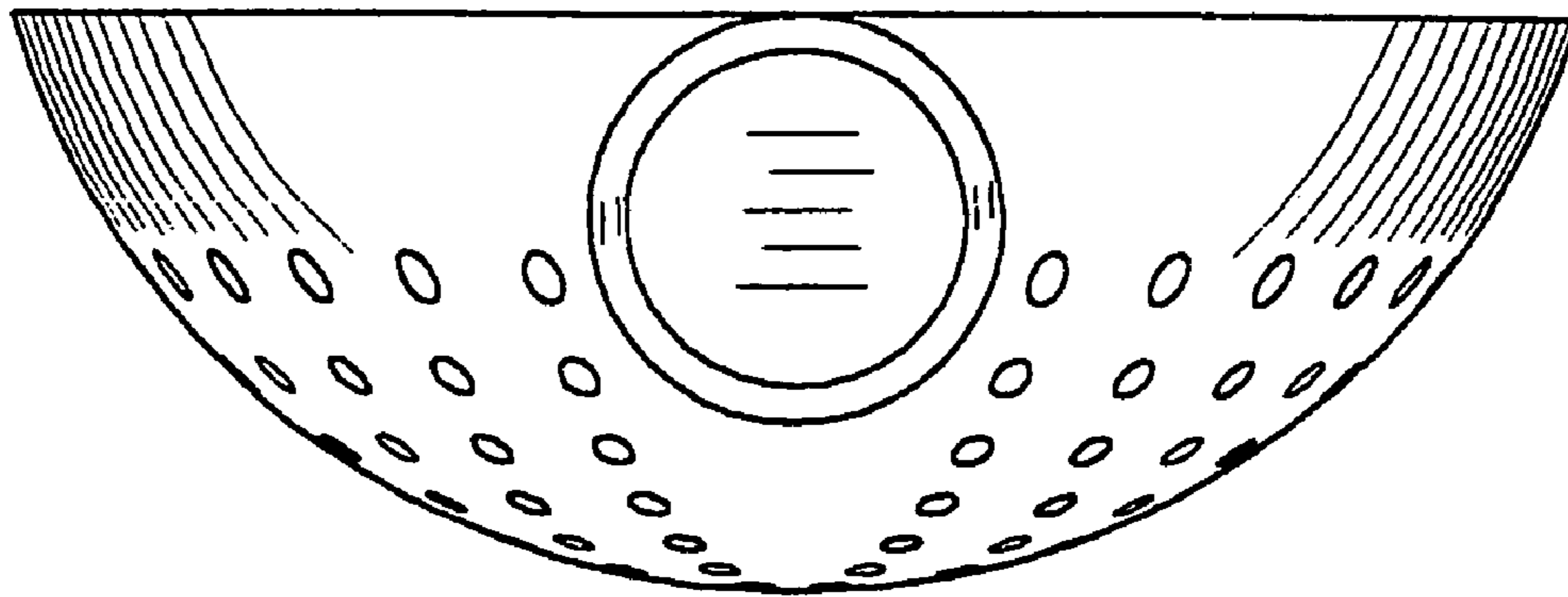

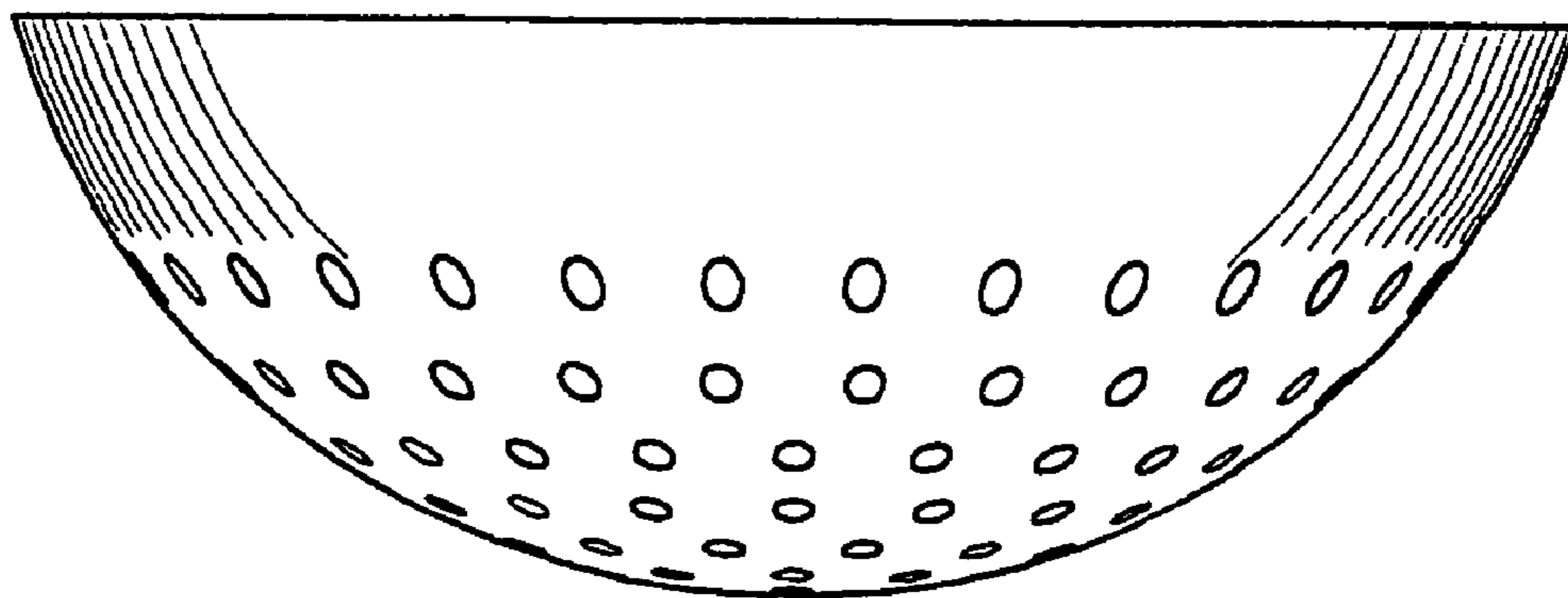

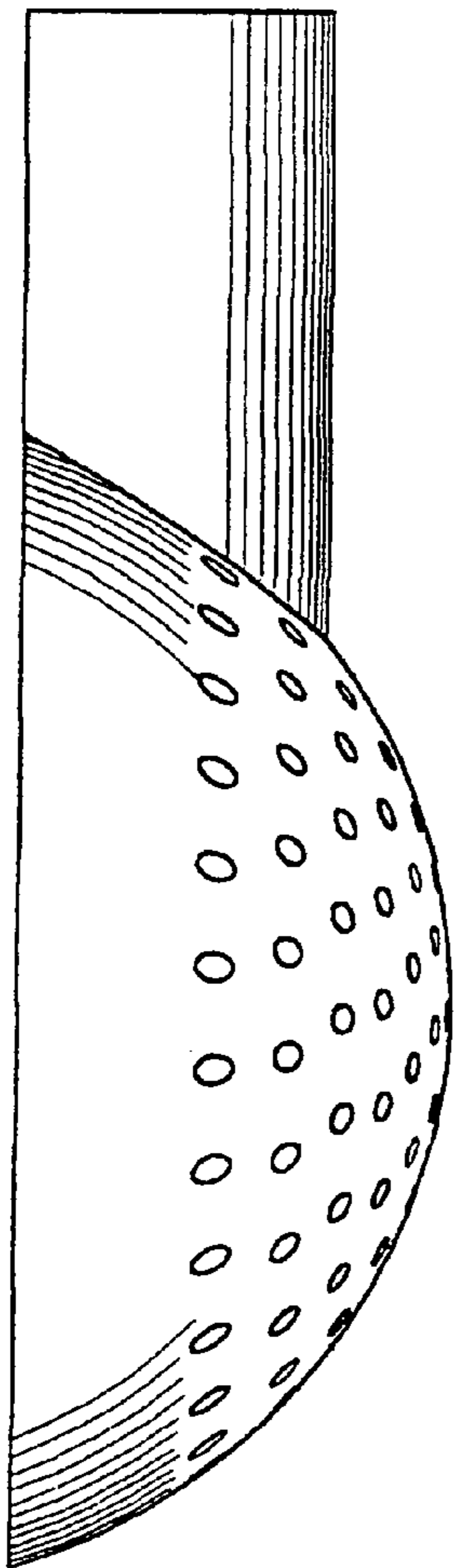

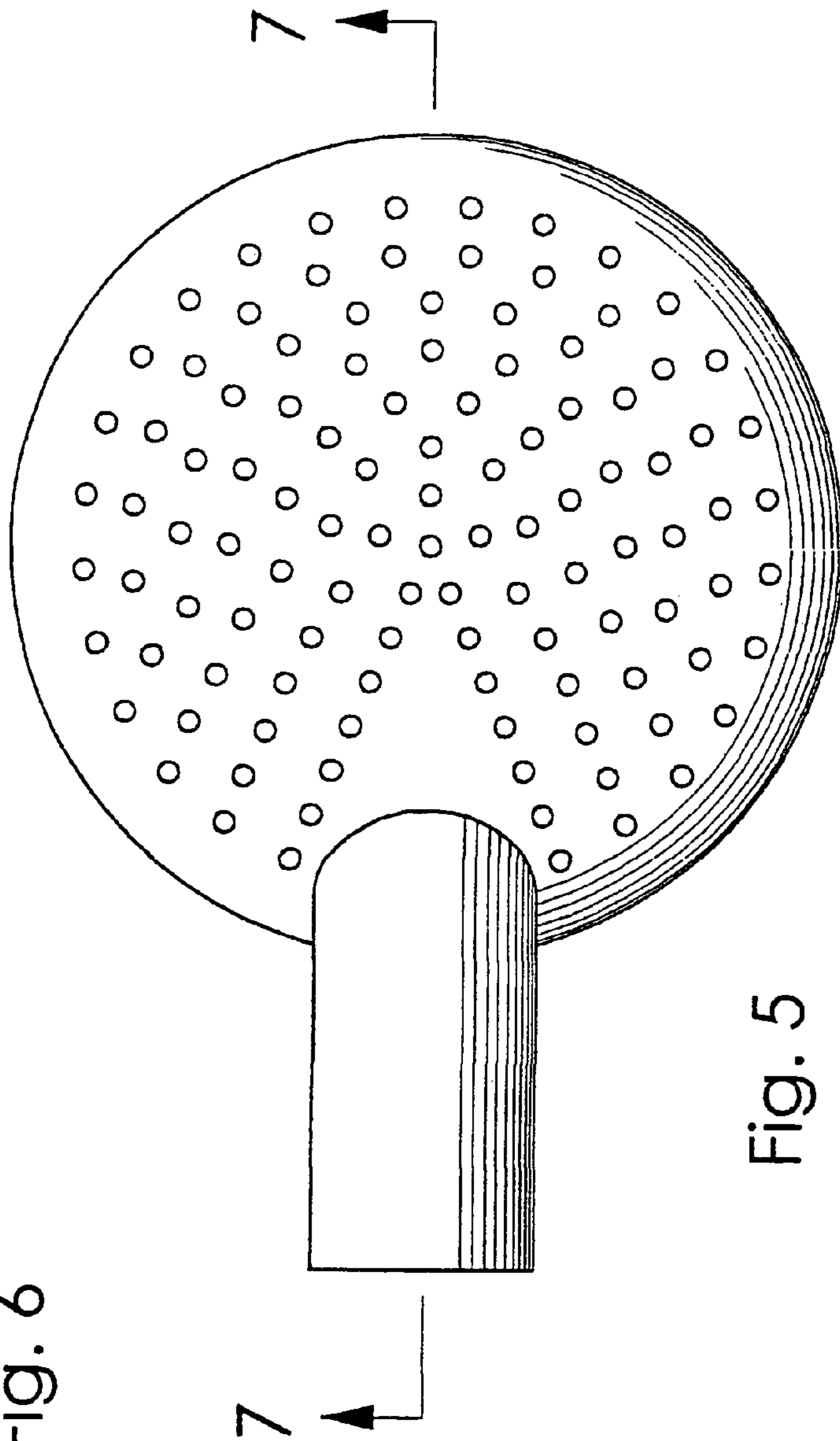

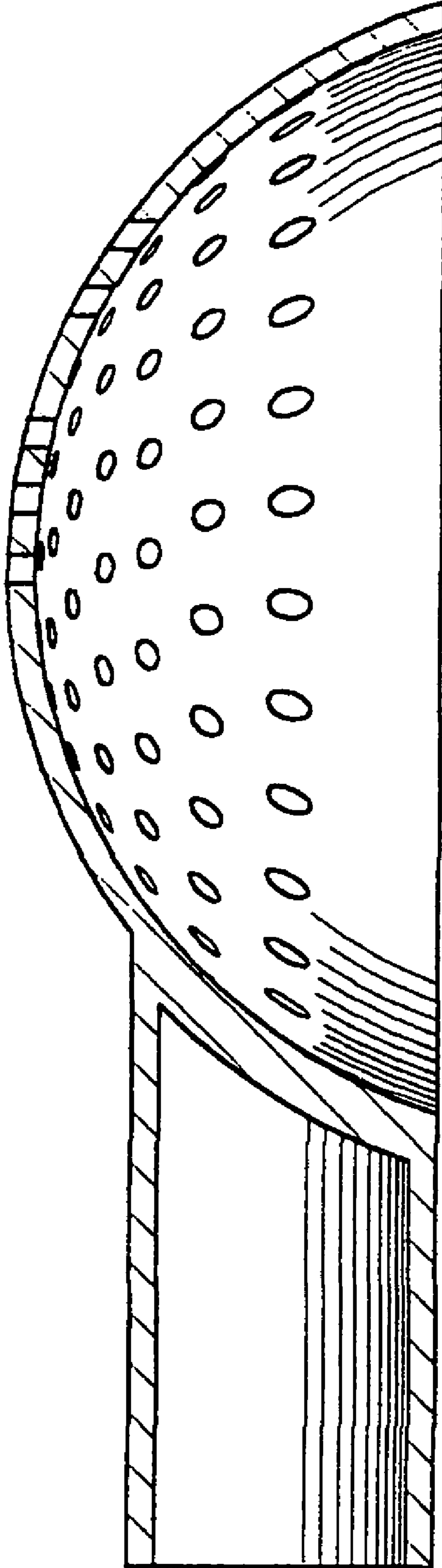
