The ornamental design for a cosmetic dispenser, as shown
and described.

DESCRIPTION

FIG. 1 is front perspective view of a first embodiment of a
cosmetic dispenser wherein the claimed design feature is red
or pink;

FIG. 2 is a front elevation view of the cosmetic dispenser
shown in FIG. 1;

shown in FIG. 8;

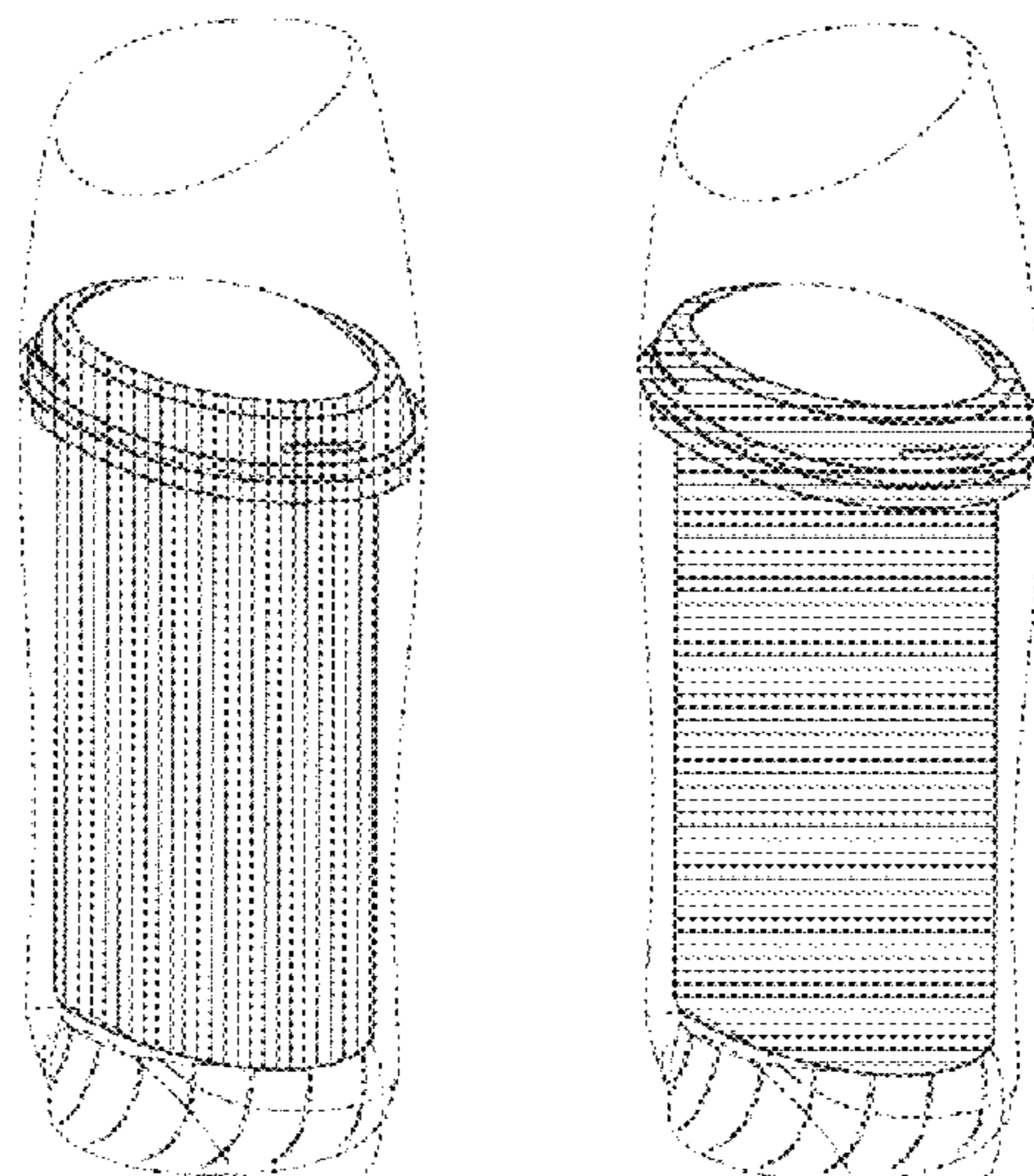
FIG. 12 is a right elevation view of the cosmetic dispenser

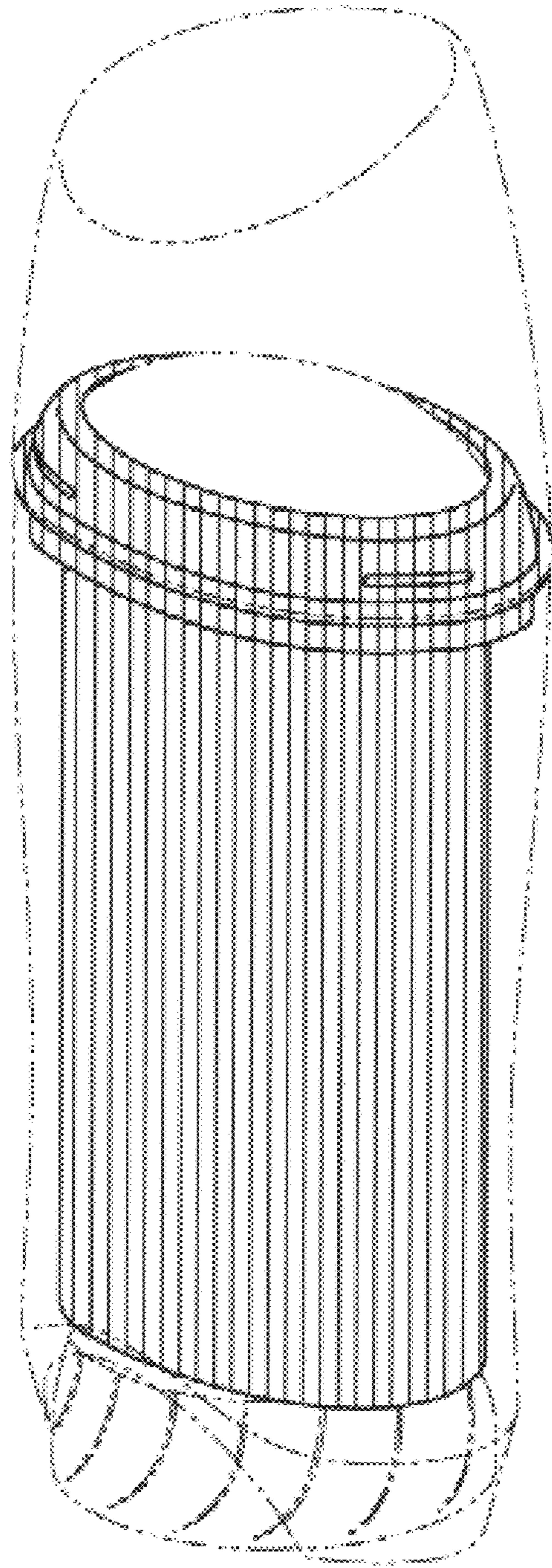

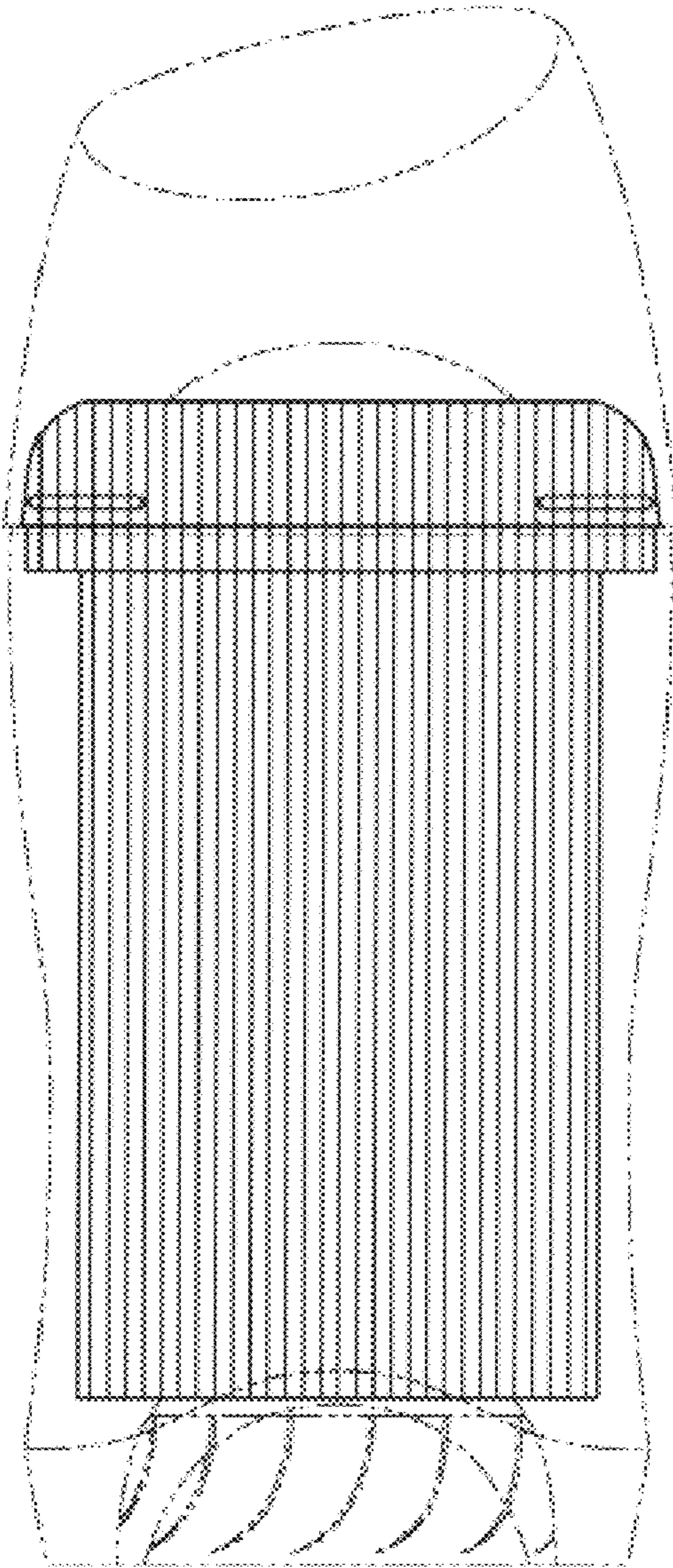

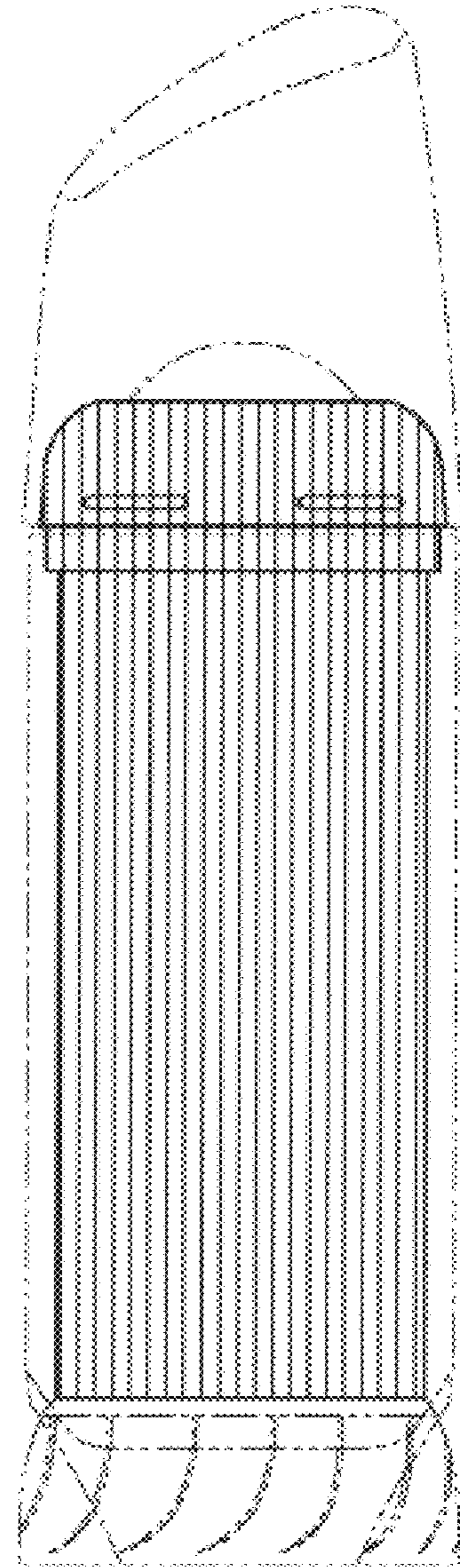

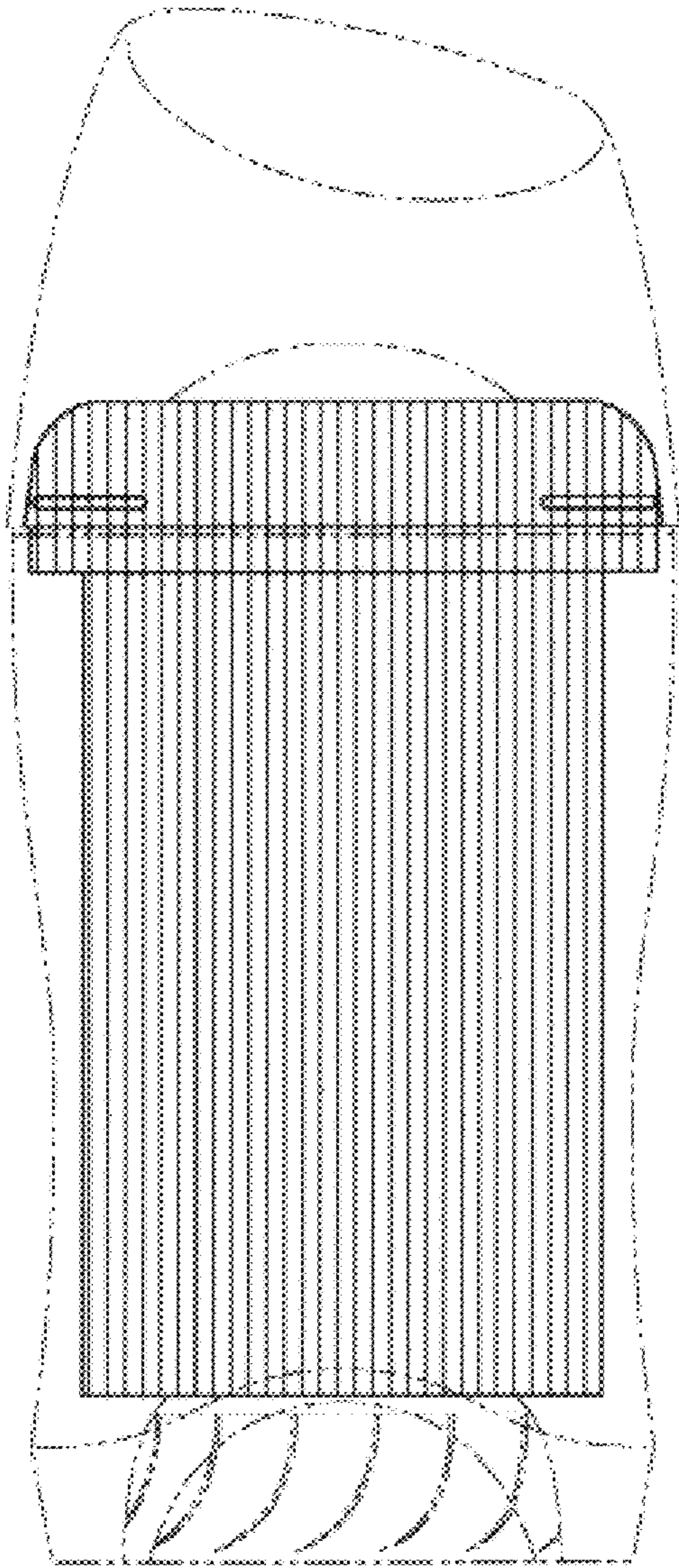

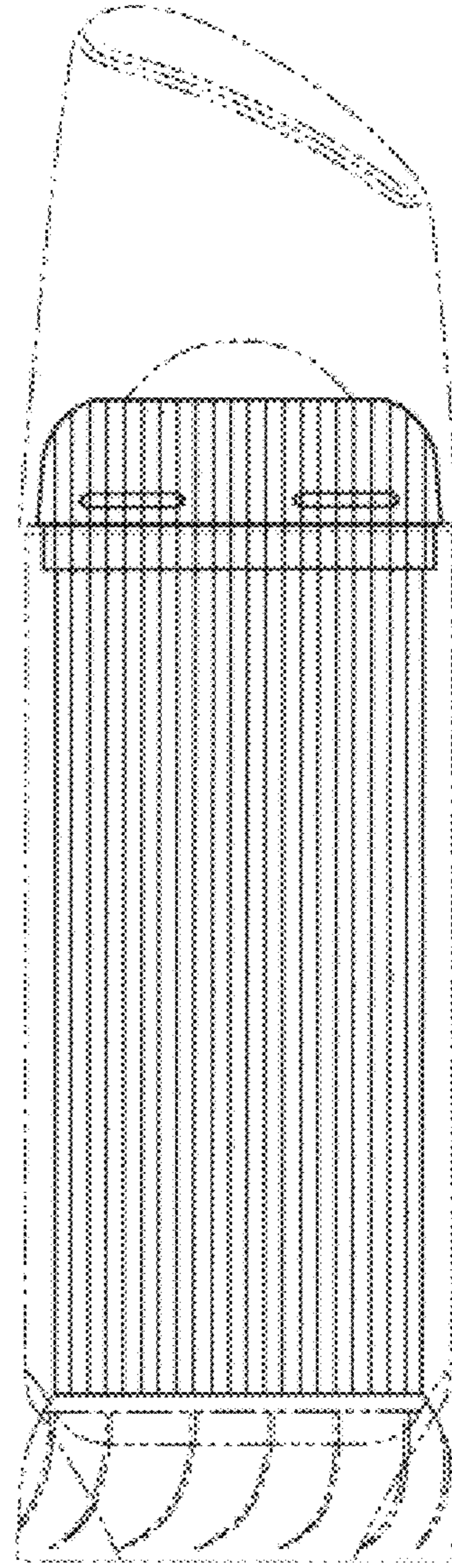

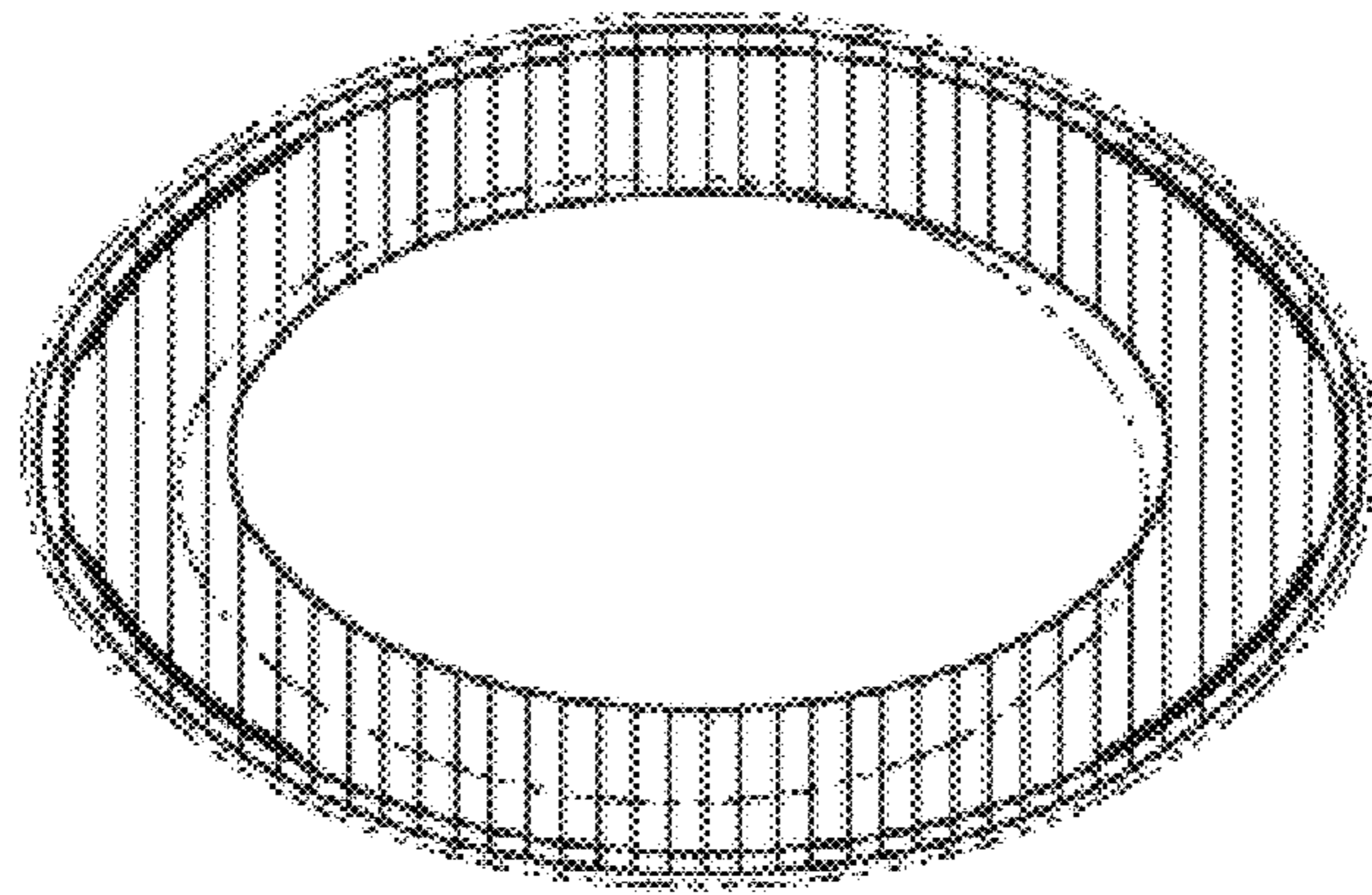

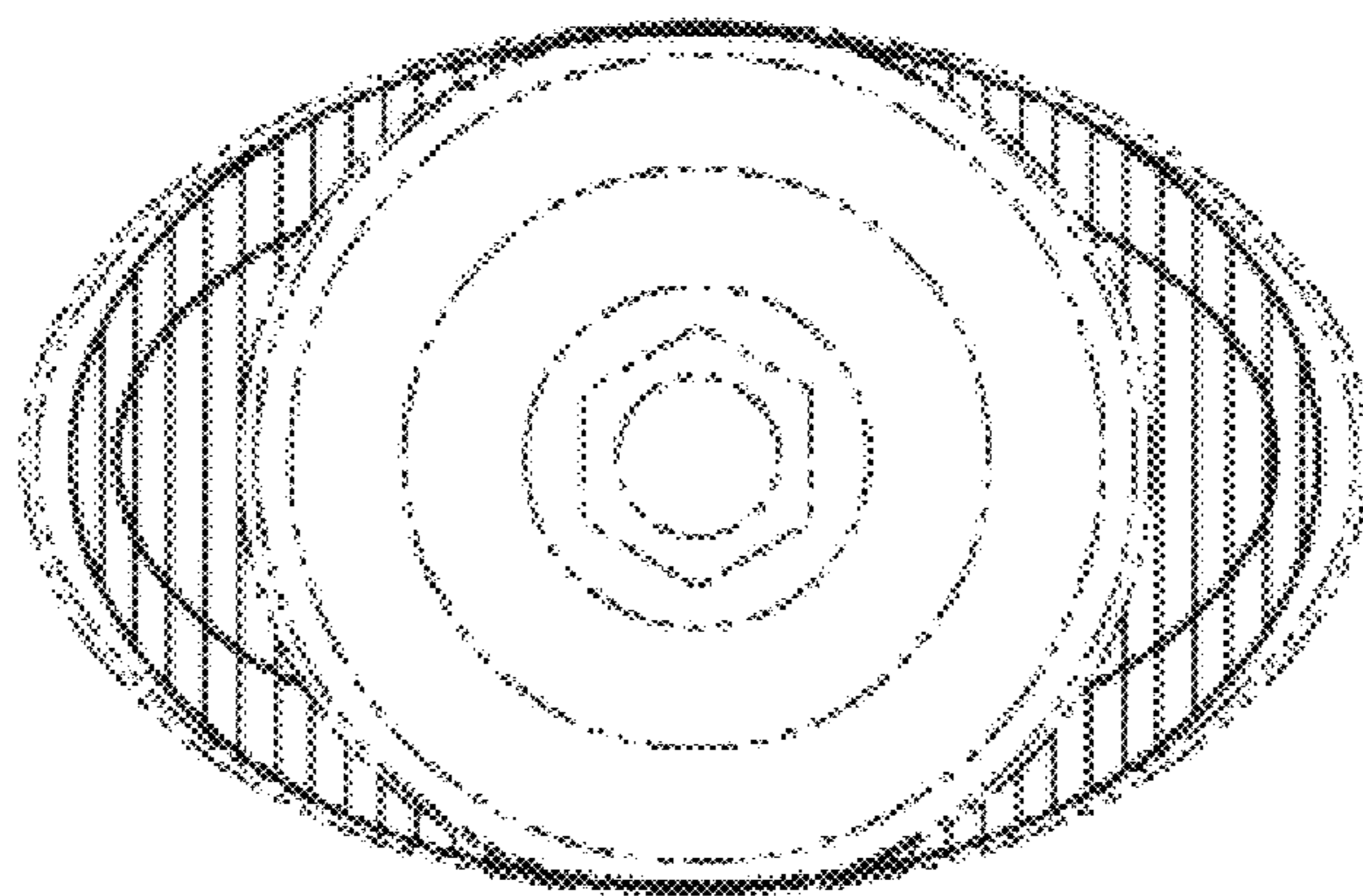

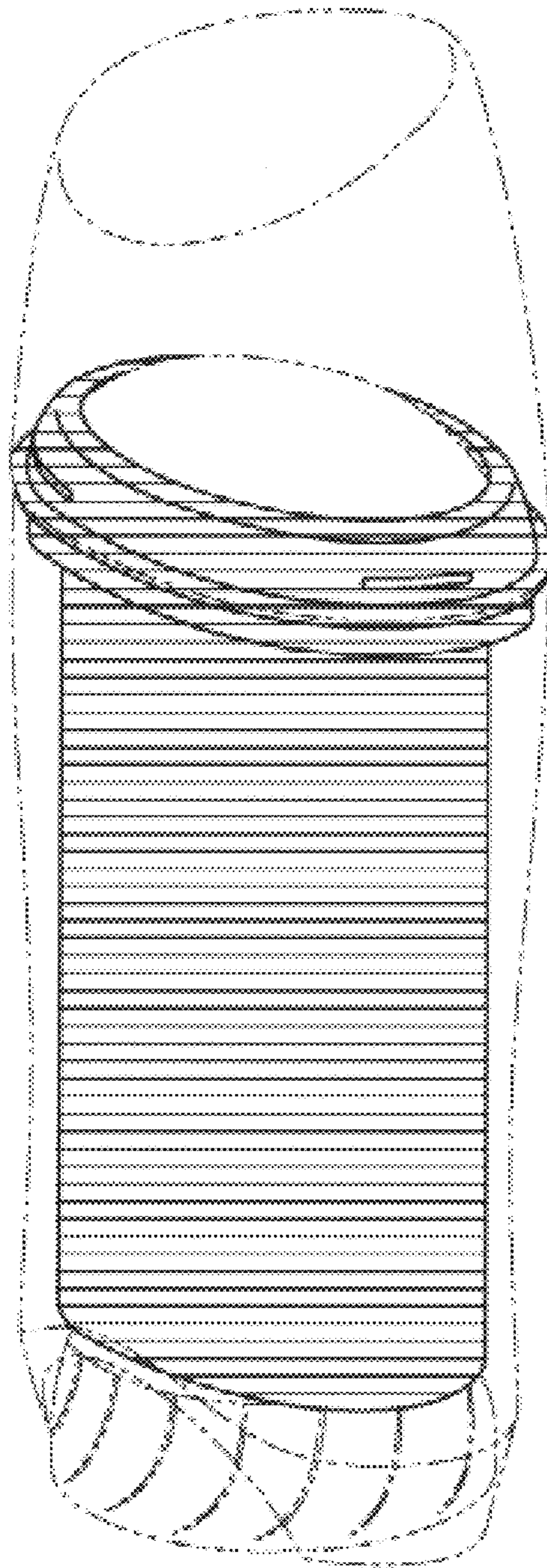

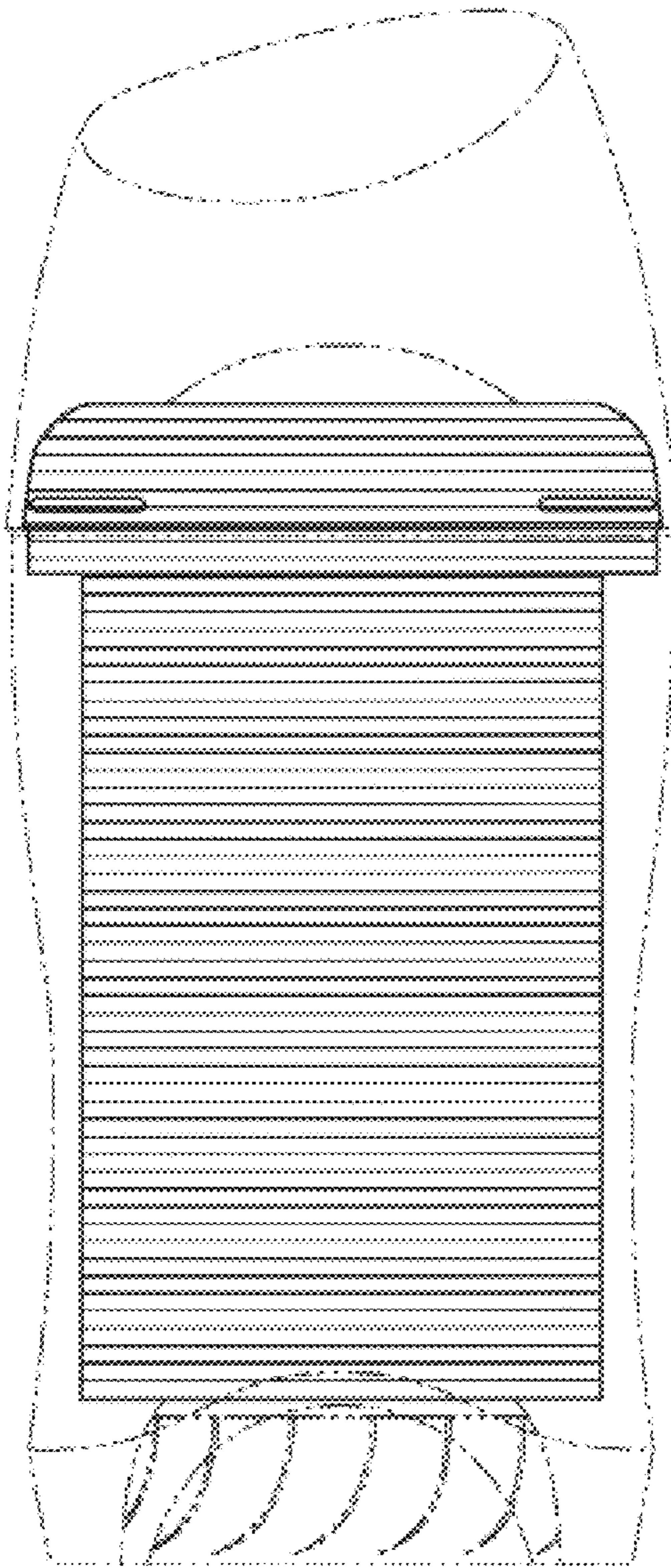

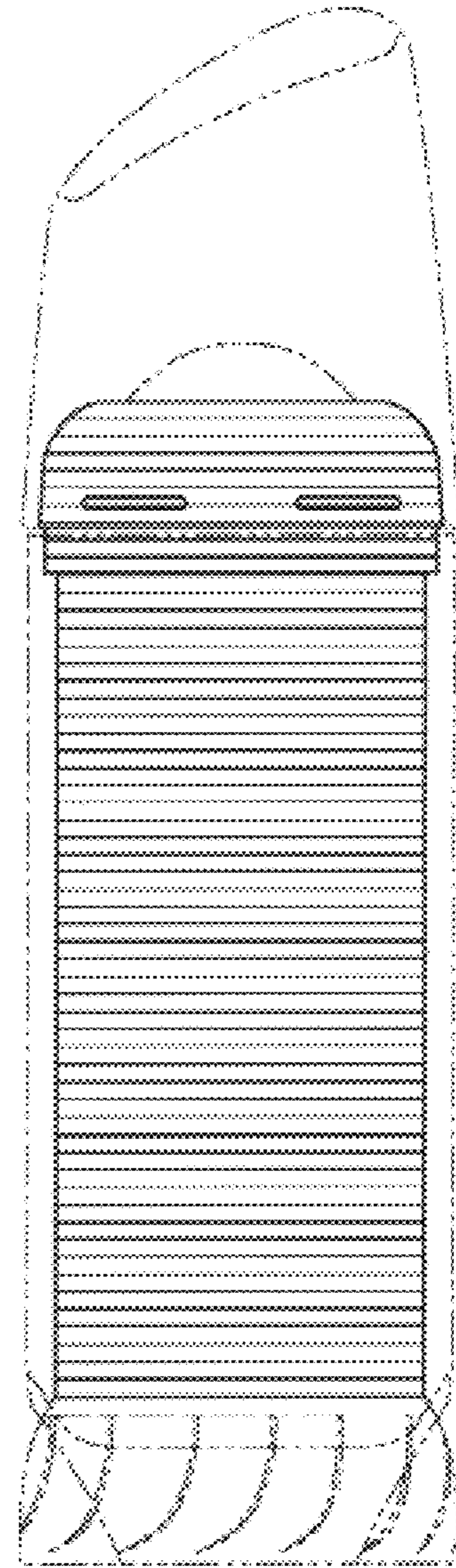

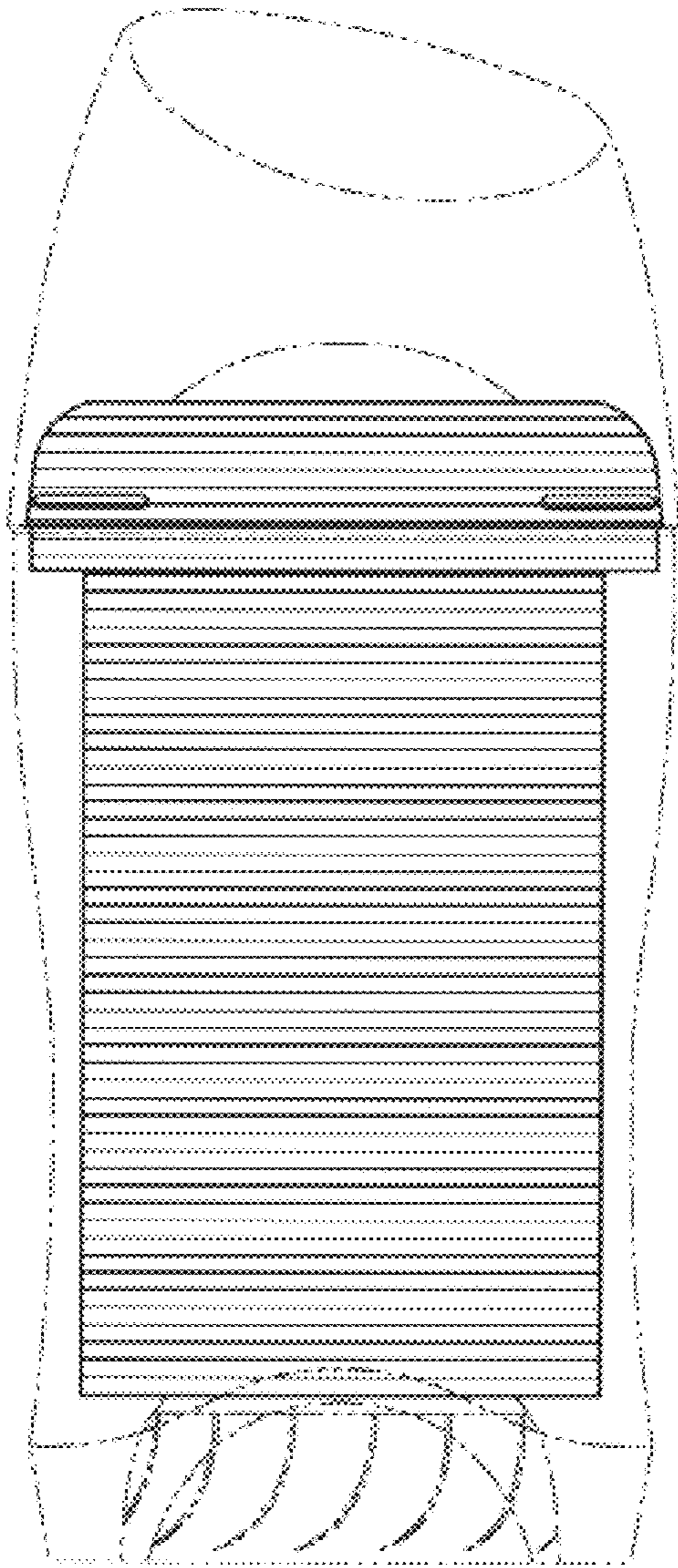

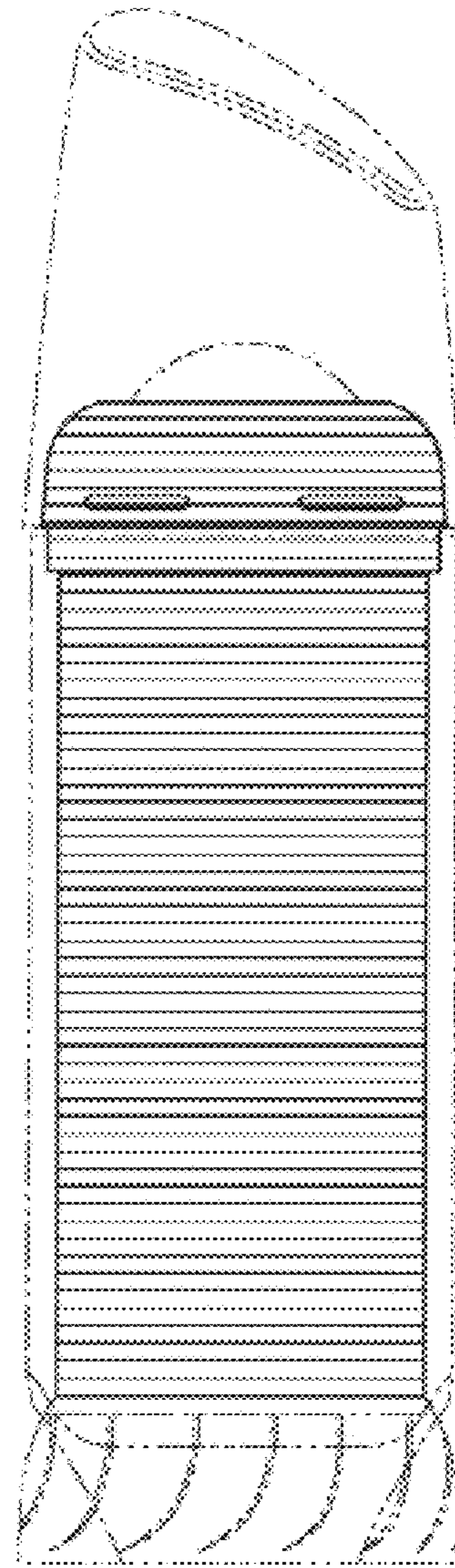

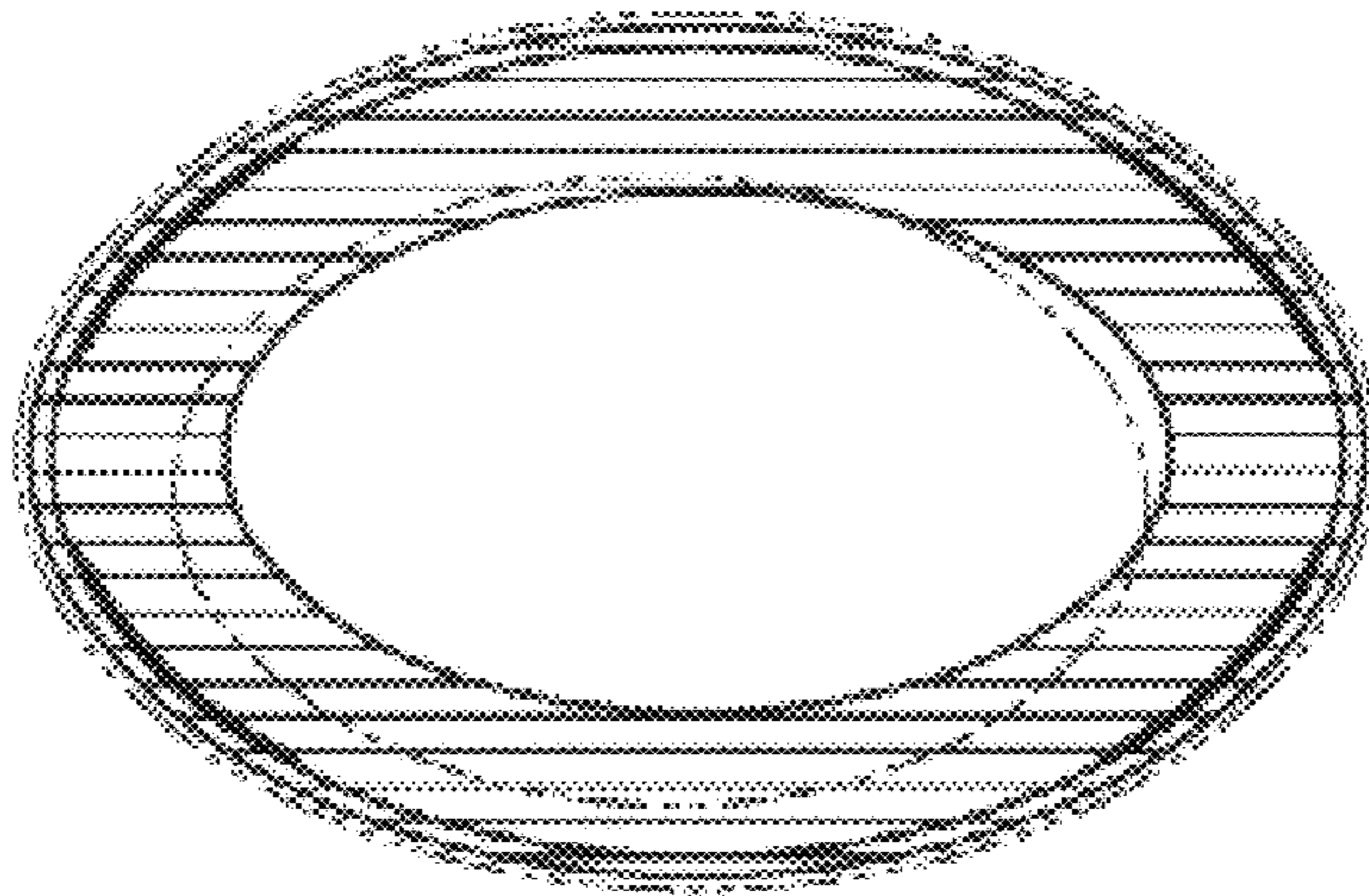

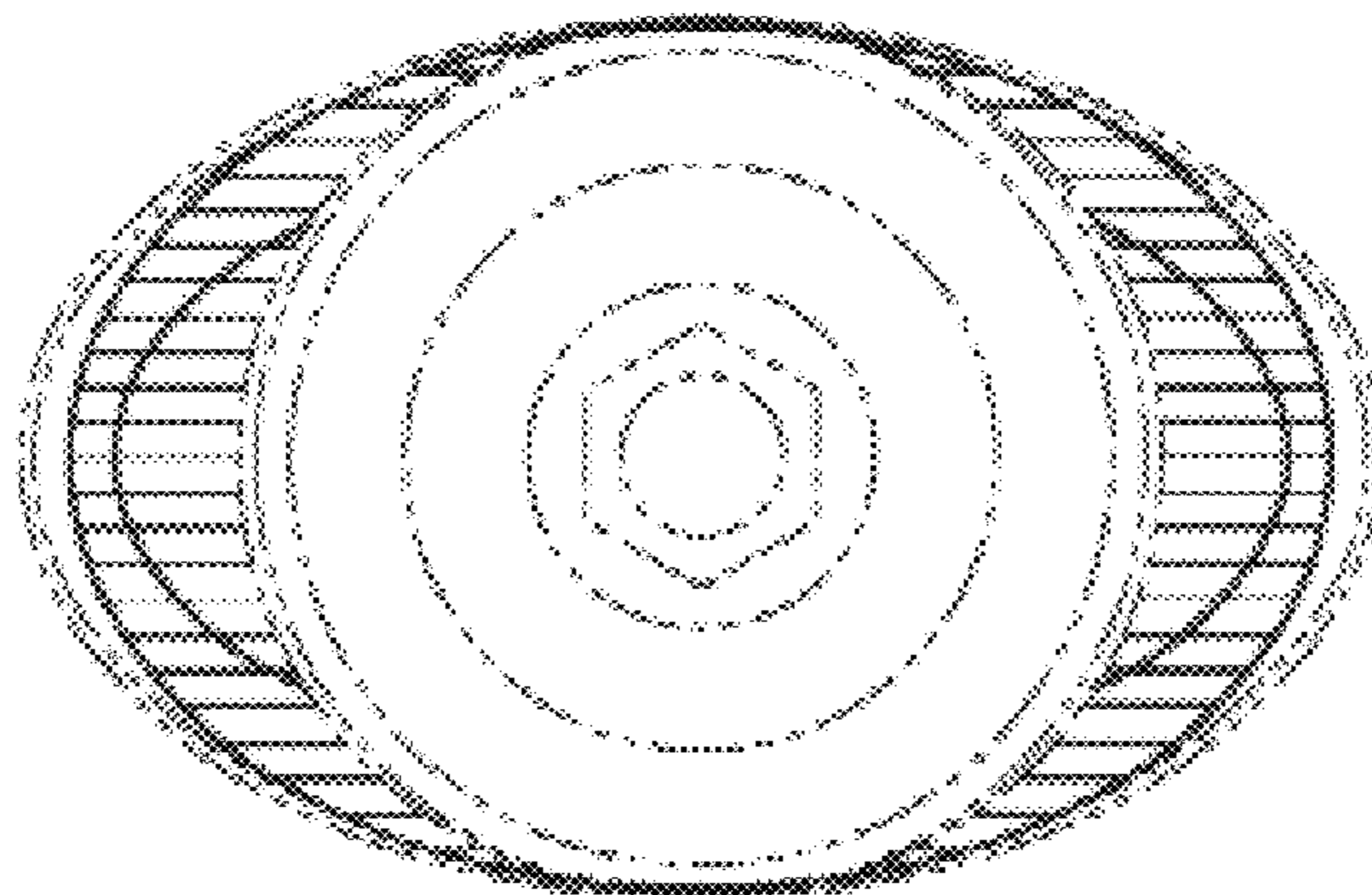
