FIG. 3 is a bottom view of the exhaust pipe;

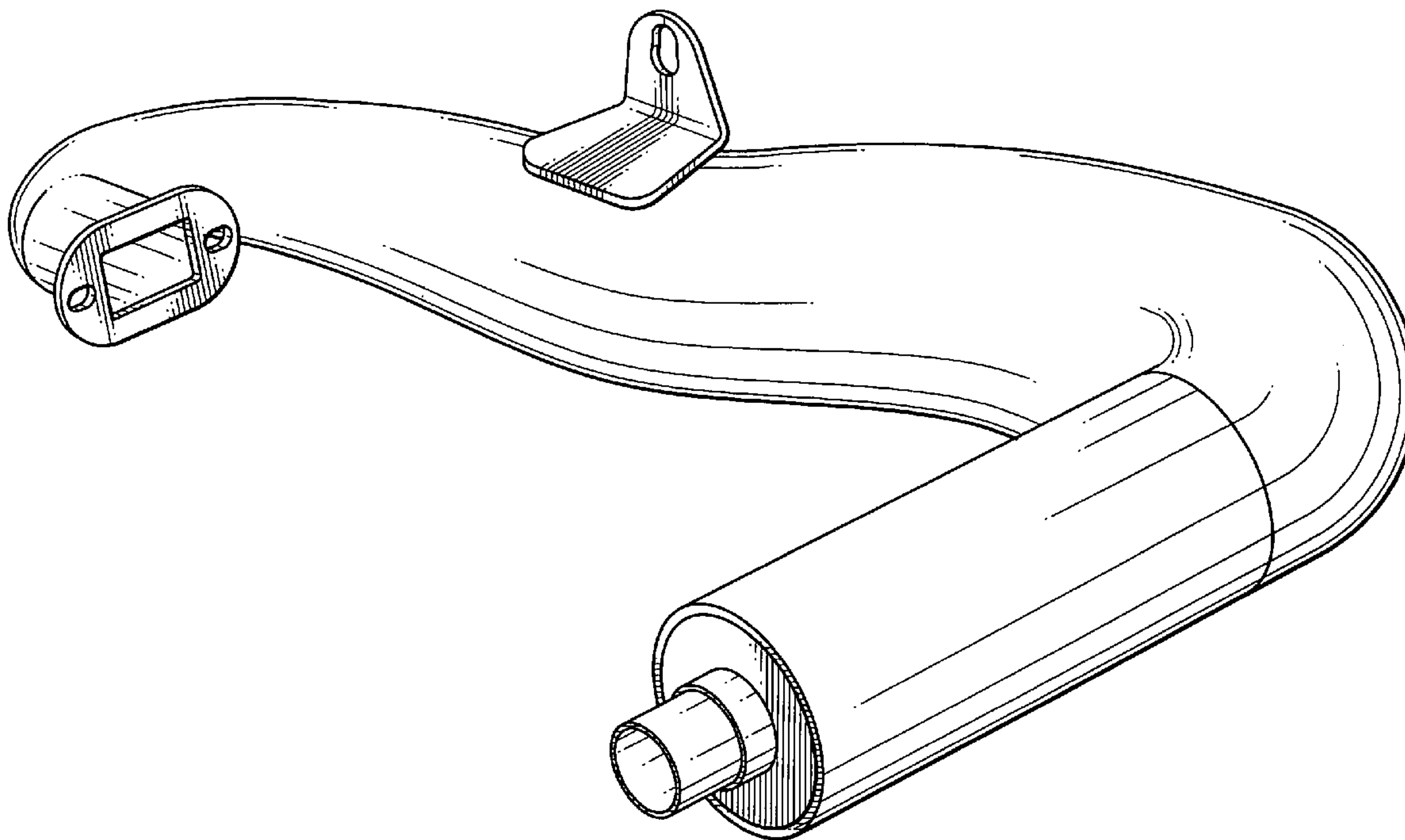
FIG. 4 is a front elevation view of the exhaust pipe;

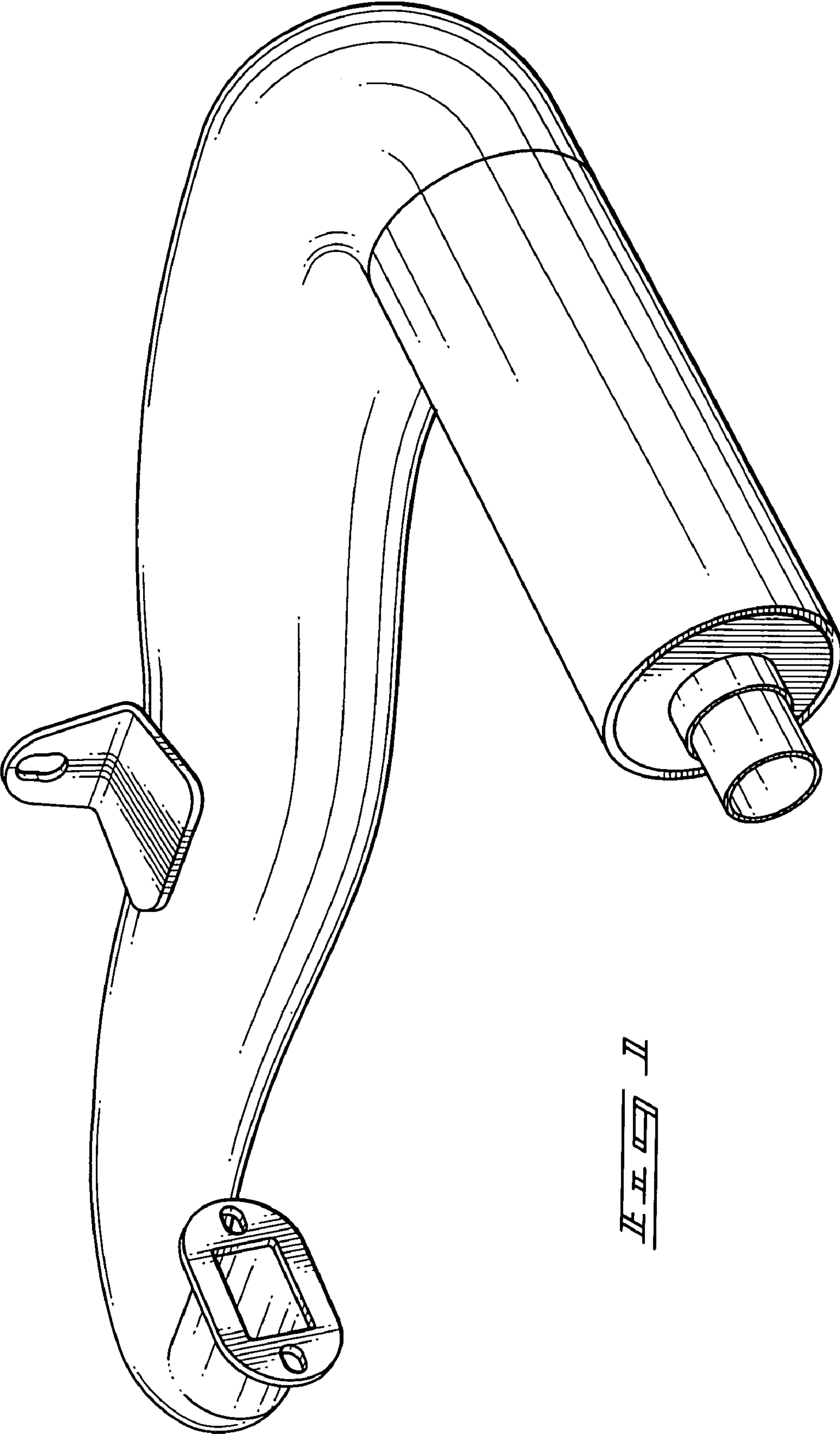
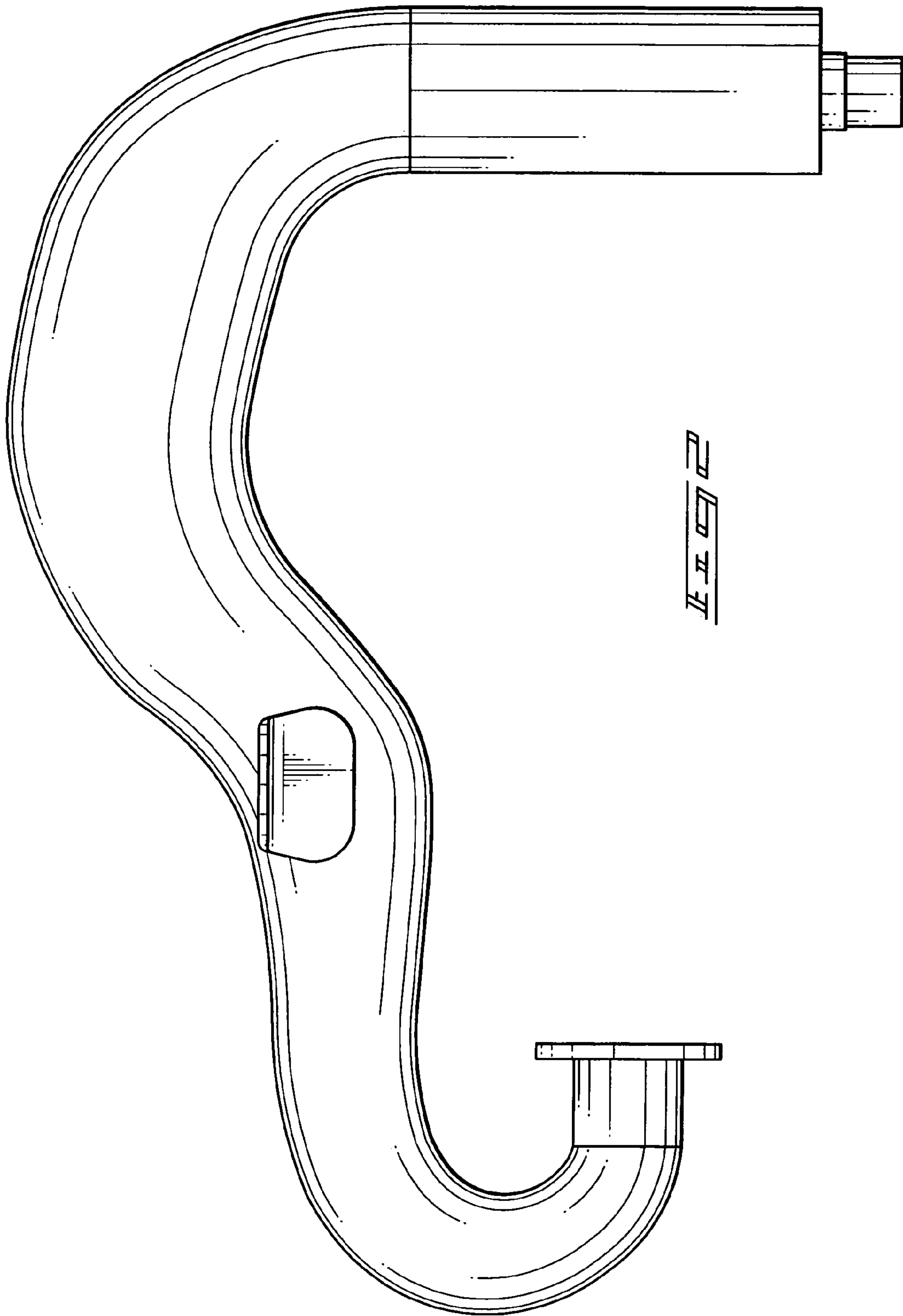

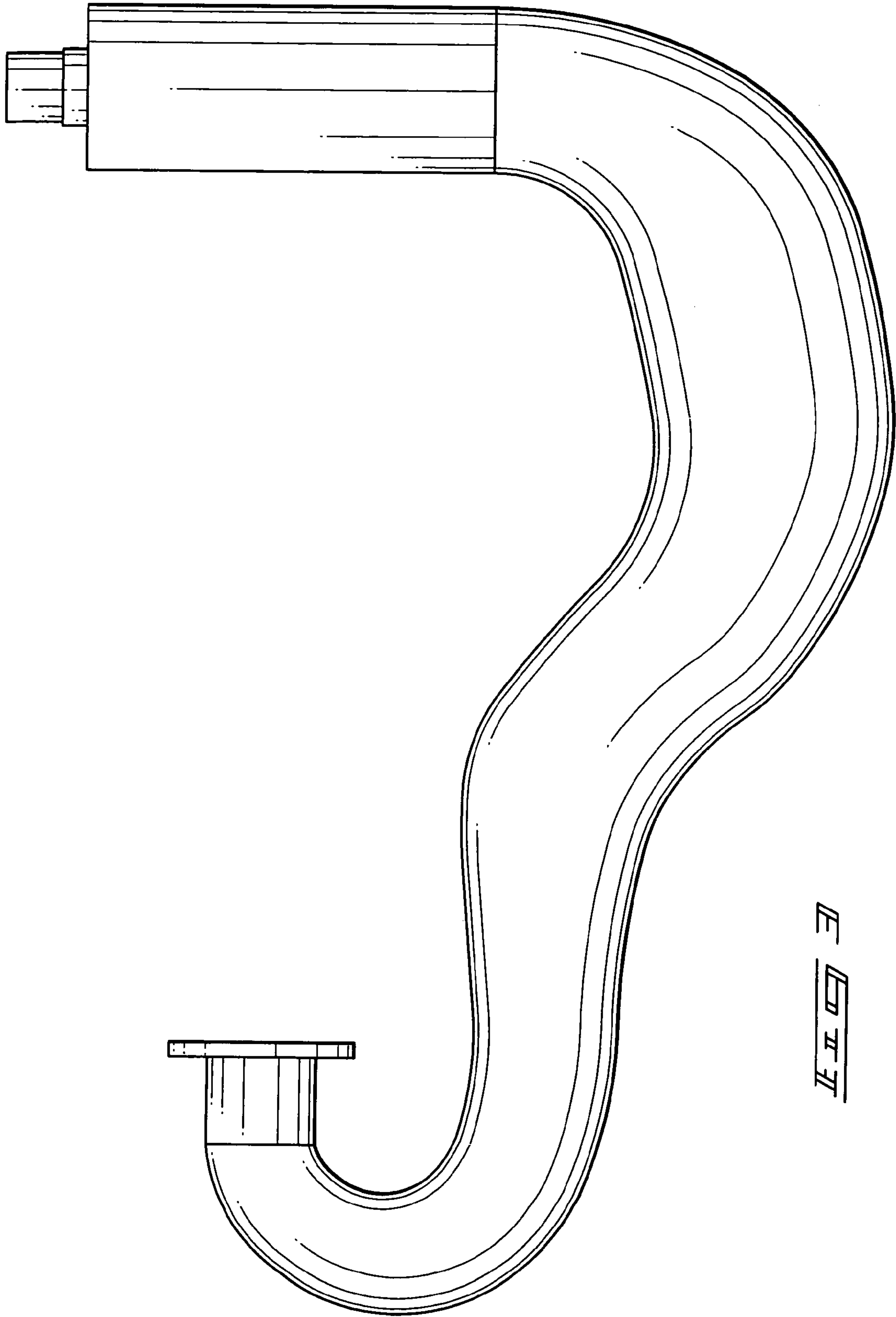
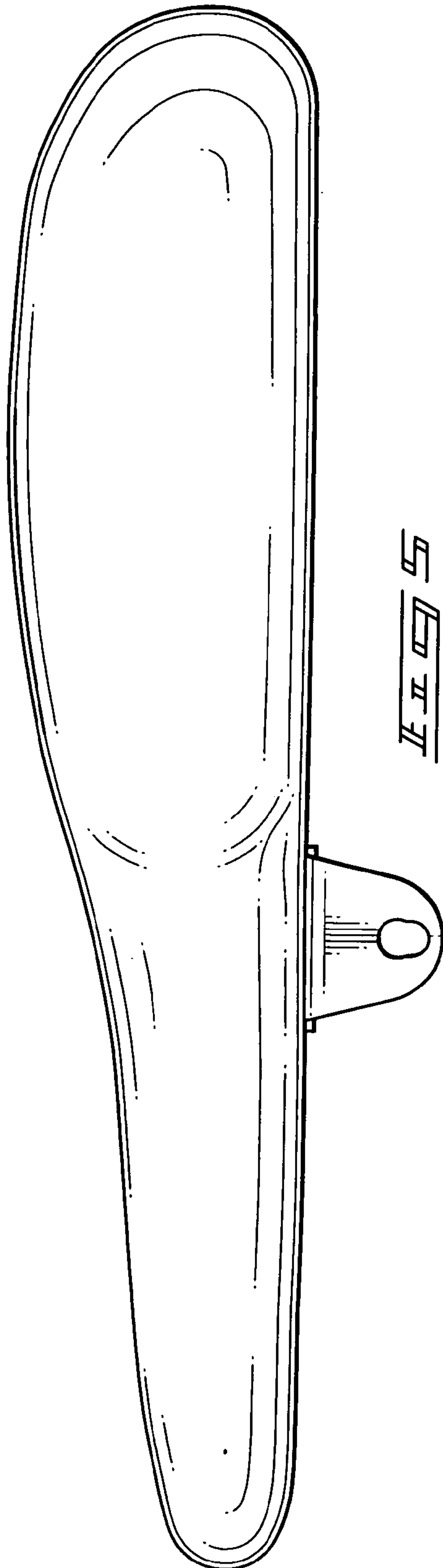
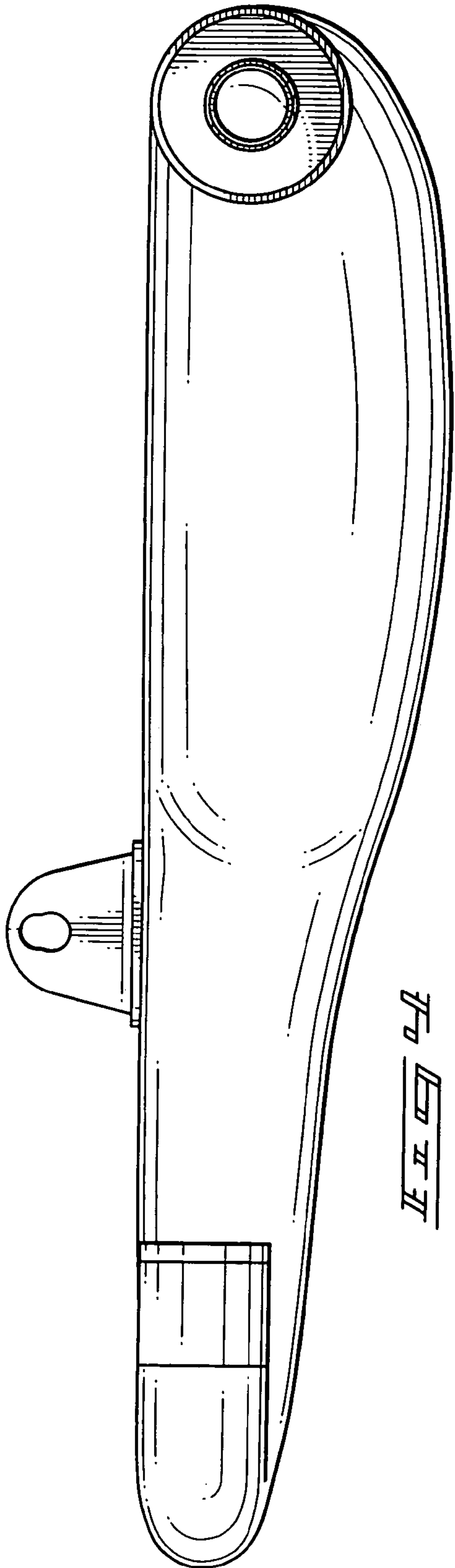

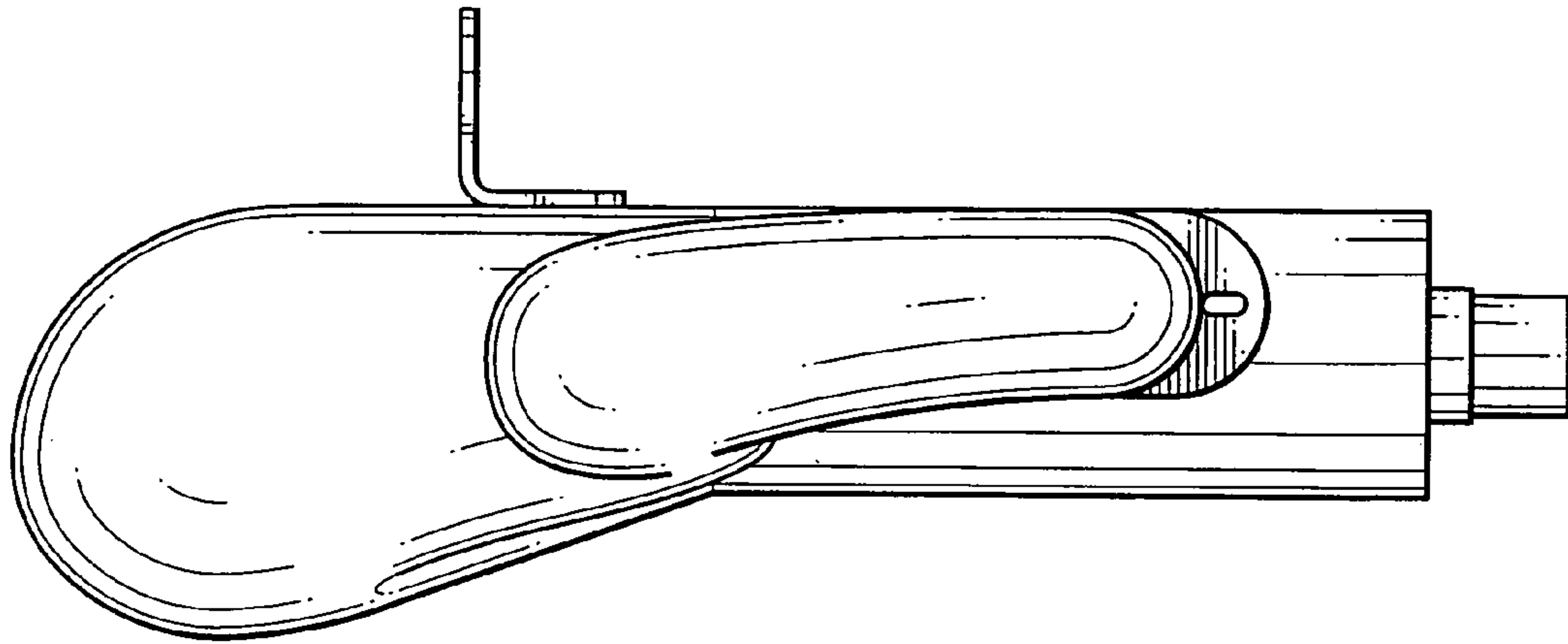

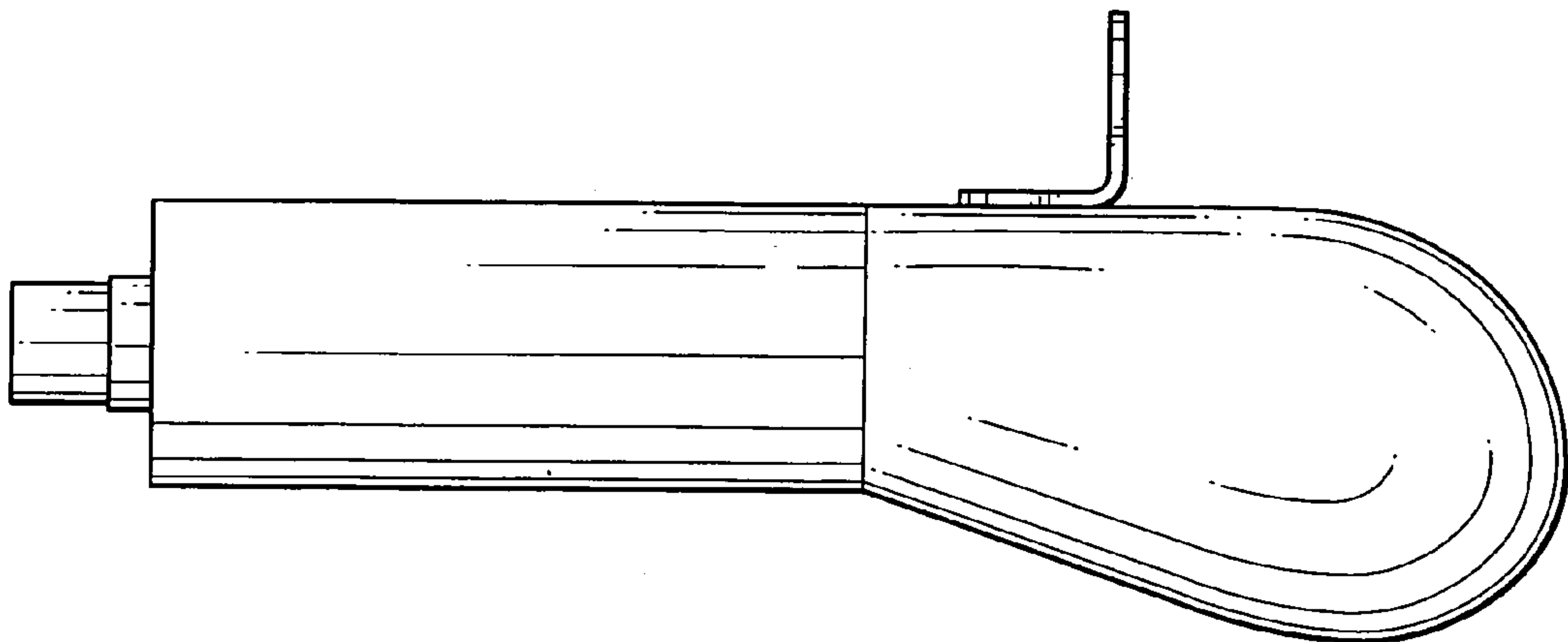
