FIG. 4 is a left side orthographic view thereof.

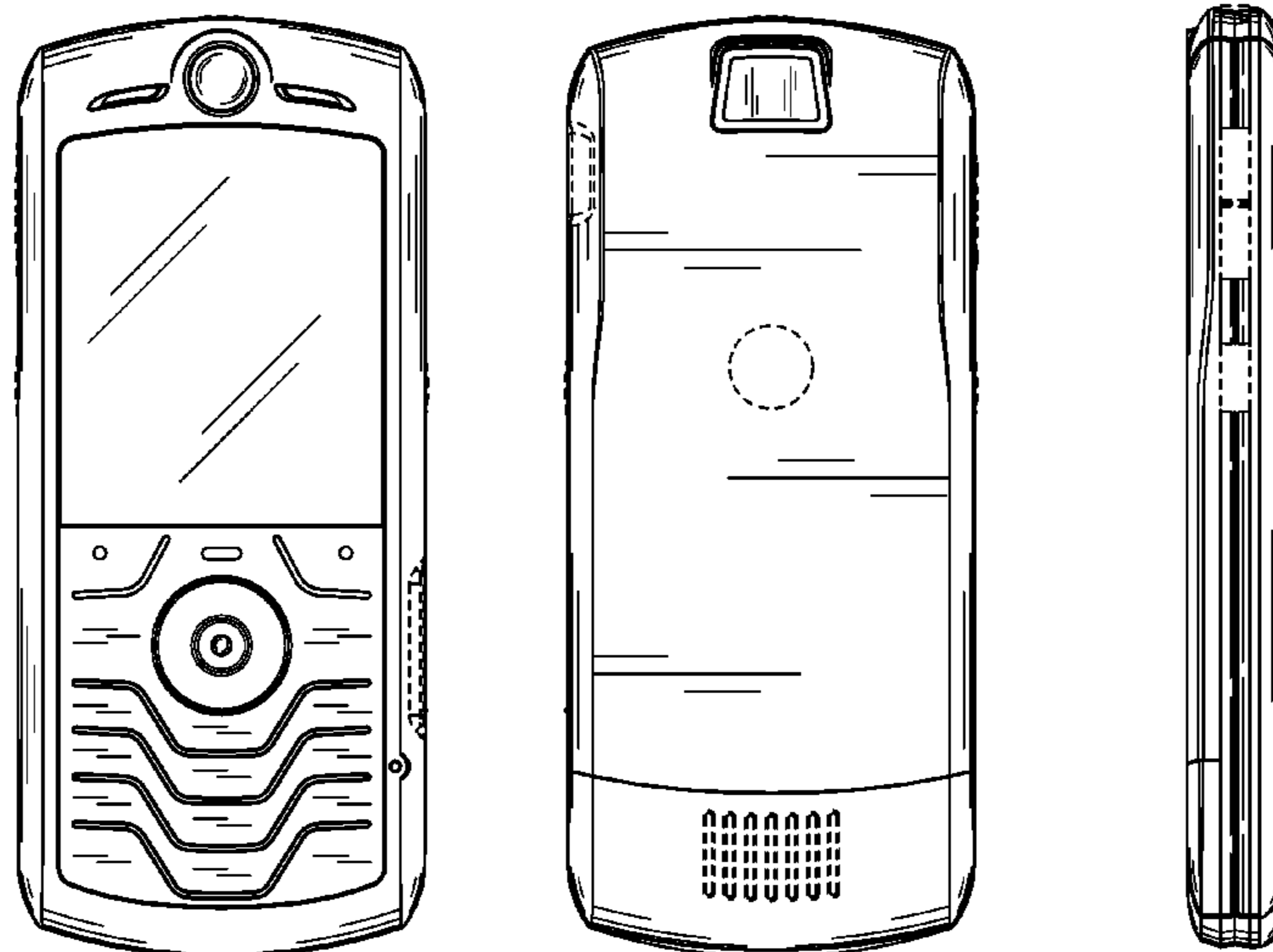
FIG. 5 is a right side orthographic view thereof.

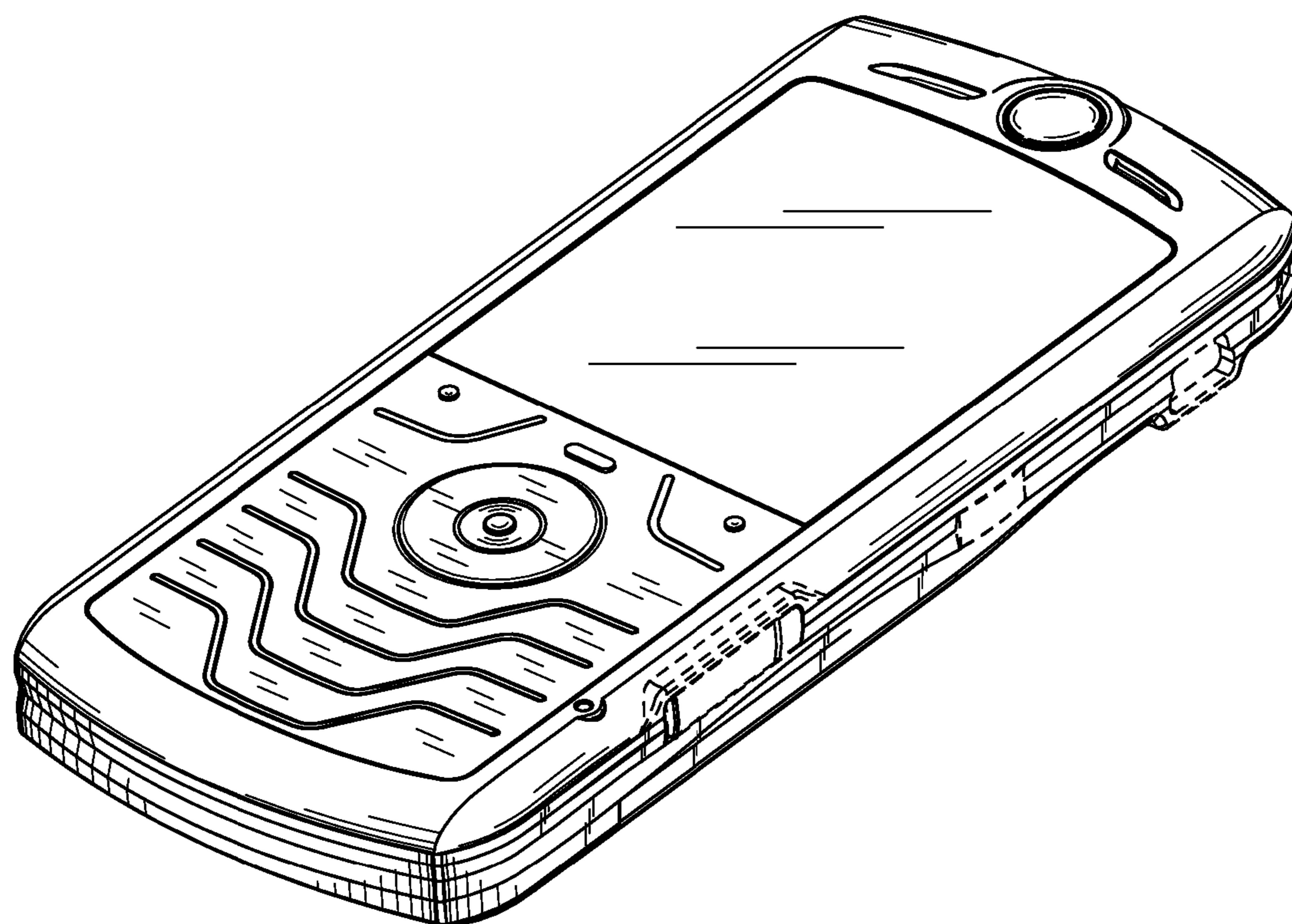

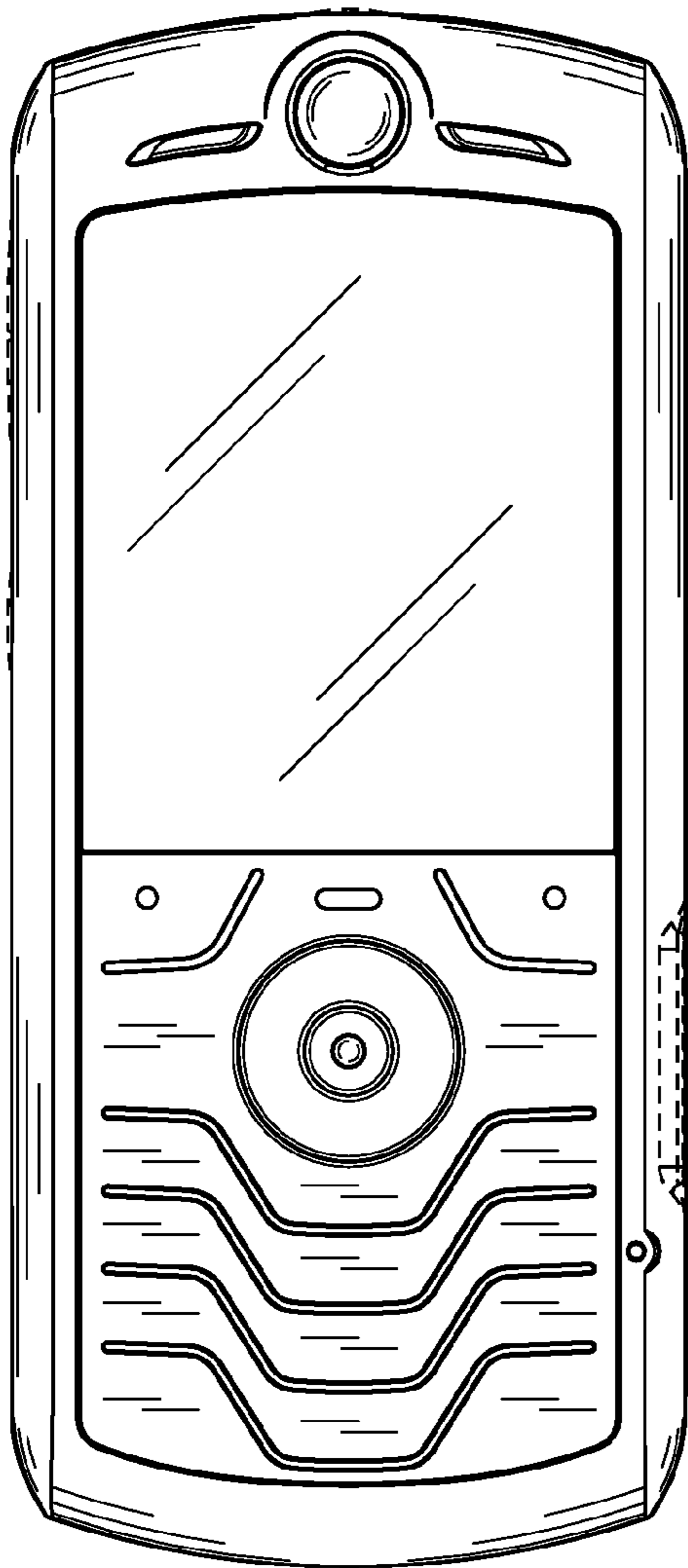

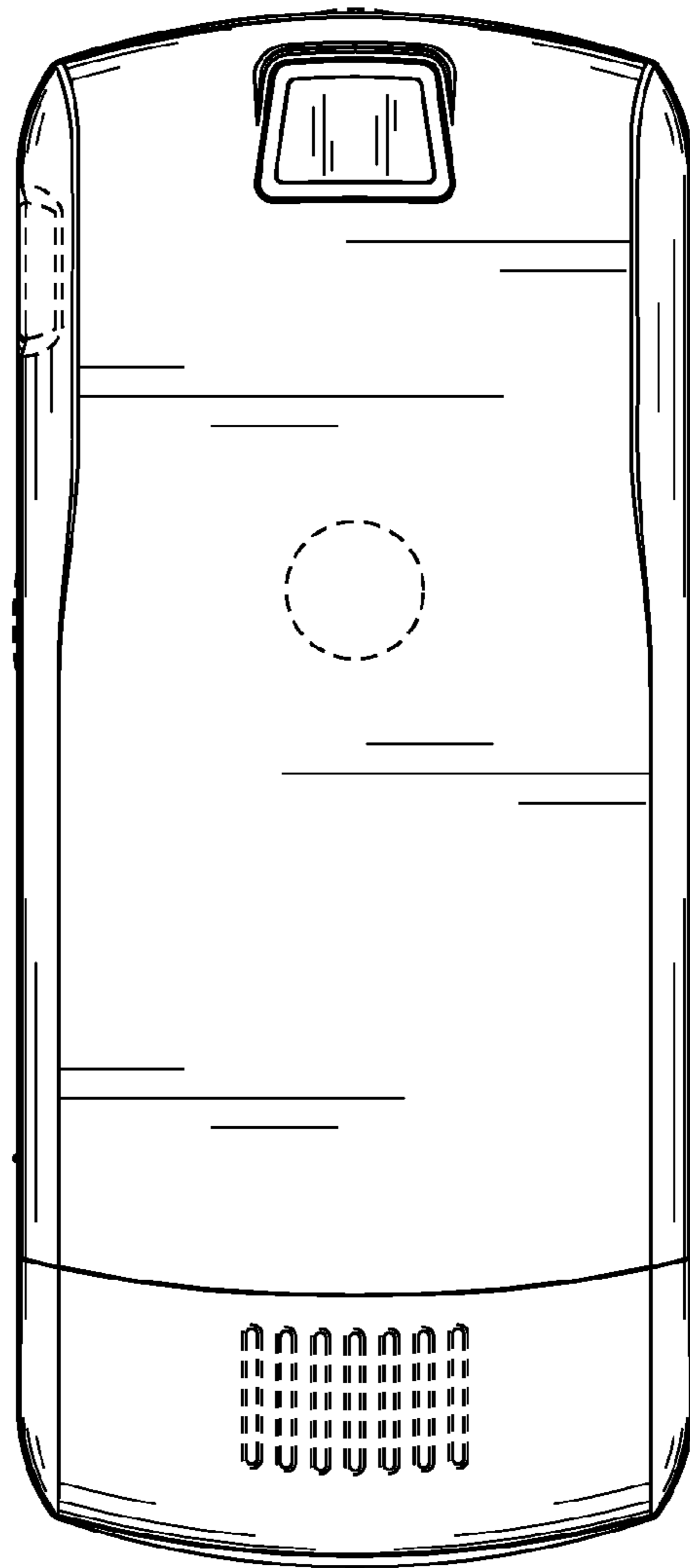

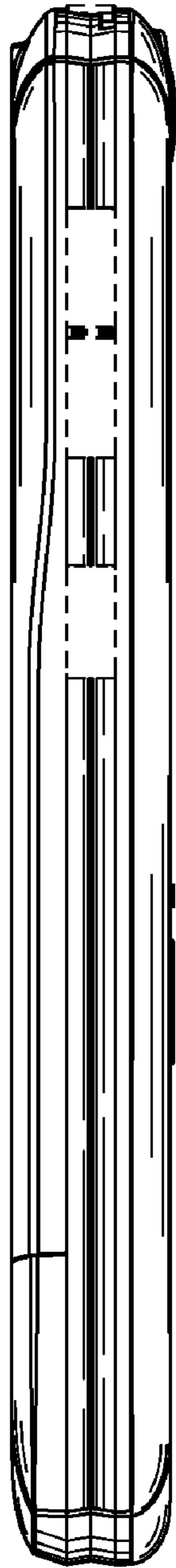

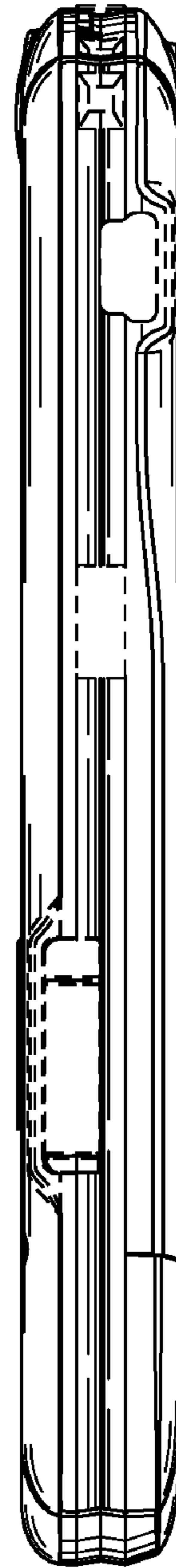

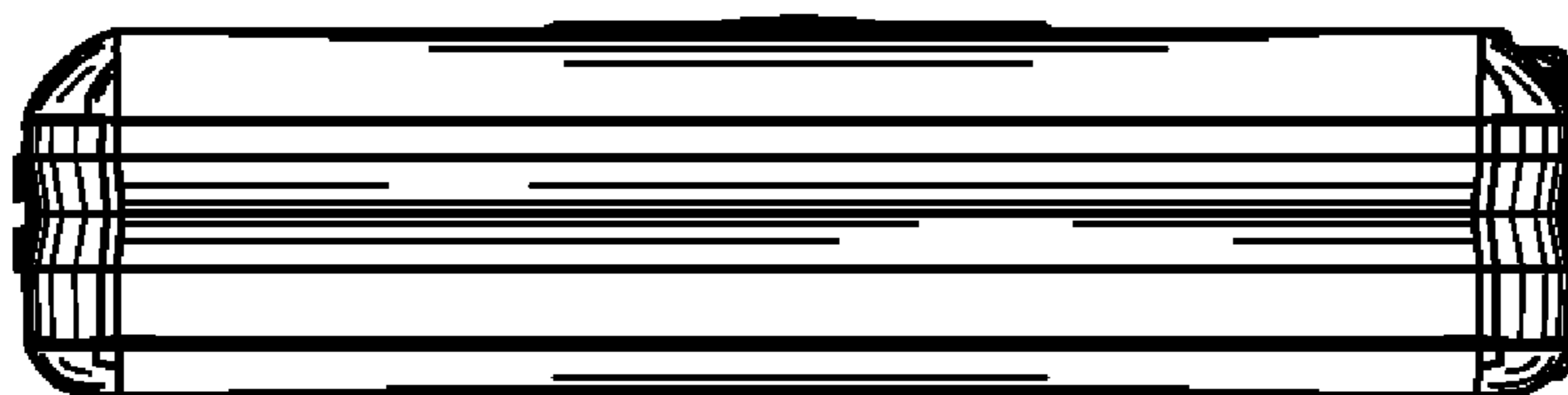
