DESCRIPTION

FIG. 1 is a perspective view of cellular phone showing the new design:

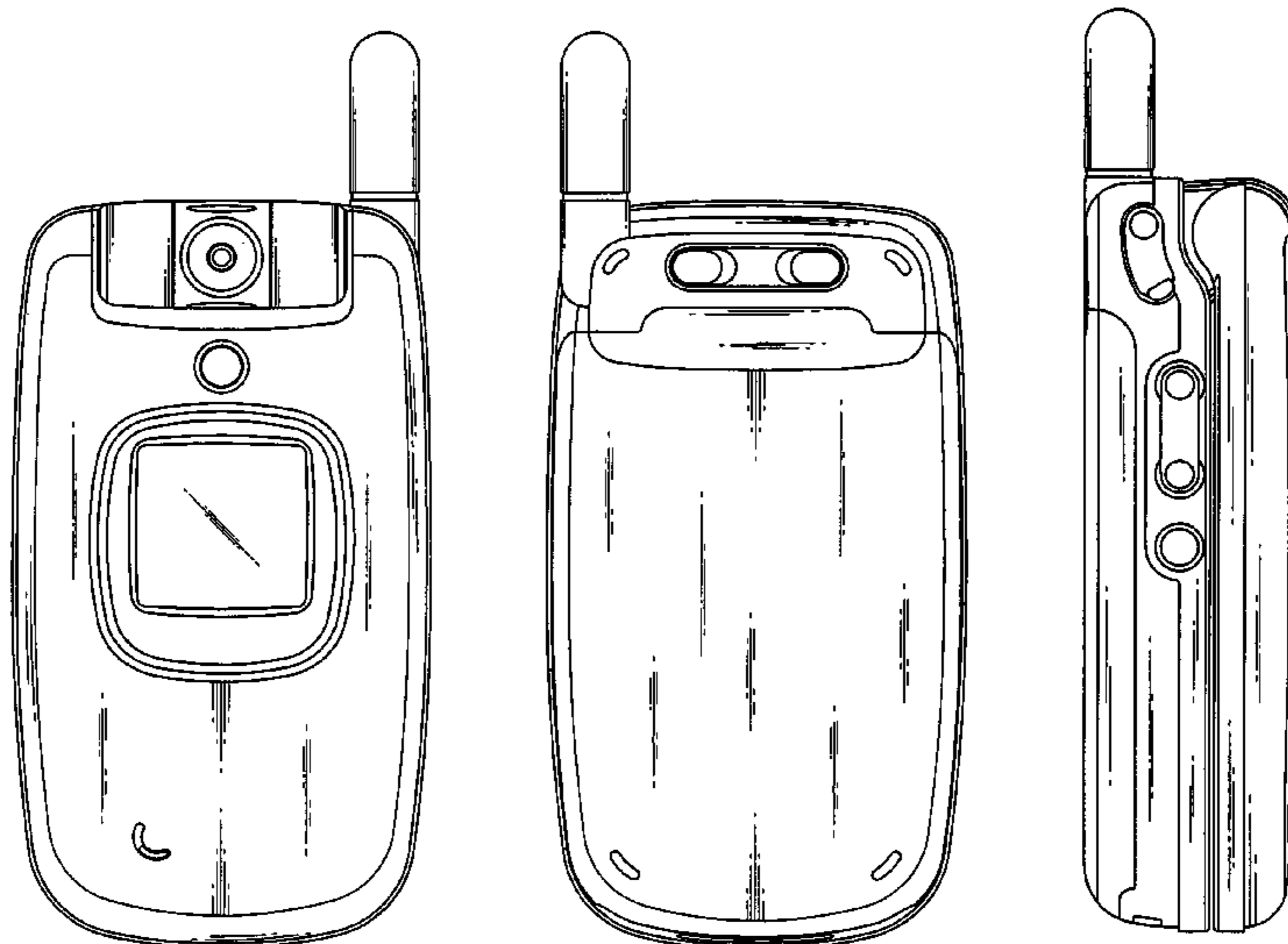

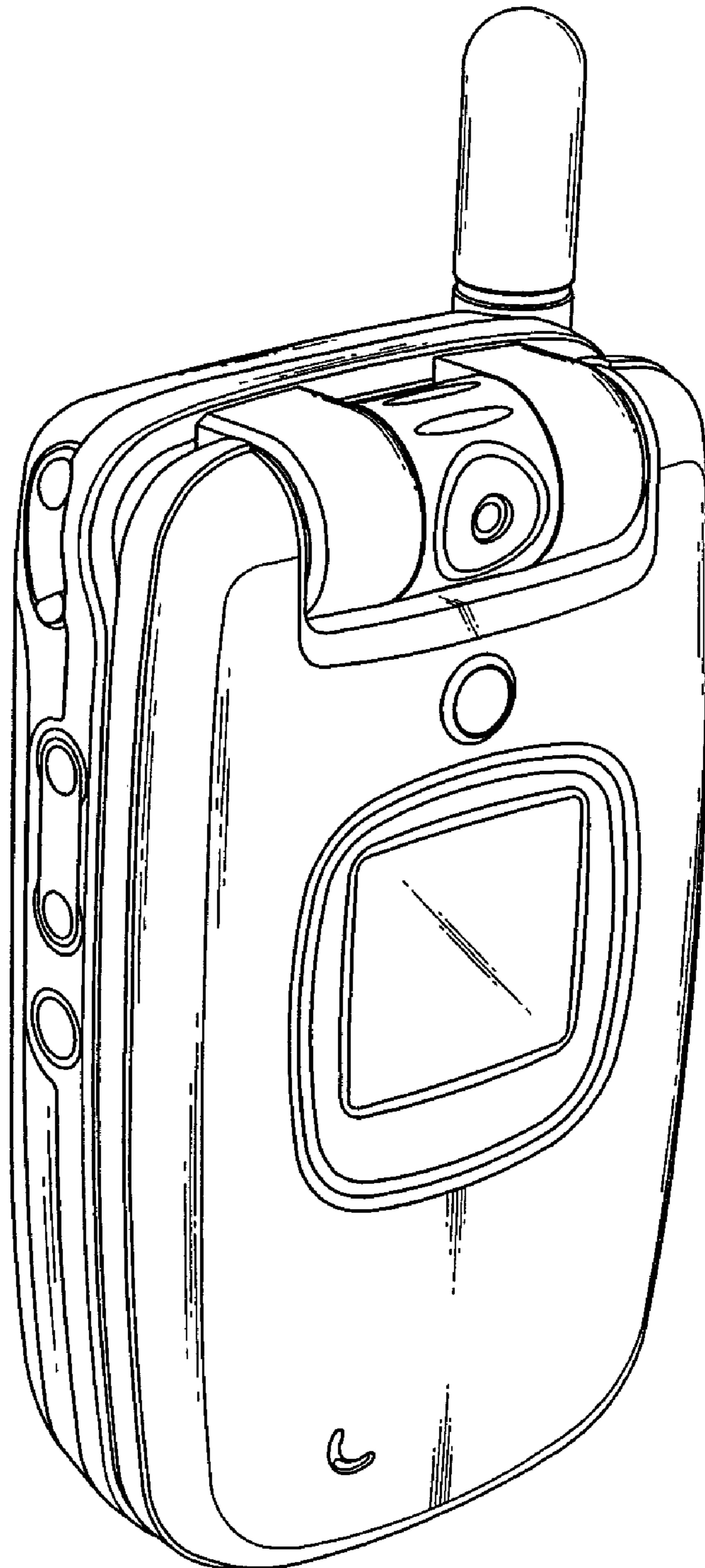

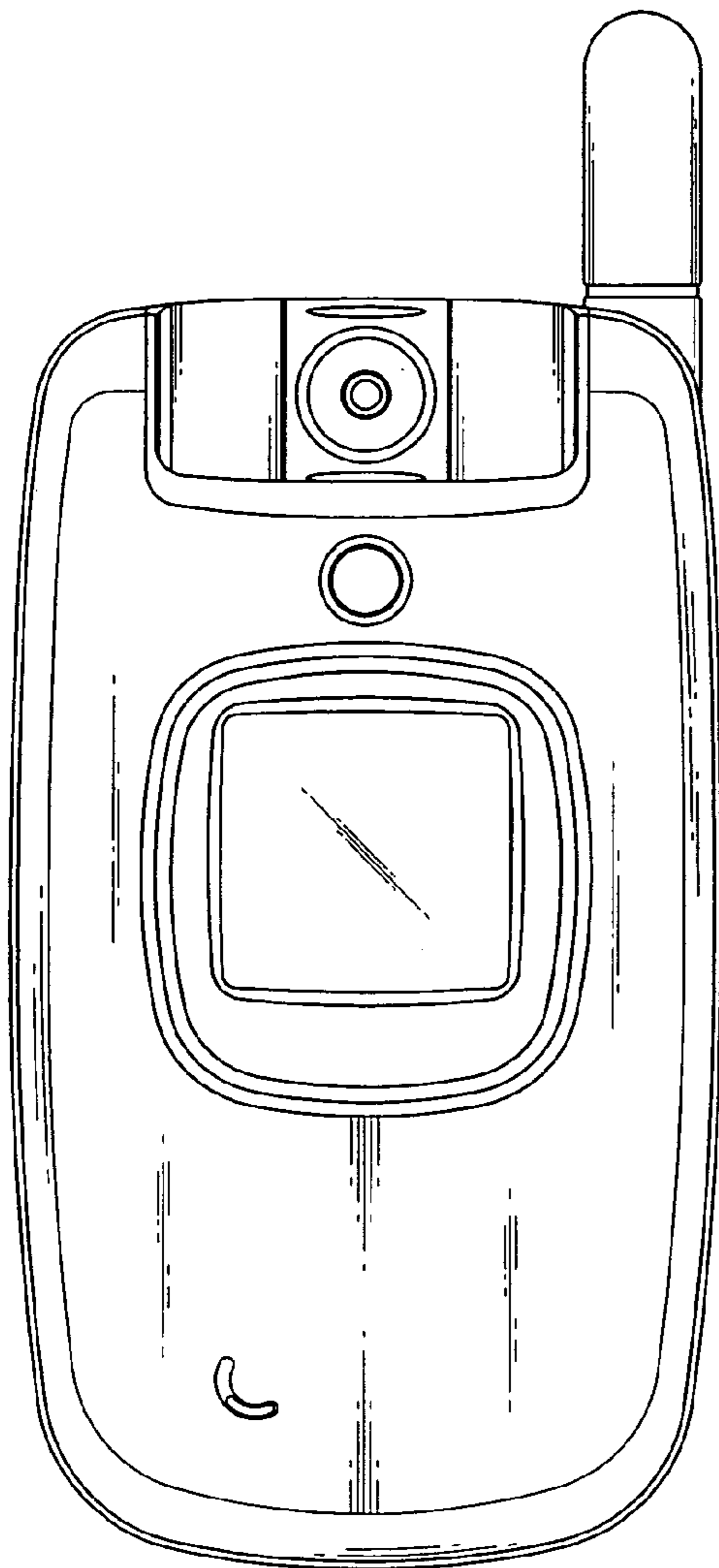

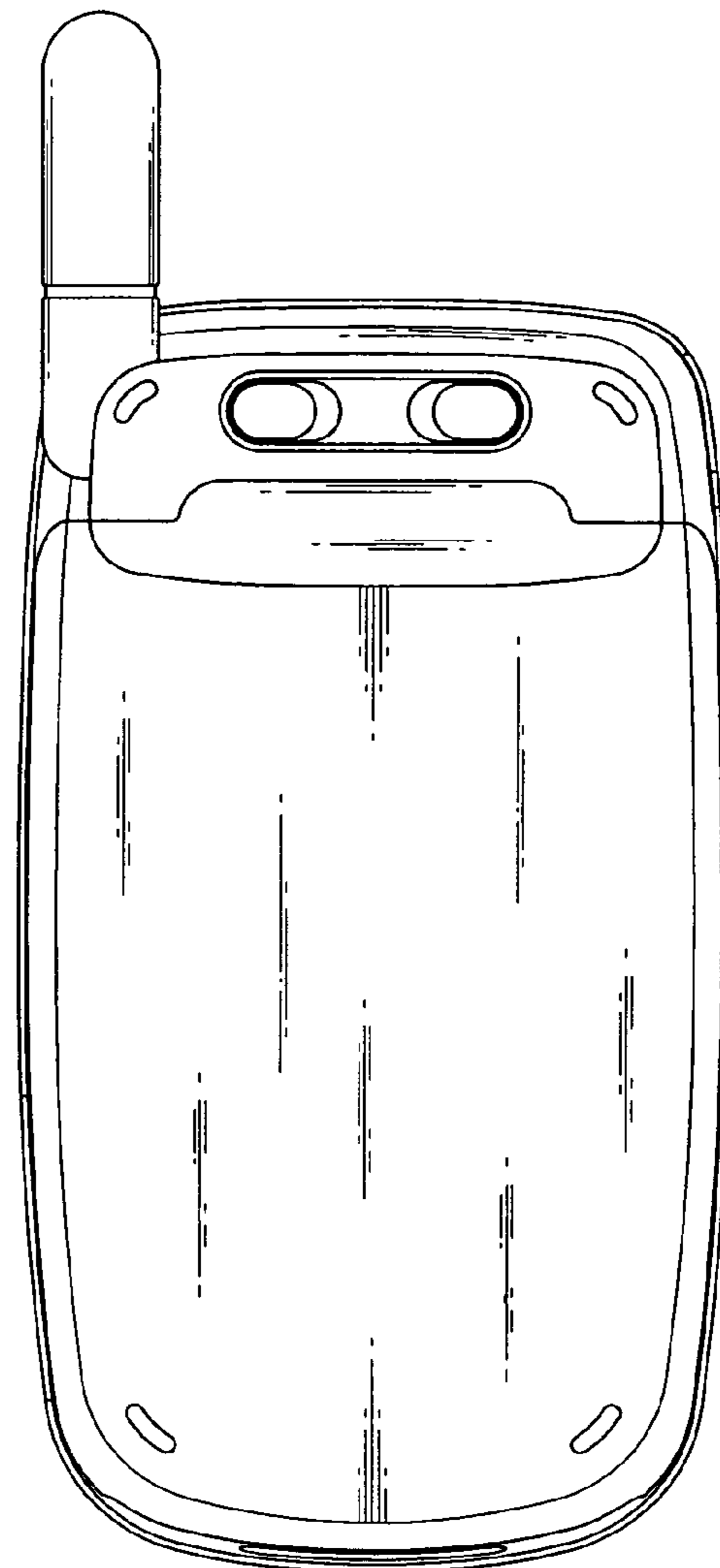

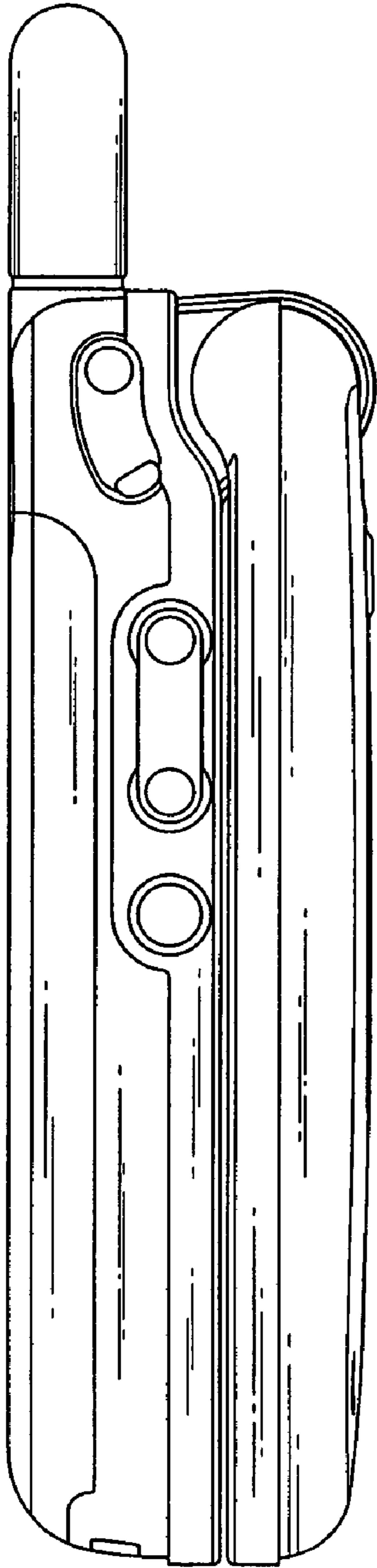

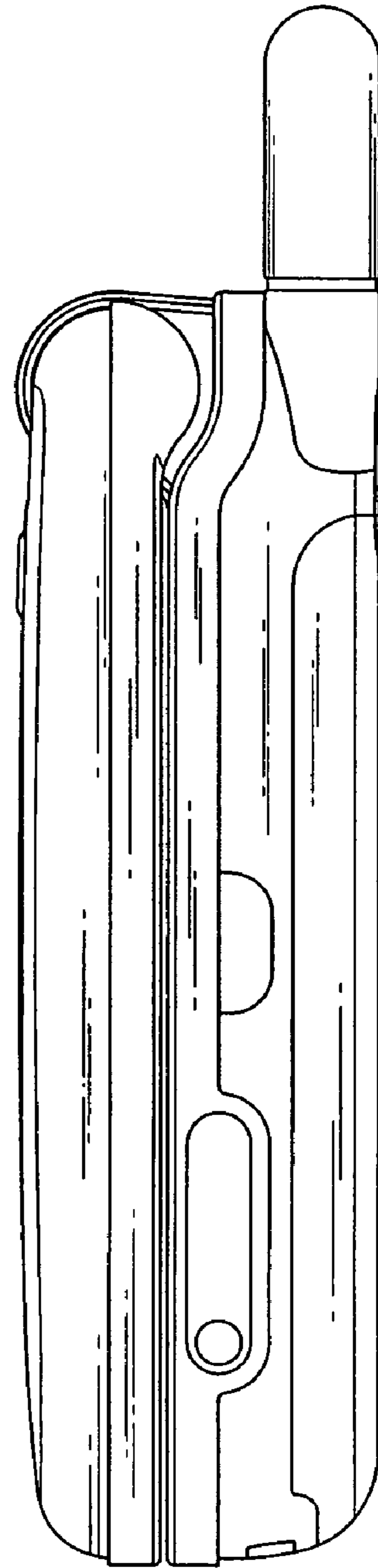

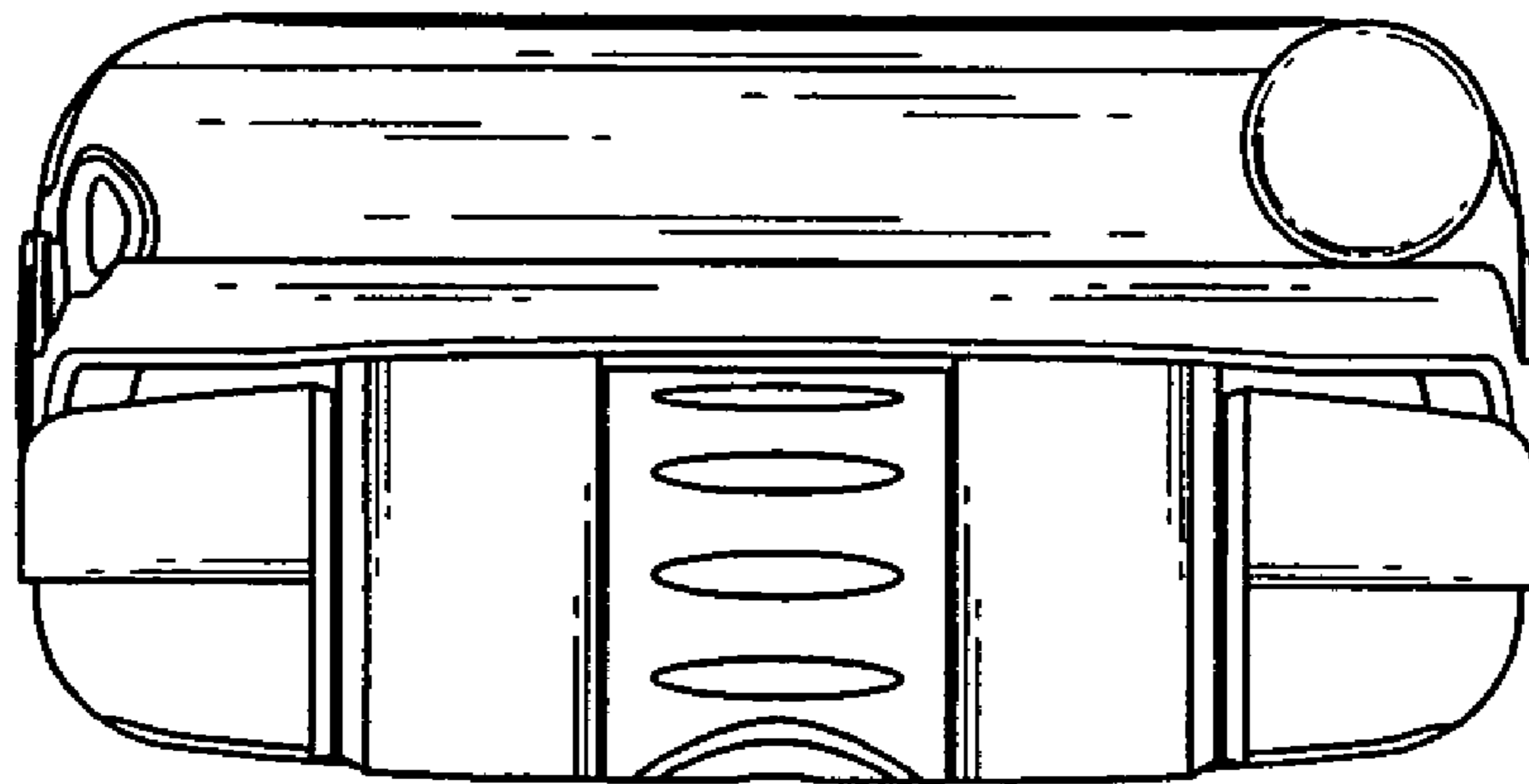
