(57) **CLAIM**

The ornamental design for a kitchen shredder, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a kitchen shredder with lids in the closed position, showing our new design.

FIG. 2 is a rear perspective view thereof.

FIG. 3 is a top plan view thereof.

FIG. 4 is a front elevational view thereof.

FIG. 5 is a right side elevational view thereof, the left side being a mirror image thereof.

FIG. 6 is a rear elevational view thereof; and,

FIG. 7 is a bottom view thereof.

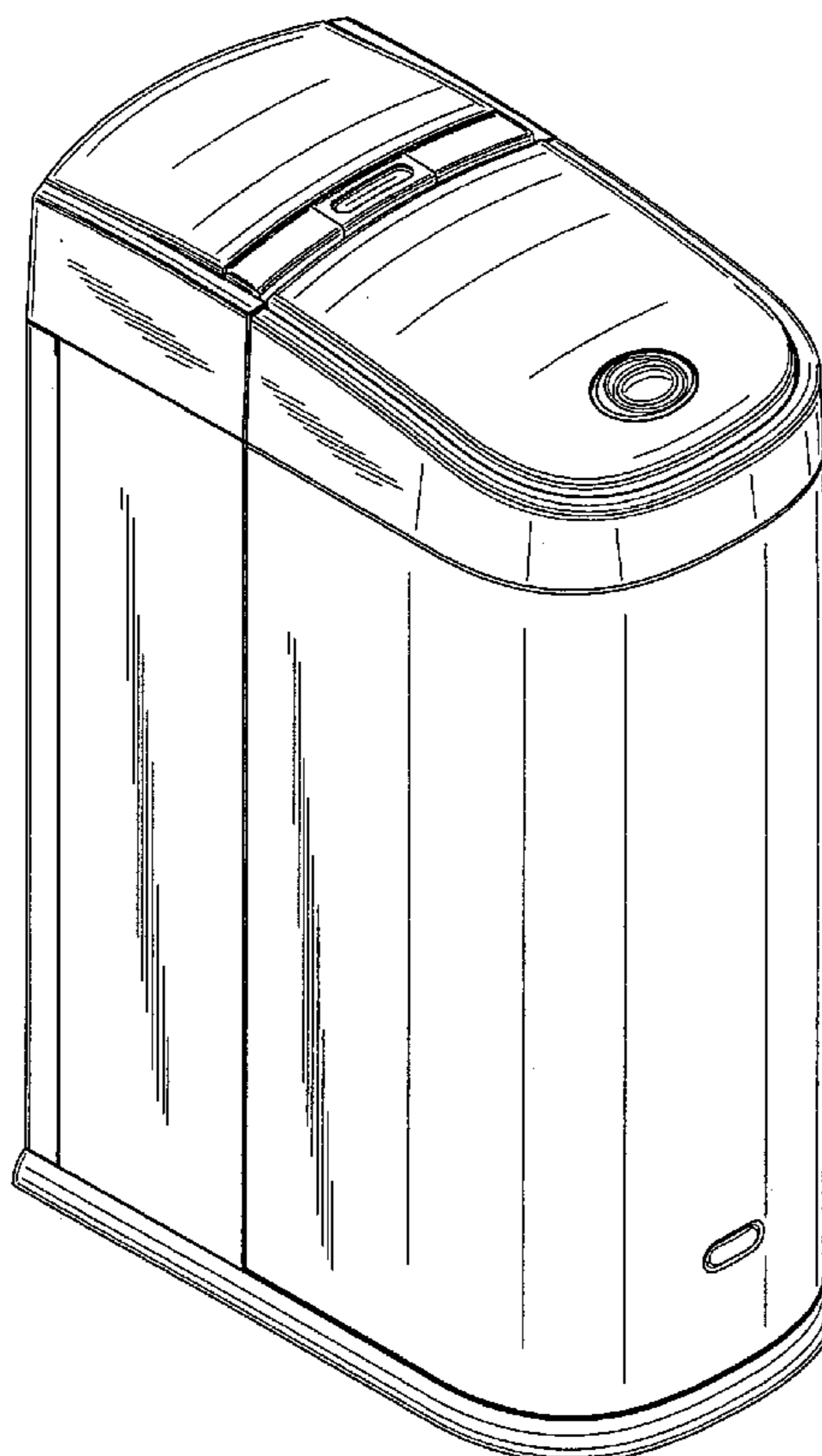

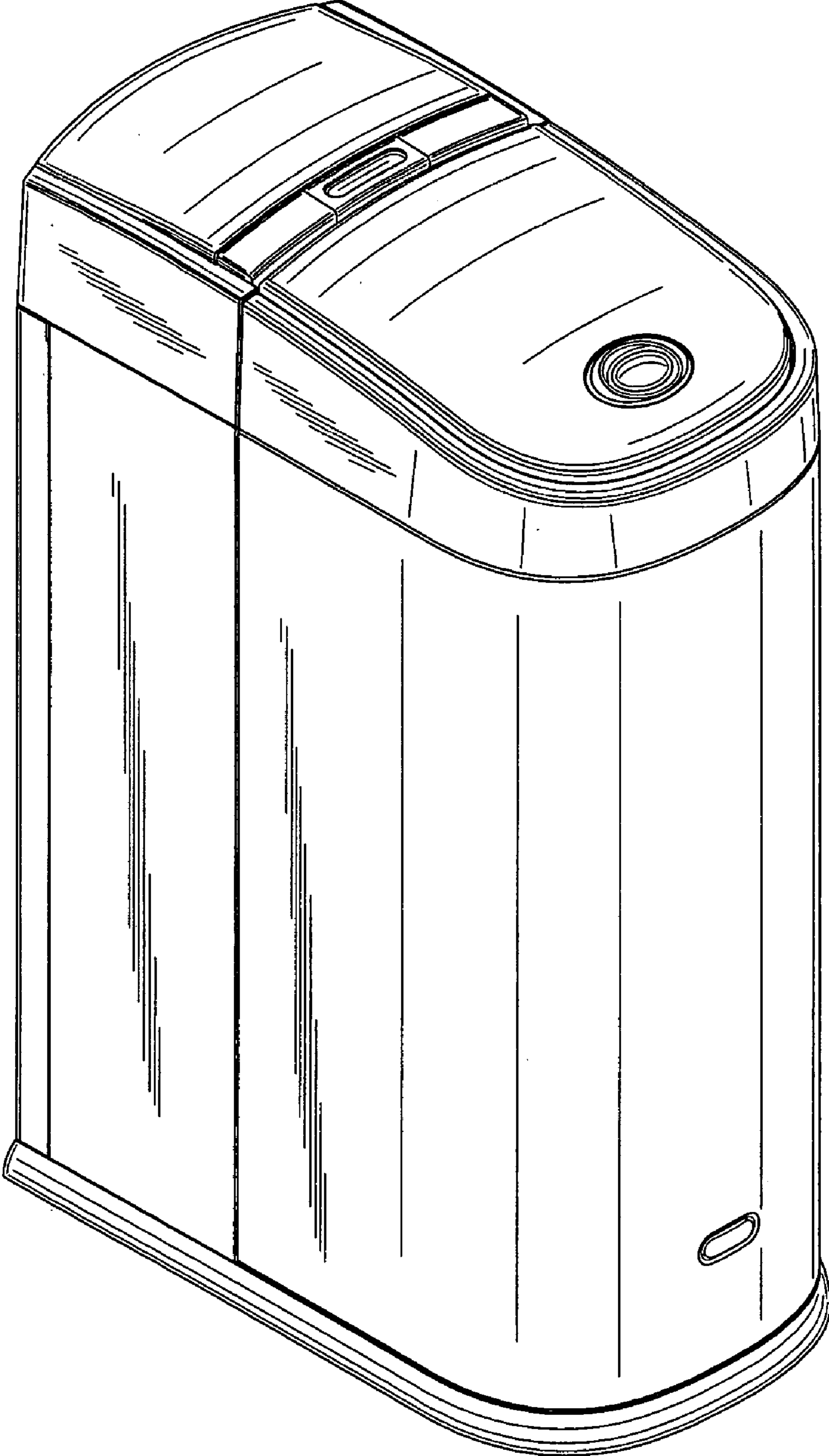

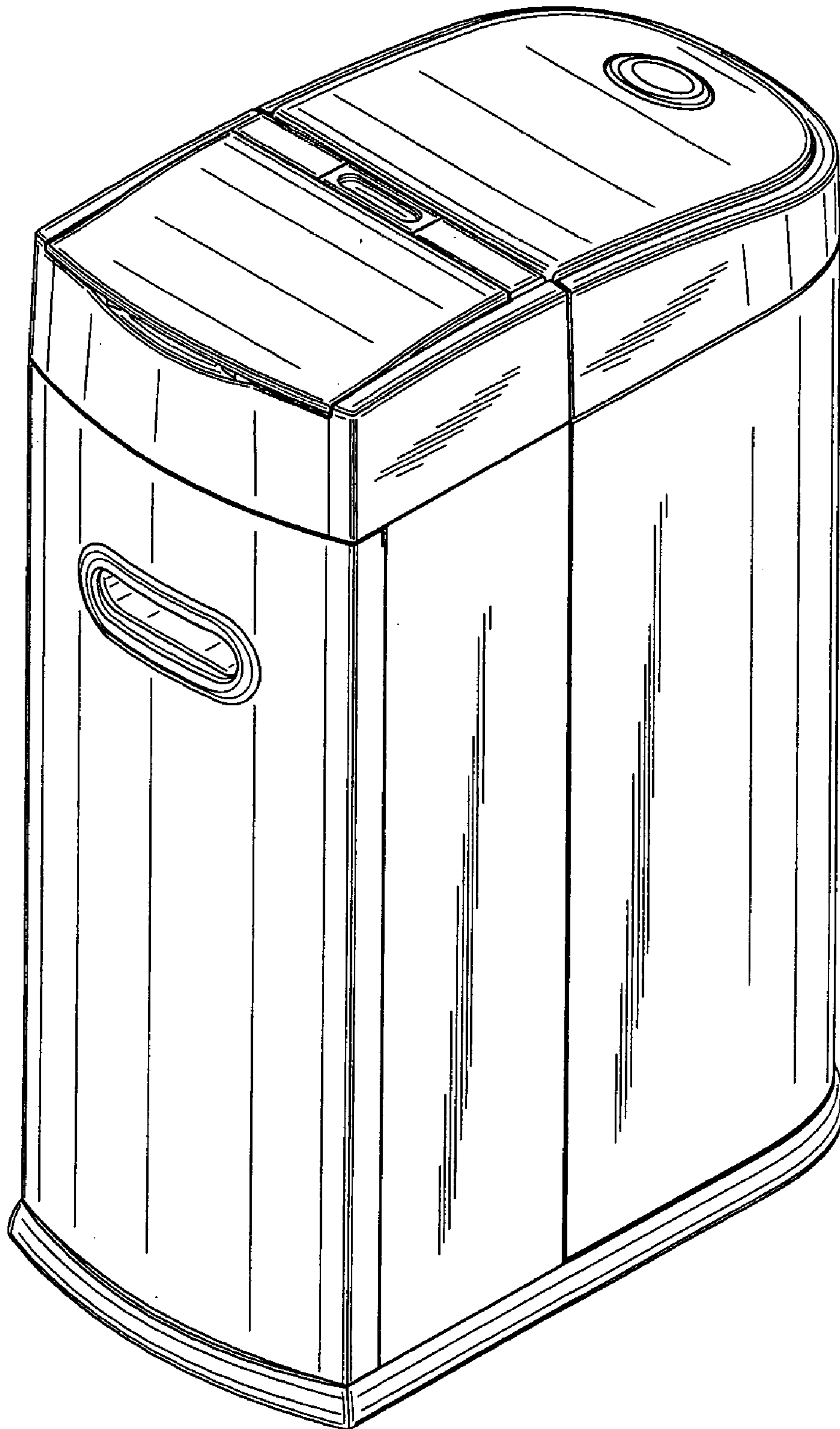

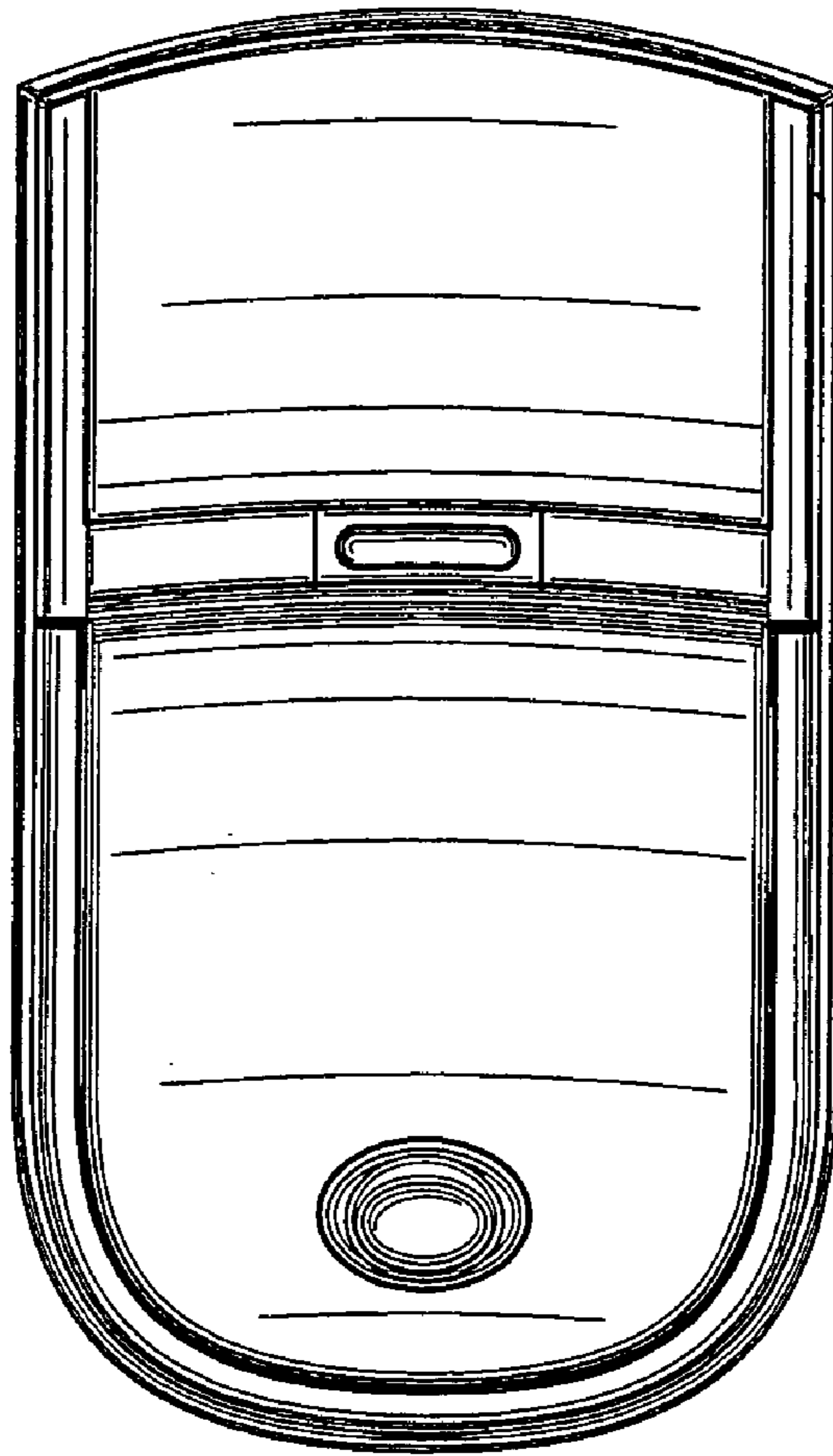

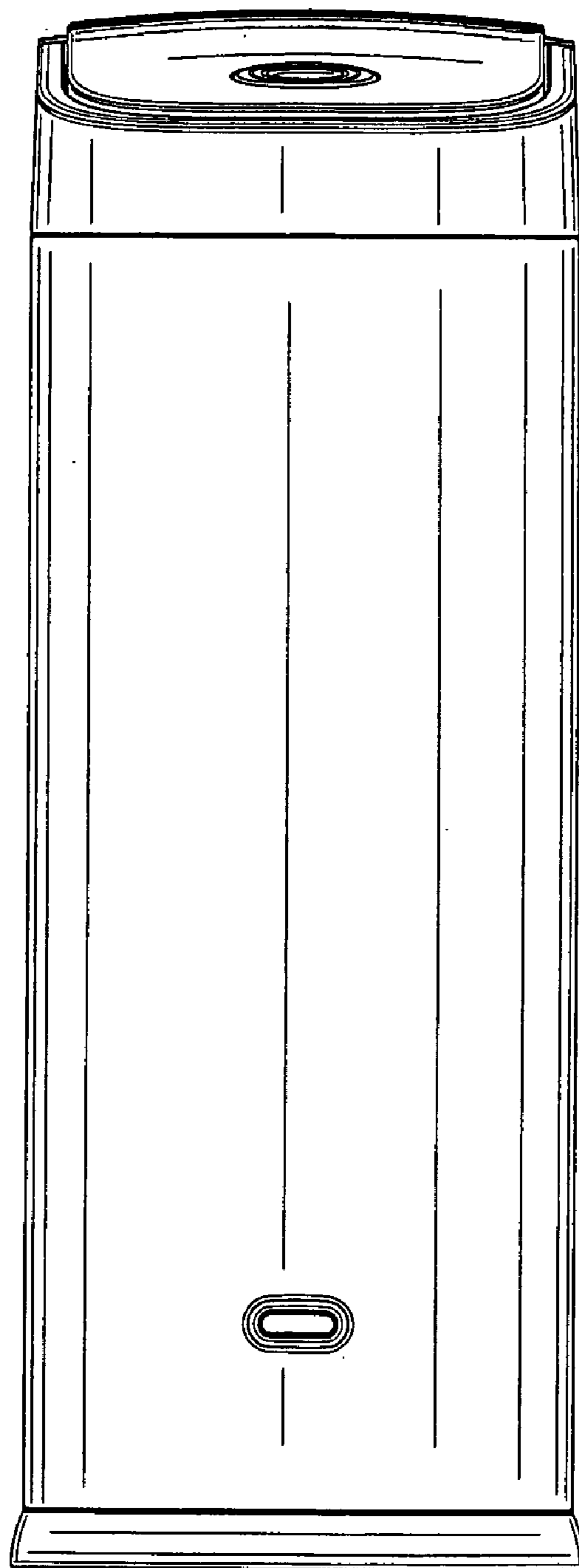

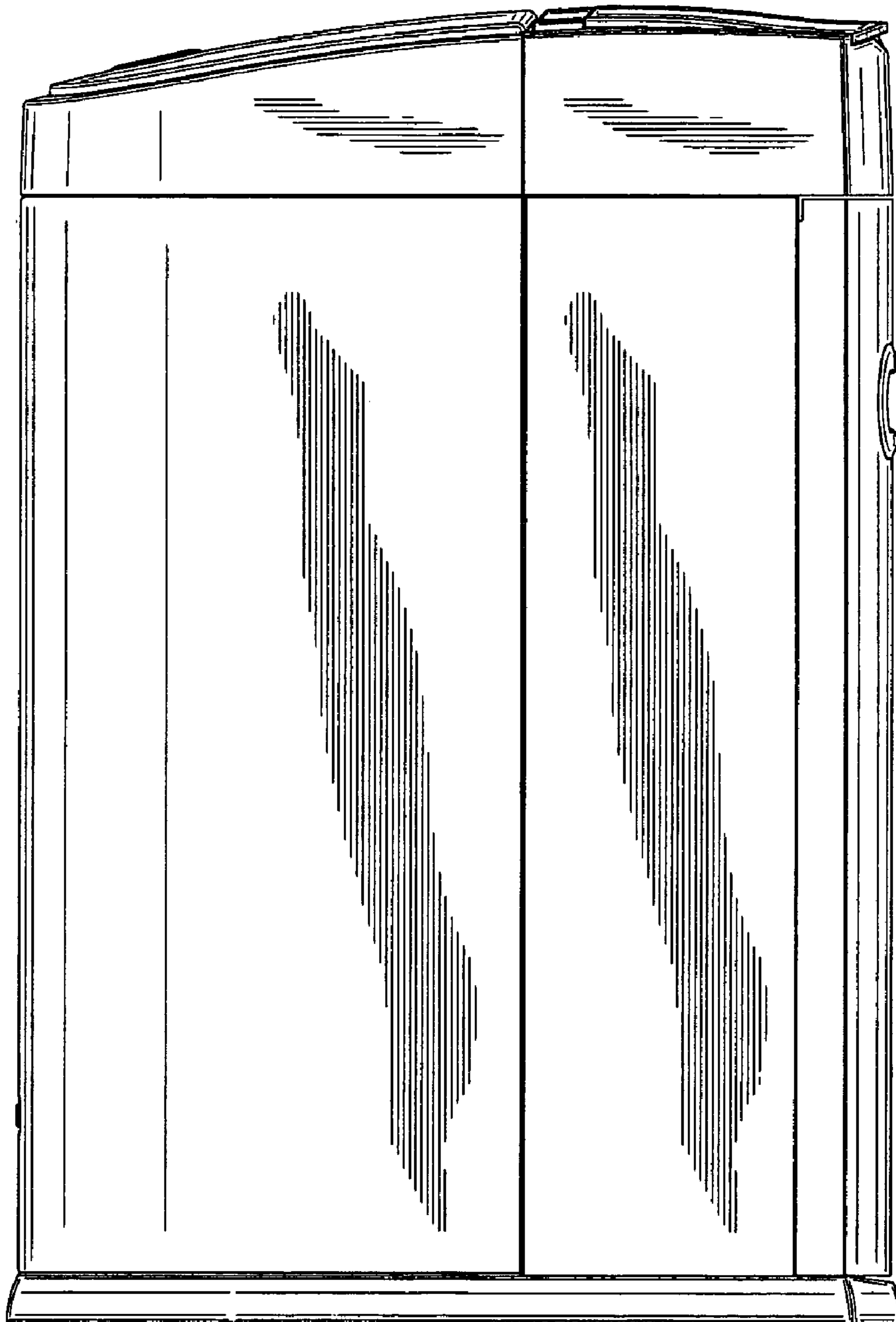

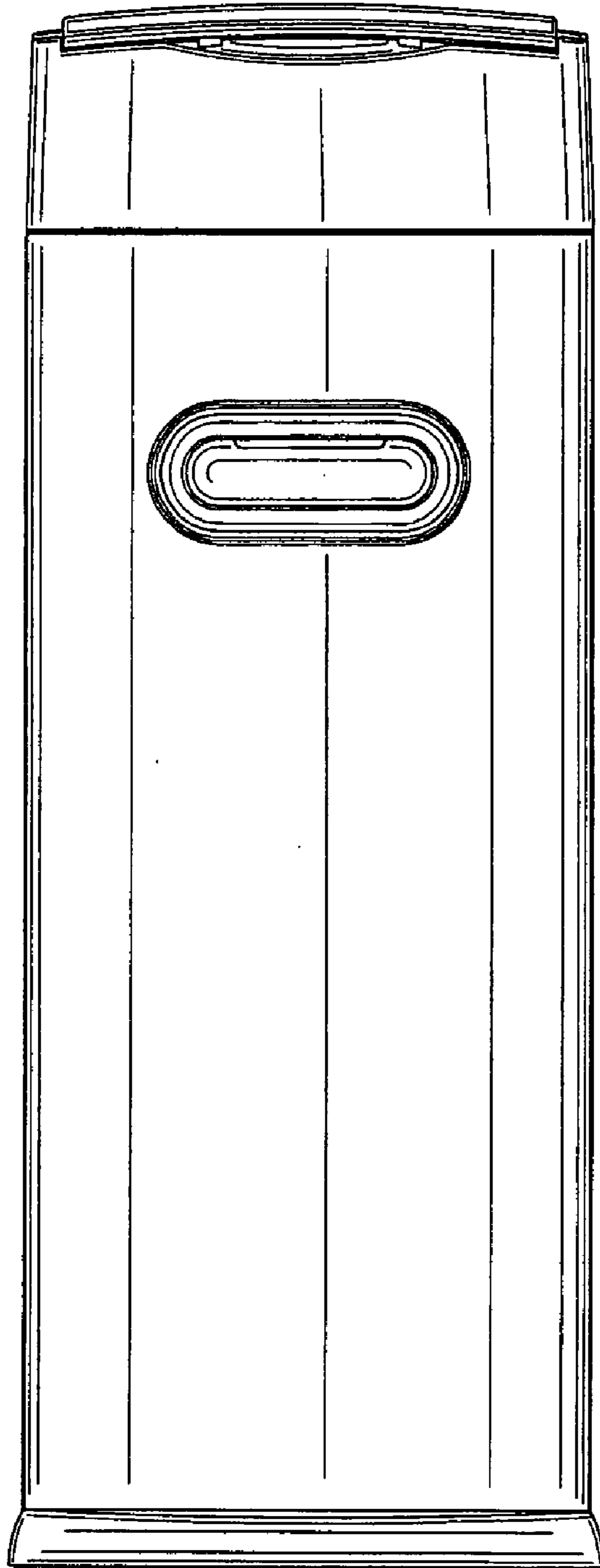
