The ornamental design for a gripped writing instrument, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the gripped writing instrument showing bottom, front, and right sides of our new design;

FIG. 2 is a front view of the gripped writing instrument of FIG. 1;

FIG. 3 is a top view of the gripped writing instrument of FIG. 1;

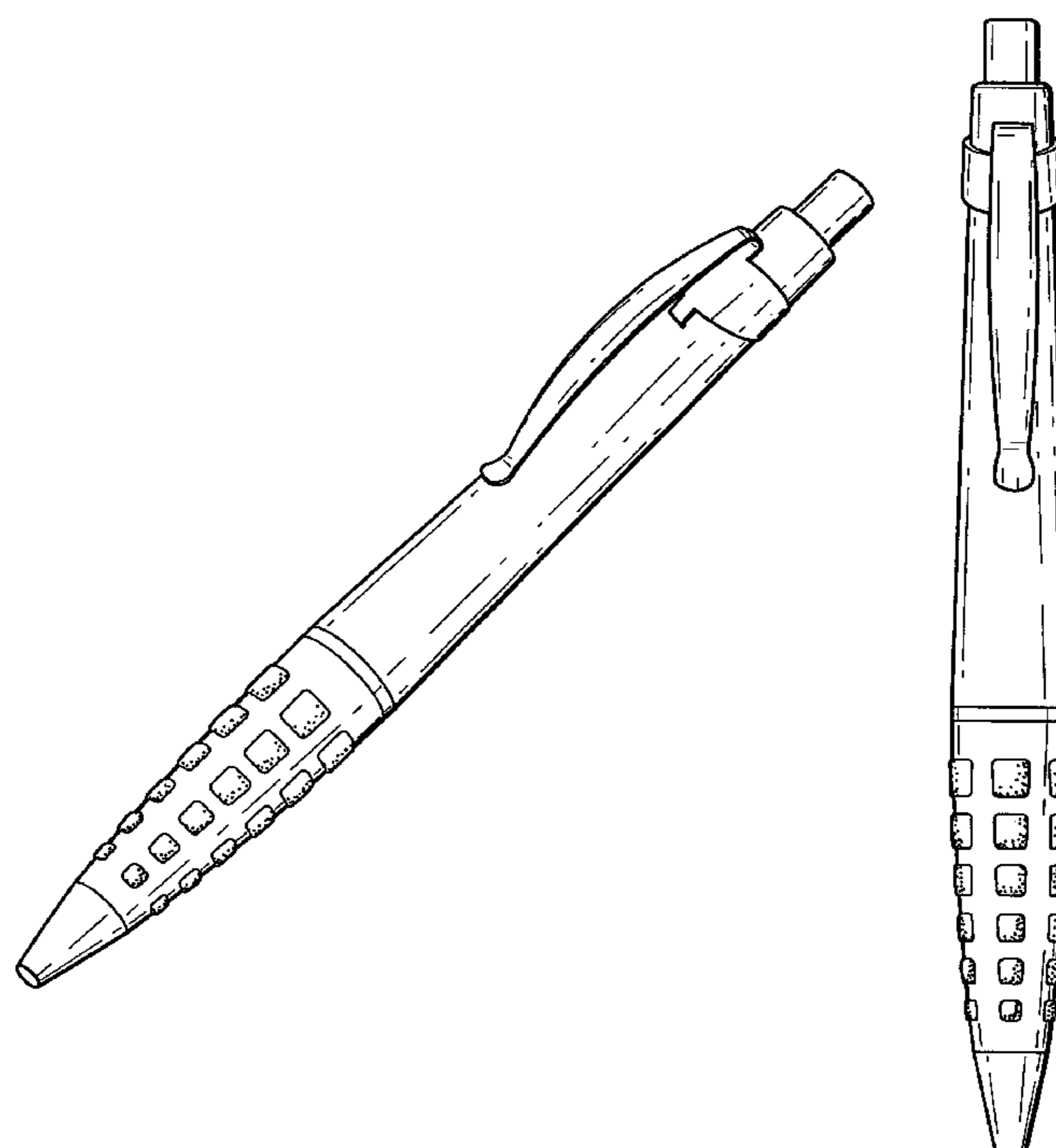
FIG. 4 is a right side view of the gripped writing instrument of FIG. 1;

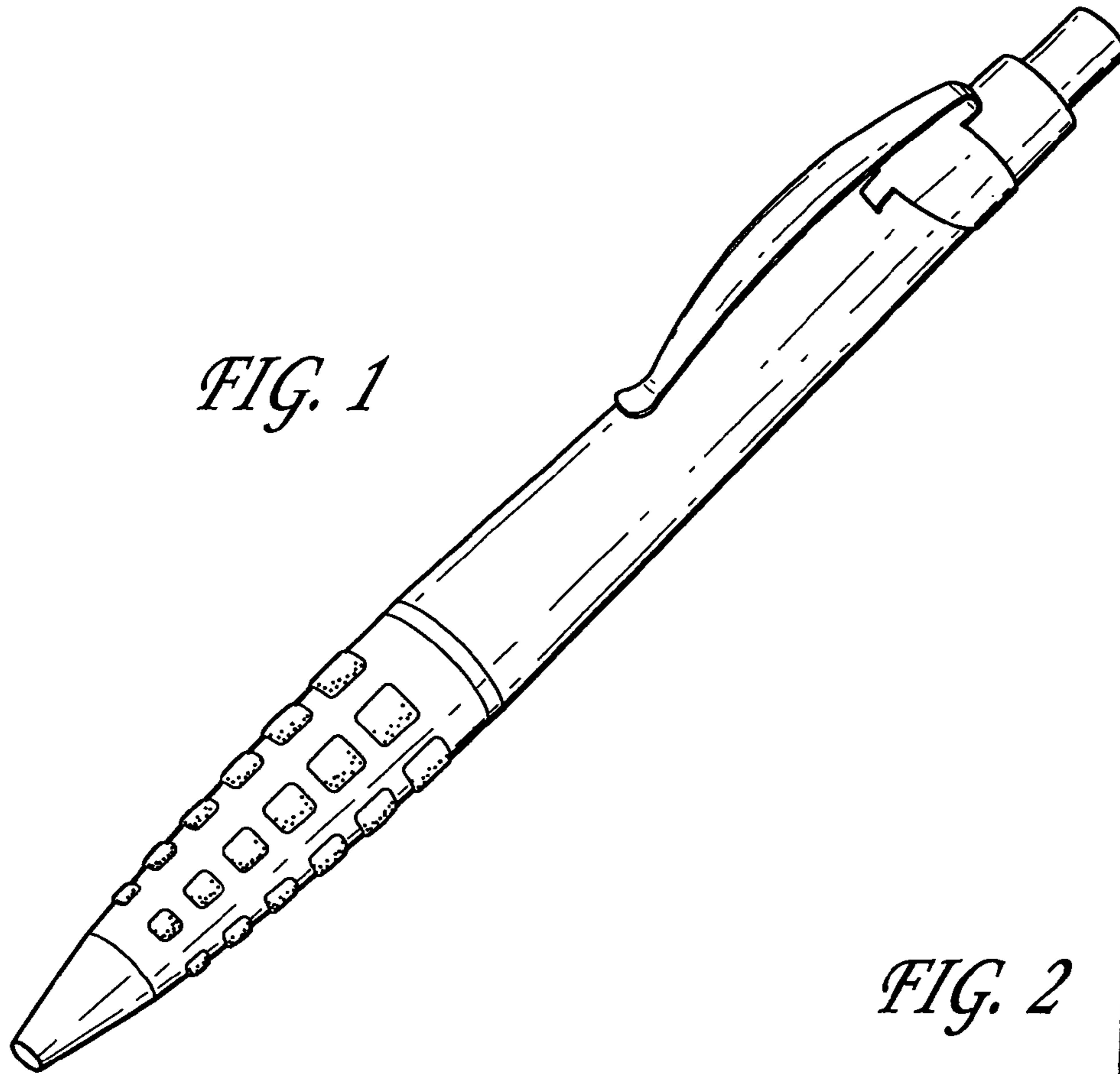

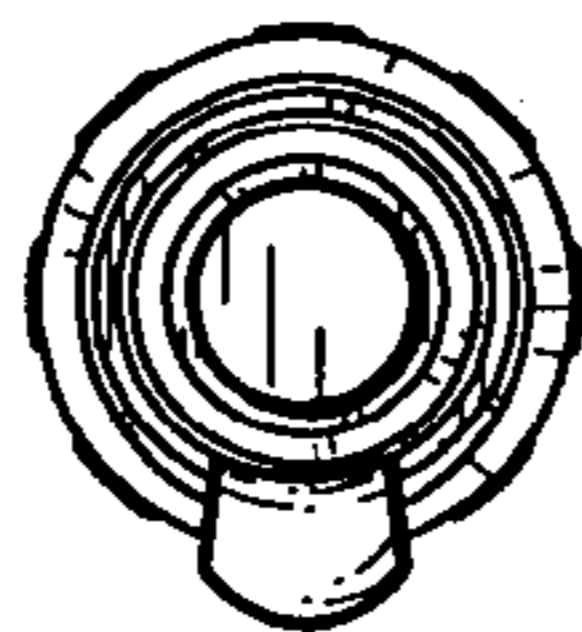

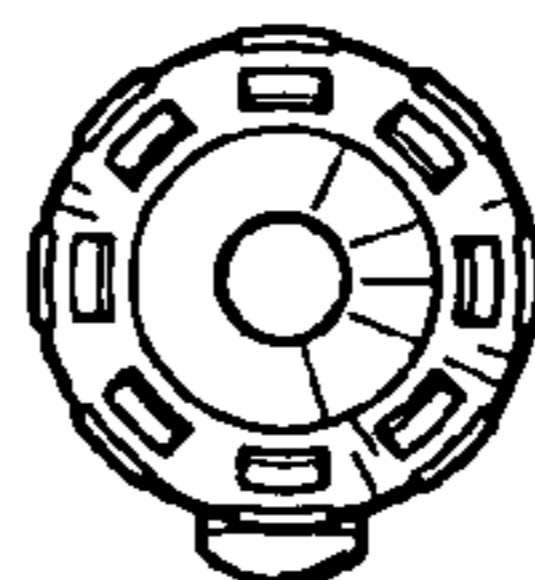
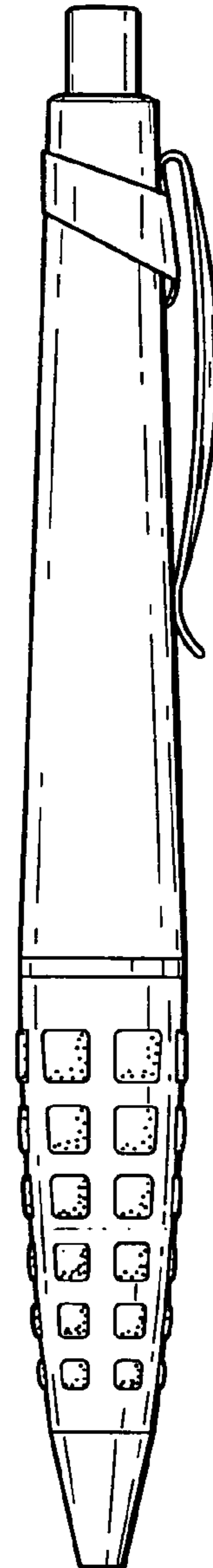
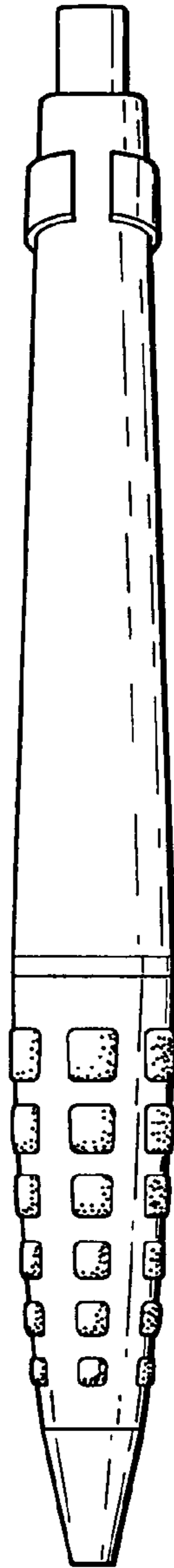
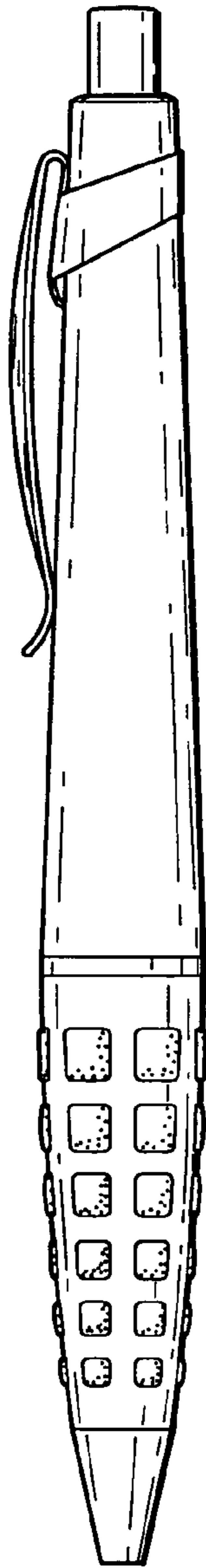
