The design is used as a noisemaker and souvenir for sporting events; and includes a textured surface with two non-raised smooth areas providing for promotional content. One embodiment includes an eyelet providing for the addition of a carrying strap.

FIG. 13 shows a left side elevation view of the rattling football noisemaker of FIG. 8; and,

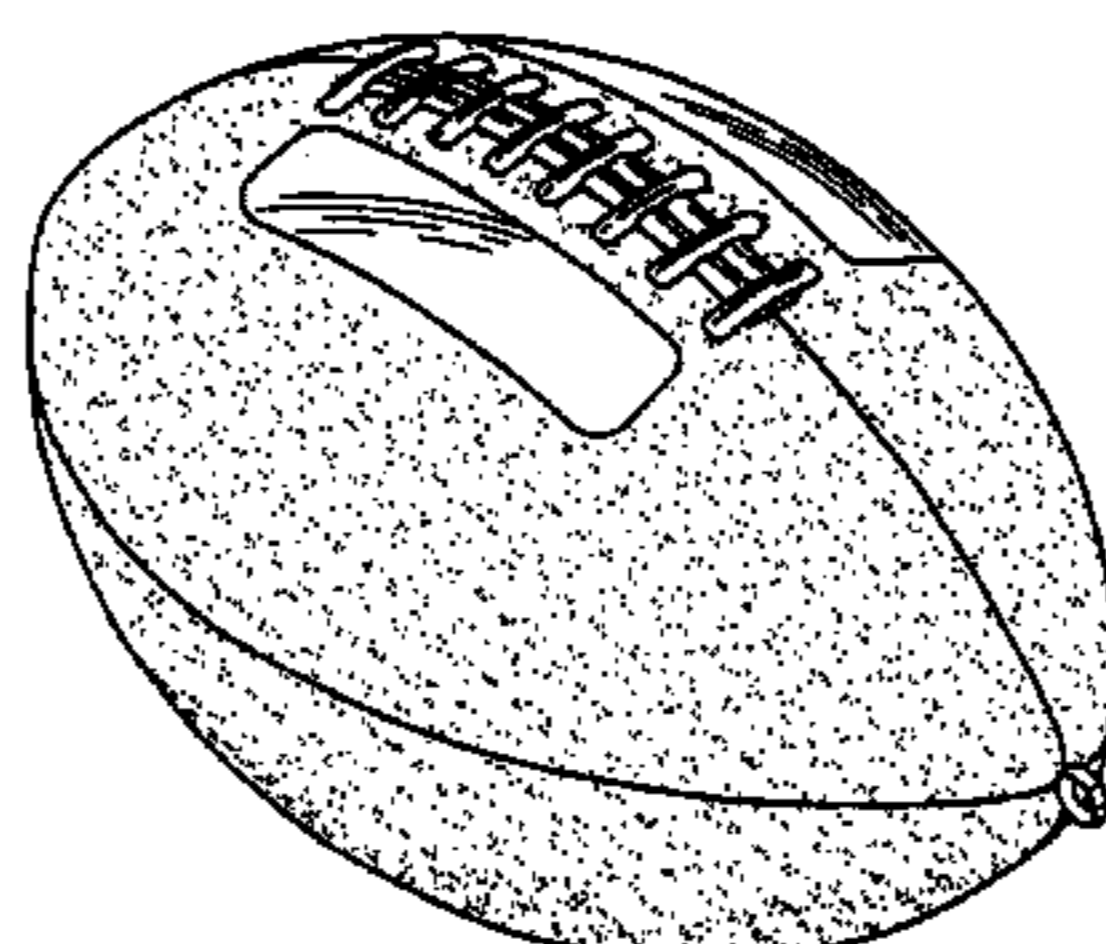
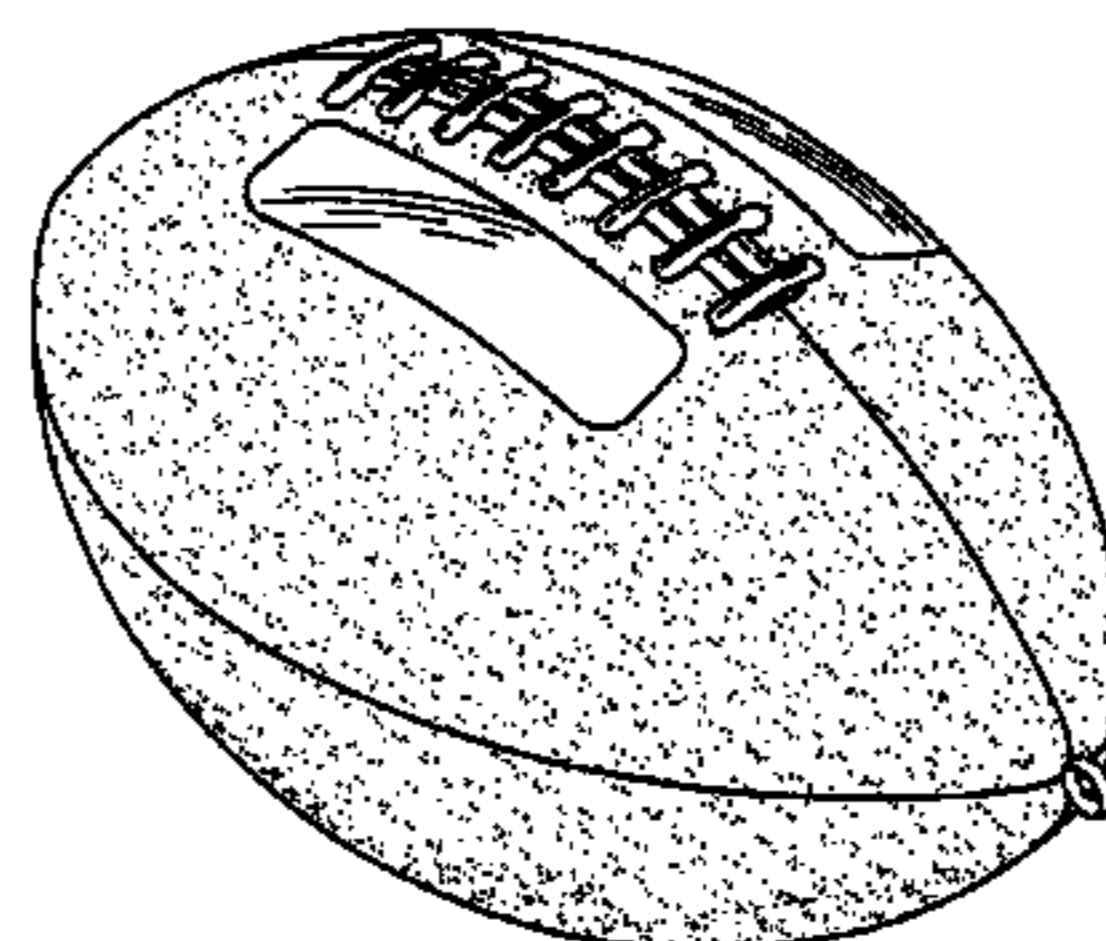
FIG. 14 shows a right side elevation view of the rattling football noisemaker of FIG. 8.

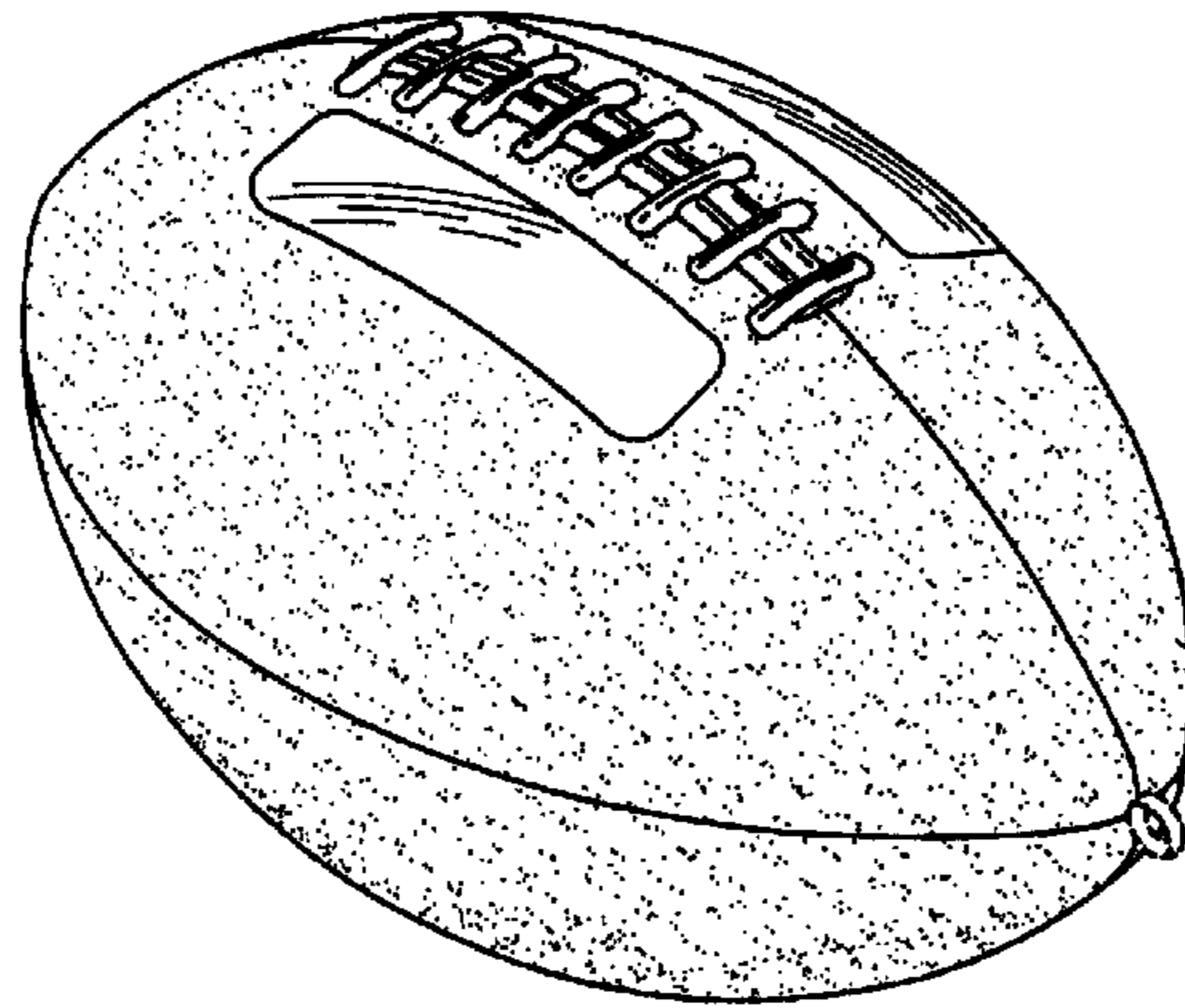

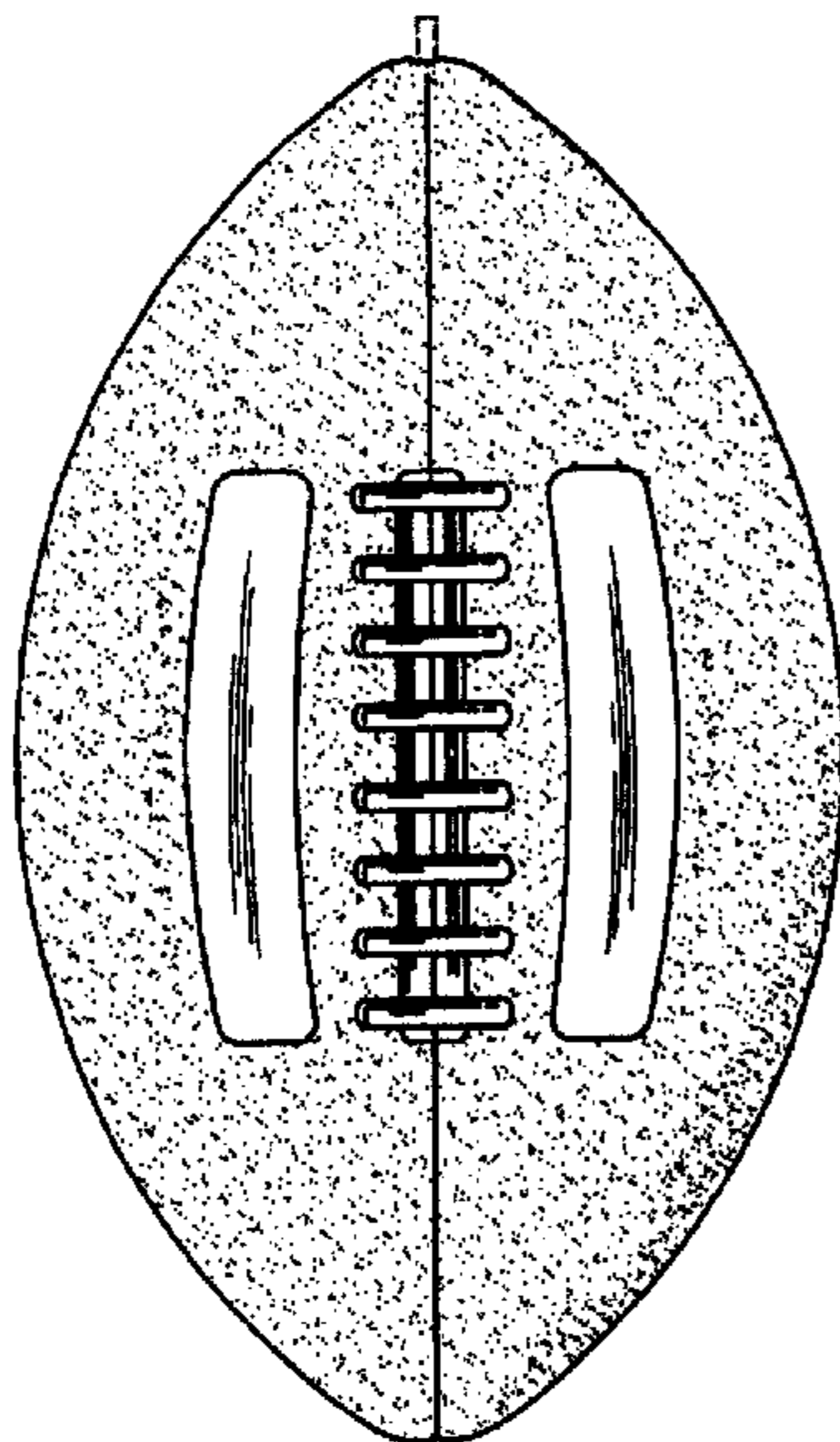
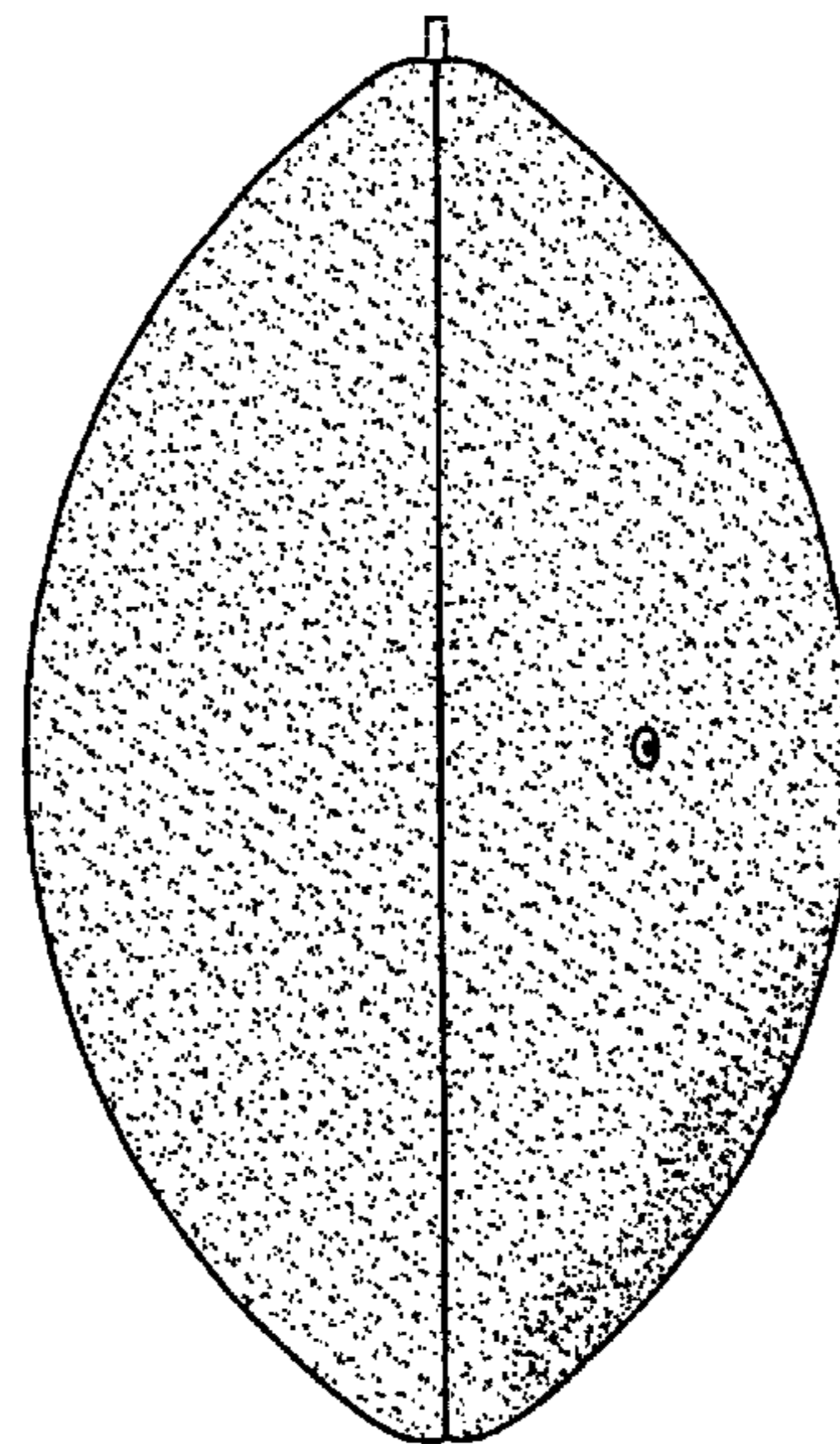

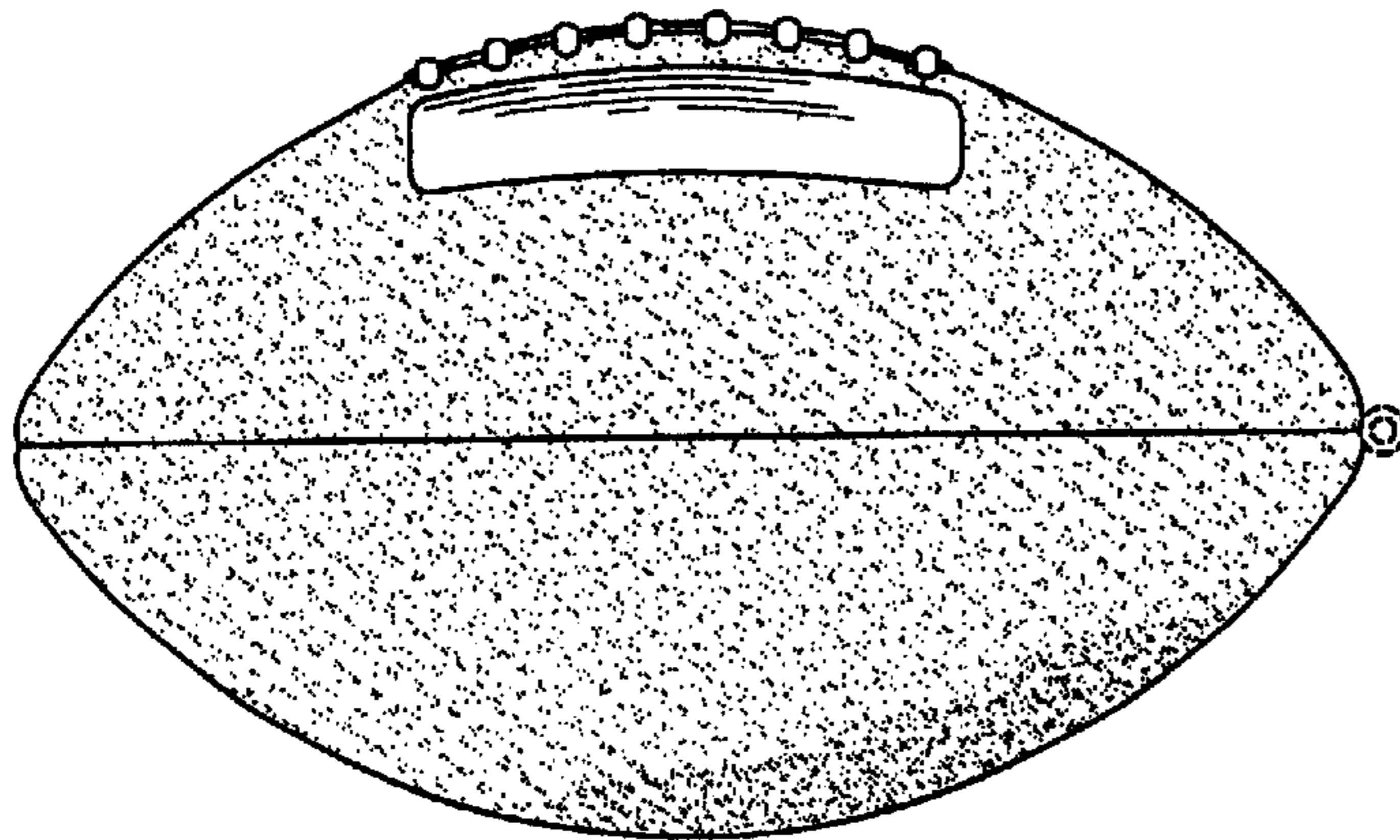

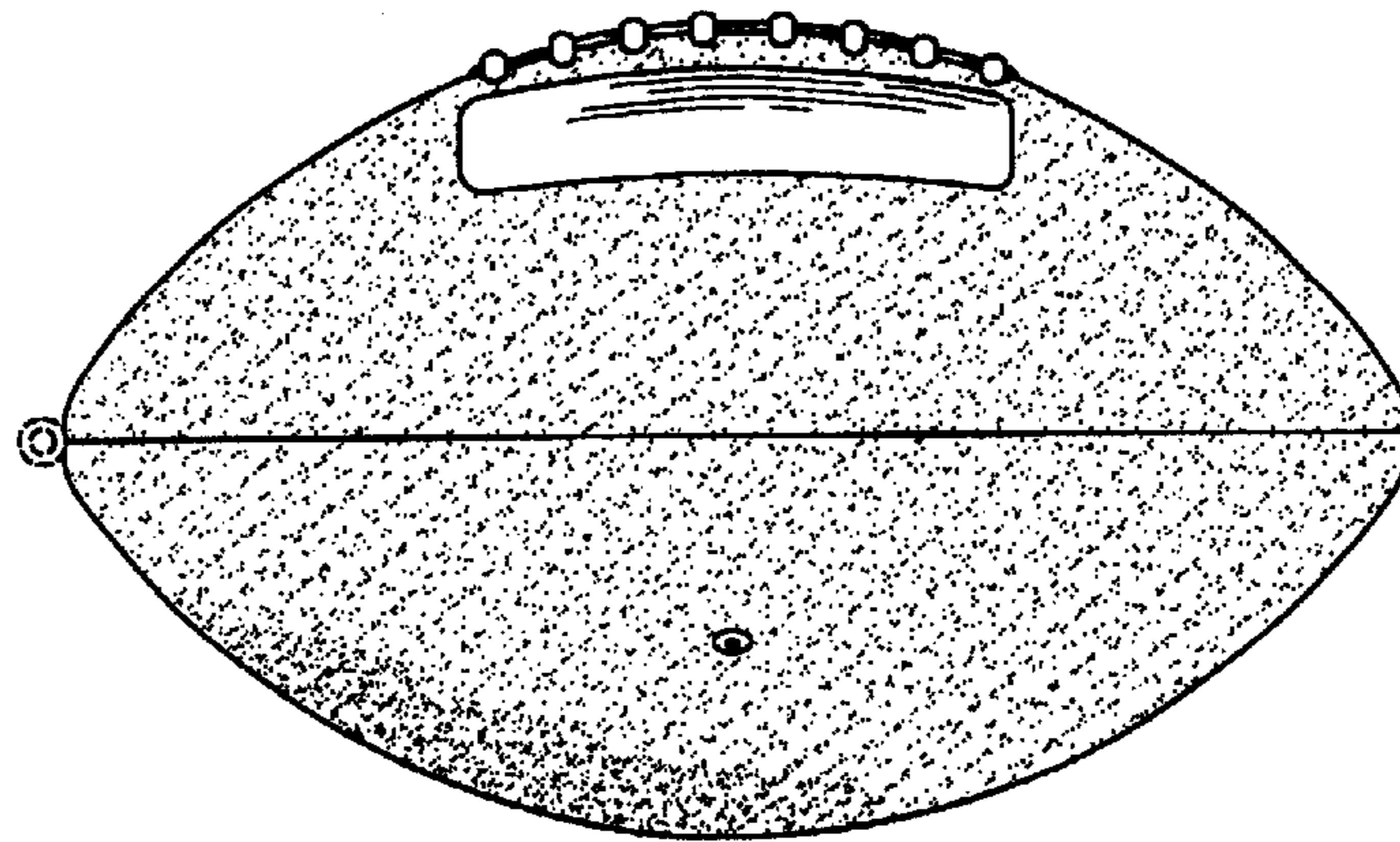

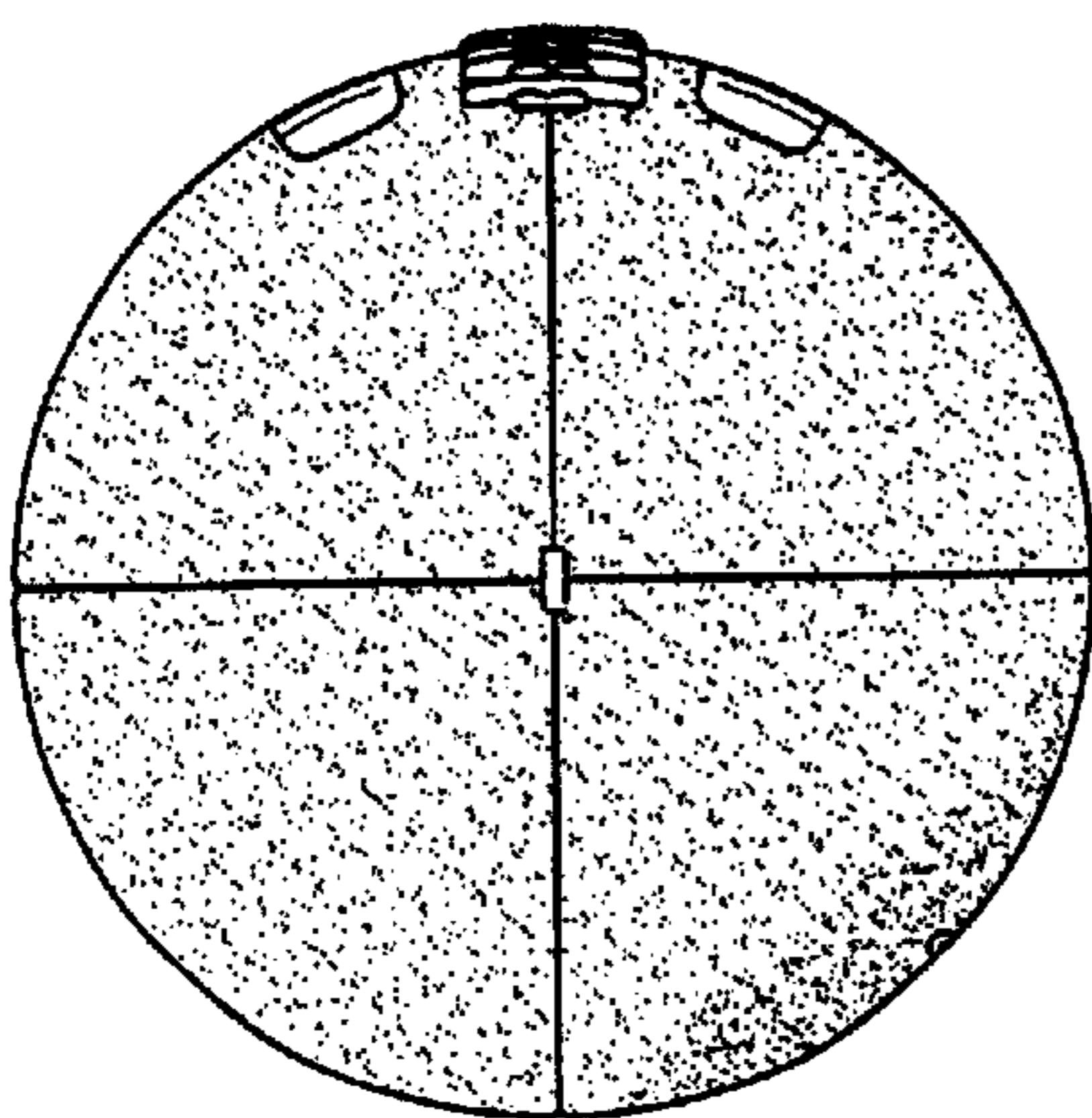

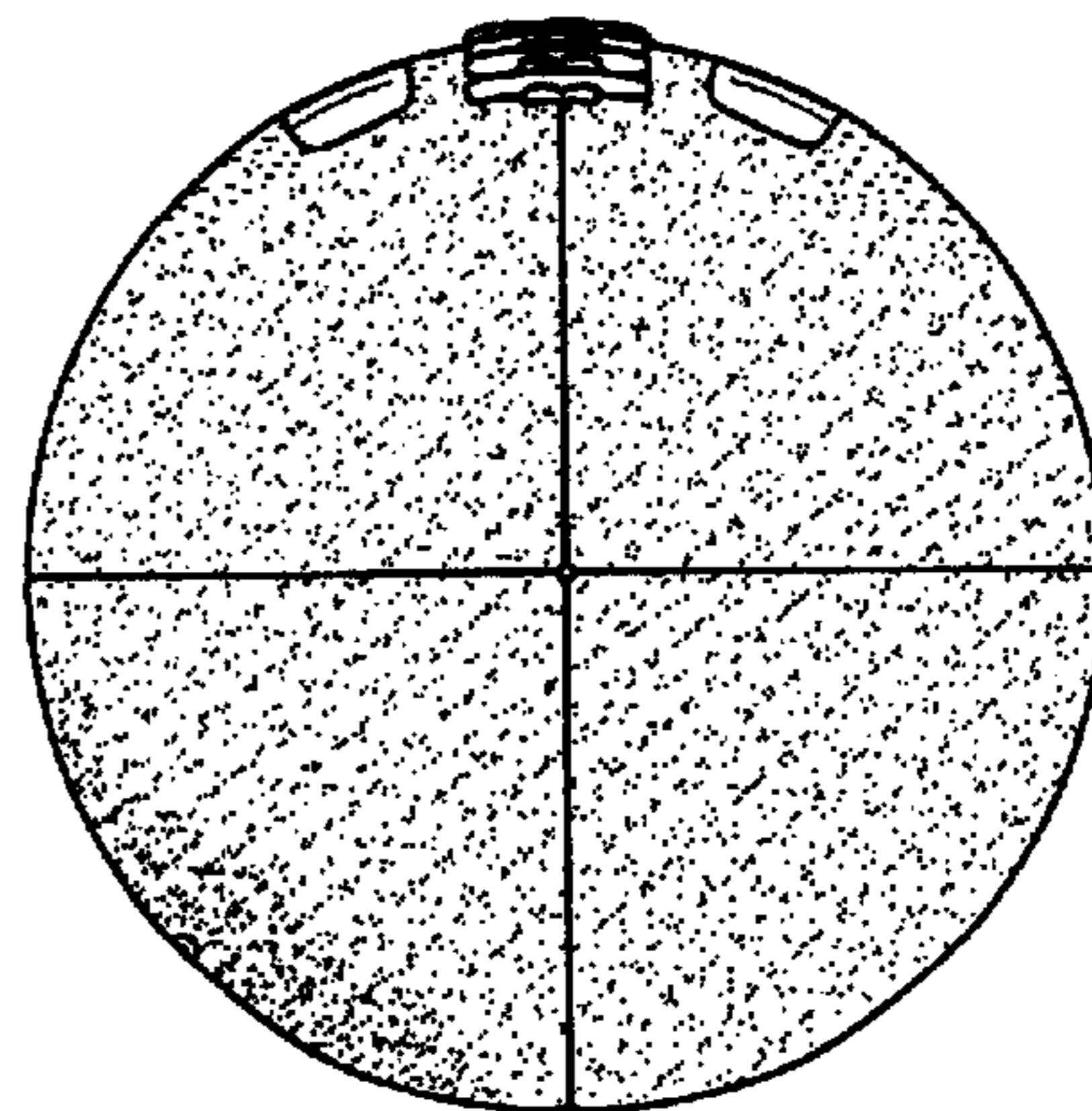

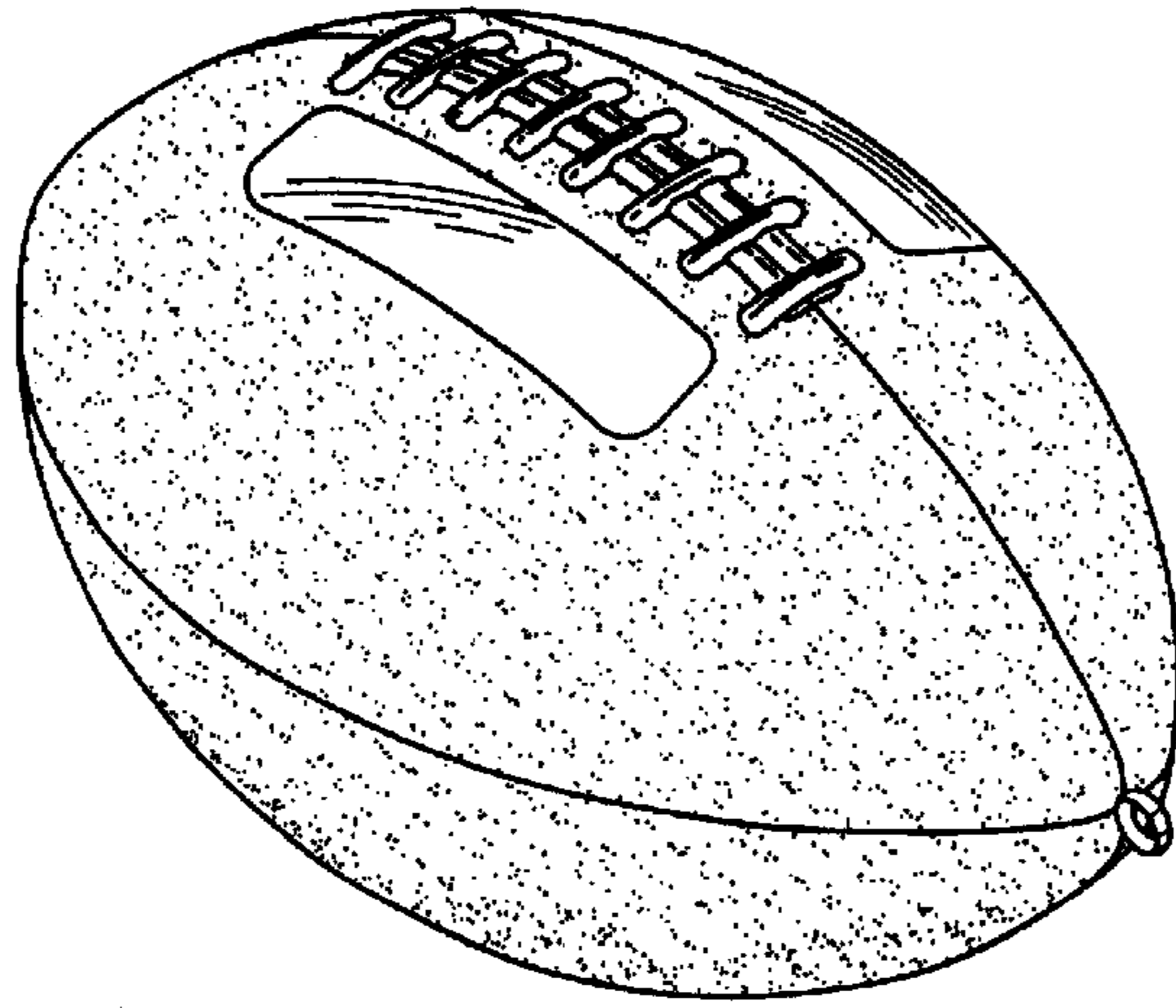

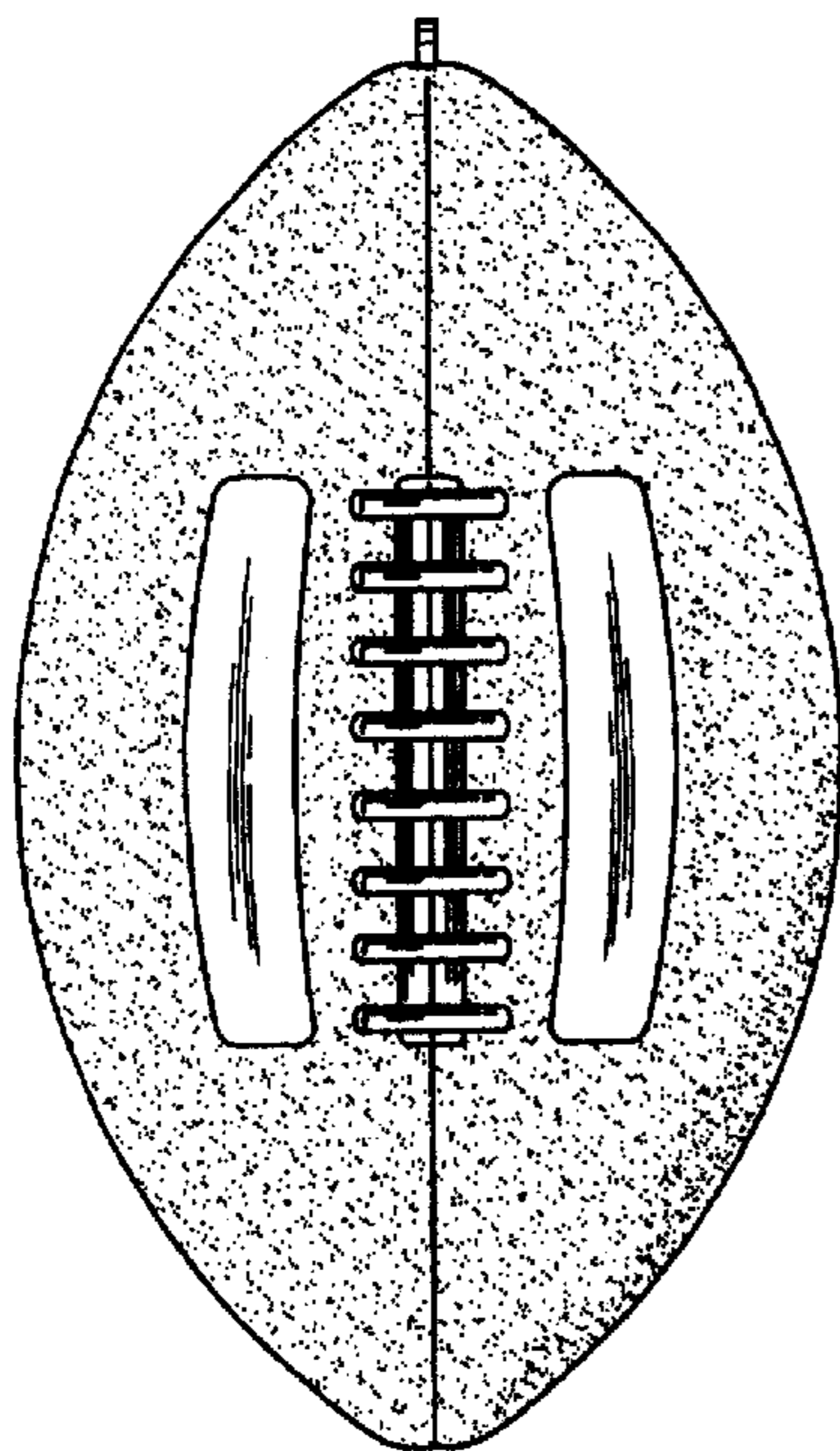
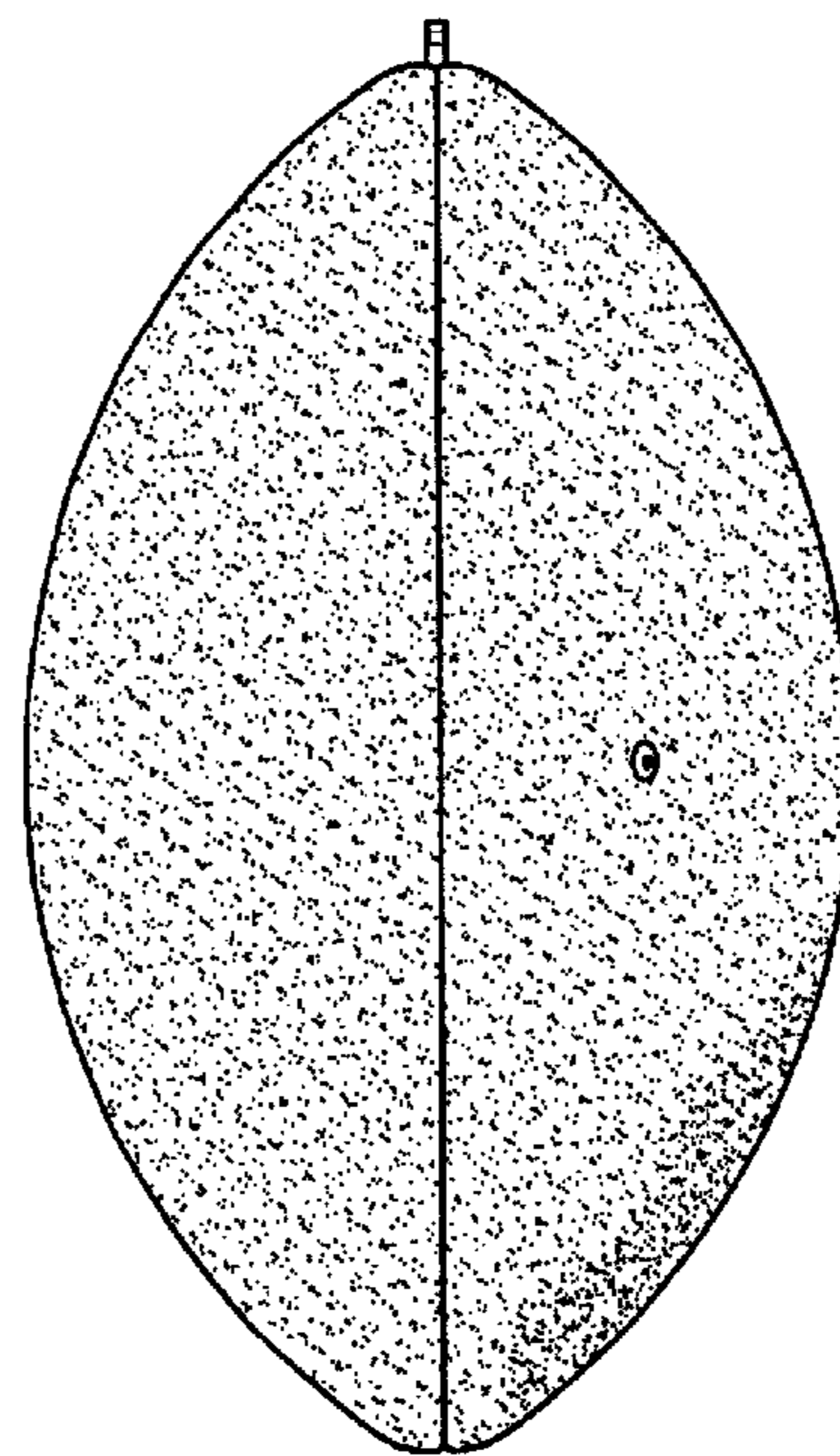

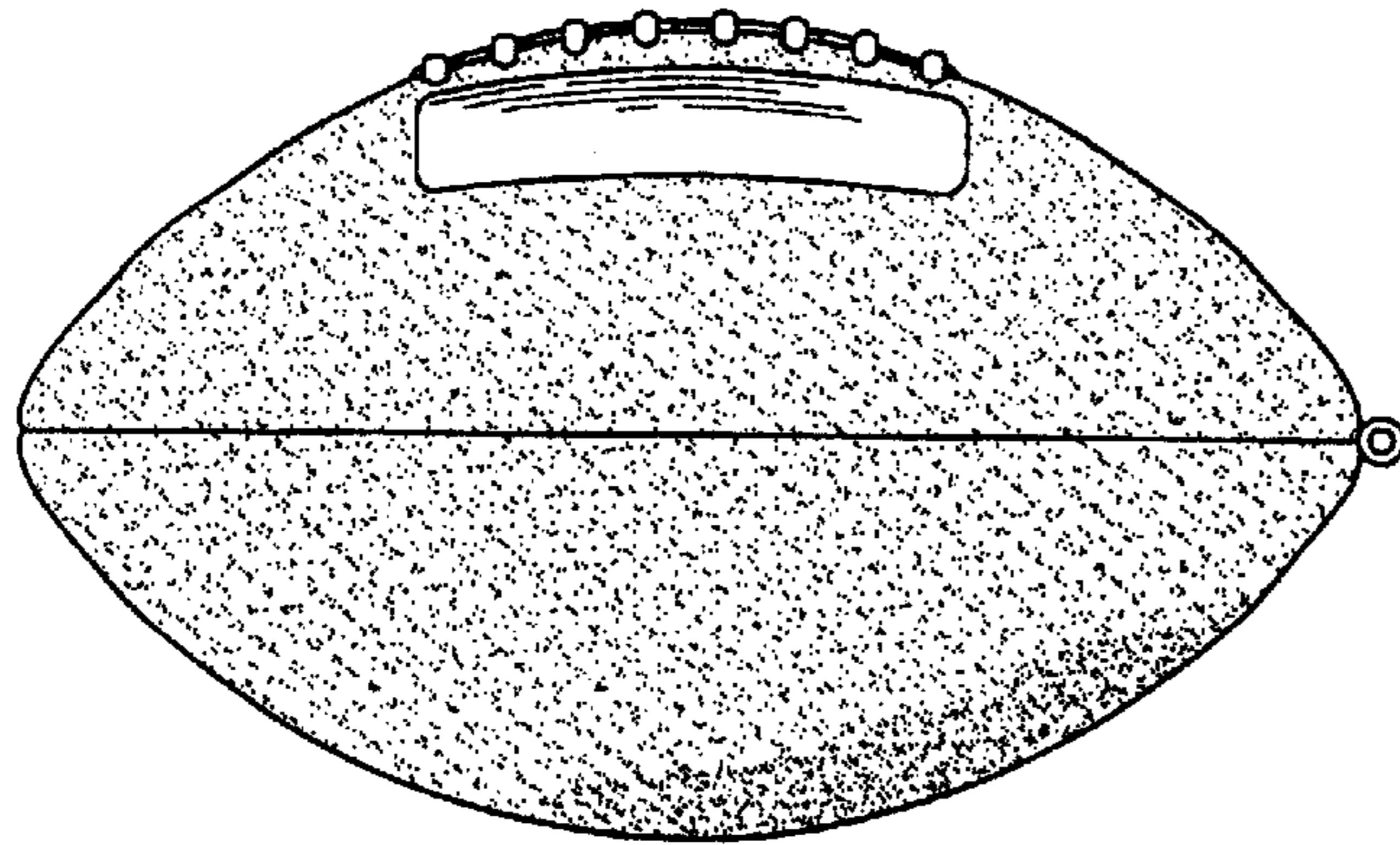

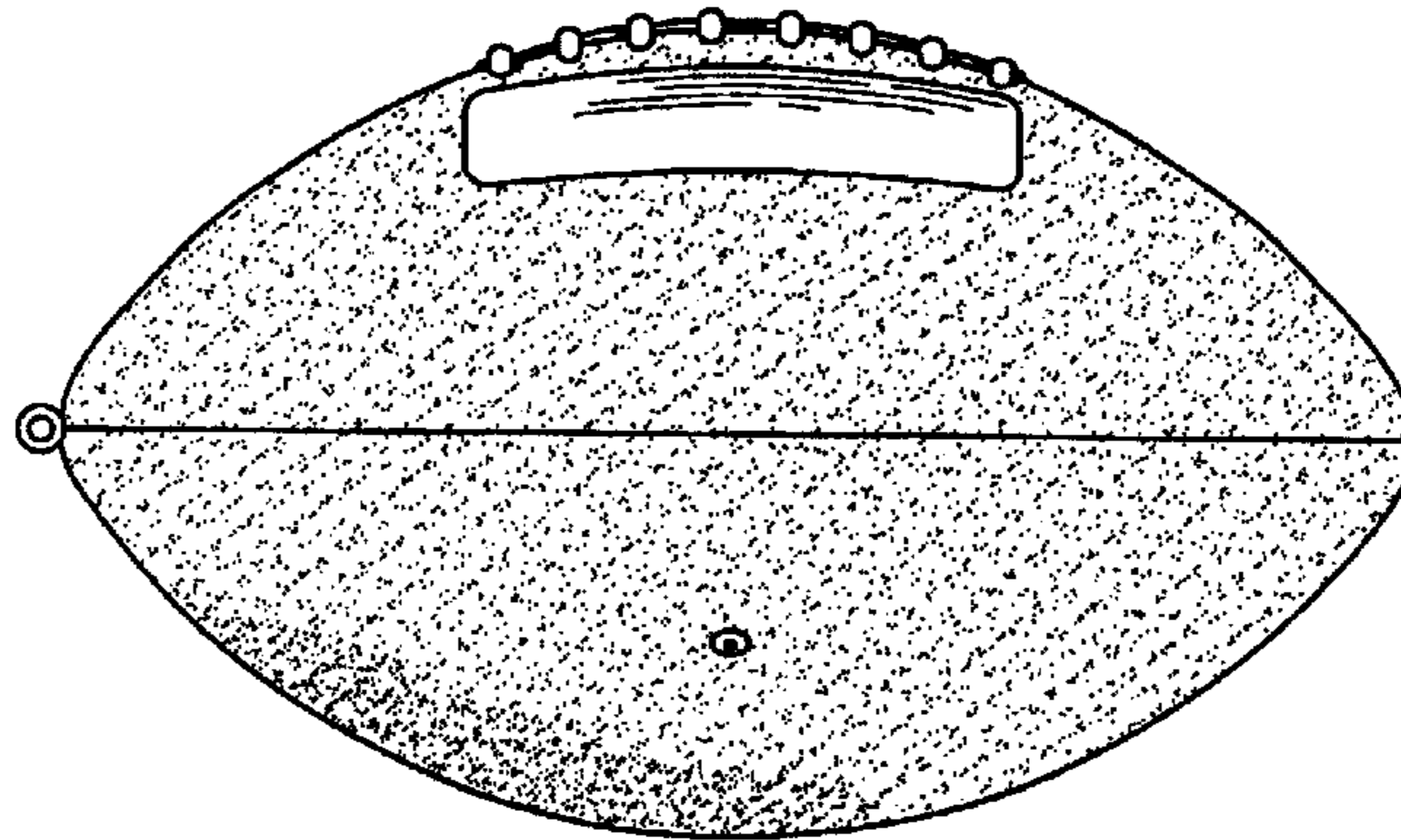

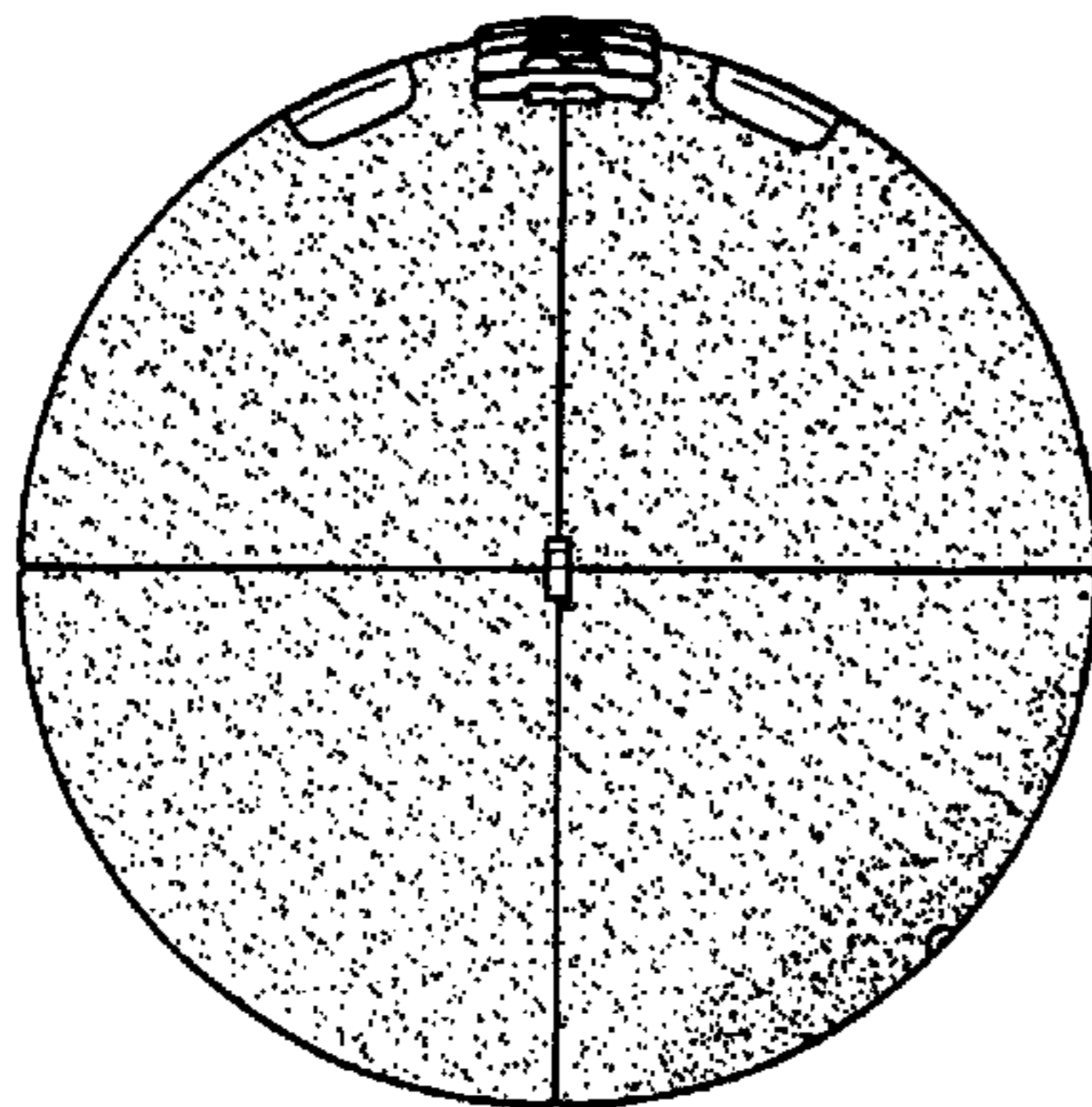
