(57) **CLAIM**

The ornamental design for a curved wagon canopy, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the curved wagon canopy;

FIG. 2 is a rear elevational view of the curved wagon canopy;

FIG. 3 is a front elevational view of the curved wagon canopy;

FIG. 4 is a right side elevational view of the curved wagon canopy, the opposite side of which is an identical mirror image;

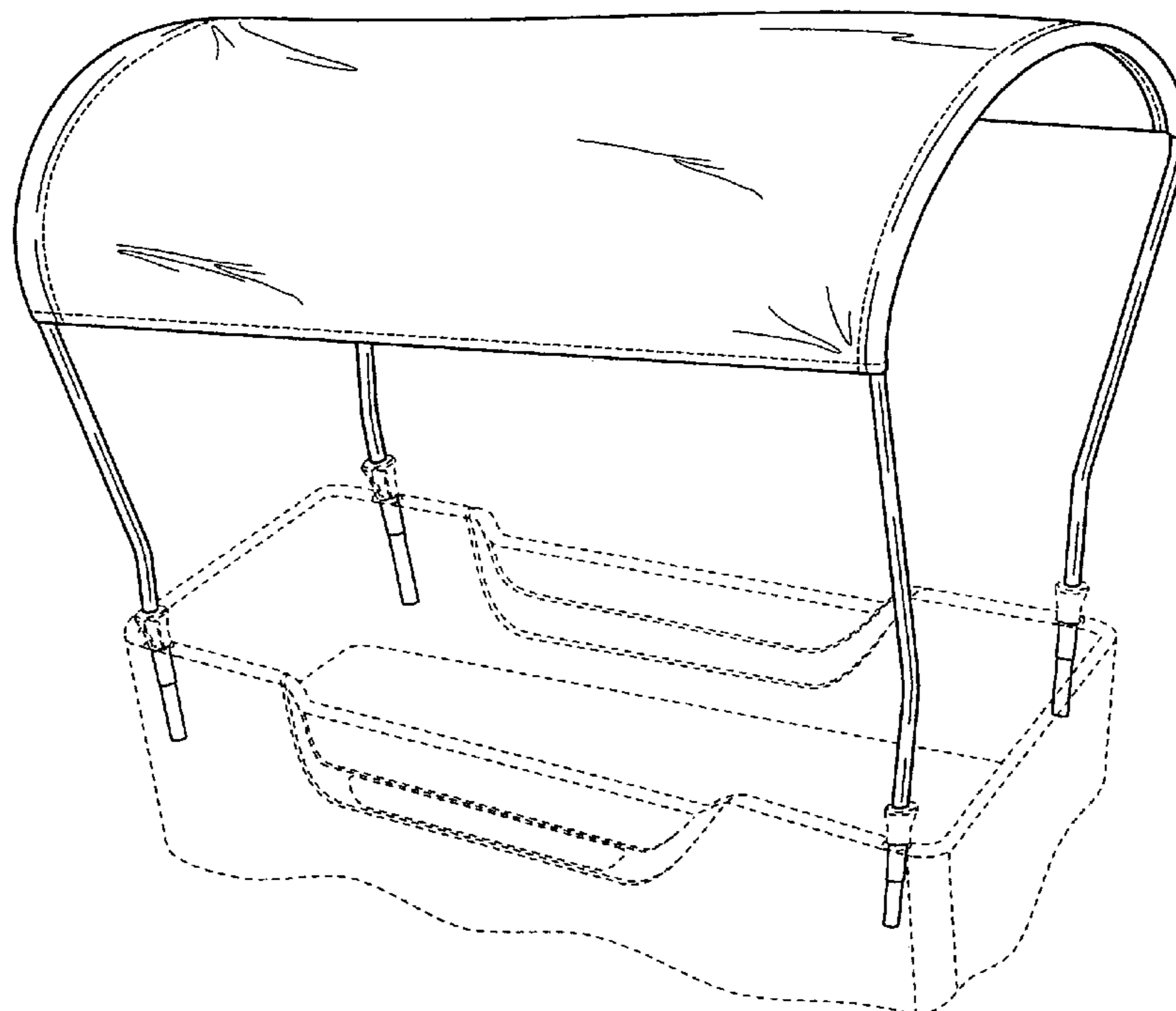
FIG. 5 is a top plan view of the curved wagon canopy;

FIG. 6 is a bottom plan view of the curved wagon canopy; and,

FIG. 7 is a perspective view of the curved wagon canopy as installed on a wagon.

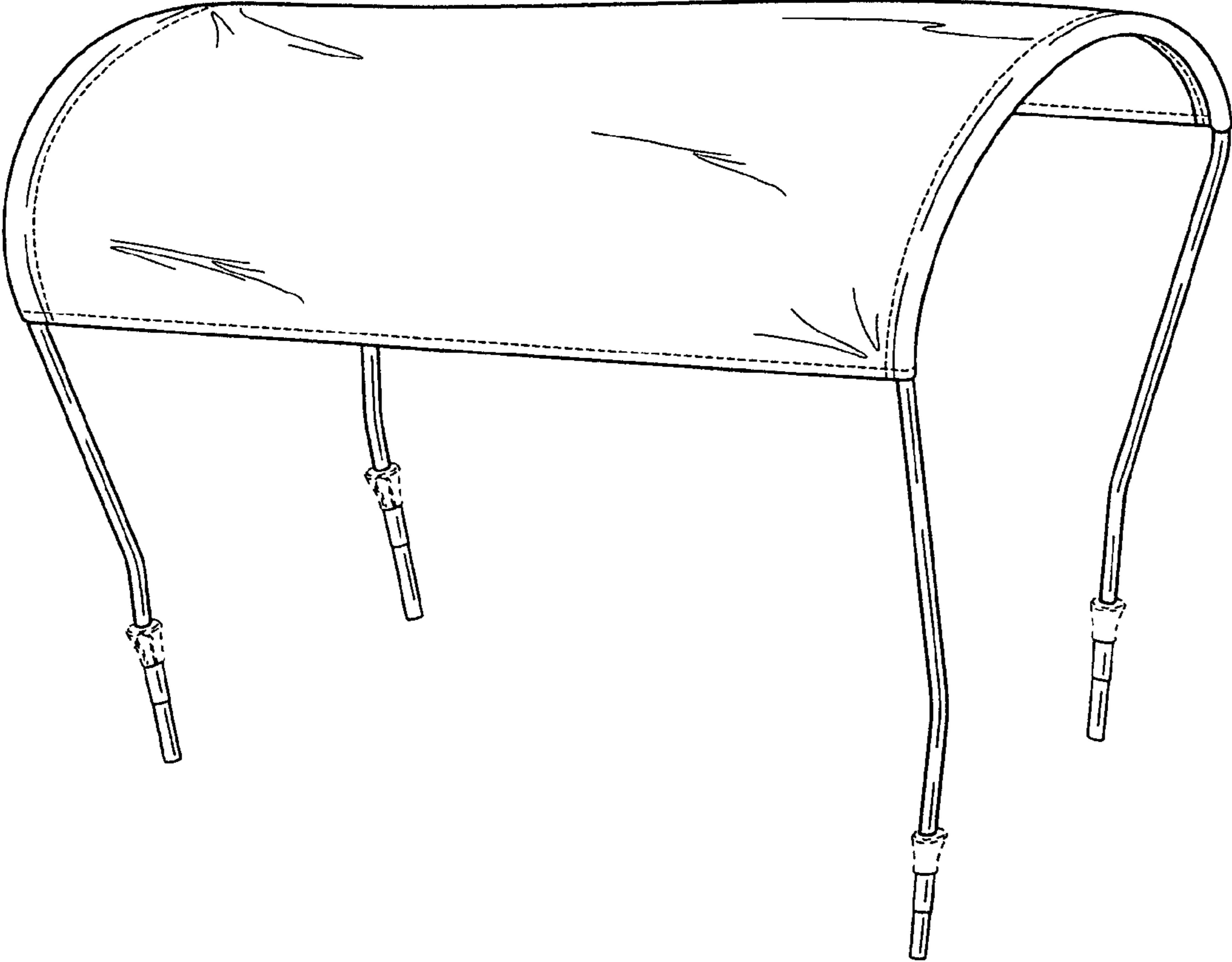

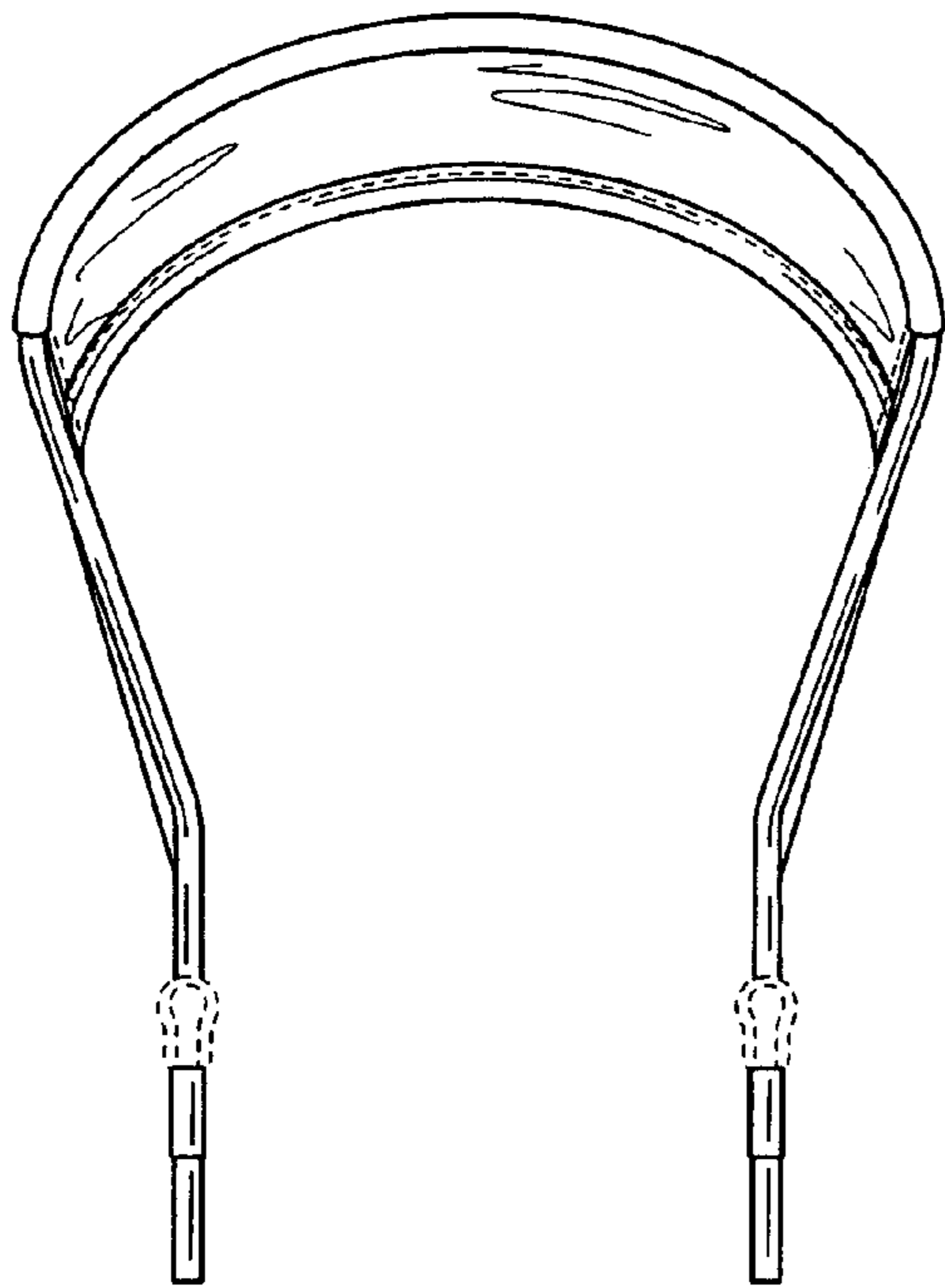

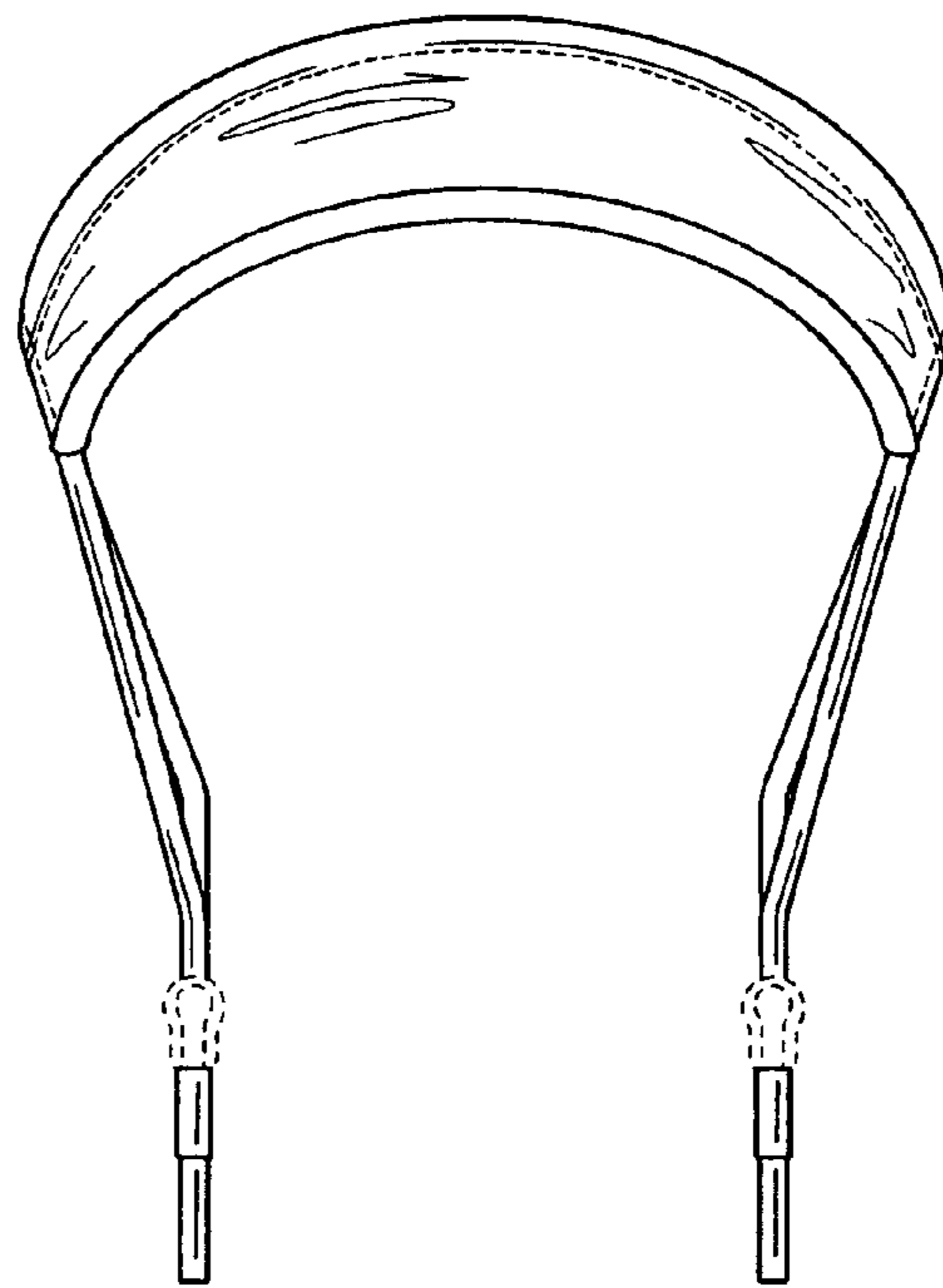

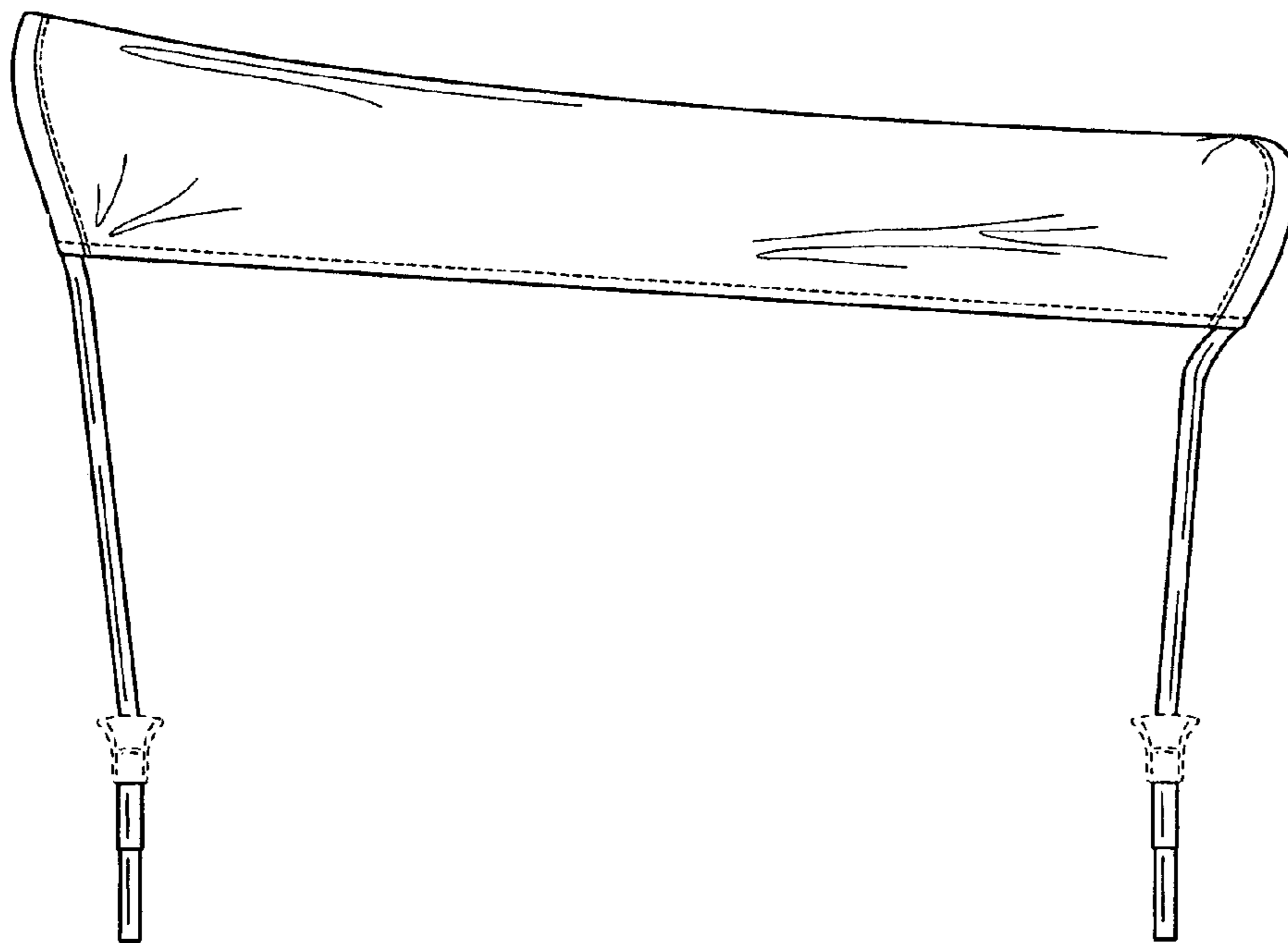

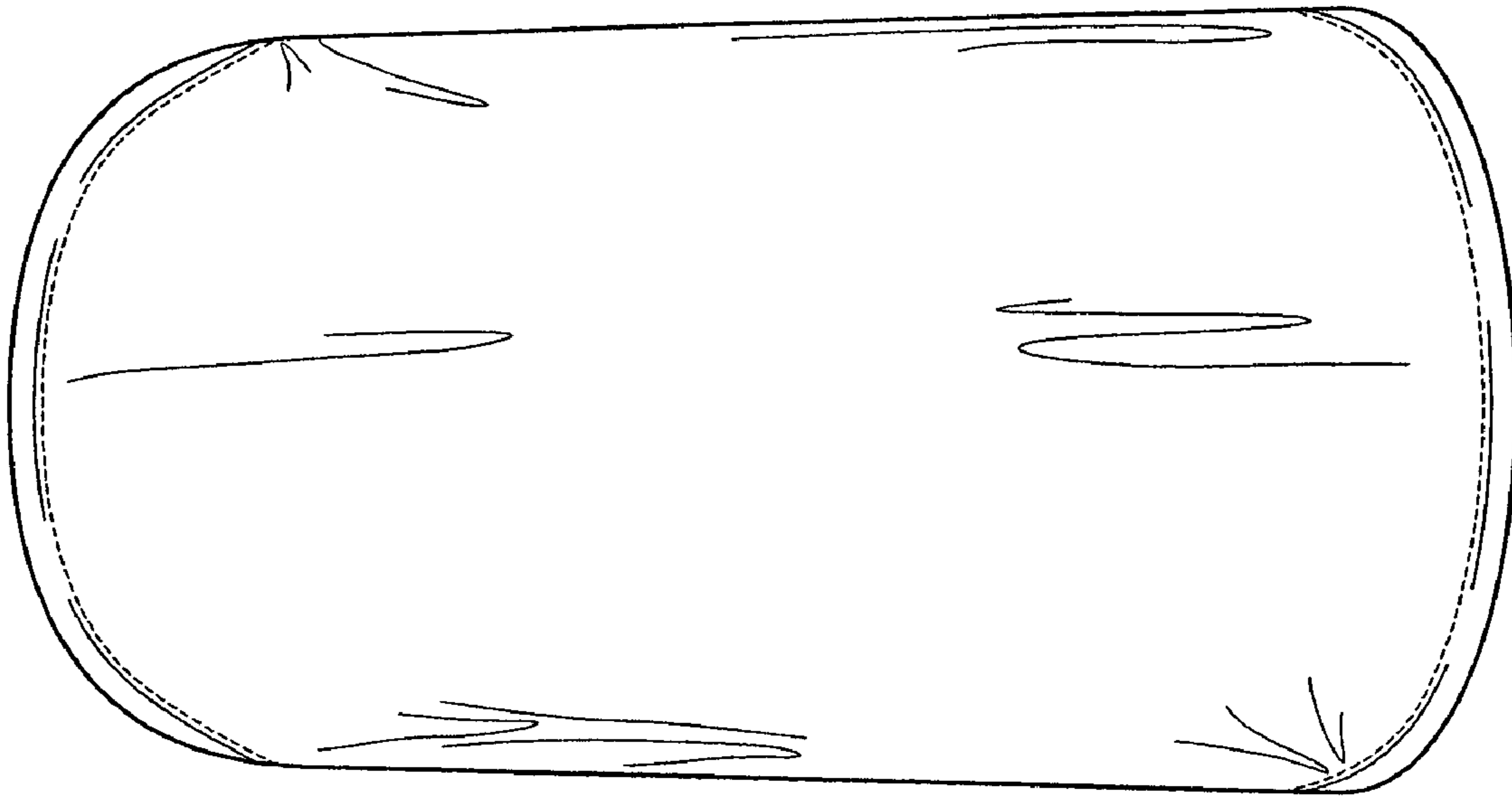

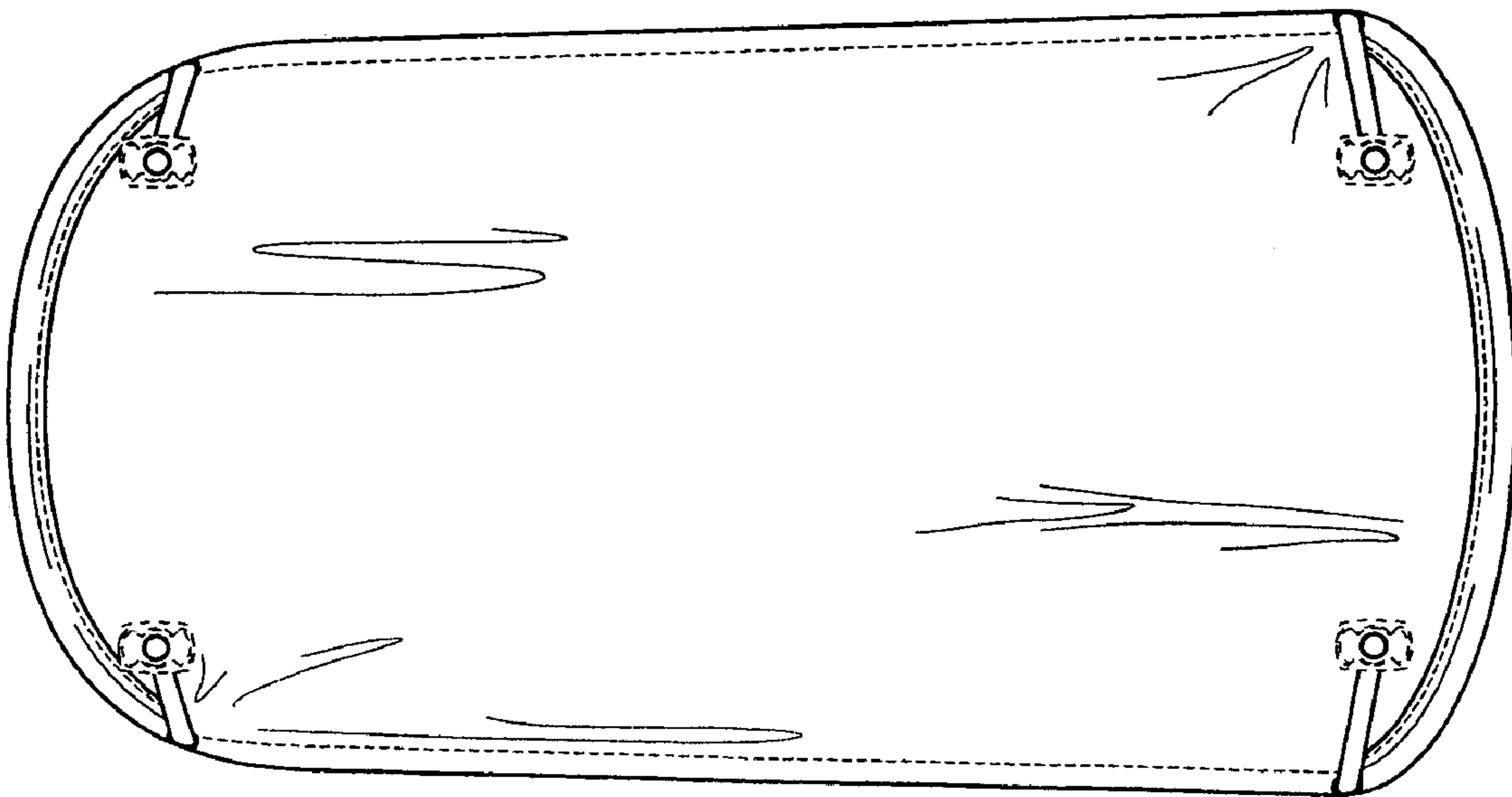

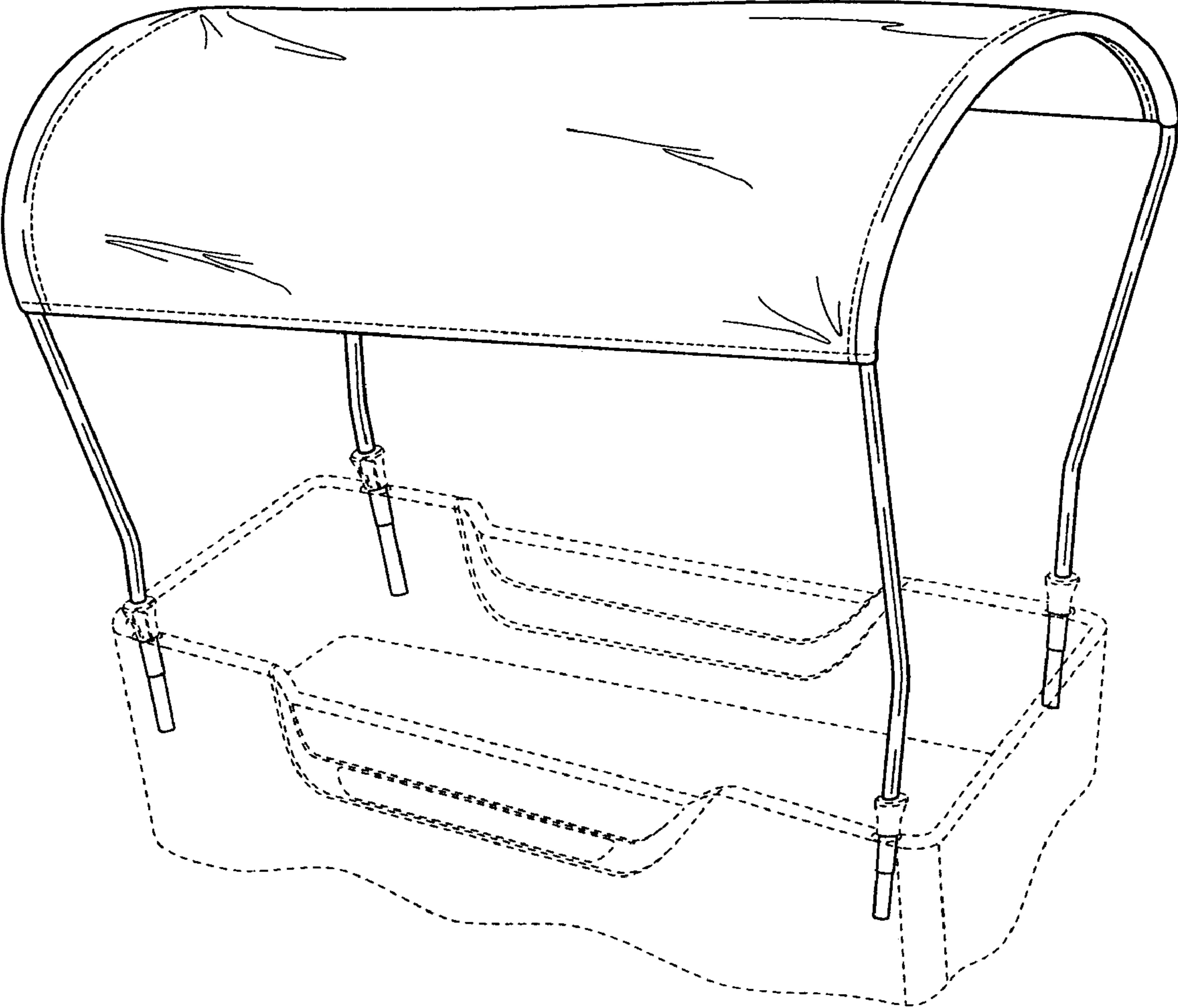
