1.

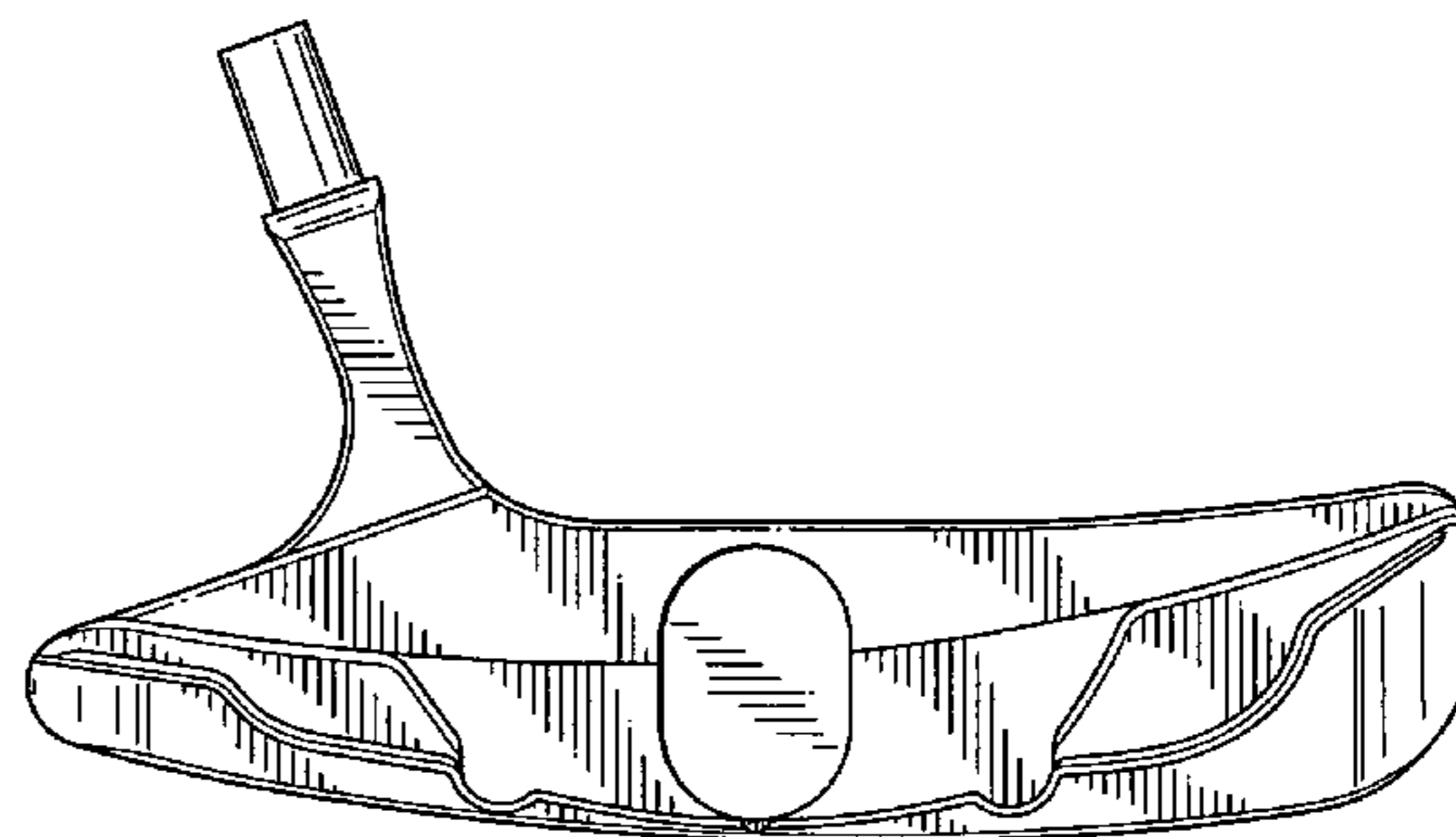
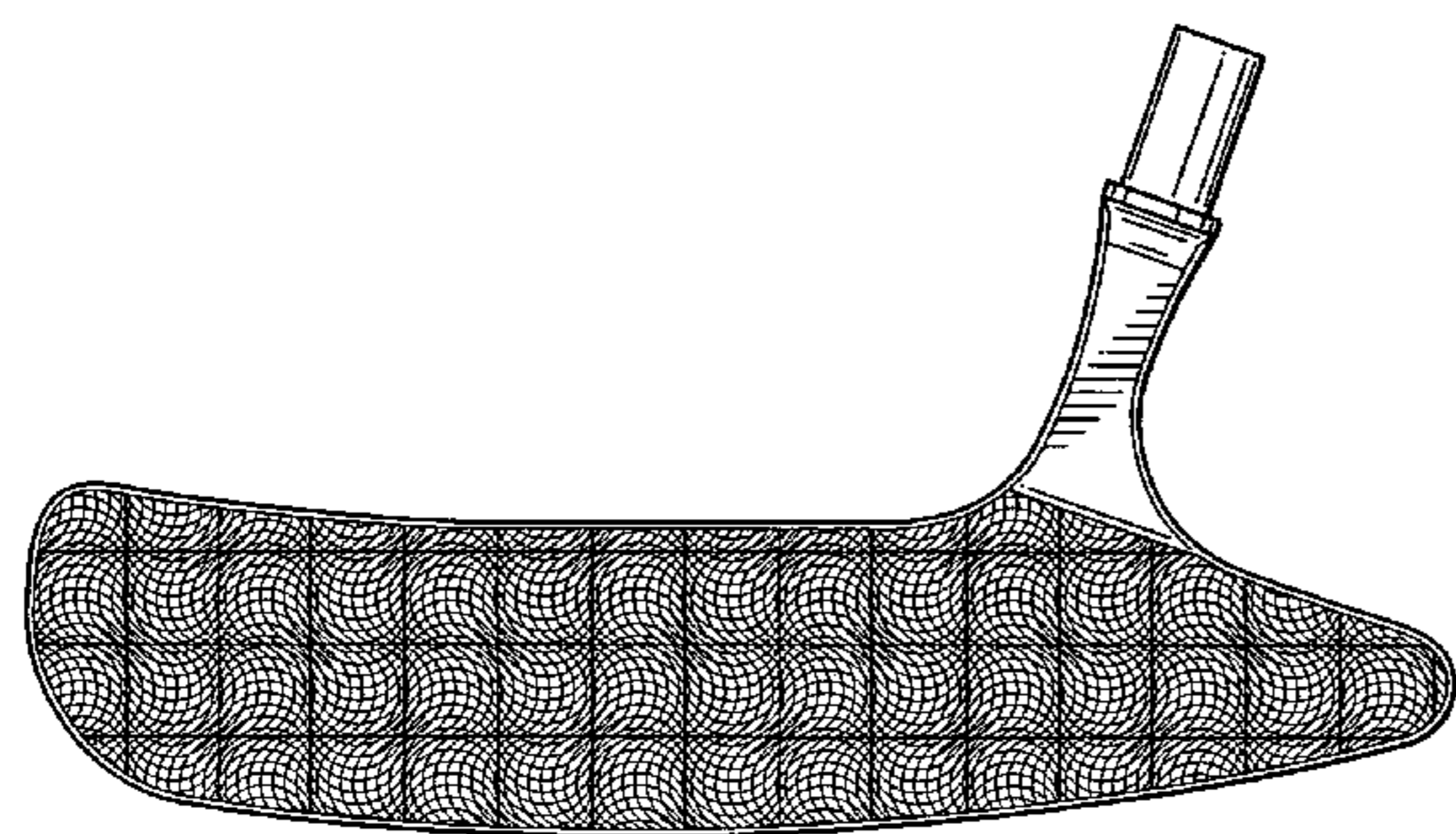
FIG. 4 is a right elevational view of the putter head of FIG.

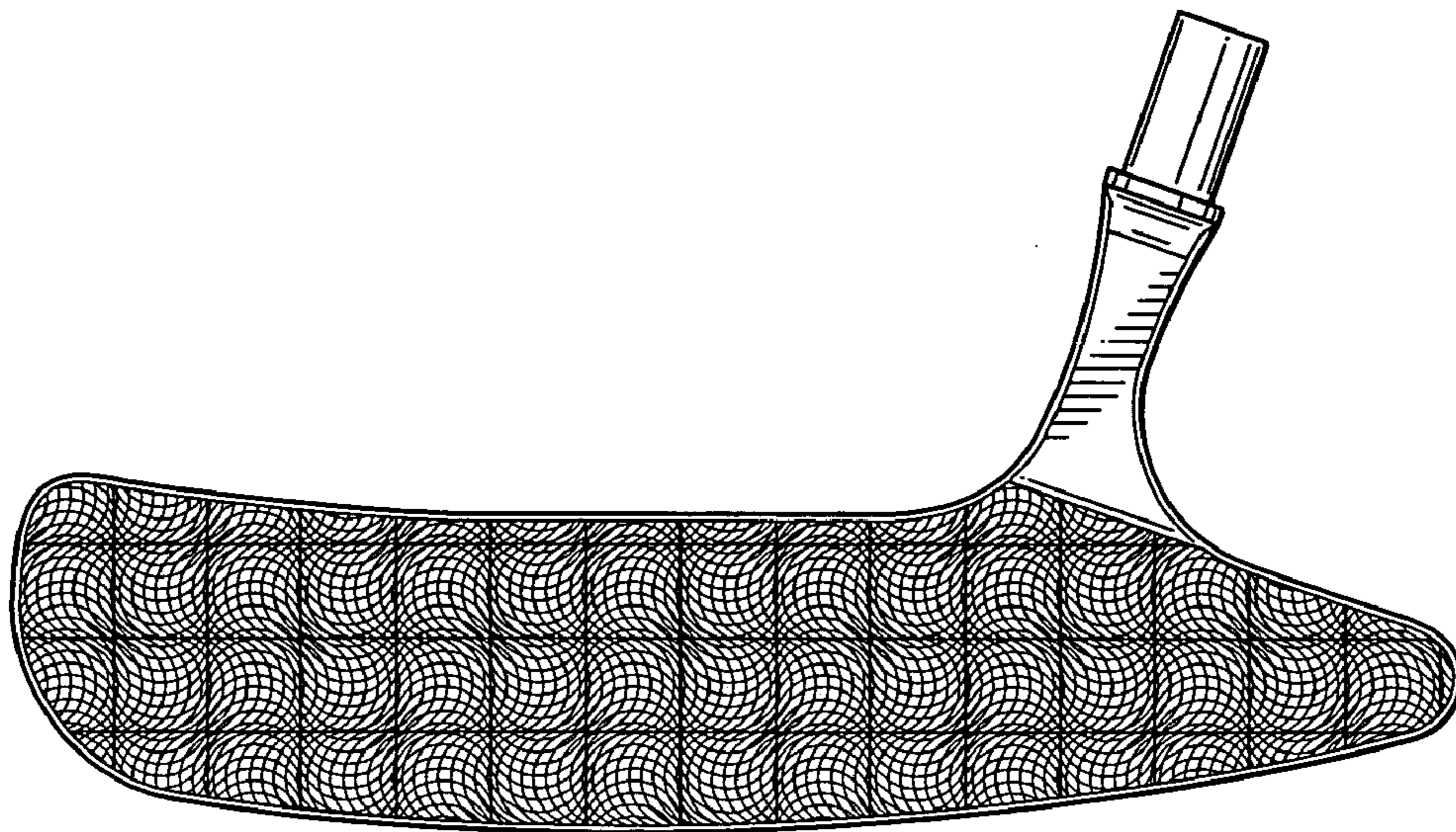

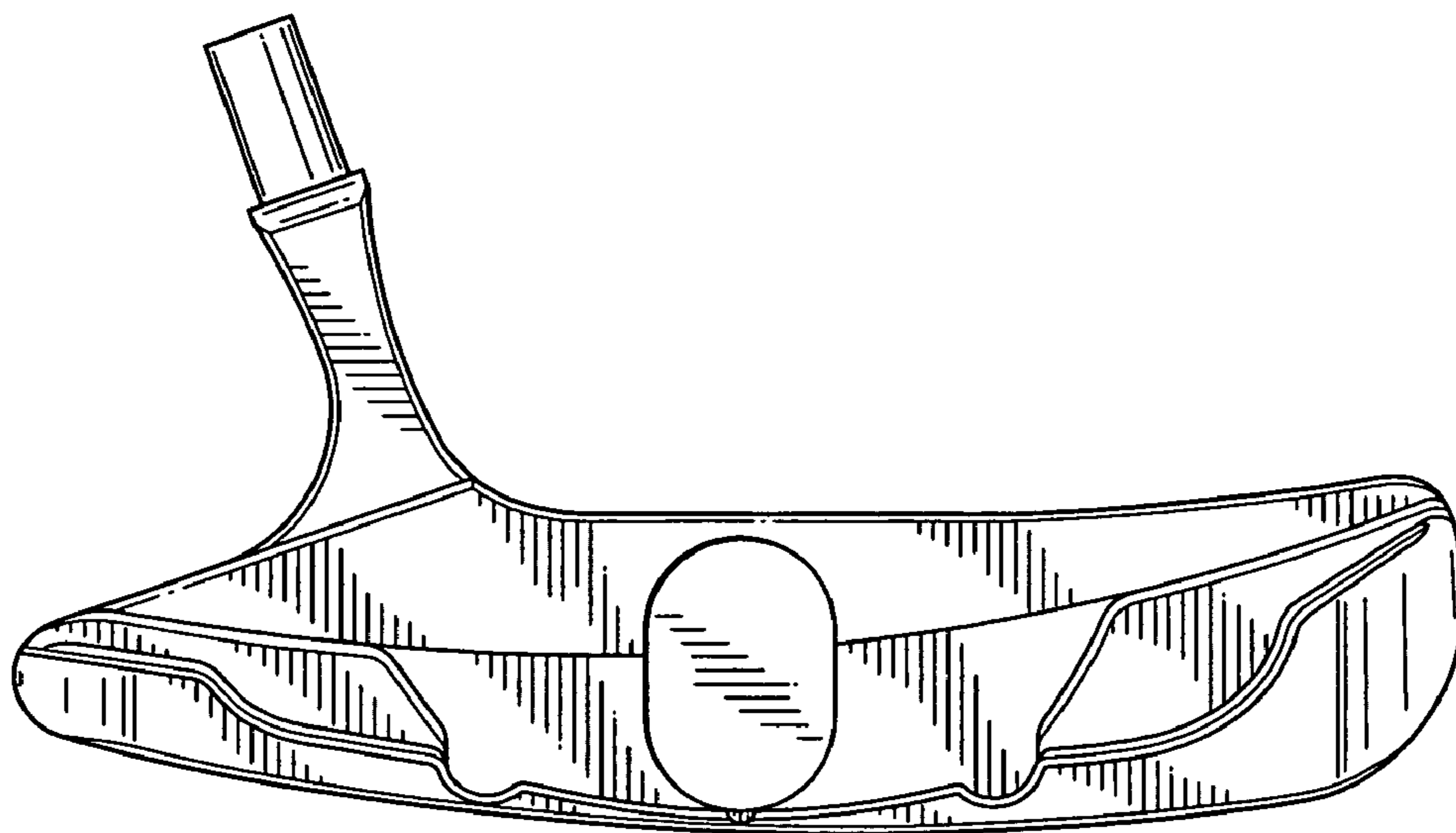

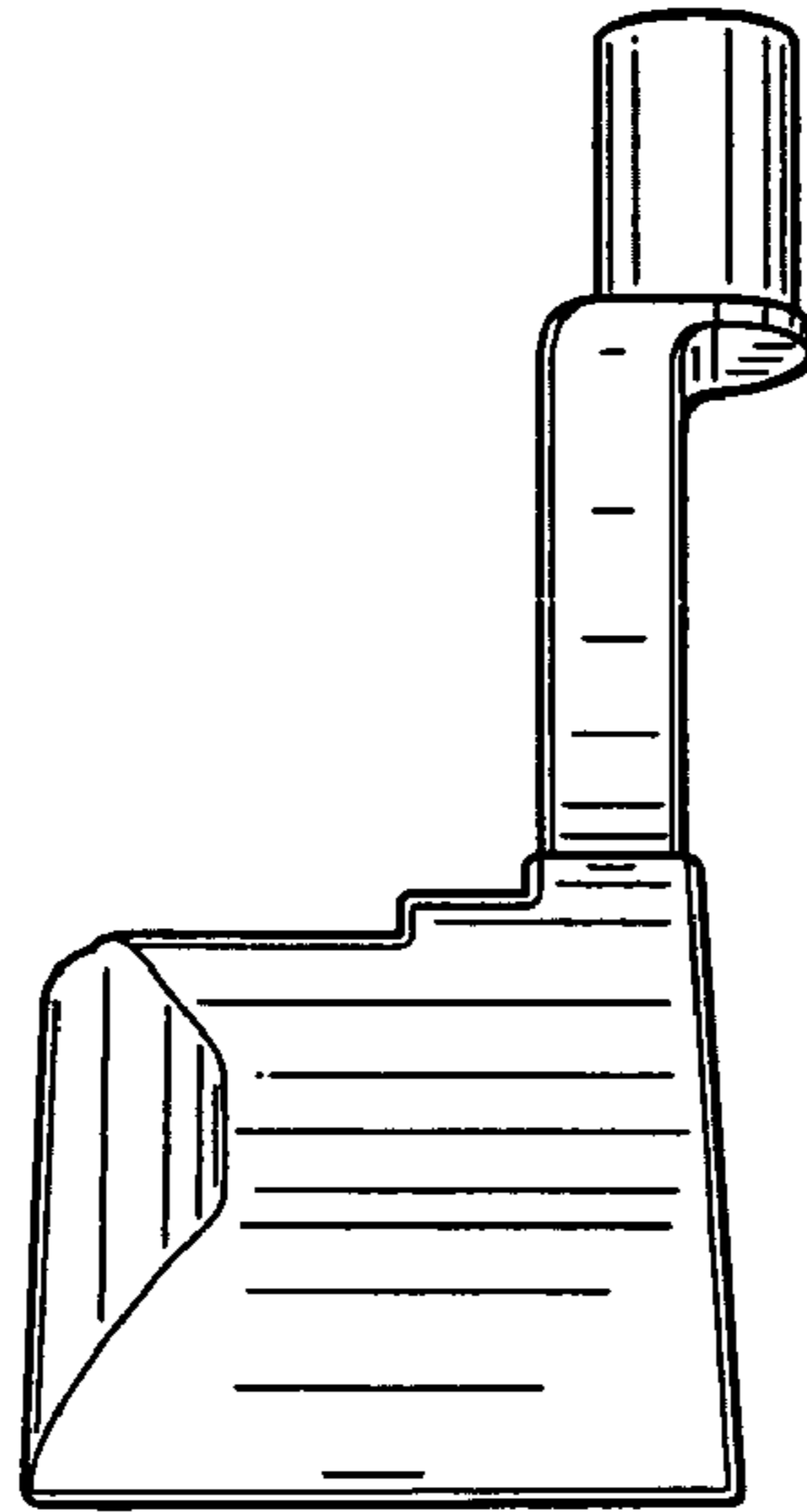

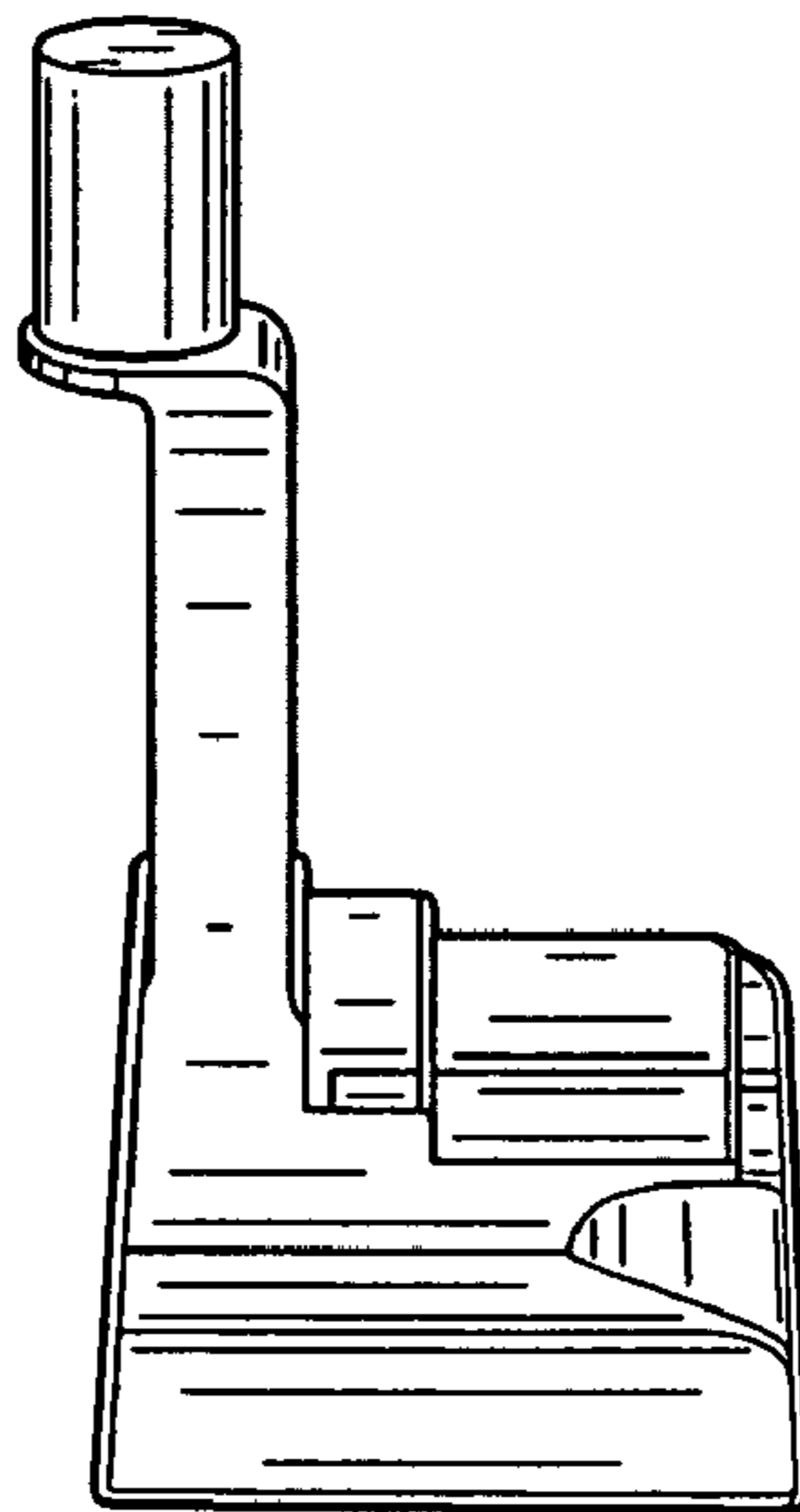

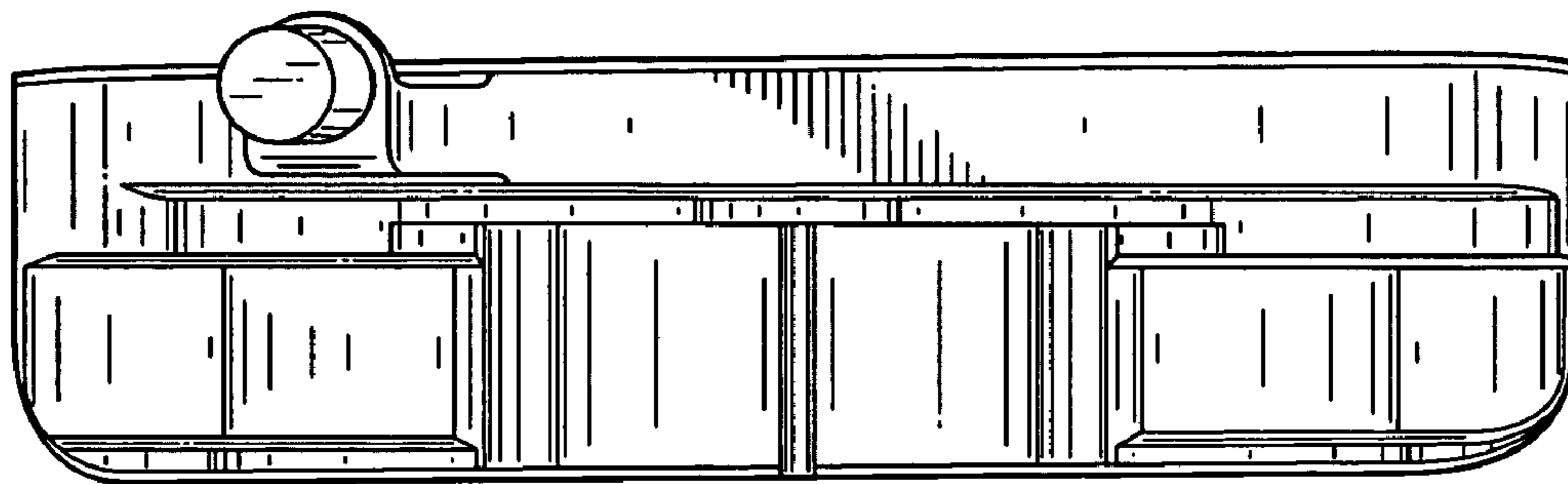

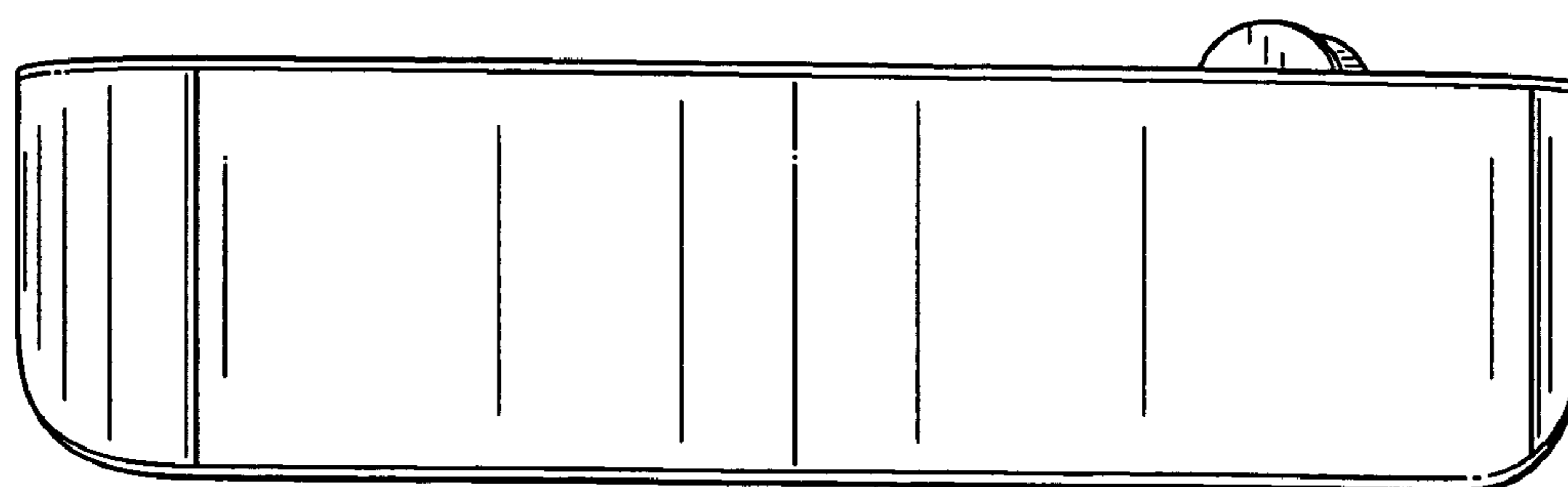

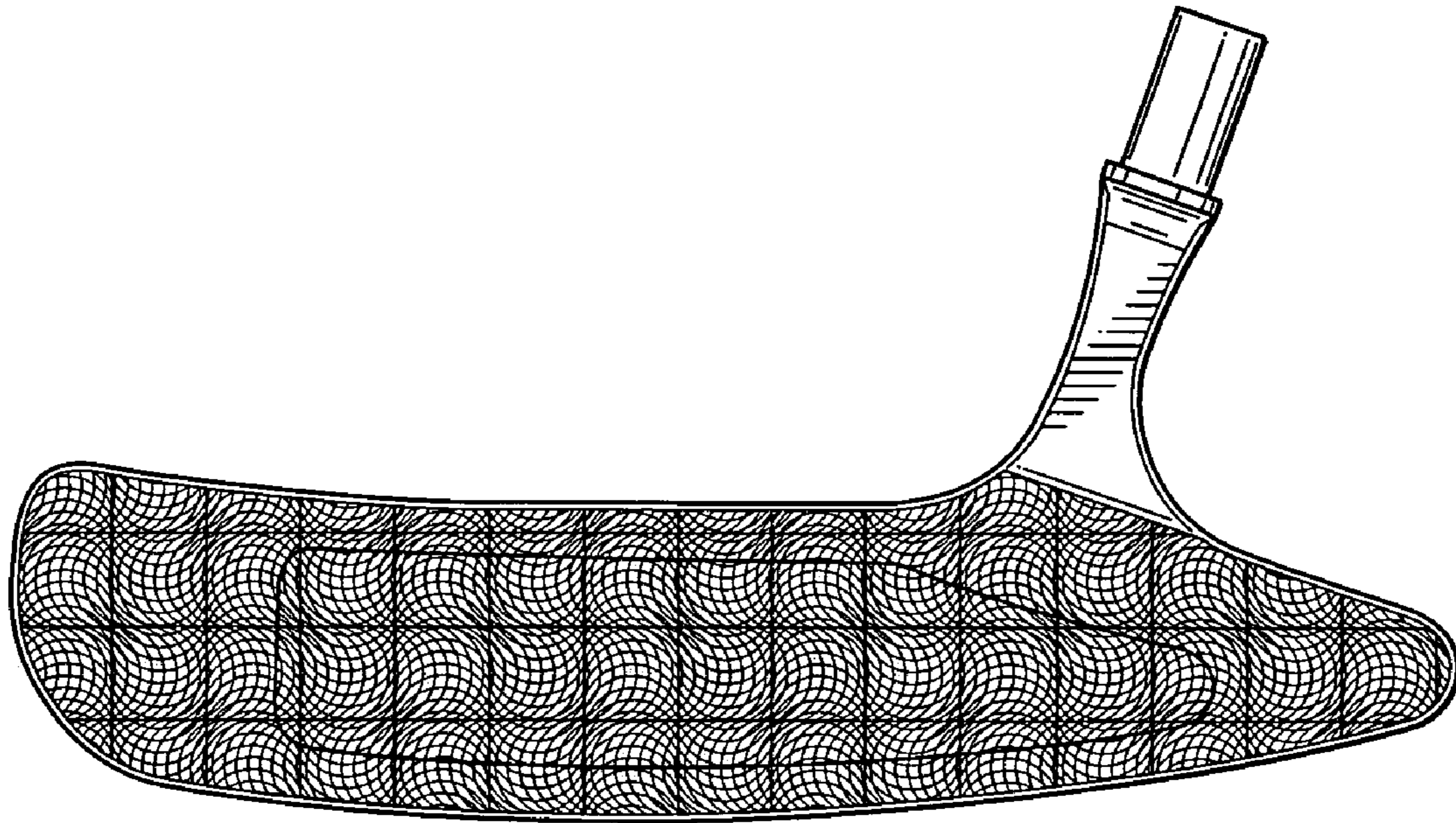
