**DESCRIPTION**

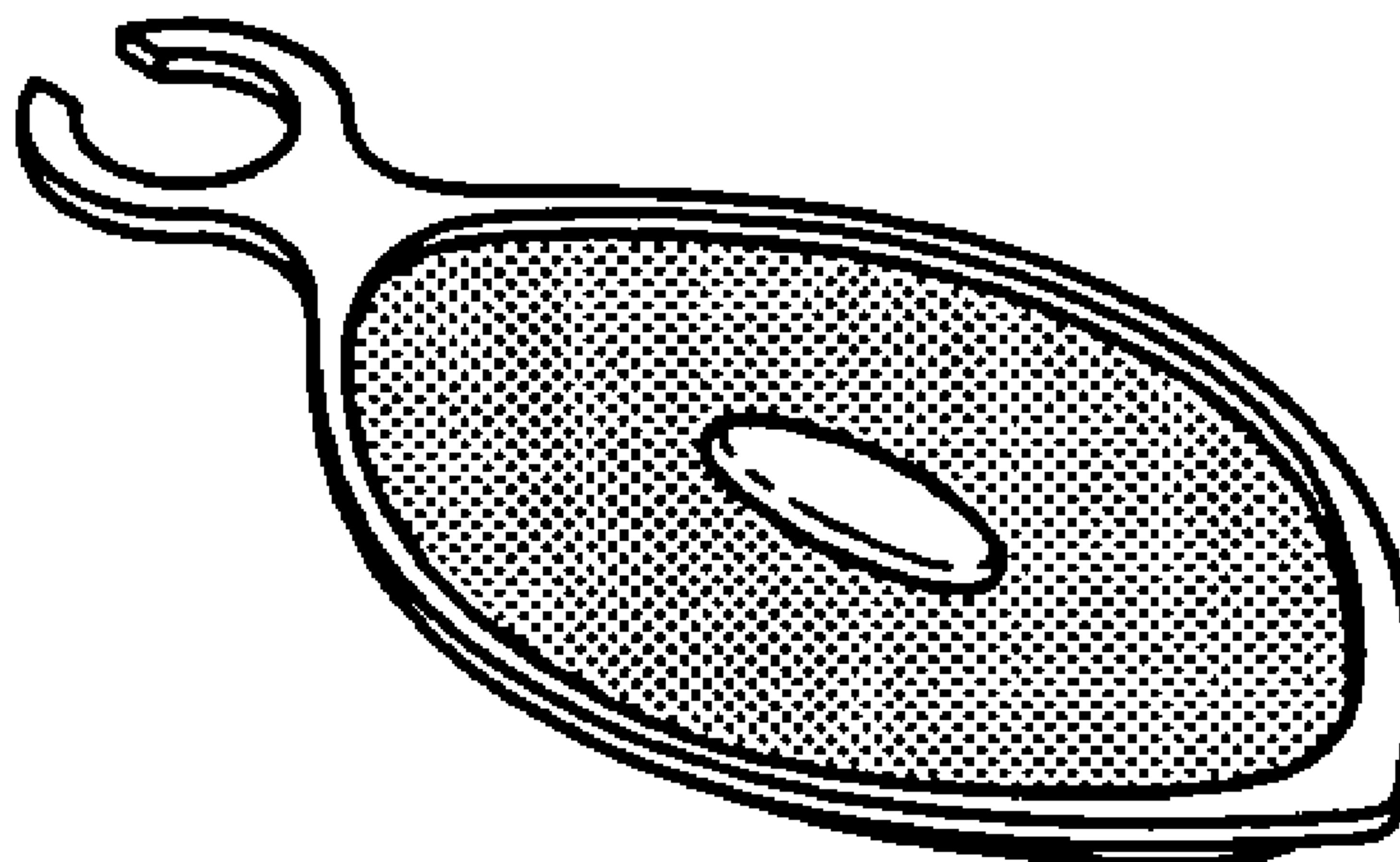
FIG. 1 is a front, top perspective view of our air freshener device;

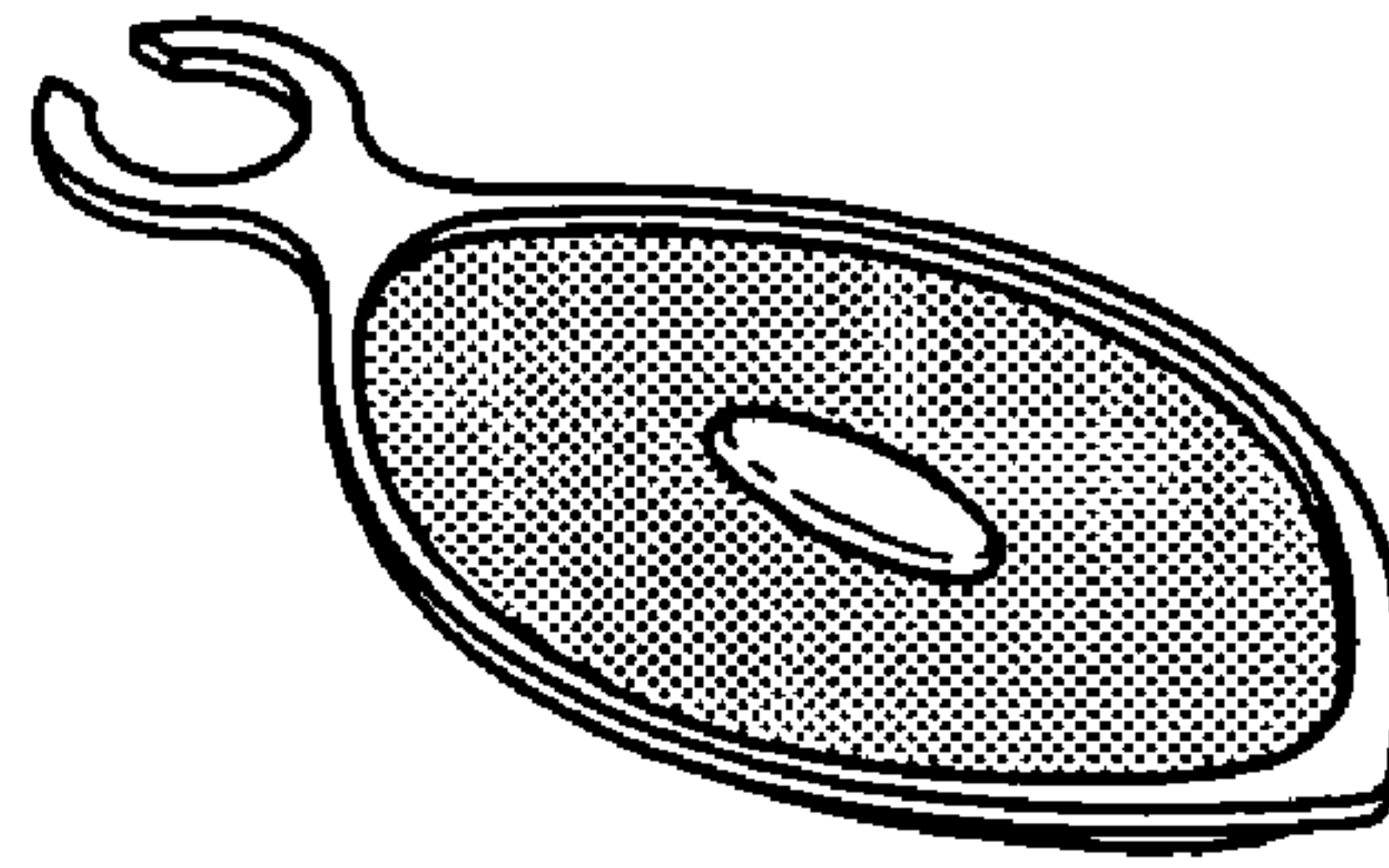

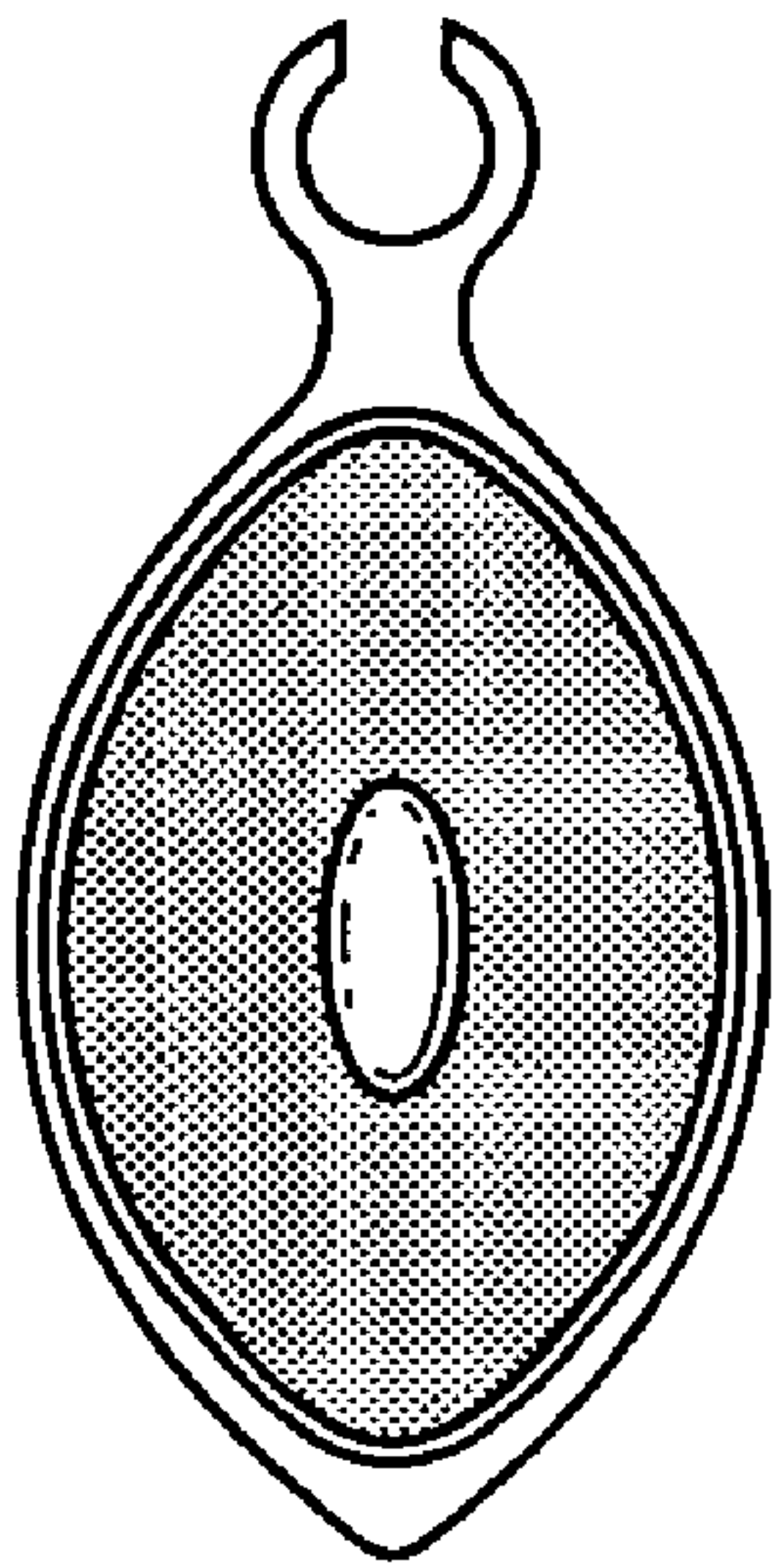

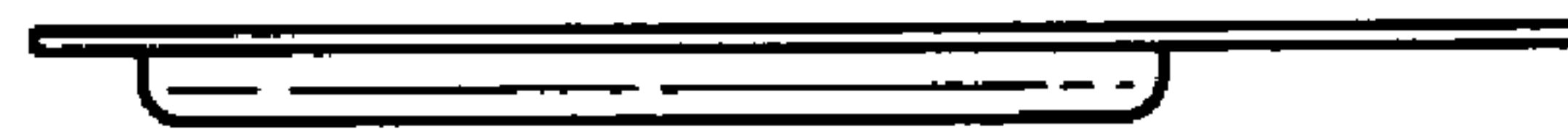
