**DESCRIPTION**

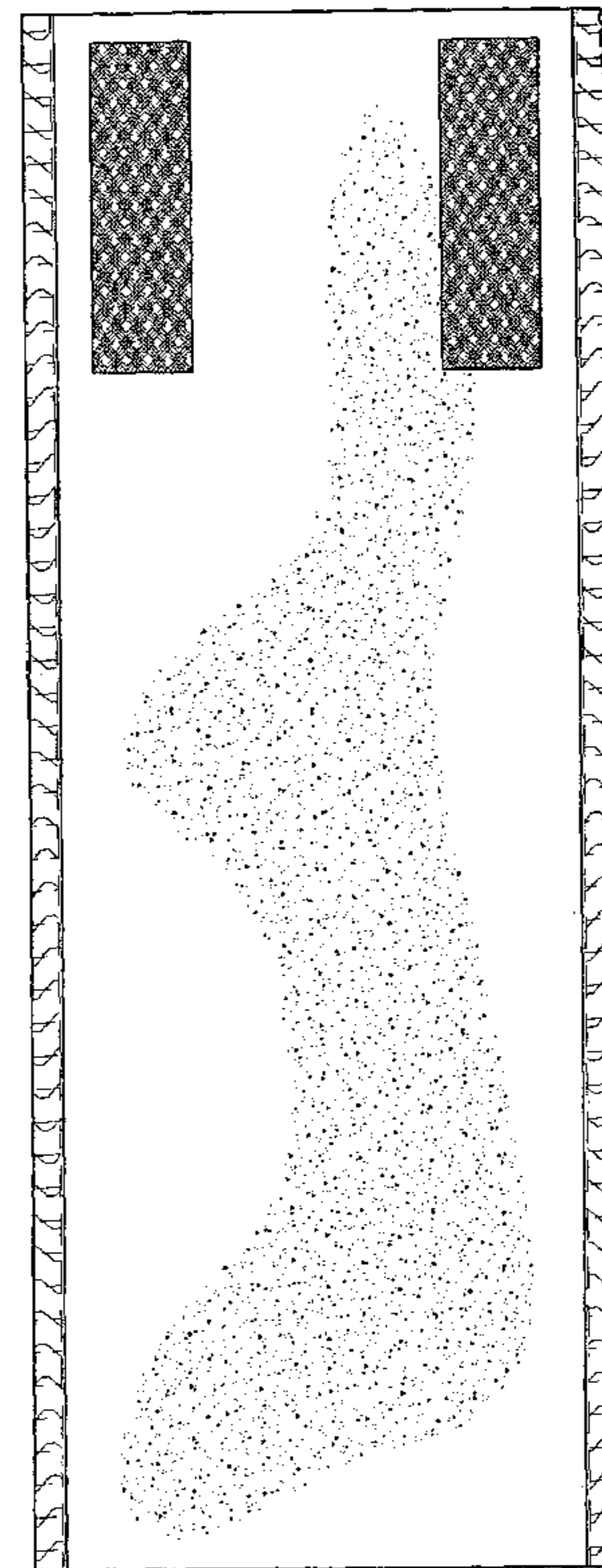
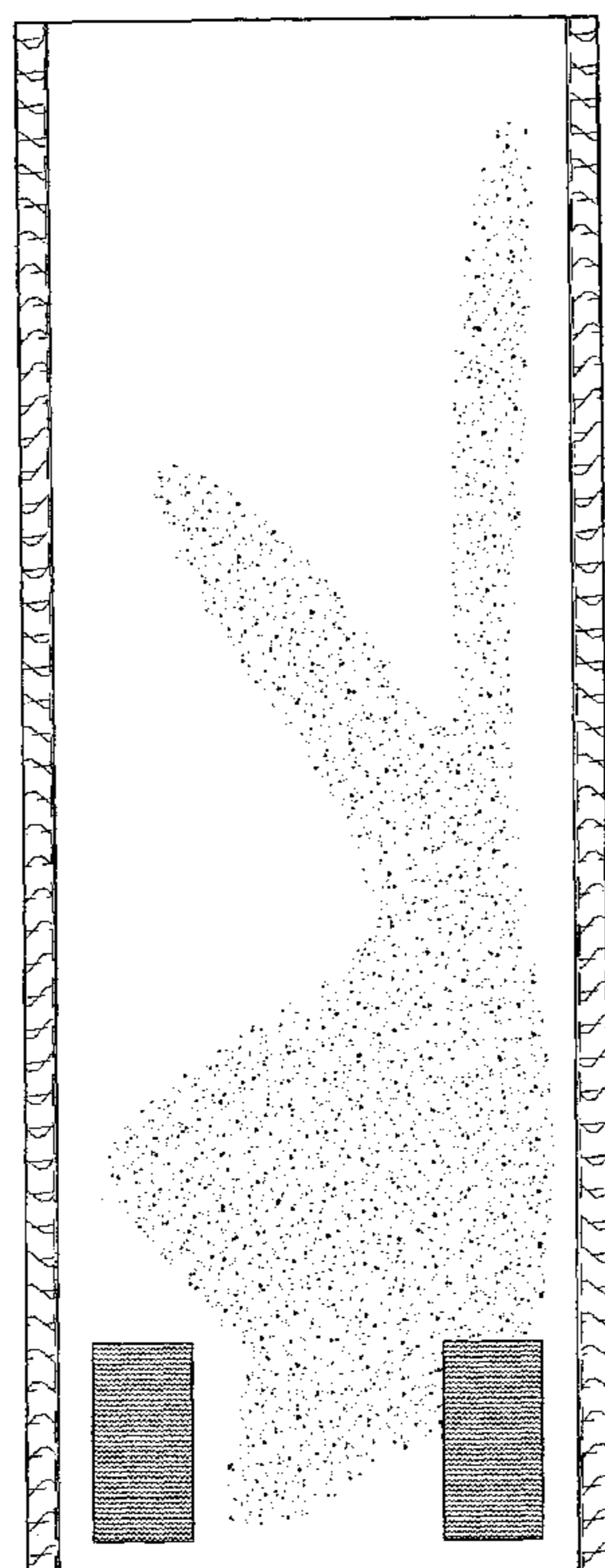
FIG. 1 is a front elevational view of a self-adhering and reusable surgical dressing showing our new design;

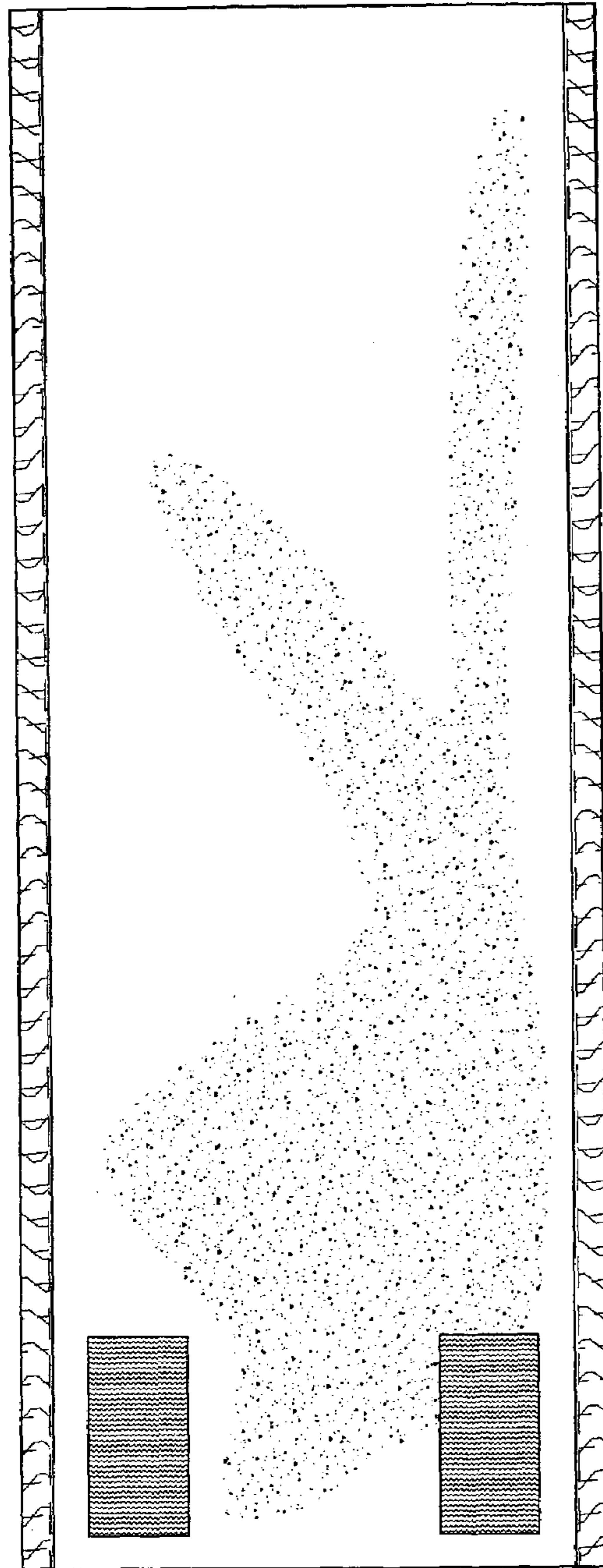

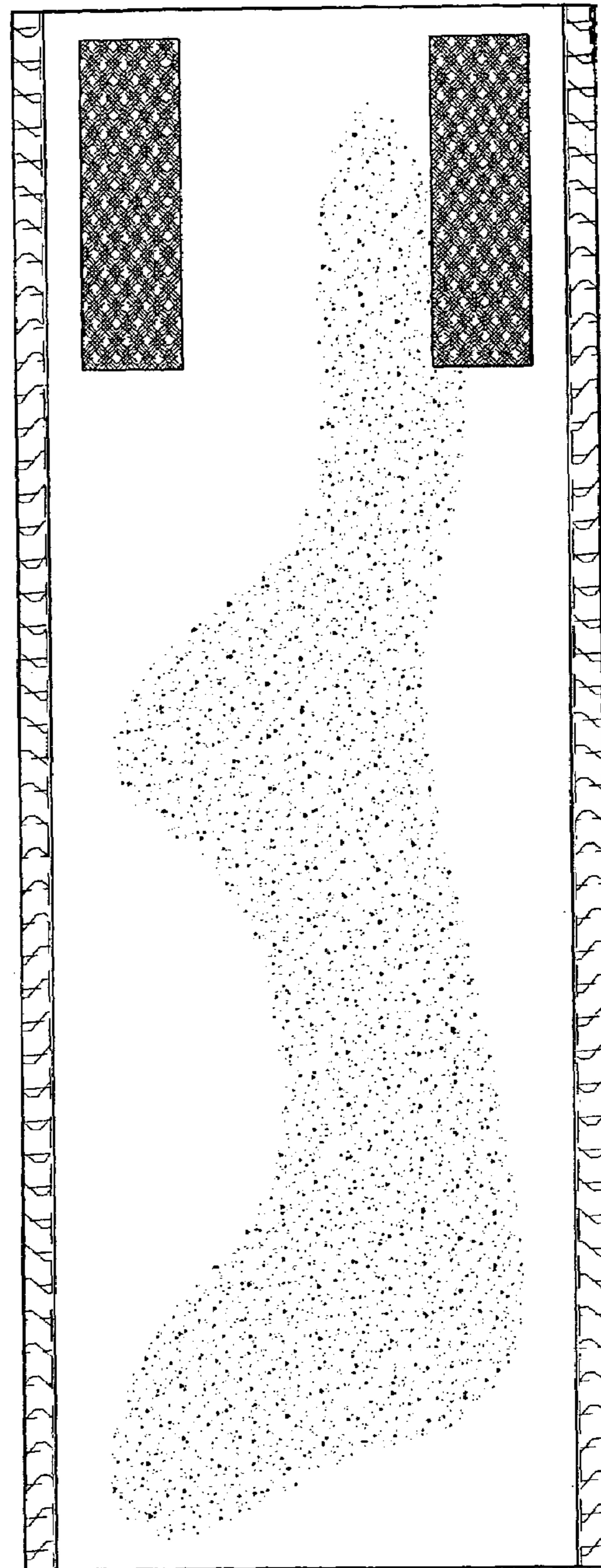

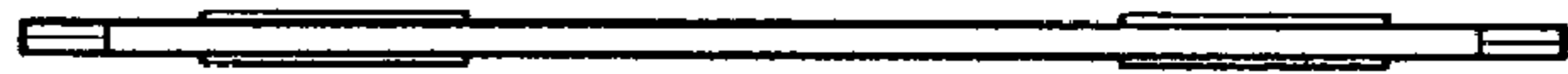
