FIG. 11 is a rear view thereof in an open position;

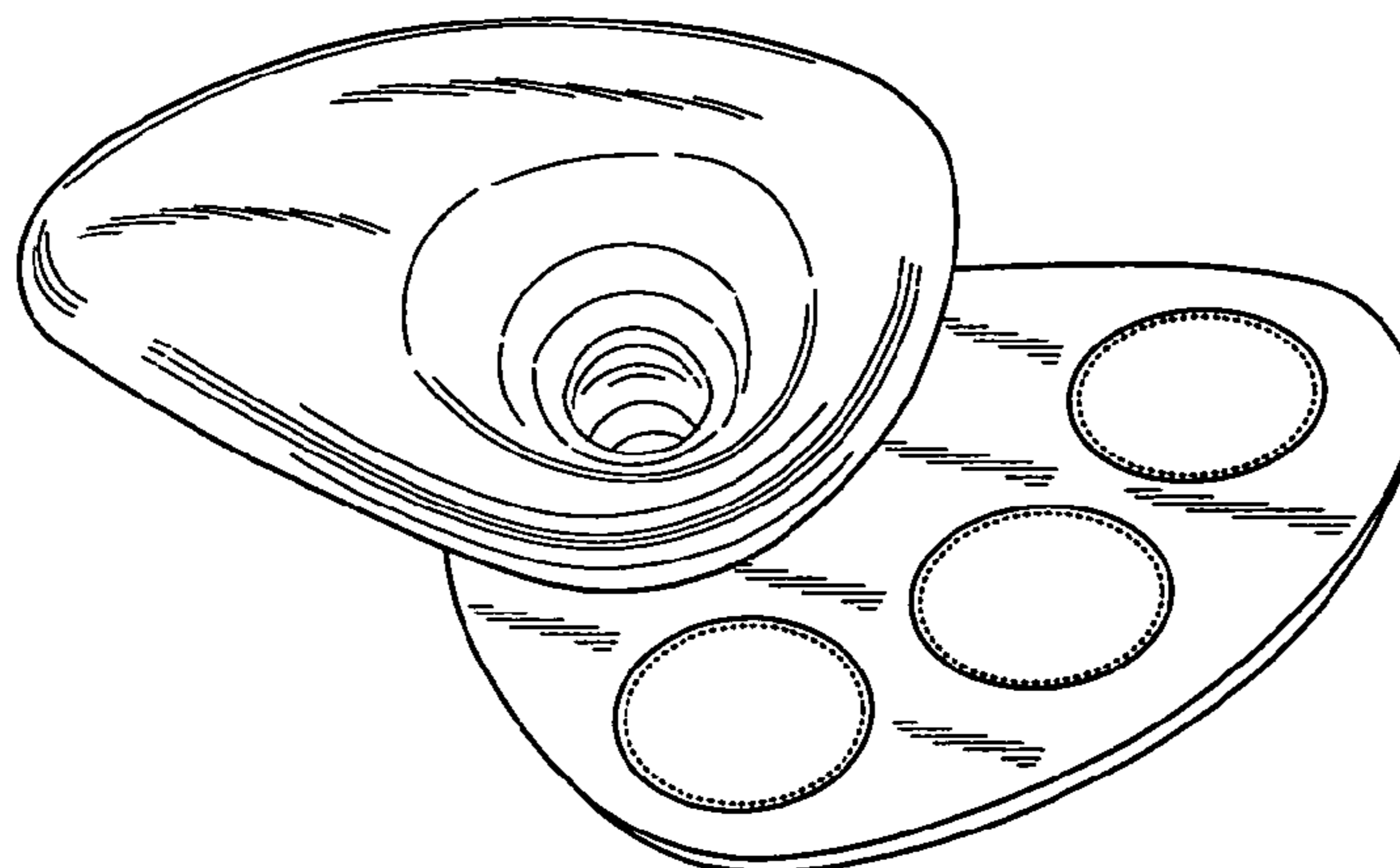
FIG. 12 is a front view thereof in an open position;

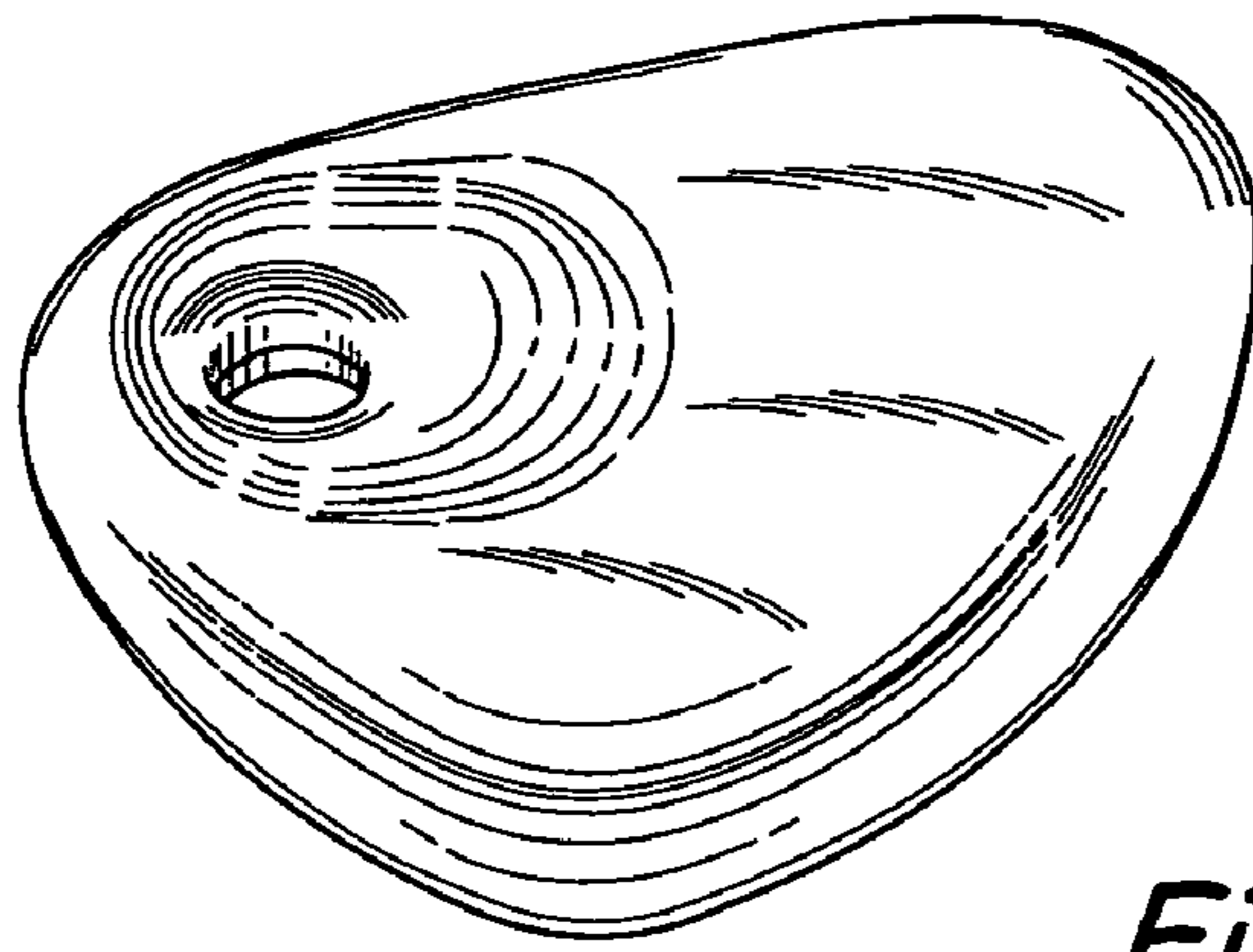

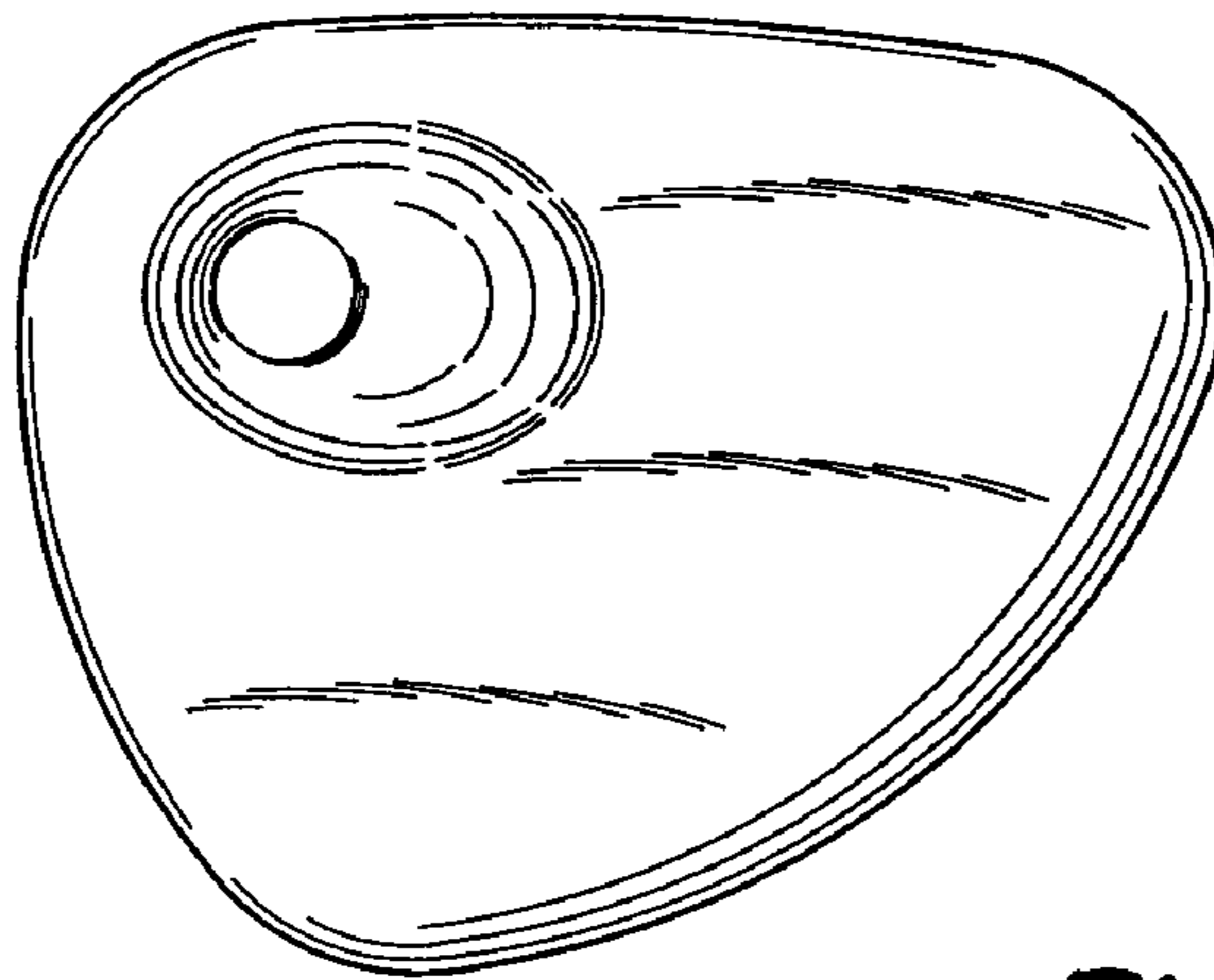

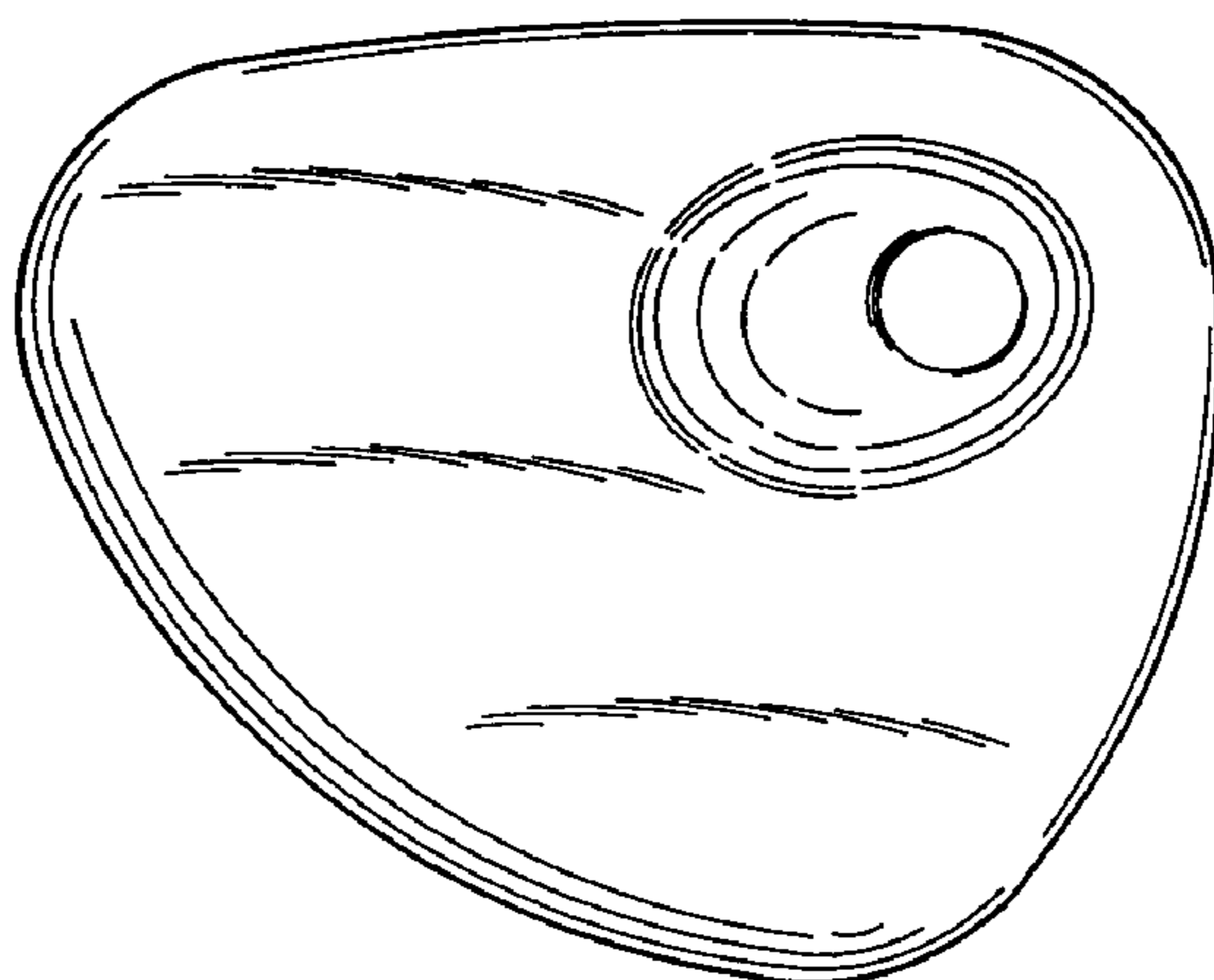

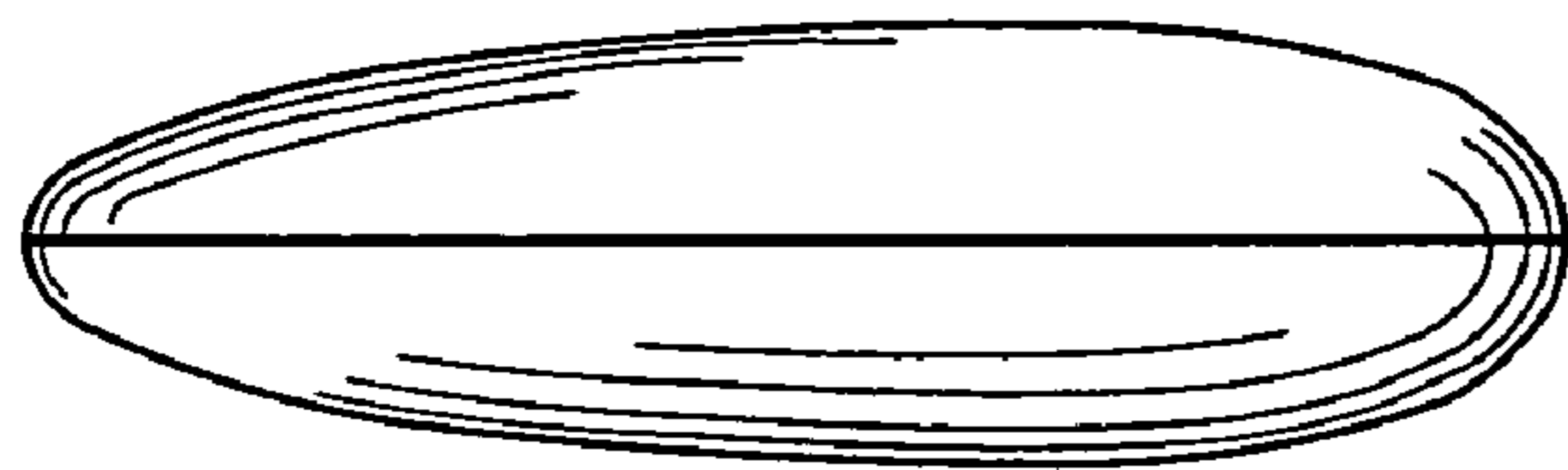

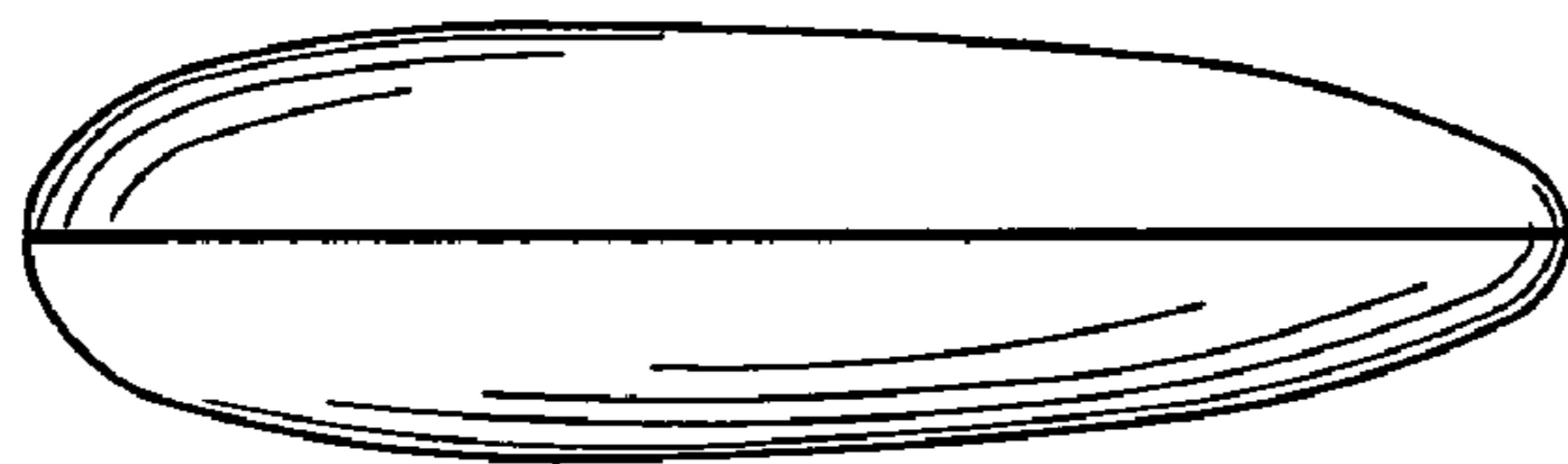

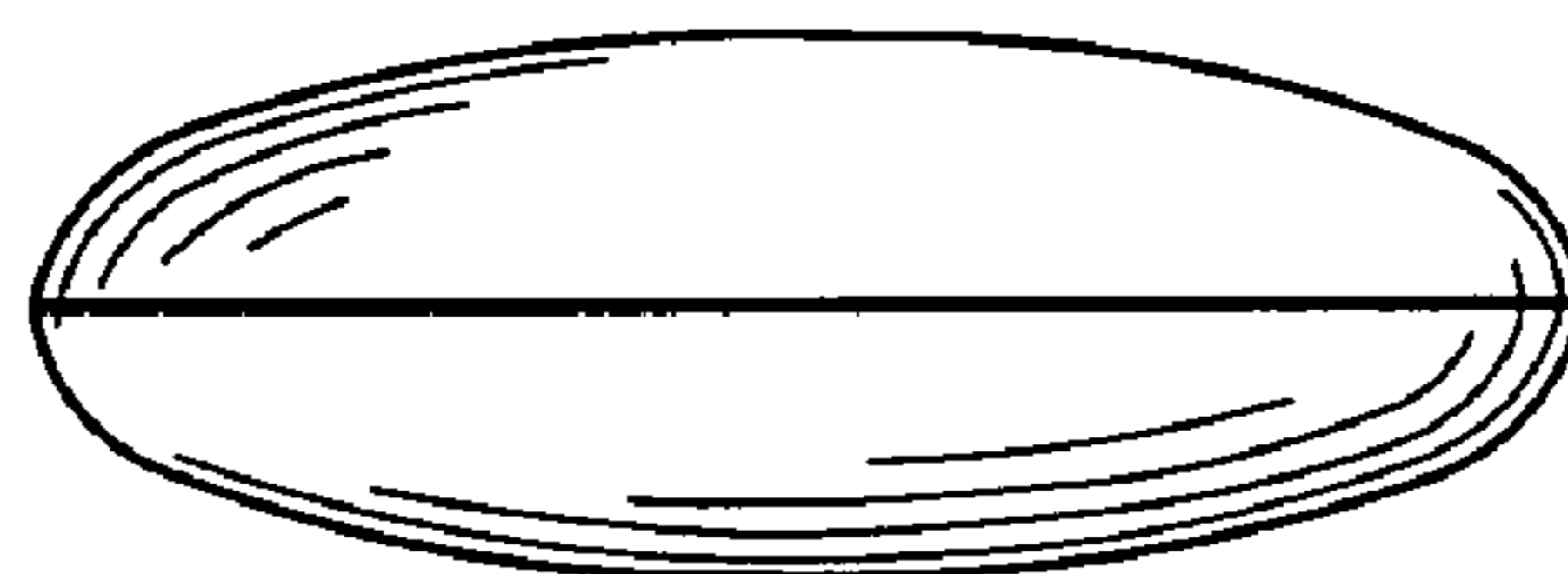
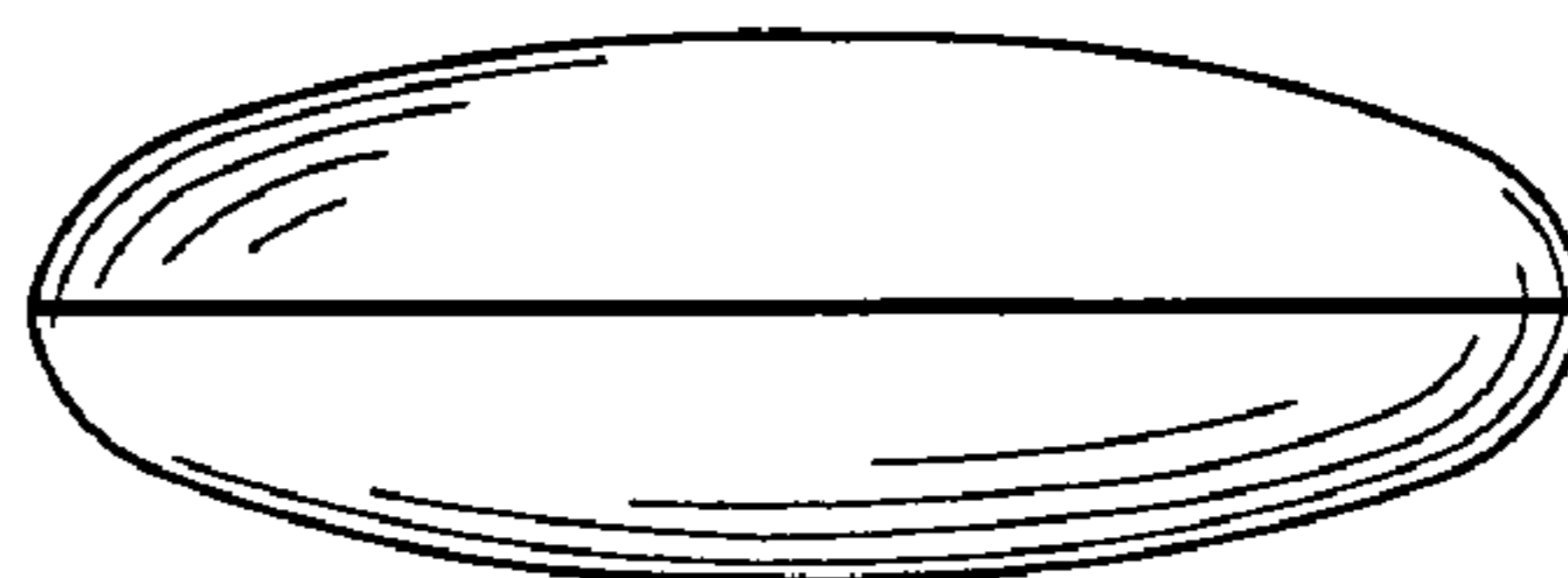

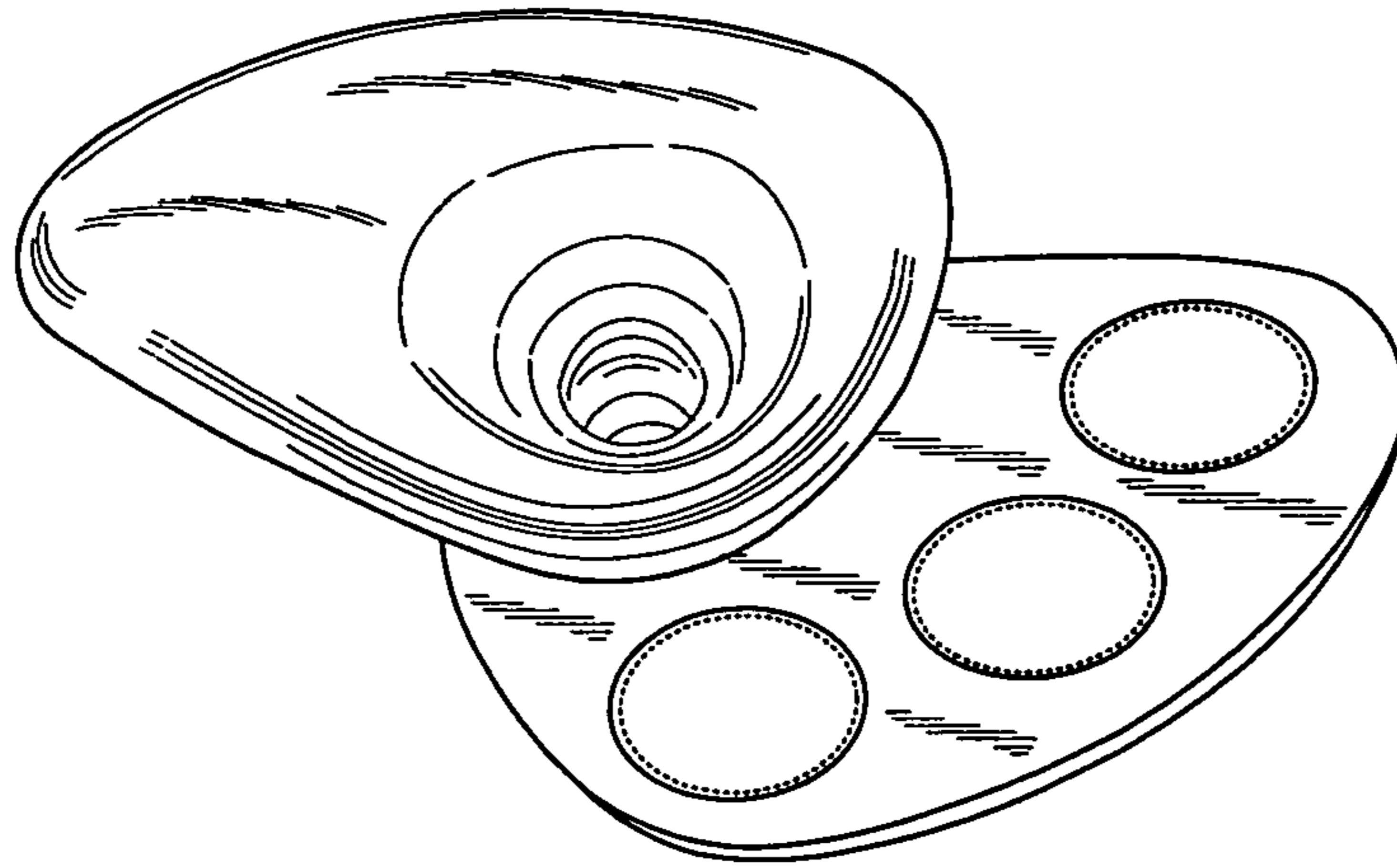

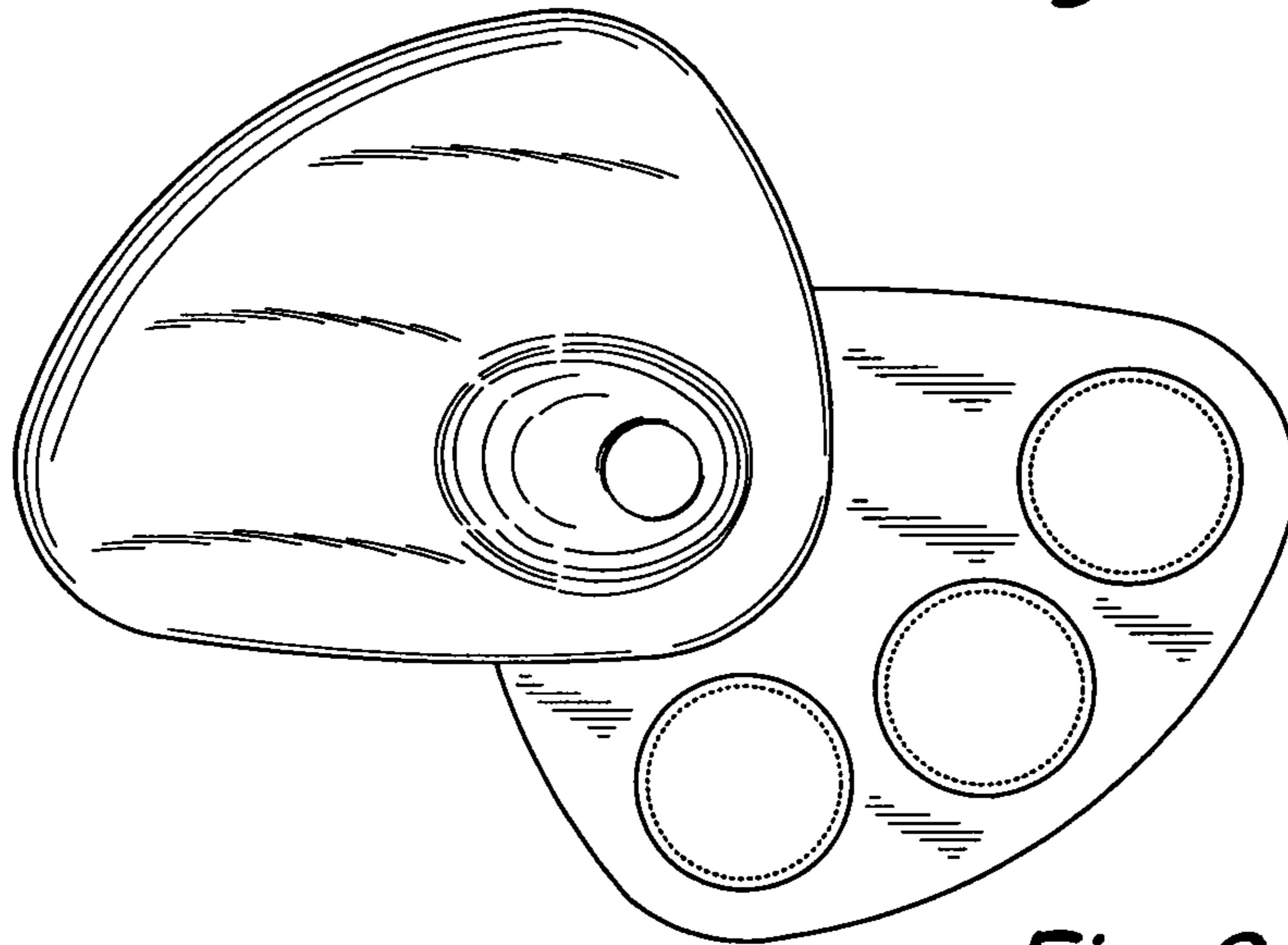

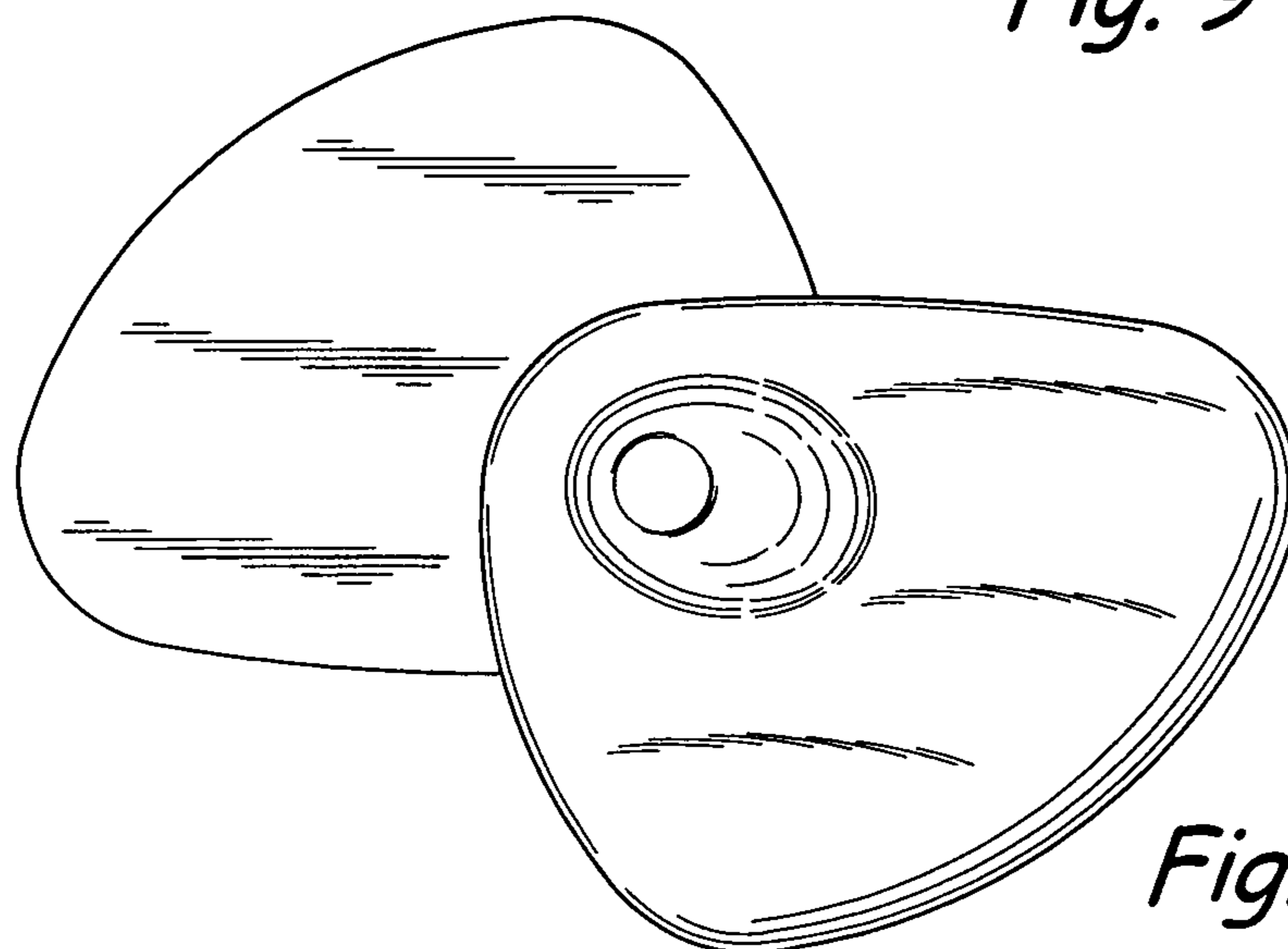

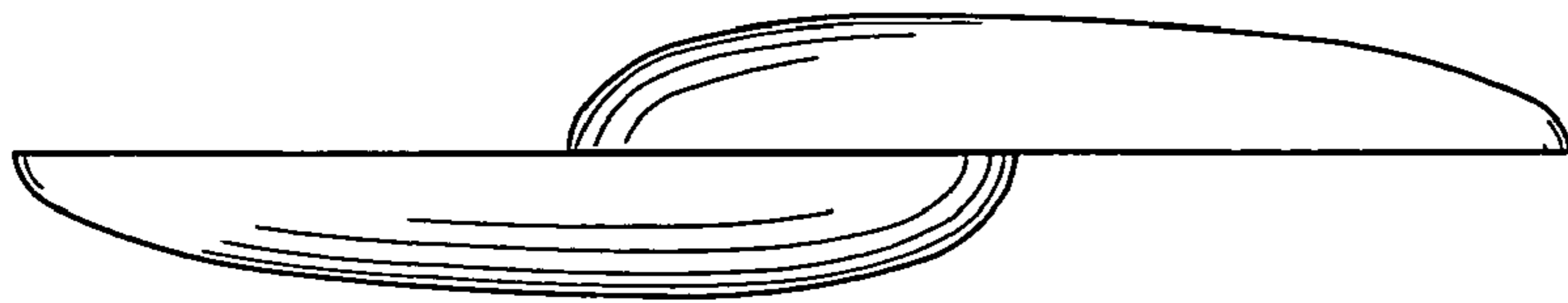

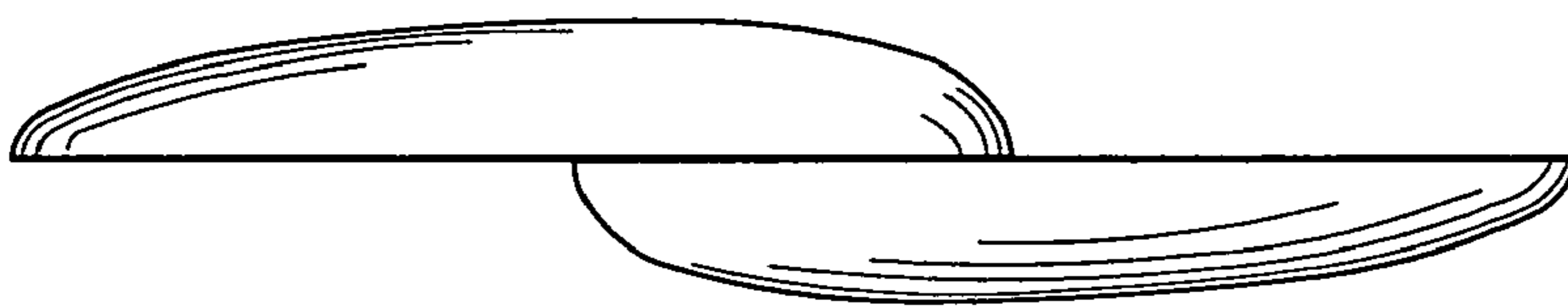

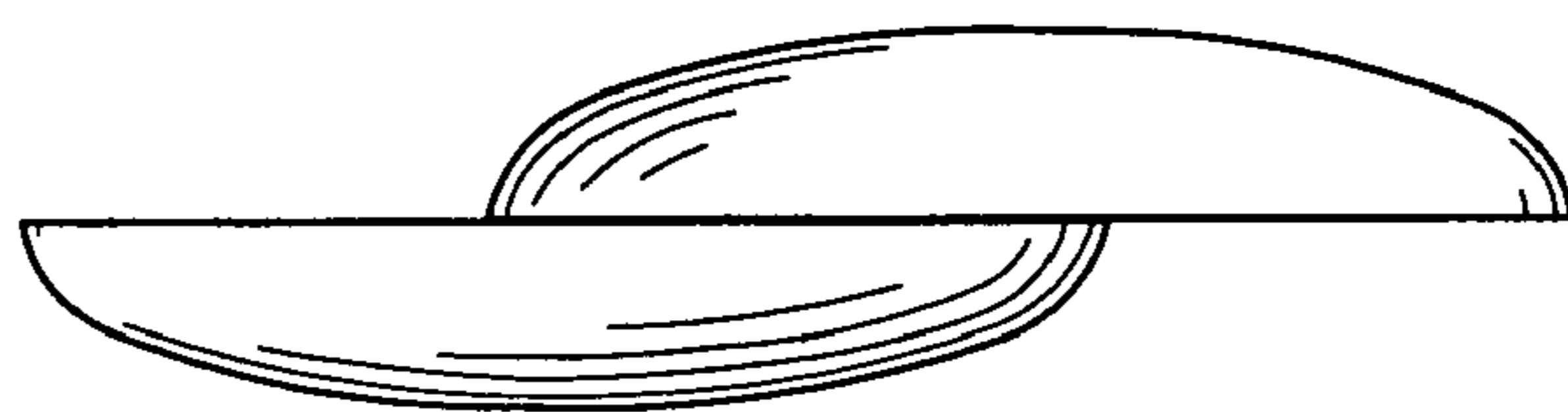

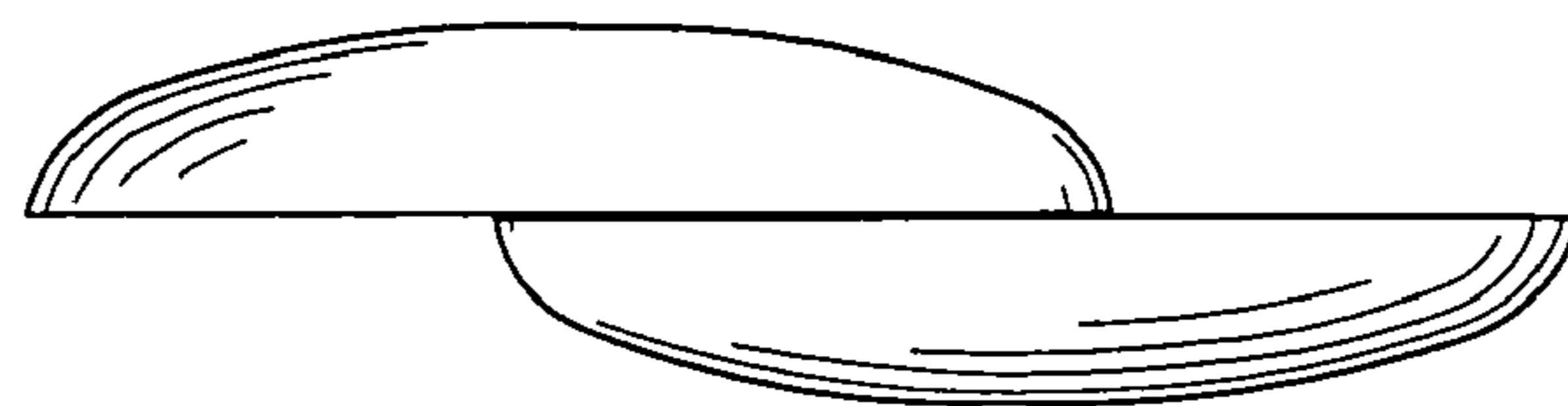
