FIG. 4 is a rear view;

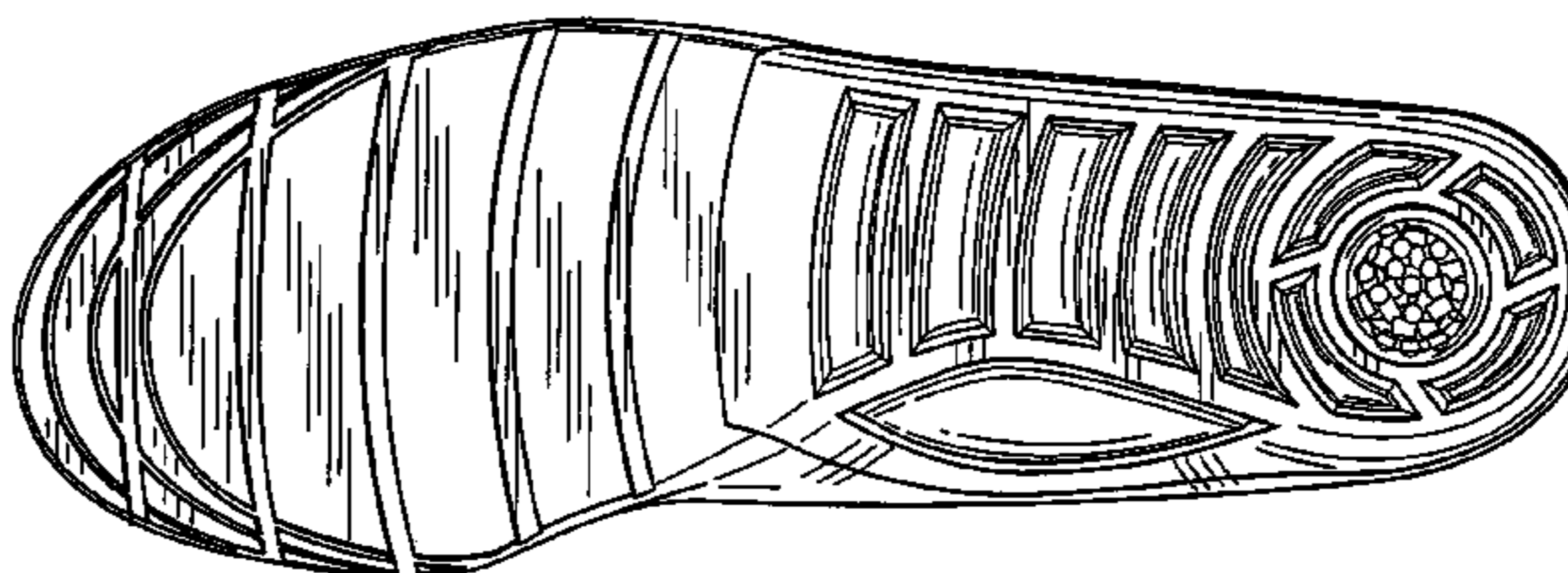
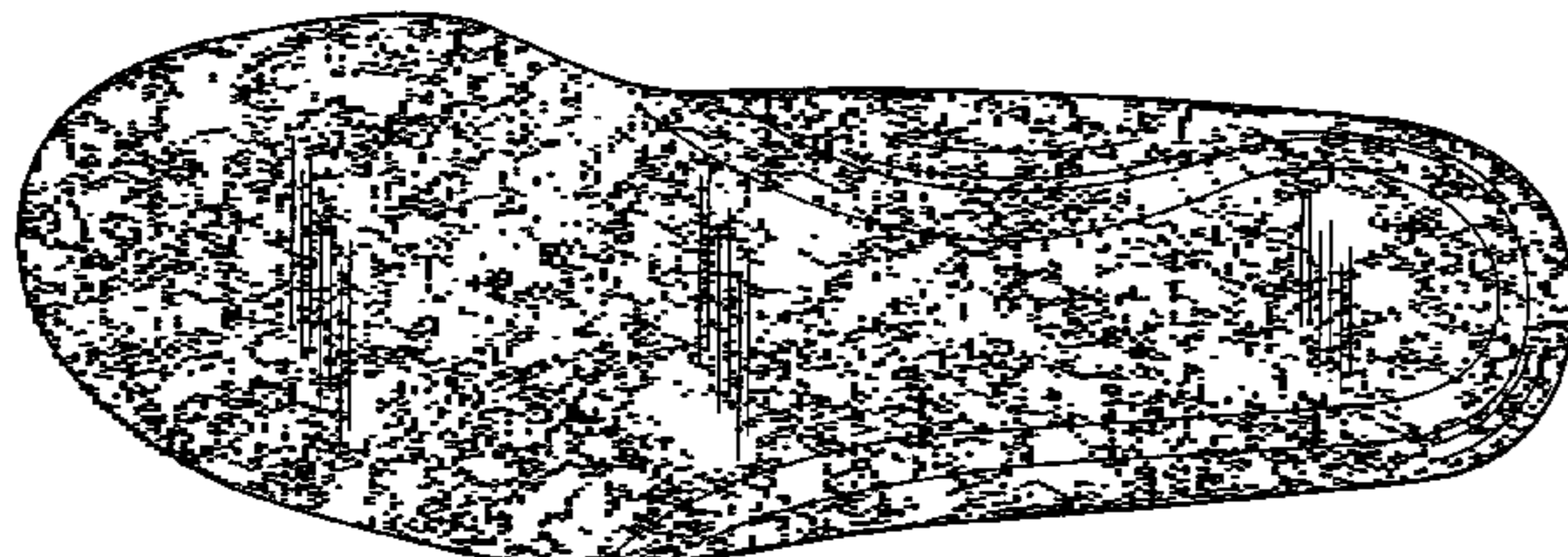
FIG. 5 is a left-hand side view;

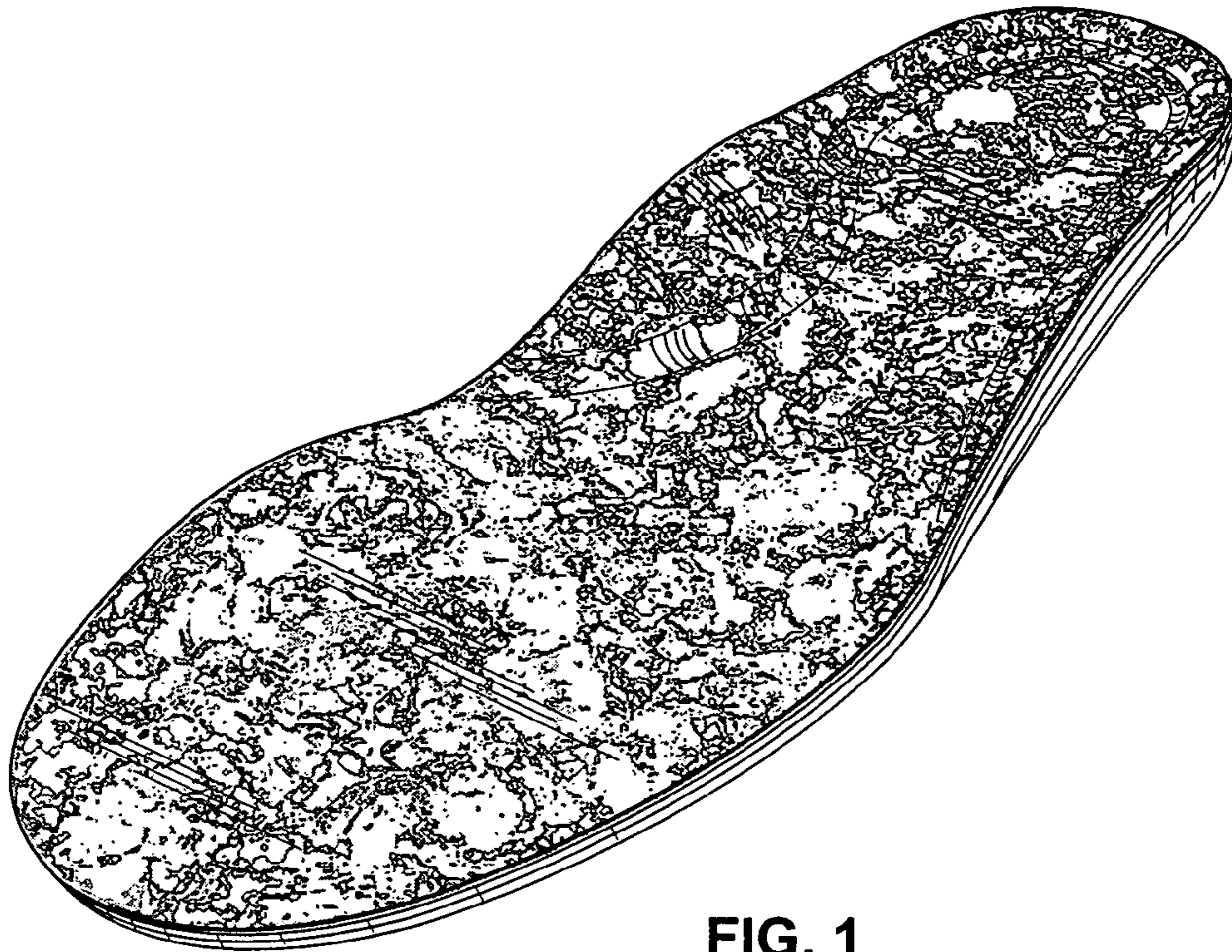

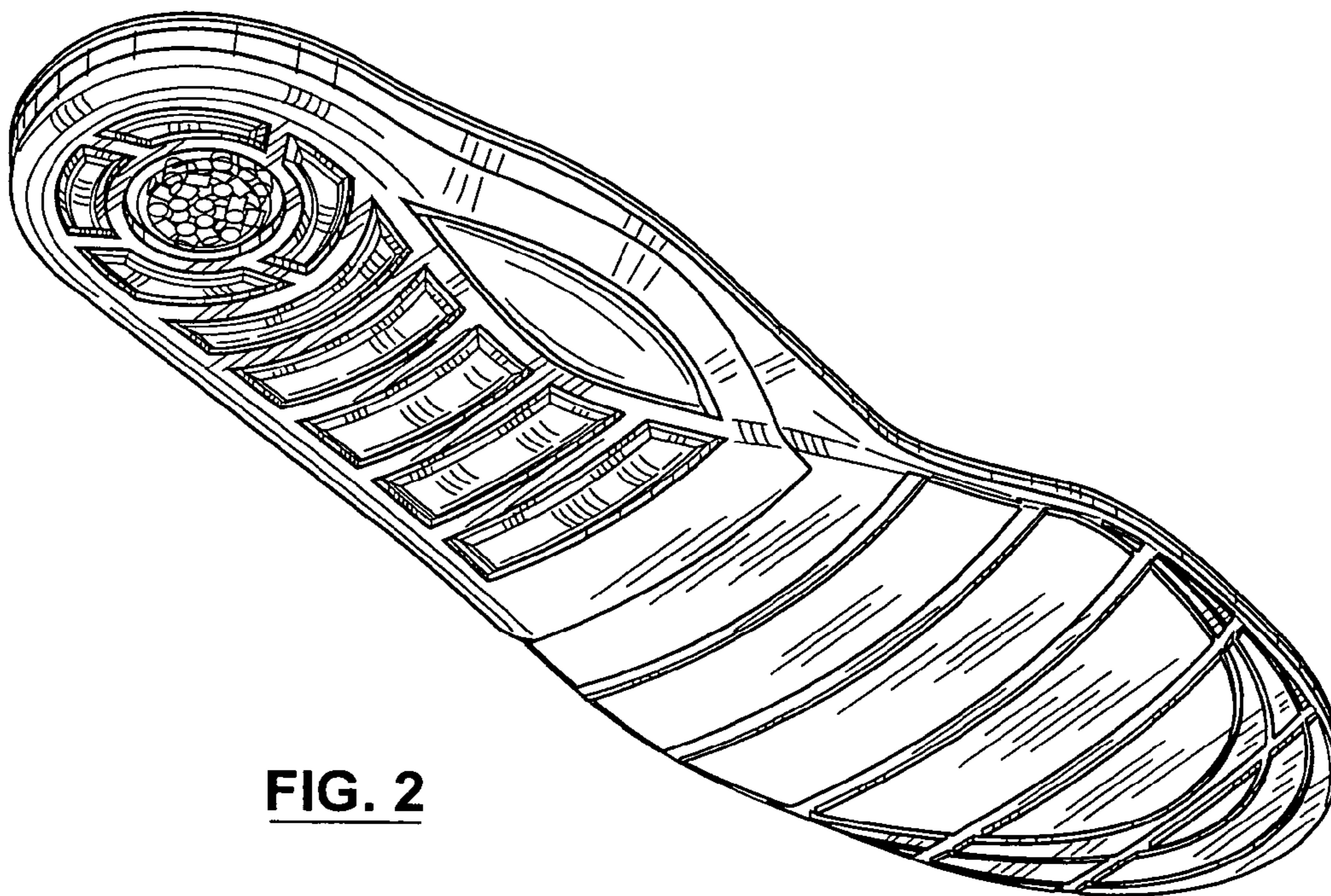

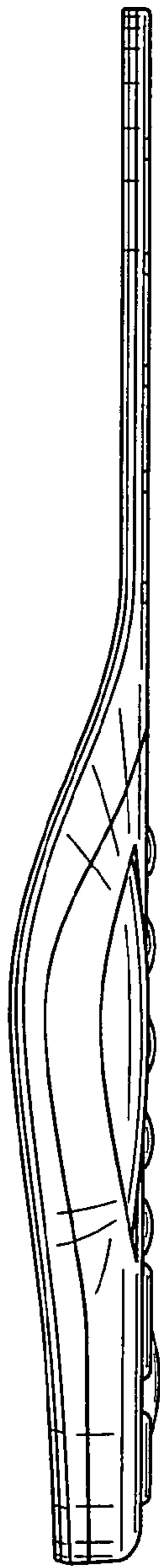

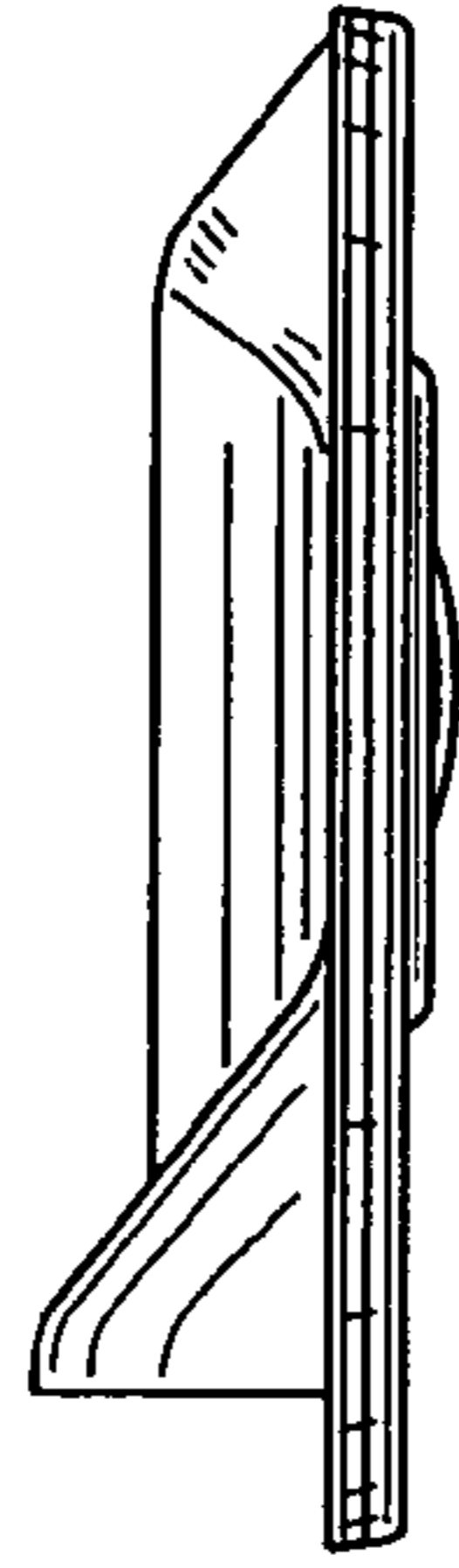

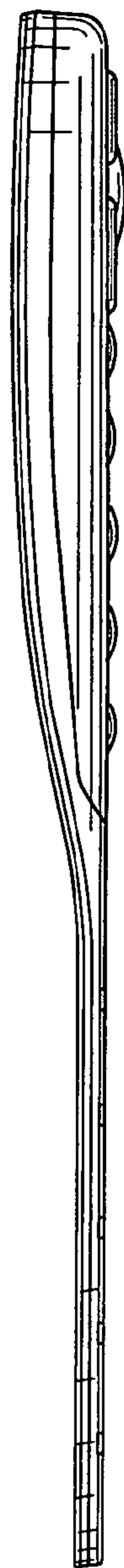

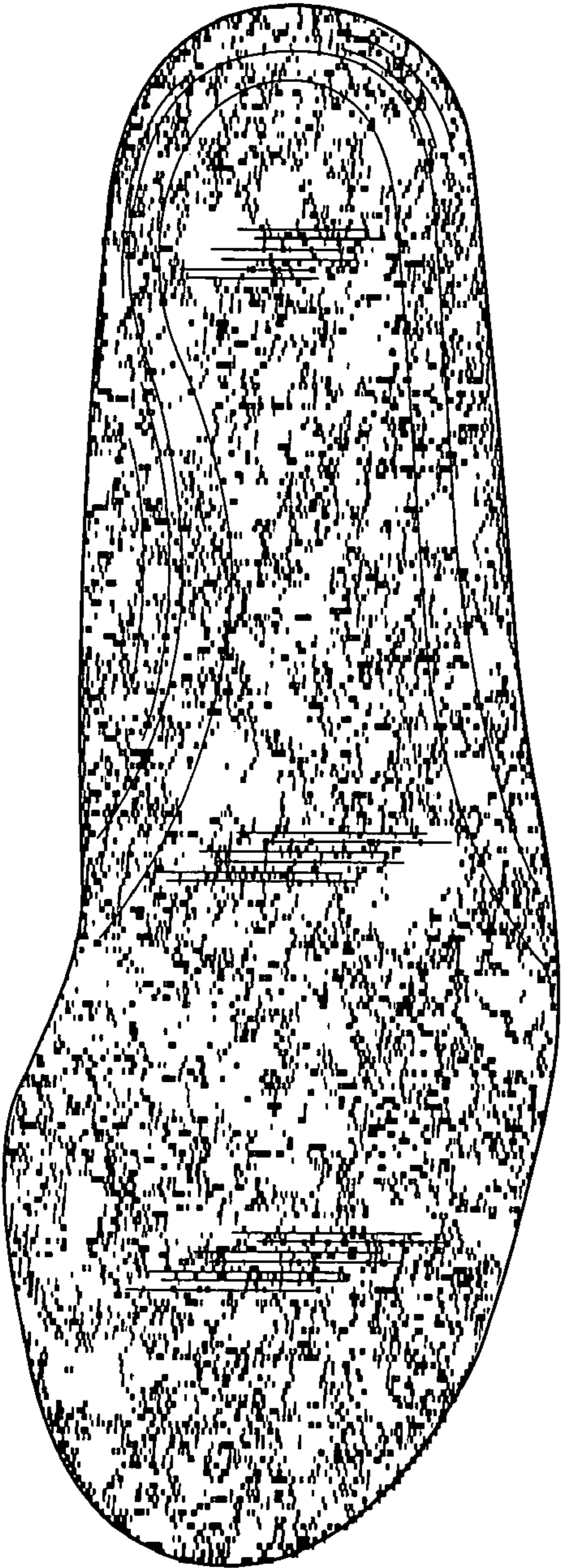

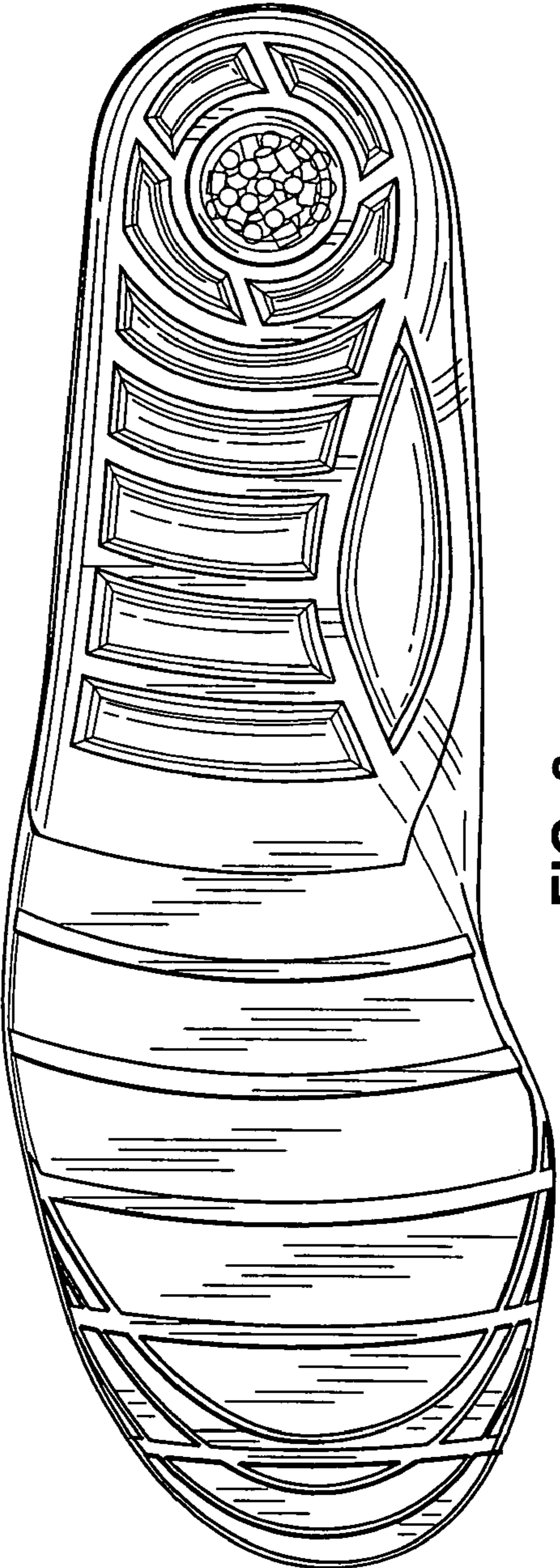
