What is claimed is the ornamental design for a bowl, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bowl according to the new design;

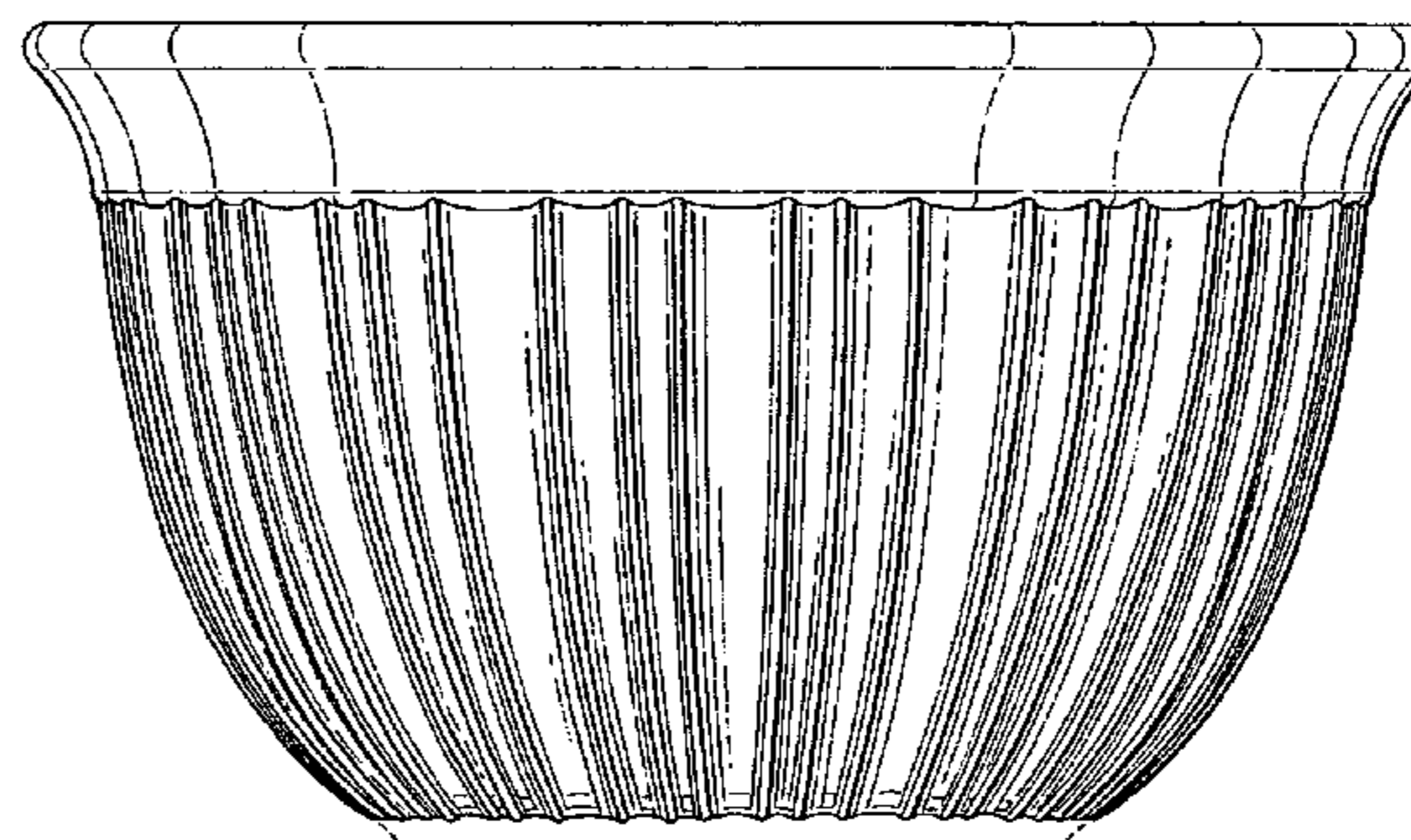
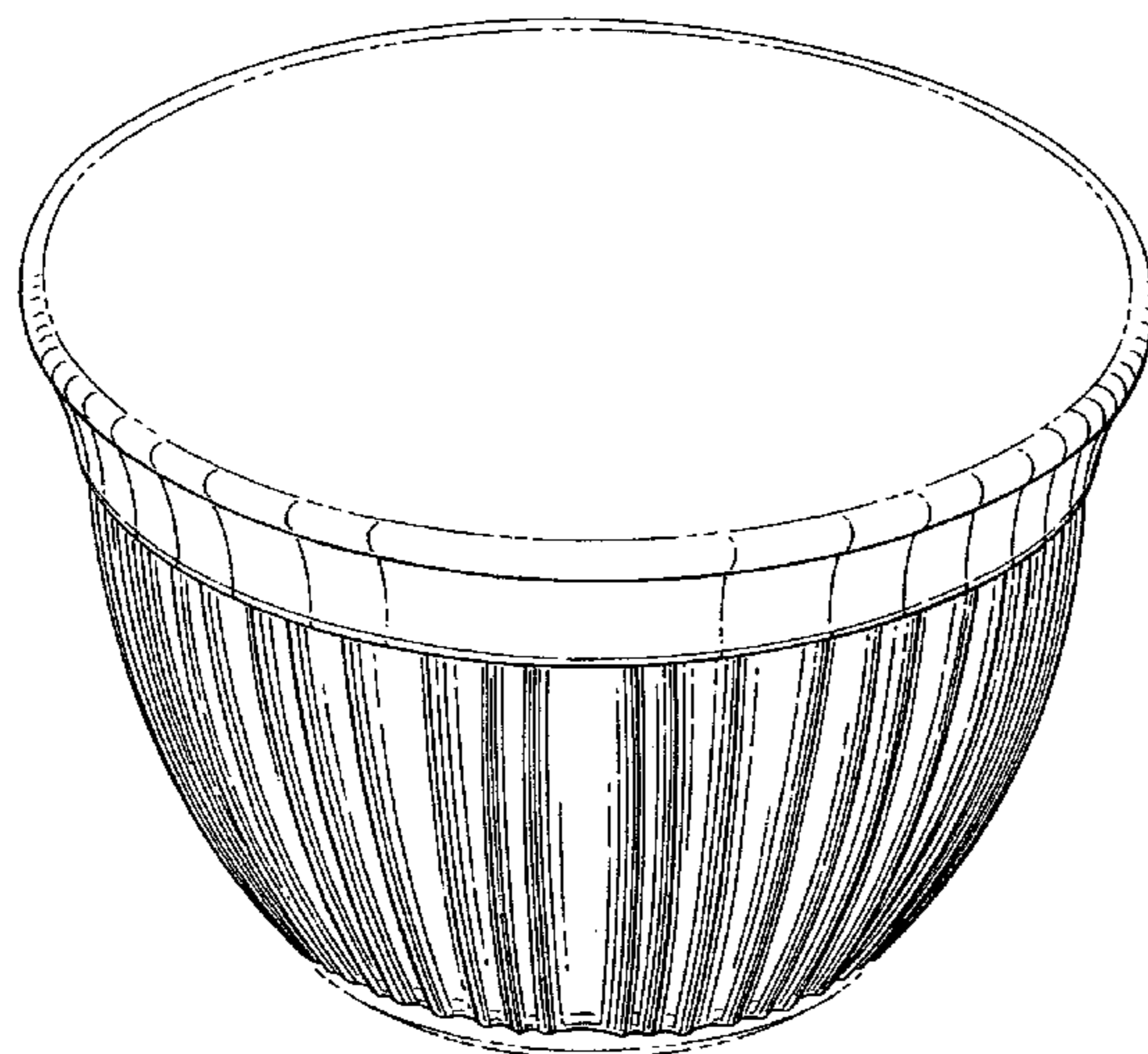
FIG. 2 is a front view of the bowl shown in FIG. 1, the rear view being identical thereto;

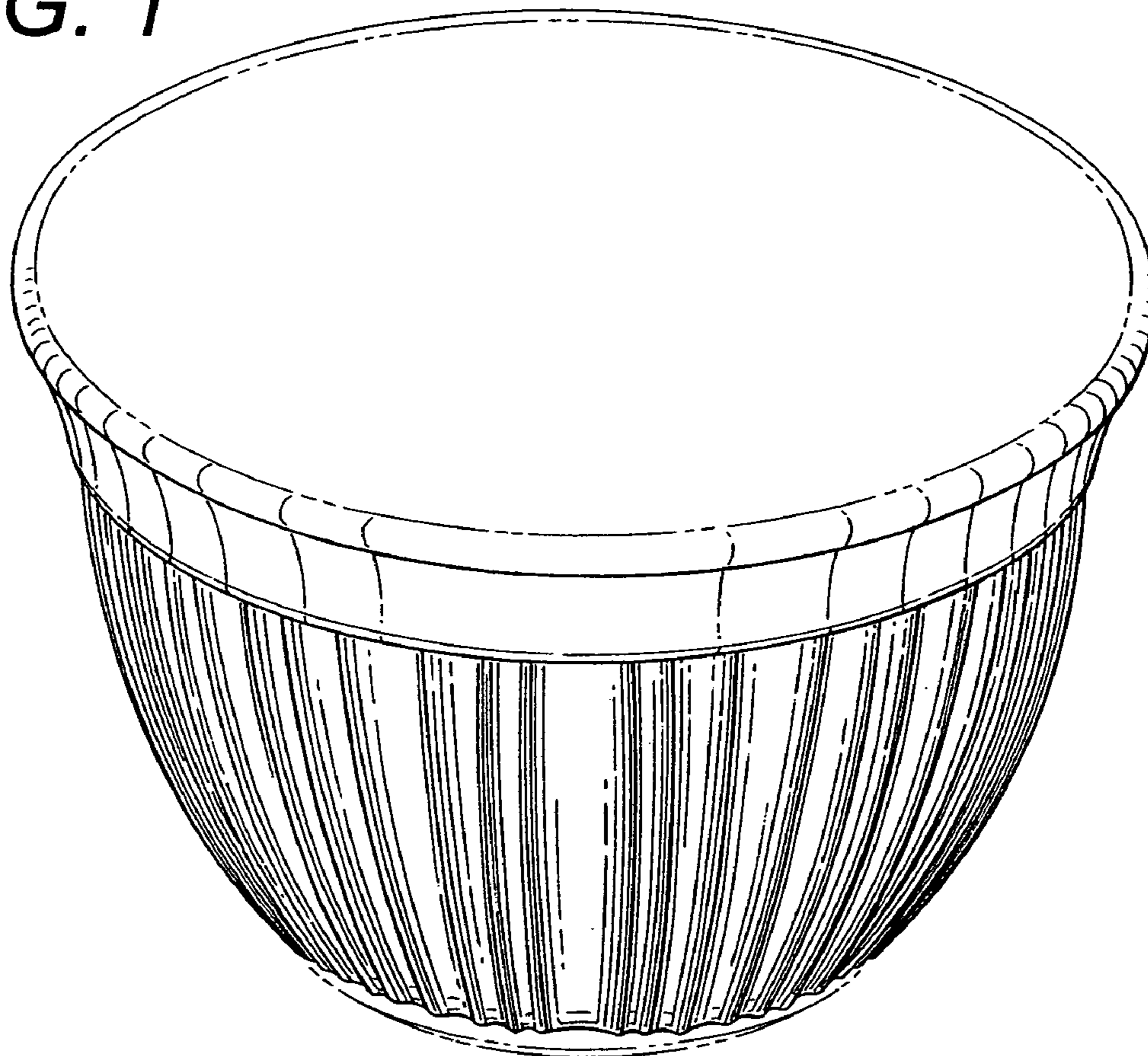

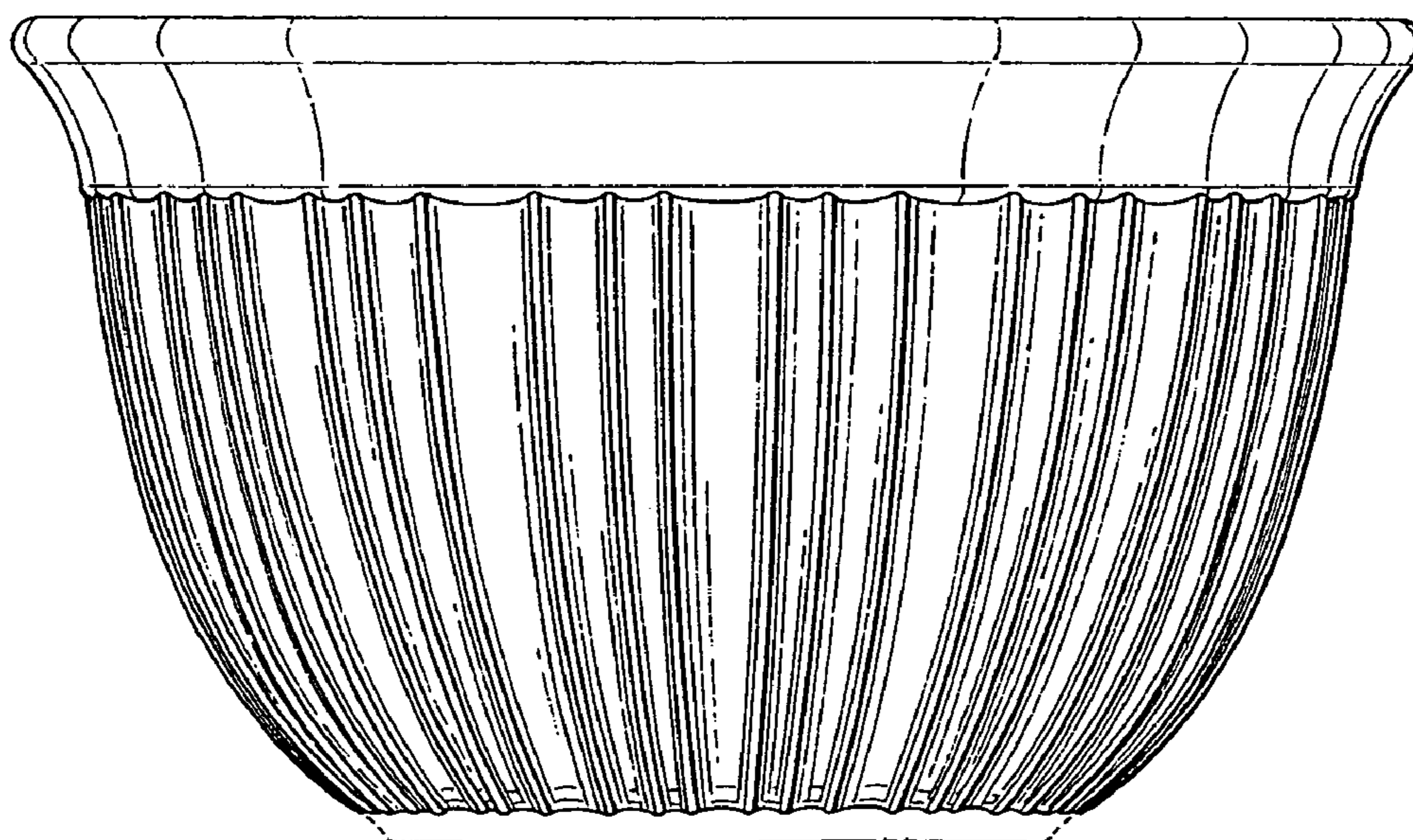

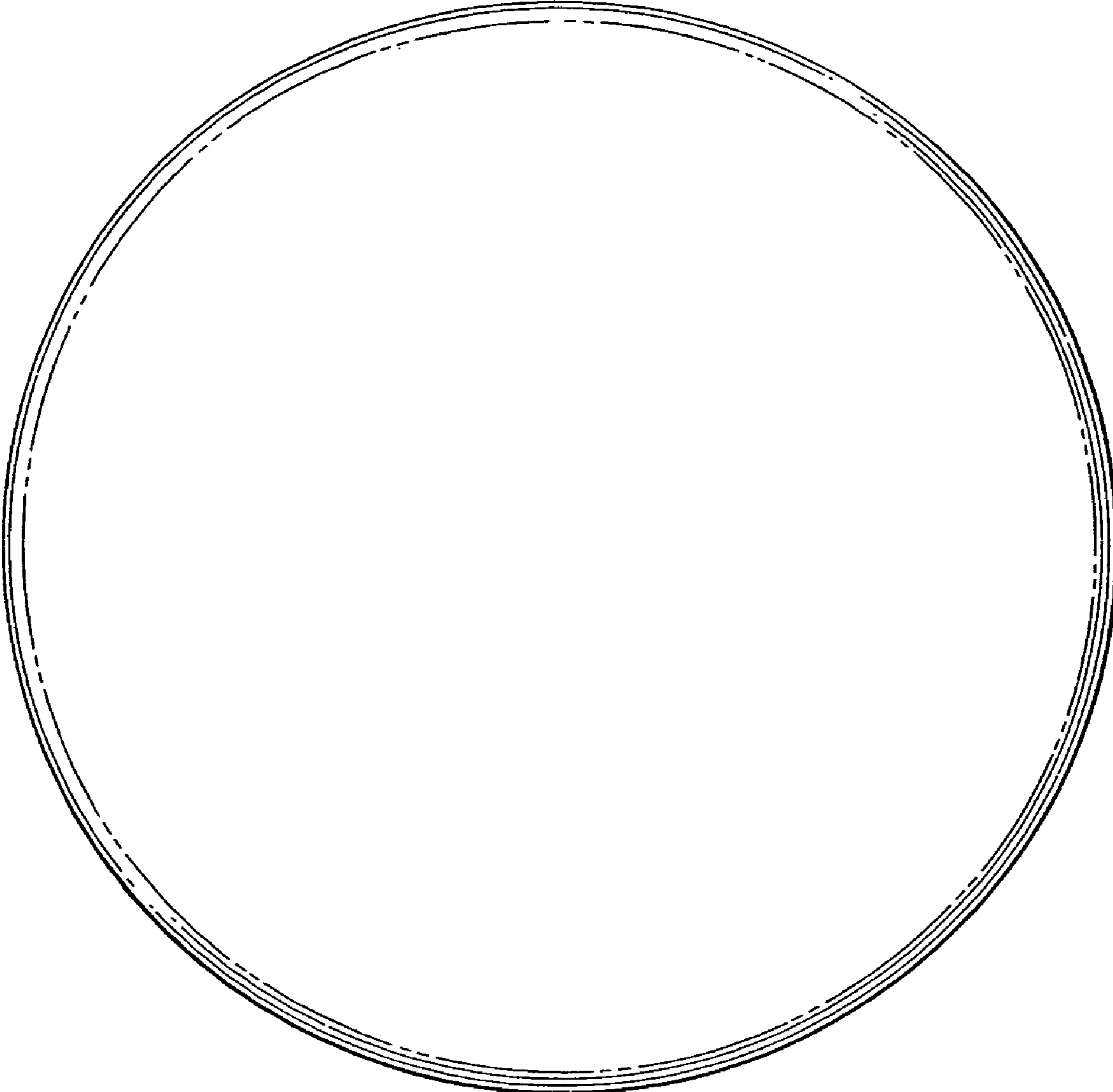
