(57) **CLAIM**

The ornamental design for a storage container, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a storage container showing my new design, the back elevational view being a mirror image;

FIG. 2 is a left side elevational view thereof, the right side elevational view being a mirror image;

FIG. 3 is a top plan view thereof; and,

FIG. 4 is a bottom plan view thereof.

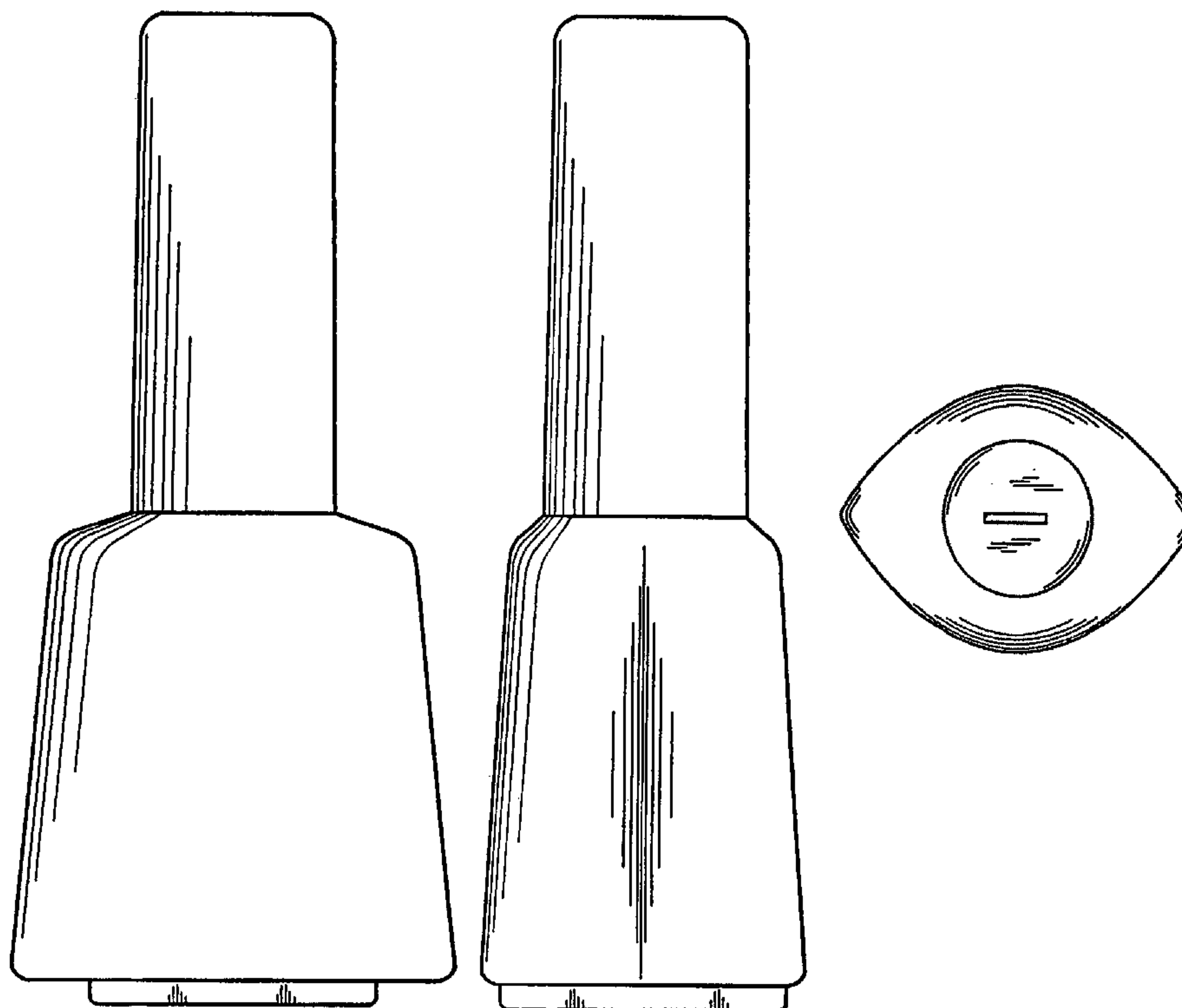

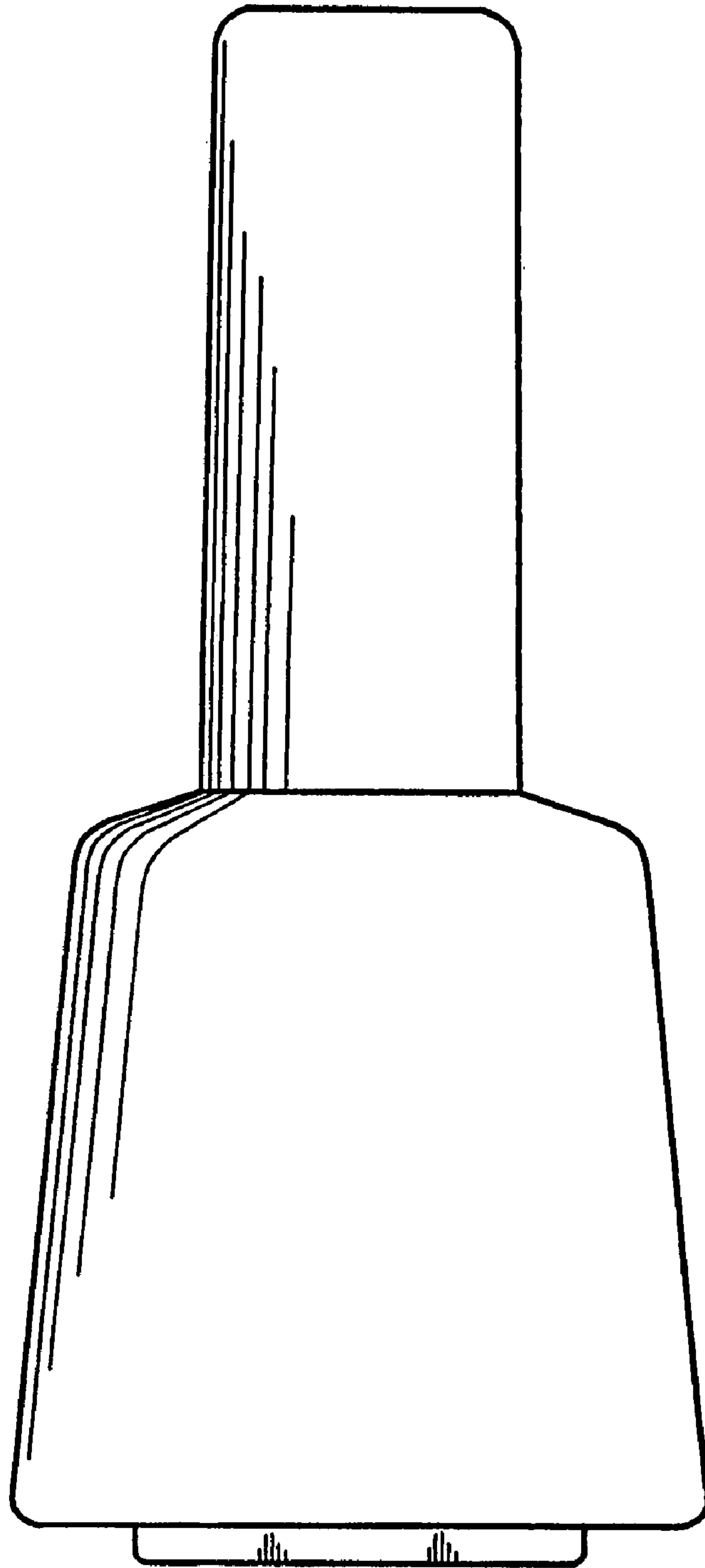

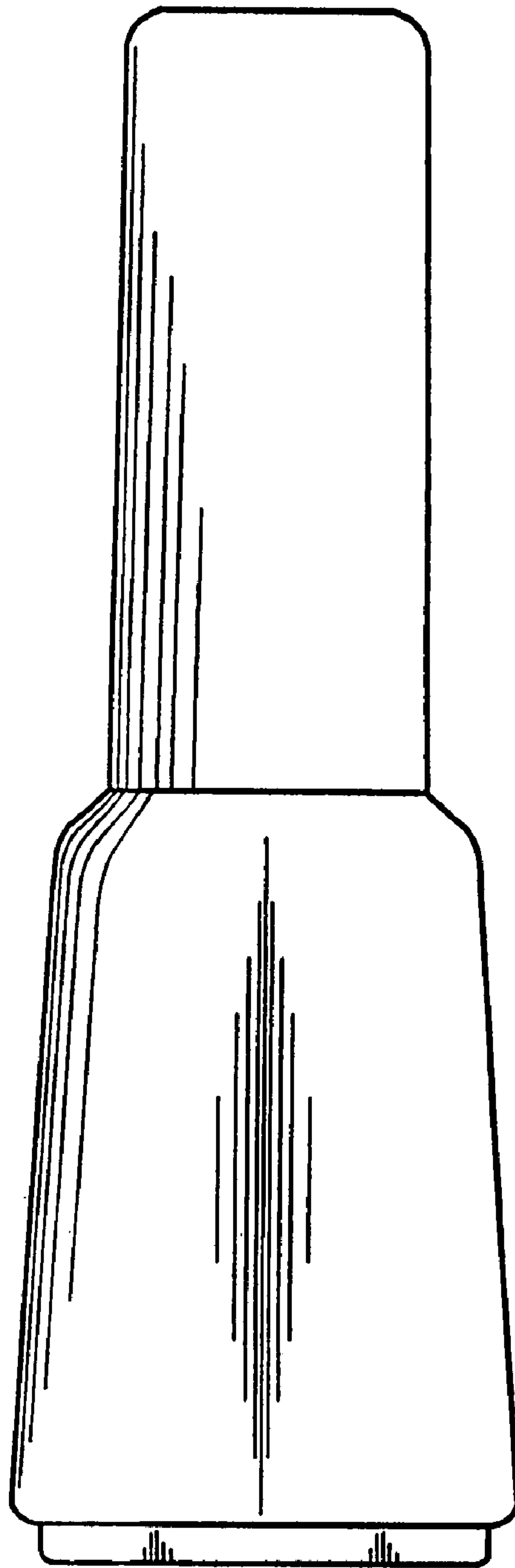

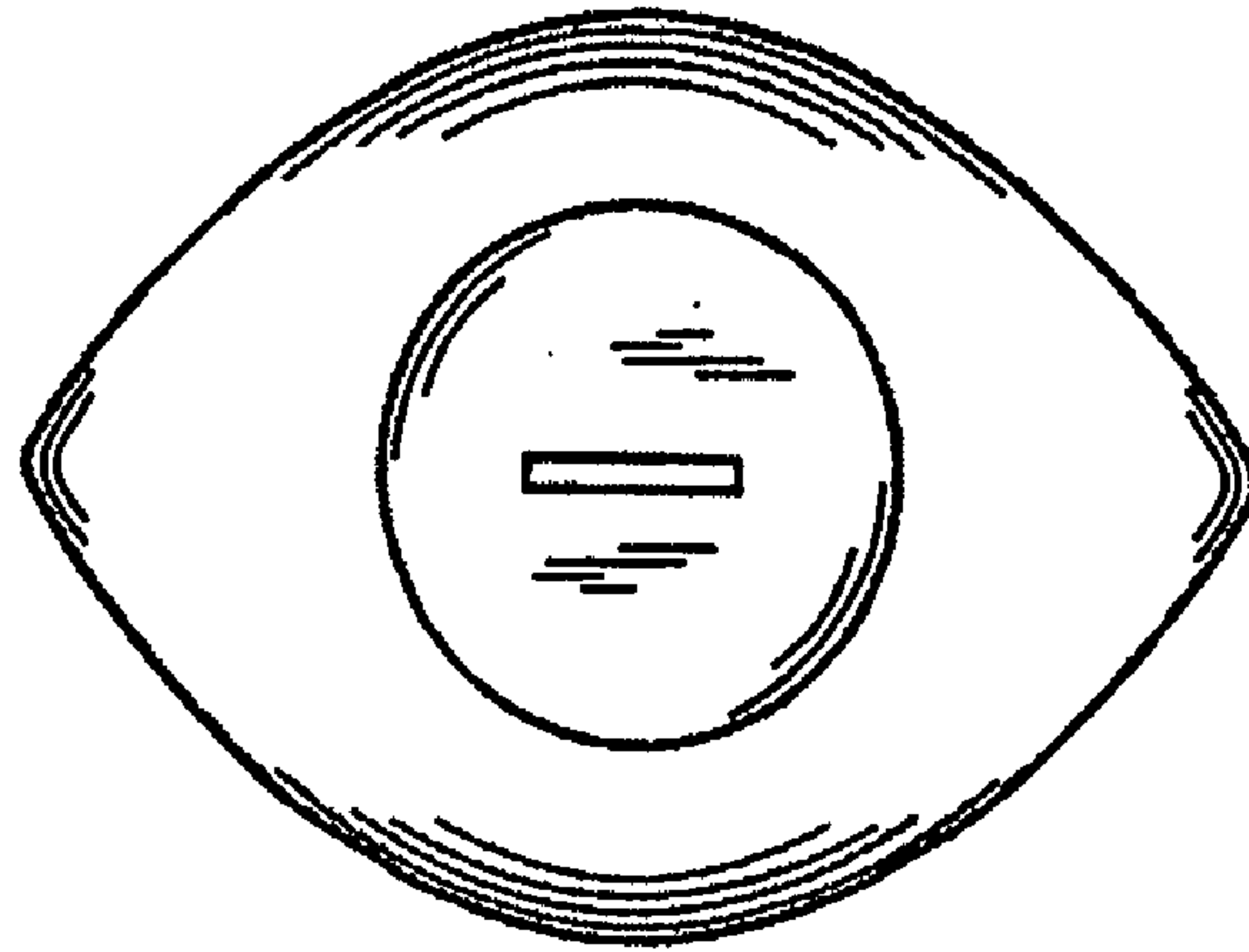
