(57) **CLAIM**

I claim the ornamental design for a Christmas stocking, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and side perspective view of the Christmas stocking embodying the design of the present invention.

FIG. 2 is a front elevational view thereof.

FIG. 3 is a side elevational view thereof.

FIG. 4 is a top view thereof.

FIG. 5 is a rear elevational view thereof.

FIG. 6 is a side view opposite to the side view shown in FIG. 3; and,

FIG. 7 is a bottom view thereof.

The broken line showing of Christmas stocking is included for the purpose of illustrating only and forms no part of the claimed design.

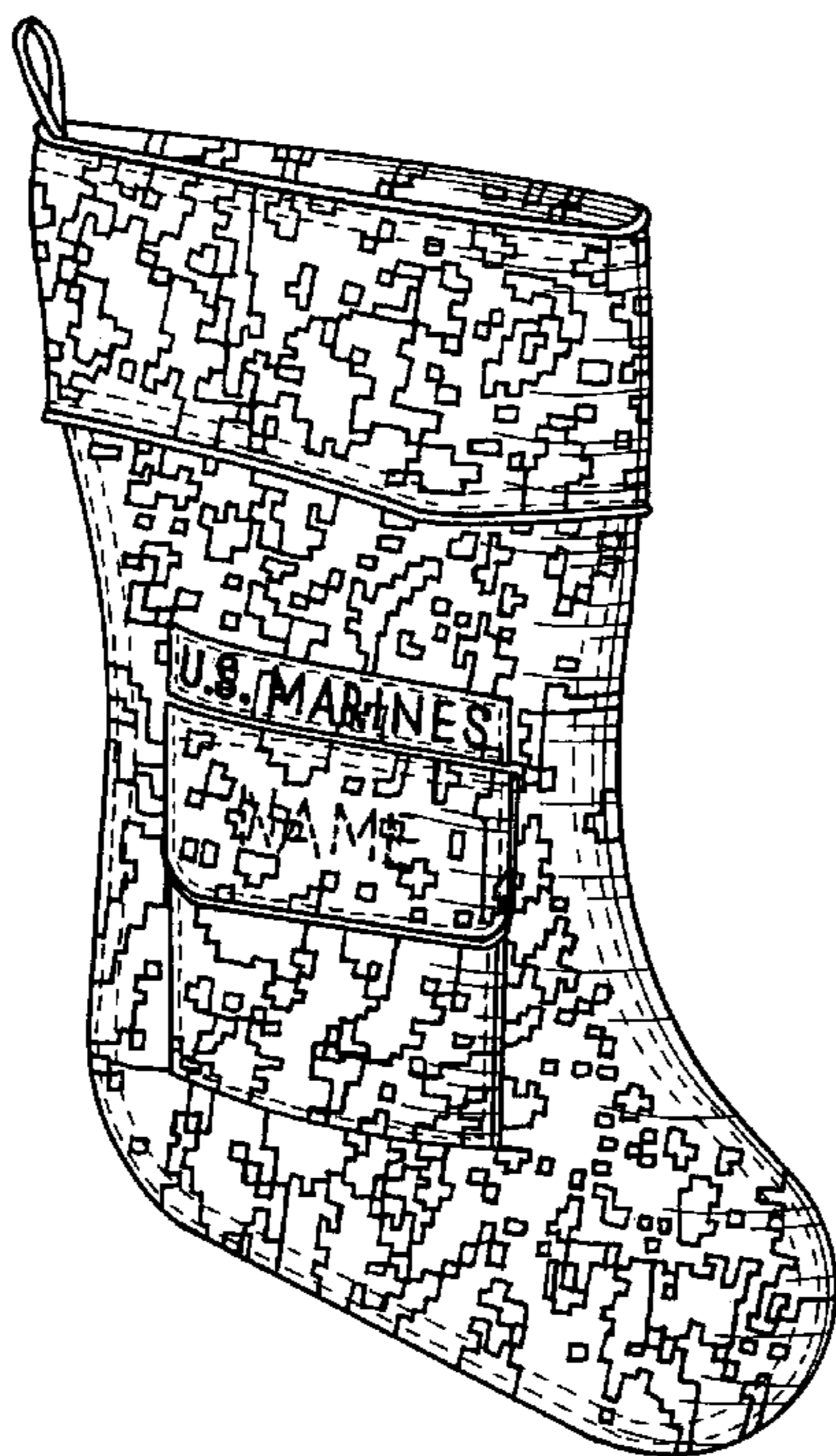

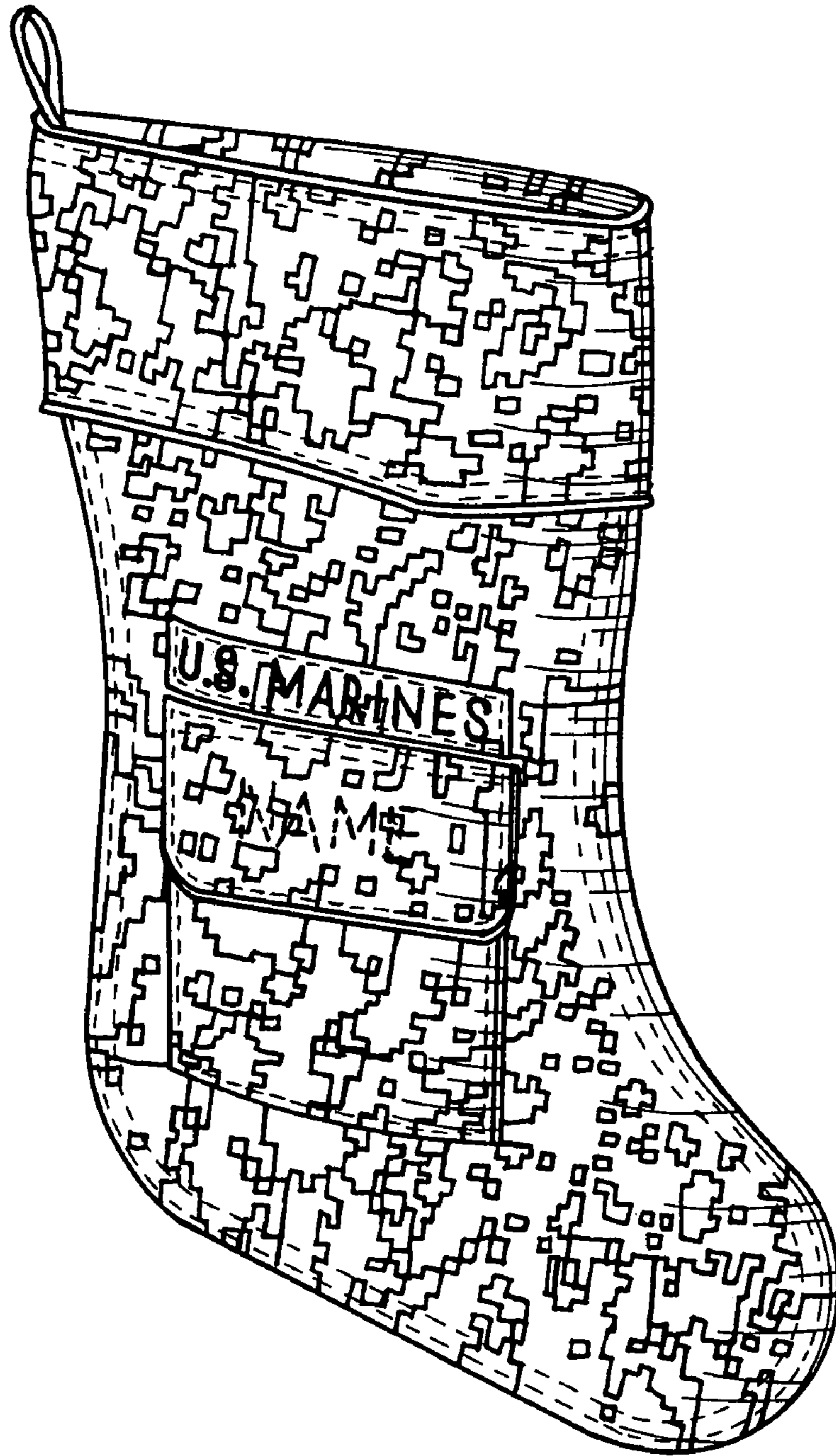

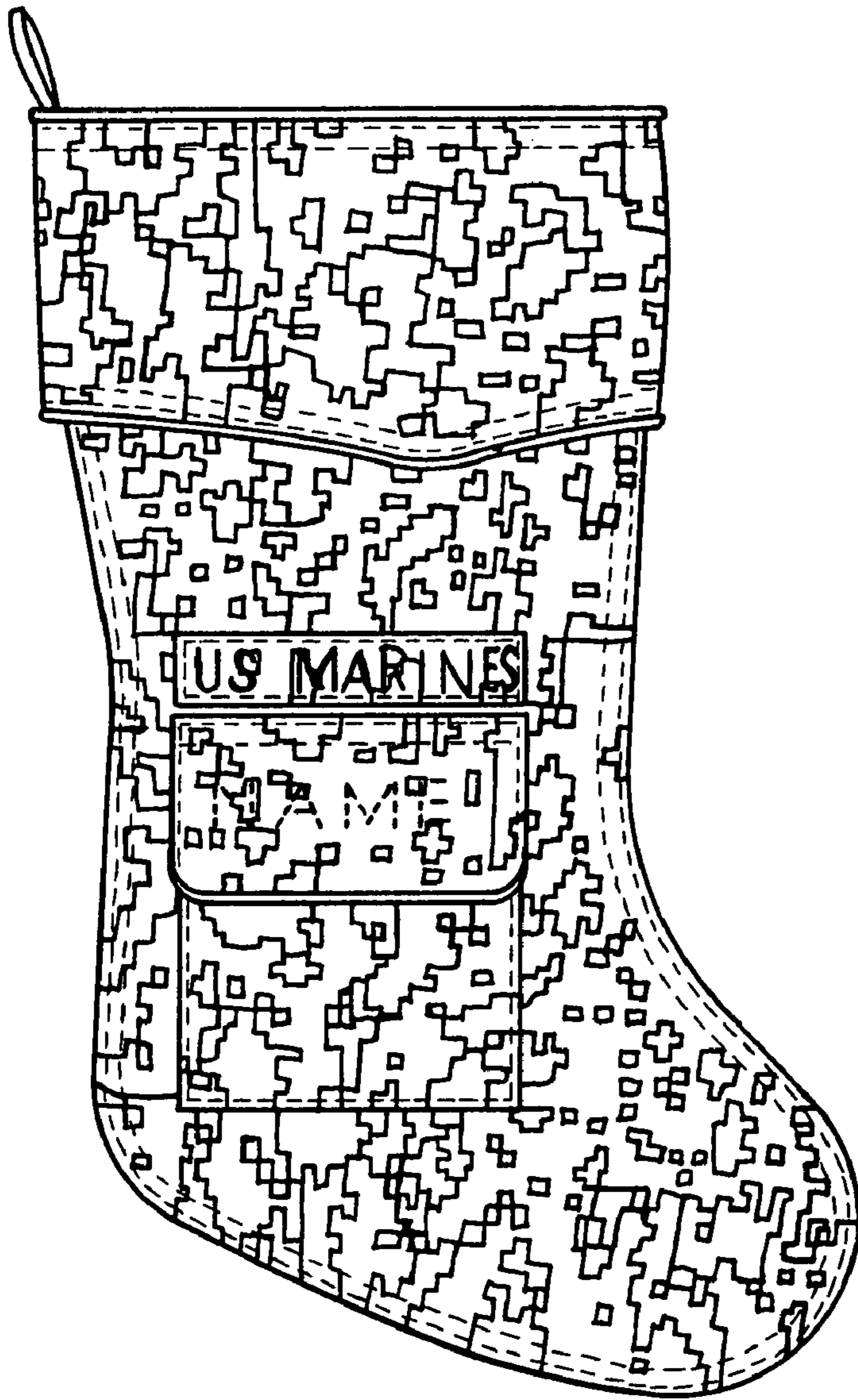

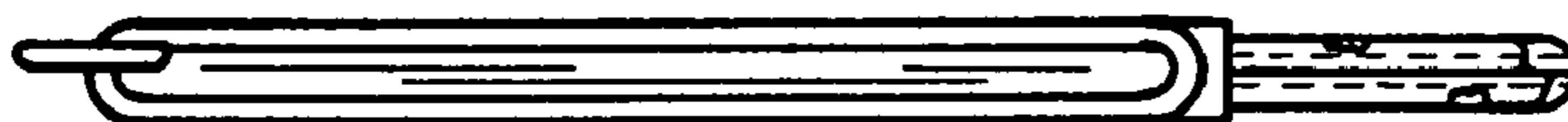

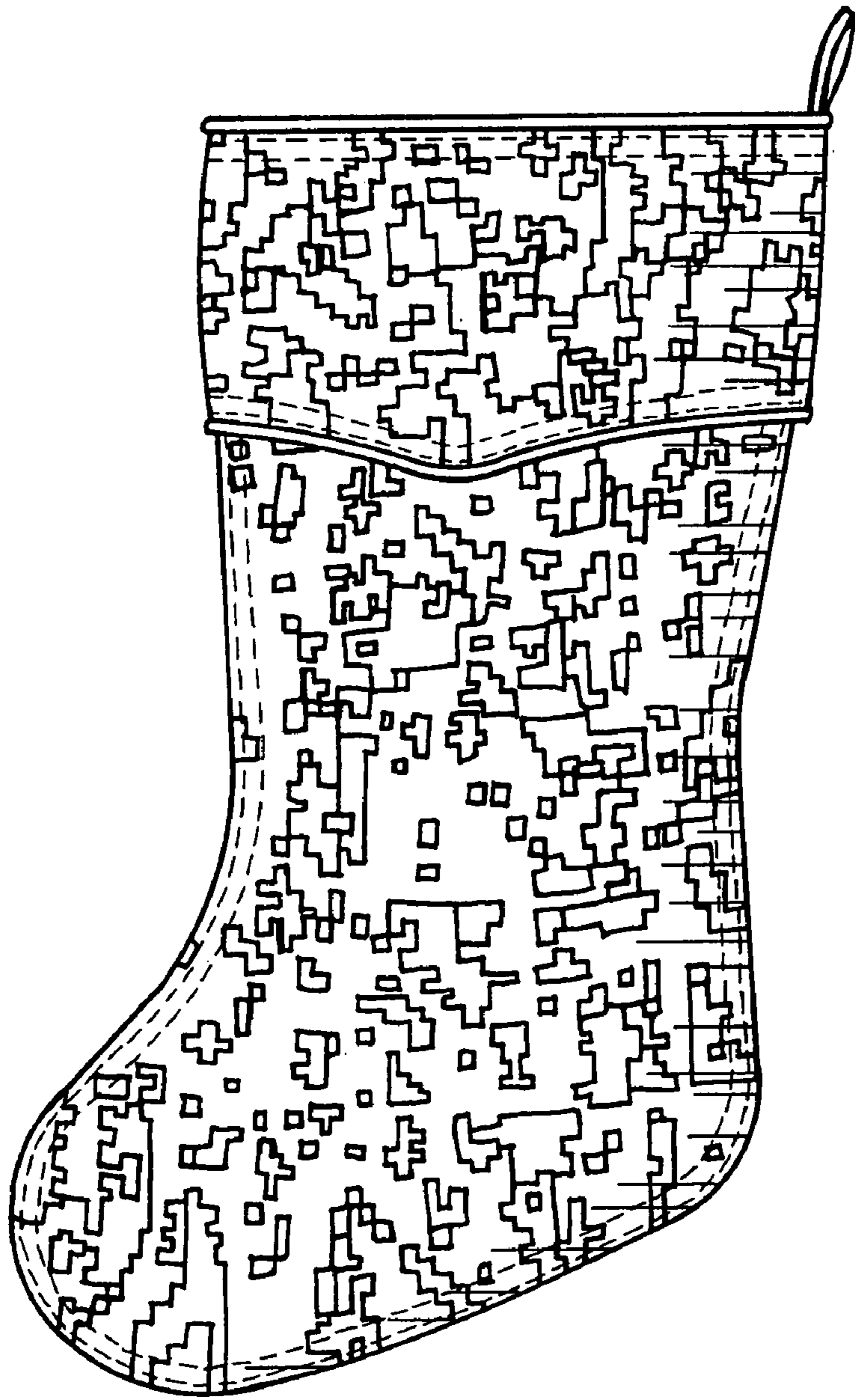
