(57) **CLAIM**

The ornamental design for a buckle assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a buckle assembly that incorporates the new design;

FIG. 2 is a front view of the buckle assembly;

FIG. 3 is a rear view of the buckle assembly;

FIG. 4 is a left-side view of the buckle assembly;

FIG. 5 is a right-side view of the buckle assembly;

FIG. 6 is a top view of the buckle assembly;

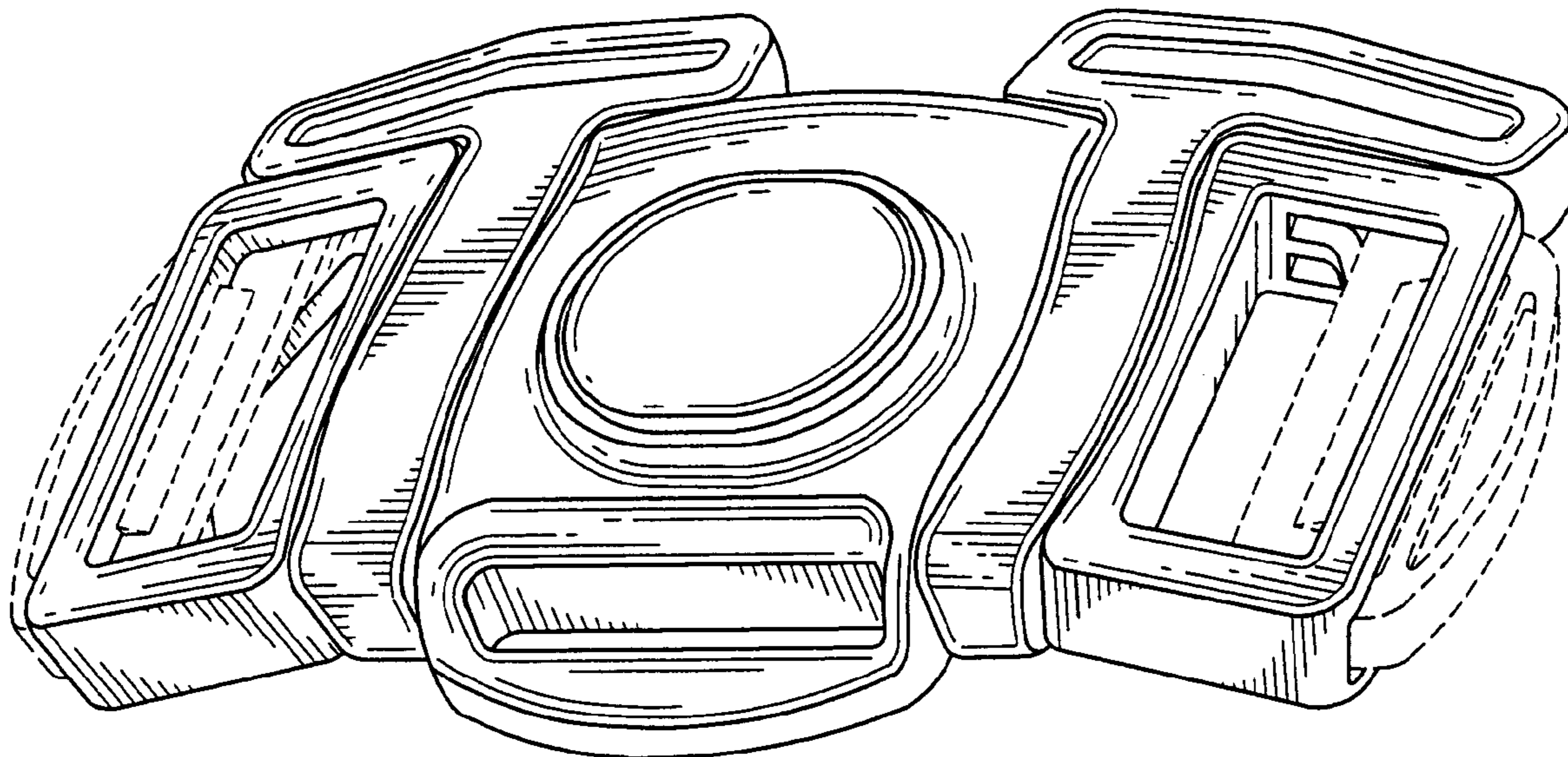
FIG. 7 is a bottom view of the buckle assembly;

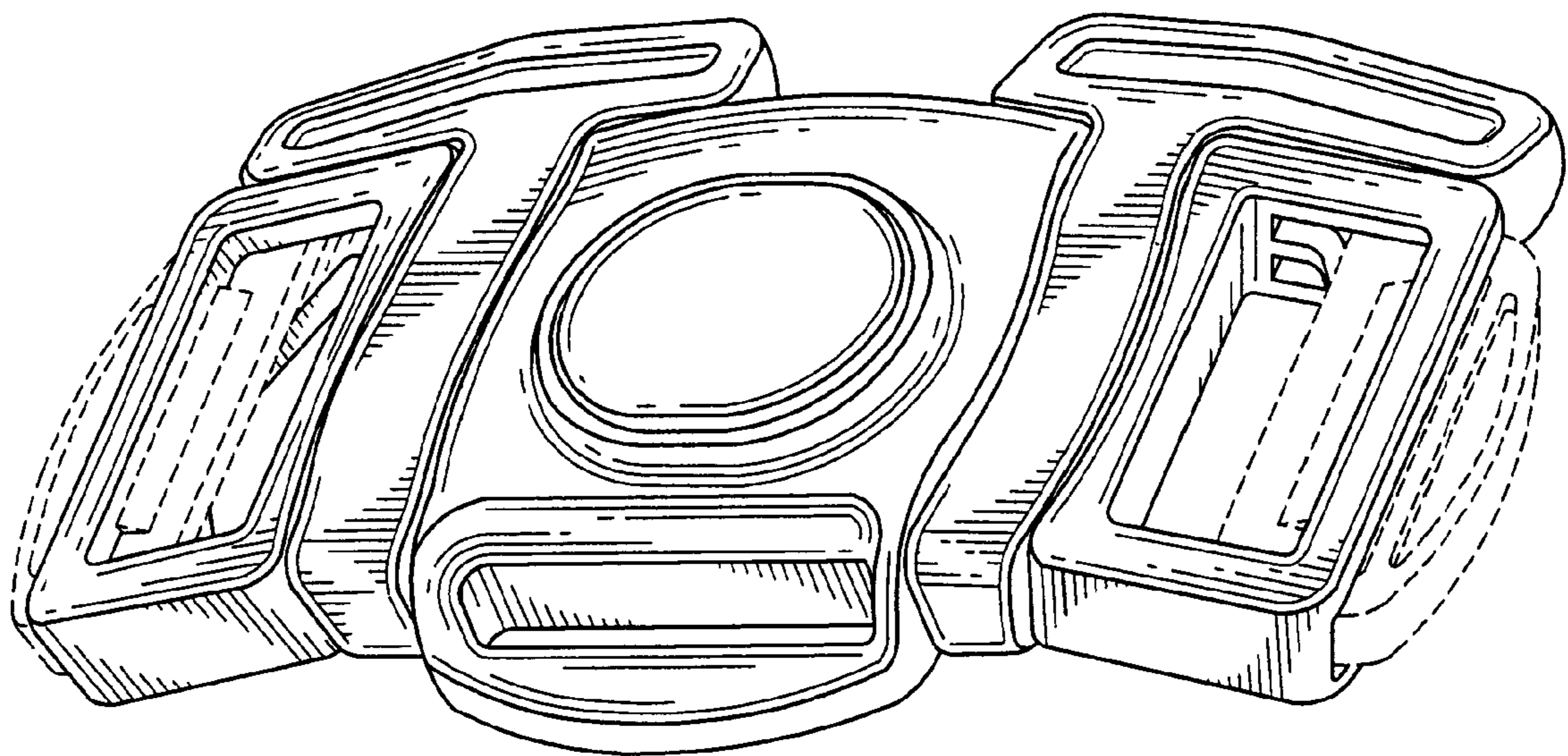

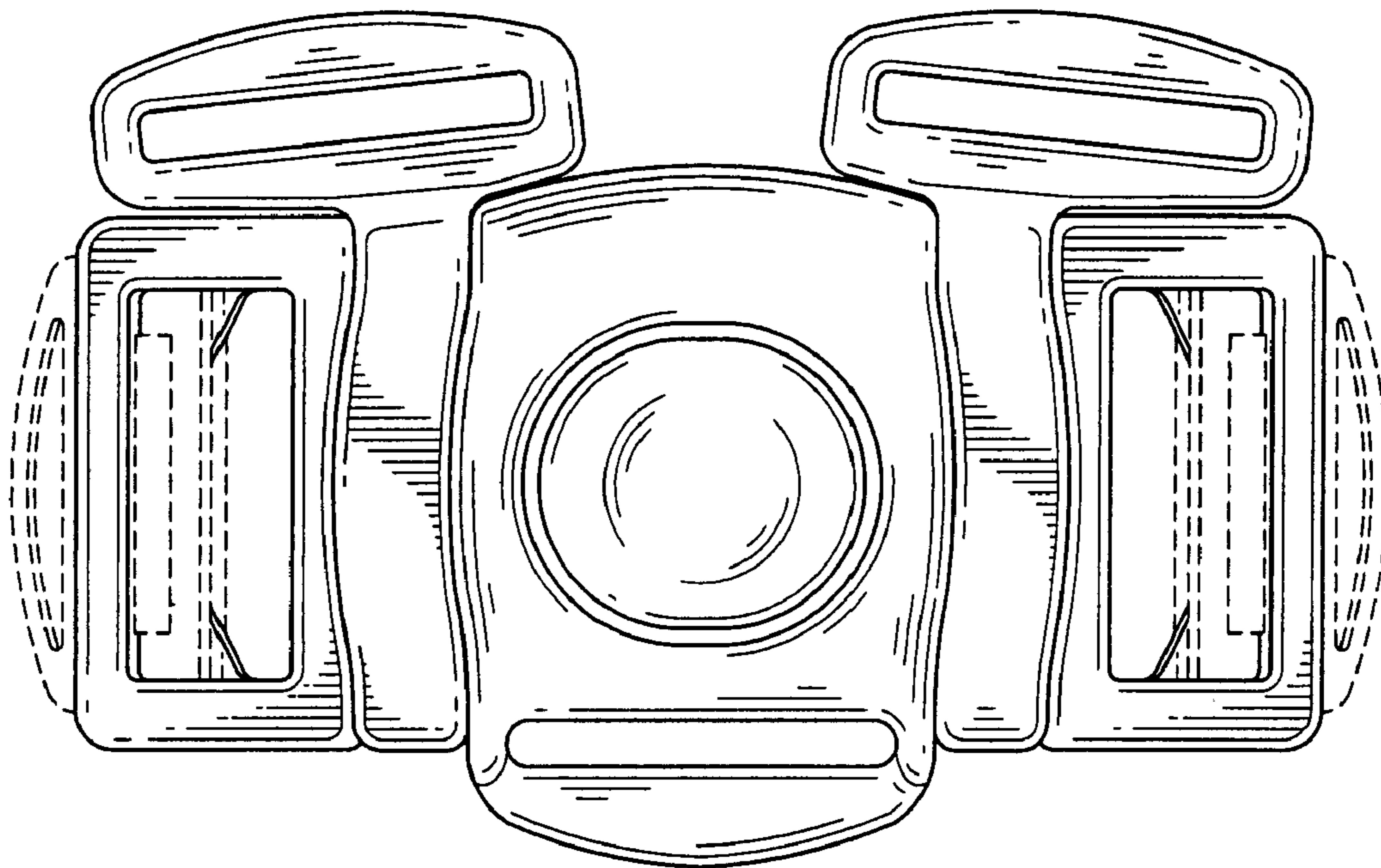

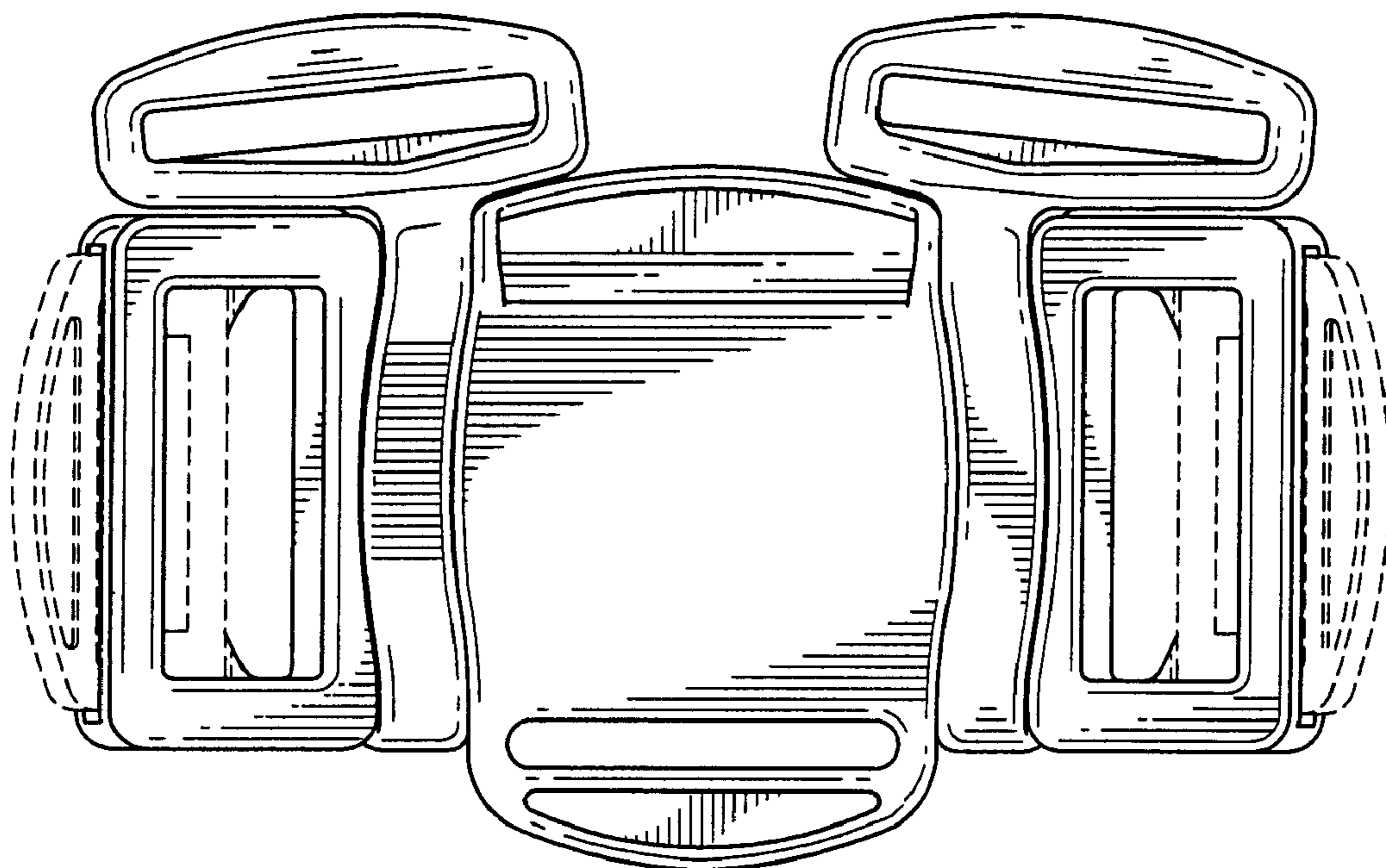

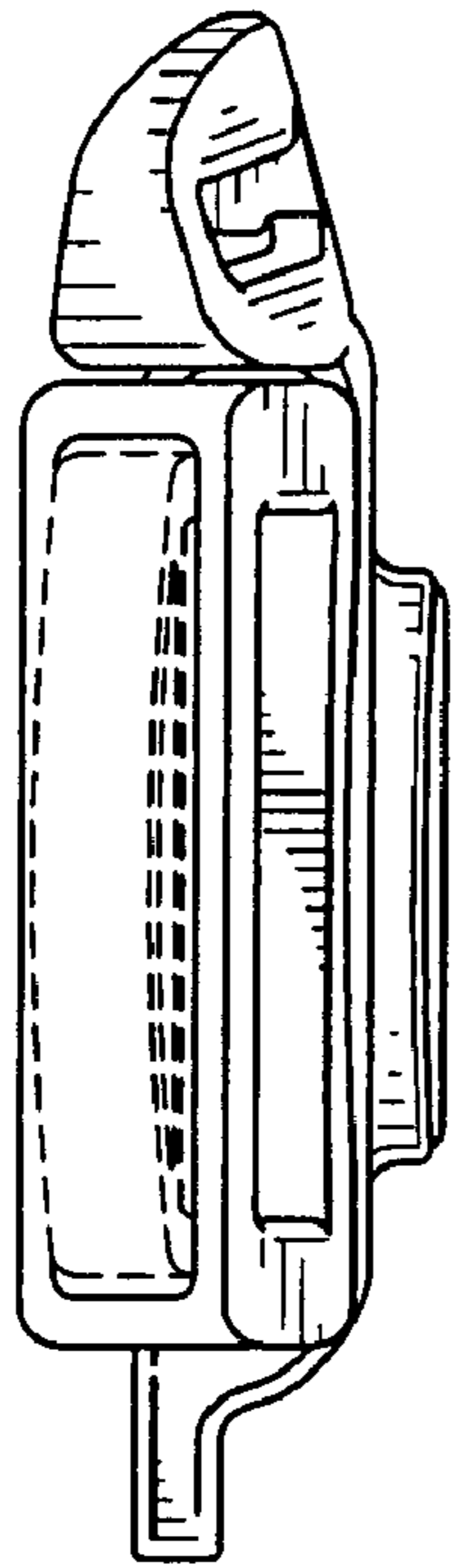

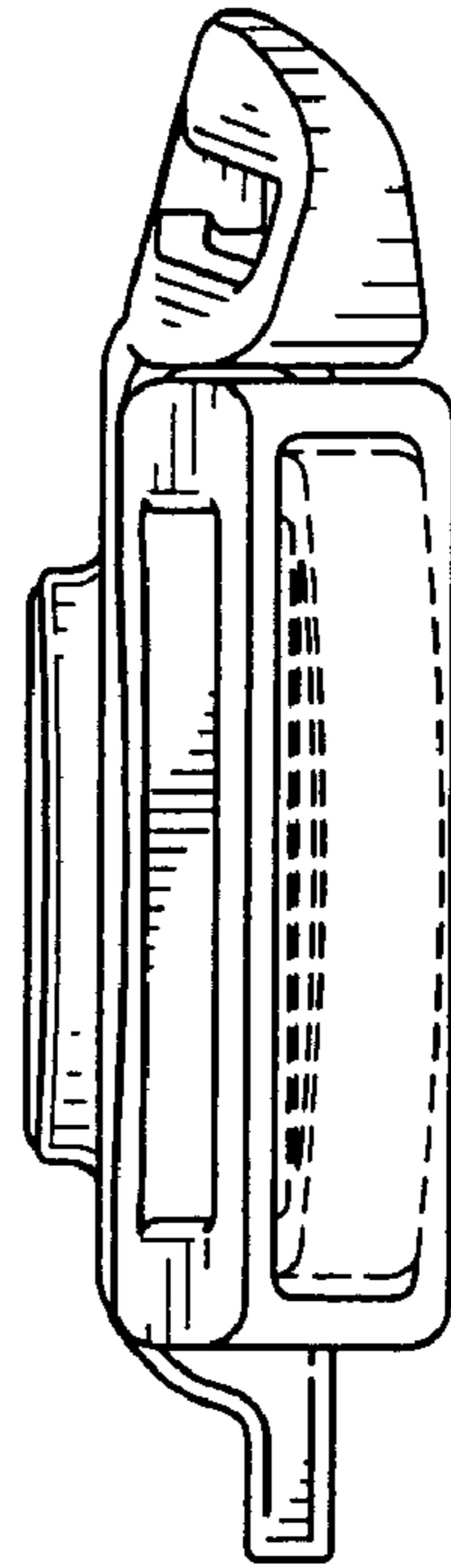

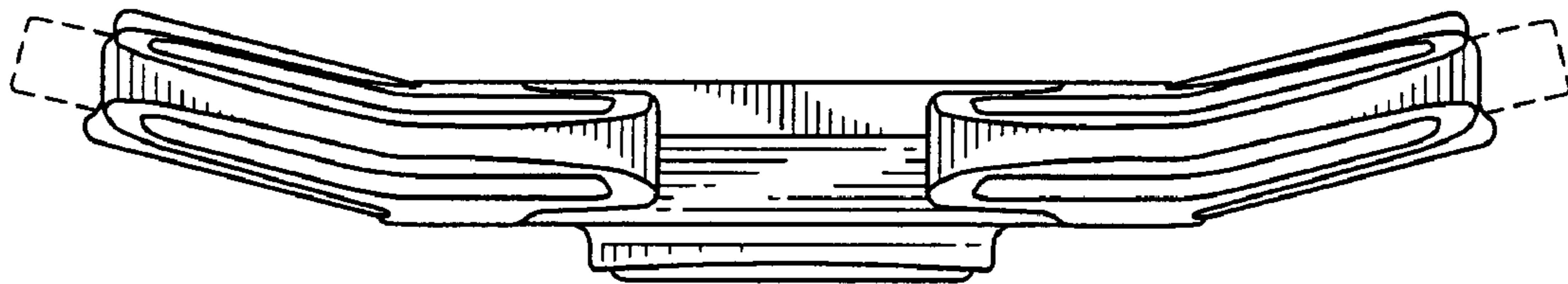

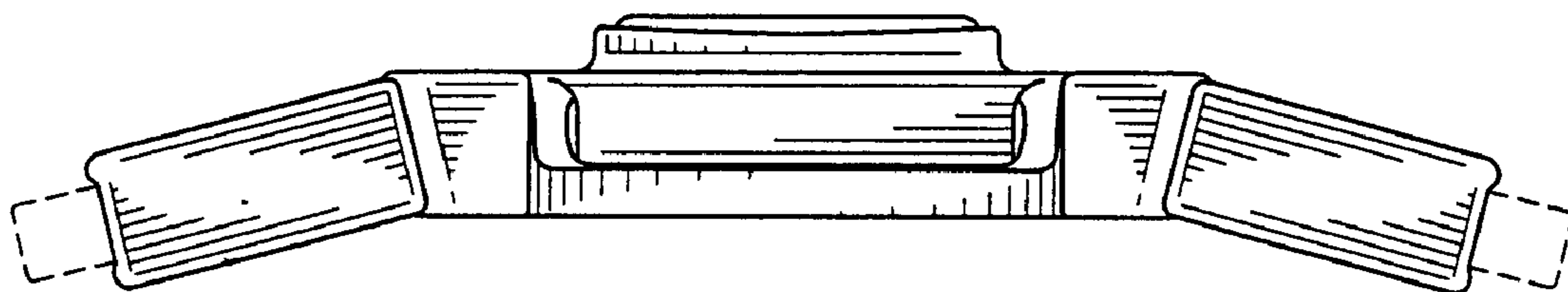

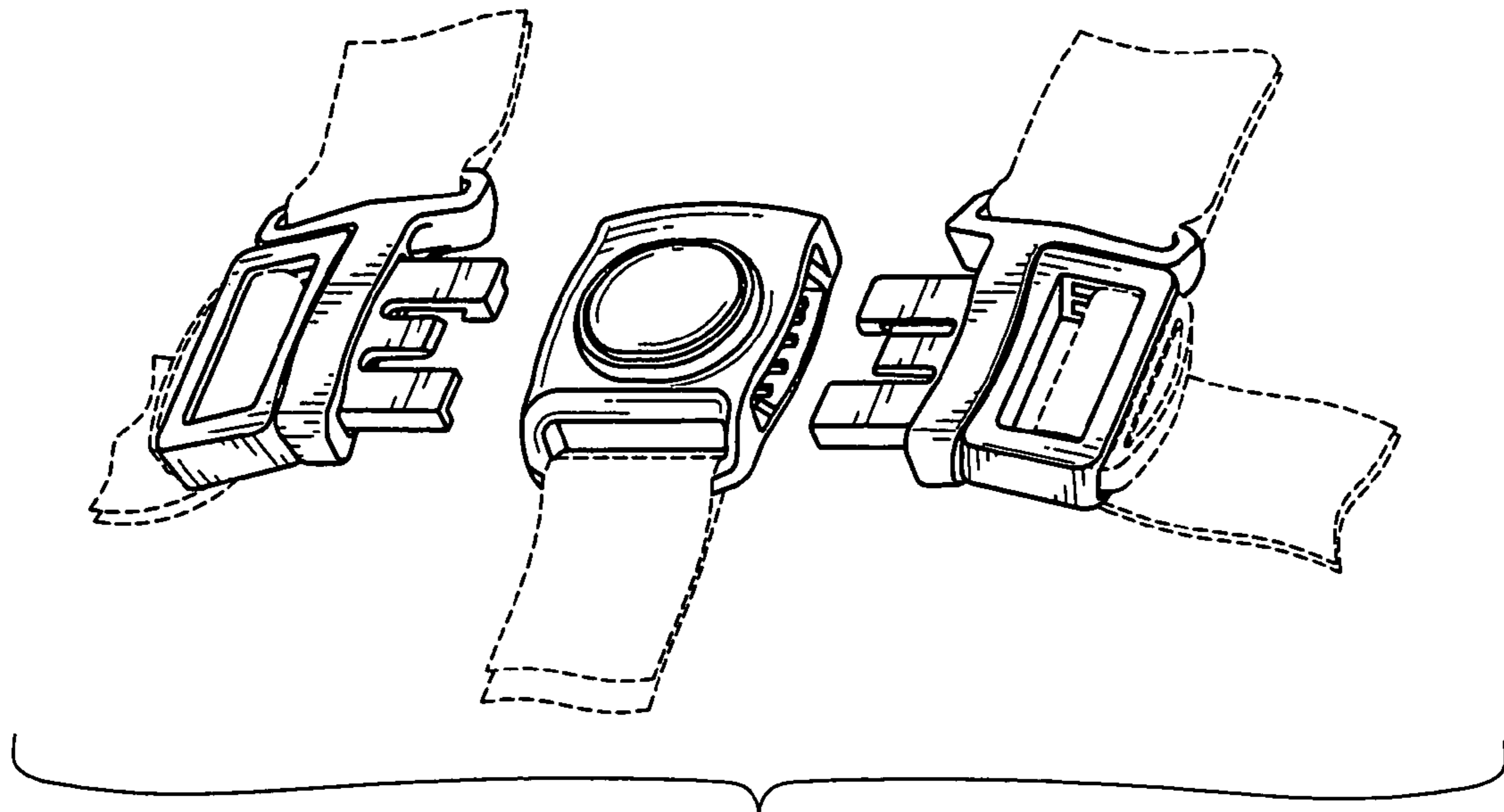

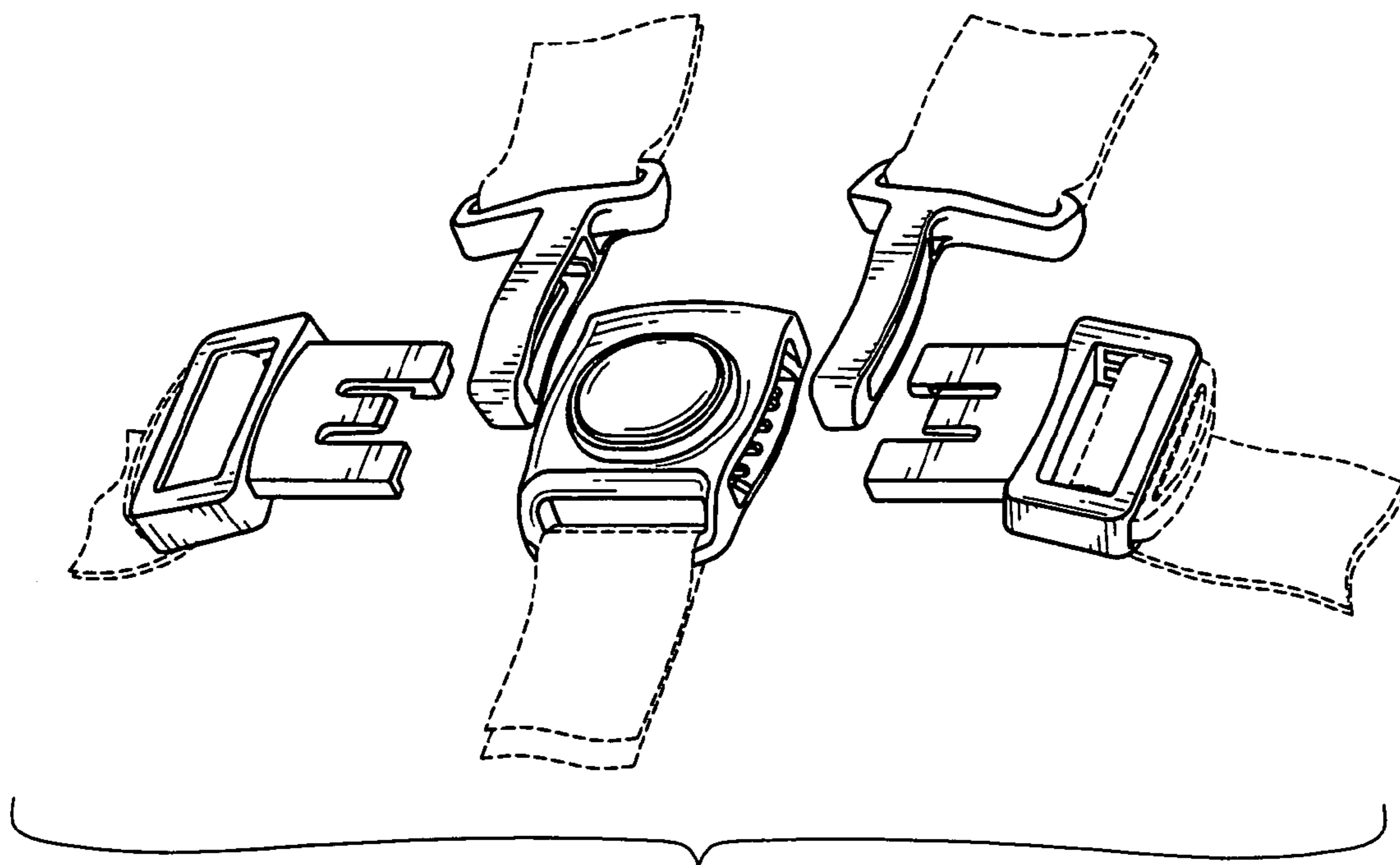
