(57) **CLAIM**

We claim the ornamental design for a shield for attachment to hood of a vehicle, as shown and described.

**DESCRIPTION**

FIG. 5 is a top plan view thereof.

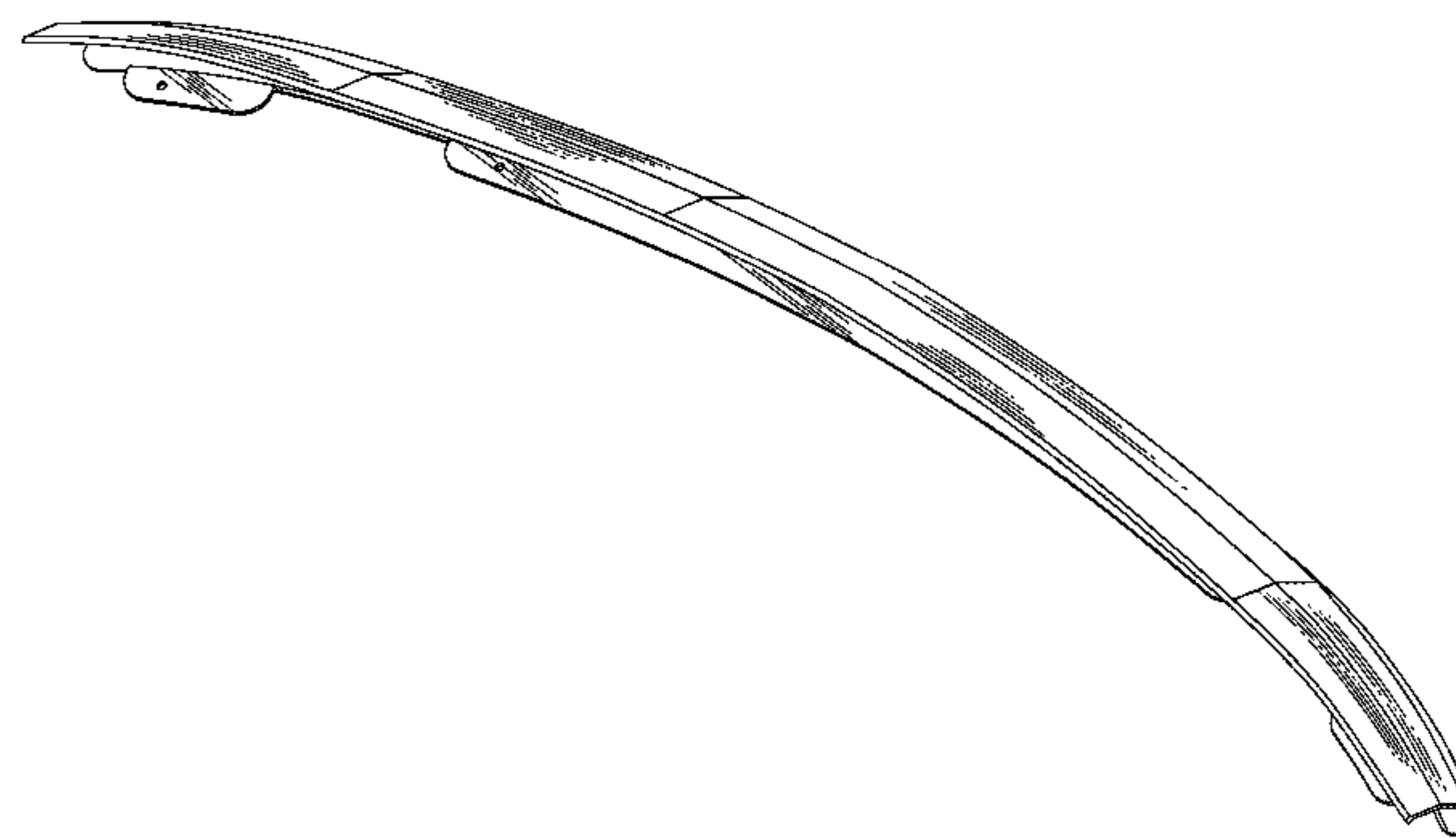
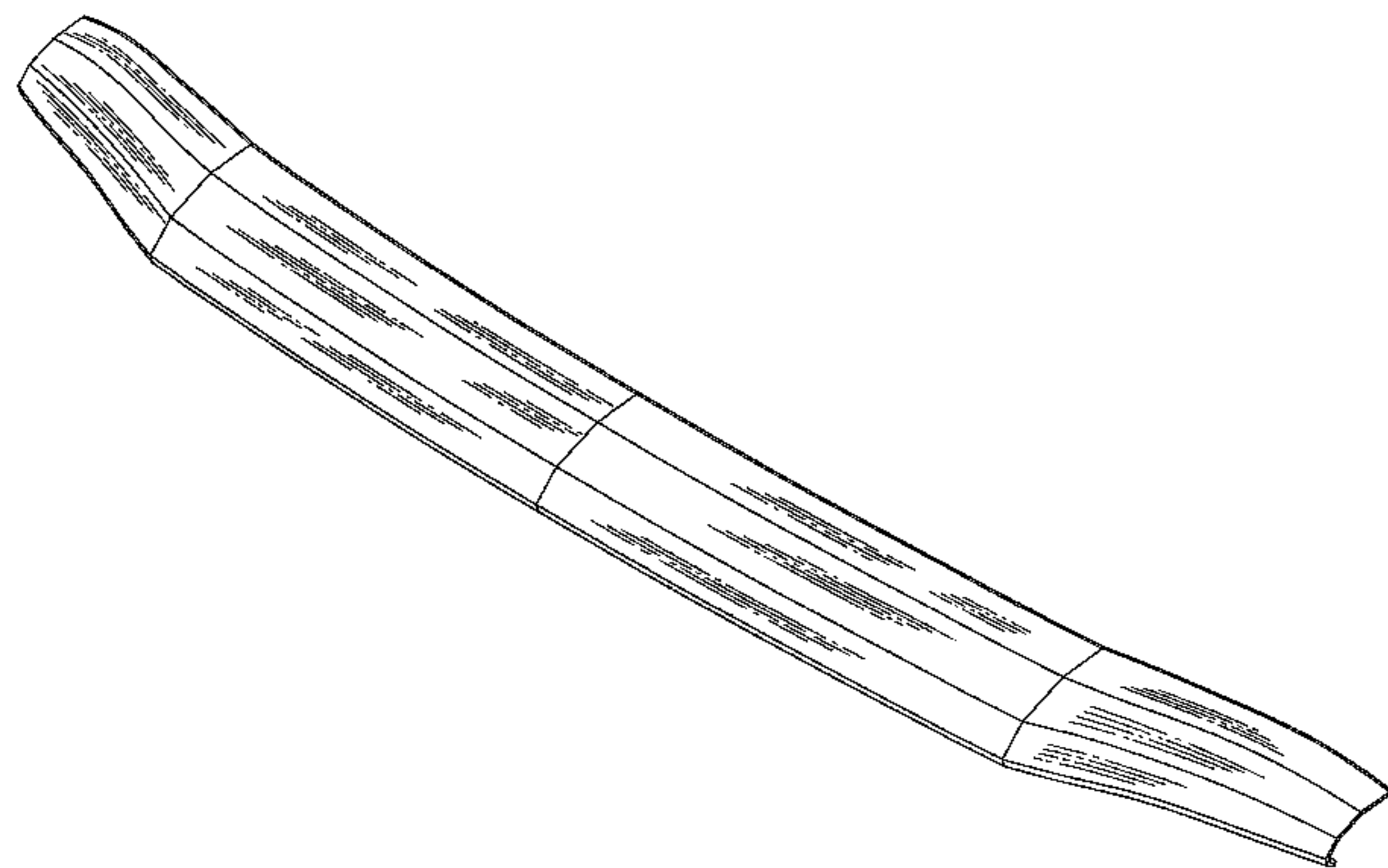
FIG. 6 is a bottom plan view thereof.

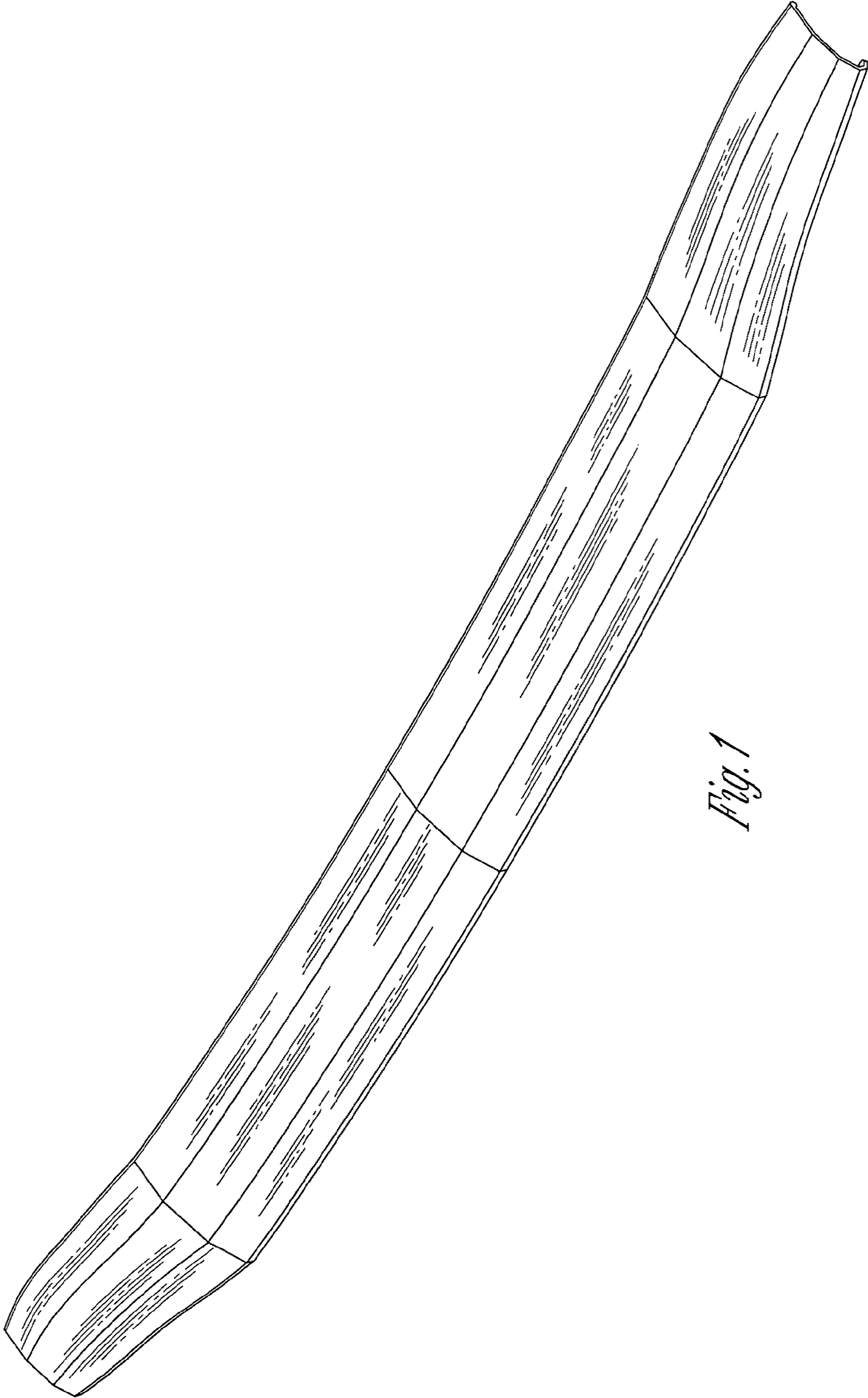
FIG. 7 is an end elevational view as taken from the left of FIG. 3.

FIG. 8 is an end elevational view as taken from the right of FIG. 3; and,

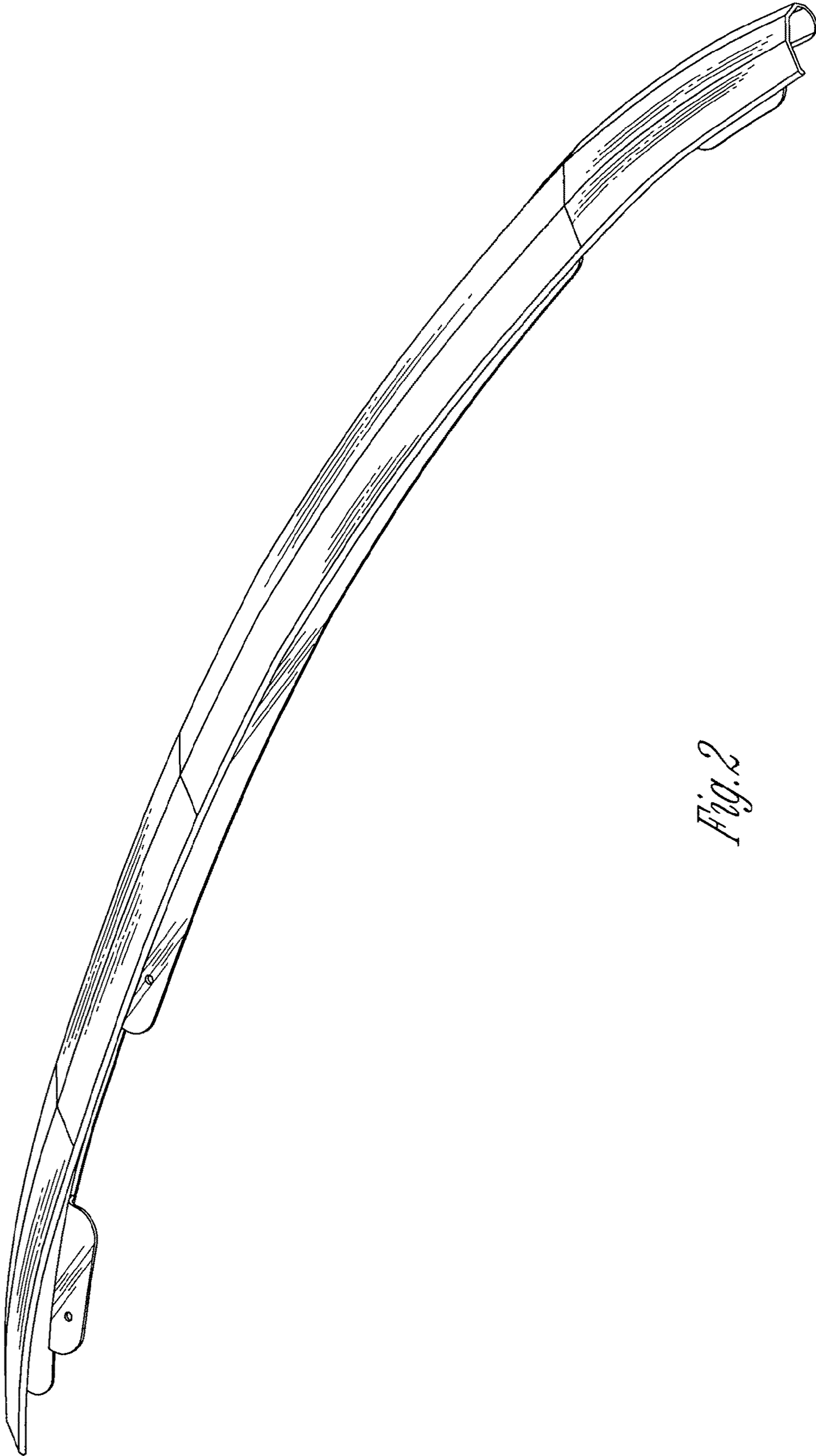
FIG. 9 is an enlarged cross-sectional view as taken along line 9—9 of FIG. 3.

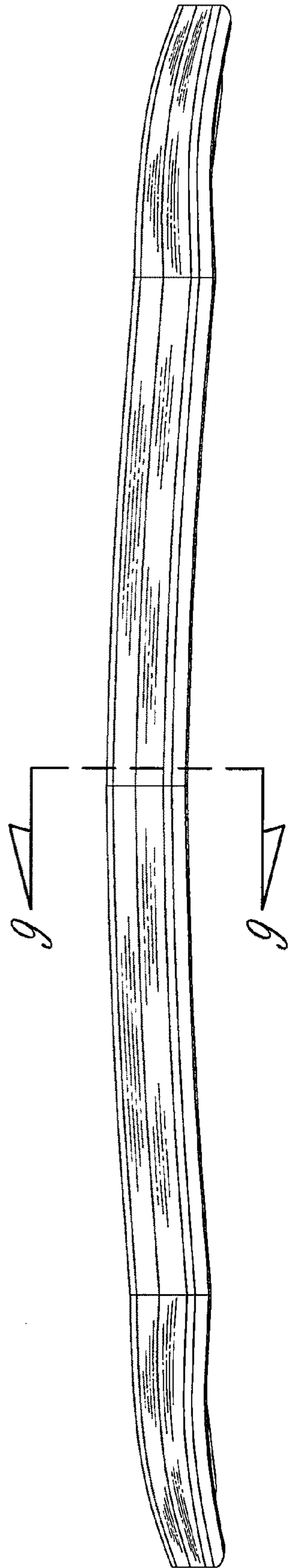




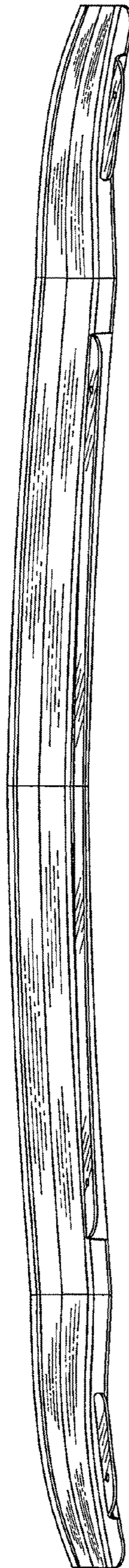

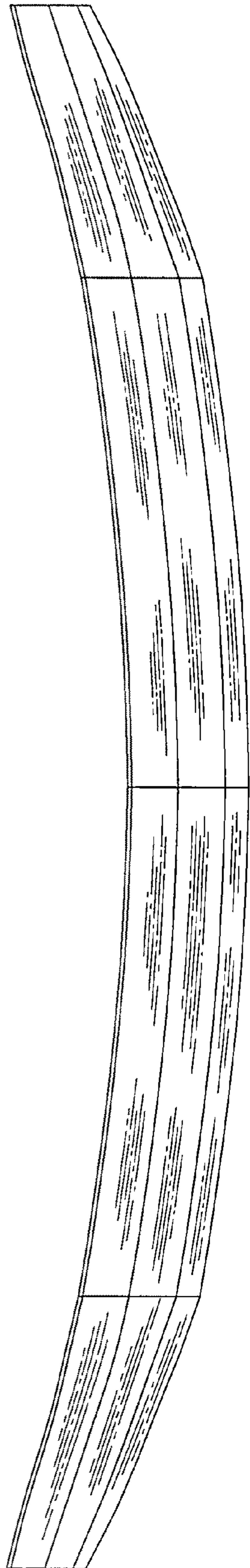

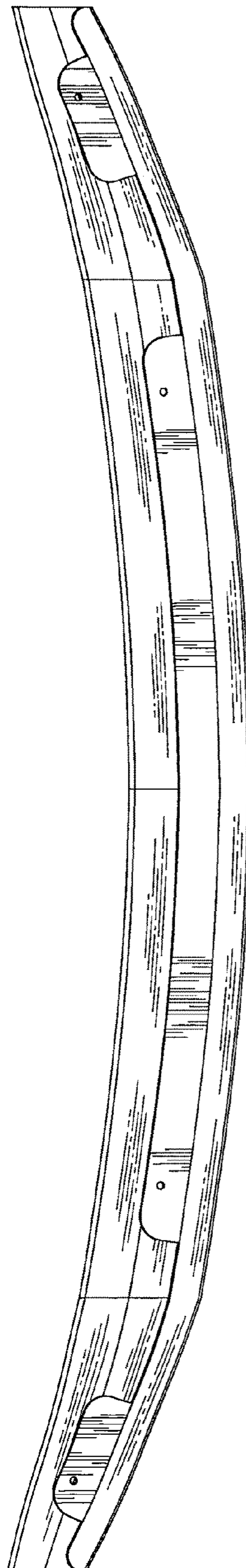

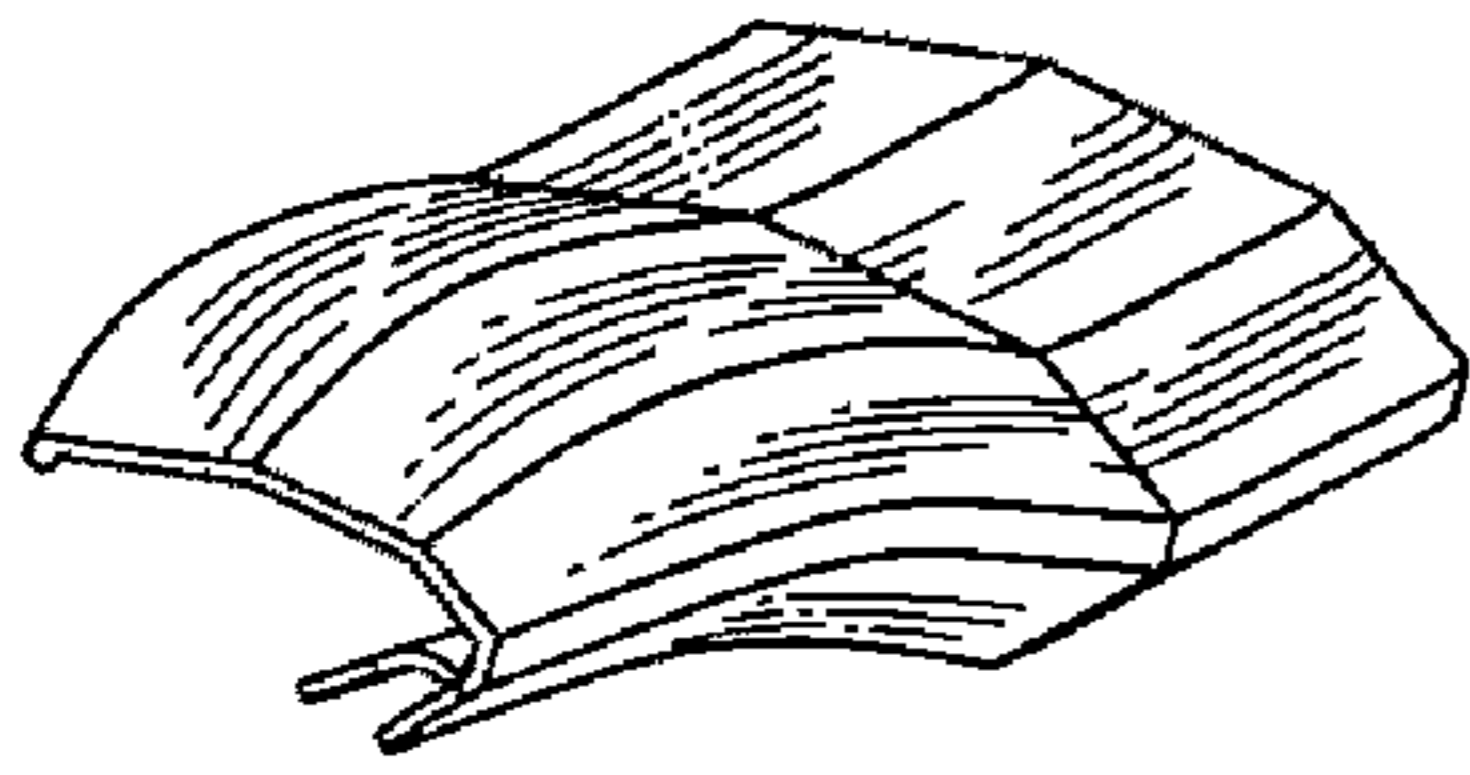

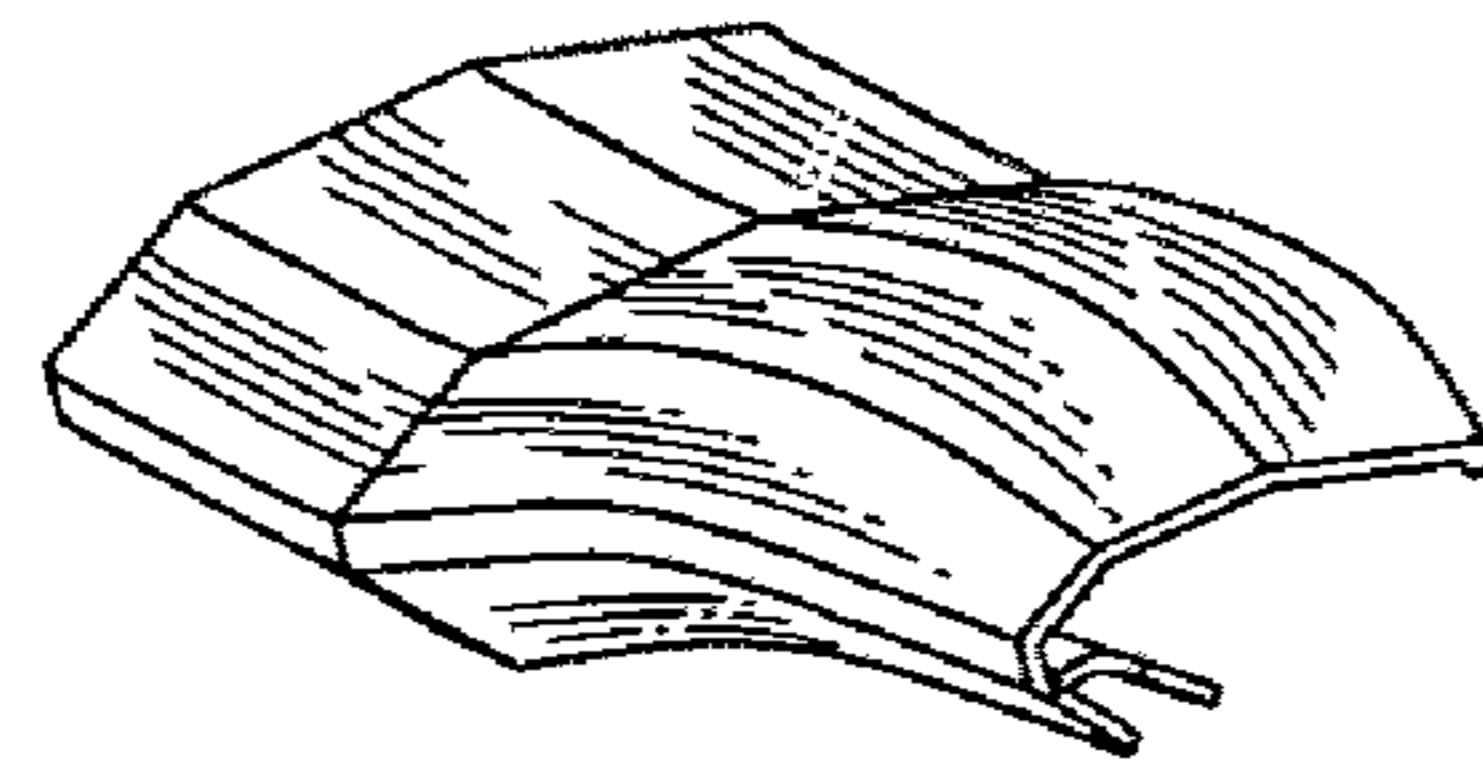

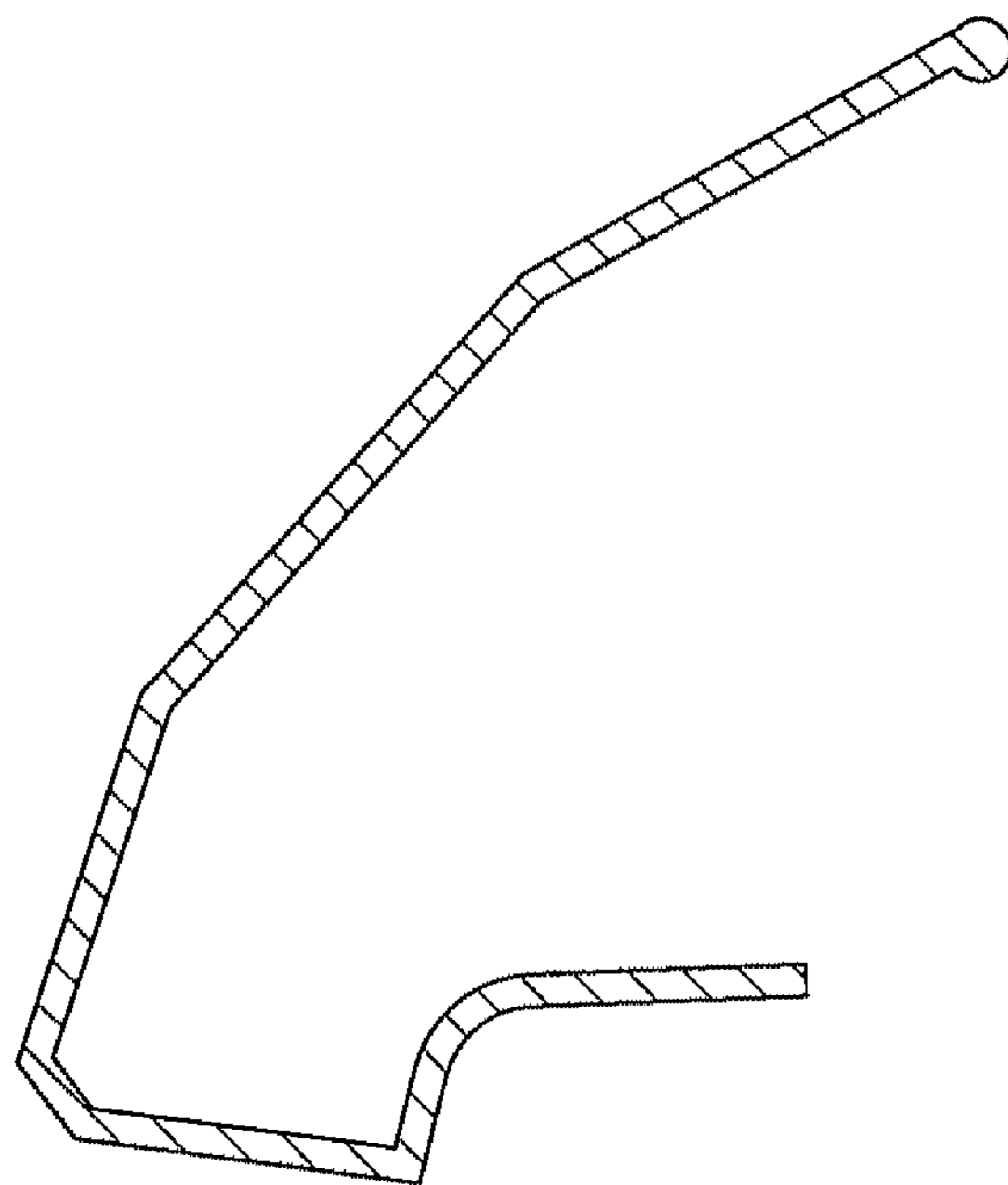
