DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of a printed circuit board showing my new design;

FIG. 4 is a right-side, elevational view thereof;

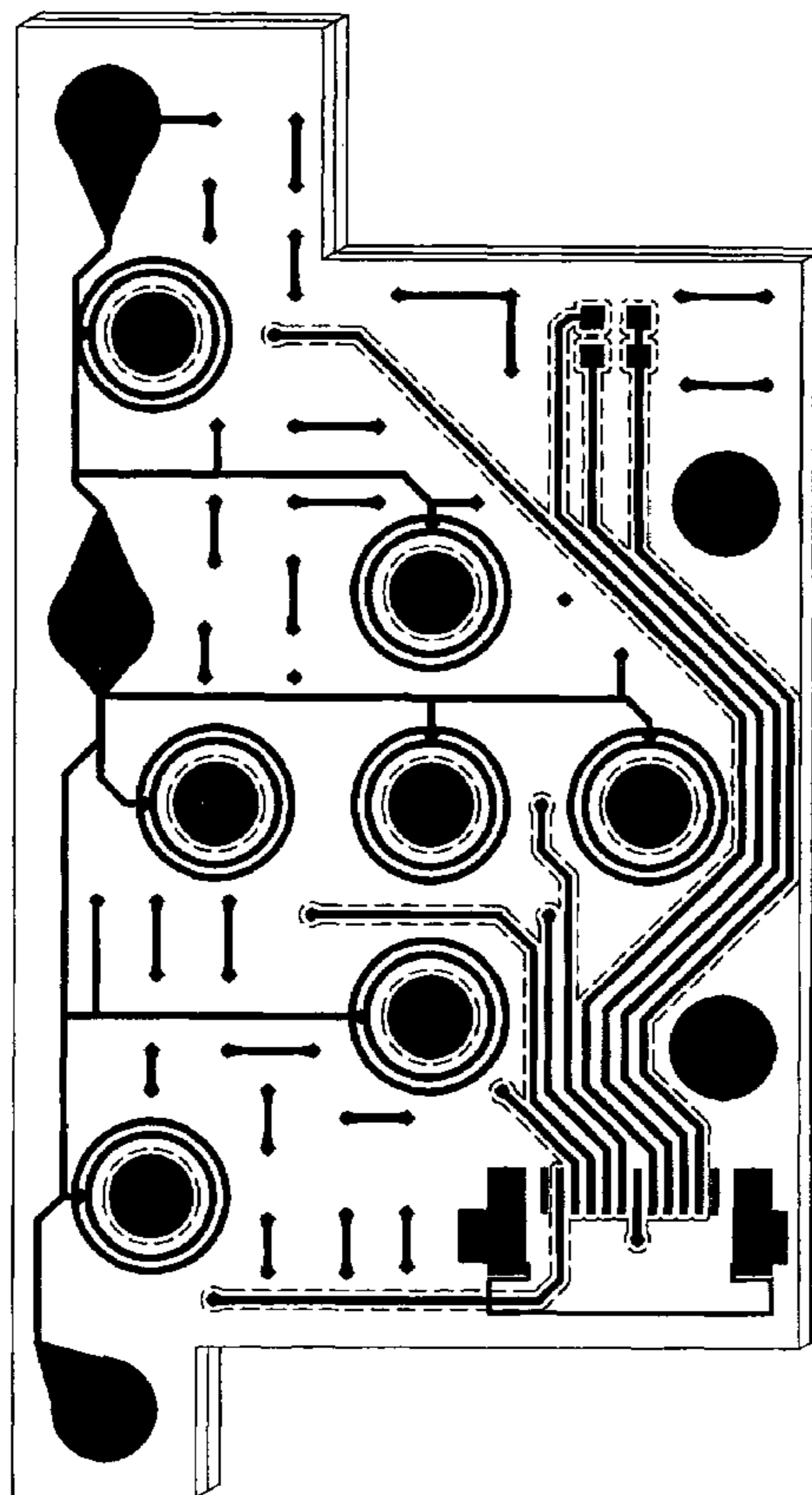
FIG. 5 is a left-side, elevational view thereof;

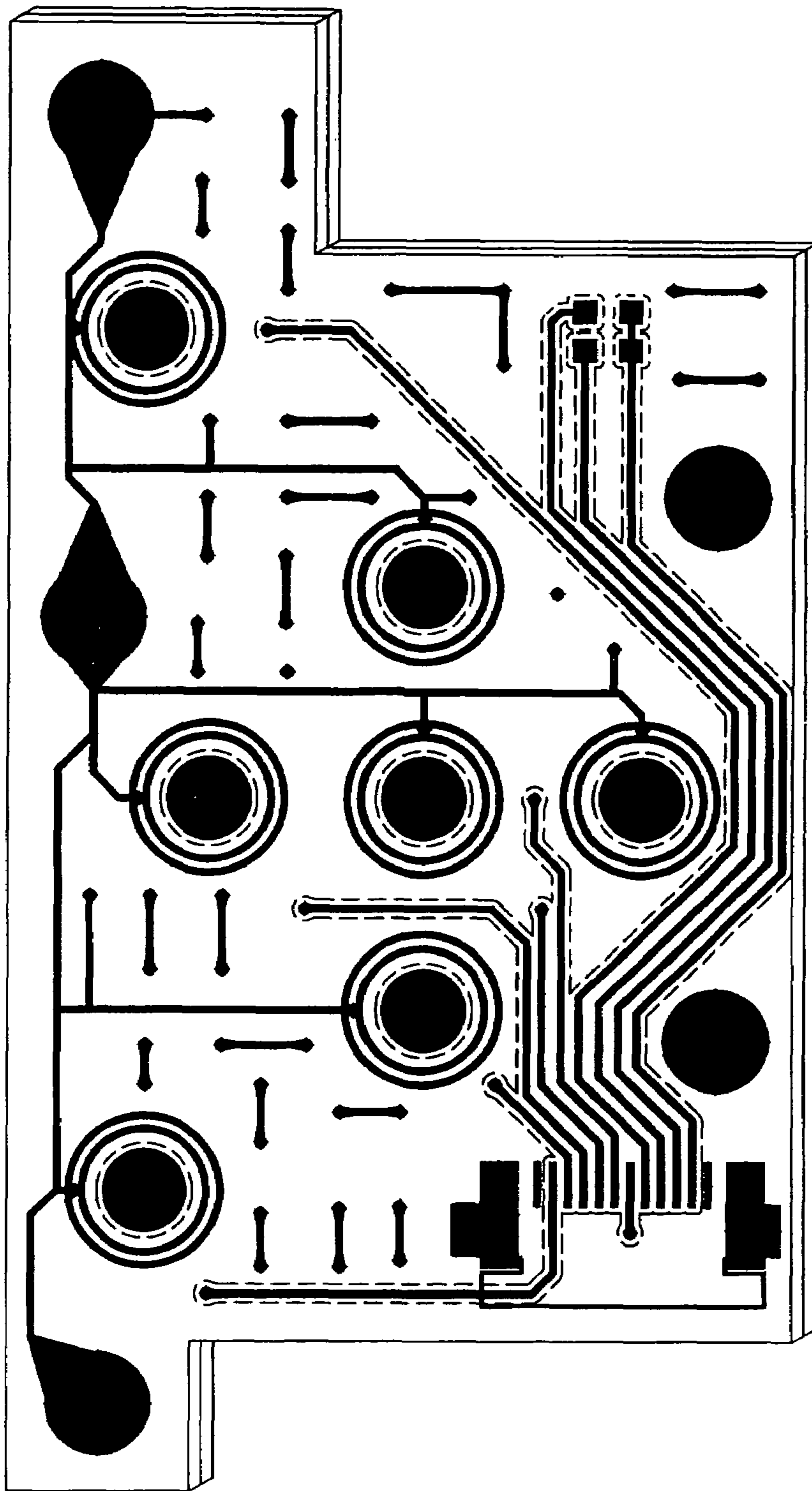

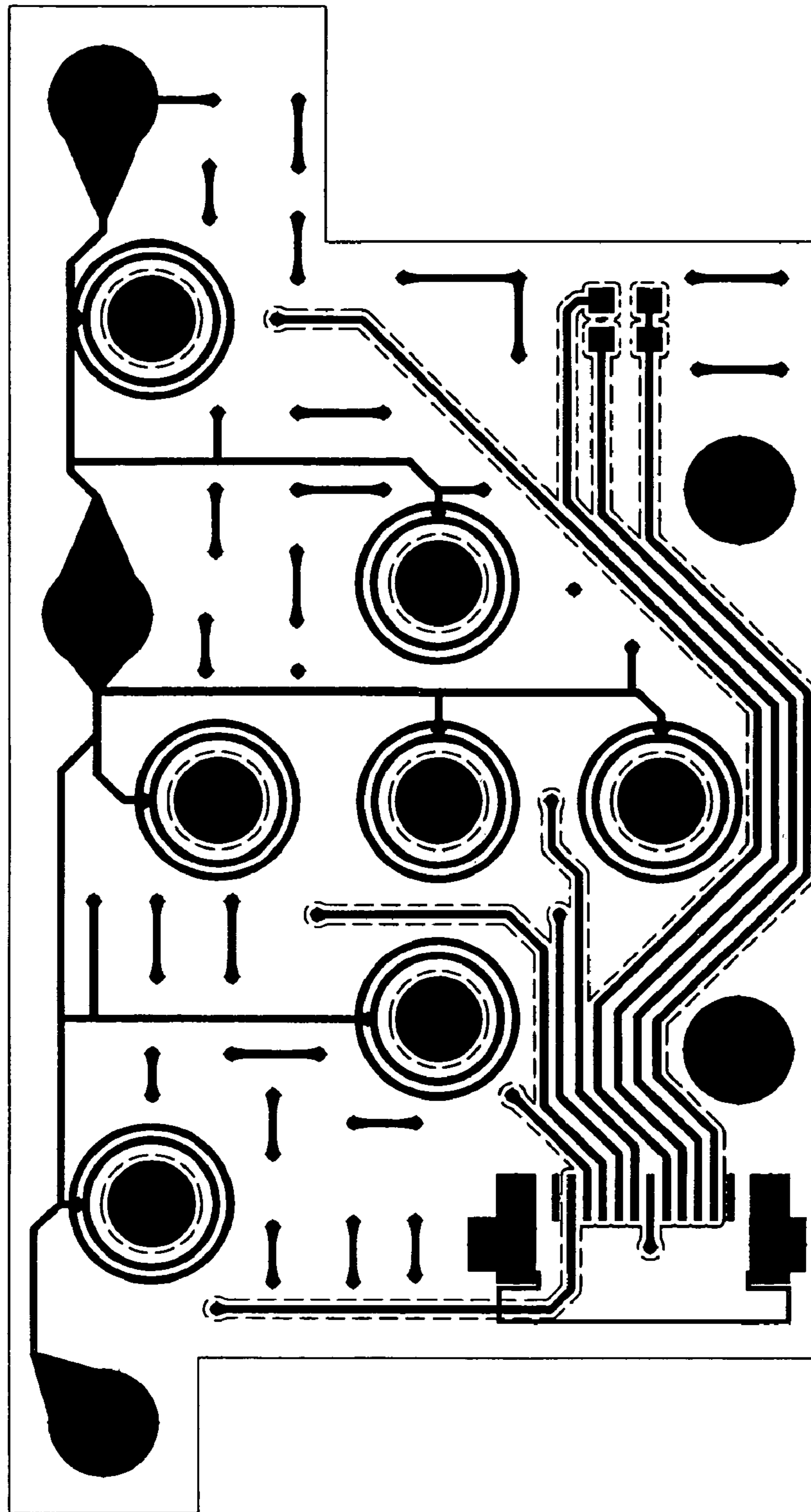

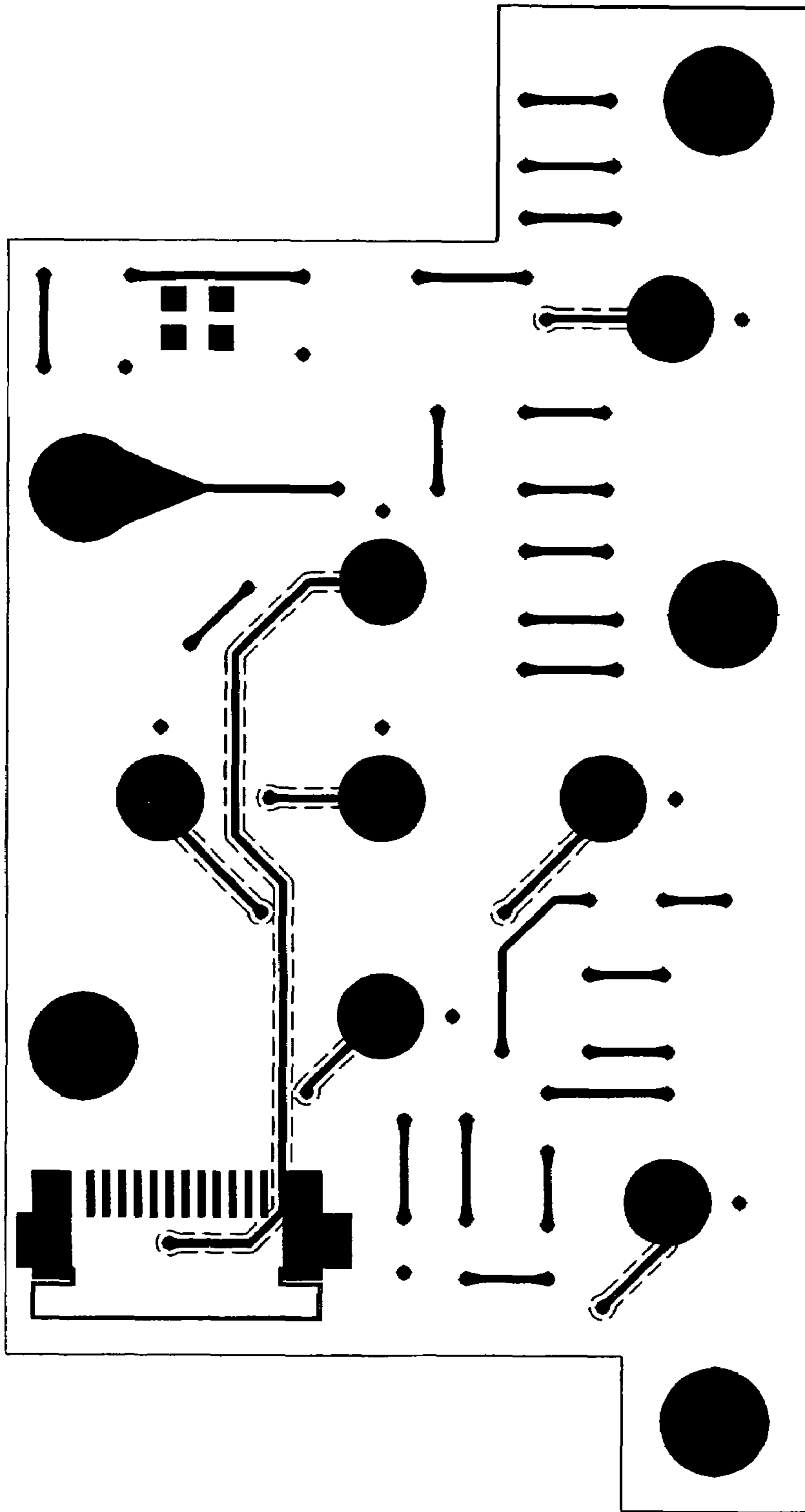

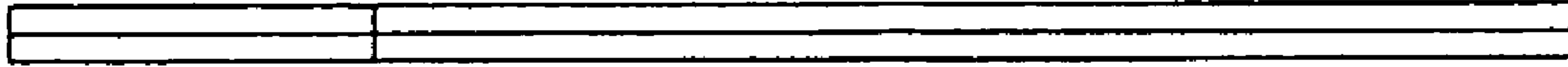

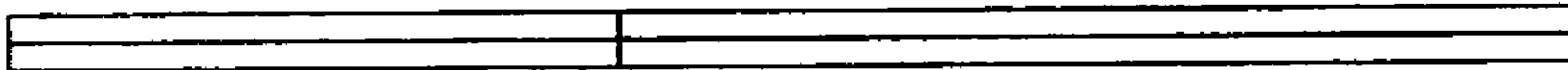
