(57) **CLAIM**

The ornamental design of a hood and protector portion of a backhoe, as shown and described.

DESCRIPTION

FIG. 1 is a left side view of the hood and protector portion of a backhoe;

FIG. 2 is a right side view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a perspective left rear view similar to FIG. 1; however the part of the photograph shown in a coarse dot pattern and outlined in dashed lines illustrates a portion of the backhoe that forms no part of the claimed design; and,

FIG. 6 is a perspective left front view similar to FIG. 1; however the part of the photograph shown in a coarse dot pattern and outlined in dashed lines illustrates a portion of the backhoe that forms no part of the claimed design.

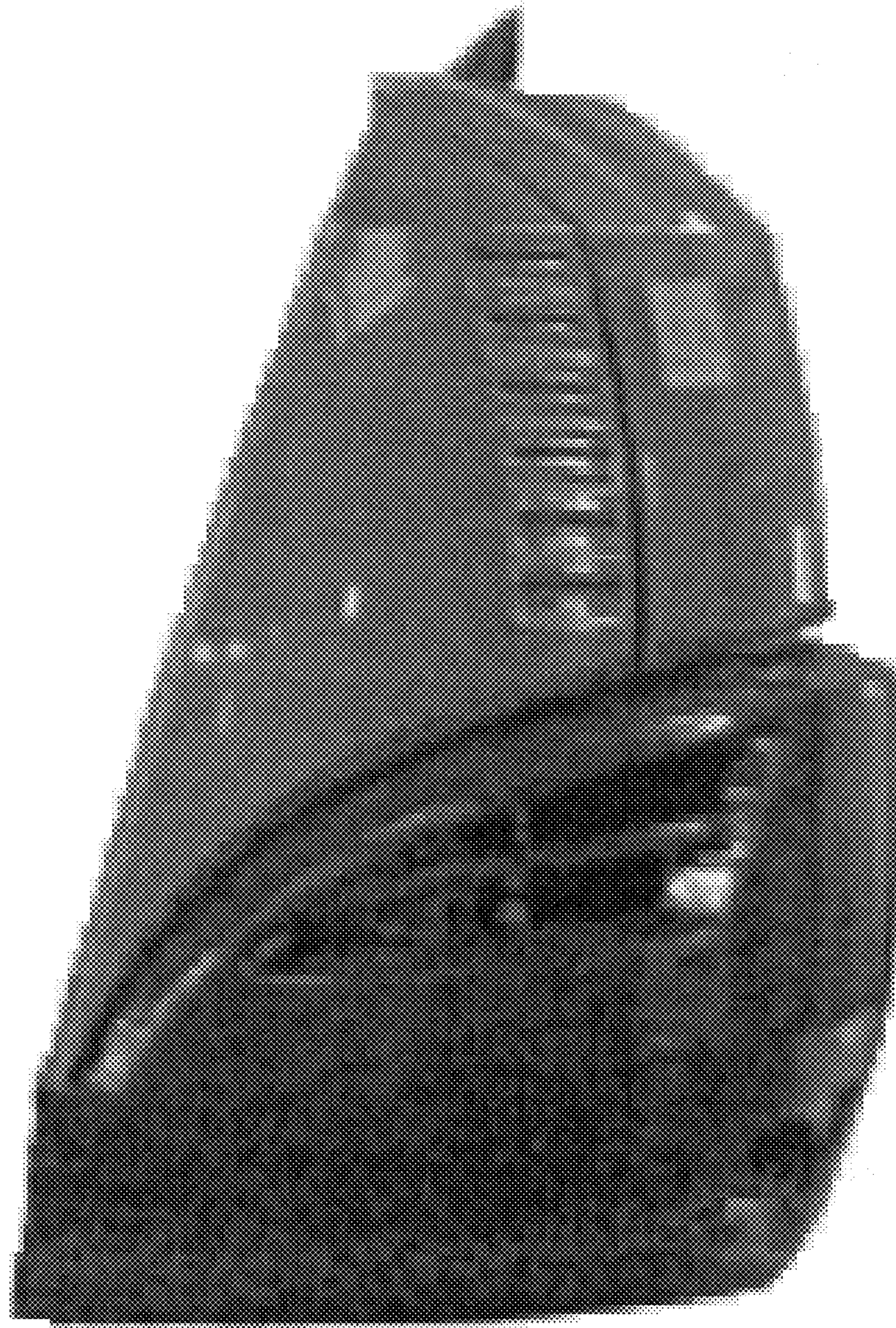

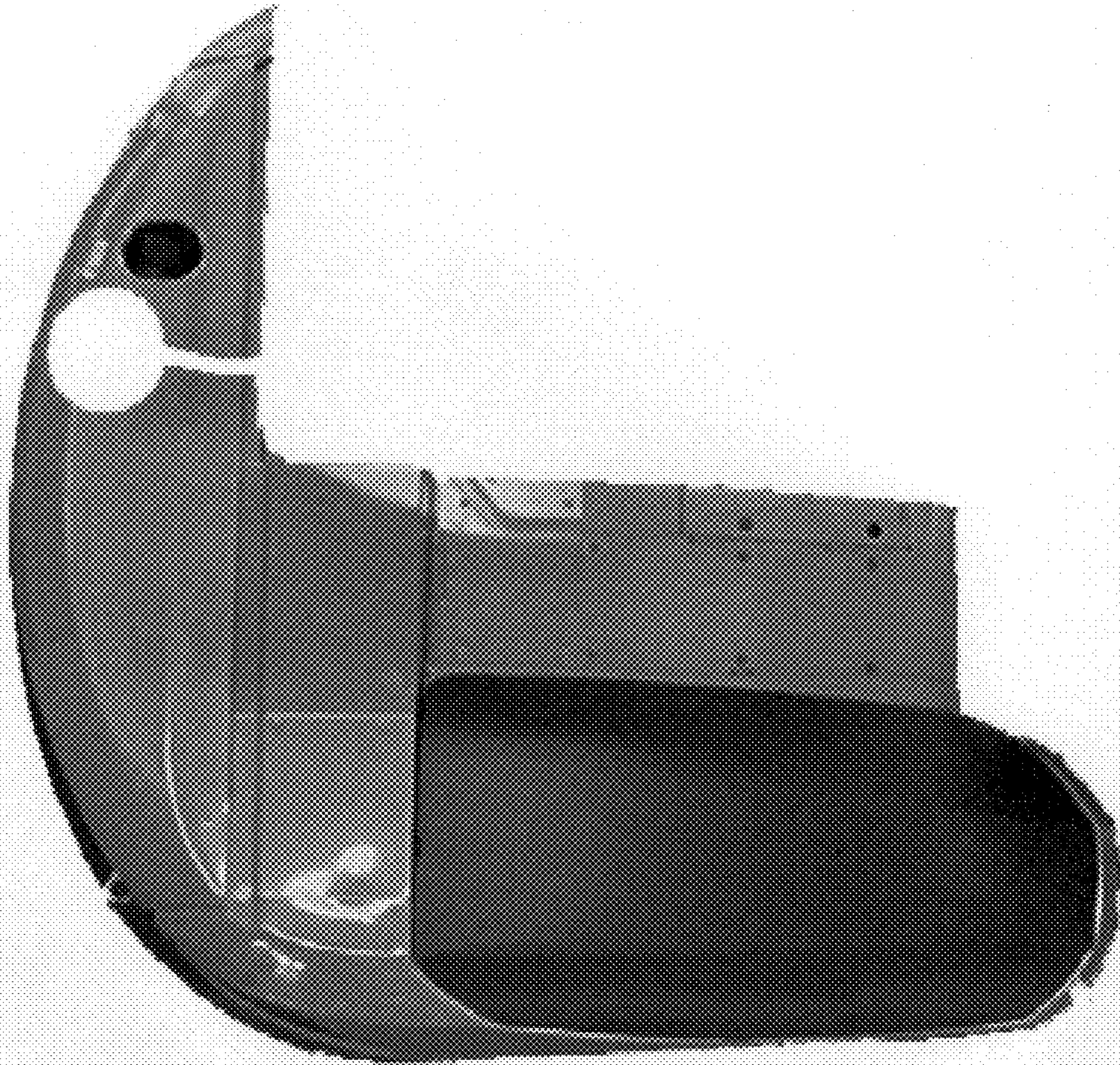

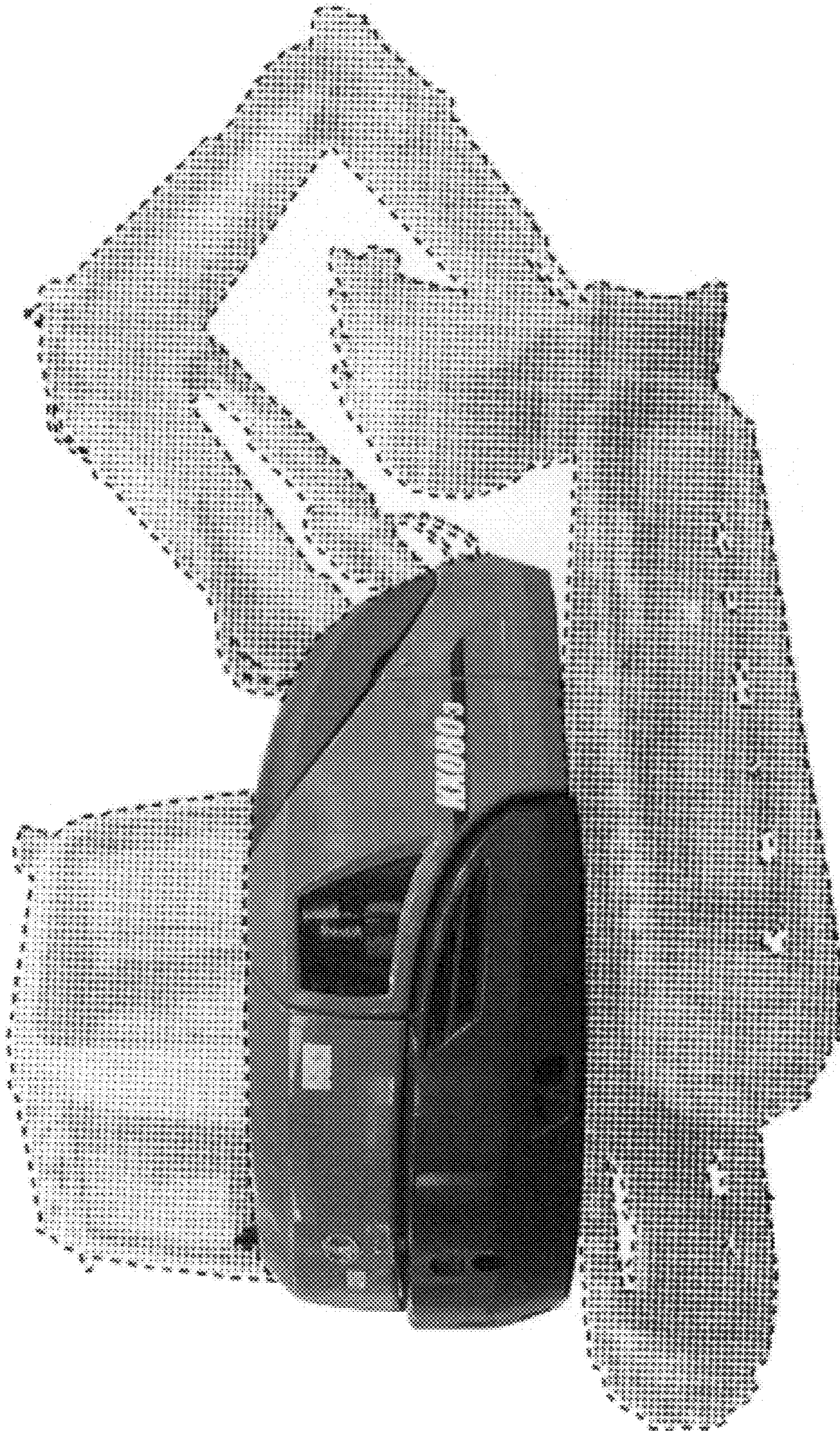

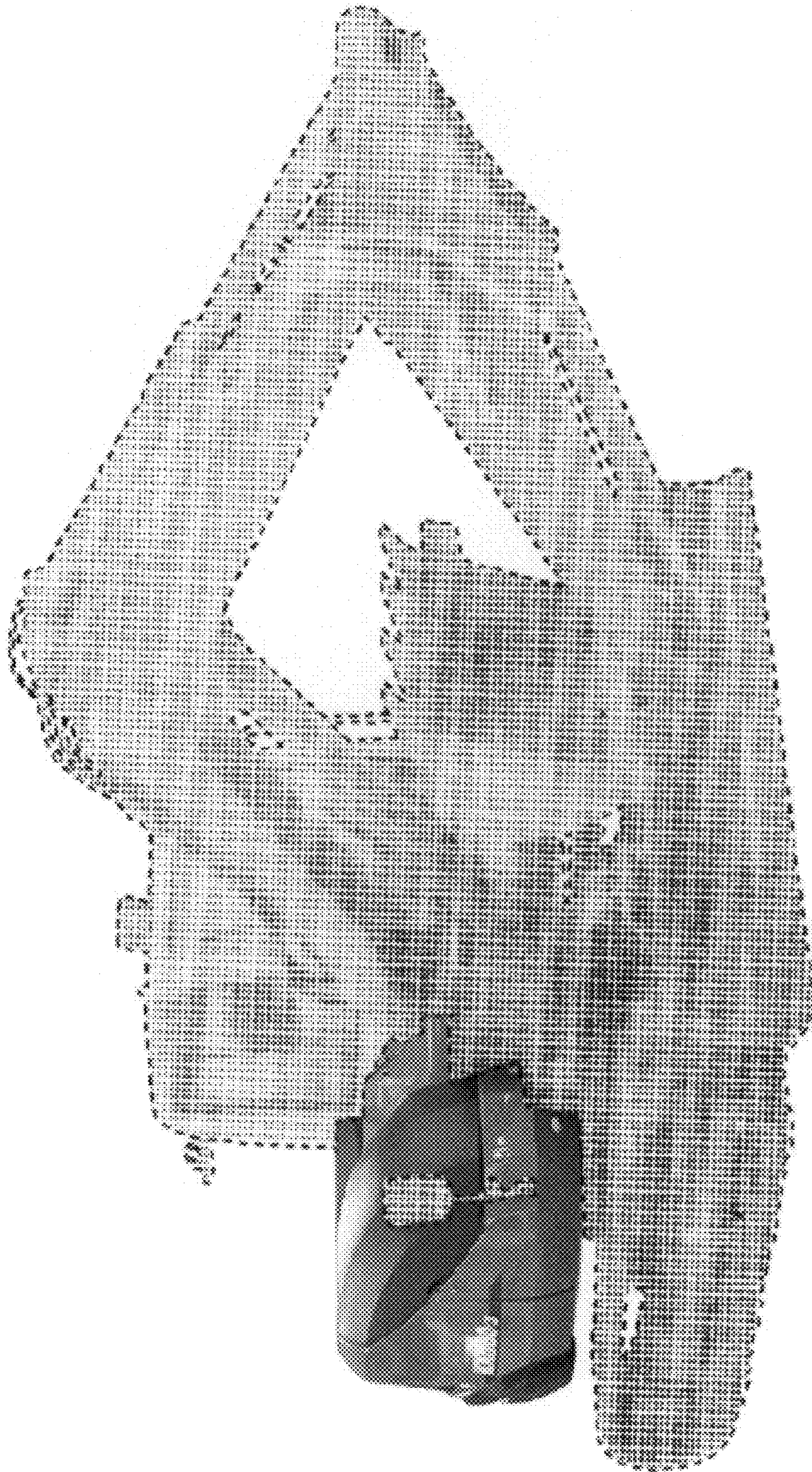
