The ornamental design for an electronic keyboard instrument, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a top, front and left side of an electronic keyboard instrument showing our new design;

FIG. 2 is a front elevational view thereof;

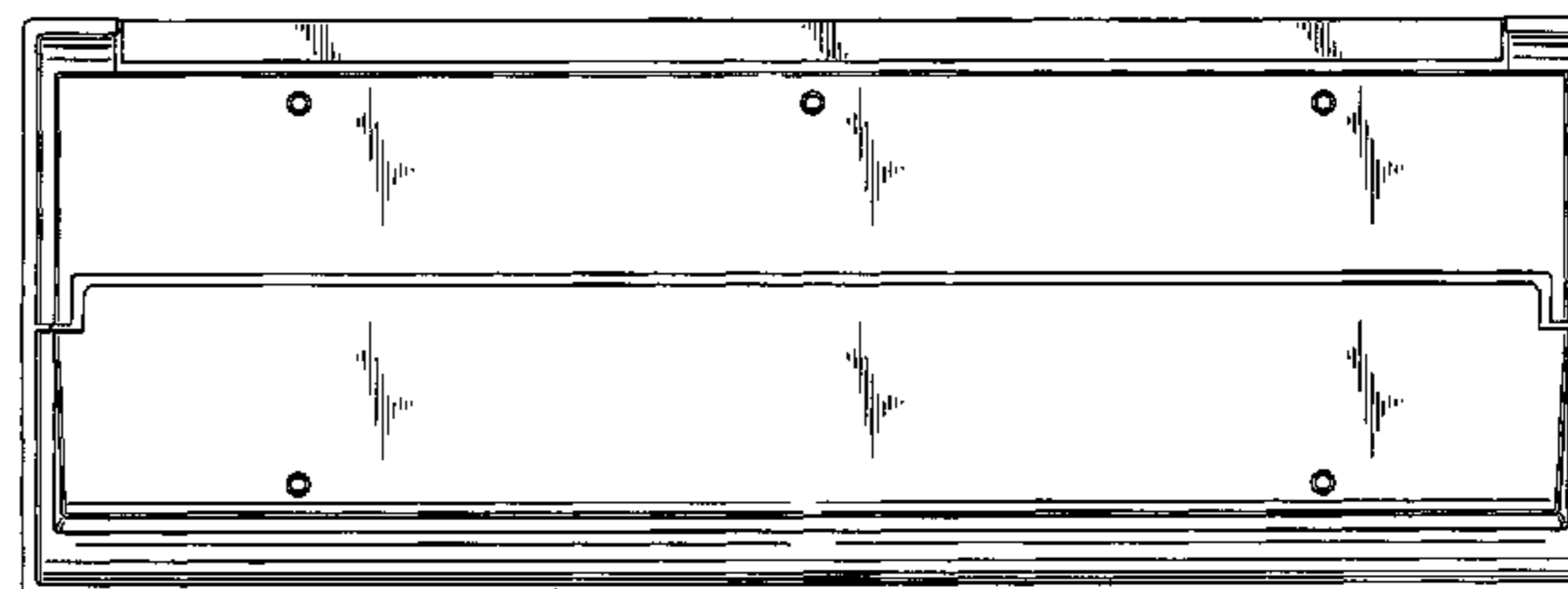
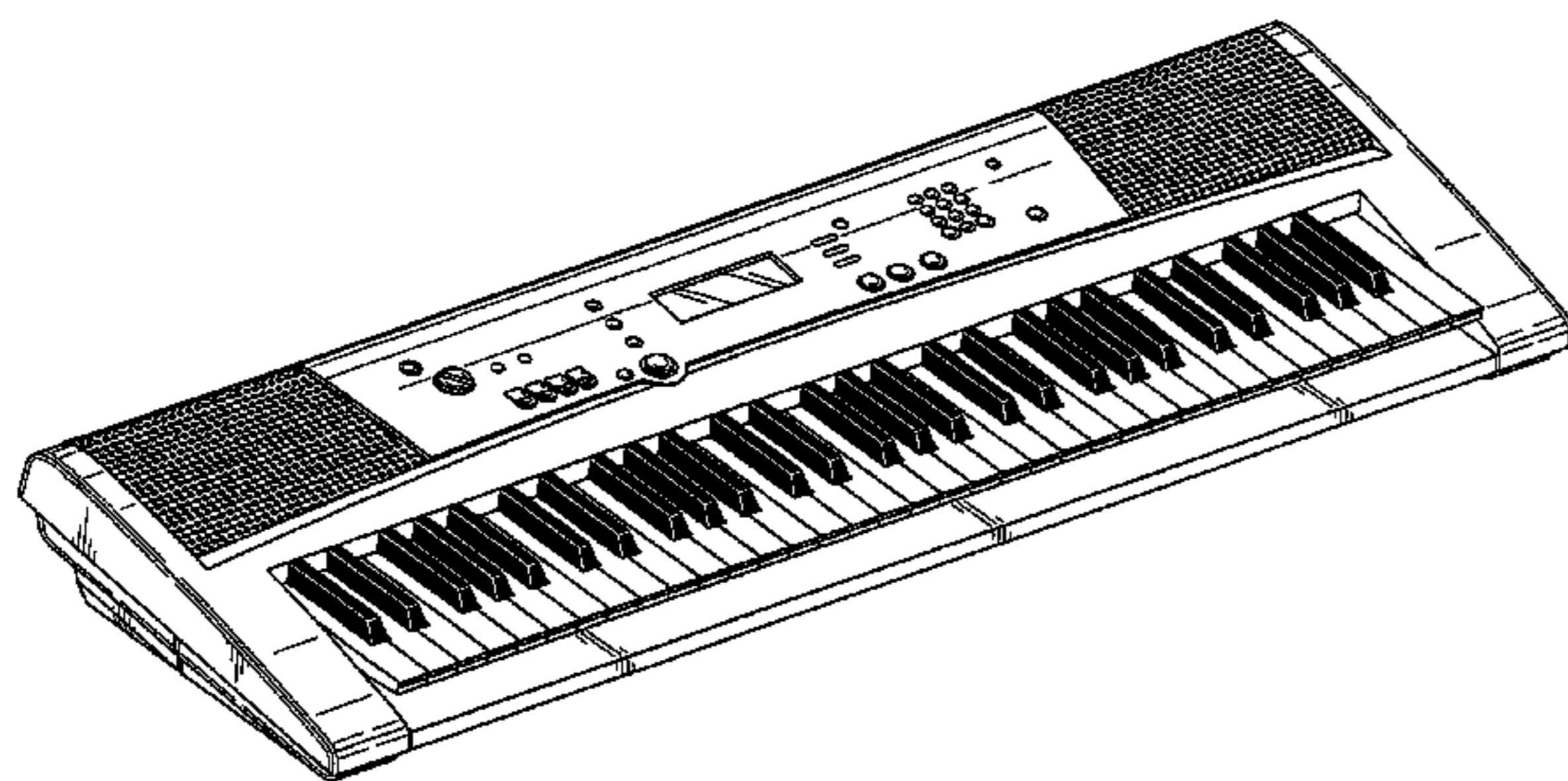

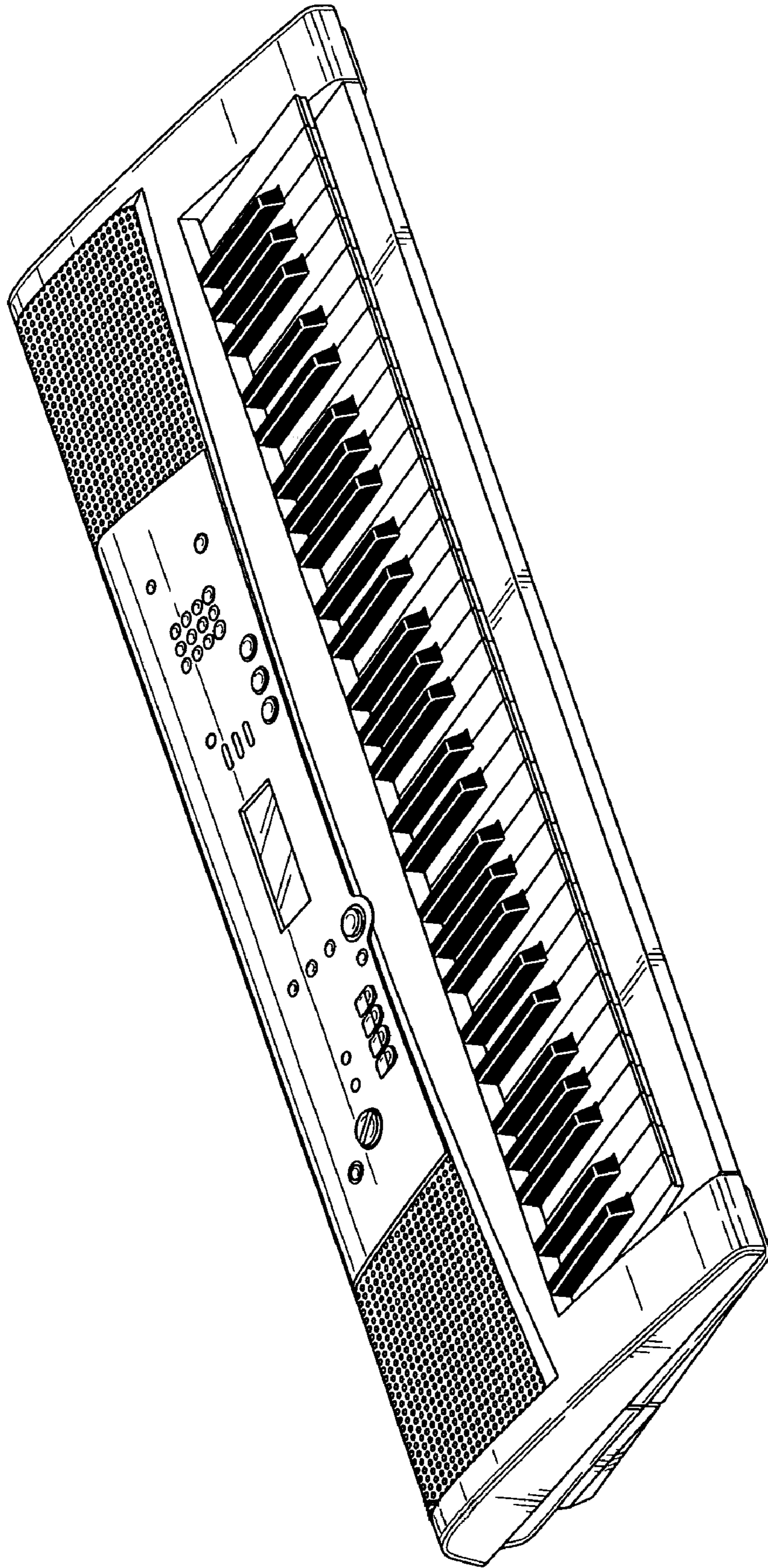

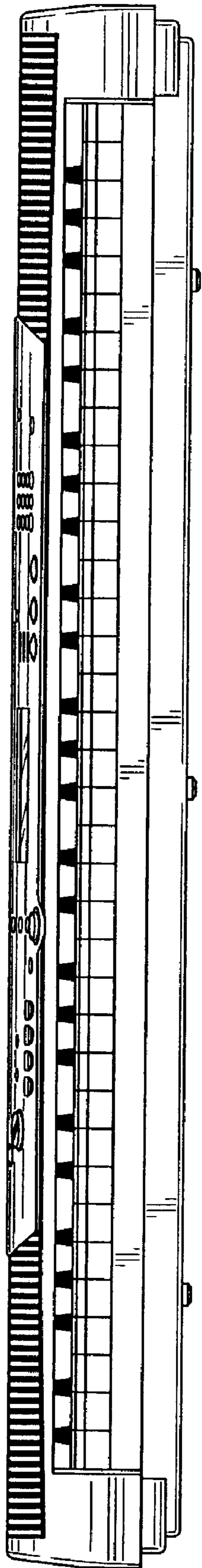
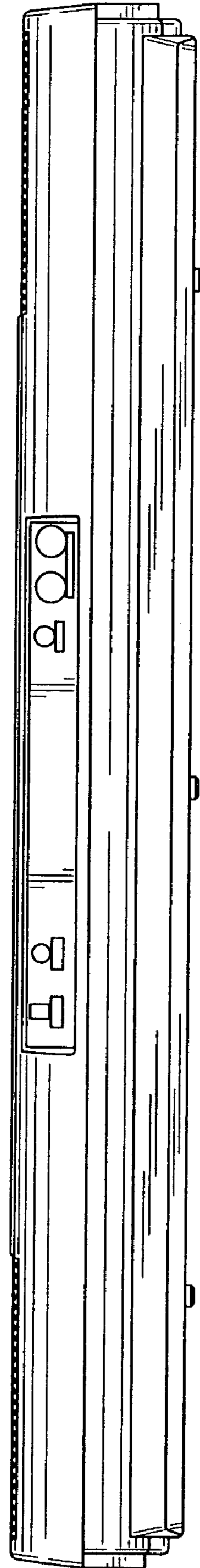
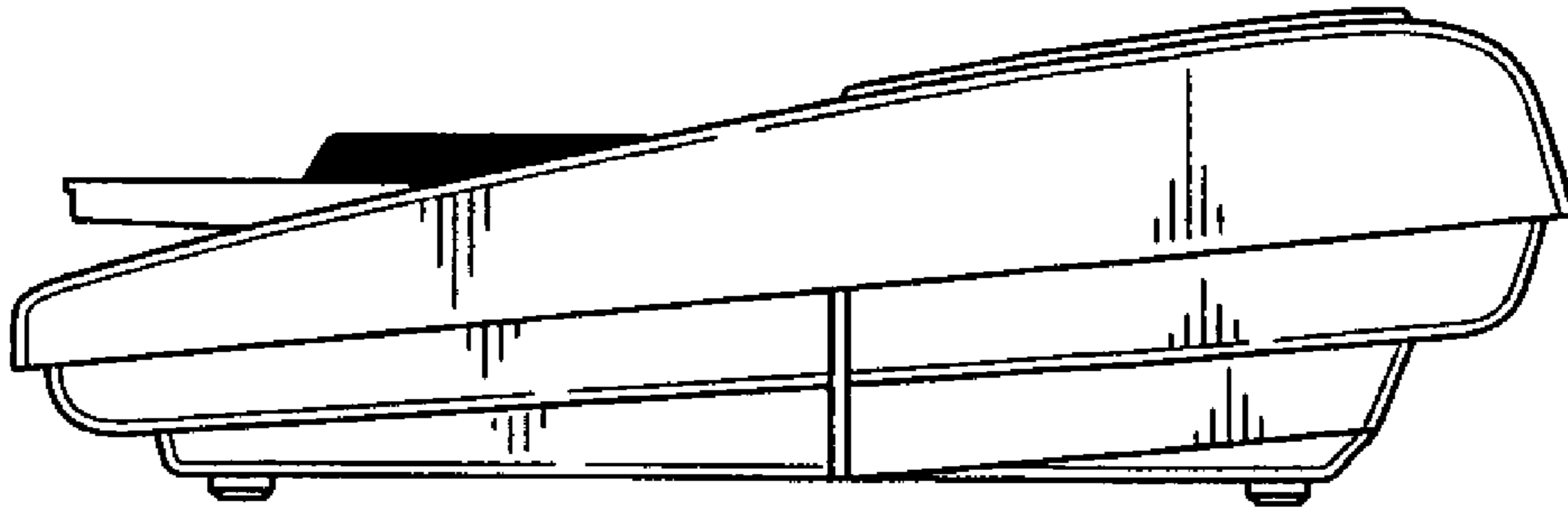

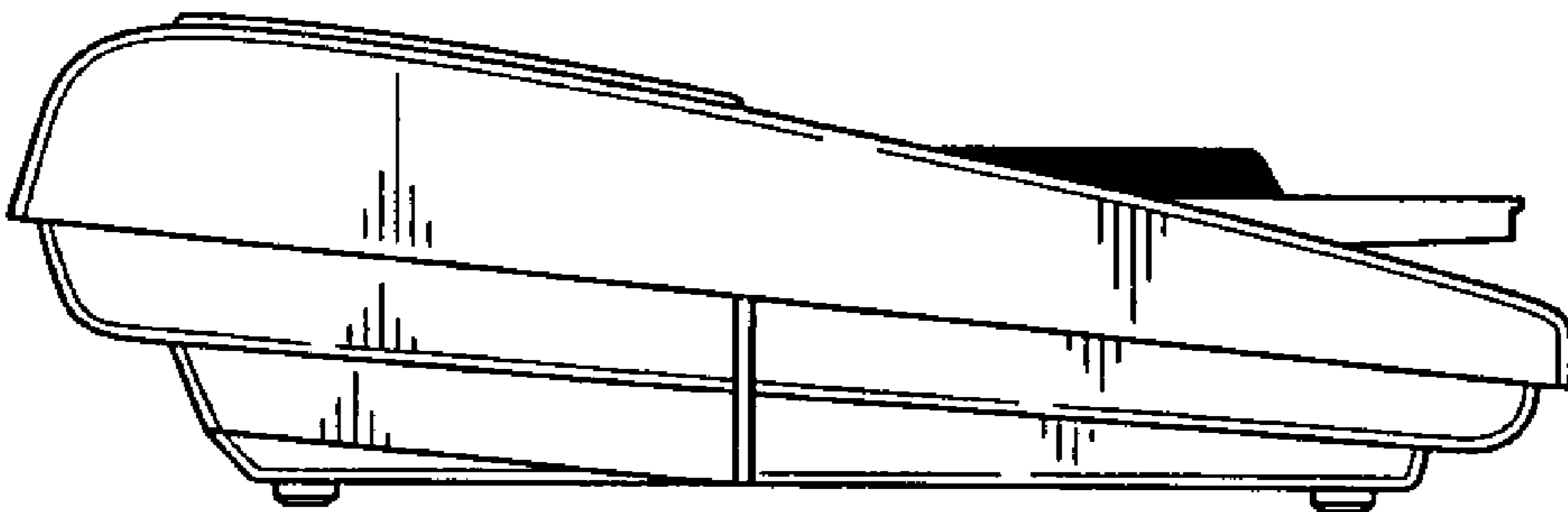

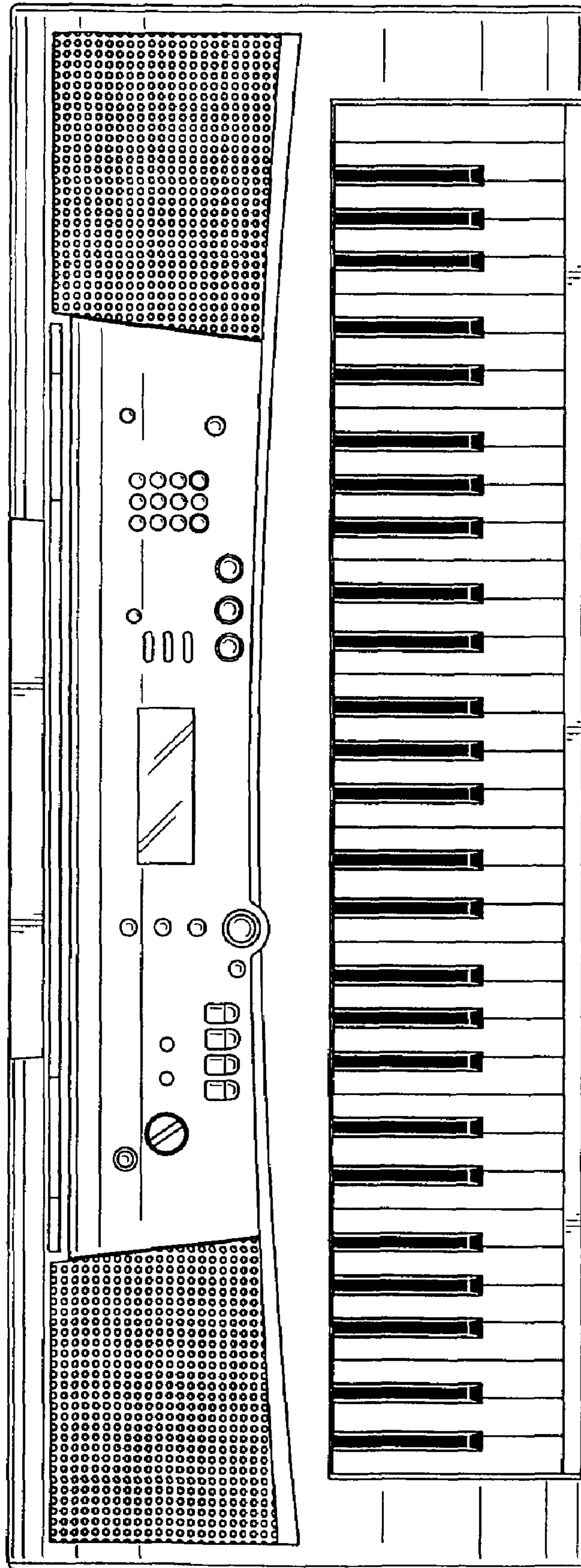
