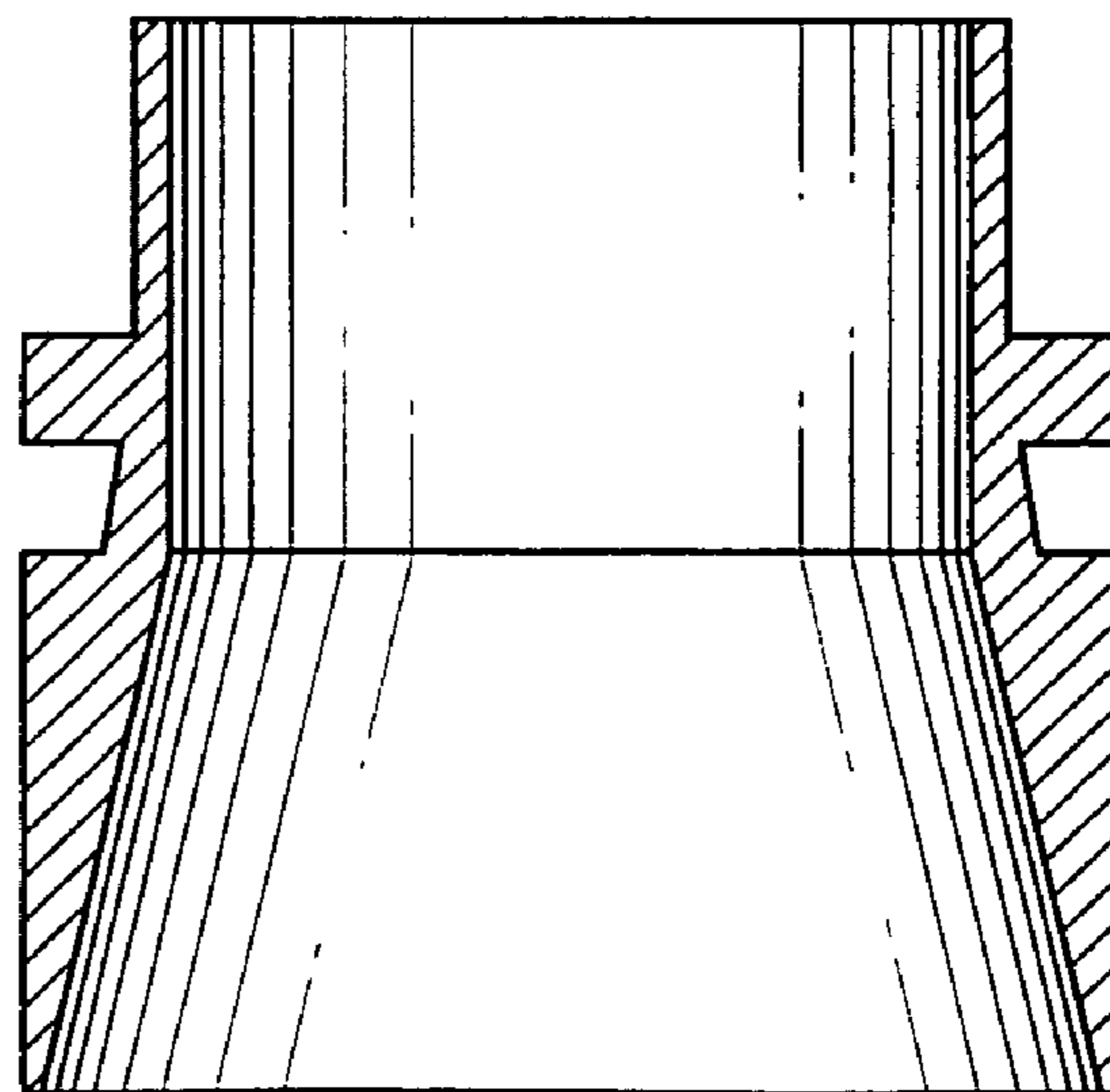
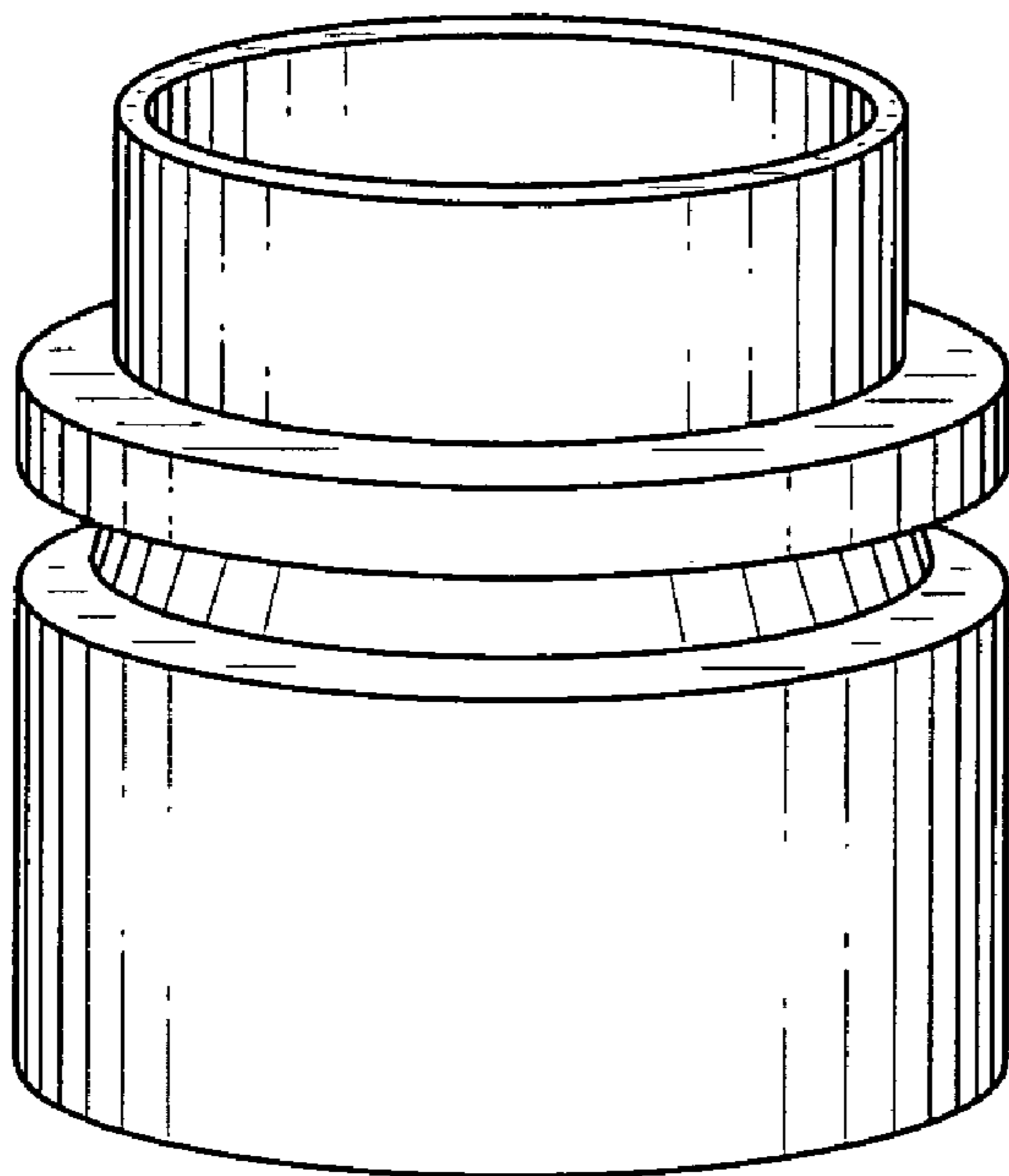

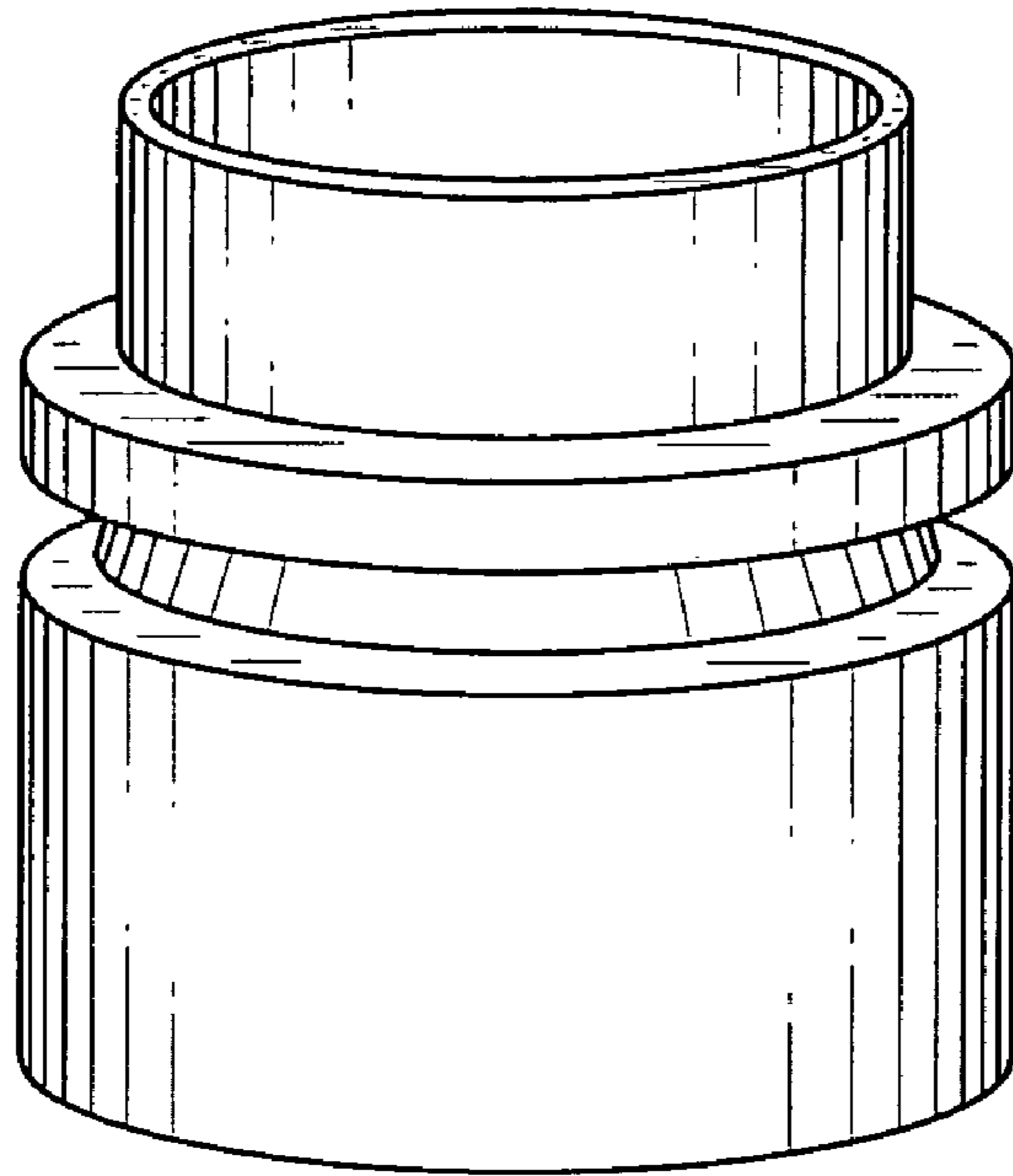
The ornamental design for a saxophone tone enhancer, as shown and described.

**DESCRIPTION**

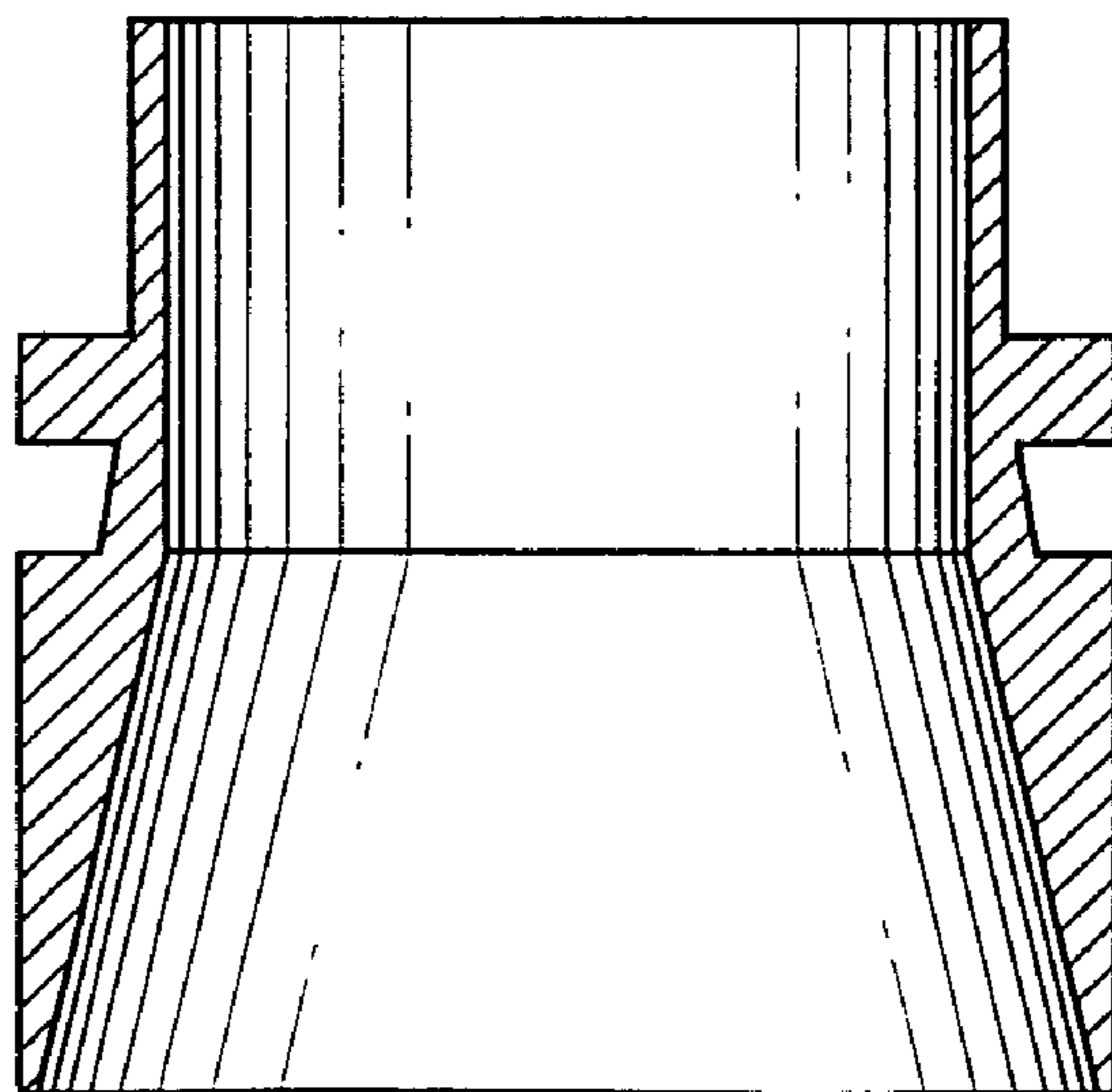
FIG. 1 is a front, top perspective view of a saxophone tone enhancer showing my new design;

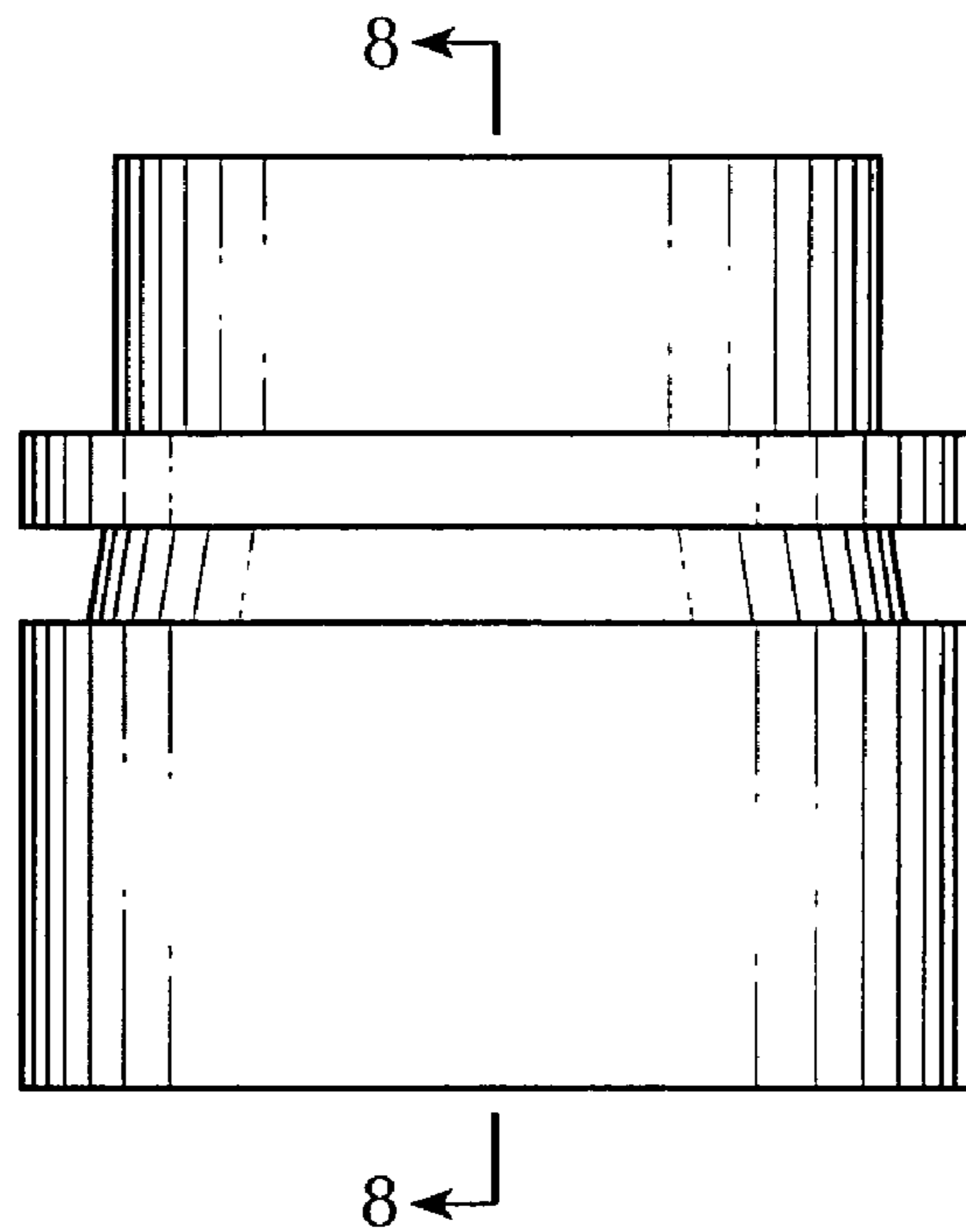




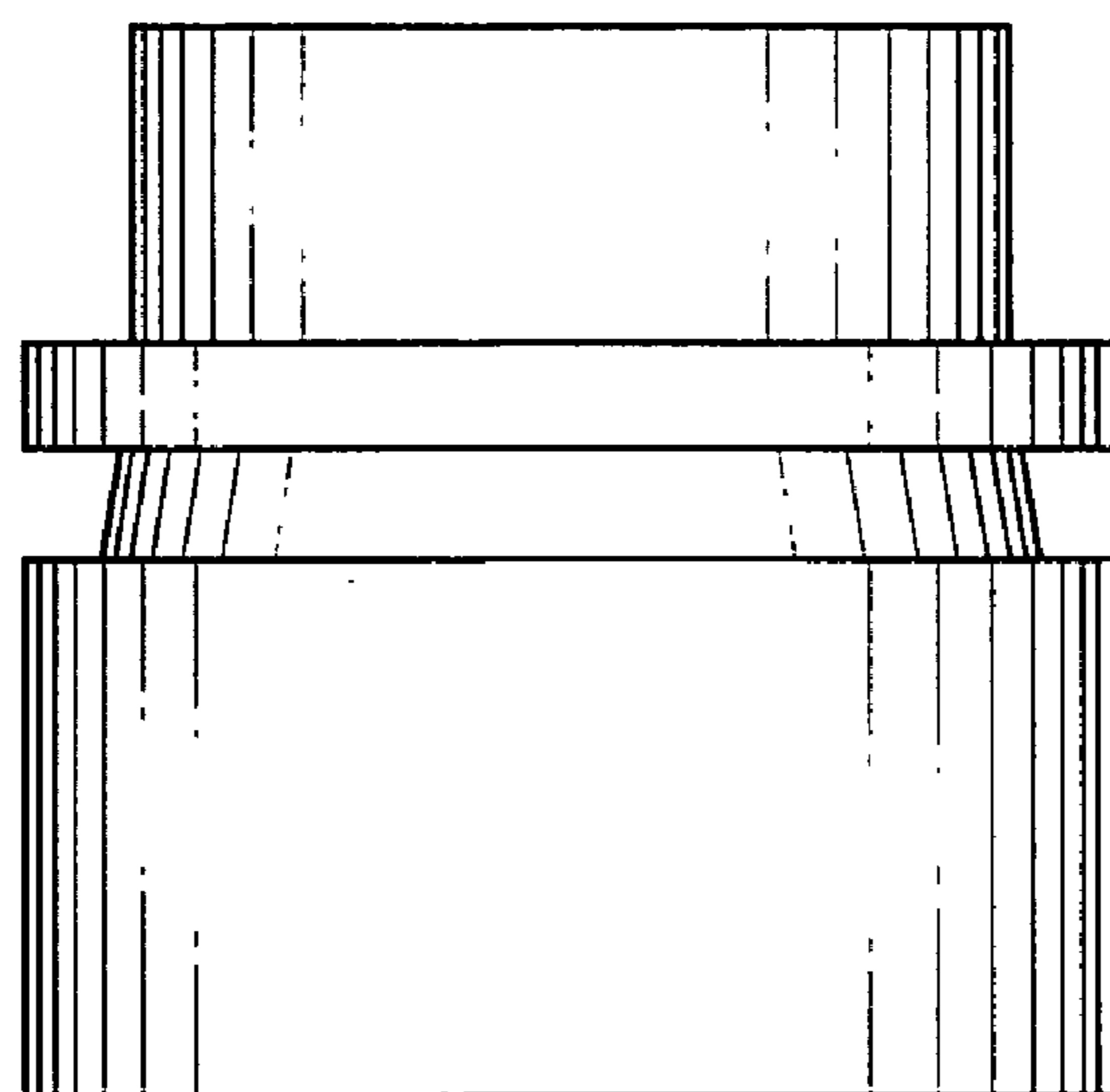

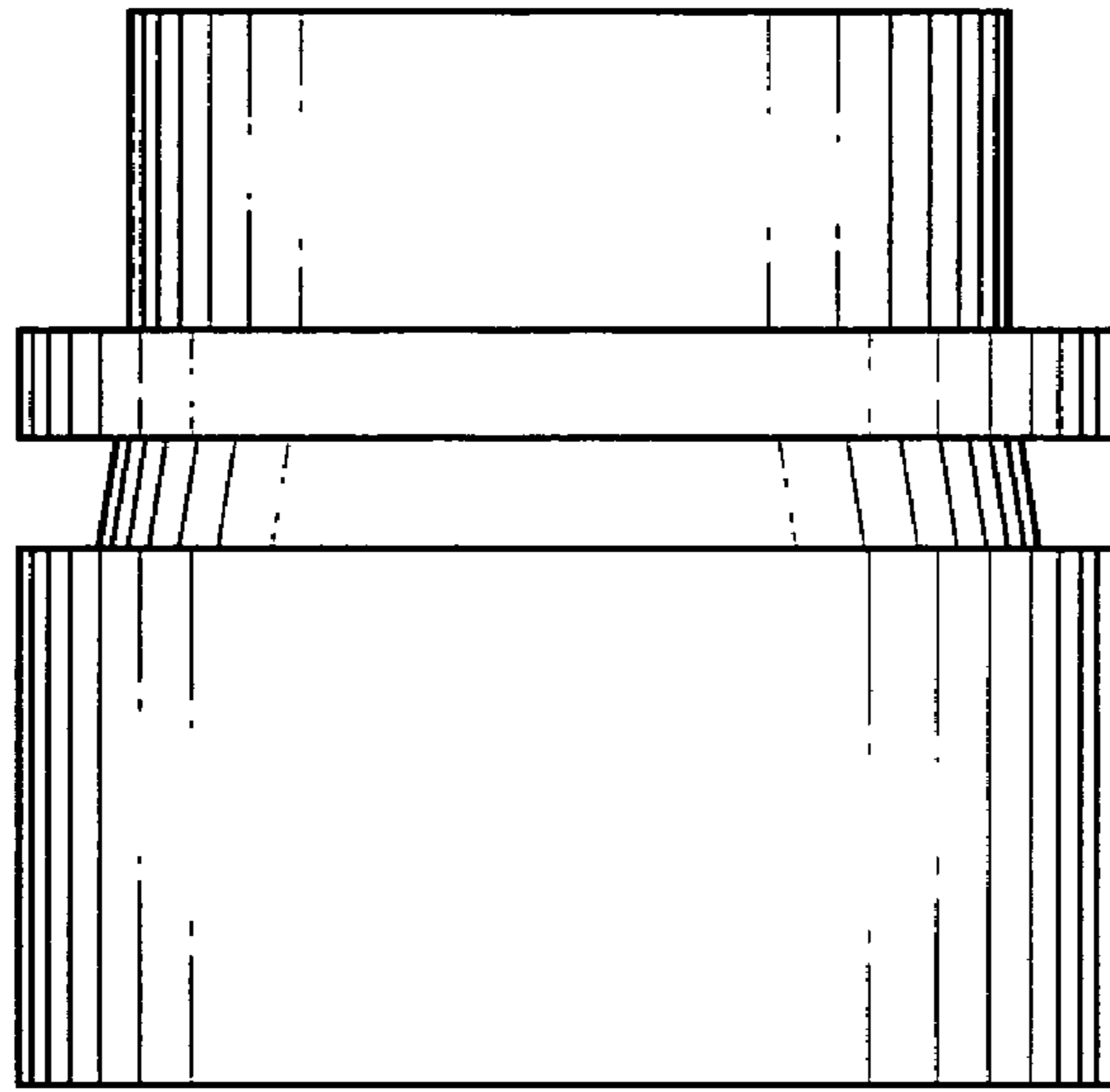

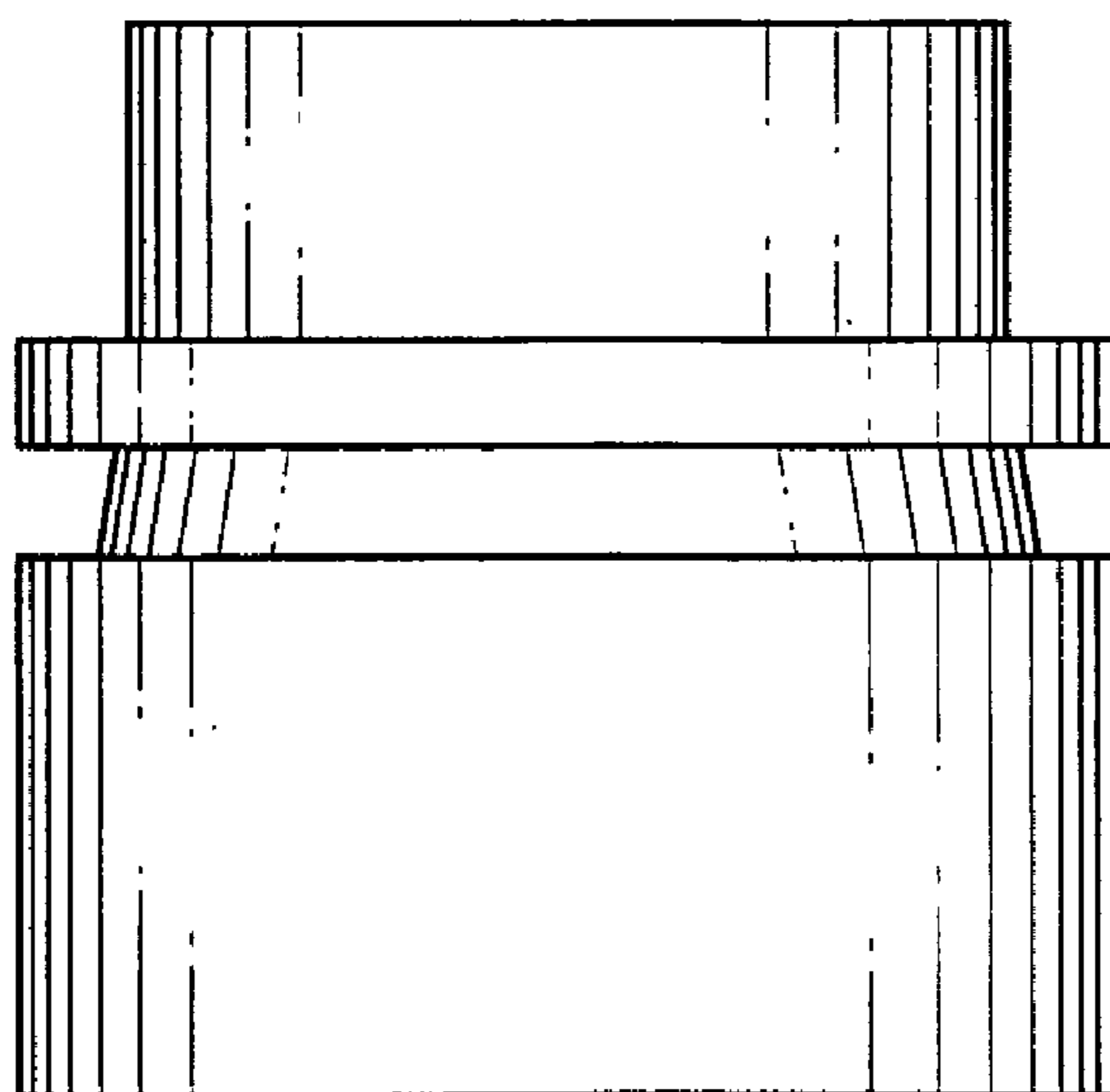

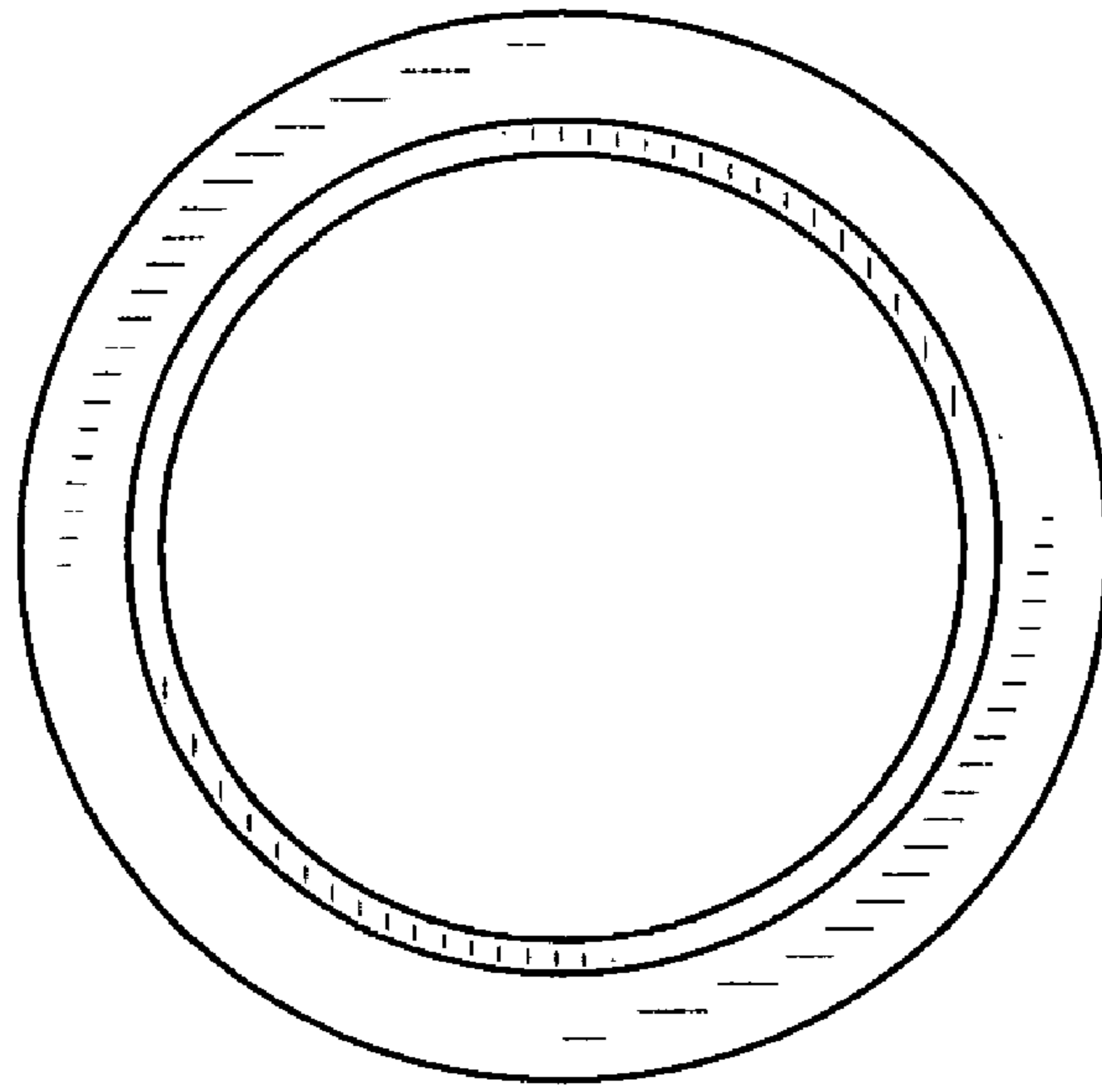

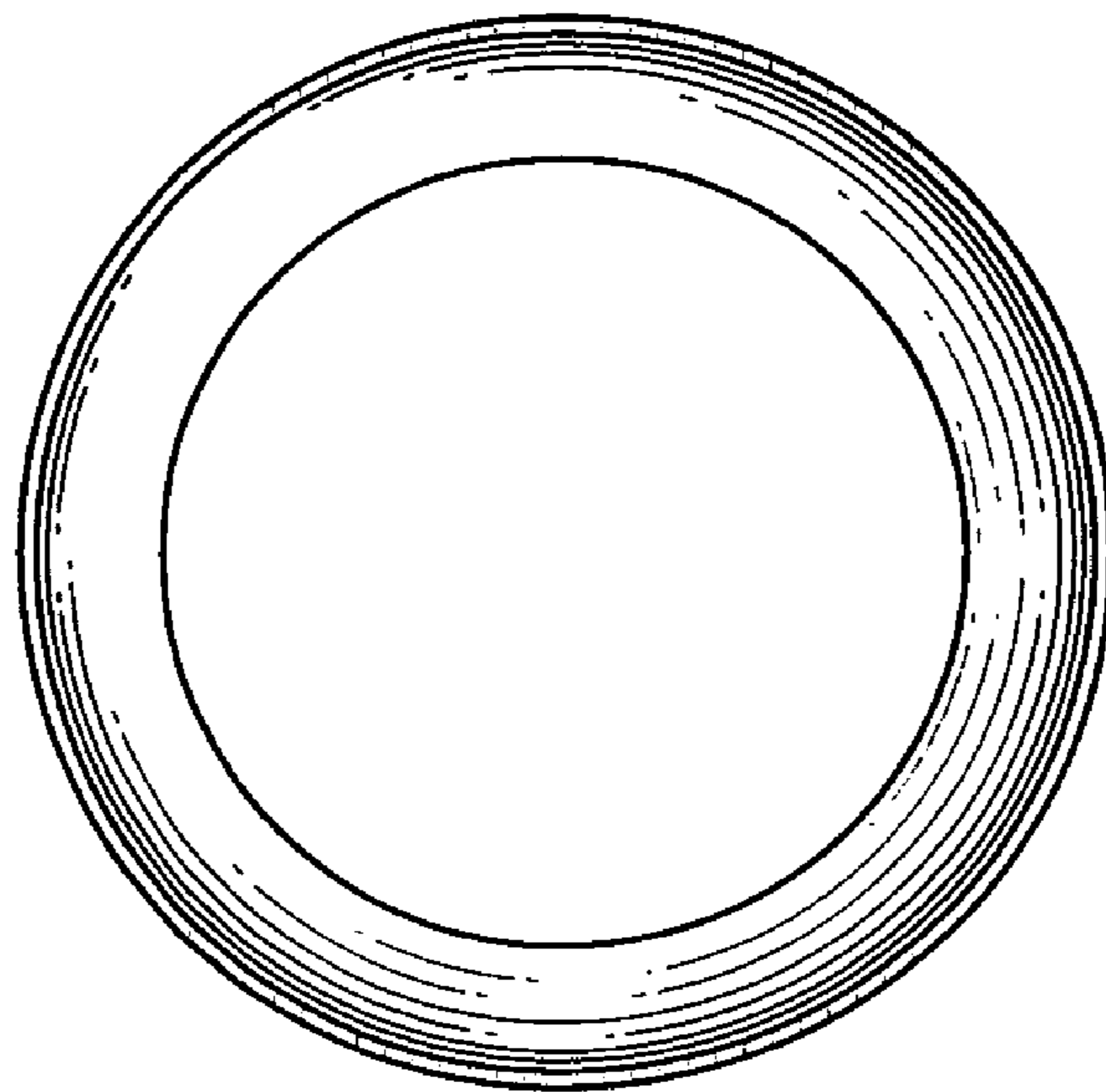
