(57) **CLAIM**

The ornamental designs for a golf club head cover, as shown and described.

FIG. 1 is a perspective view of the front, right side and bottom of a golf club head cover.

FIG. 2 is a front view of the golf club head cover of FIG. 1.

FIG. 3 is a rear view of the golf club head cover of FIG. 1.

FIG. 4 is a right side view of the golf club head cover of FIG. 1.

FIG. 5 is a left side view of the golf club head cover of FIG. 1.

FIG. 6 is a top view of the golf club head cover of FIG. 1.

FIG. 7 is a bottom view of the golf club head cover of FIG. 1.

FIG. 8 is a perspective view of the front, right side and bottom of a second embodiment of the golf club head cover disclosed in FIG. 1;

FIG. 9 is a front view of the golf club head cover of FIG. 8.

FIG. 10 is a rear view of the golf club head cover of FIG. 8.

FIG. 11 is a right side view of the golf club head cover of FIG. 8.

FIG. 12 is a left side view of the golf club head cover of FIG. 8.

FIG. 13 is a top view of the golf club head cover of FIG. 8; and,

FIG. 14 is a bottom view of the golf club head cover of FIG. 8.

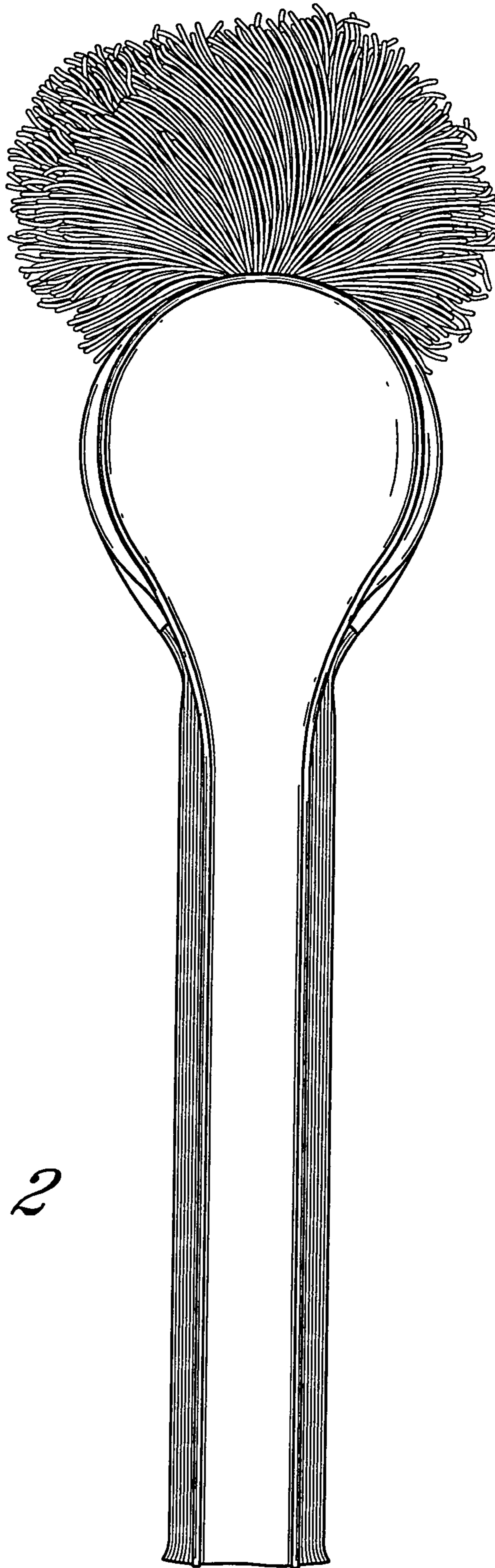

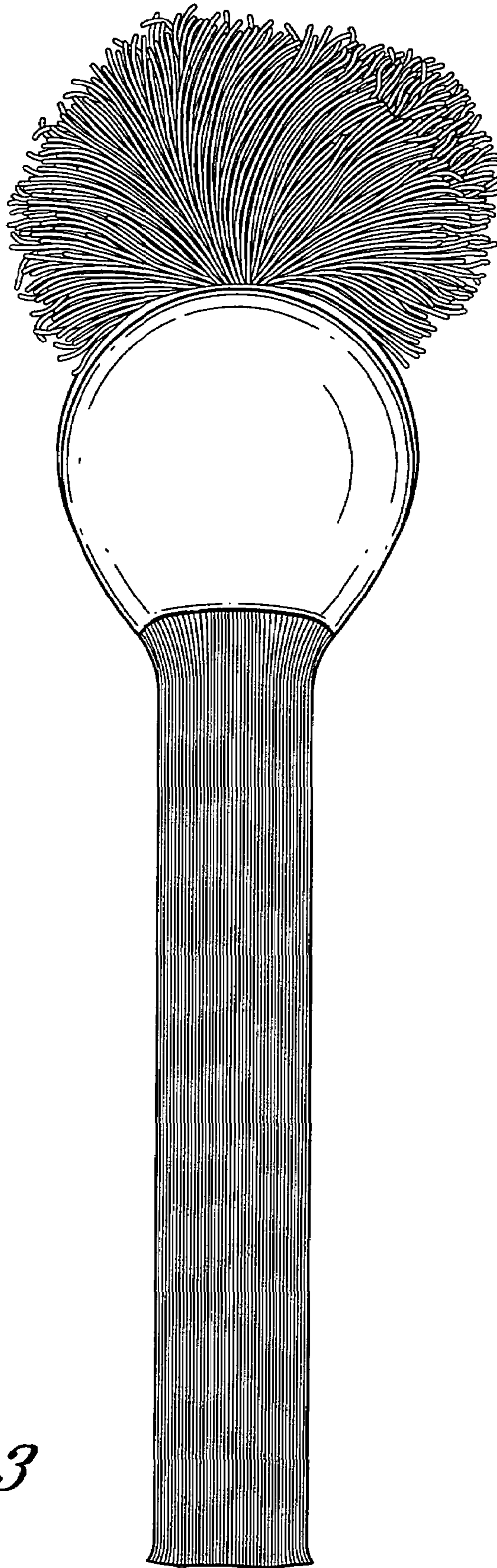

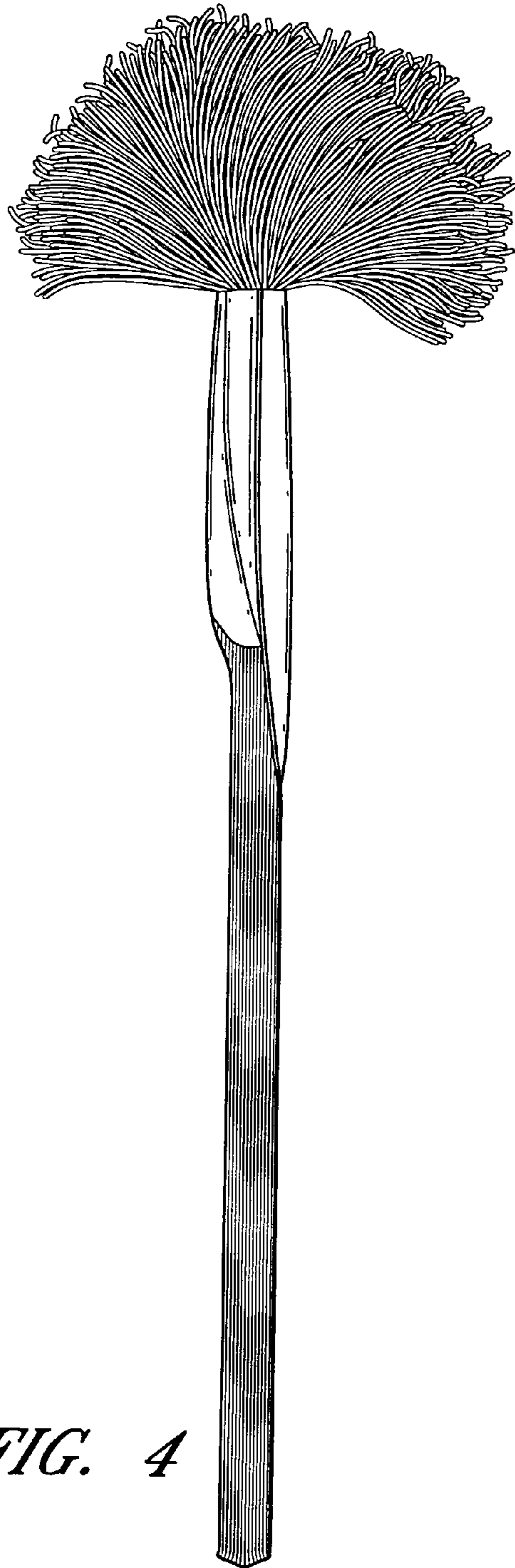

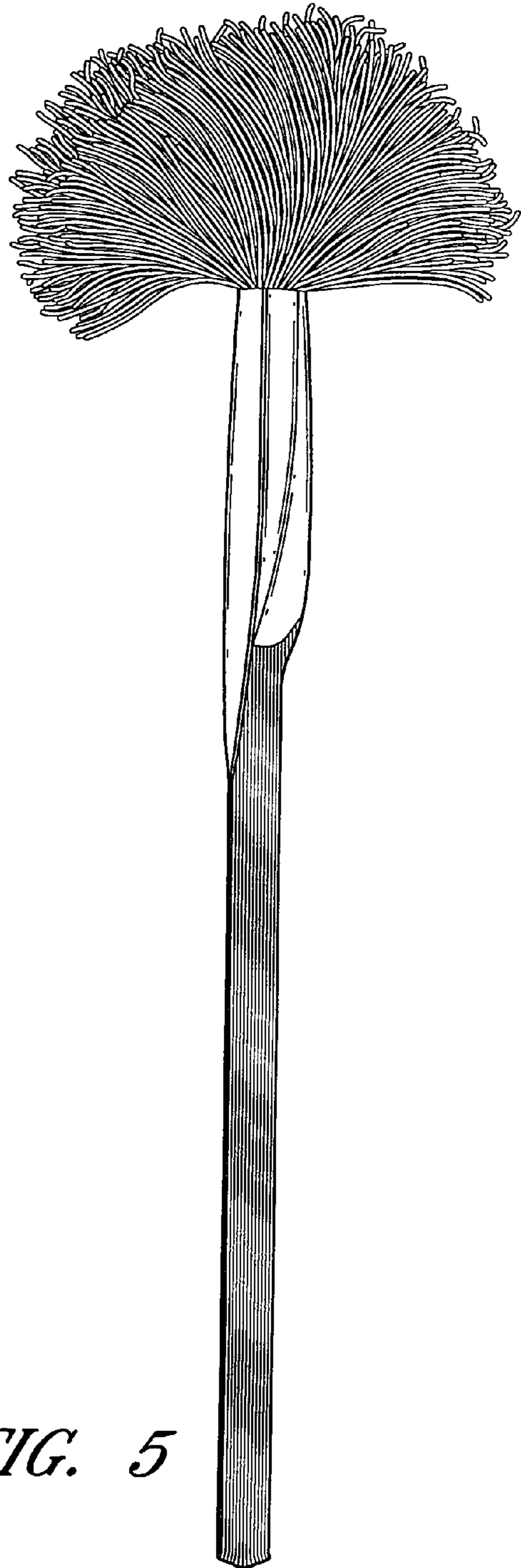

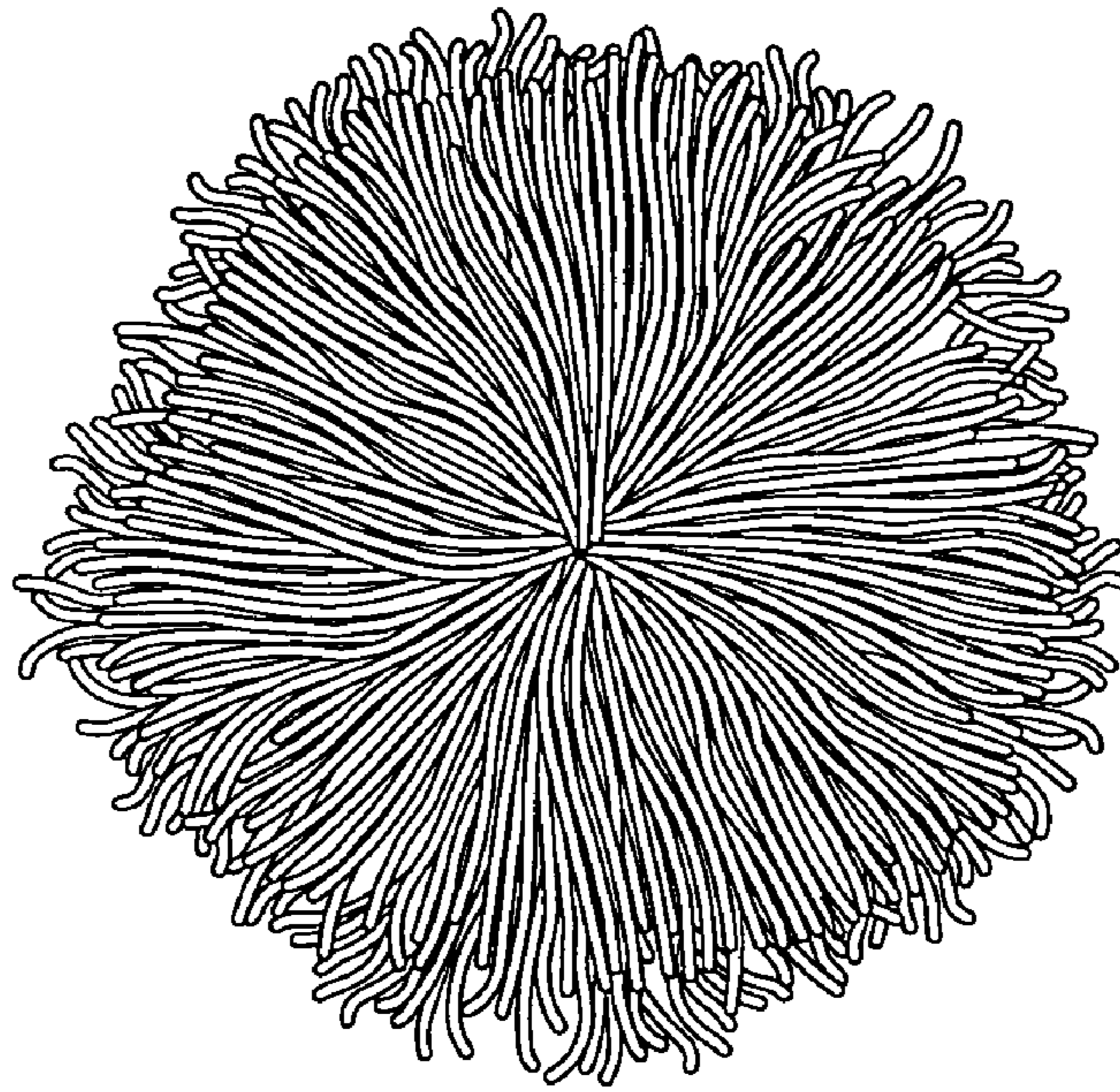

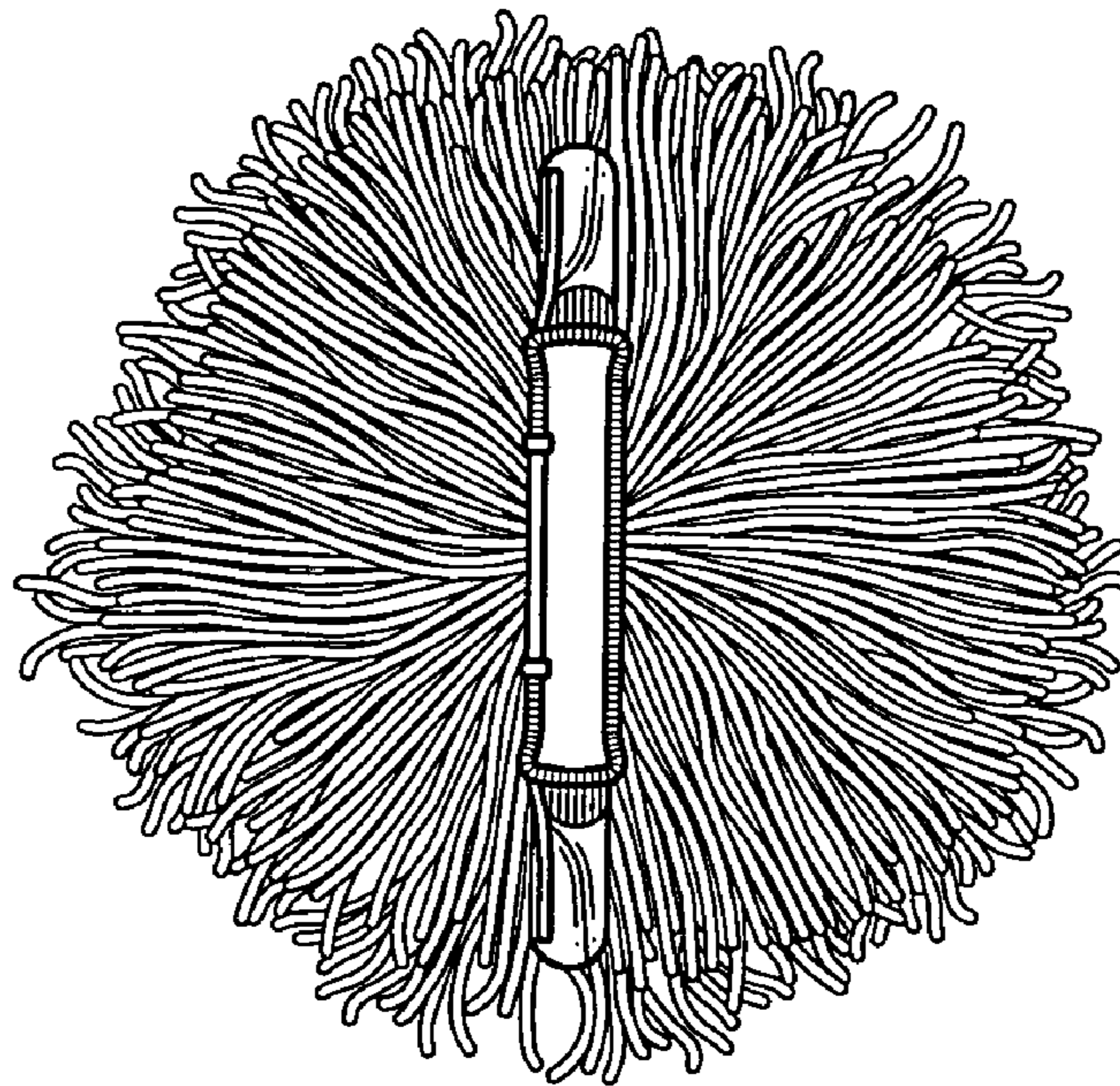

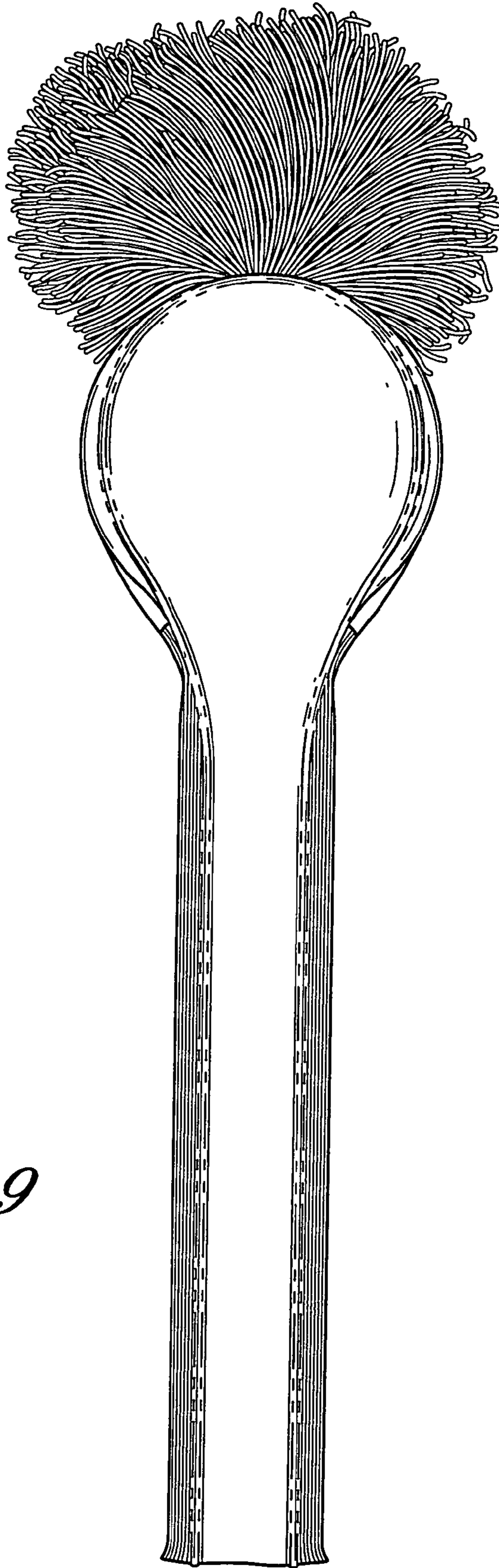

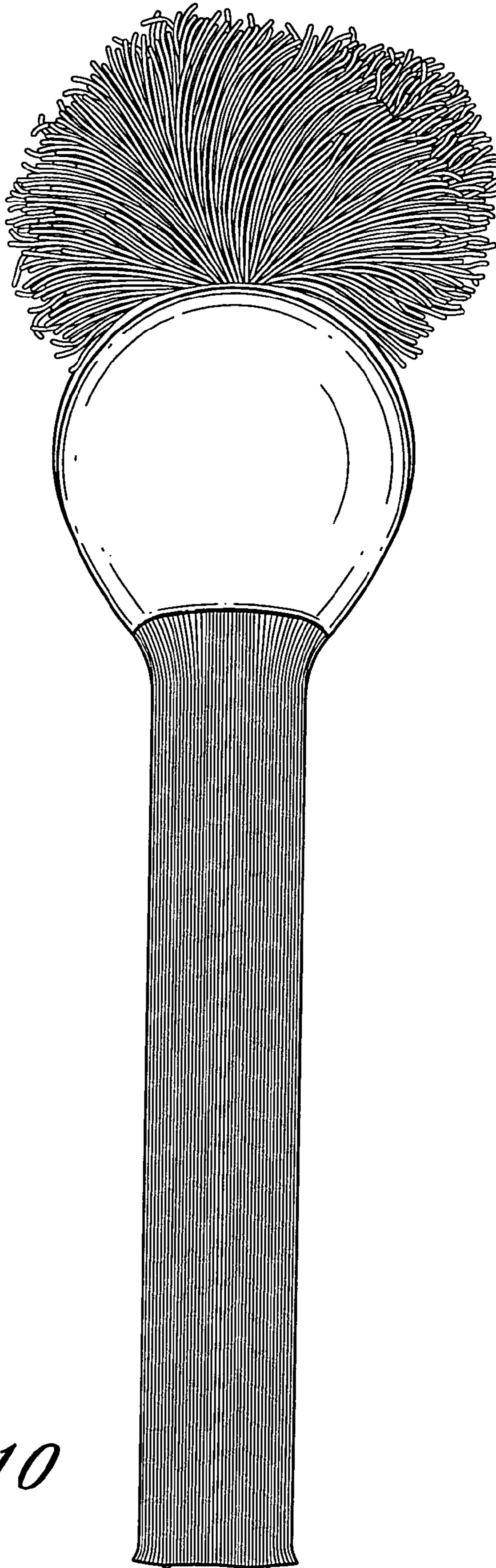

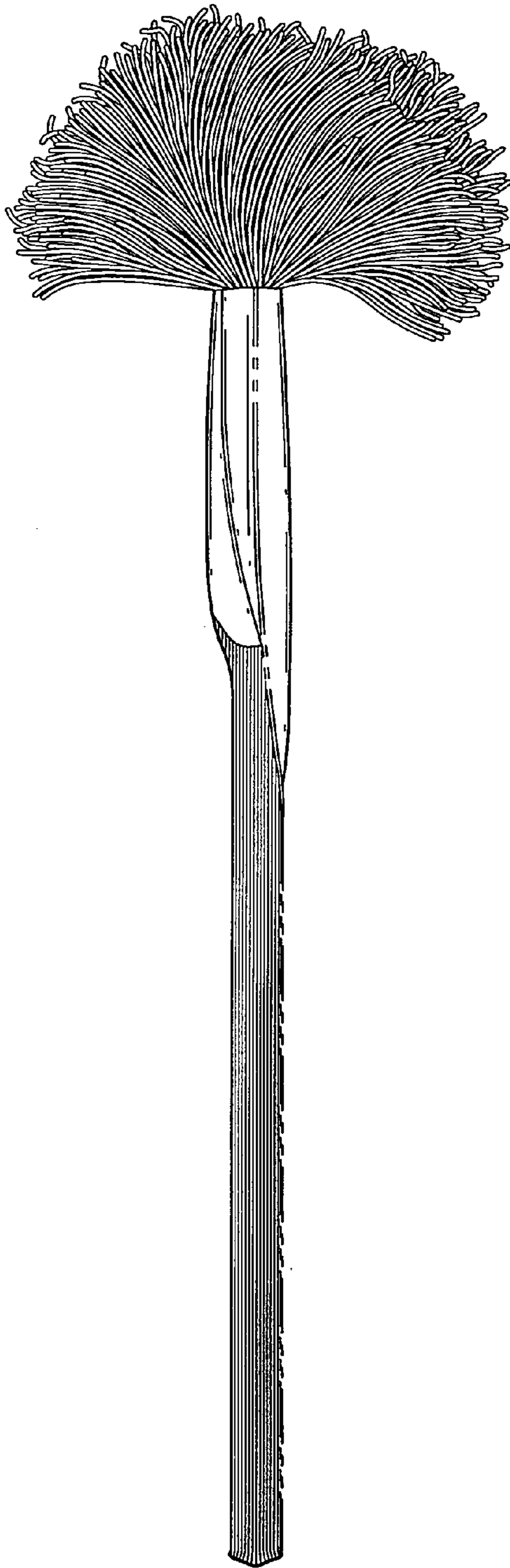

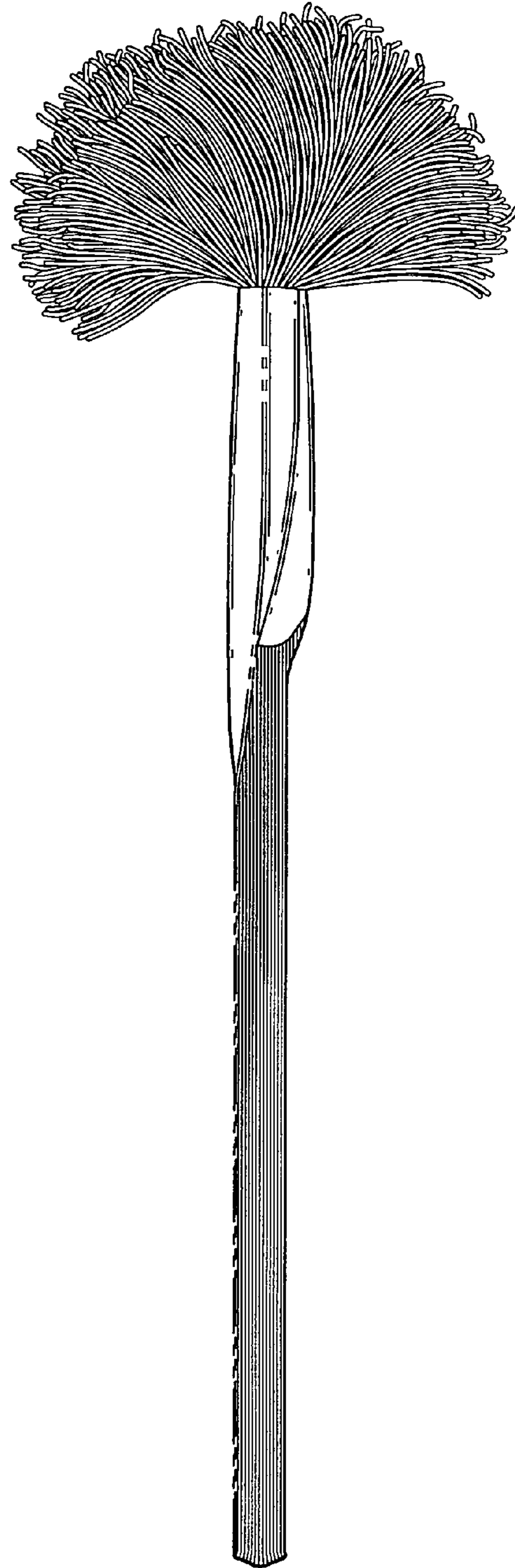

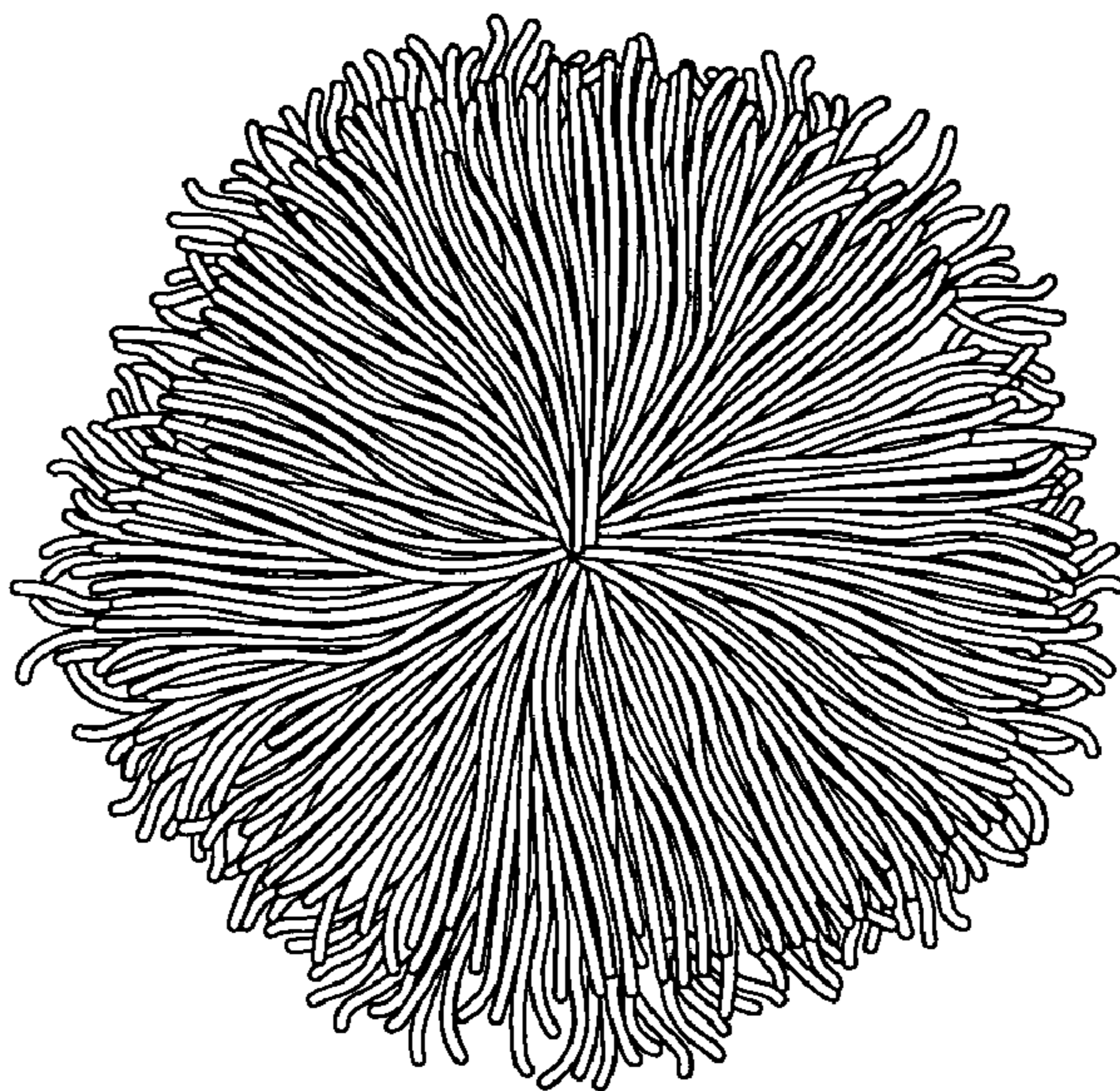

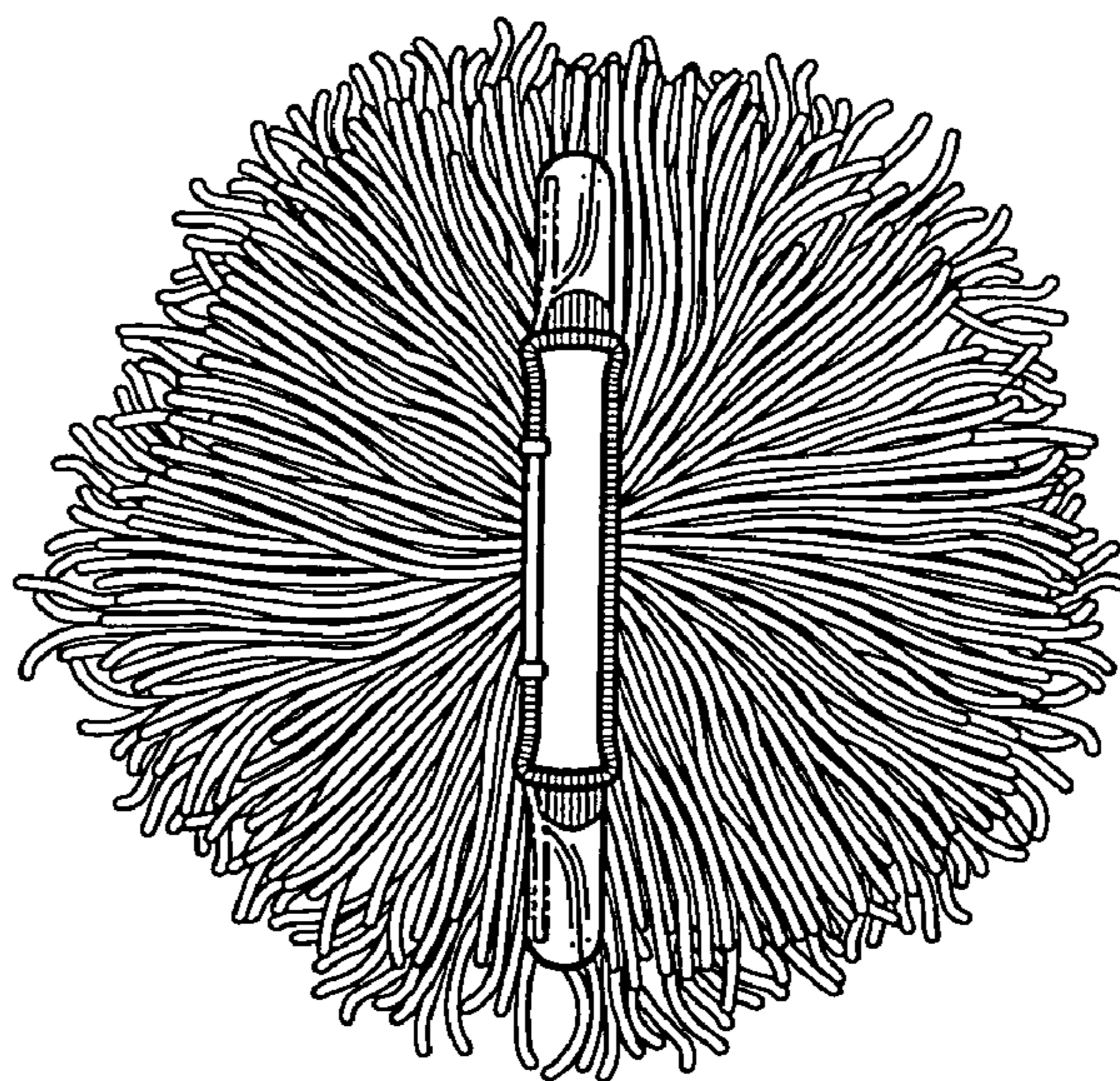
