(57) **CLAIM**

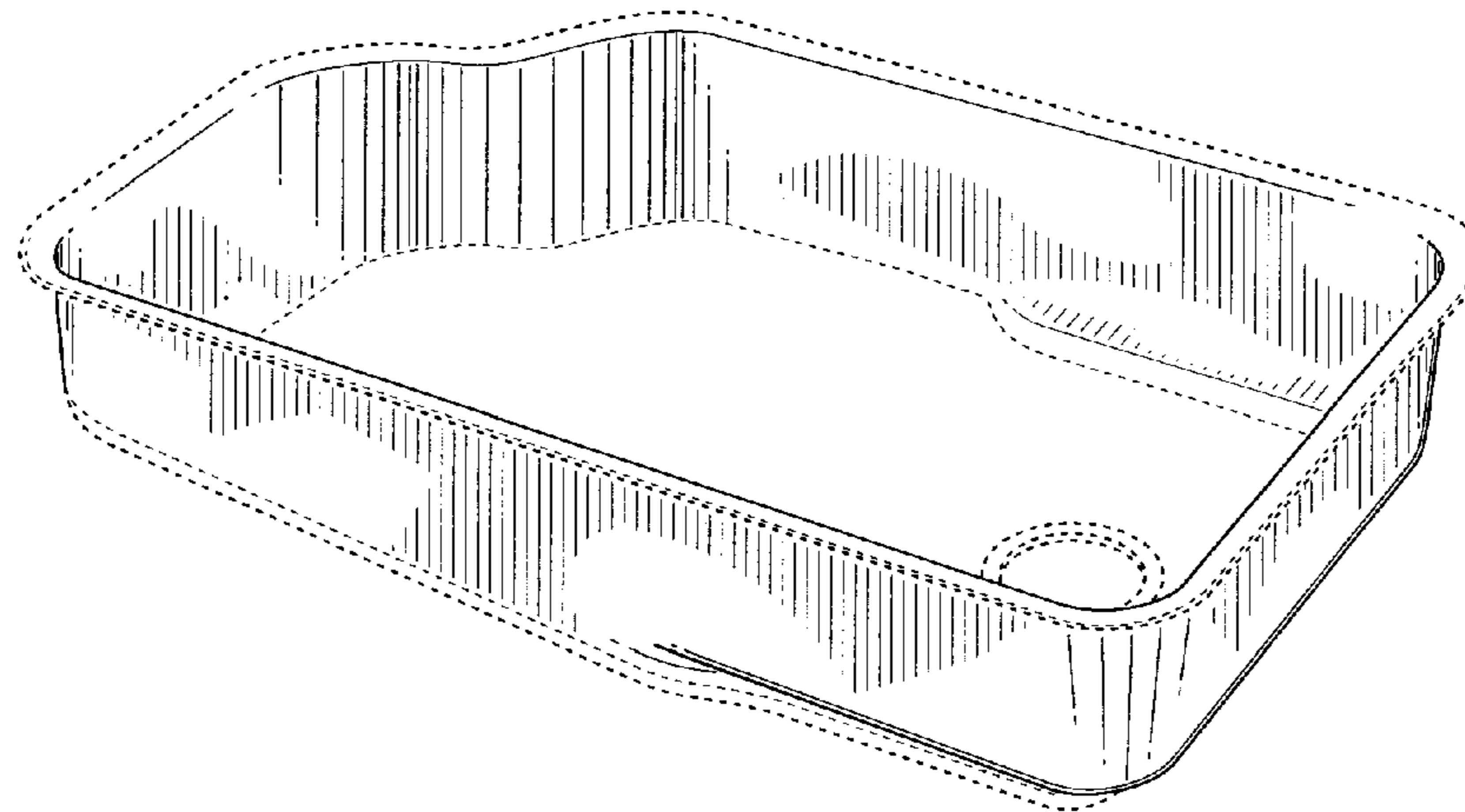
The ornamental design for a sink, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view taken from the top, front, and right side of a sink showing my new design;  
FIG. 2 is a top plan view of the sink shown in FIG. 1;  
FIG. 3 is a bottom view of the sink shown in FIG. 1;  
FIG. 4 is a front elevational view of the sink shown in FIG. 1;  
FIG. 5 is a rear elevational view of the sink shown in FIG. 1;  
FIG. 6 is a left elevational side view of the sink shown in FIG. 1; and,  
FIG. 7 is a right elevational side view of the sink shown in FIG. 1.

The broken lines are for illustration purposes only and form no part of the claimed design.

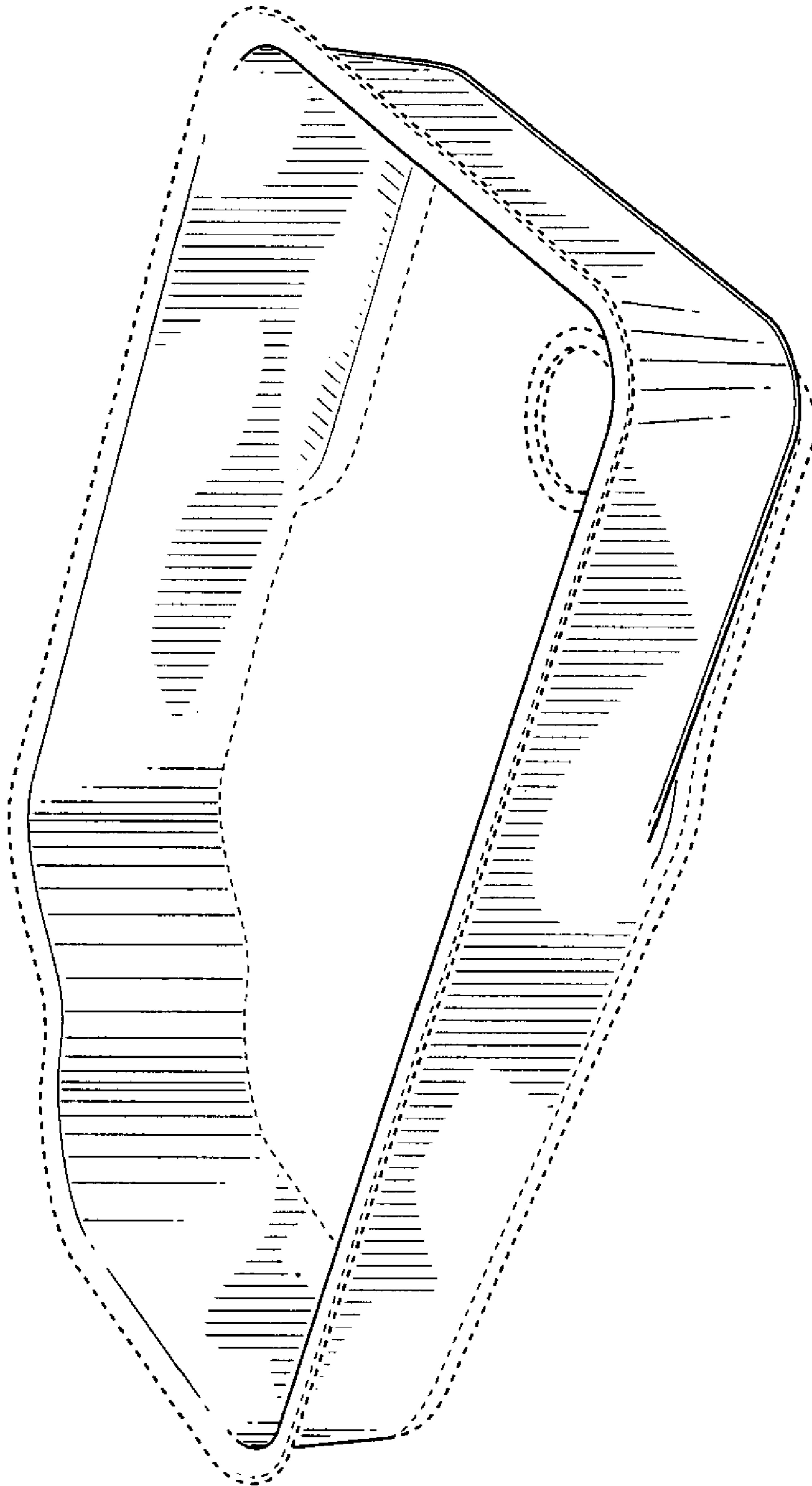

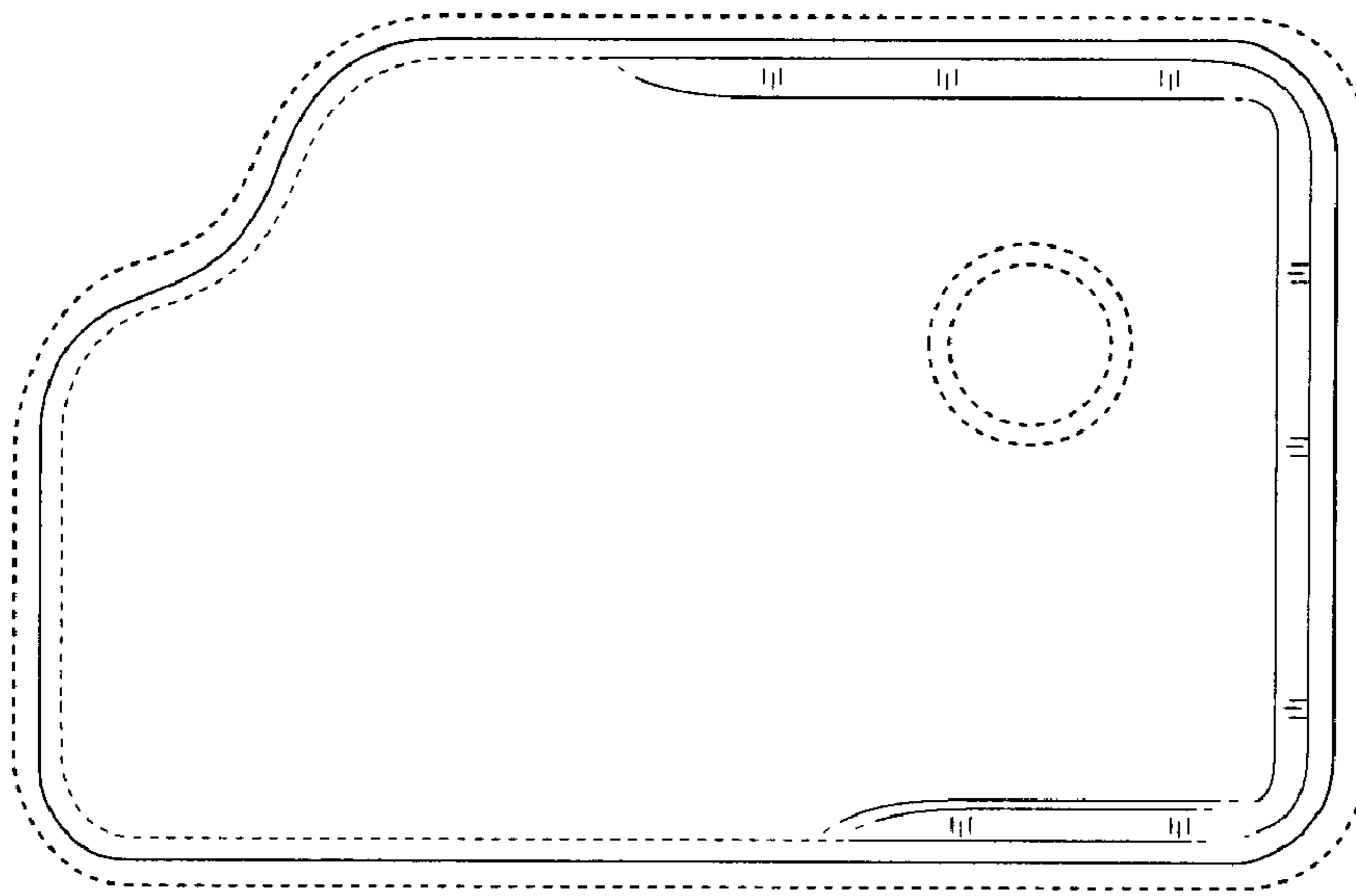

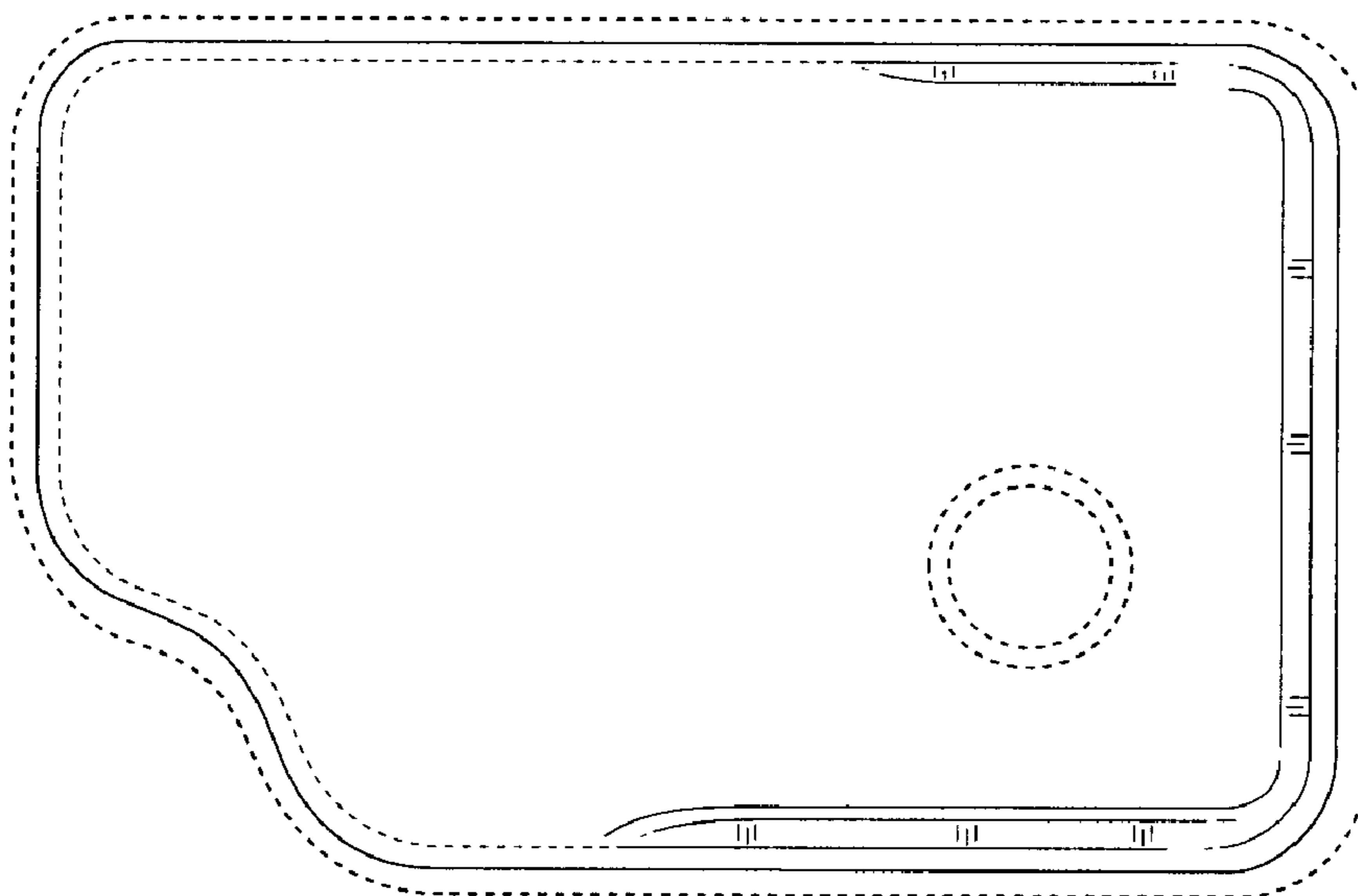

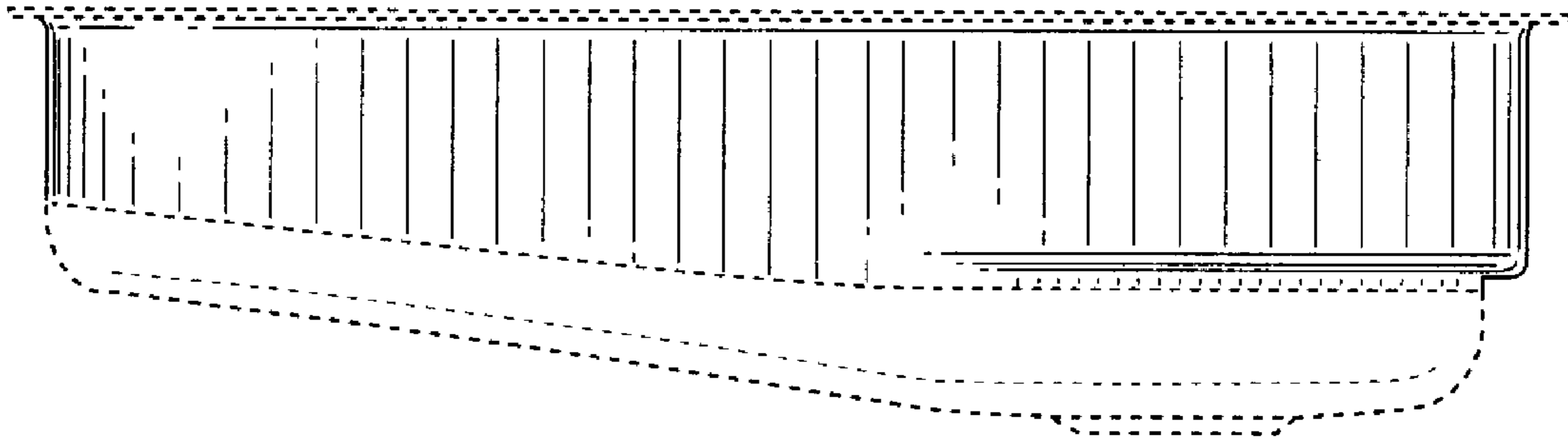

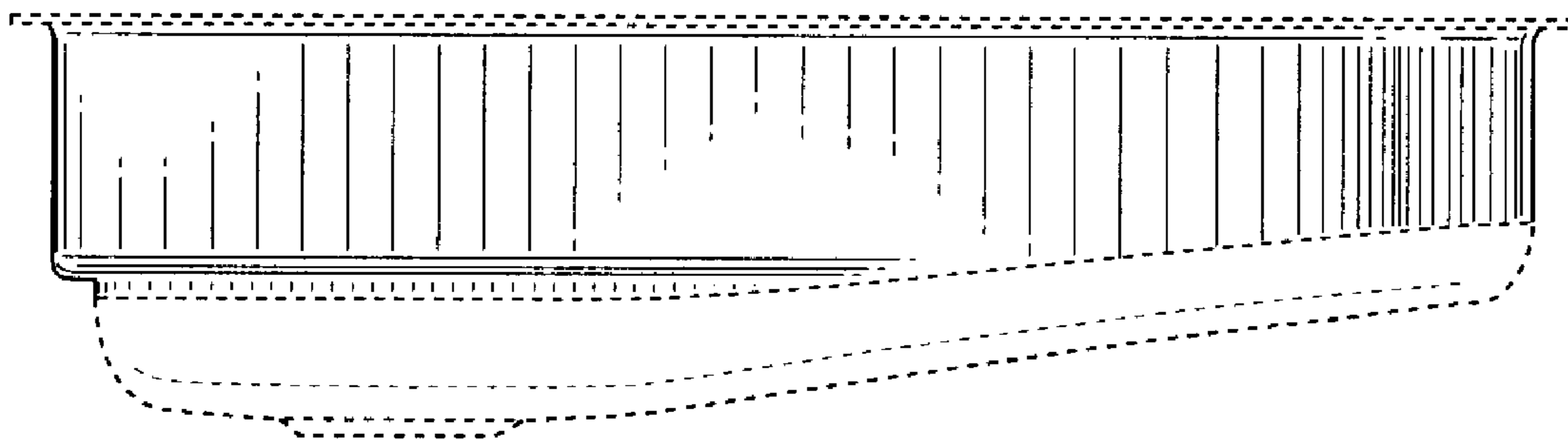

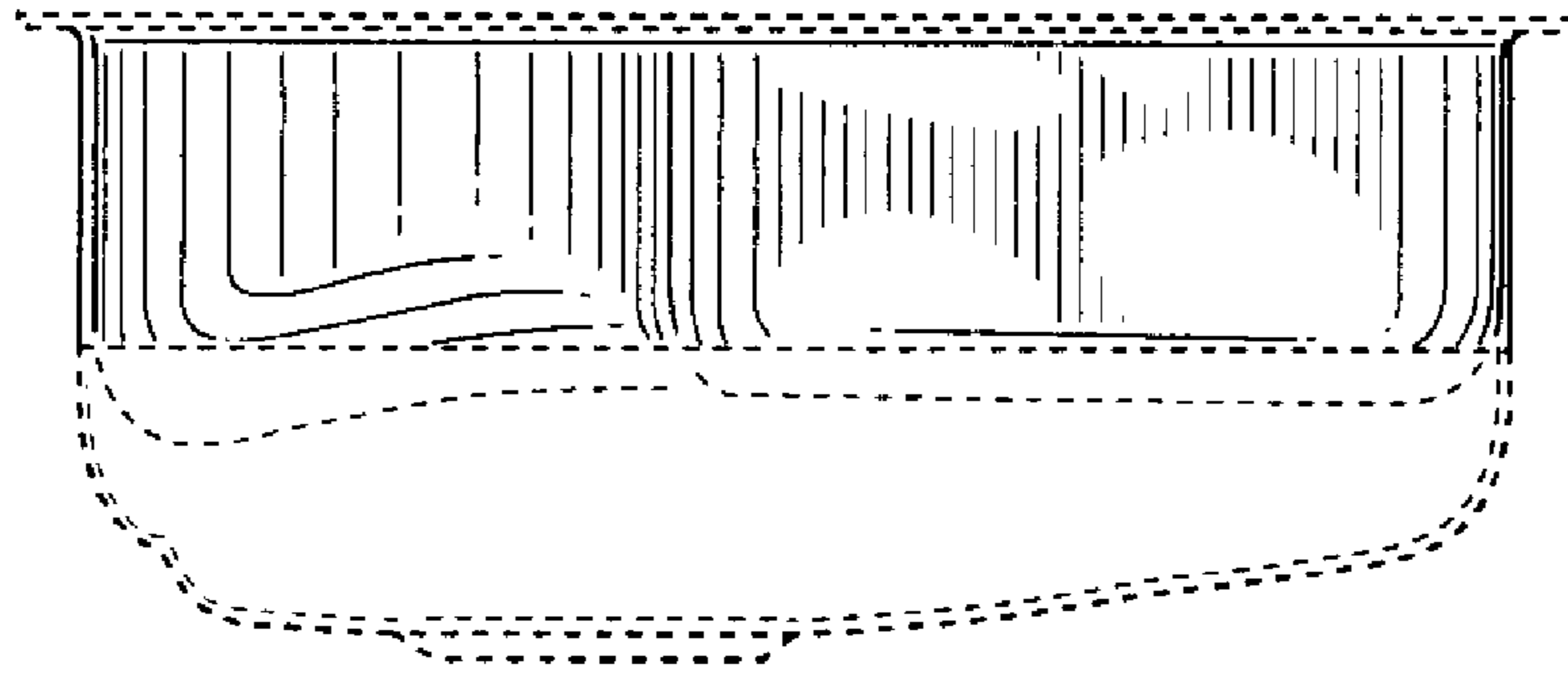

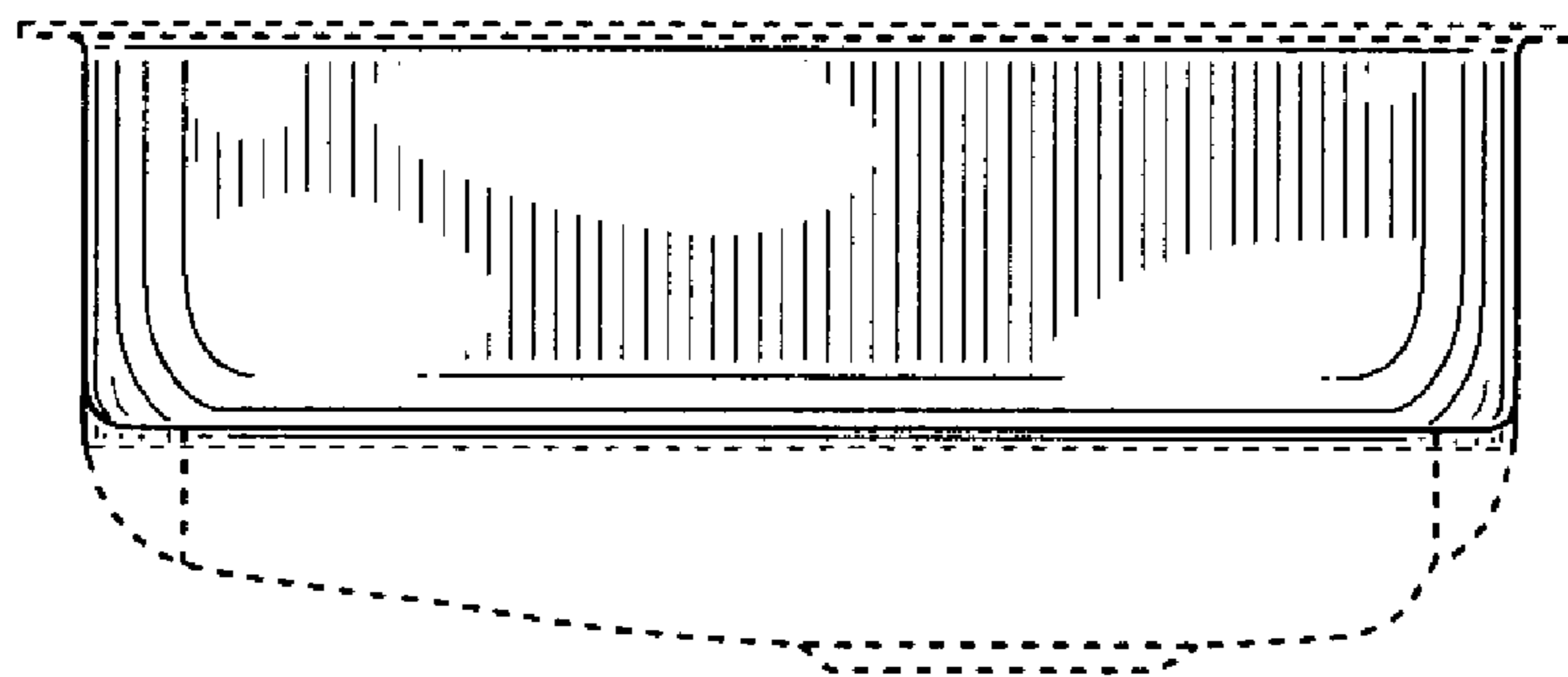
