FIG. 3 is a front view thereof;

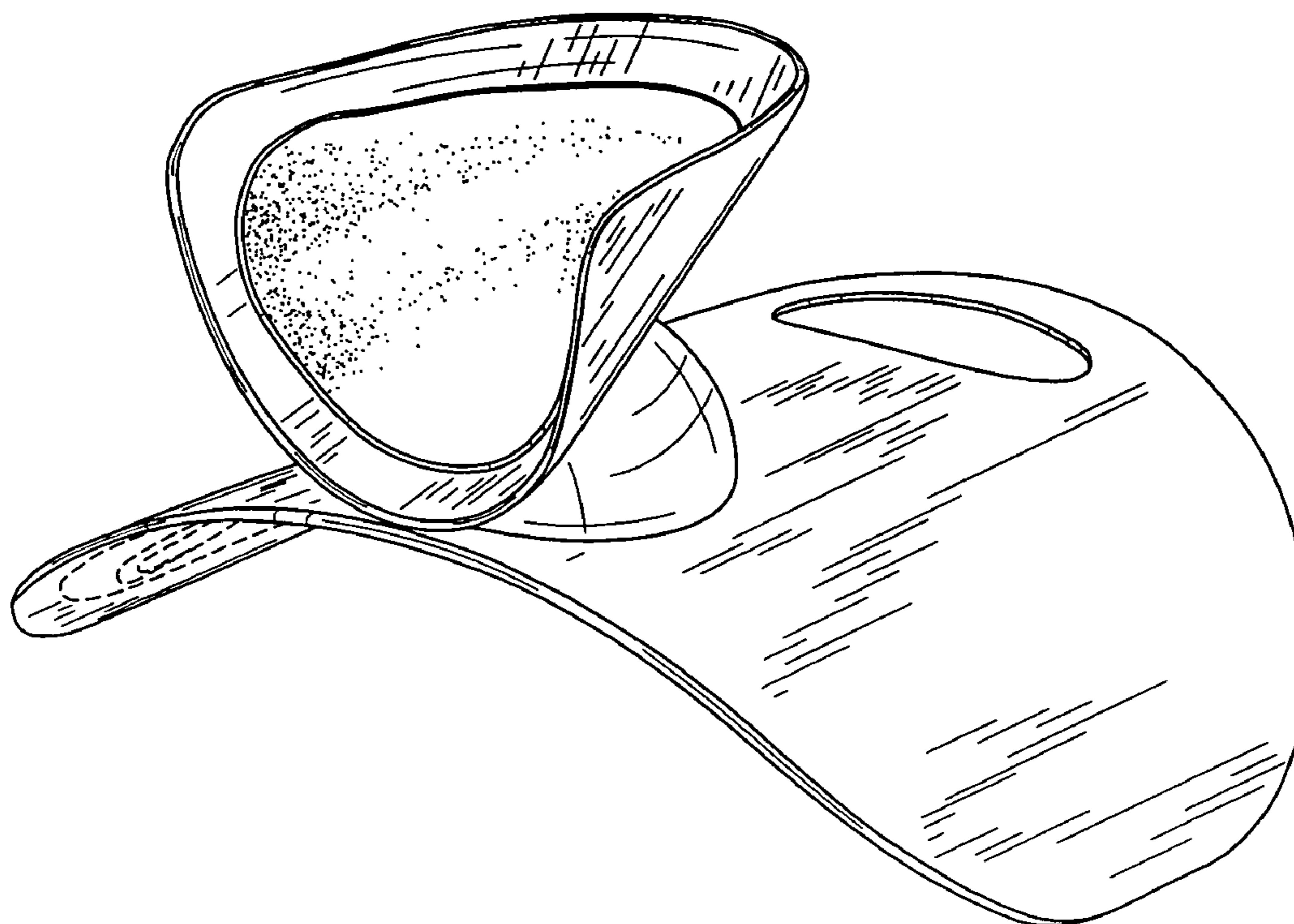
Fig. 4 is a right side view with the left side view being a mirror image thereof;

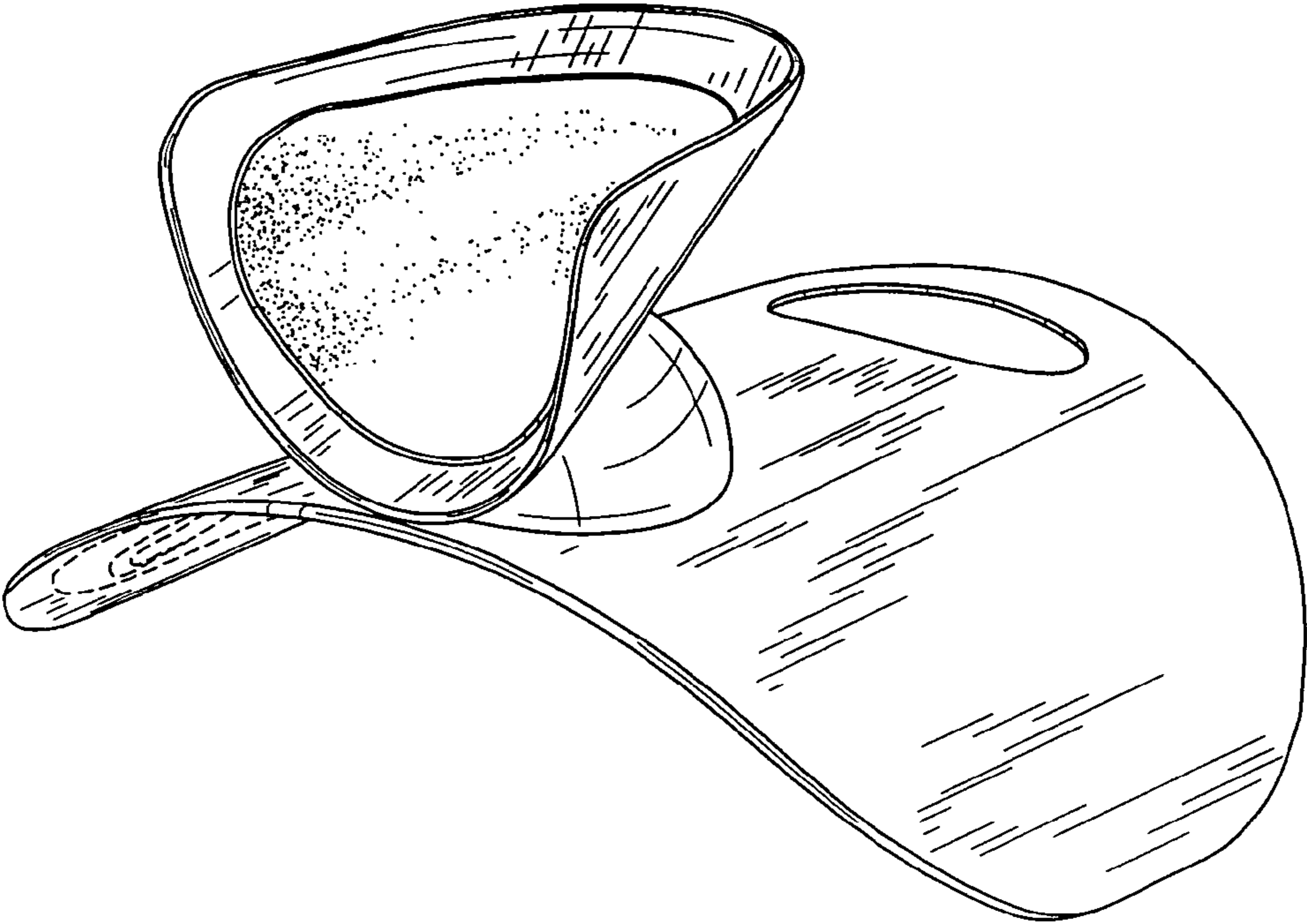

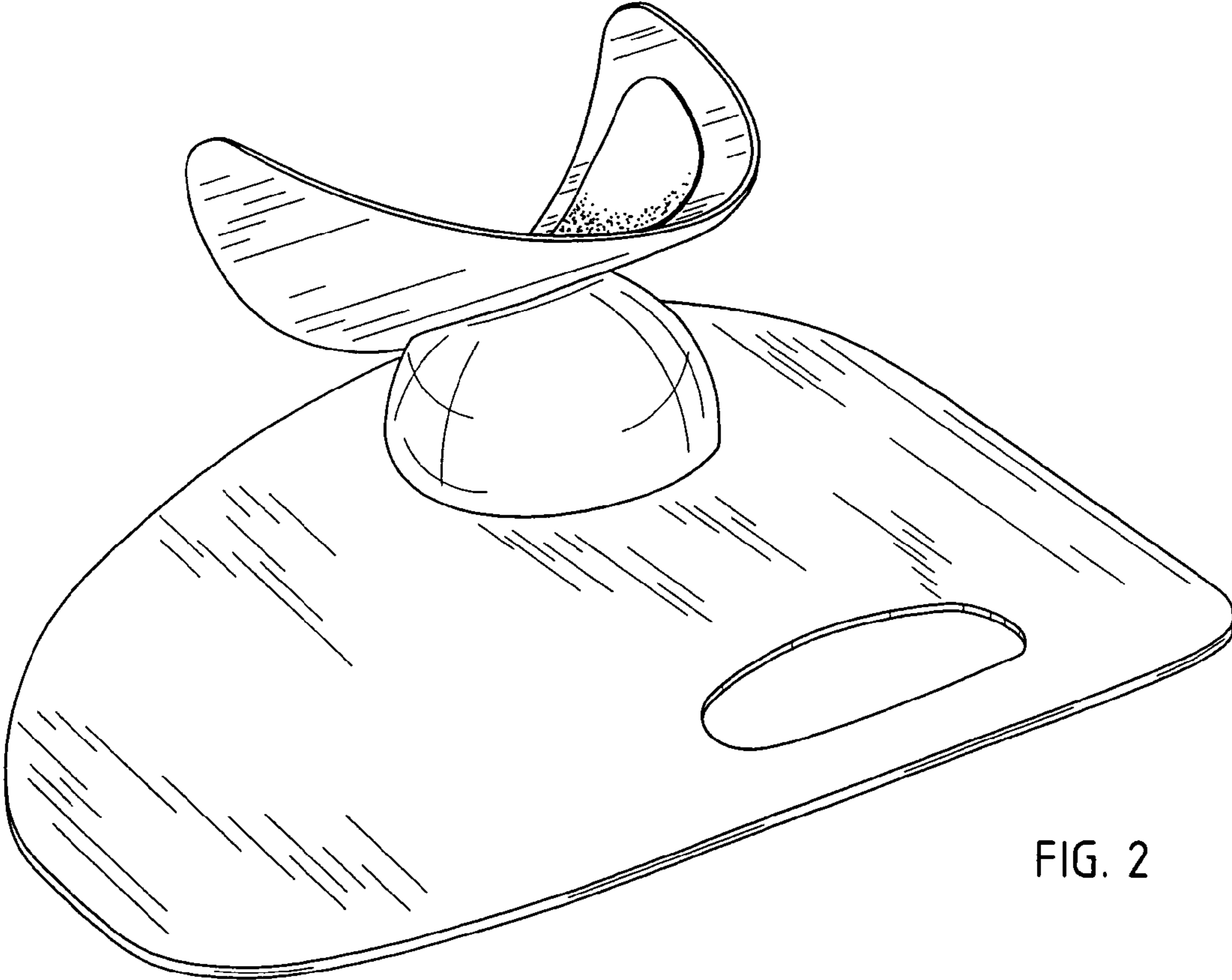

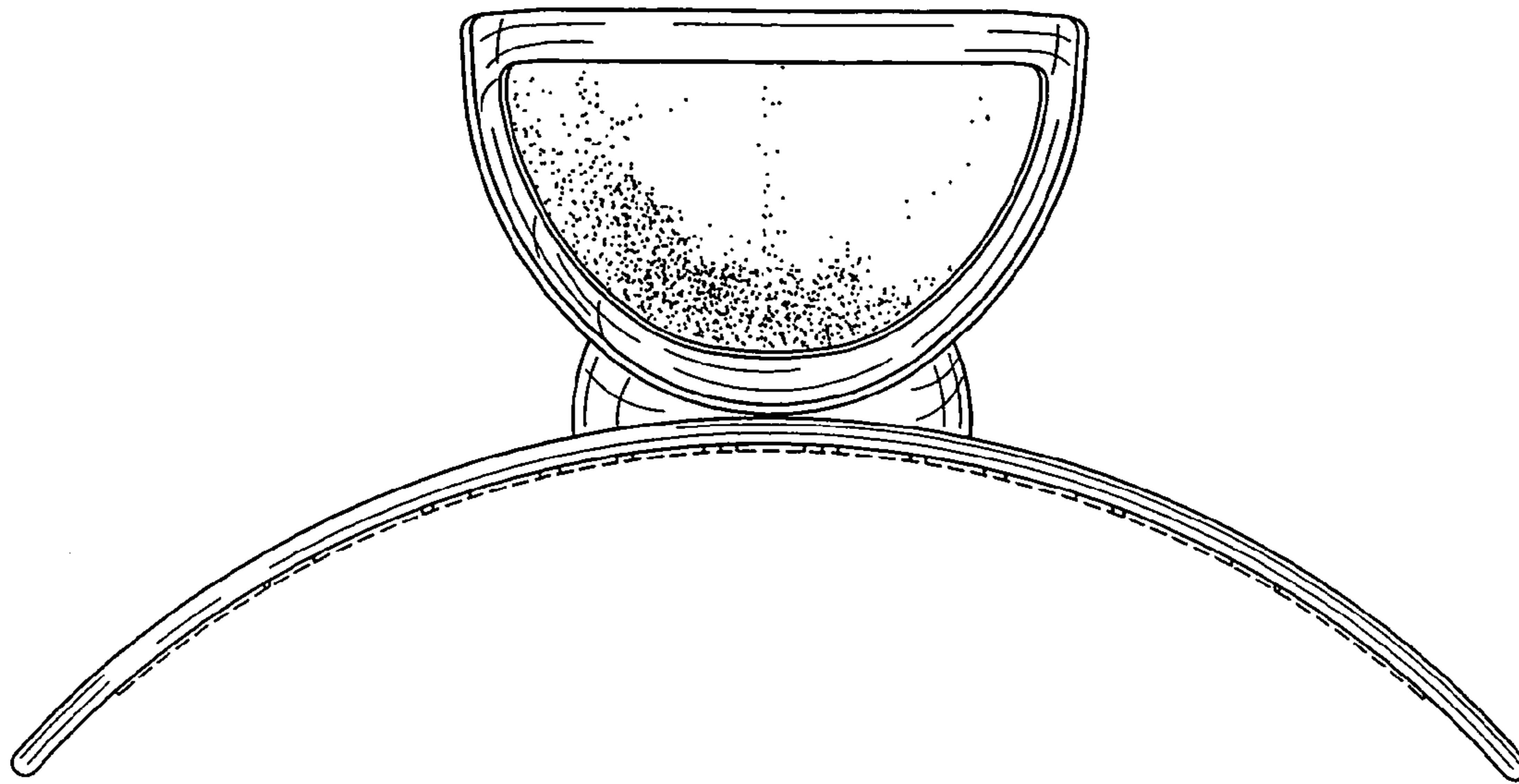

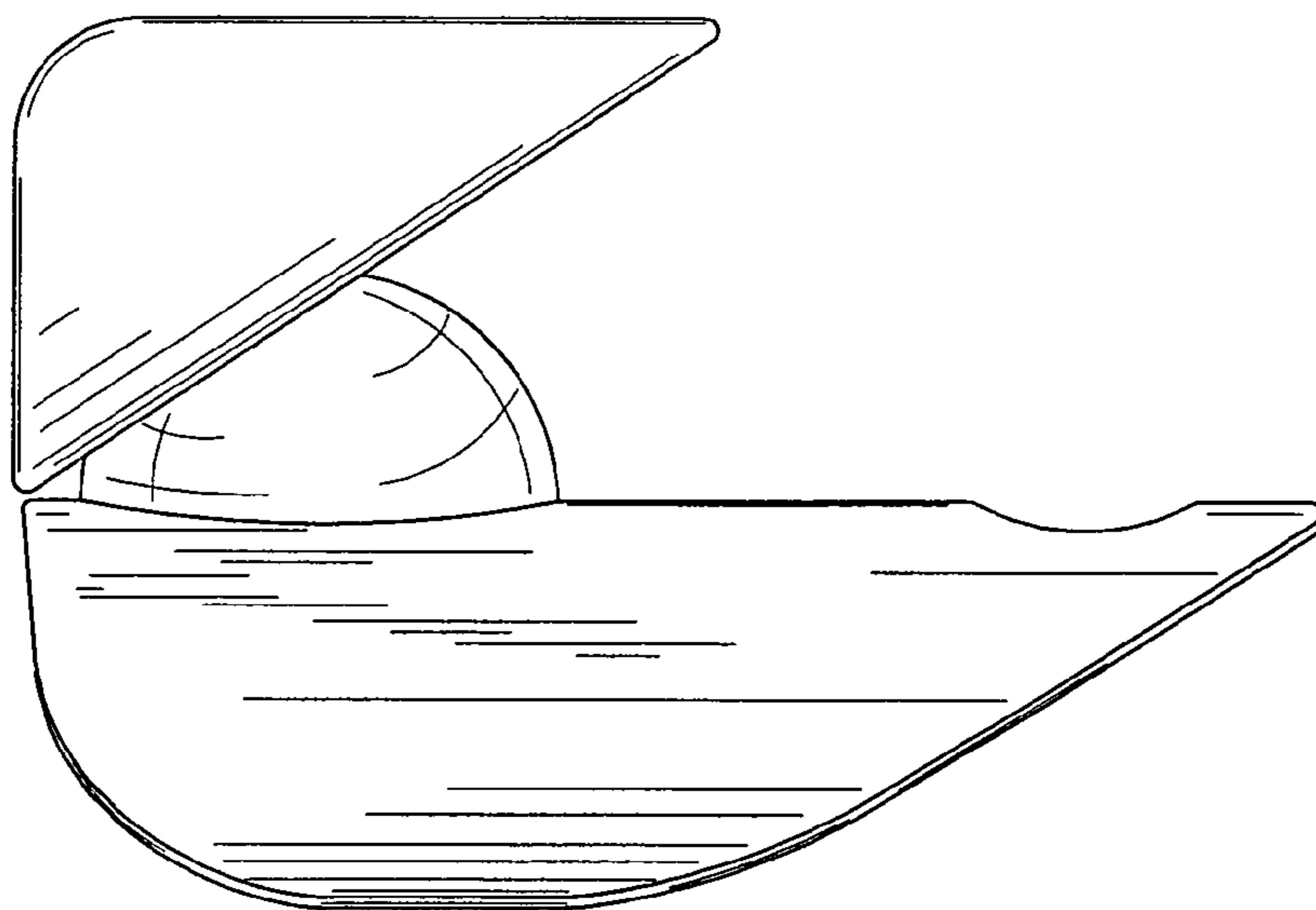

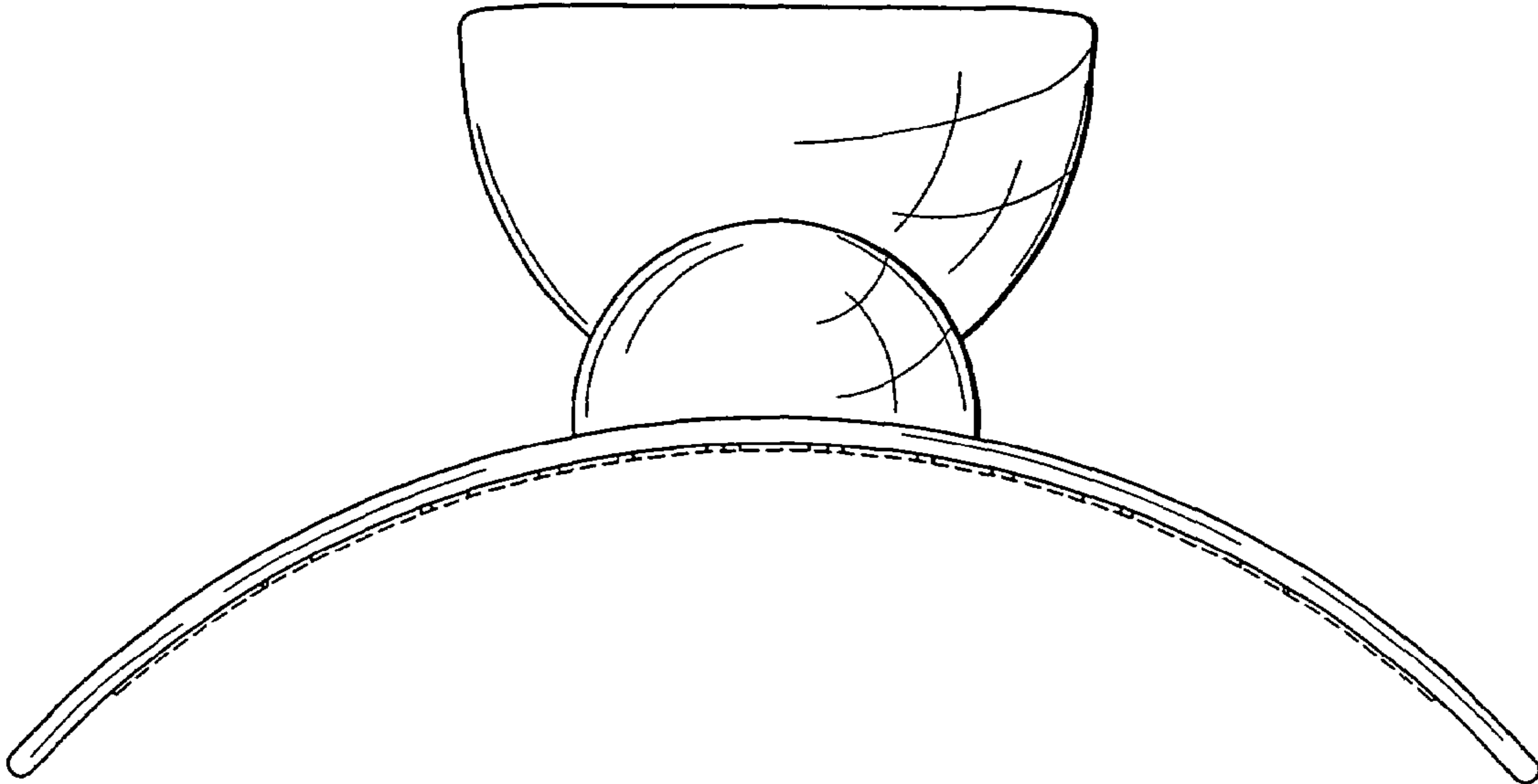

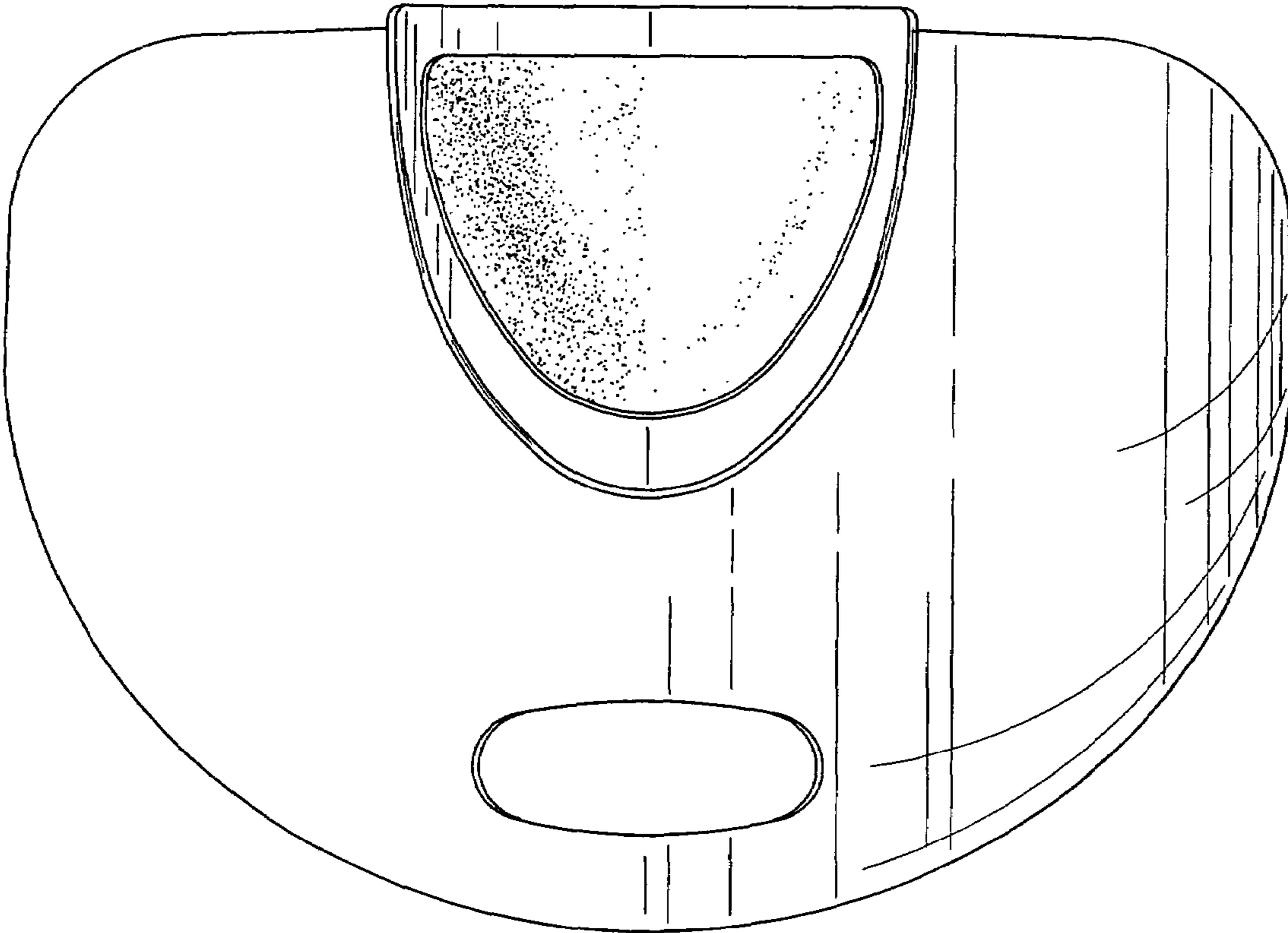

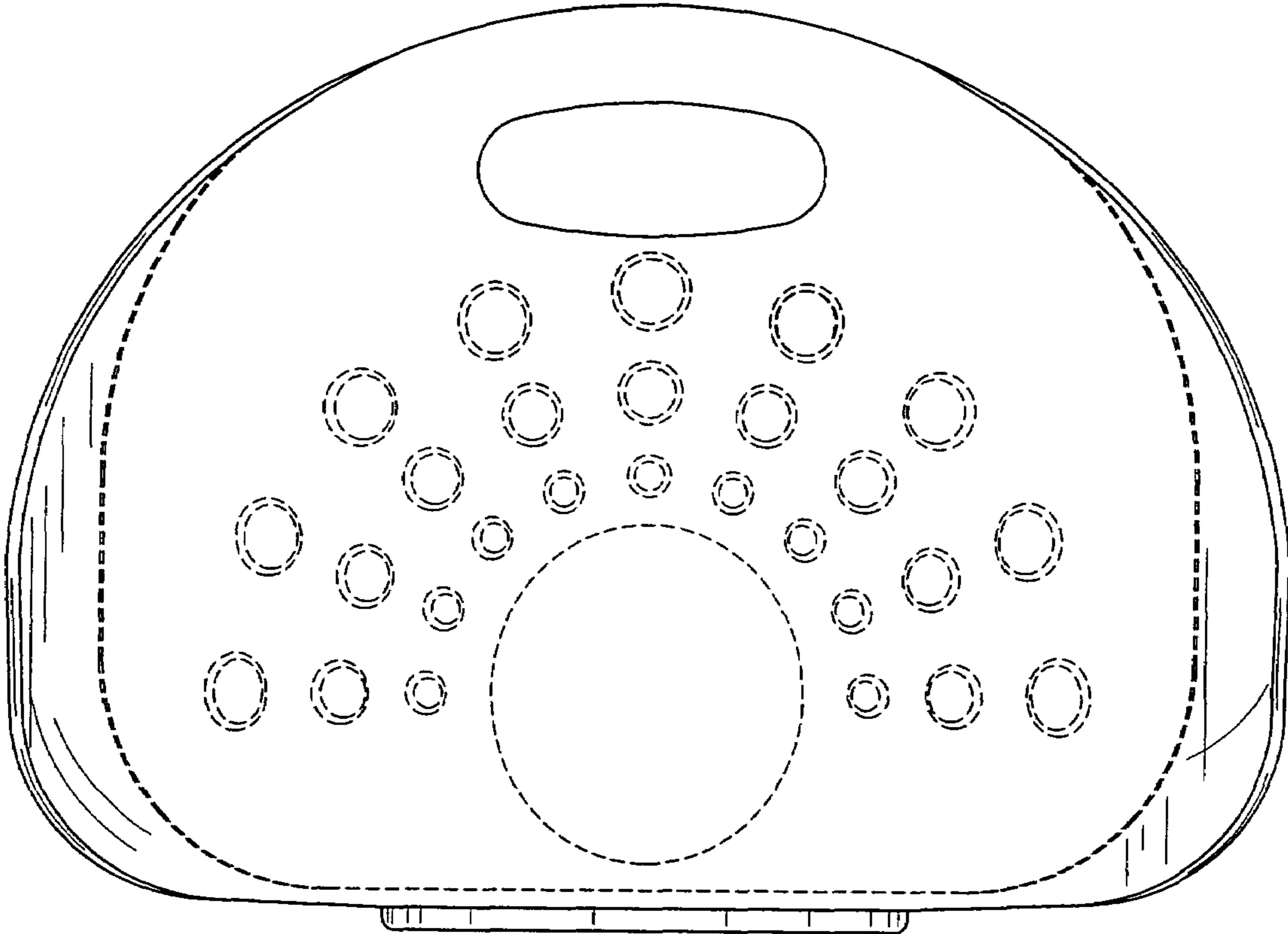
