The ornamental design for a flex light fixture with slip fit mount, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a flex light fixture with slip fit mount;

FIG. 2 is a front view of the flex light of FIG. 1;

FIG. 3 is a left side view of the flex light of FIG. 1;

FIG. 4 is a top view of the flex light of FIG. 1;

FIG. 5 is a bottom view of the flex light of FIG. 1;

FIG. 6 is a right view of the flex light of FIG. 1; and,

FIG. 7 is a back view of the flex light of FIG. 1.

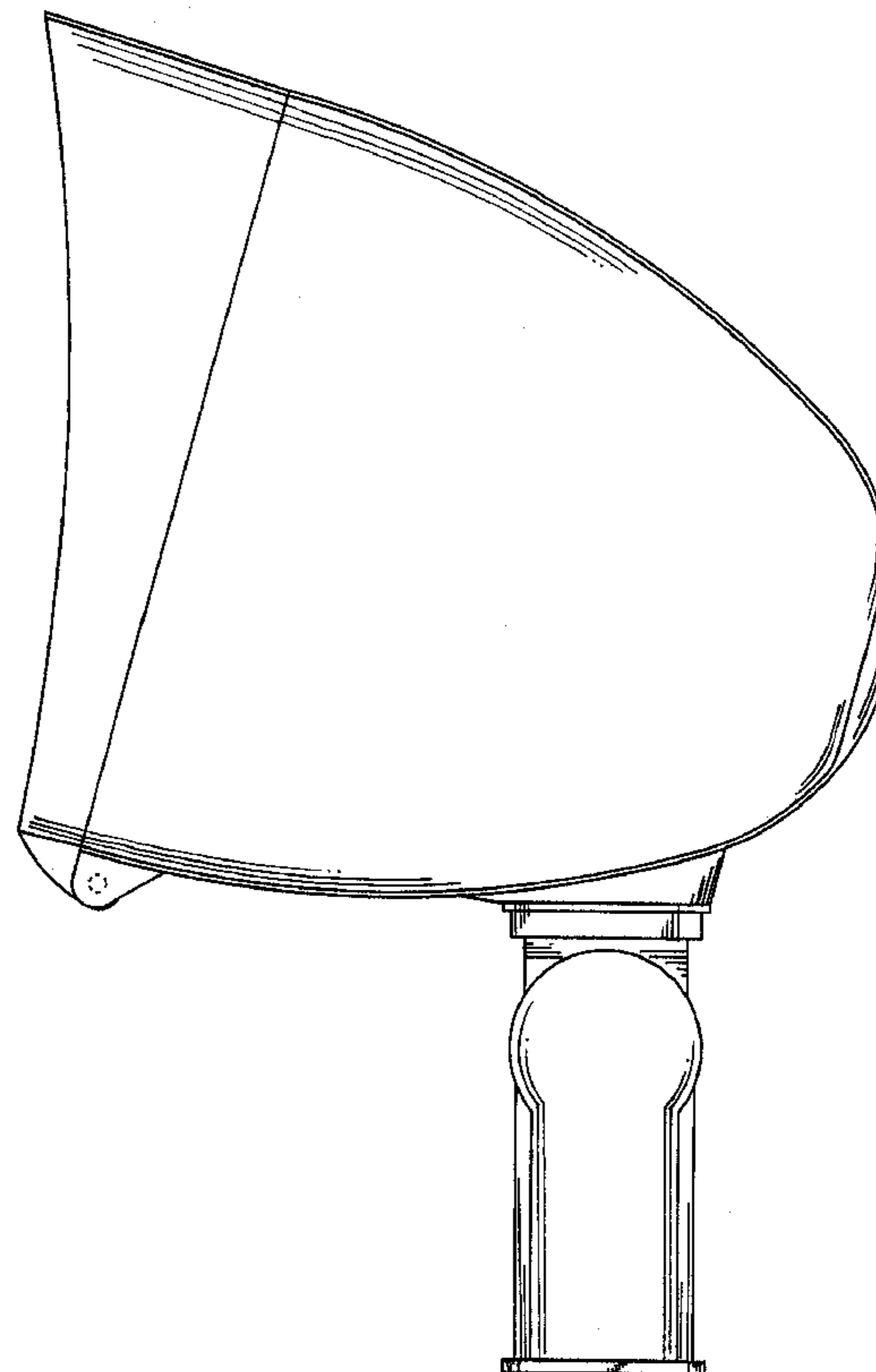
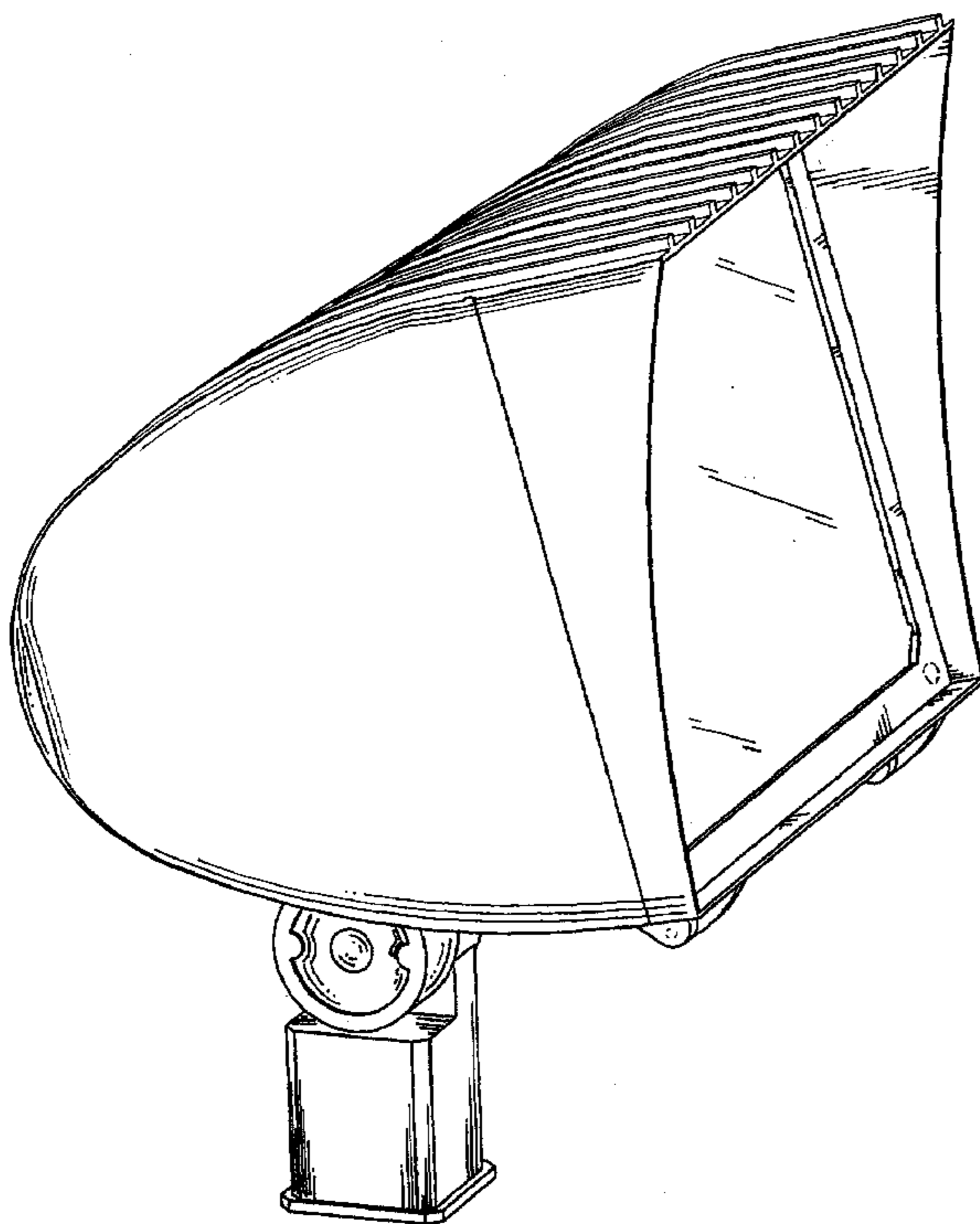

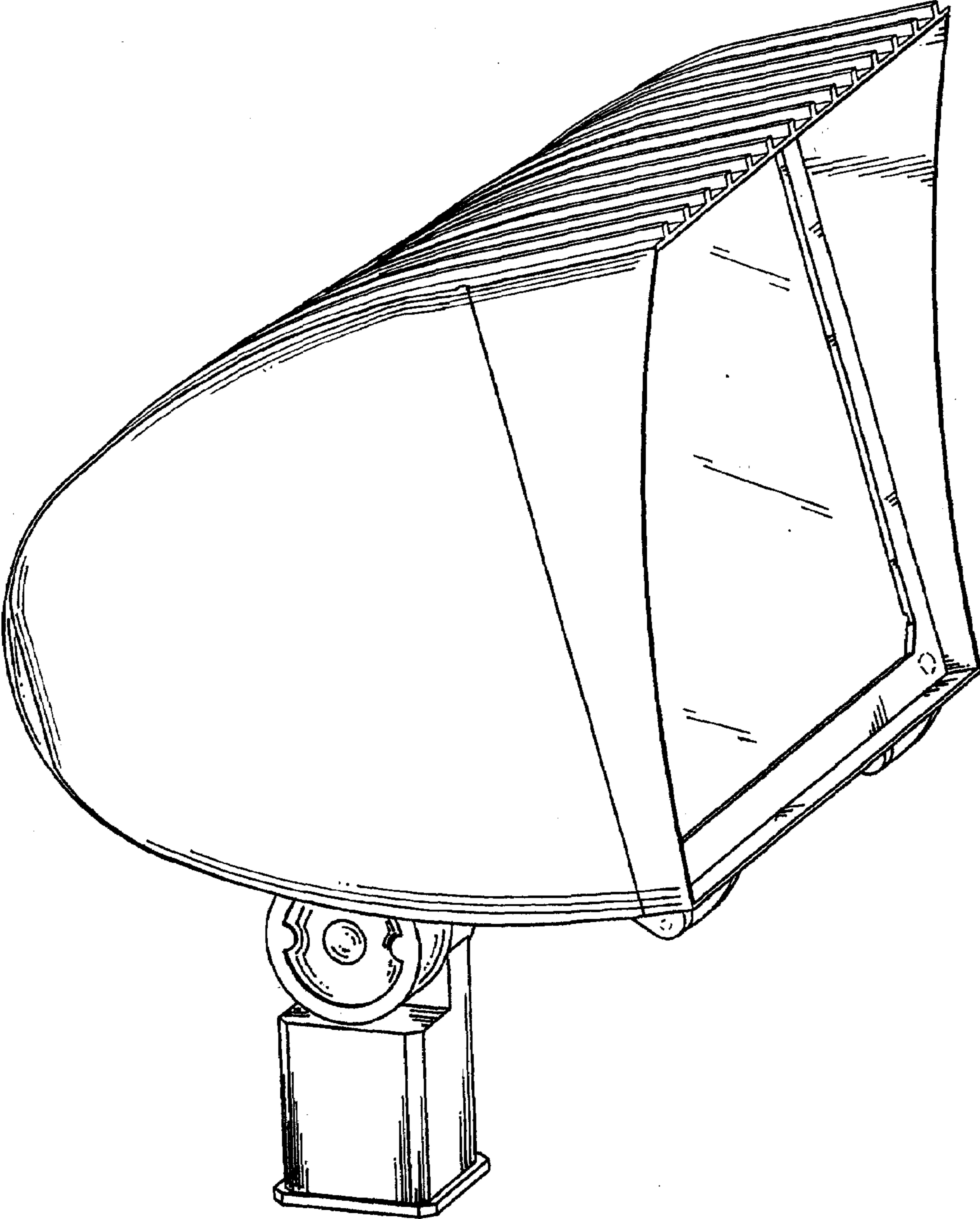

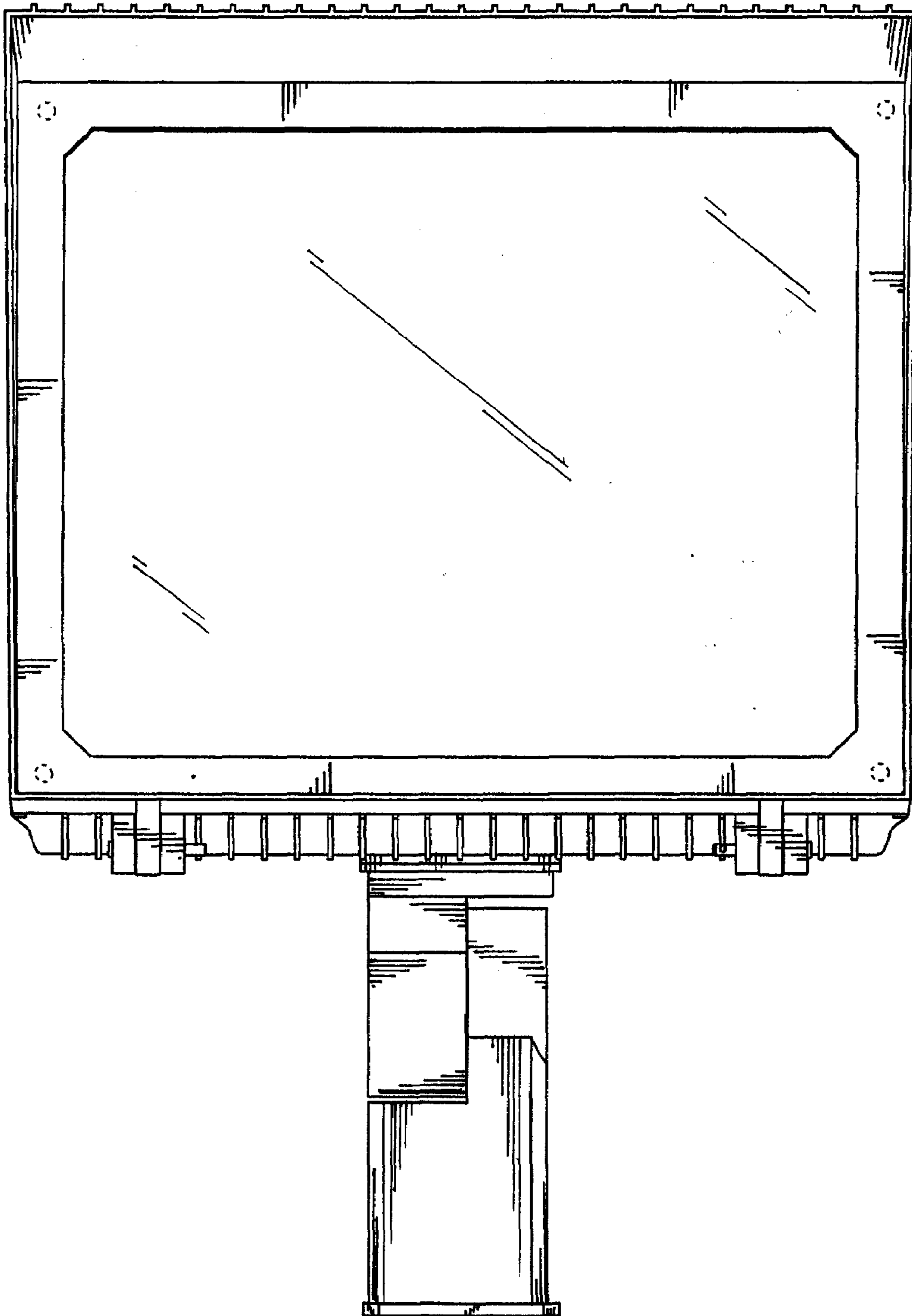
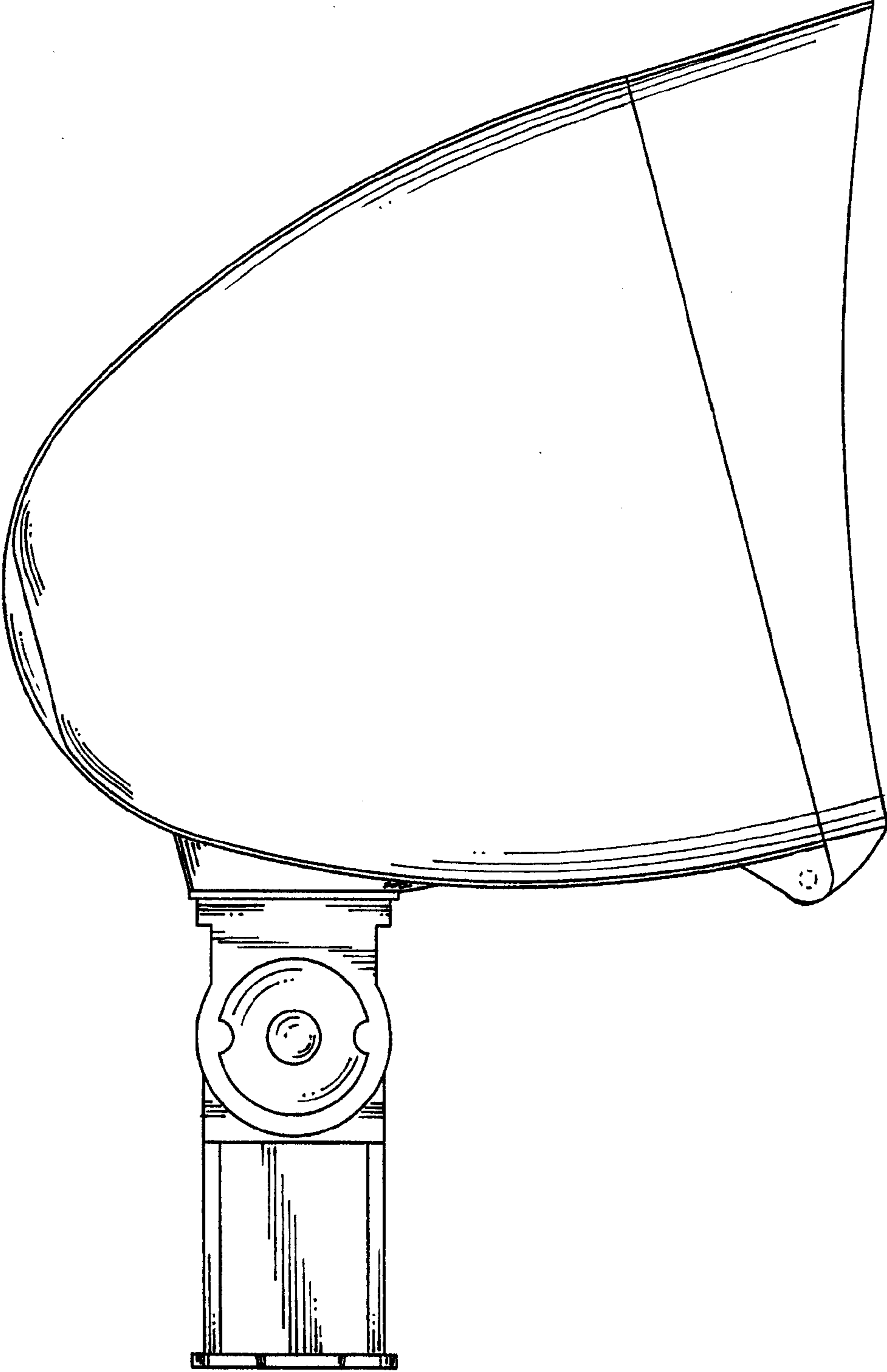

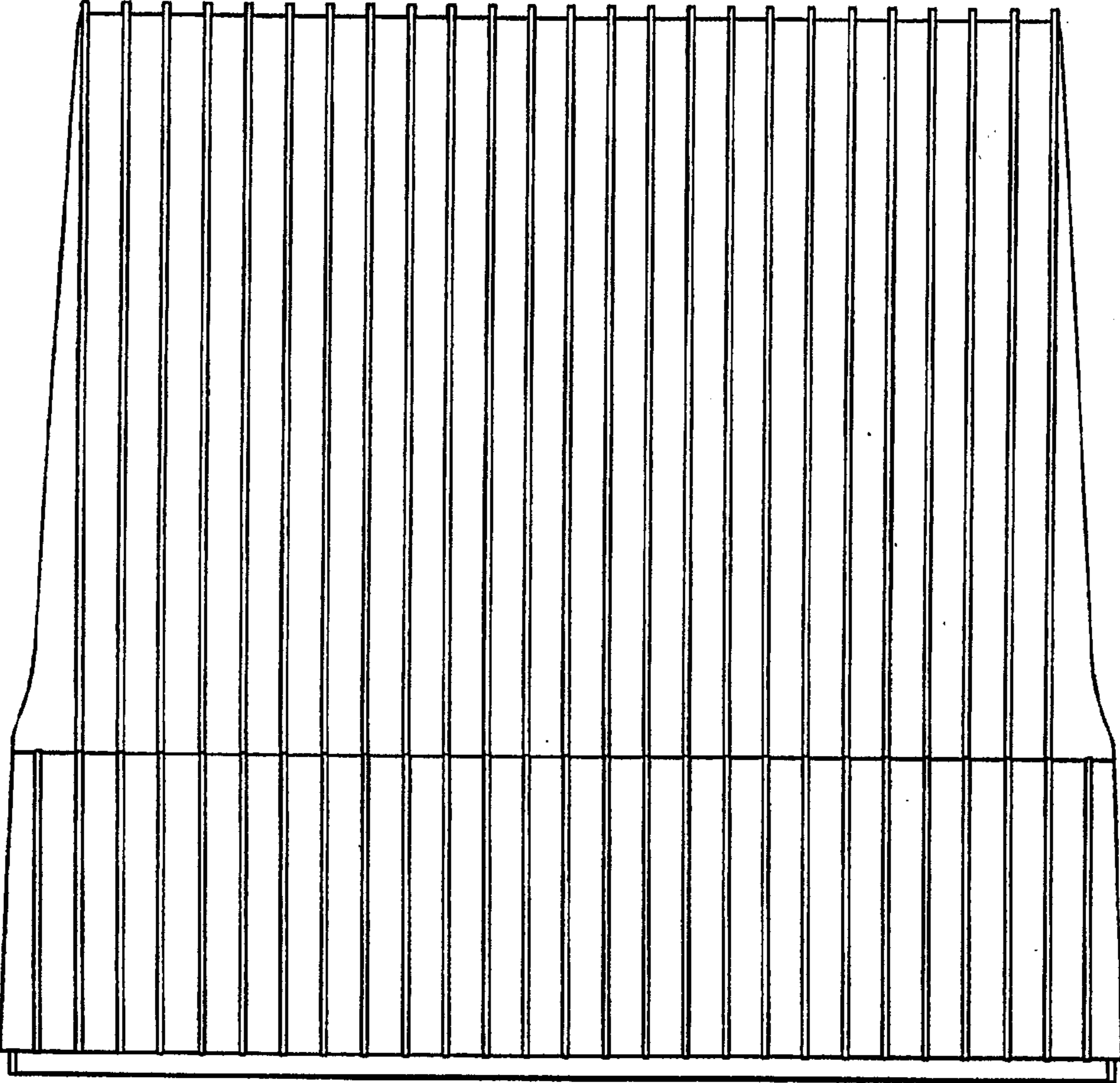

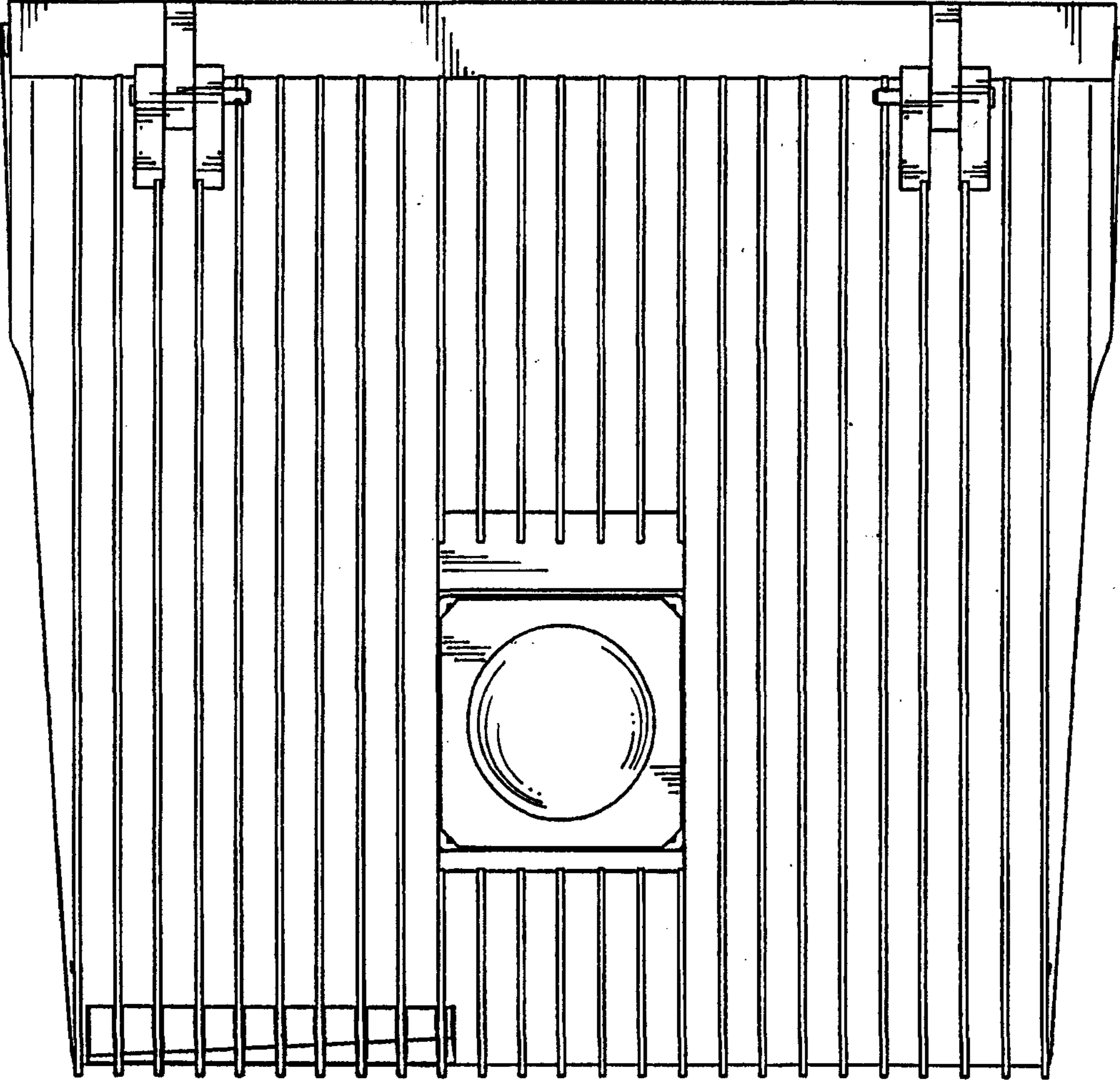

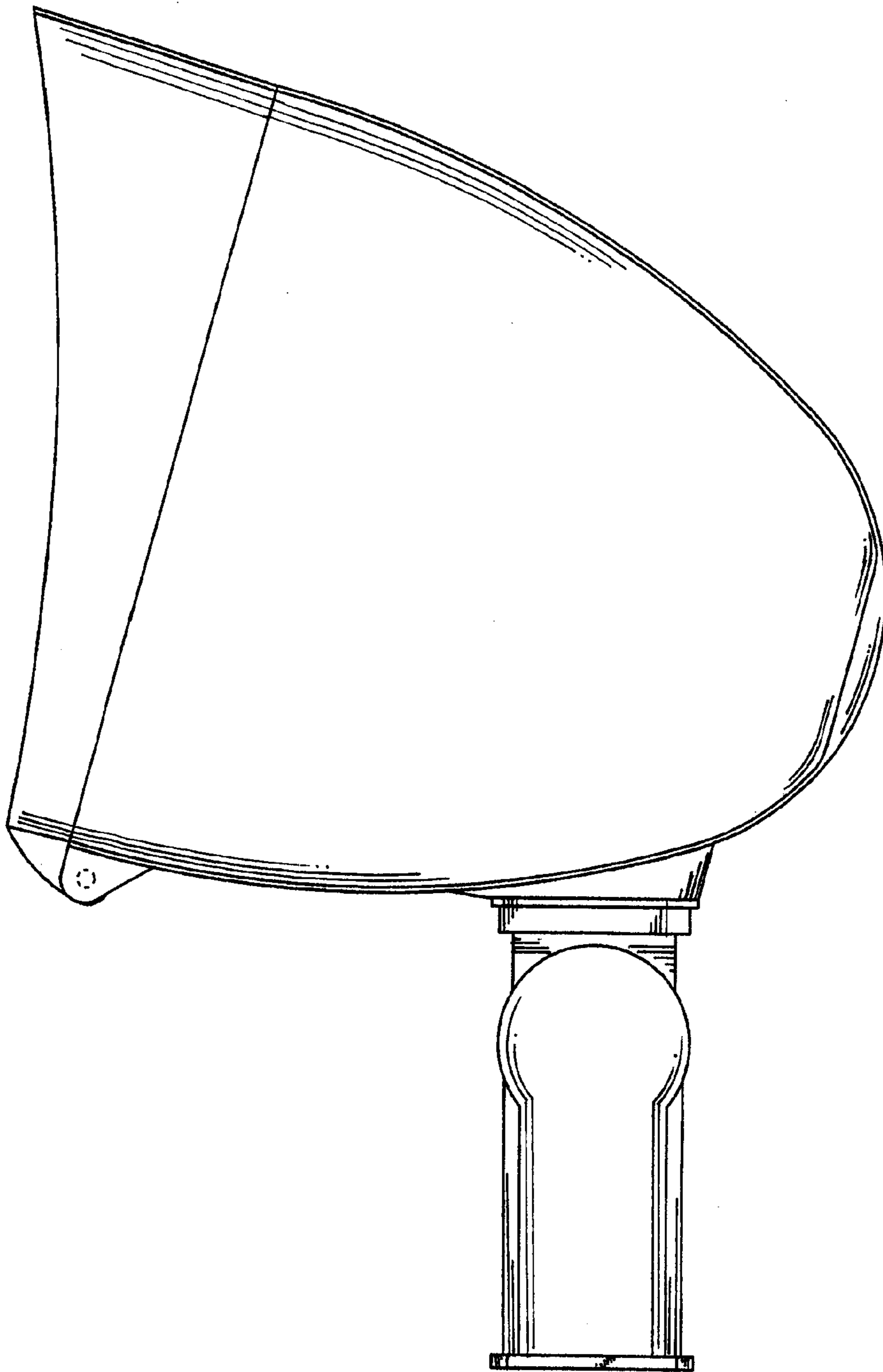
