(57) **CLAIM**

What is claimed is the ornamental design for a compact, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a new design for a compact;

FIG. 2 is a front elevation view of the compact shown in FIG. 1;

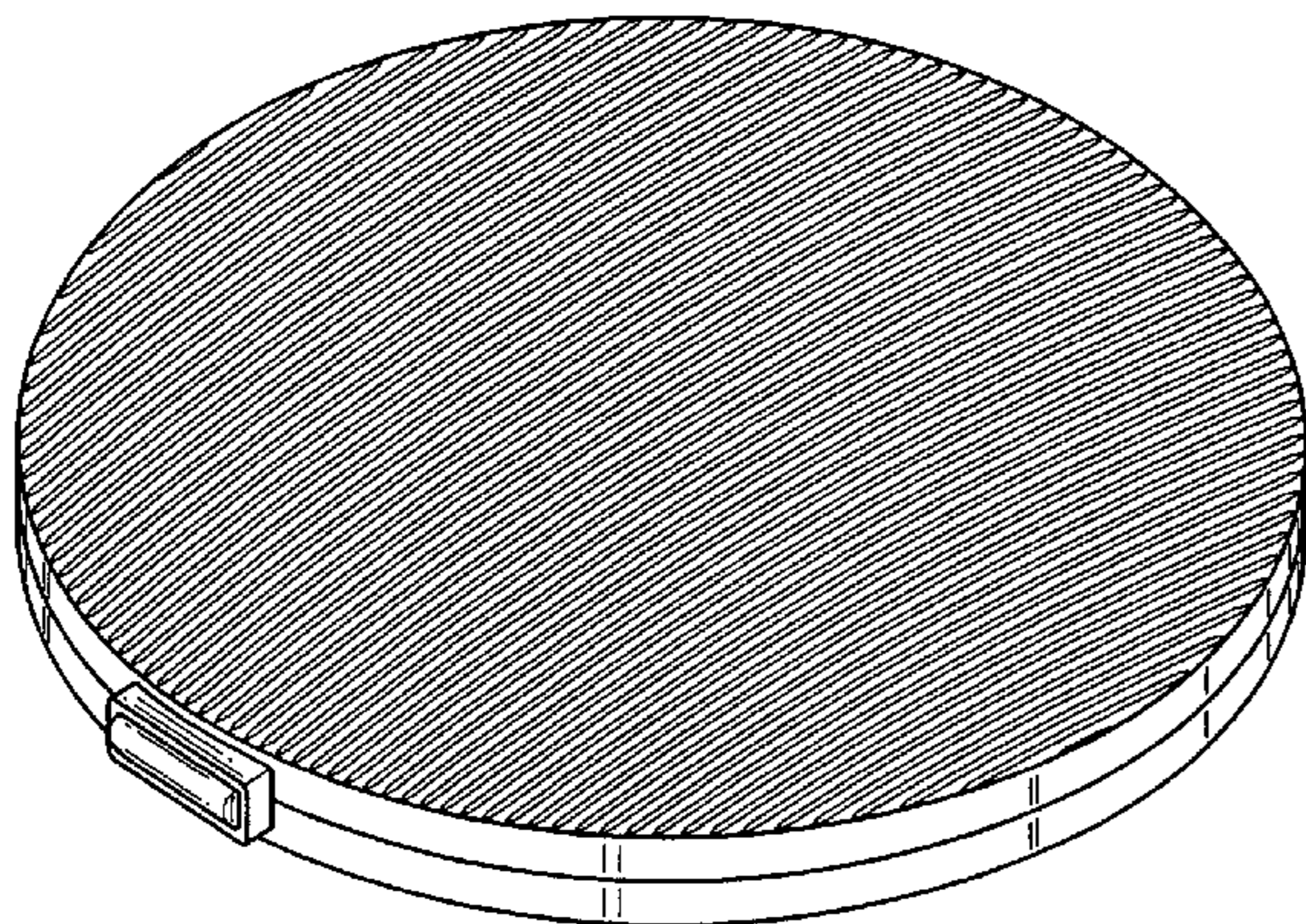
FIG. 3 is a right side elevation view of the compact shown in FIG. 1, a left side elevation view being a mirror image thereof;

FIG. 4 is a top plan view of the compact shown in FIG. 1;

FIG. 5 is a bottom plan view of the compact shown in FIG. 1; and,

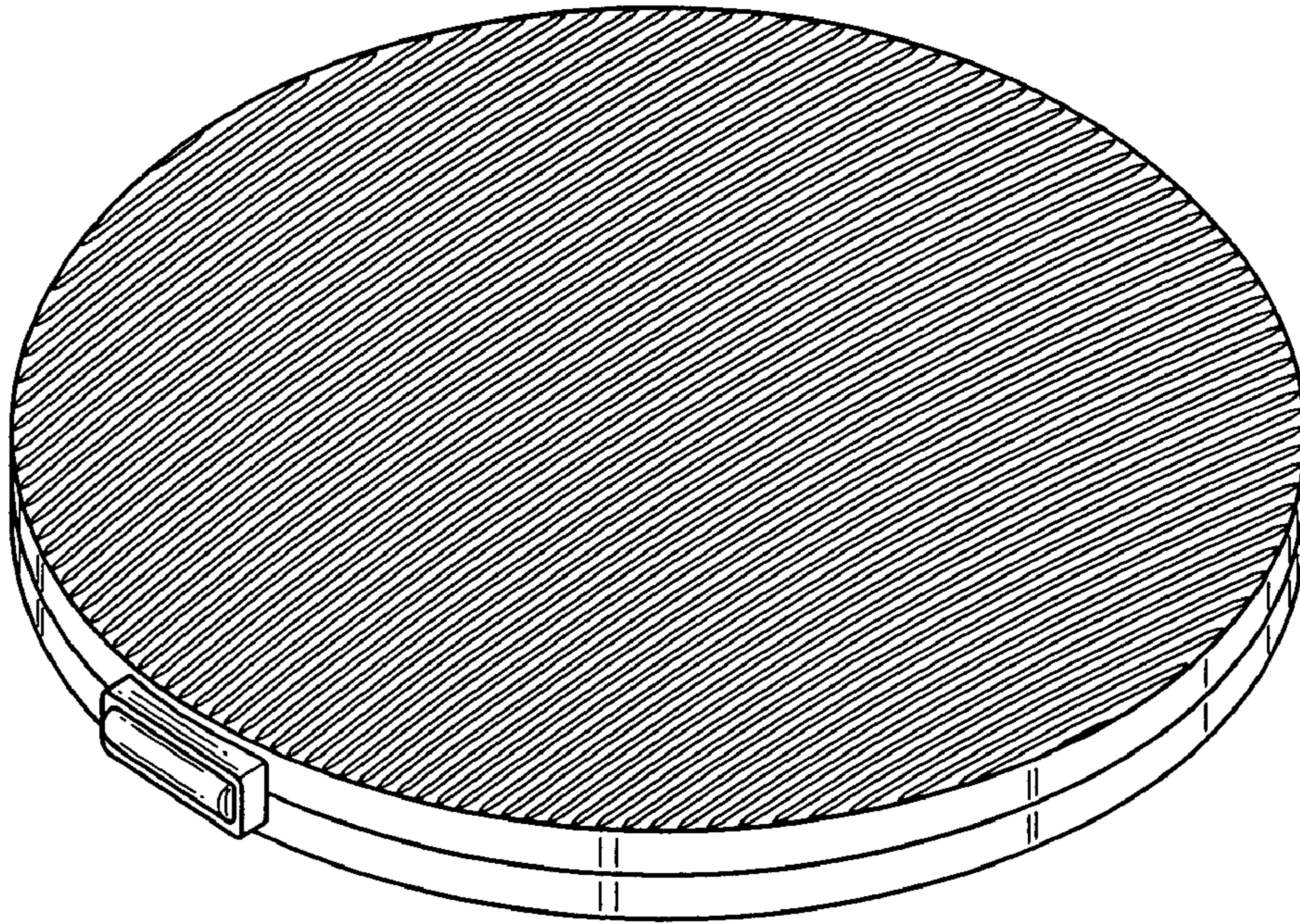

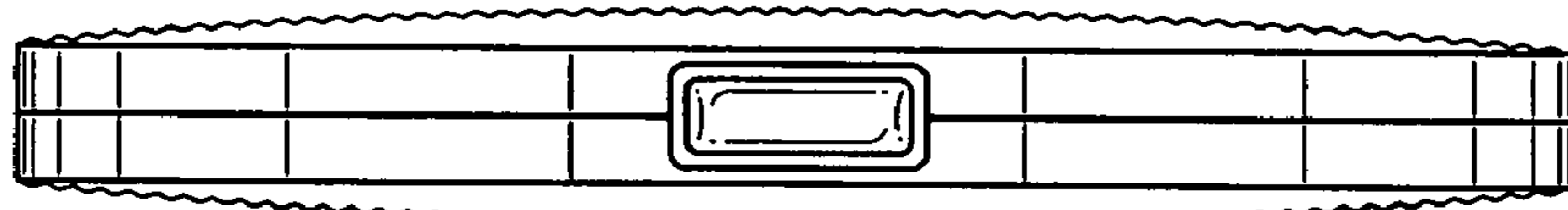

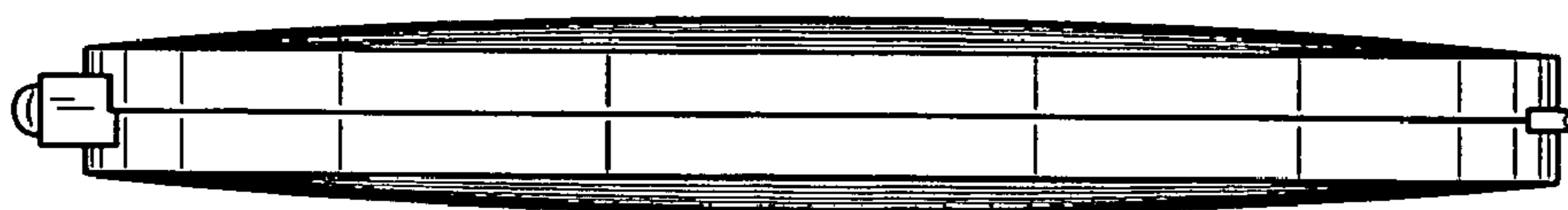

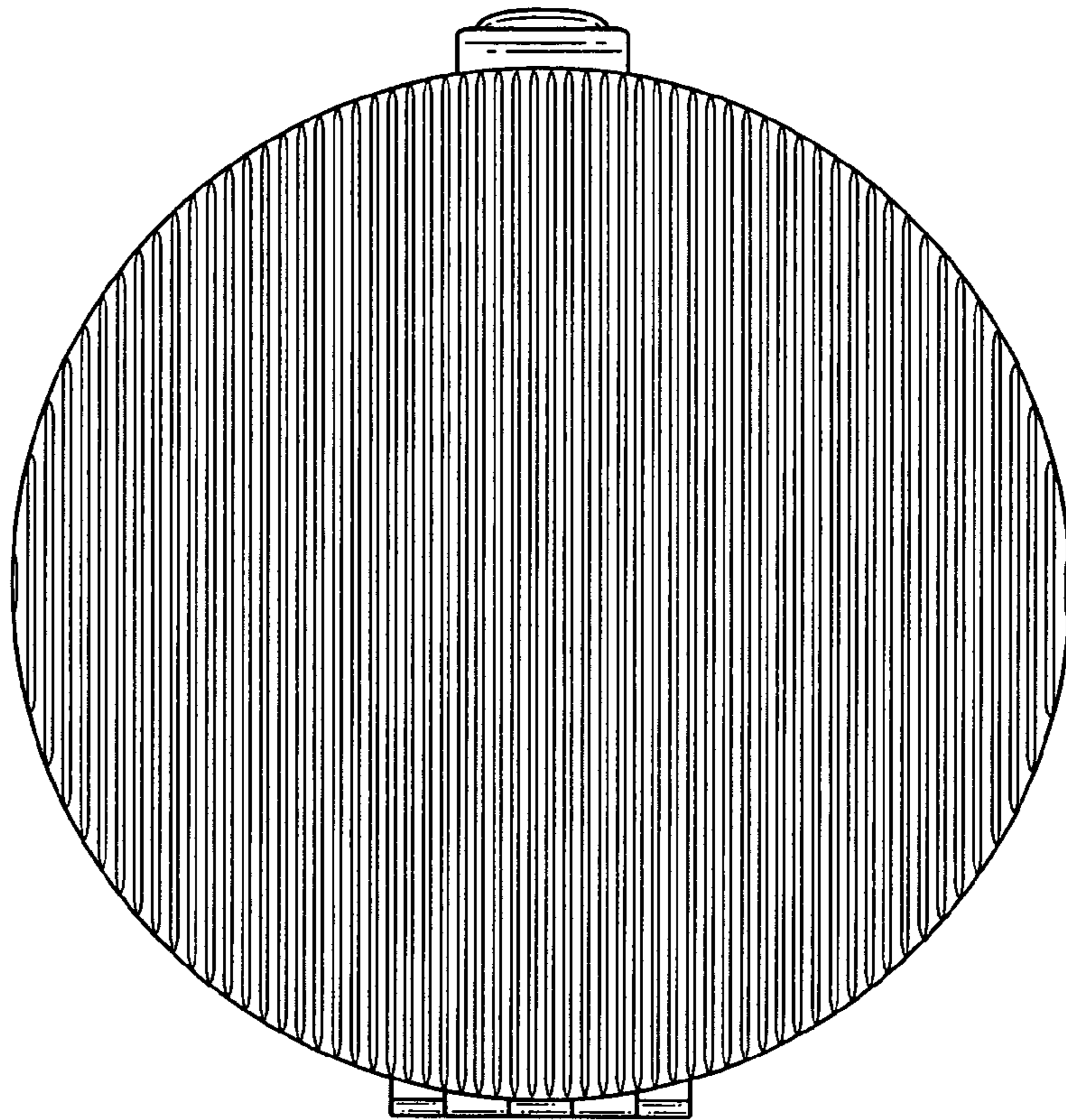
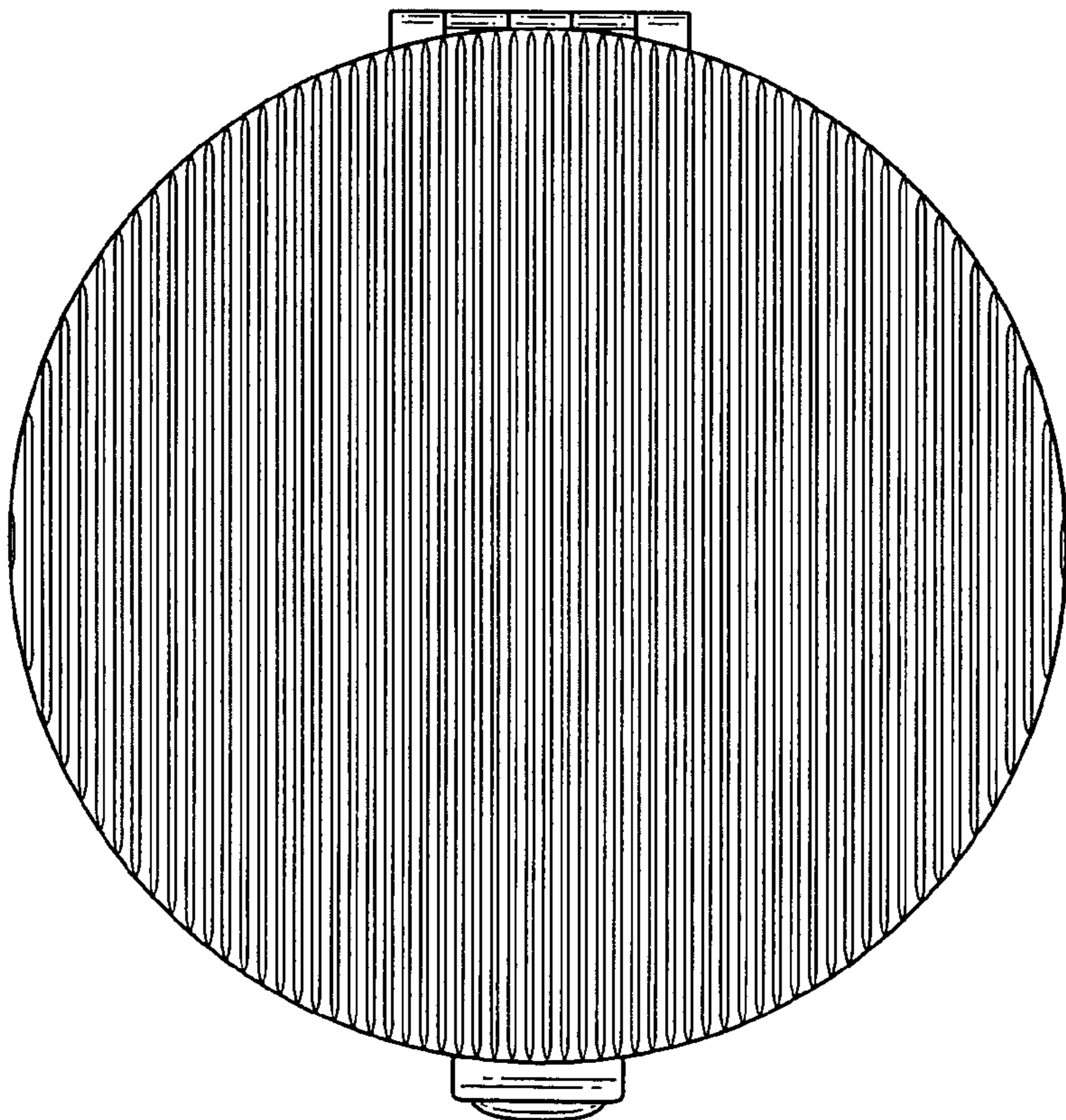

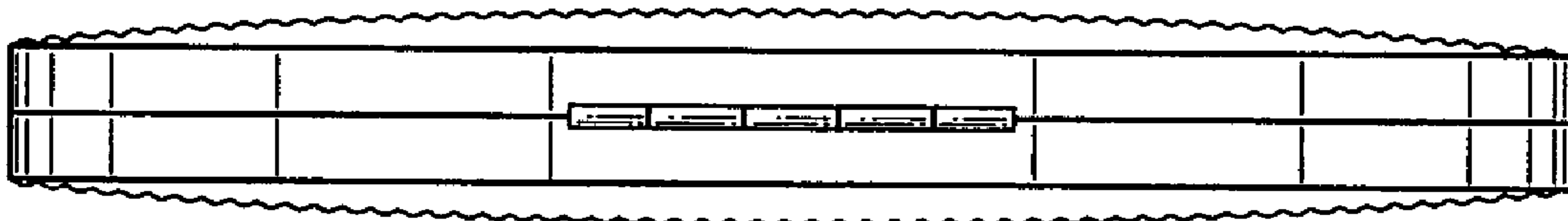
