(57) **CLAIM**

I claim the ornamental design for a hoof block, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the bottom of the hoof block of the new design;

FIG. 2 is a perspective view showing the top of the hoof block;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is an enlarged right side view thereof;

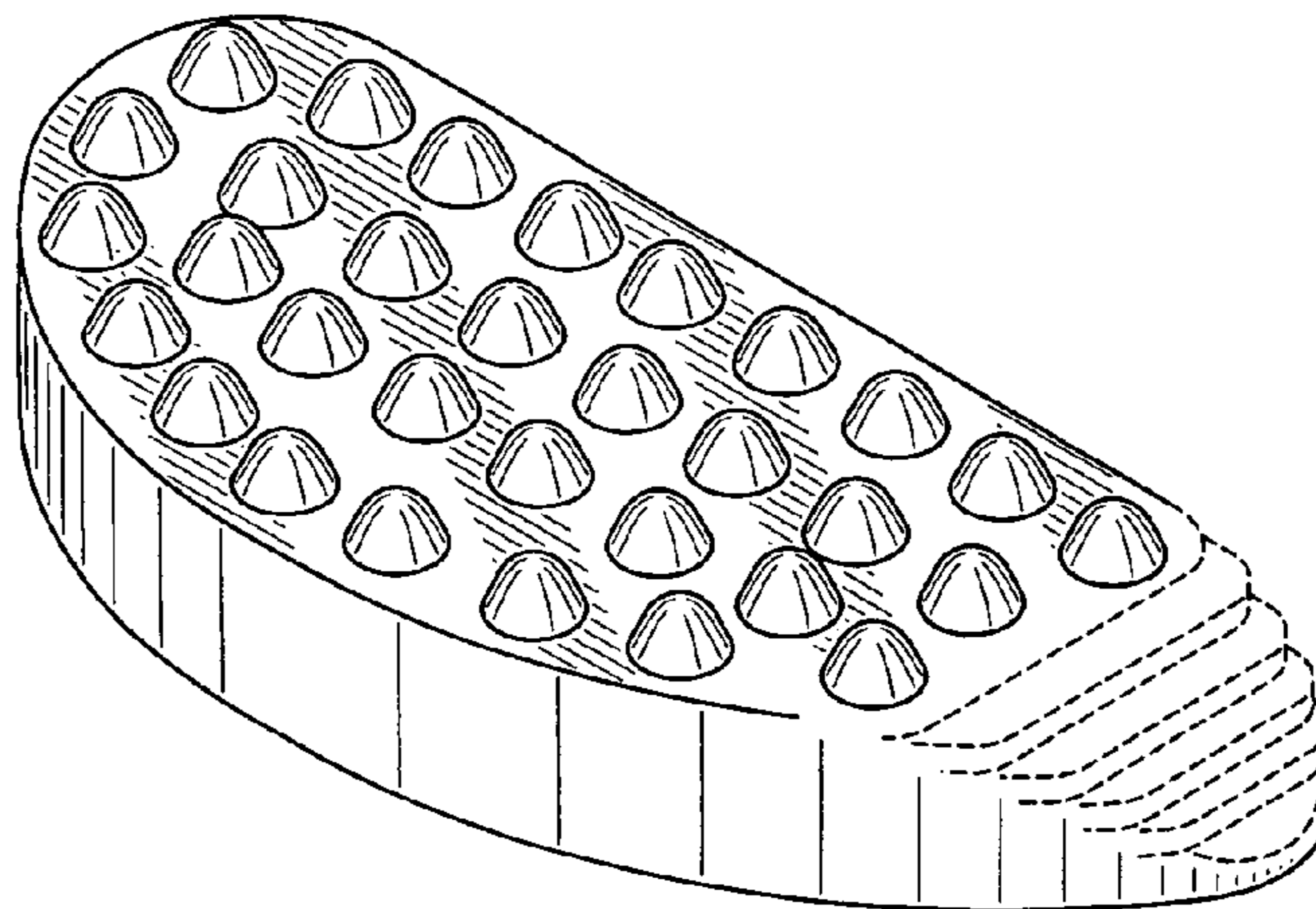
FIG. 6 is an enlarged left side view thereof;

FIG. 7 is an enlarged front elevation view thereof; and,

FIG. 8 is an enlarged rear elevation view thereof.

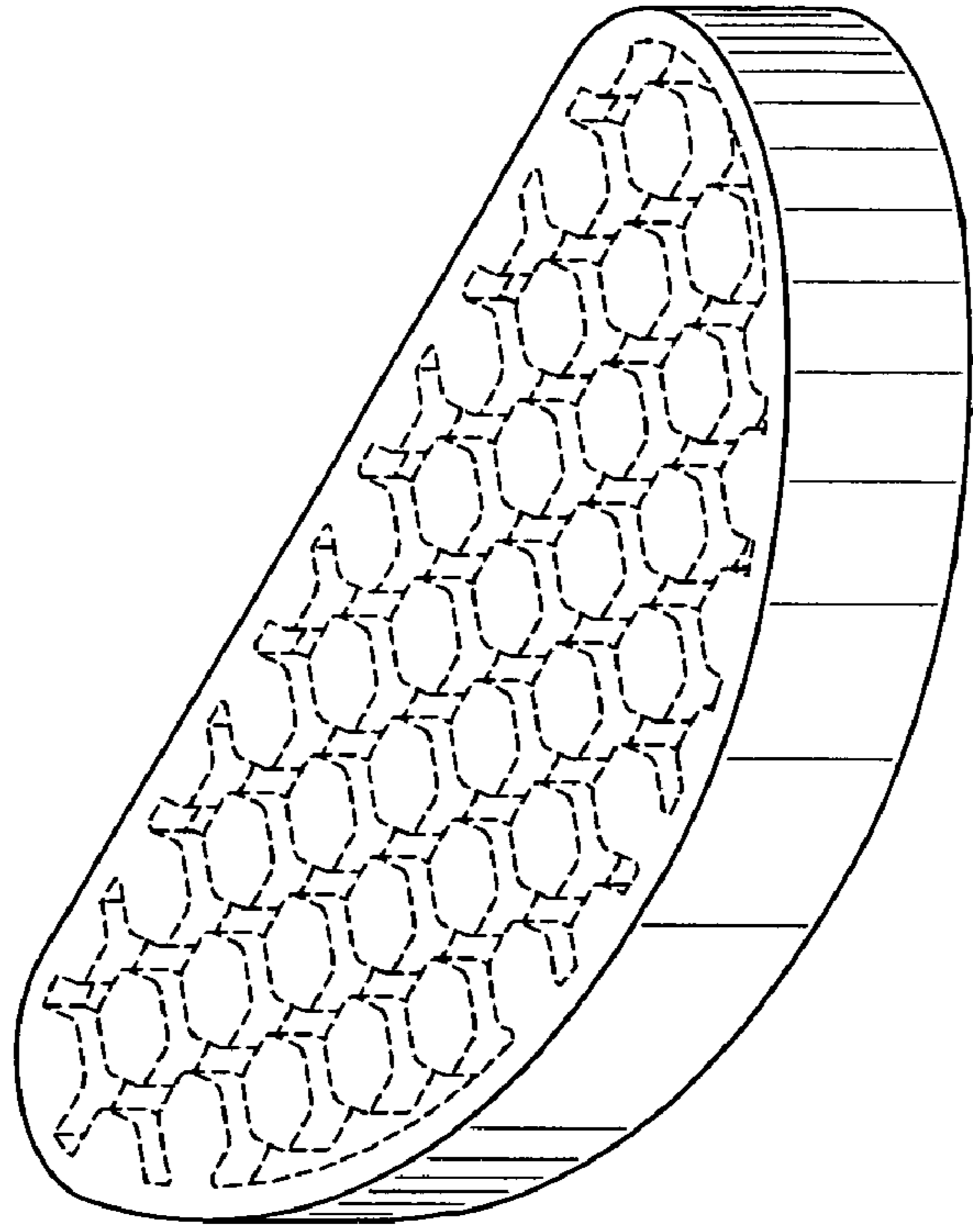

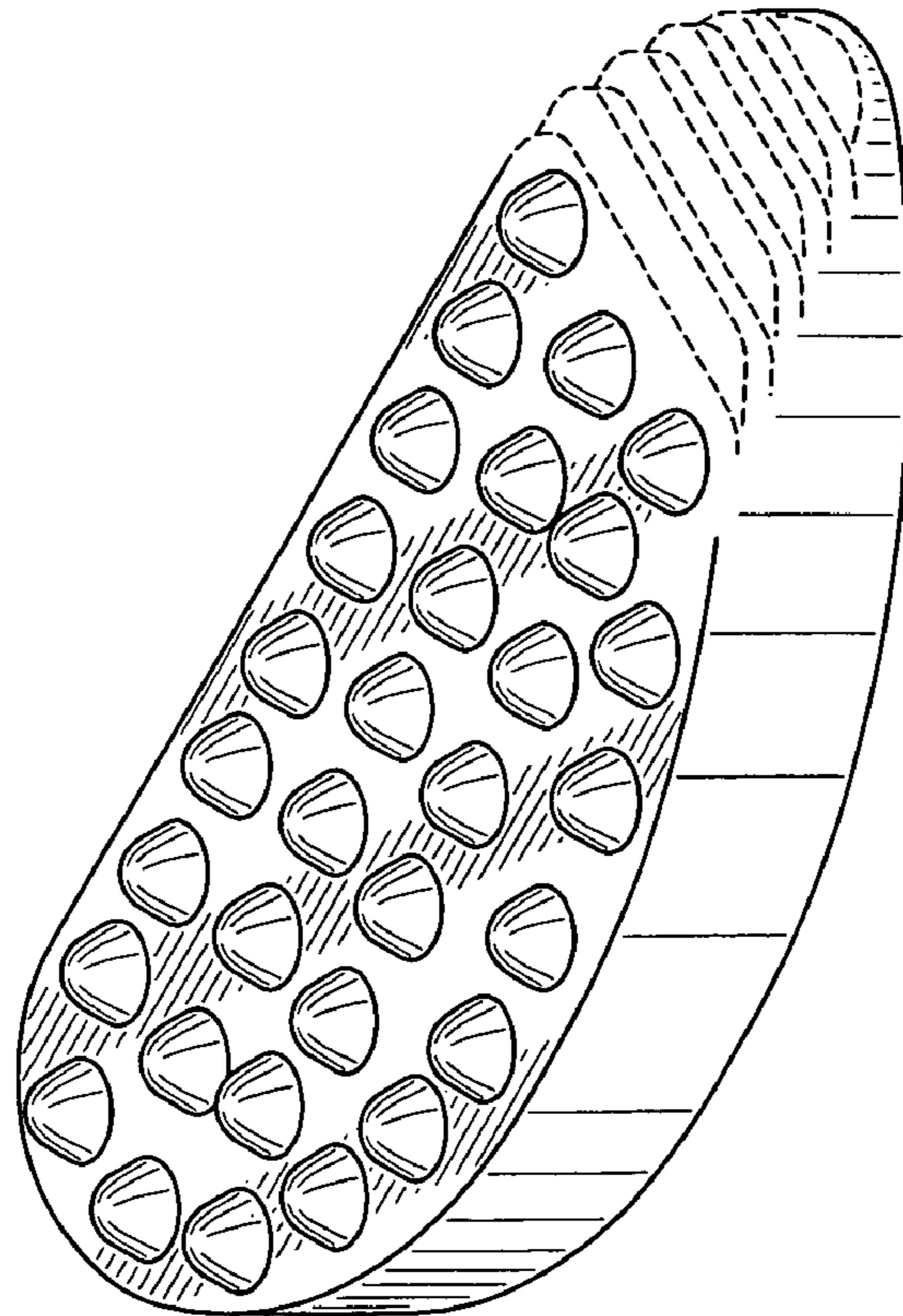

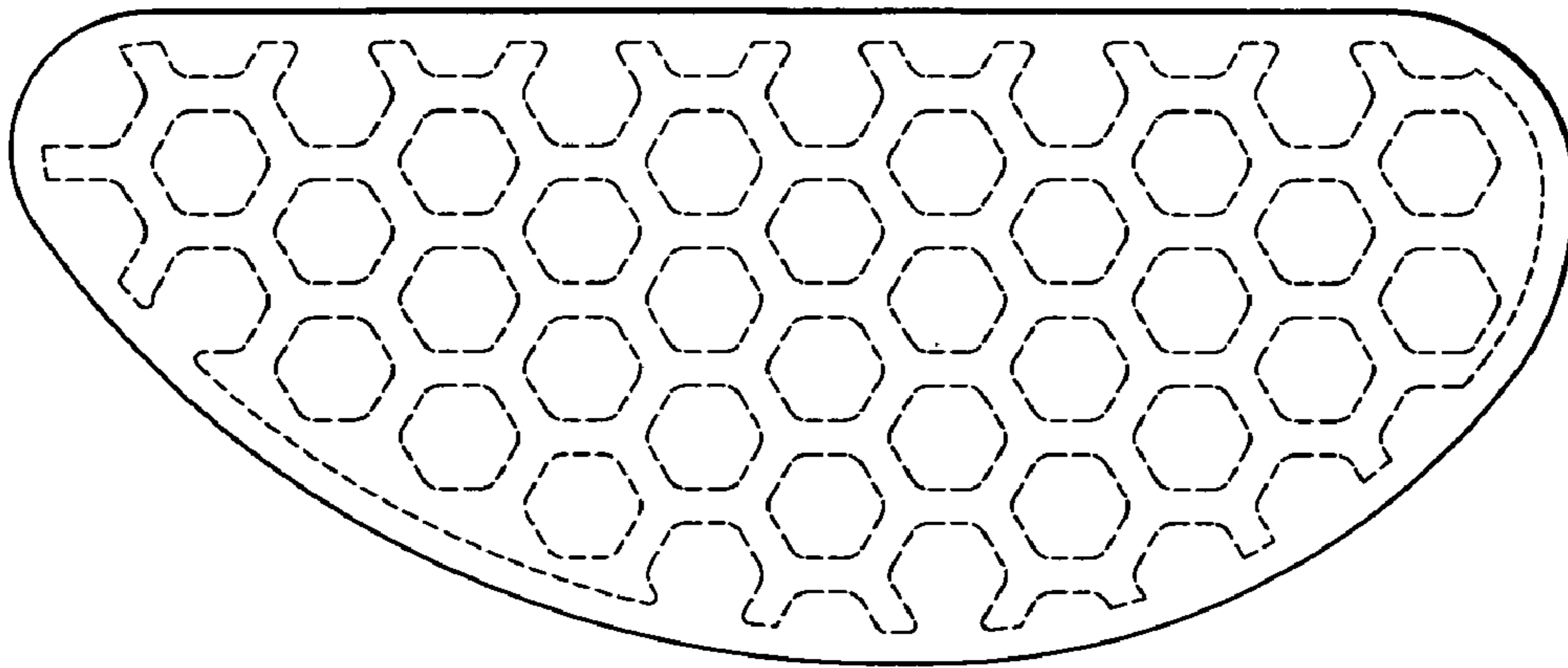

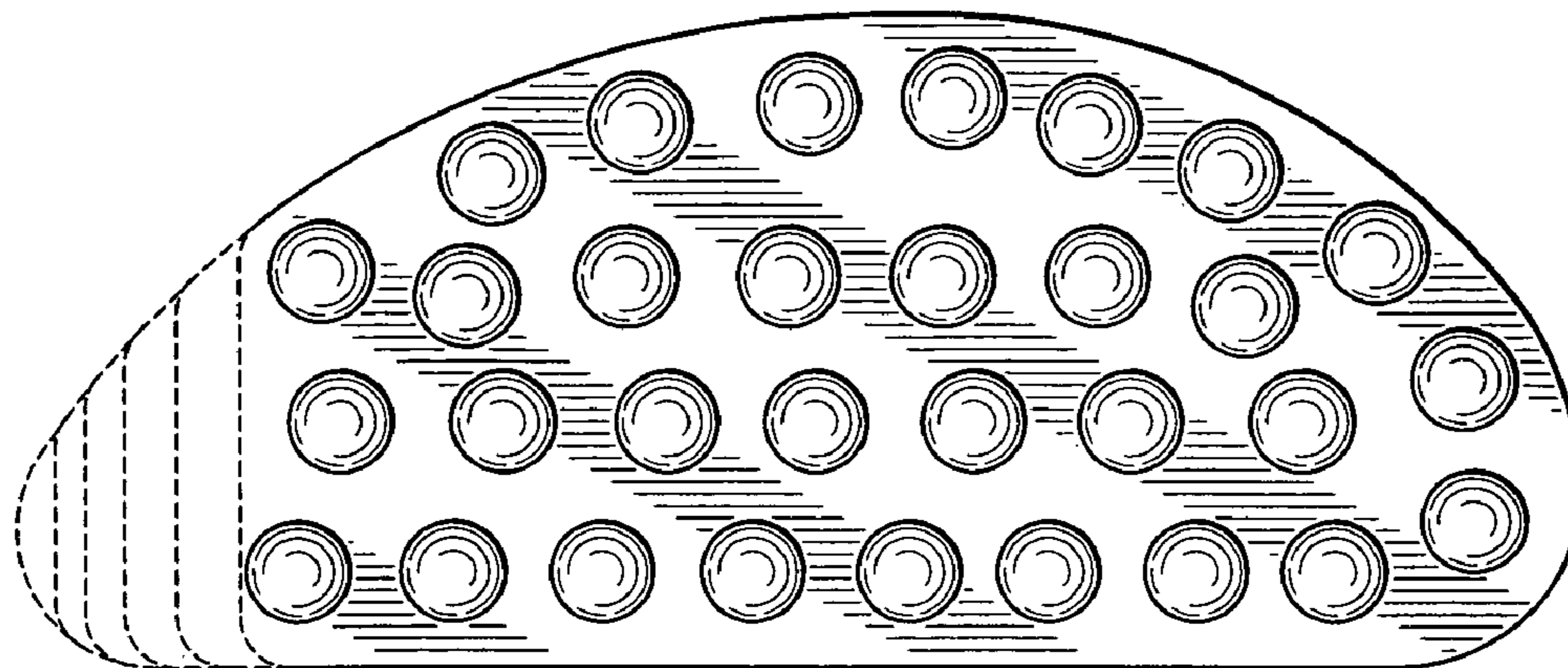

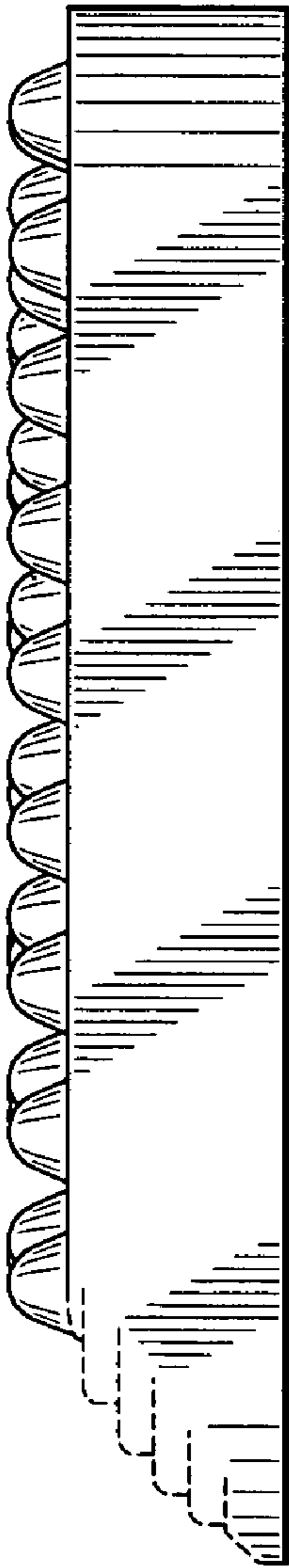

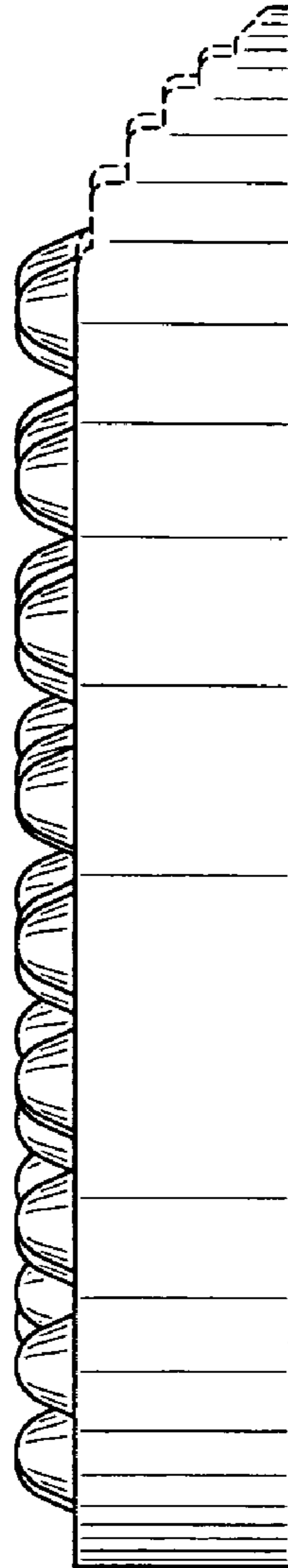

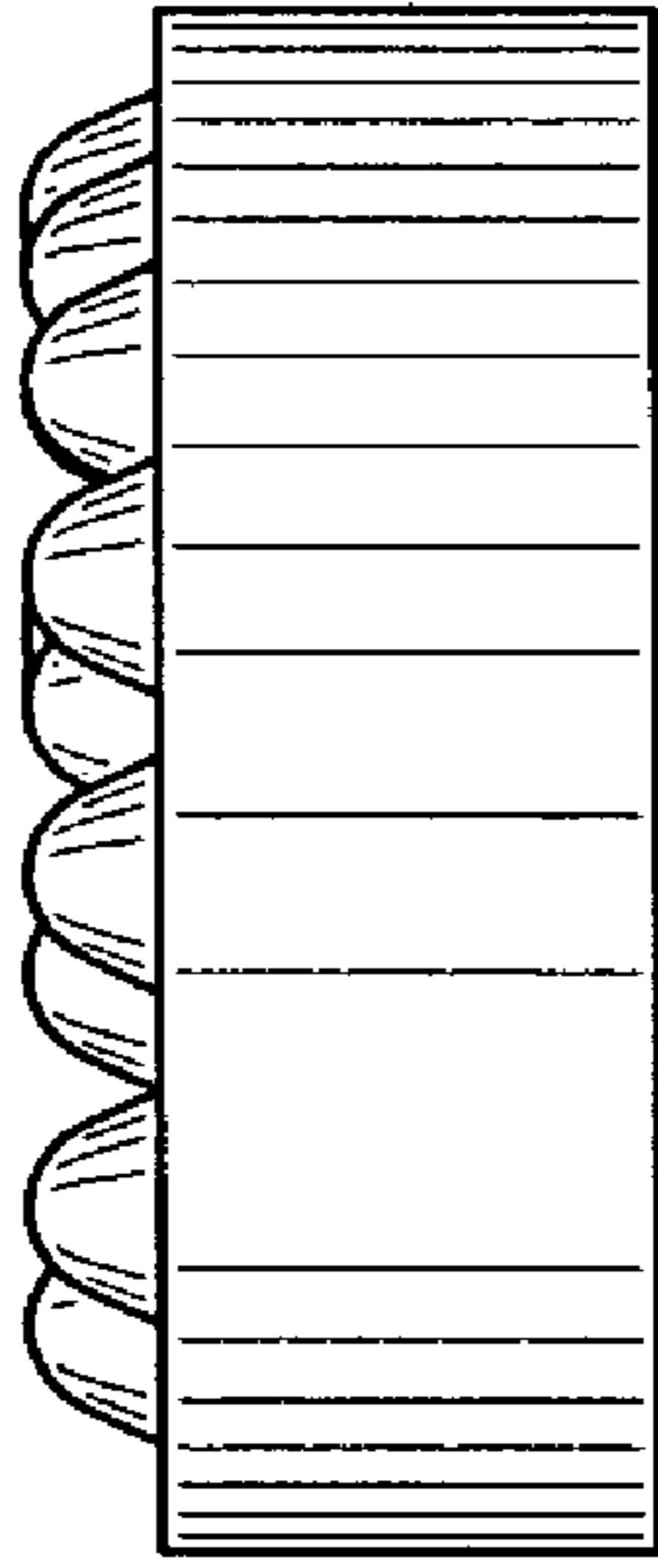

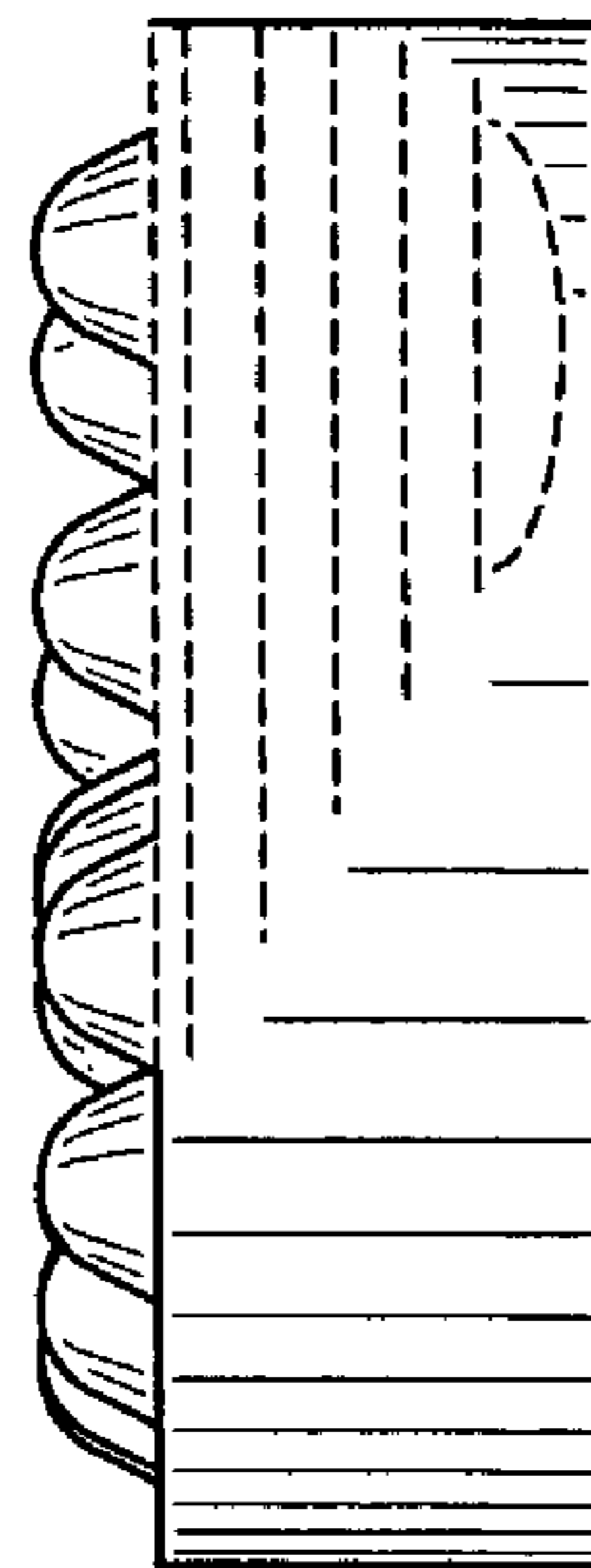
