FIG. 5 is a left side elevational view thereof;

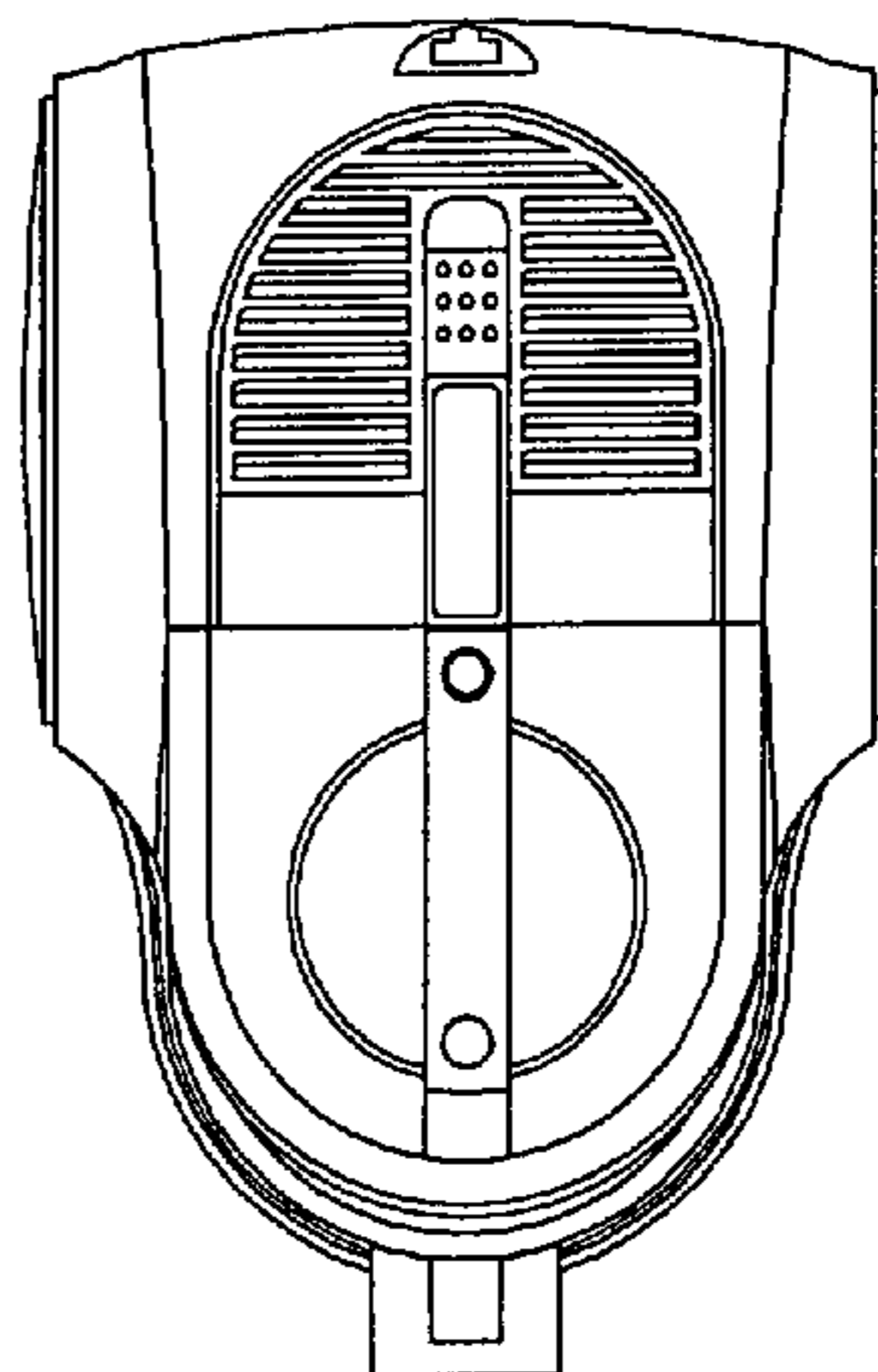
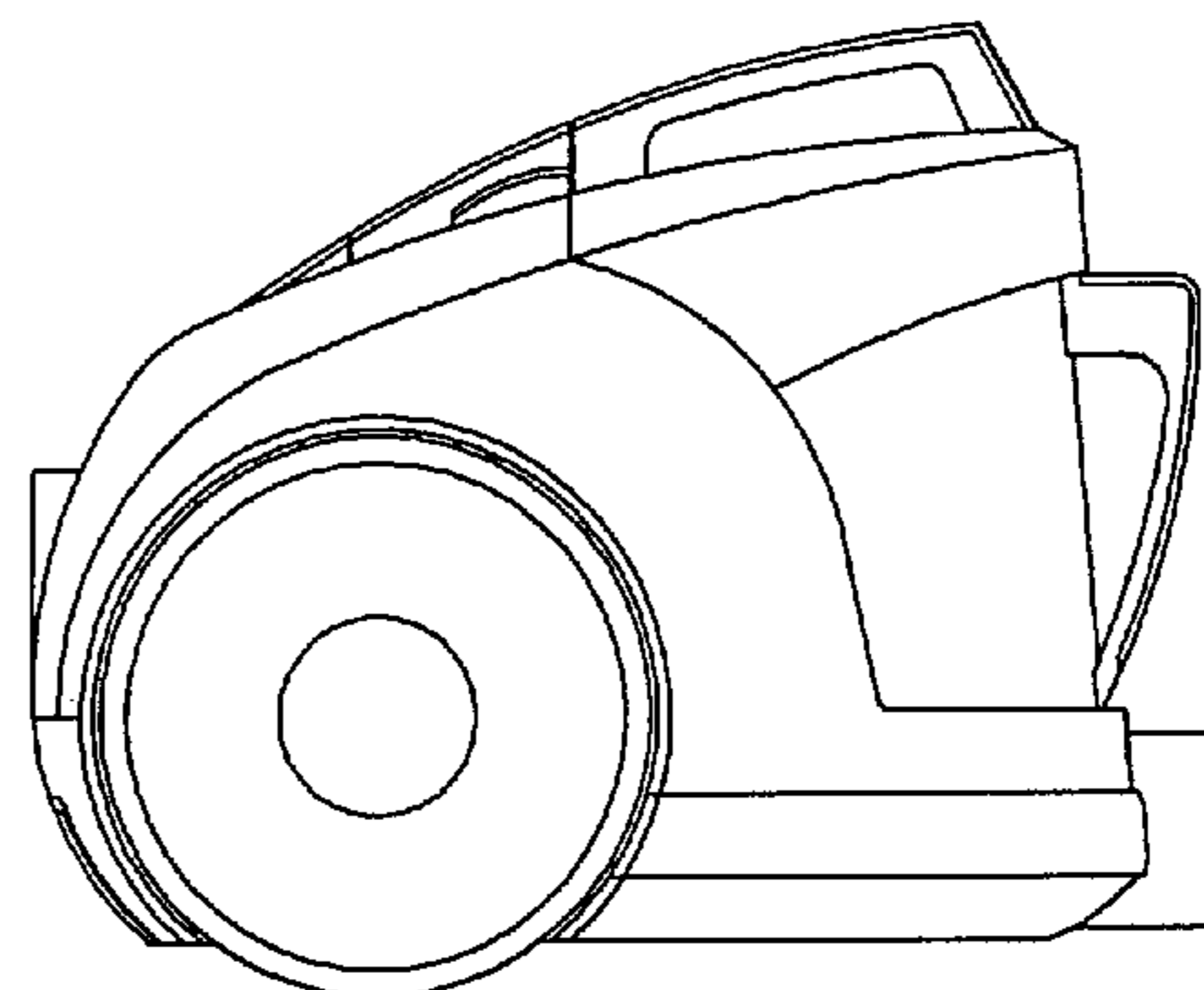
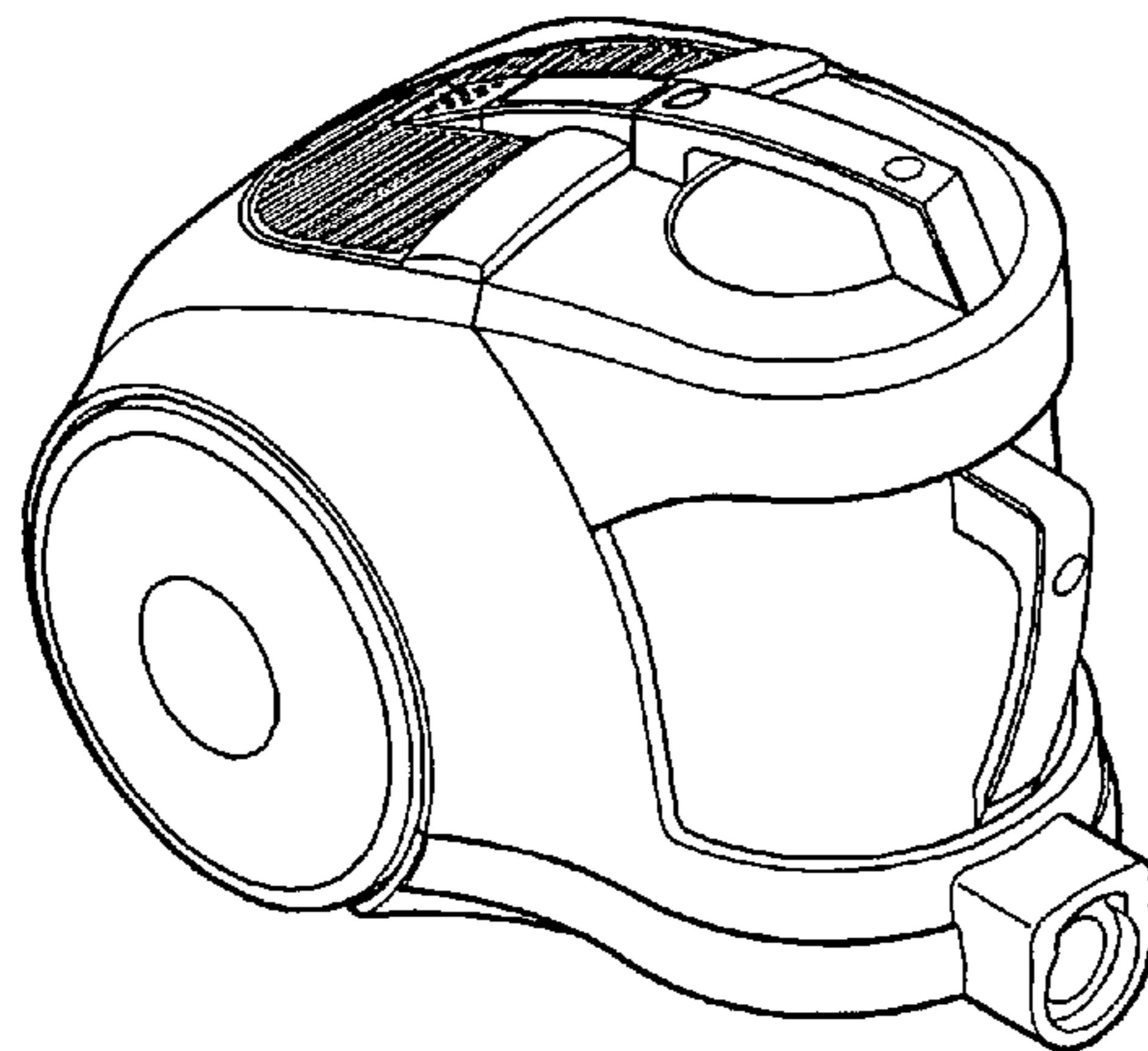
FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof; and,

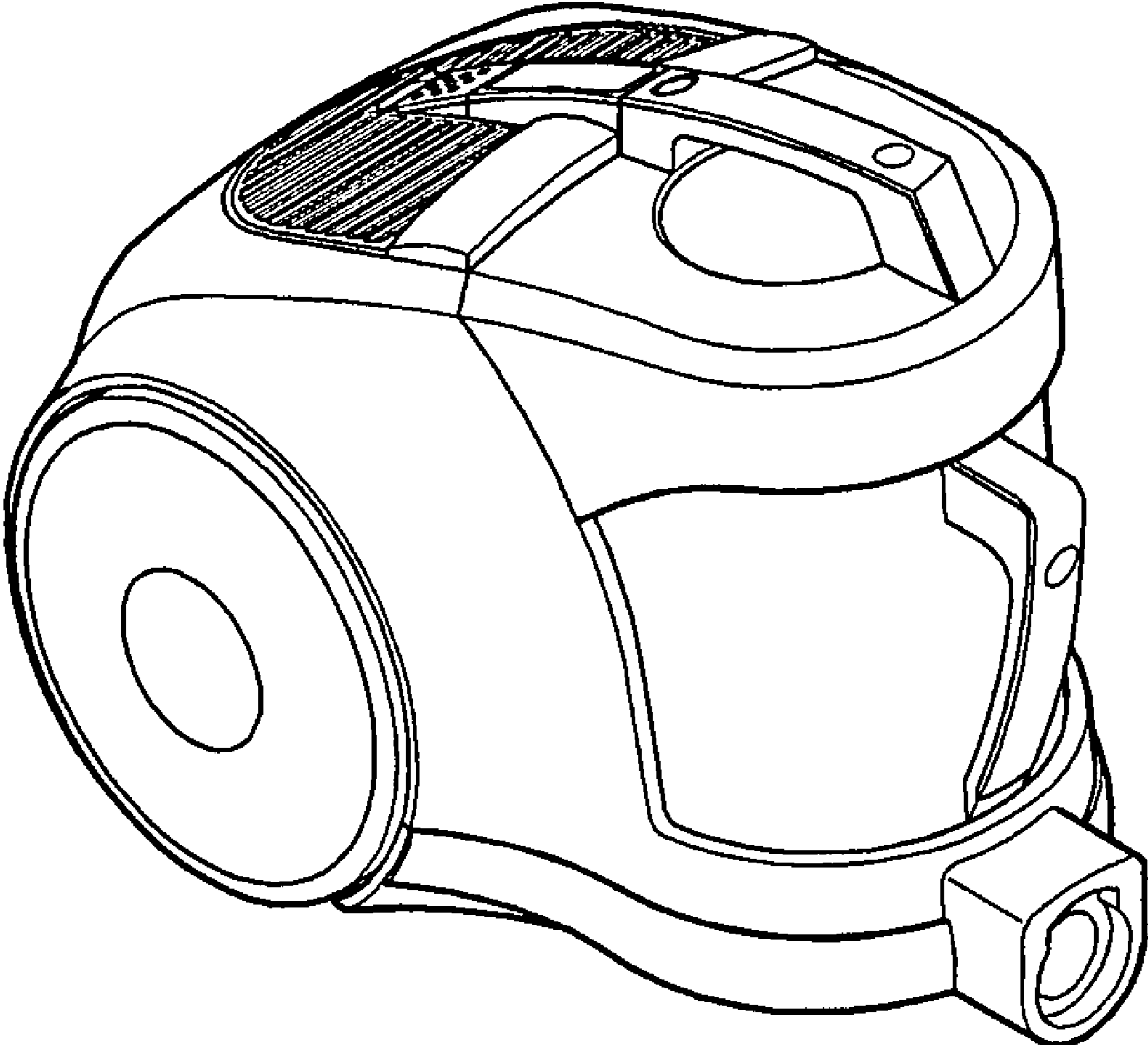
FIG. 8 is a perspective view as seen from the top, front, and right side of the vacuum cleaner of FIG. 1 shown in use with a hose and a brush.

The broken lines in FIG. 8 are for illustrative purposes only and form no part of the claimed design.

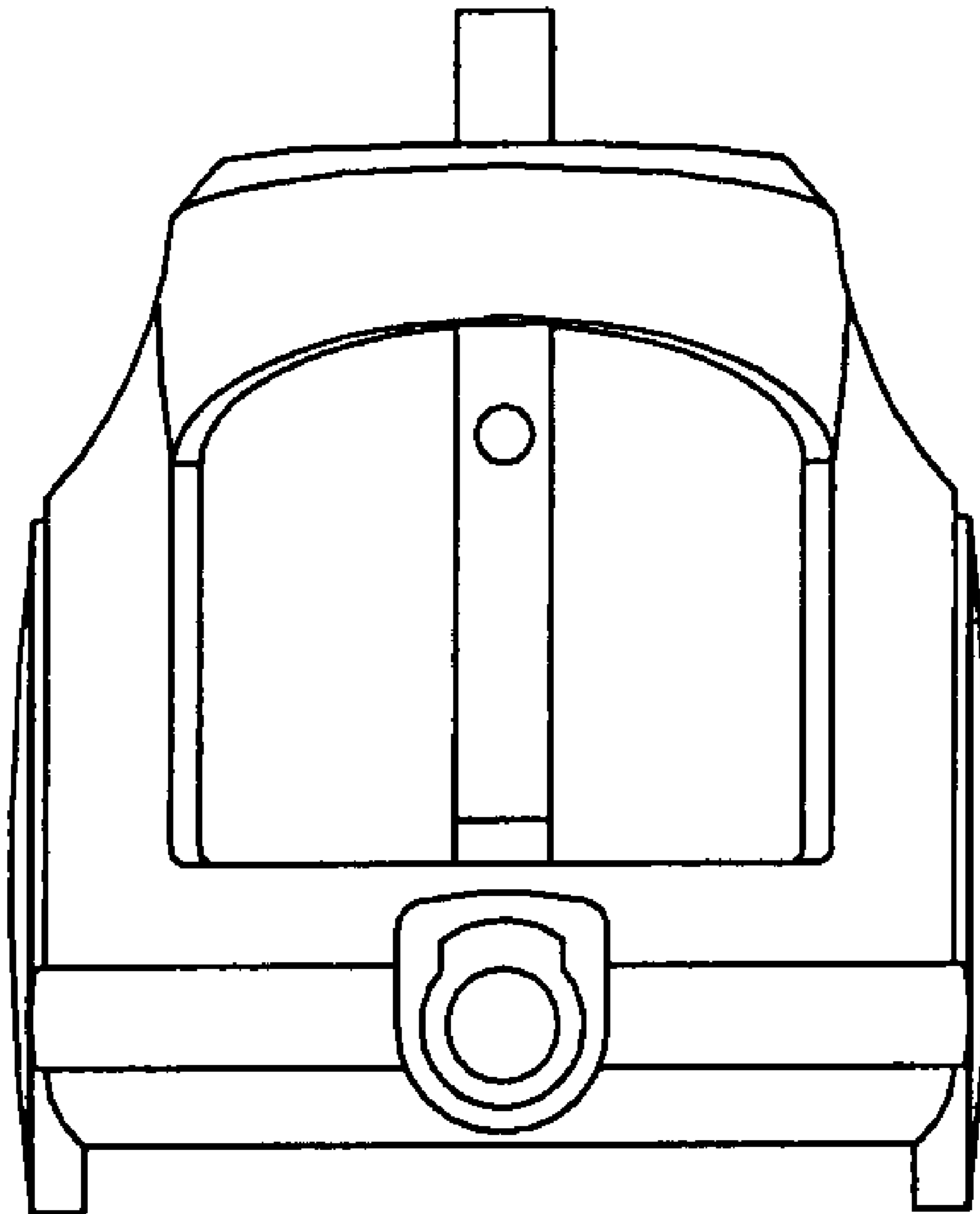

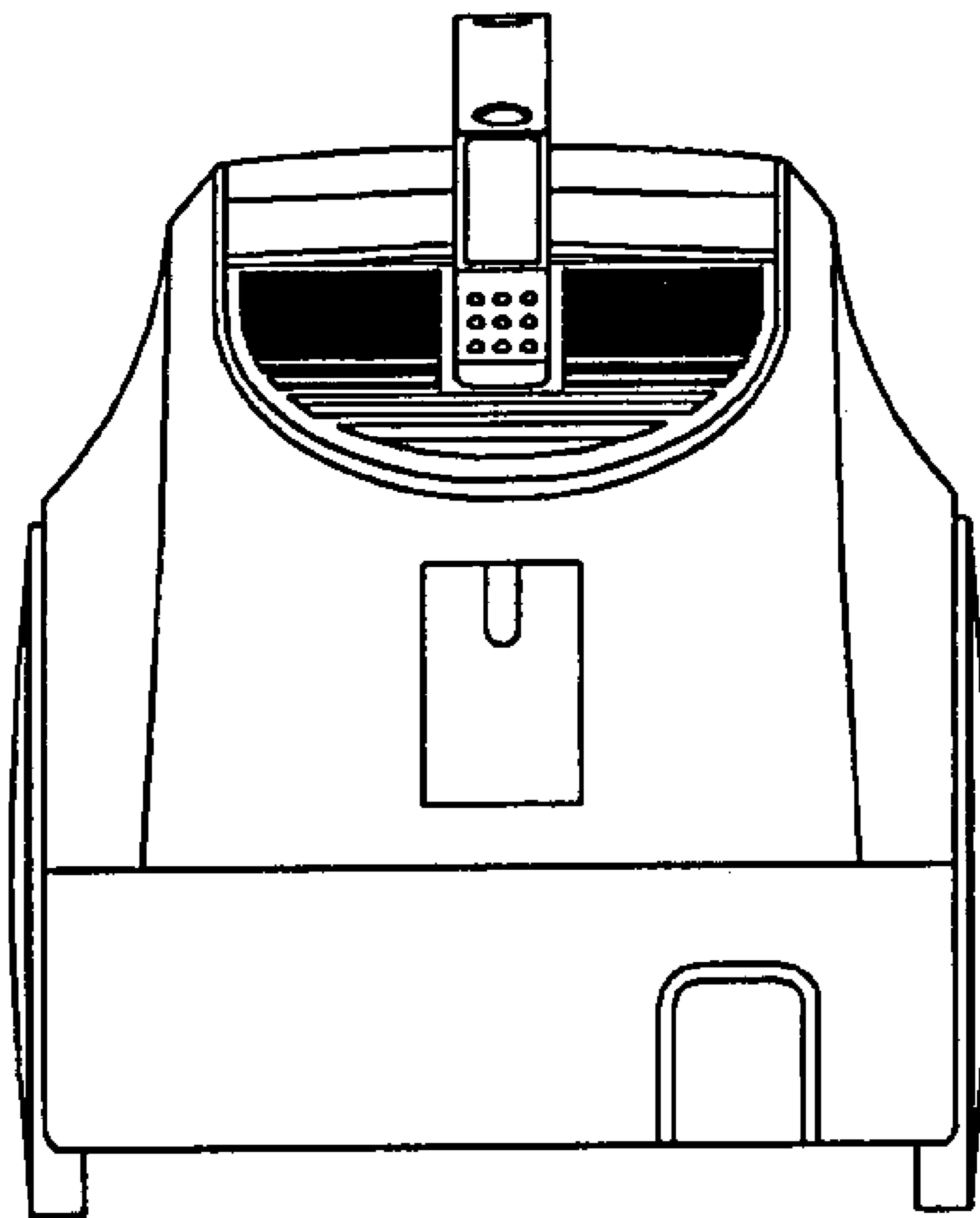

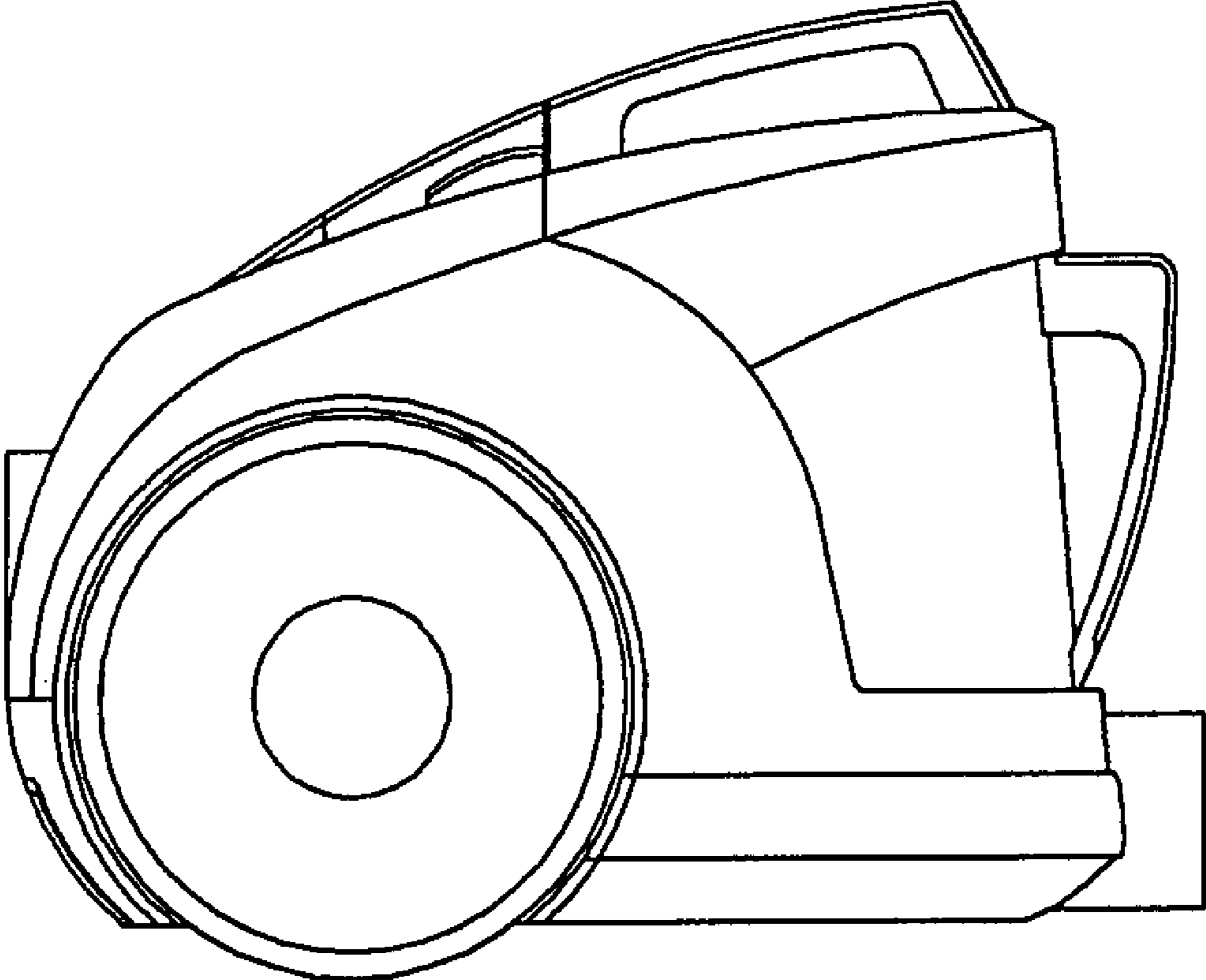

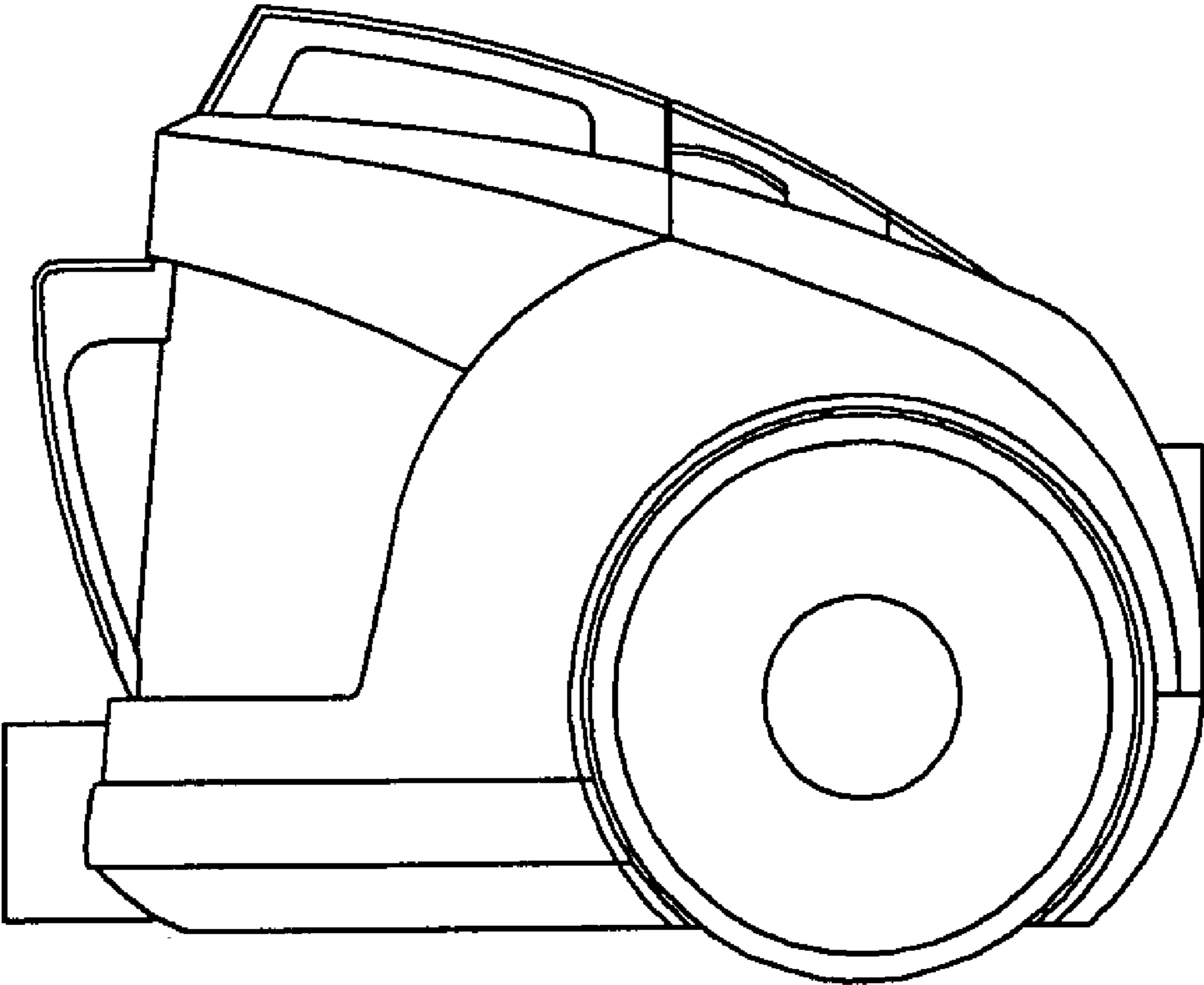

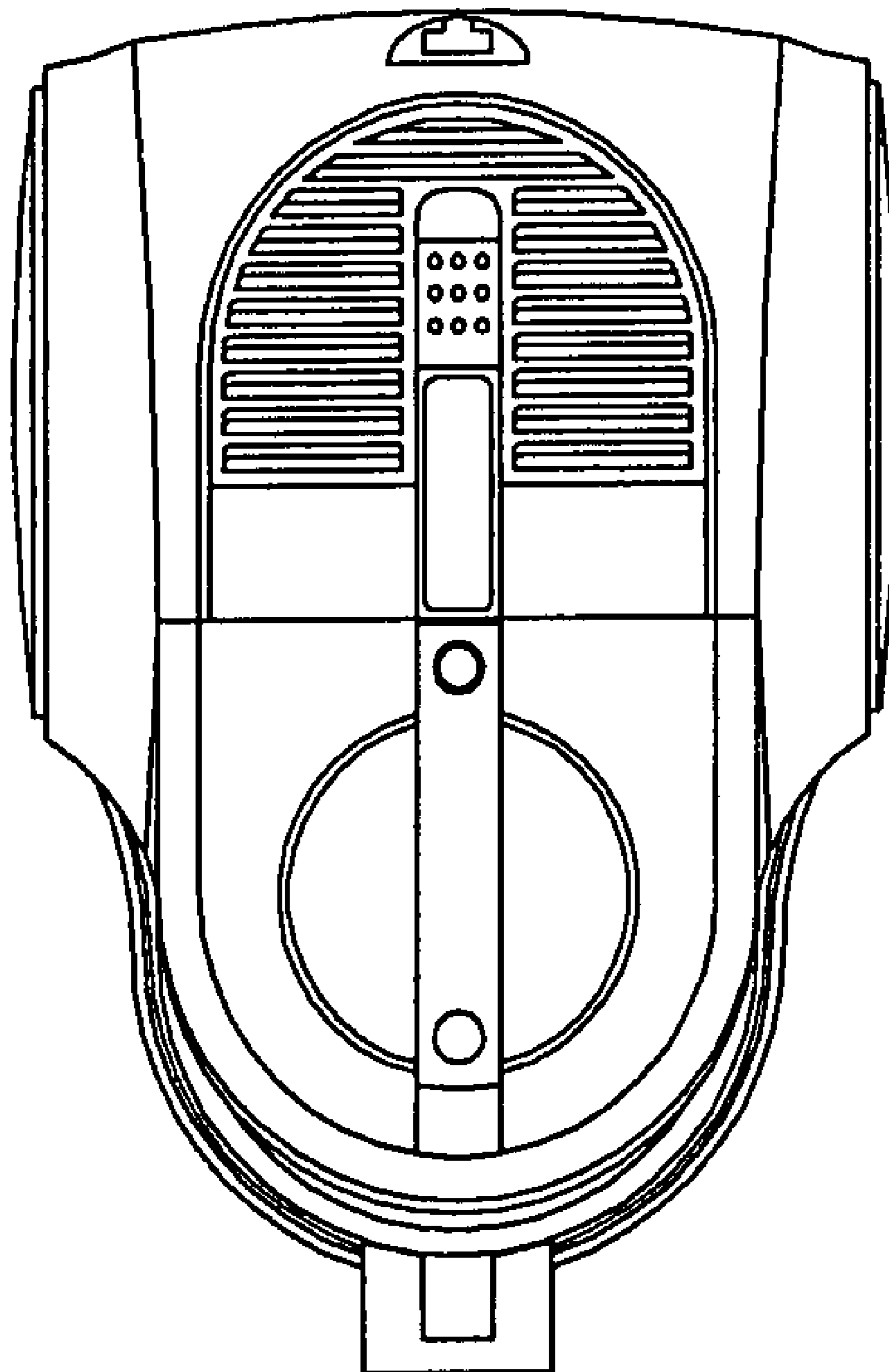

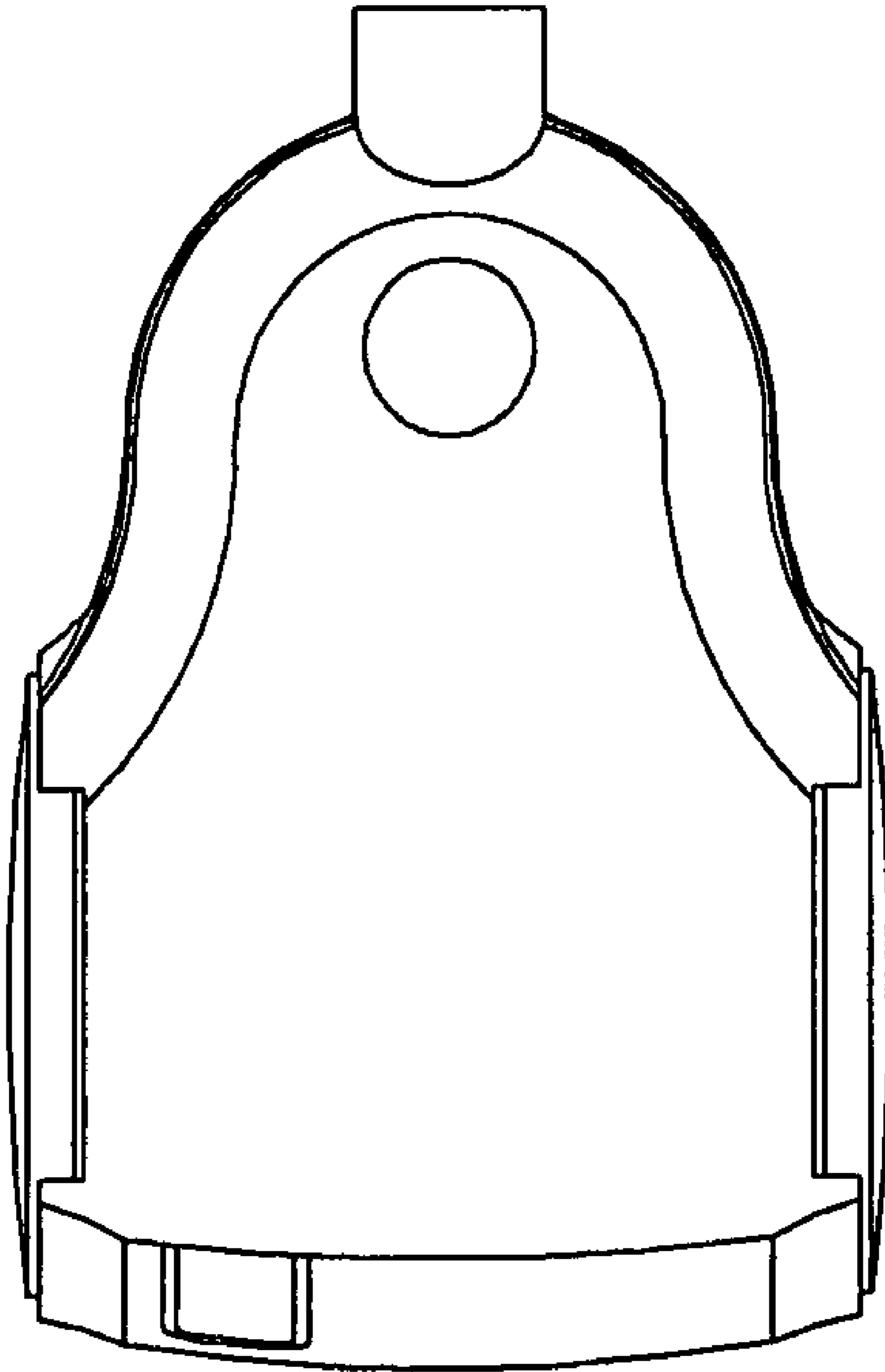
