DESCRIPTION

FIG. 1 is a top perspective view of the snack food product of the present invention;

FIG. 2 is a bottom perspective view of the snack food product of the present invention;

FIG. 3 is a left elevation view of the snack food product of the present invention, with the right elevation view a mirror image of the left elevation view;

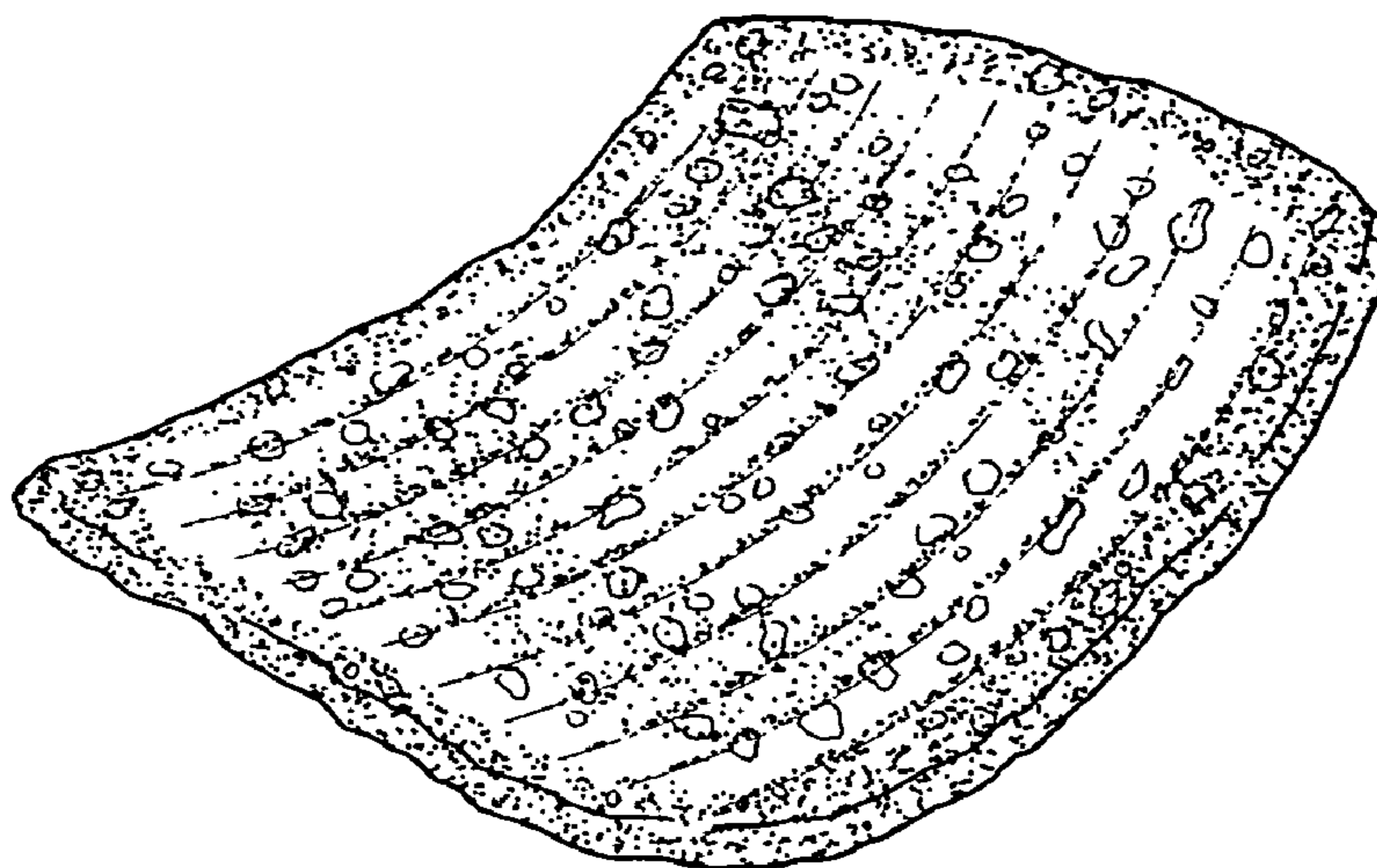
FIG. 4 is a front elevation view of the snack food product of the present invention;

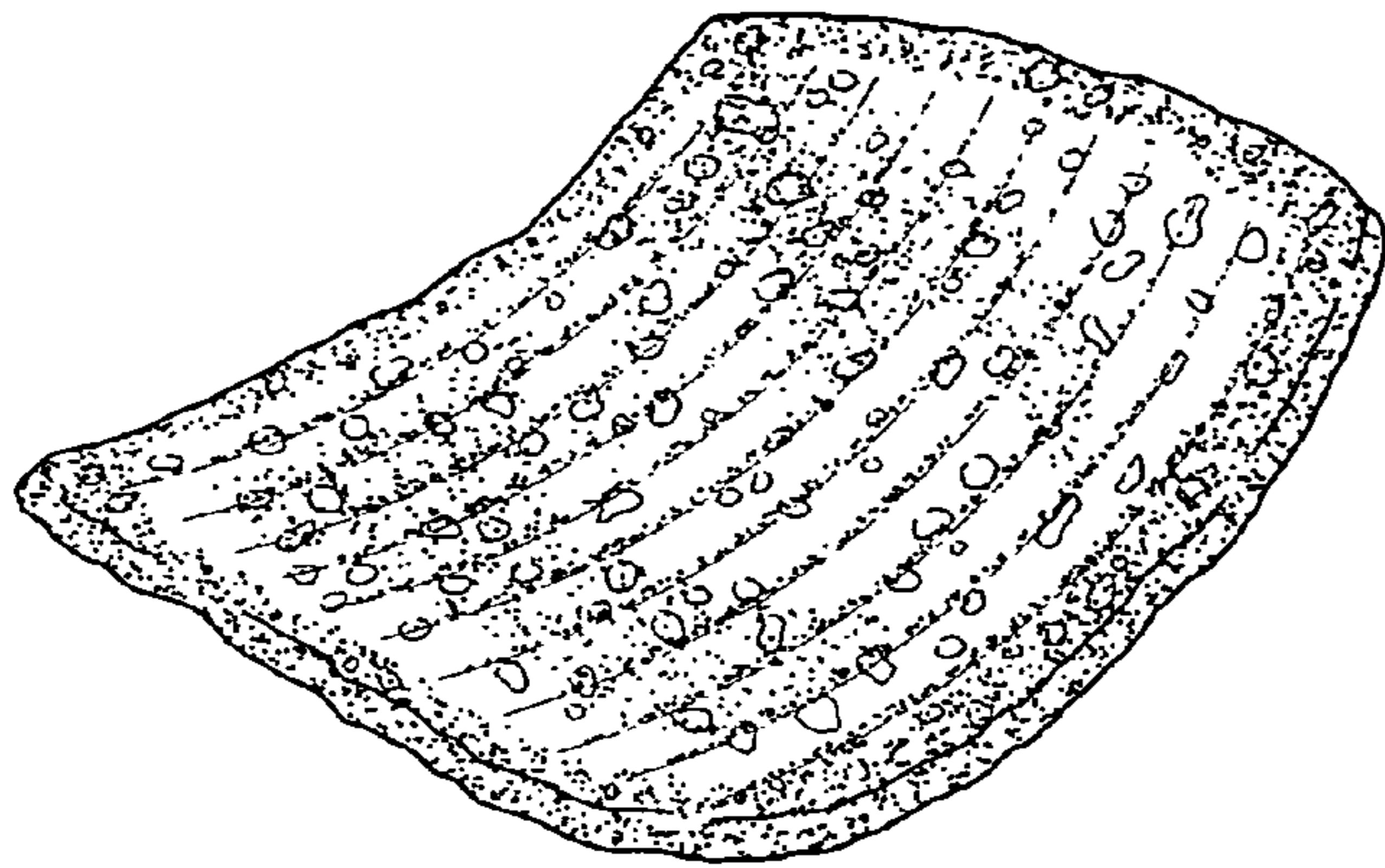

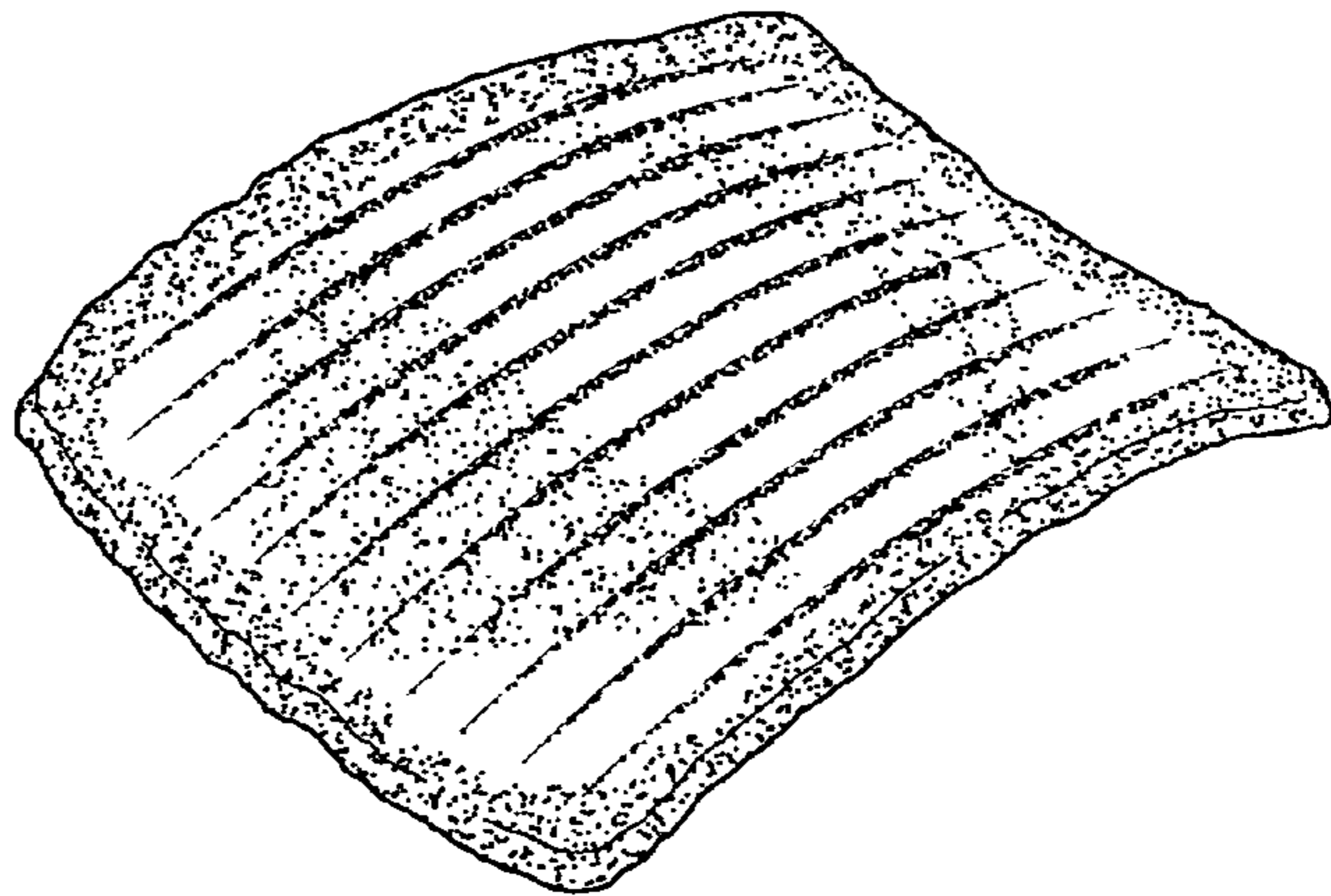

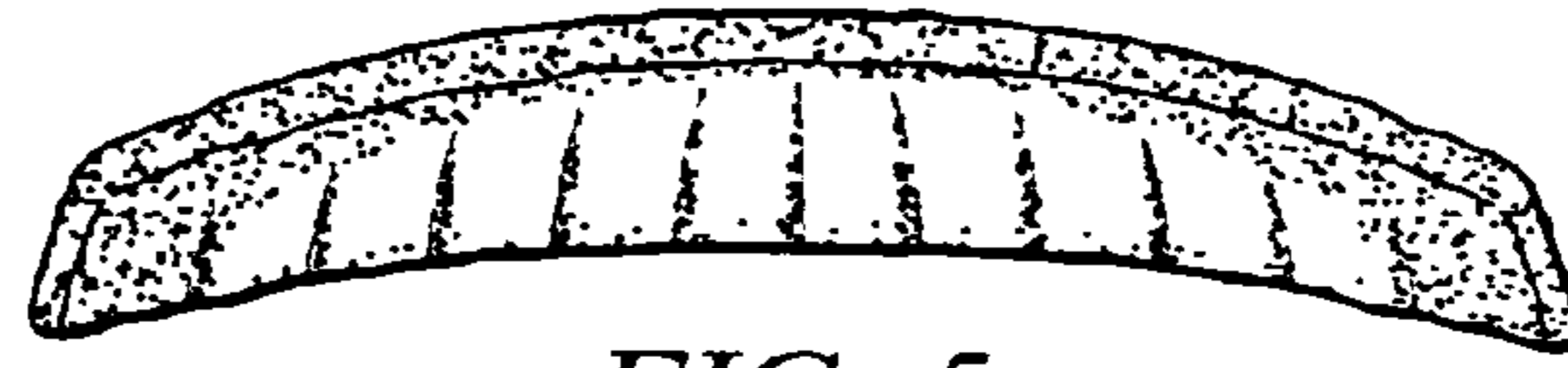

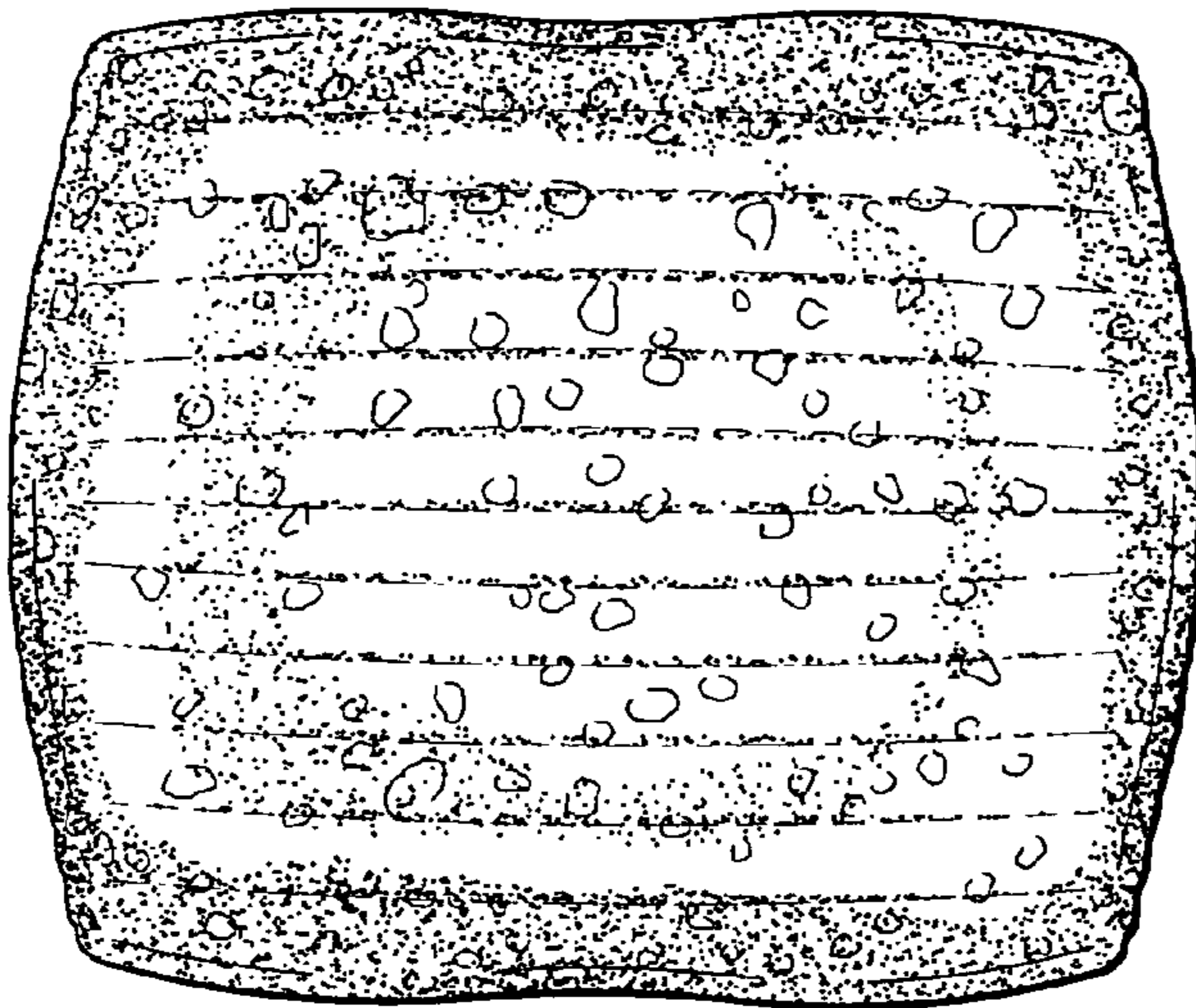

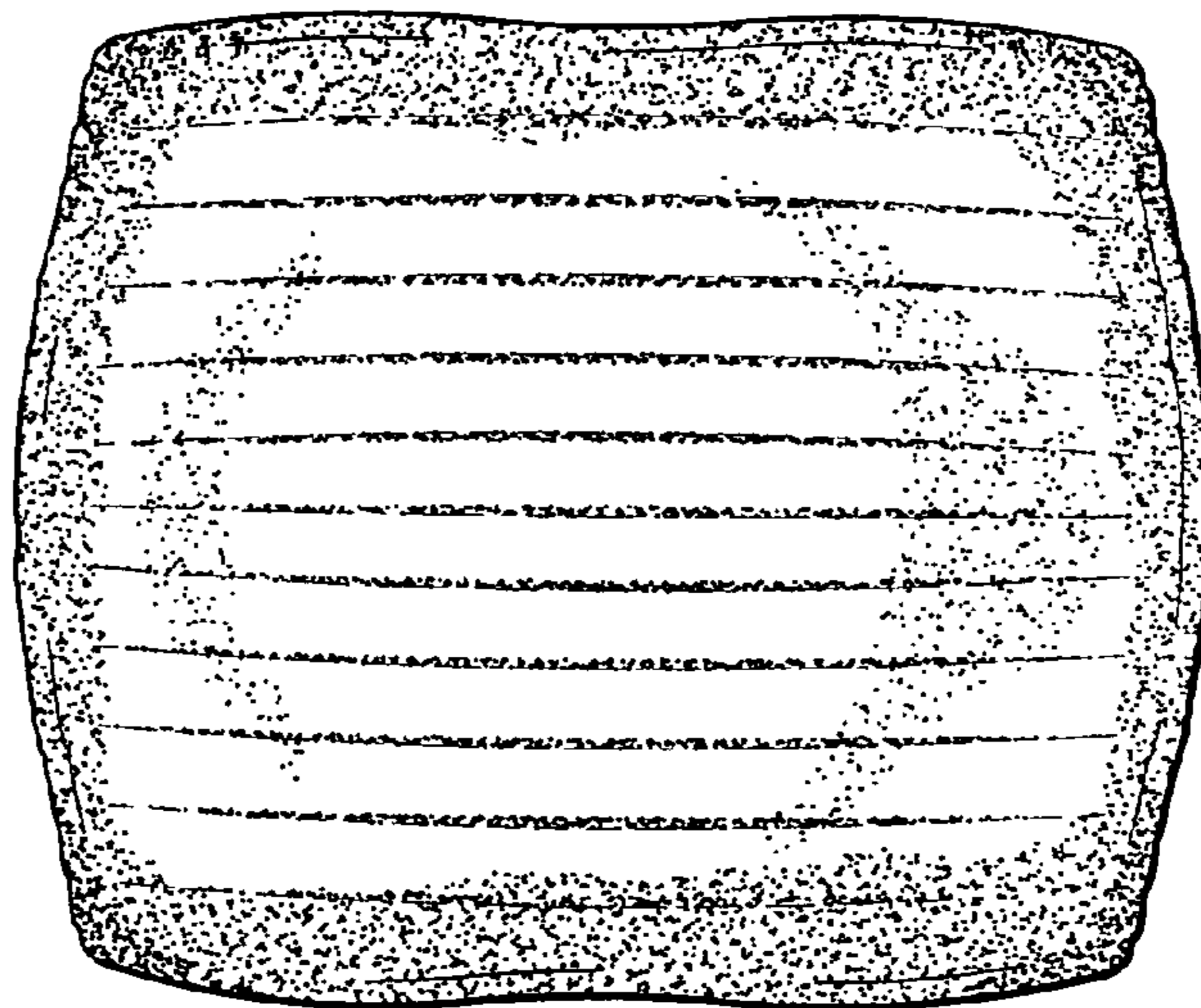
