(57) **CLAIM**

The ornamental design for a breastfeeding cover, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a breastfeeding cover of the present invention;

FIG. 2 is a left side elevational view of the breastfeeding cover of FIG. 1;

FIG. 3 is a rear elevational view of the breastfeeding cover of FIG. 1;

FIG. 4 is a front elevational view thereof, showing the front flap lifted to reveal a panel having two openings;

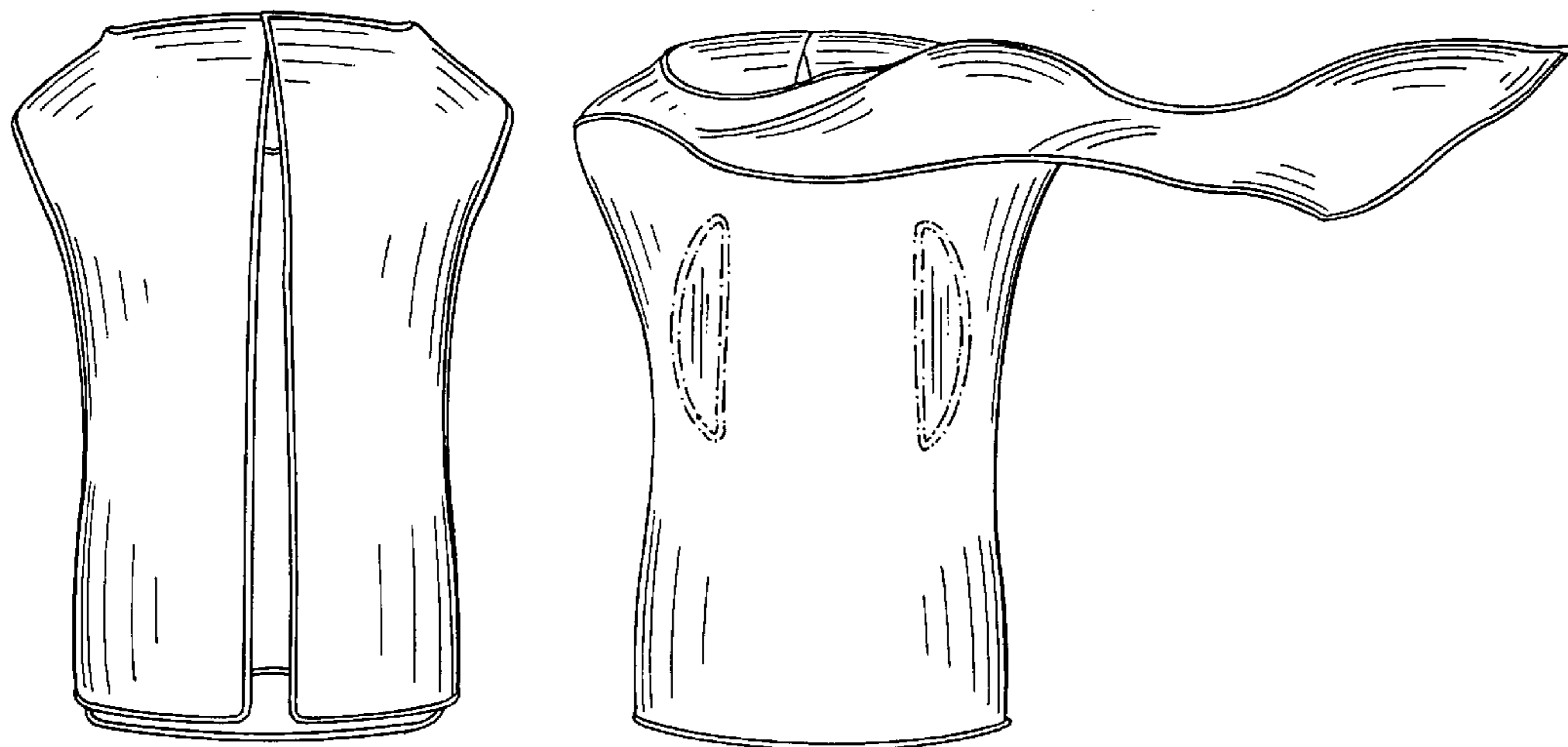
FIG. 5 is right side elevational view thereof, showing the front flap lifted to reveal a panel having two openings;

FIG. 6 is top plan view of the breastfeeding cover of FIG. 1; and,

FIG. 7 is a bottom plan view thereof.

The broken lines shown in FIGS. 4, 5, and 7 represent the portion of the design that forms no part of the claim.

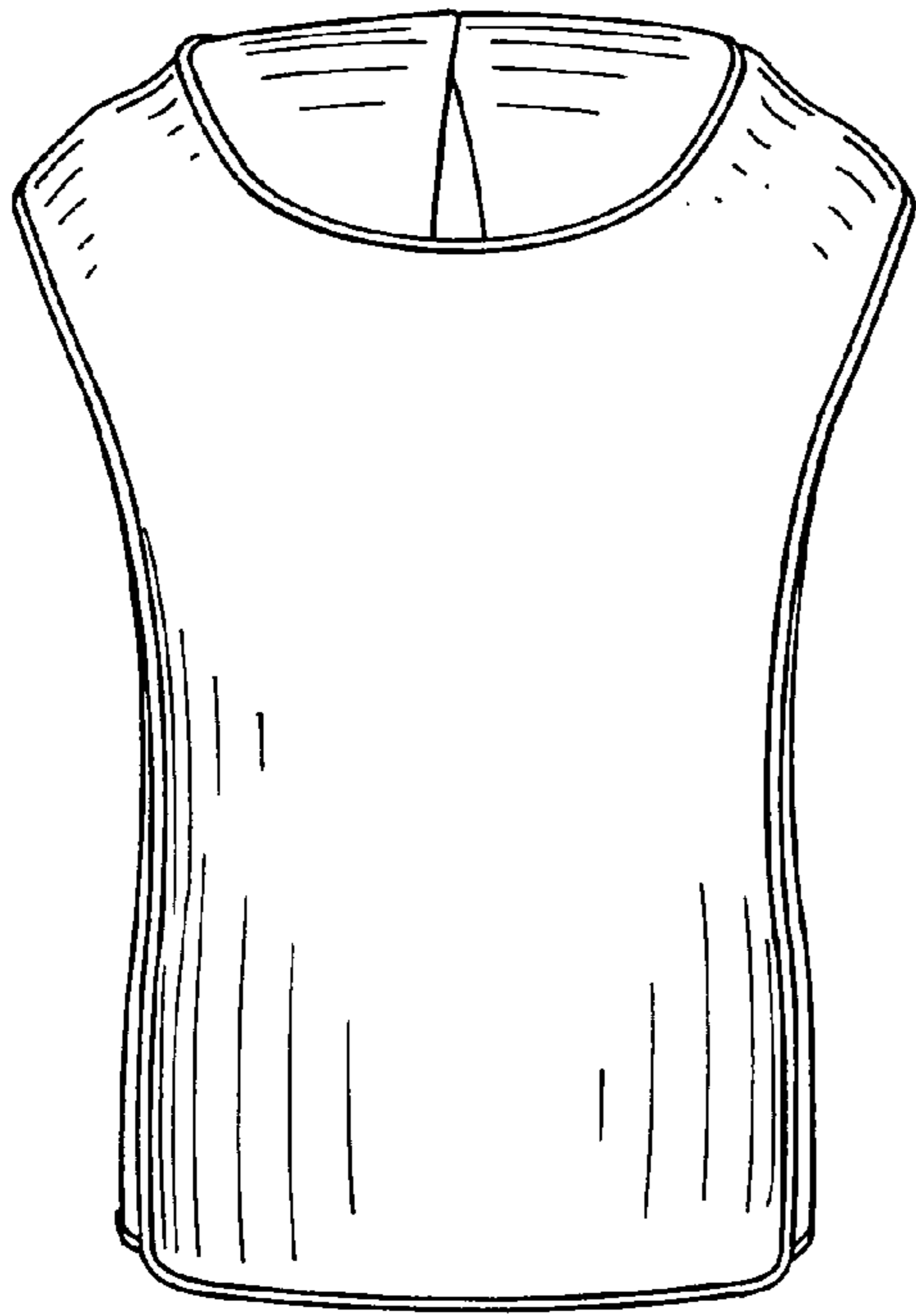

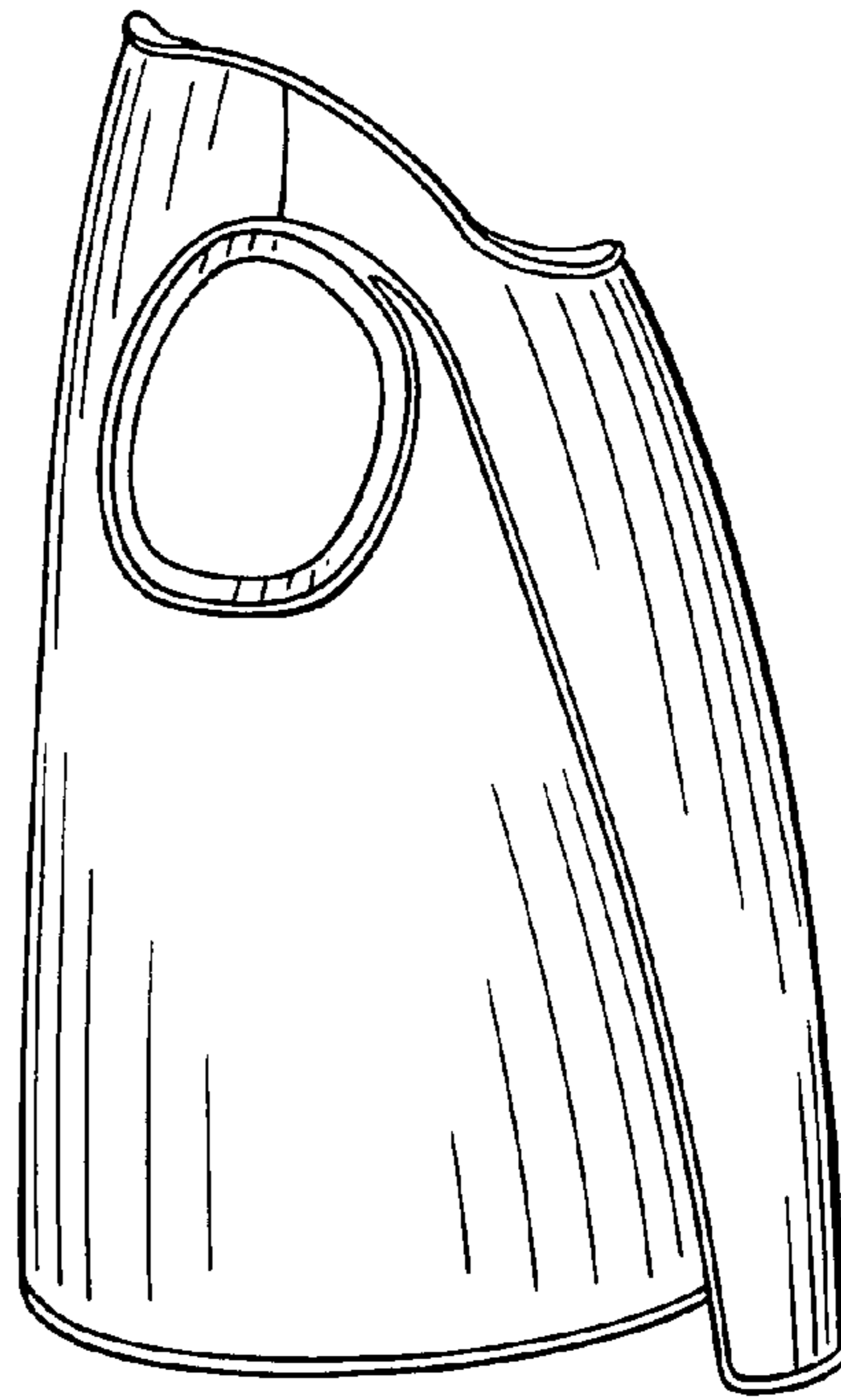

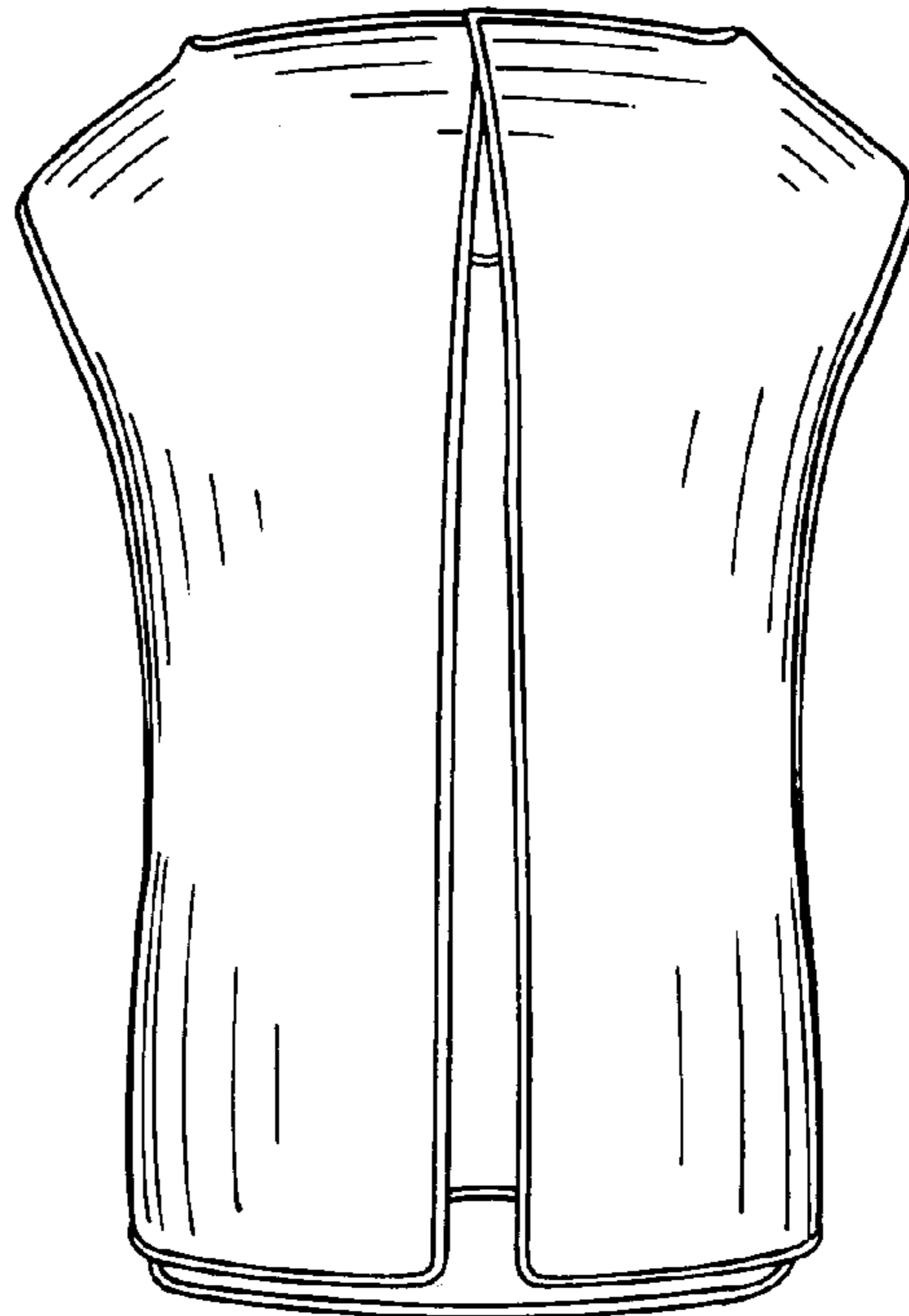

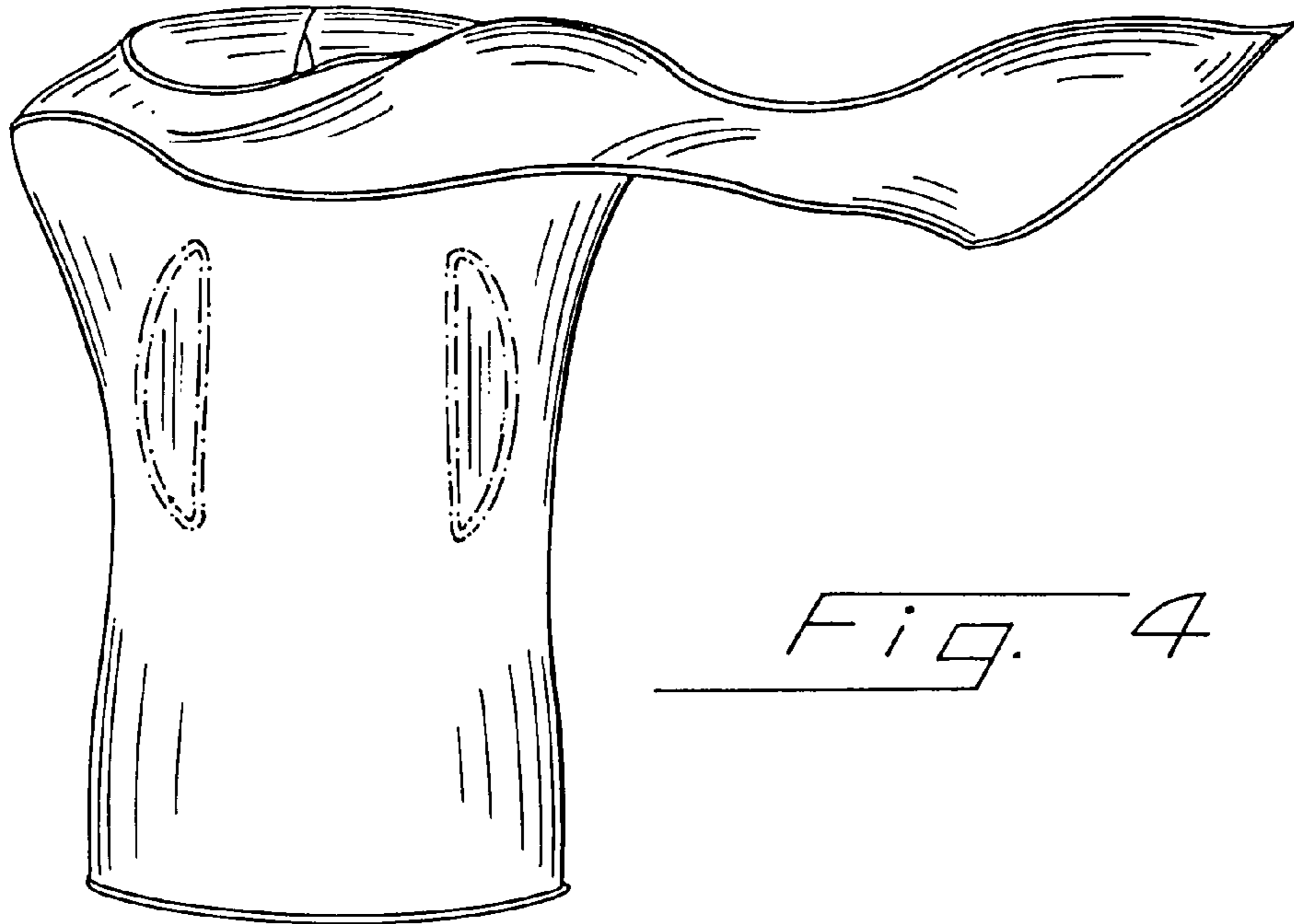

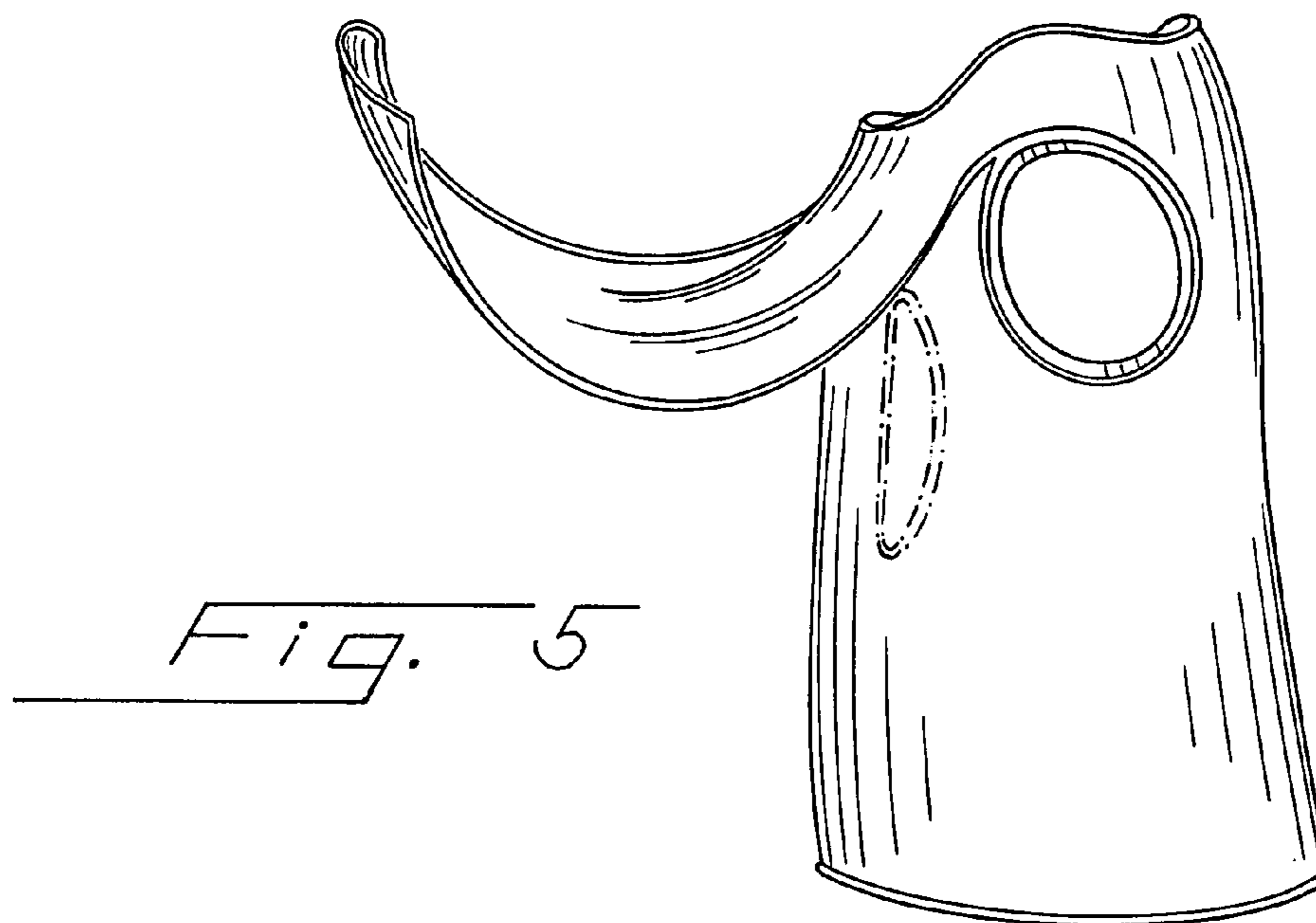

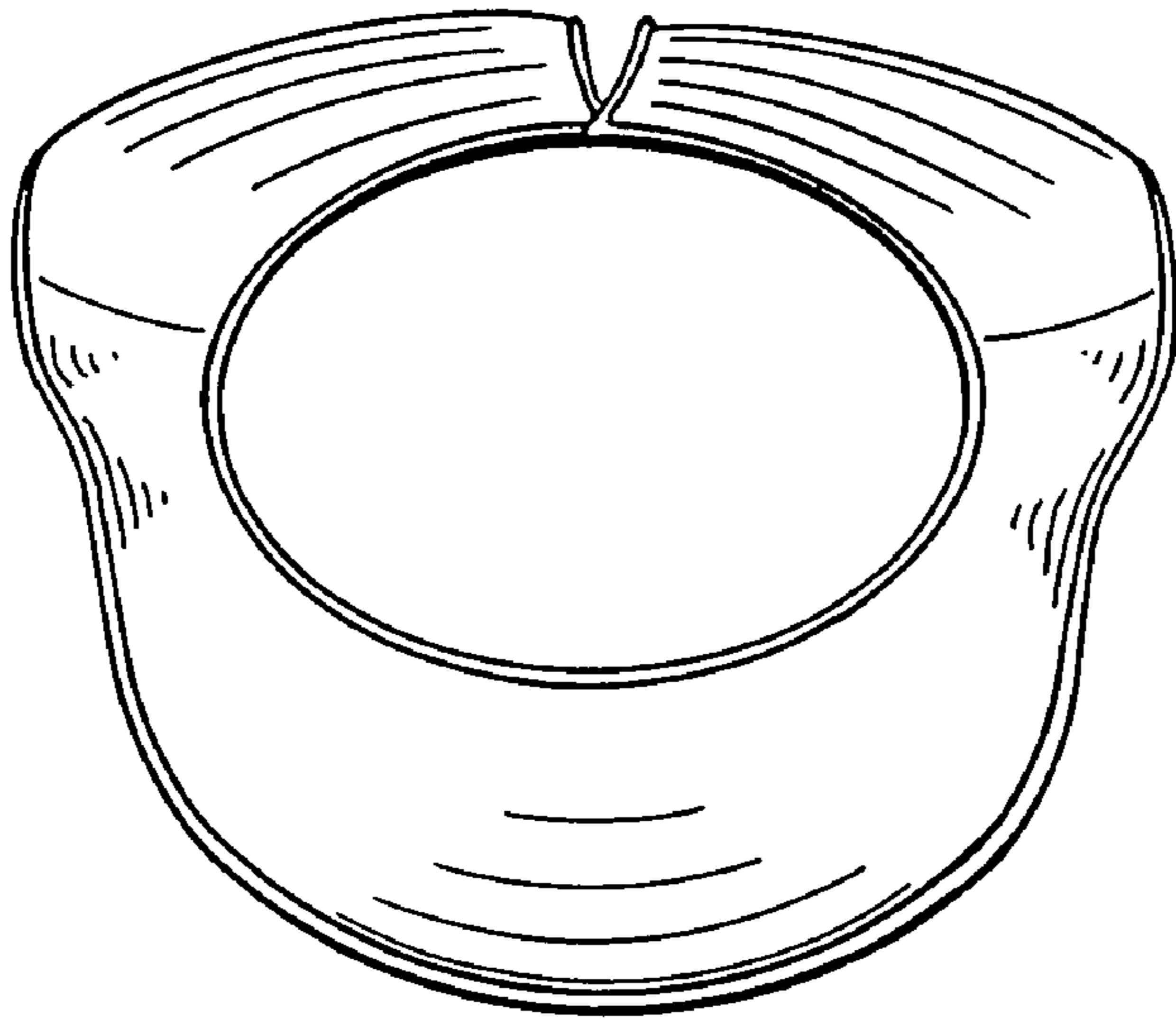

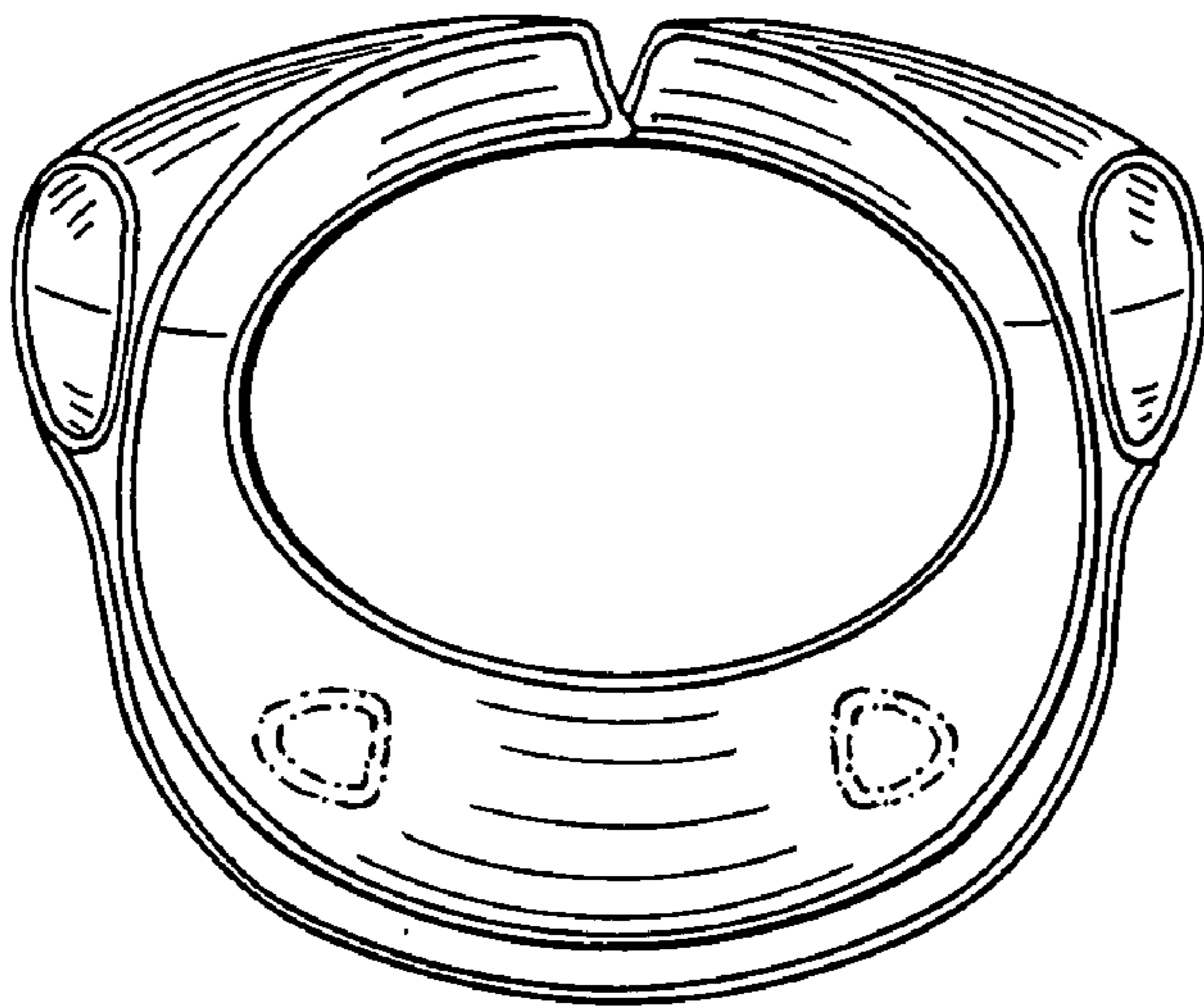
