**DESCRIPTION**

FIG. 1 is a perspective view showing my new design for a container/collection device.

FIG. 13 is a back view of the container/collection device of FIG. 9.

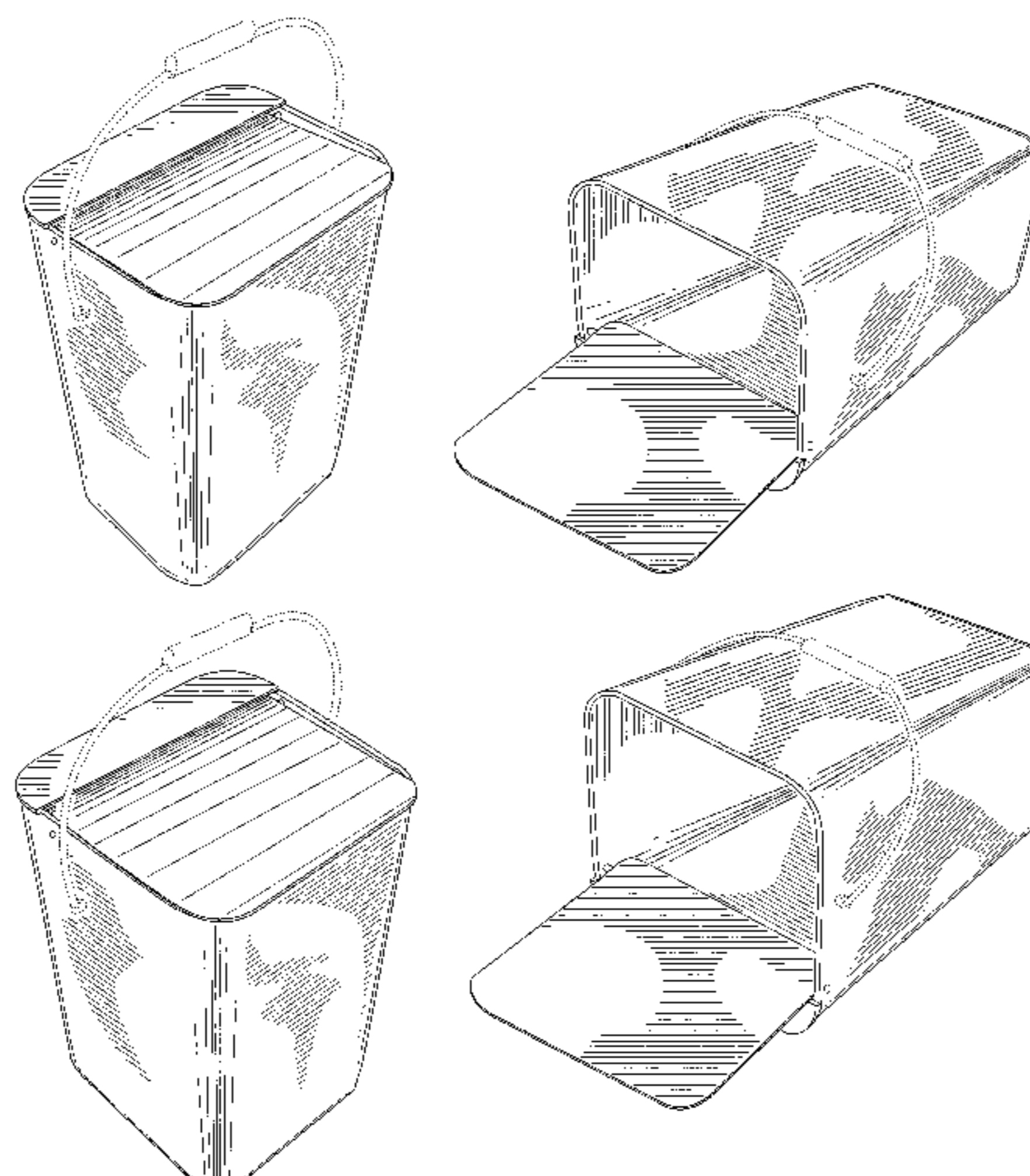
FIG. 14 is a left side view of the container/collection device of FIG. 9.

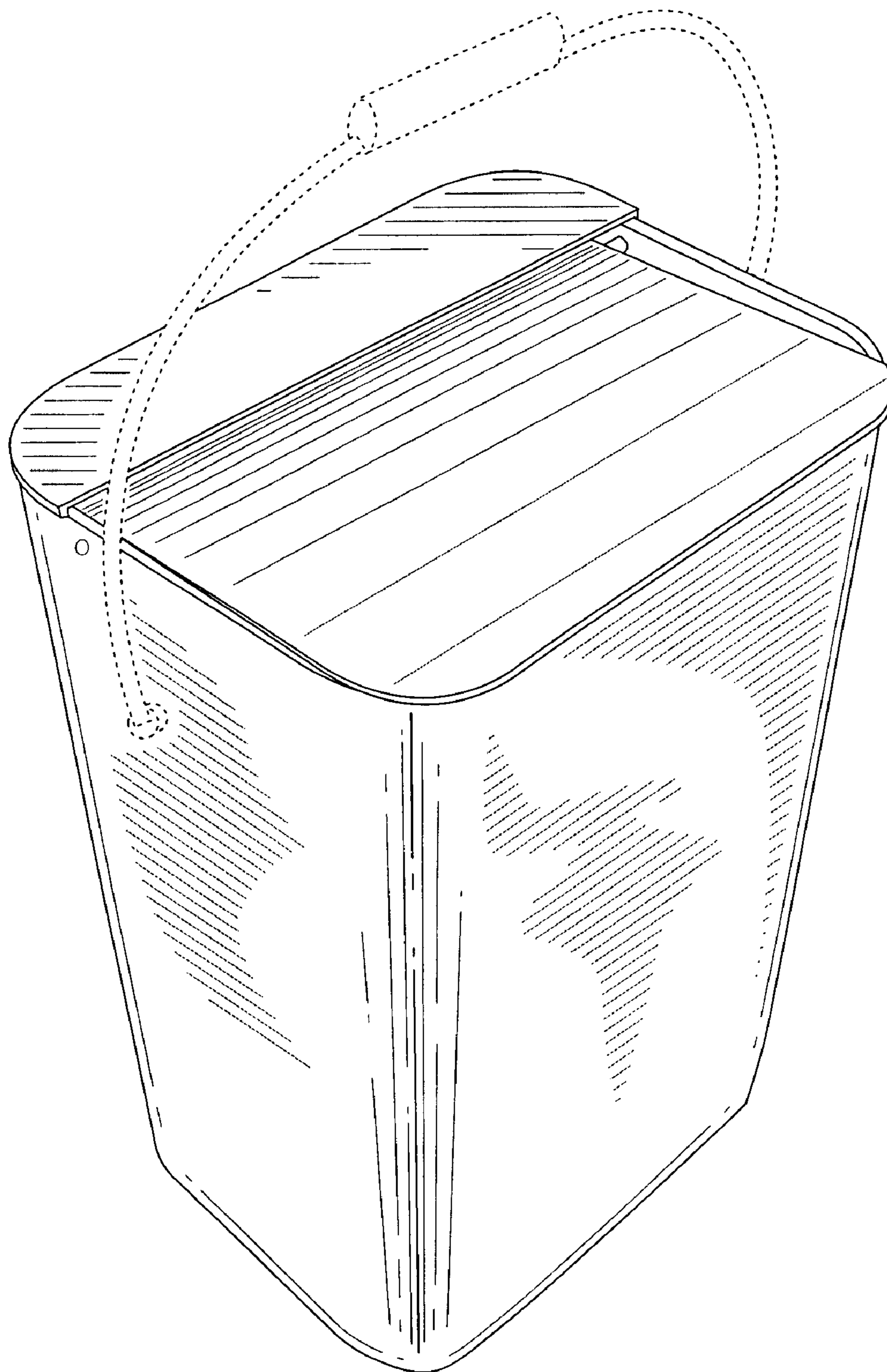

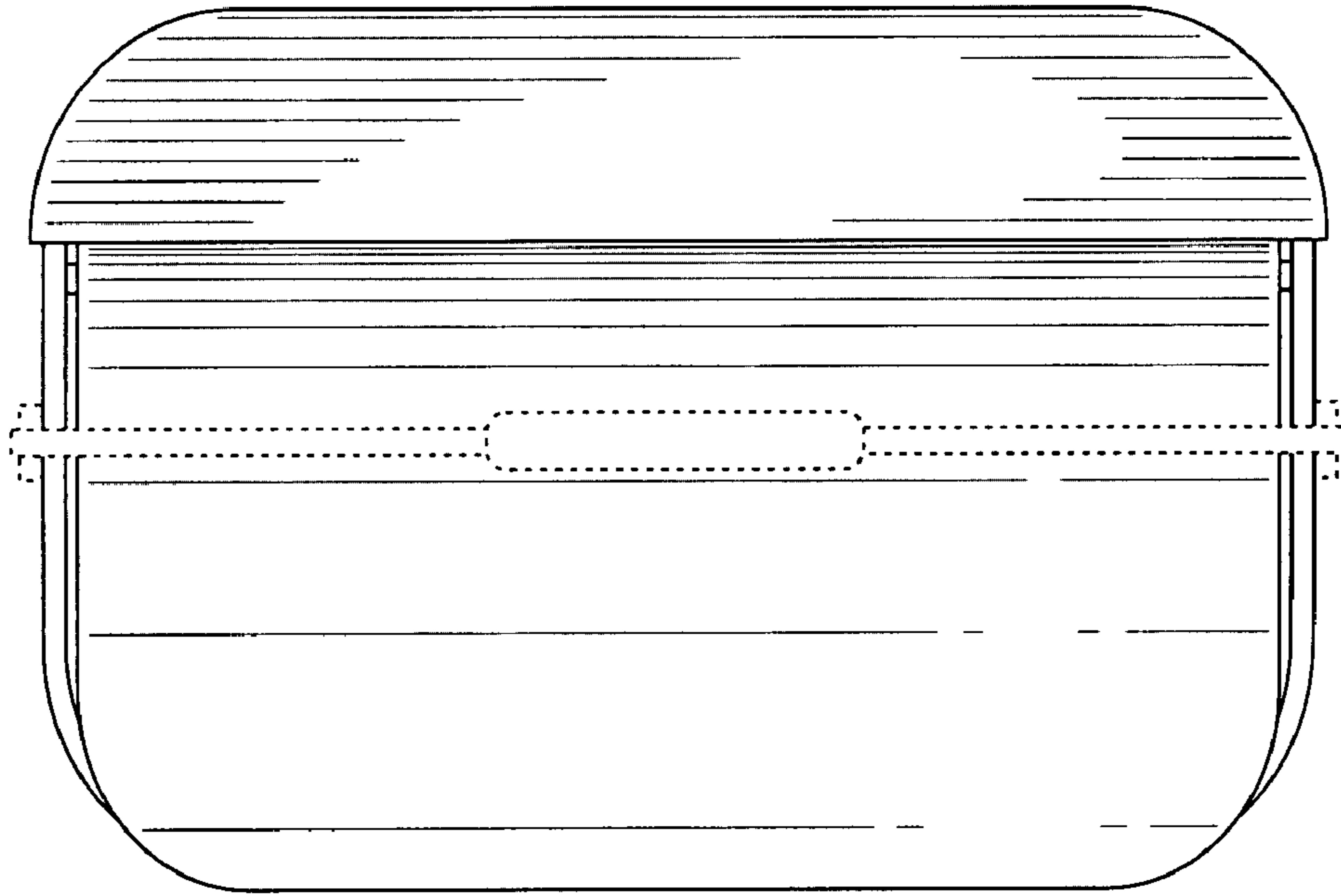

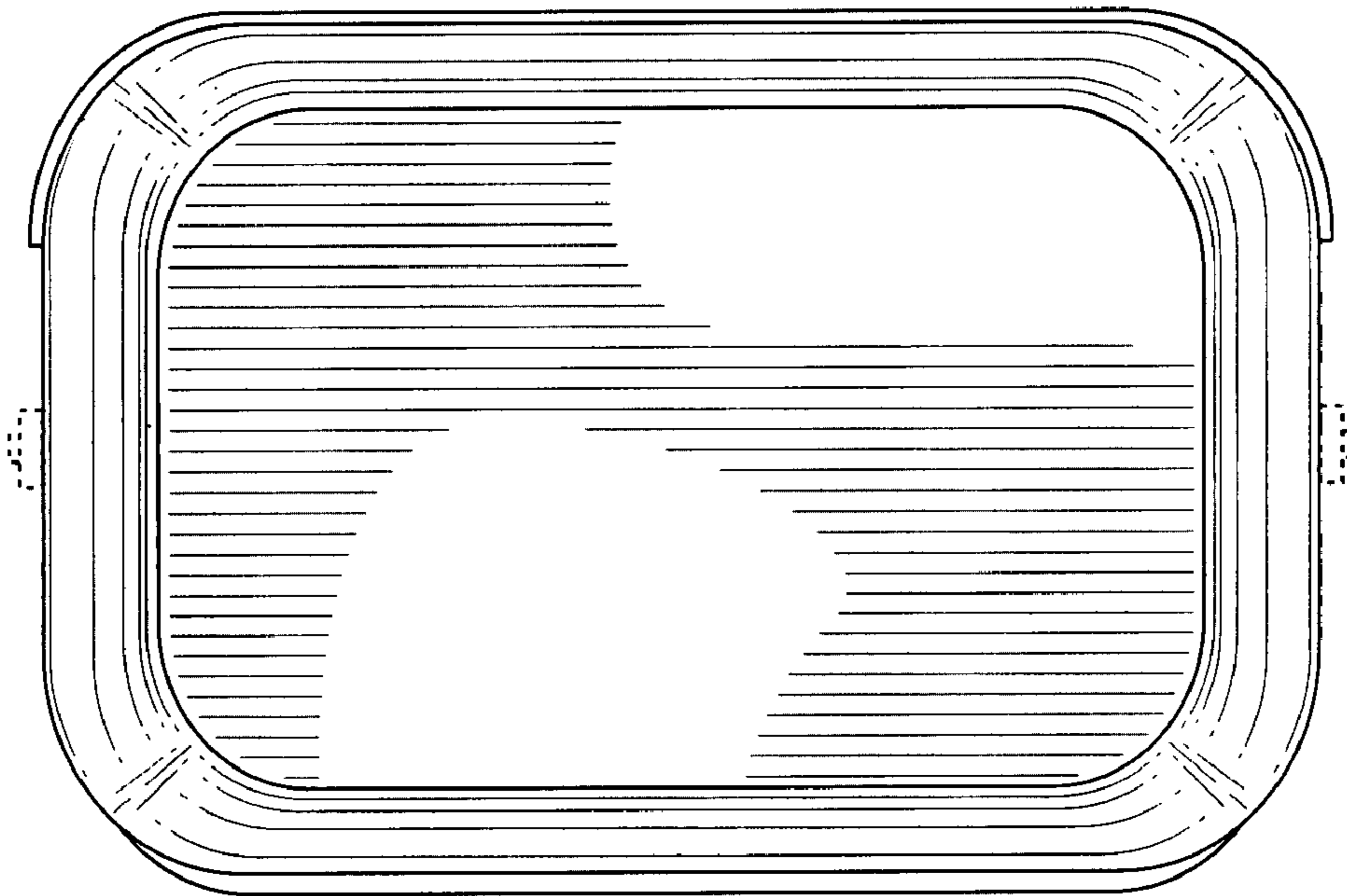

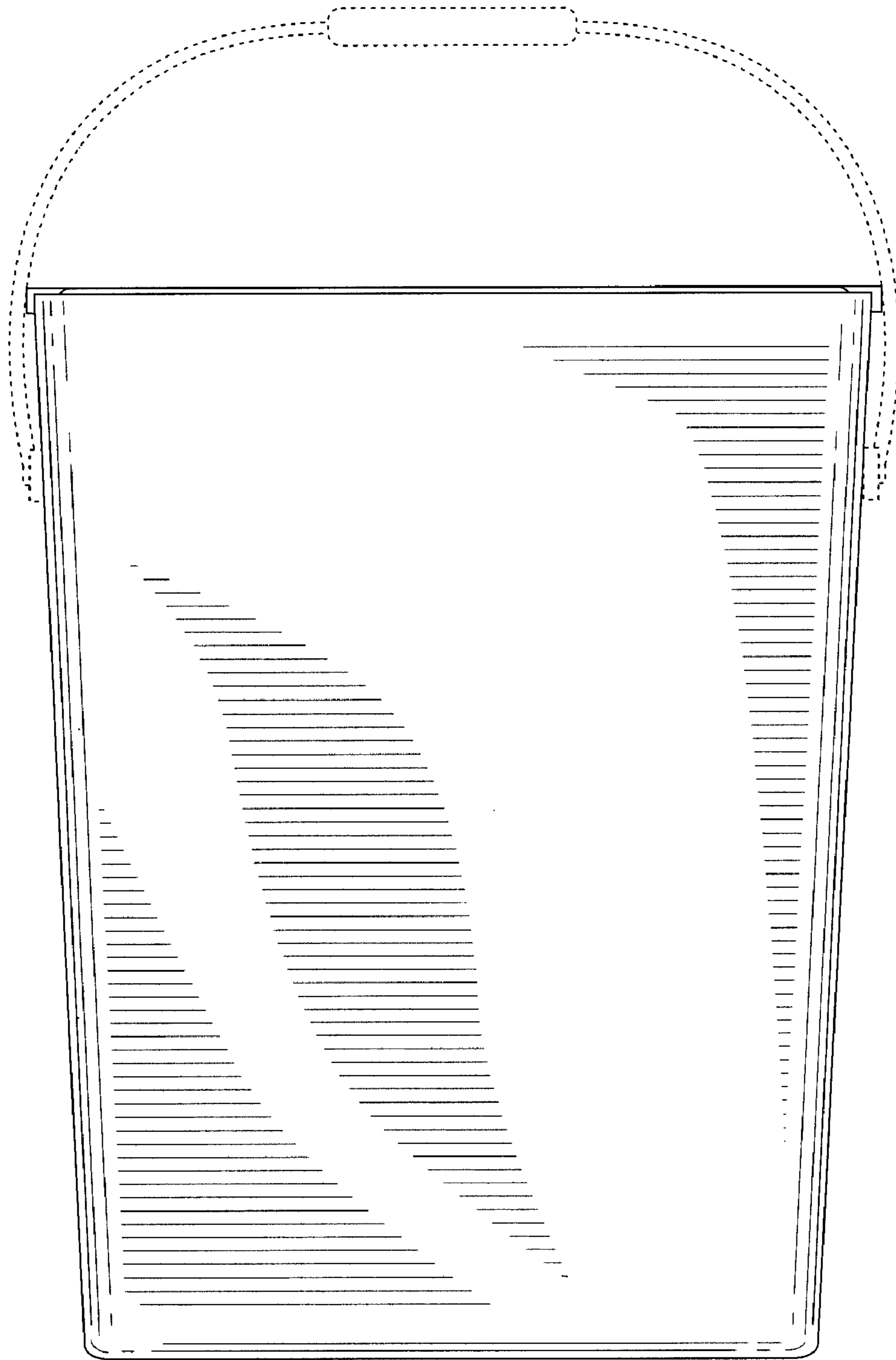

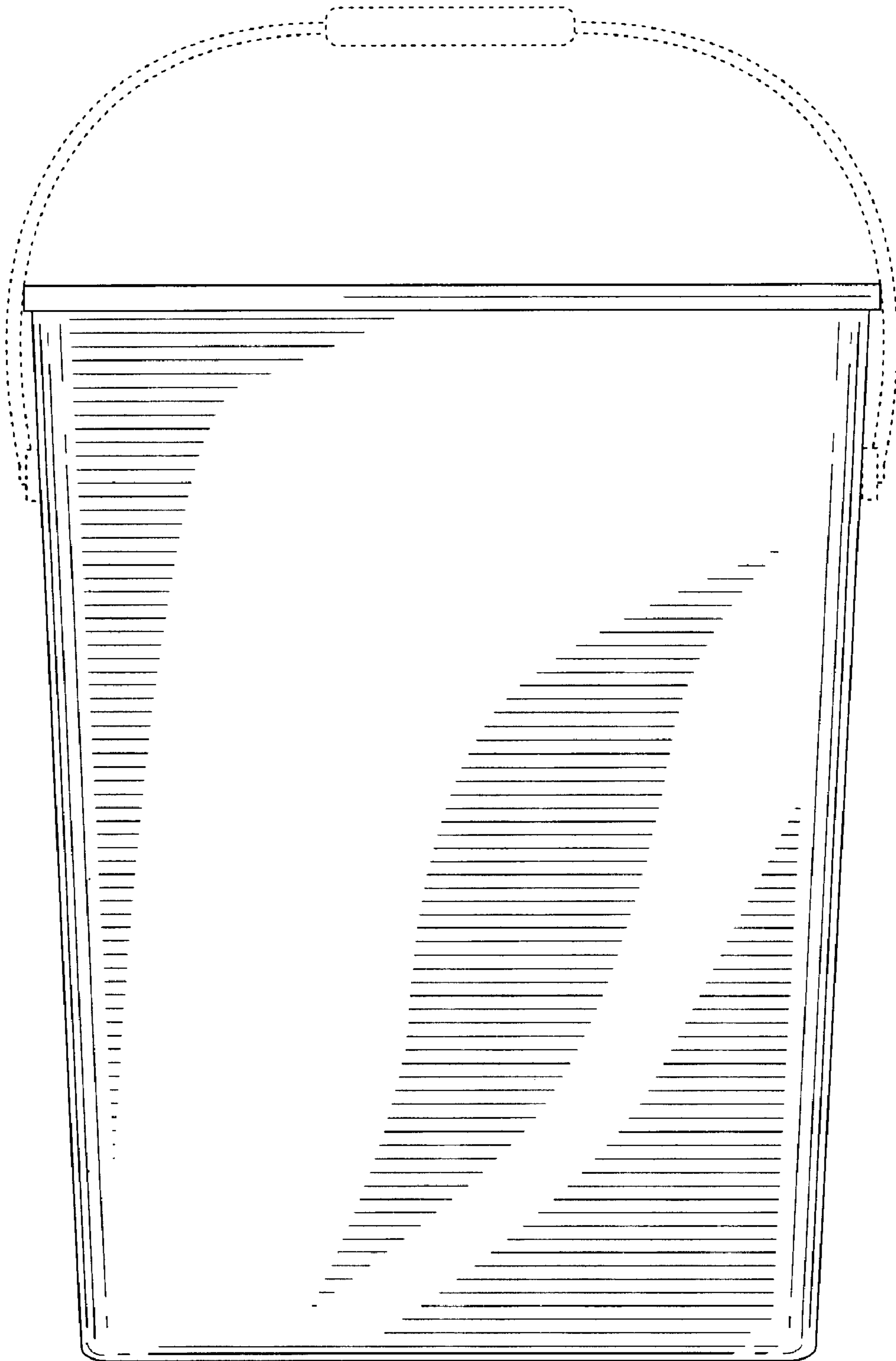

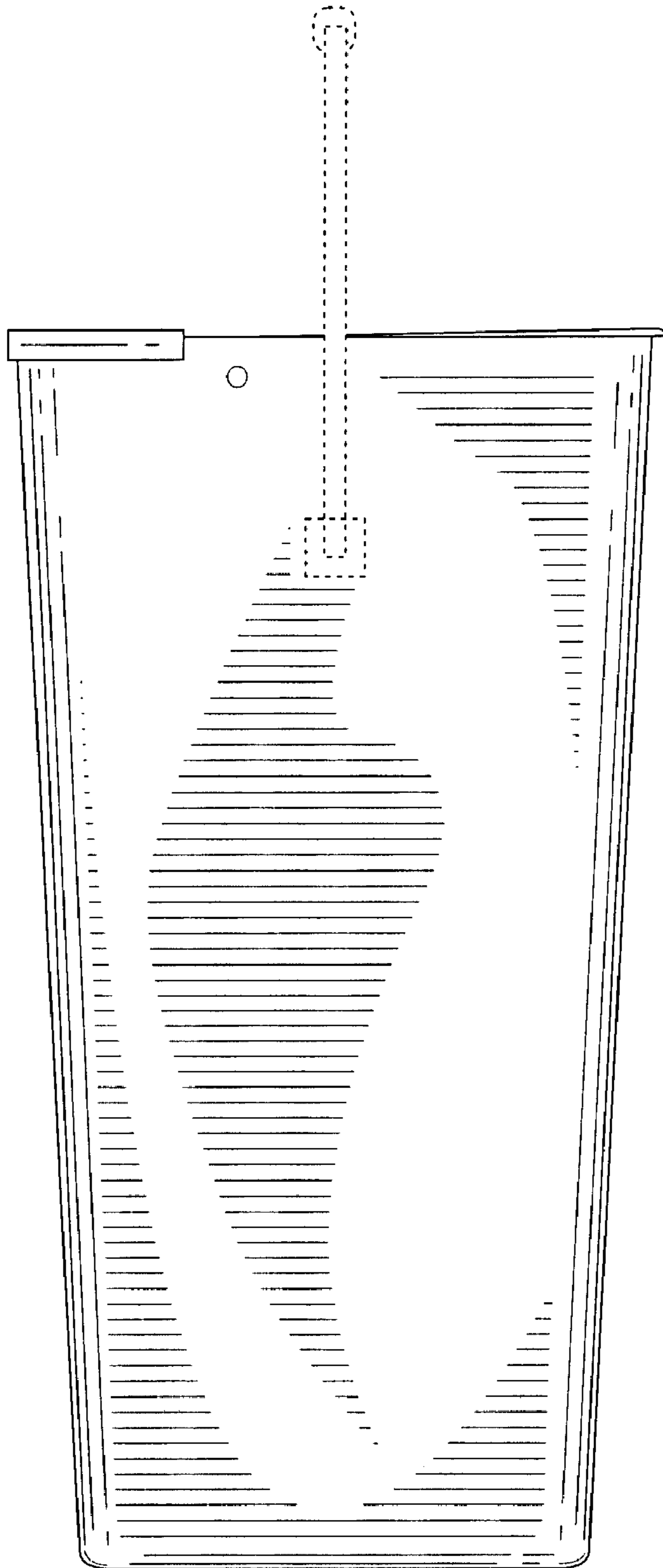

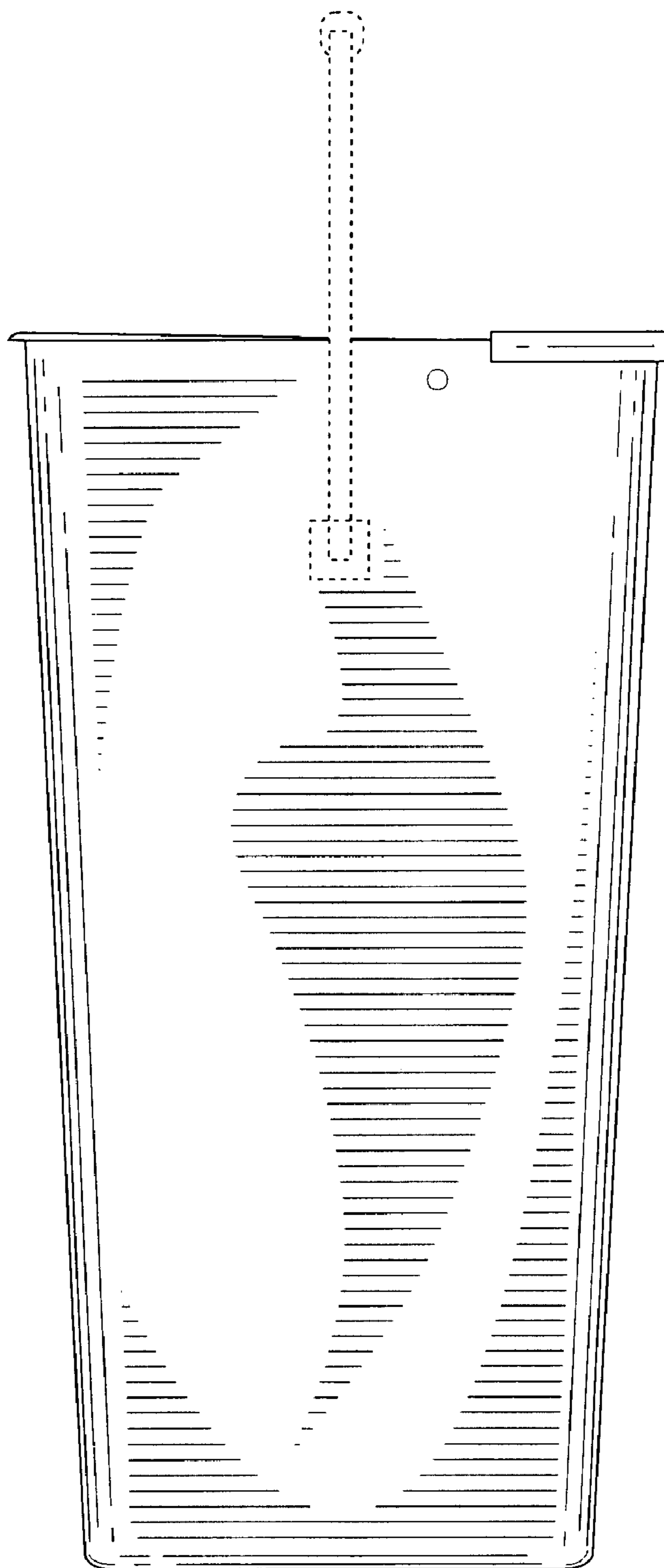

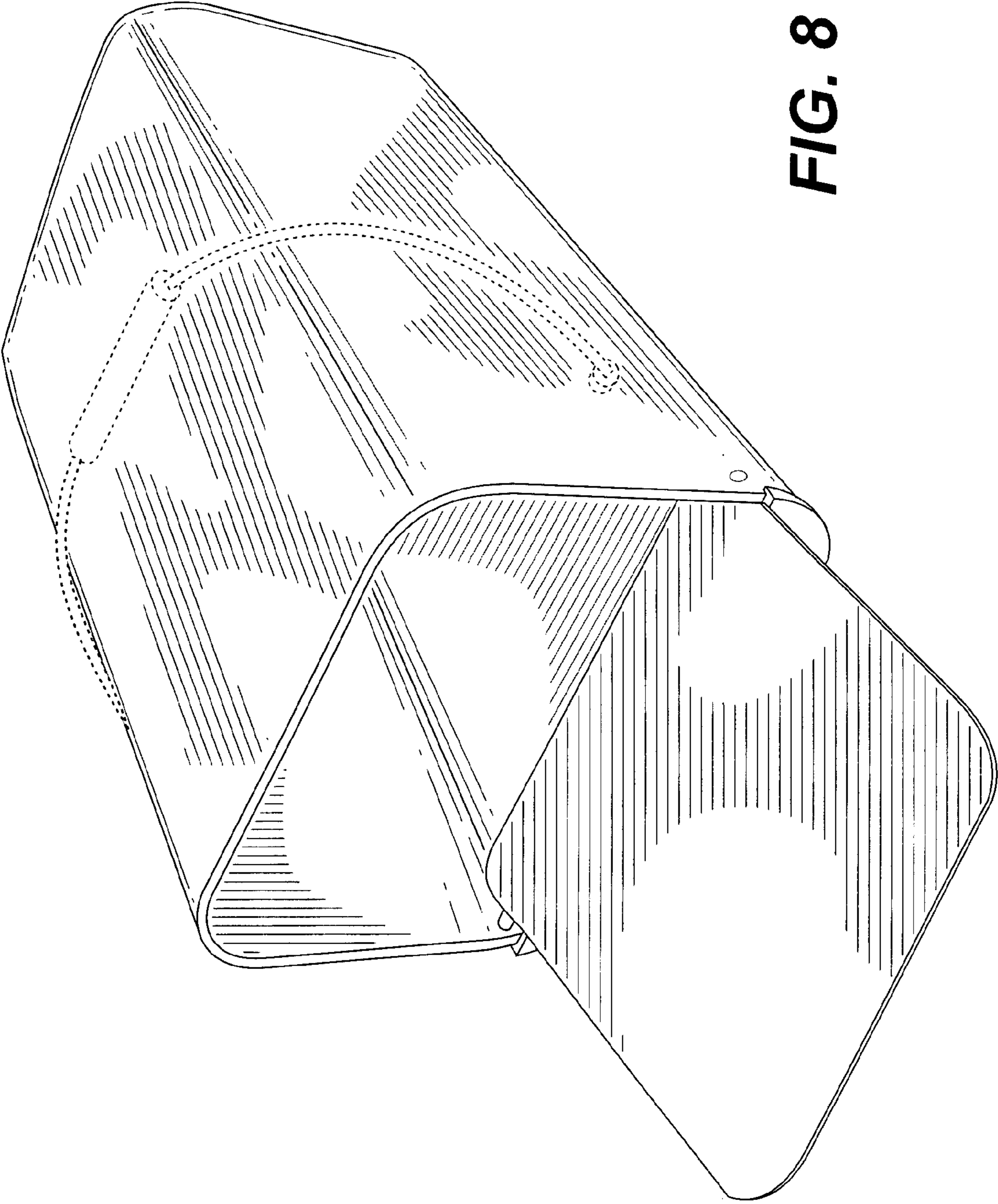

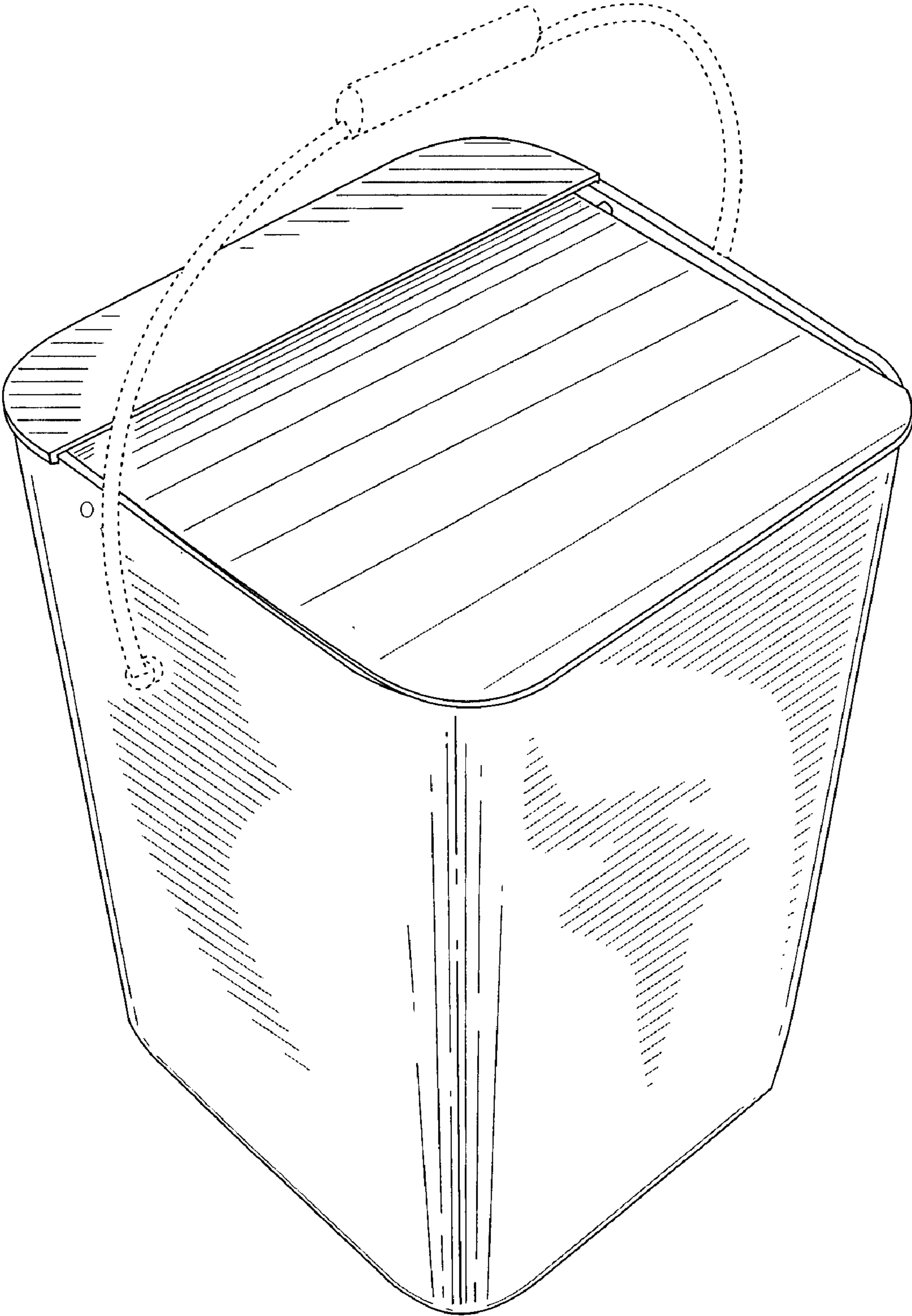

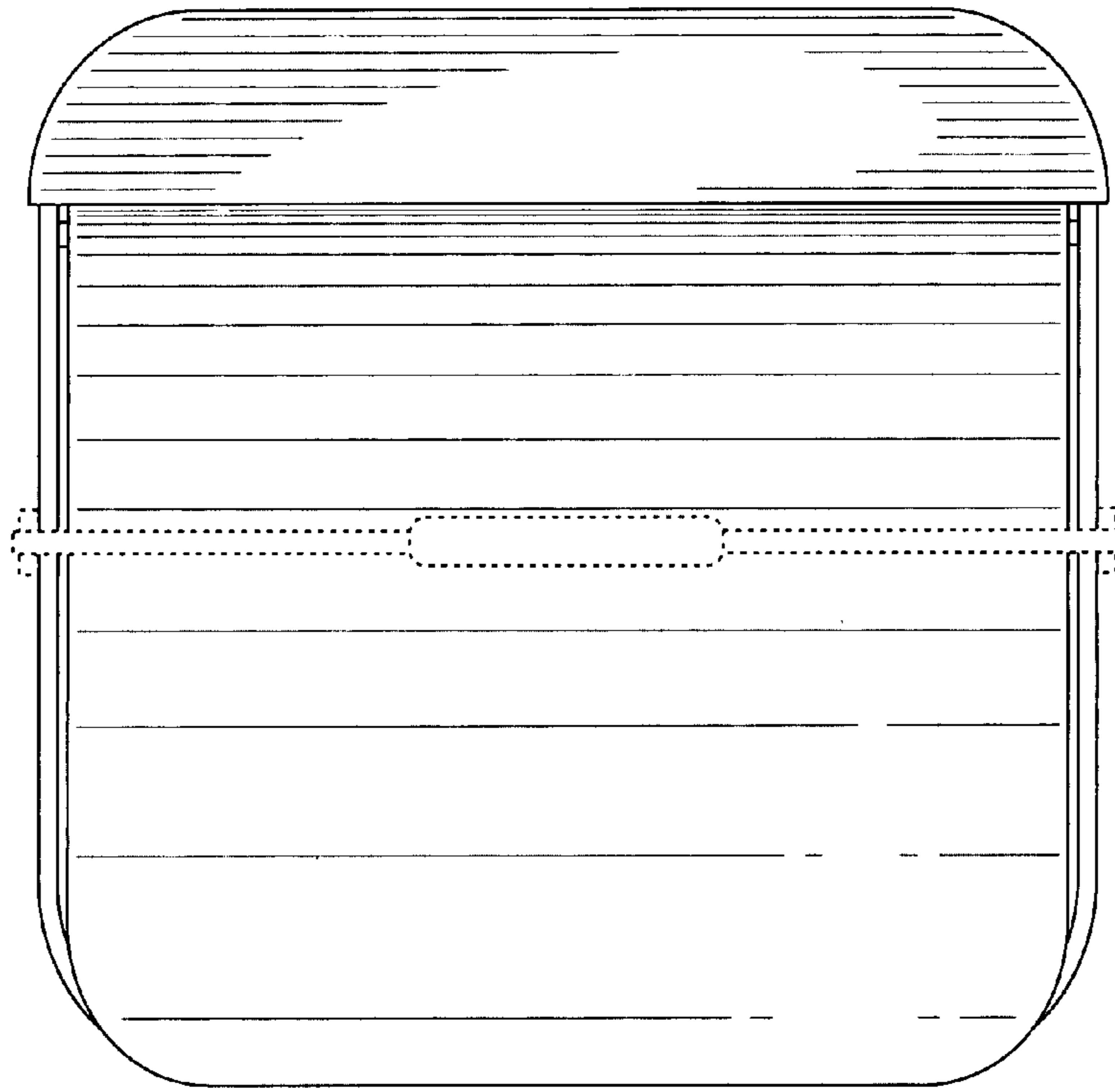




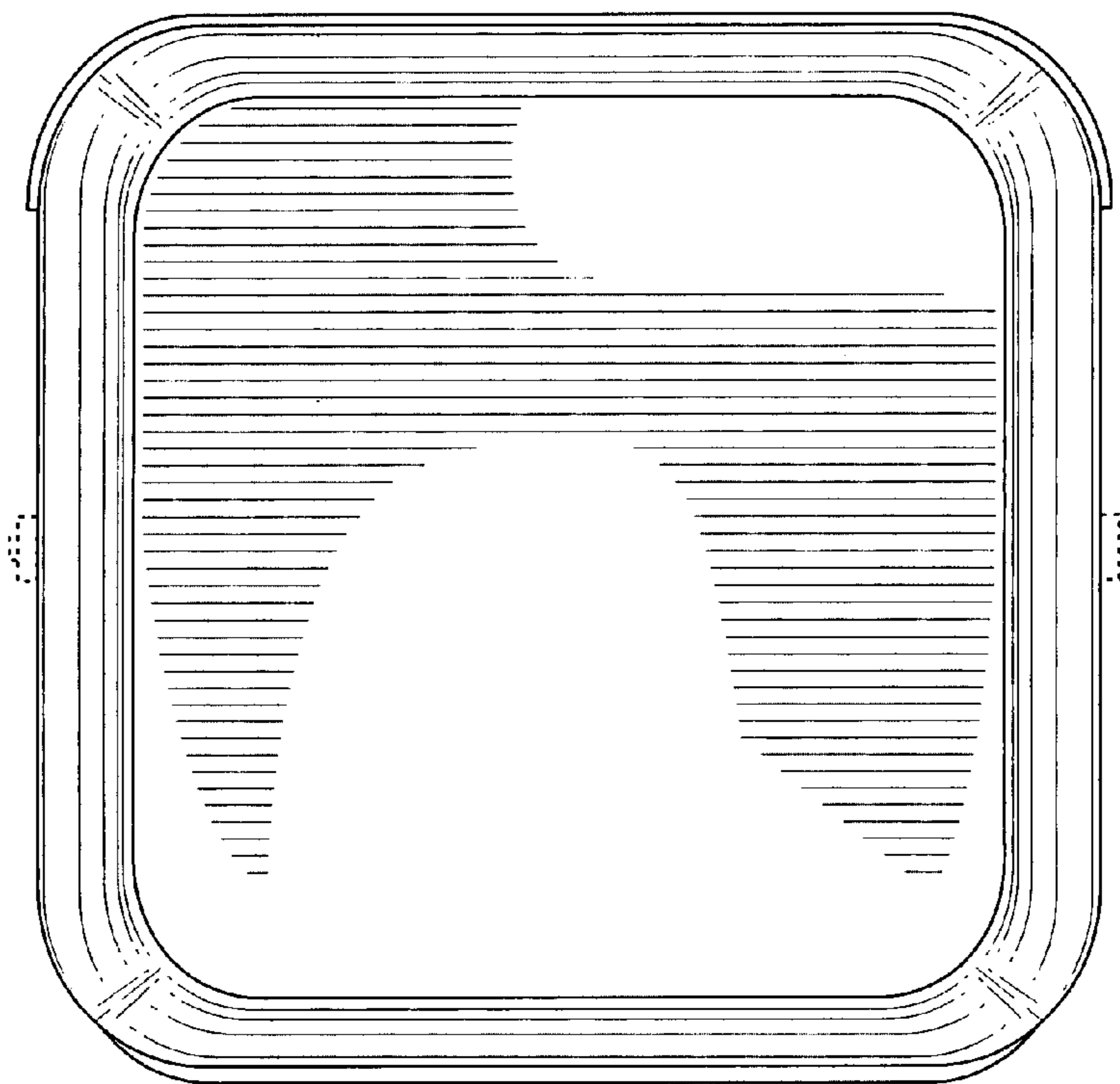

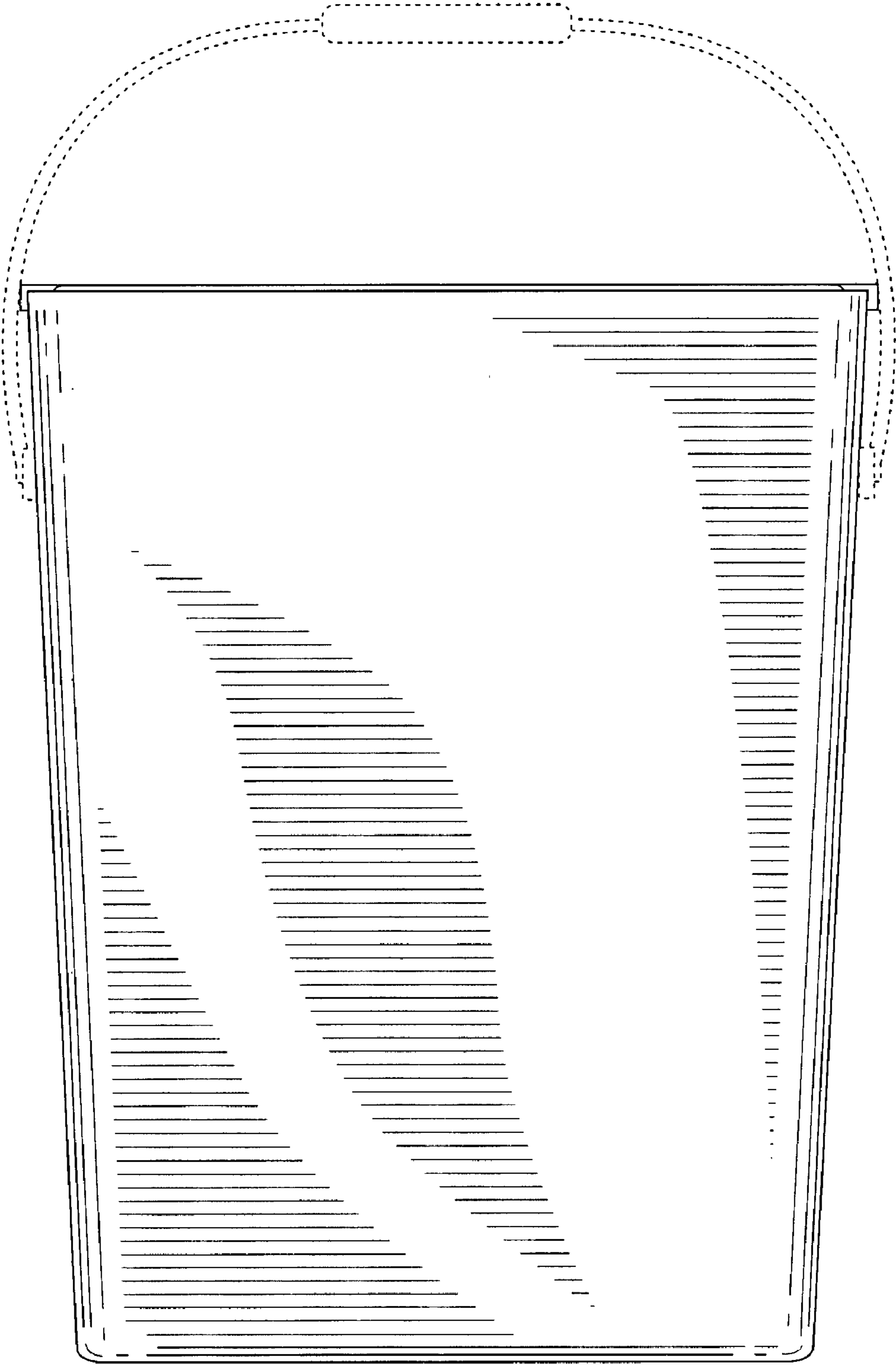

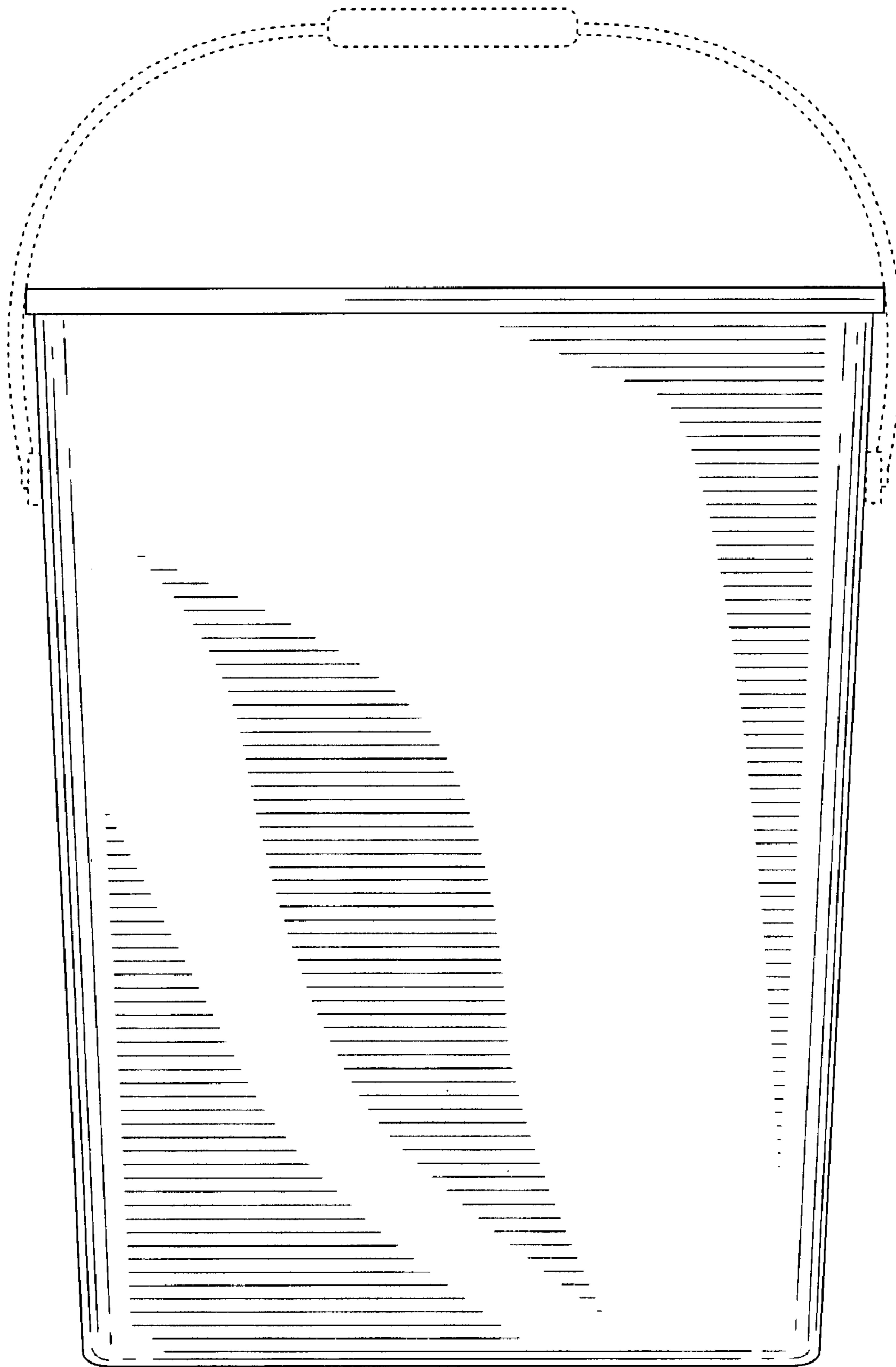

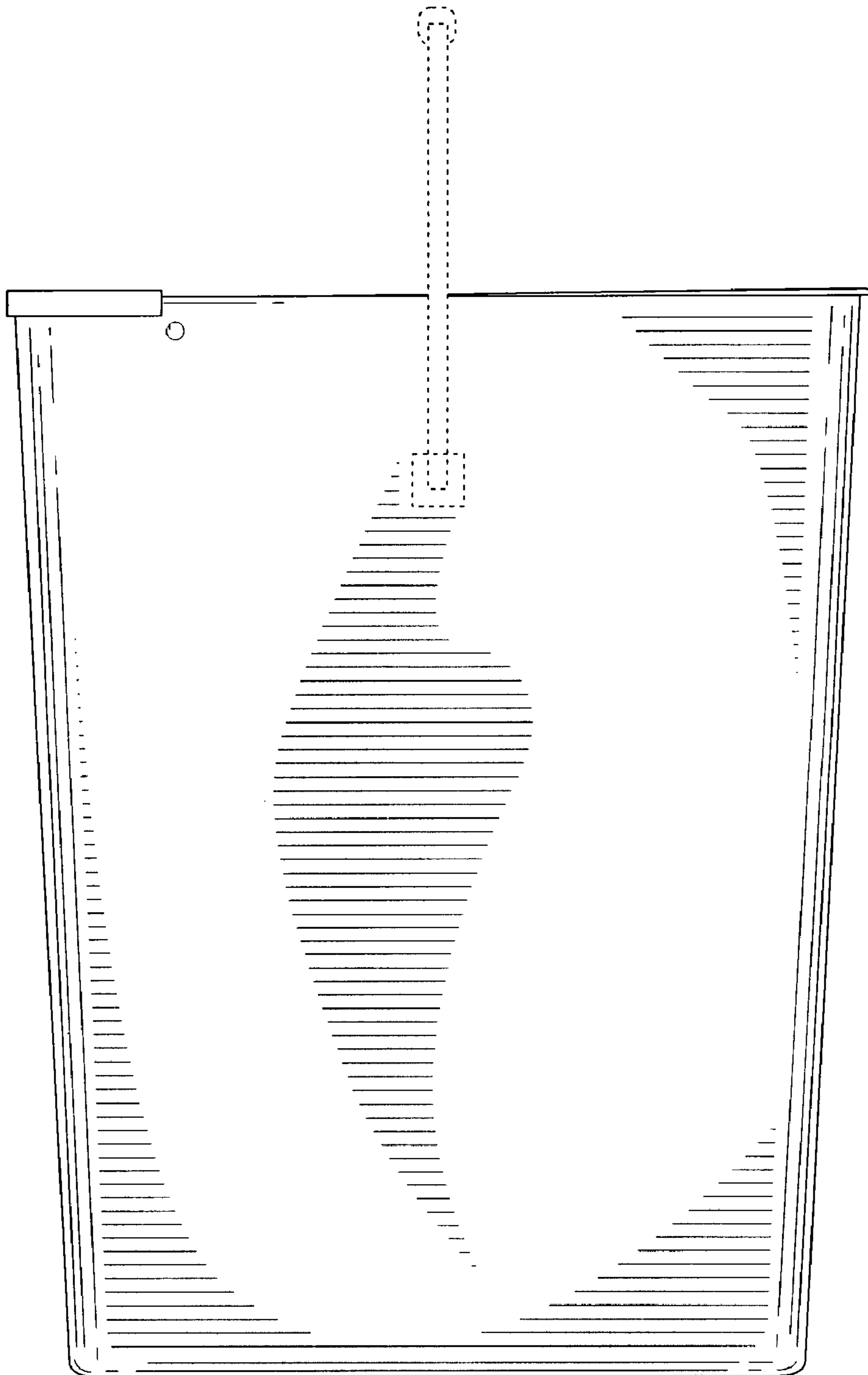

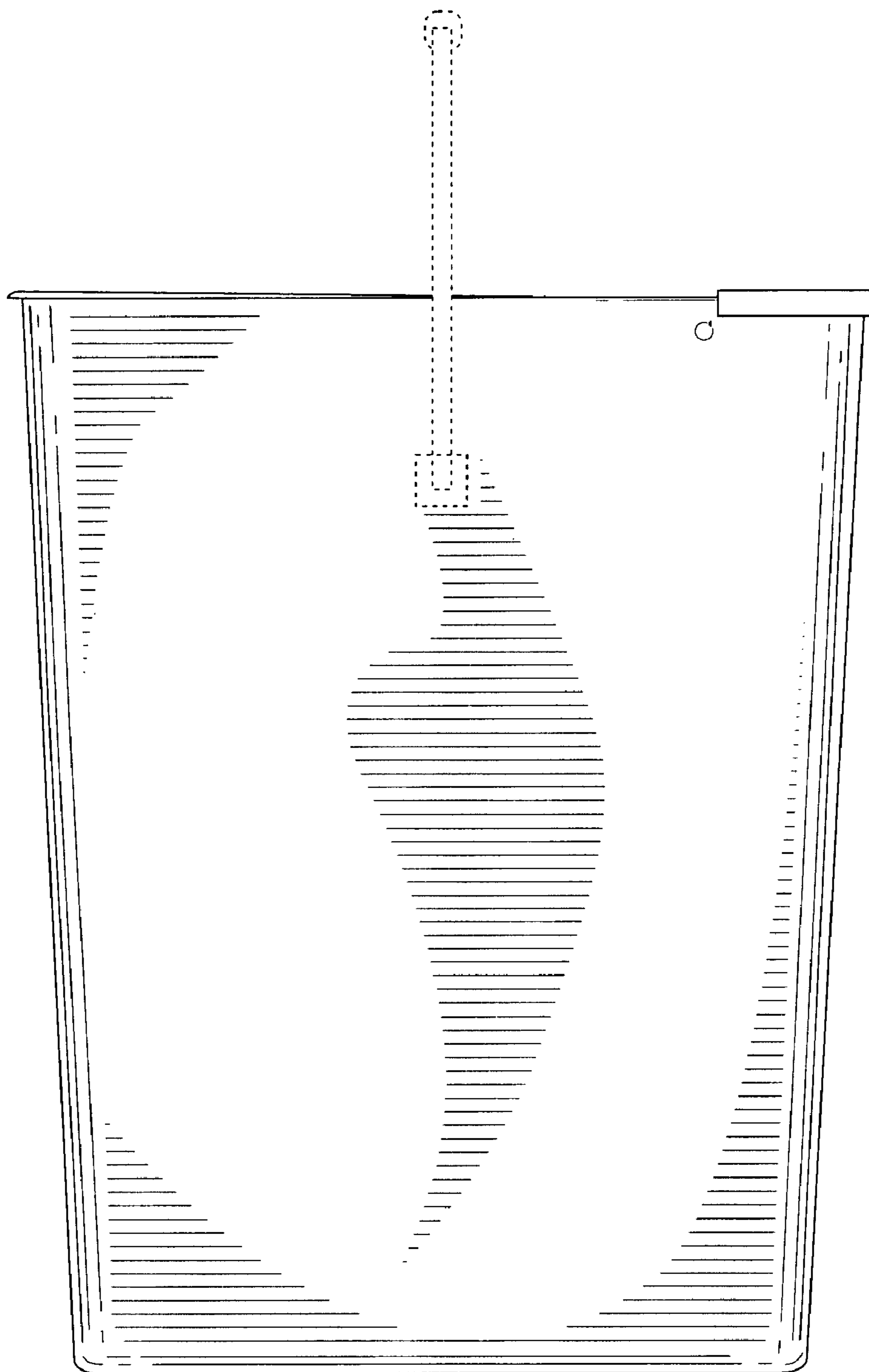

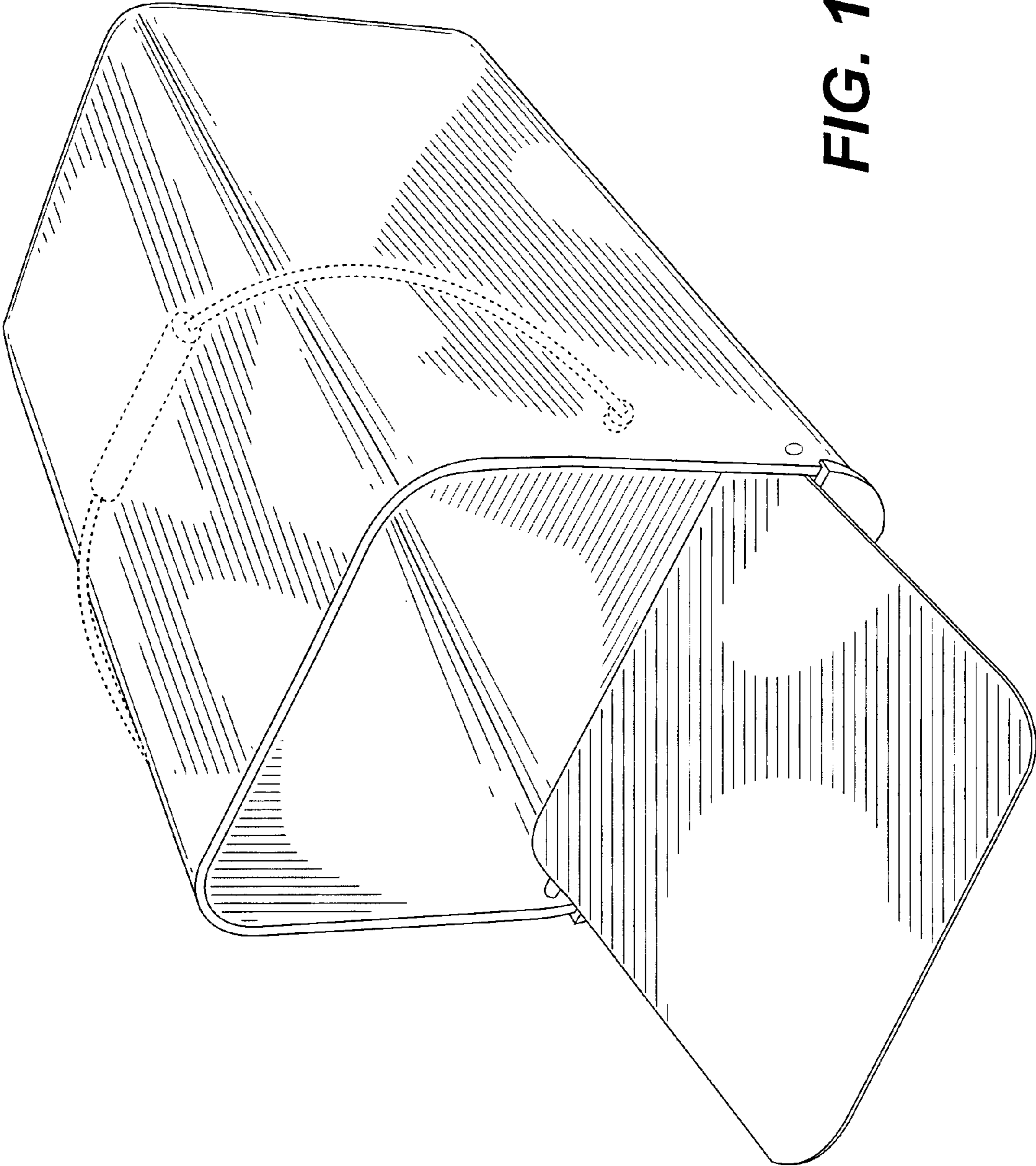
