(57) **CLAIM**

The ornamental design for a portion of a tote bag, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of a portion of a tote bag showing the new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a right side elevational view thereof, a left side elevational view thereof being a mirror image of the right side elevational view;

FIG. 5 is a top, front perspective view of a second embodiment of a portion of a tote bag;

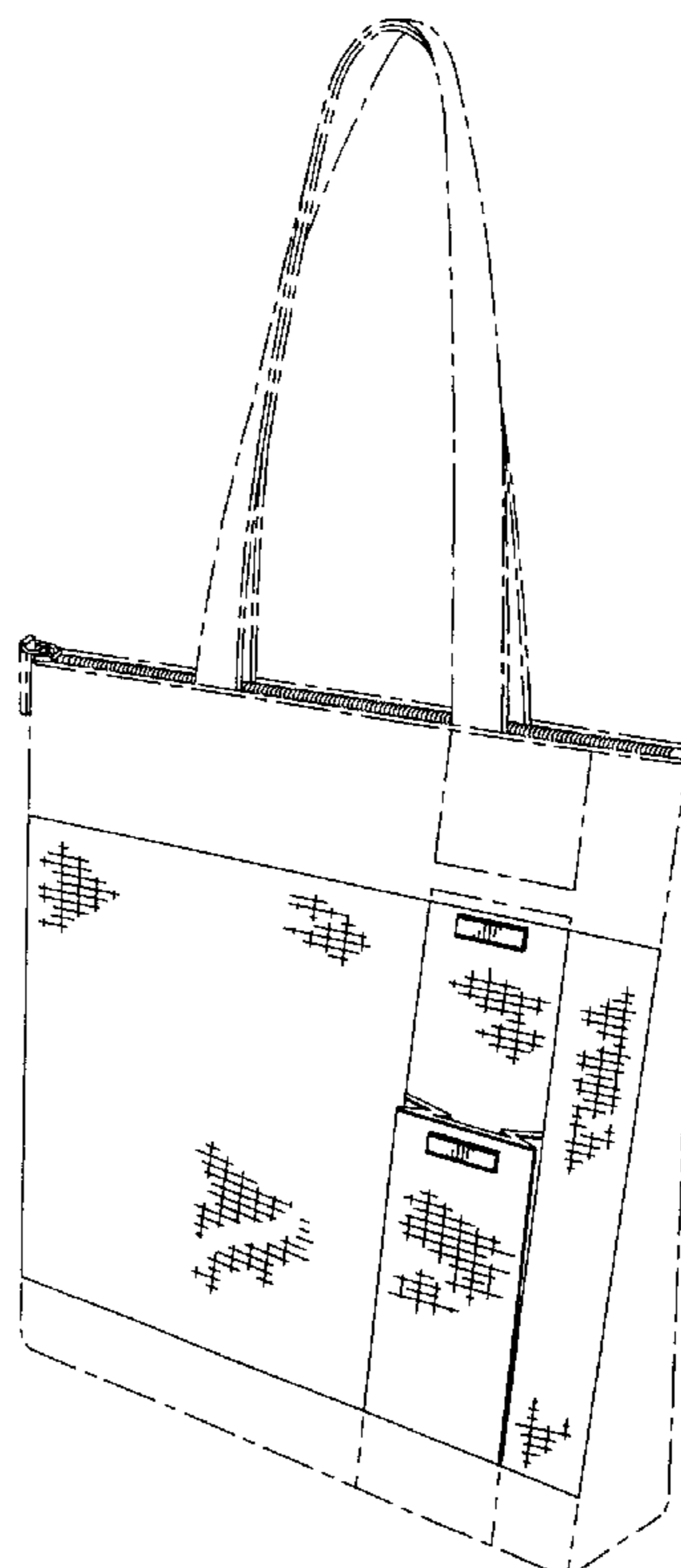
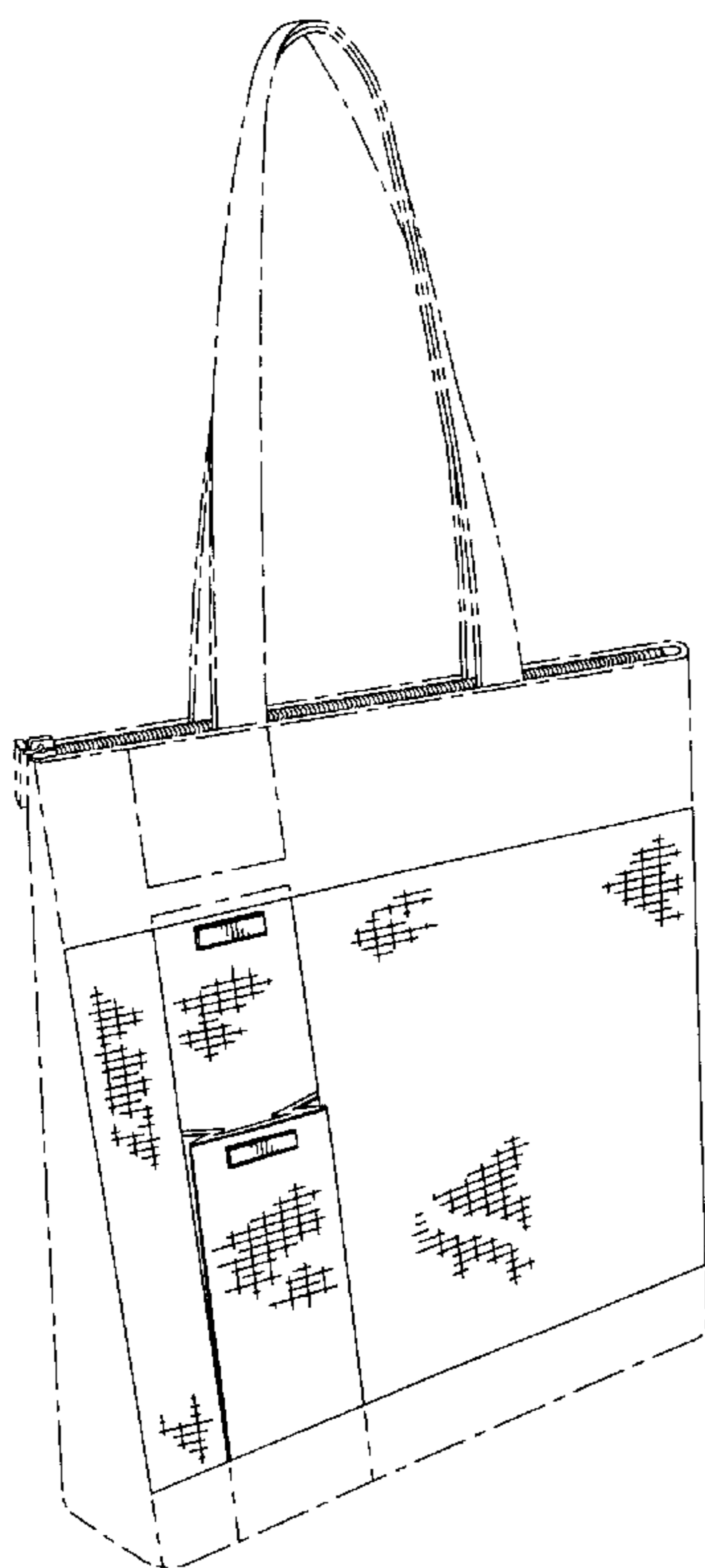
FIG. 6 is a front elevation view thereof;

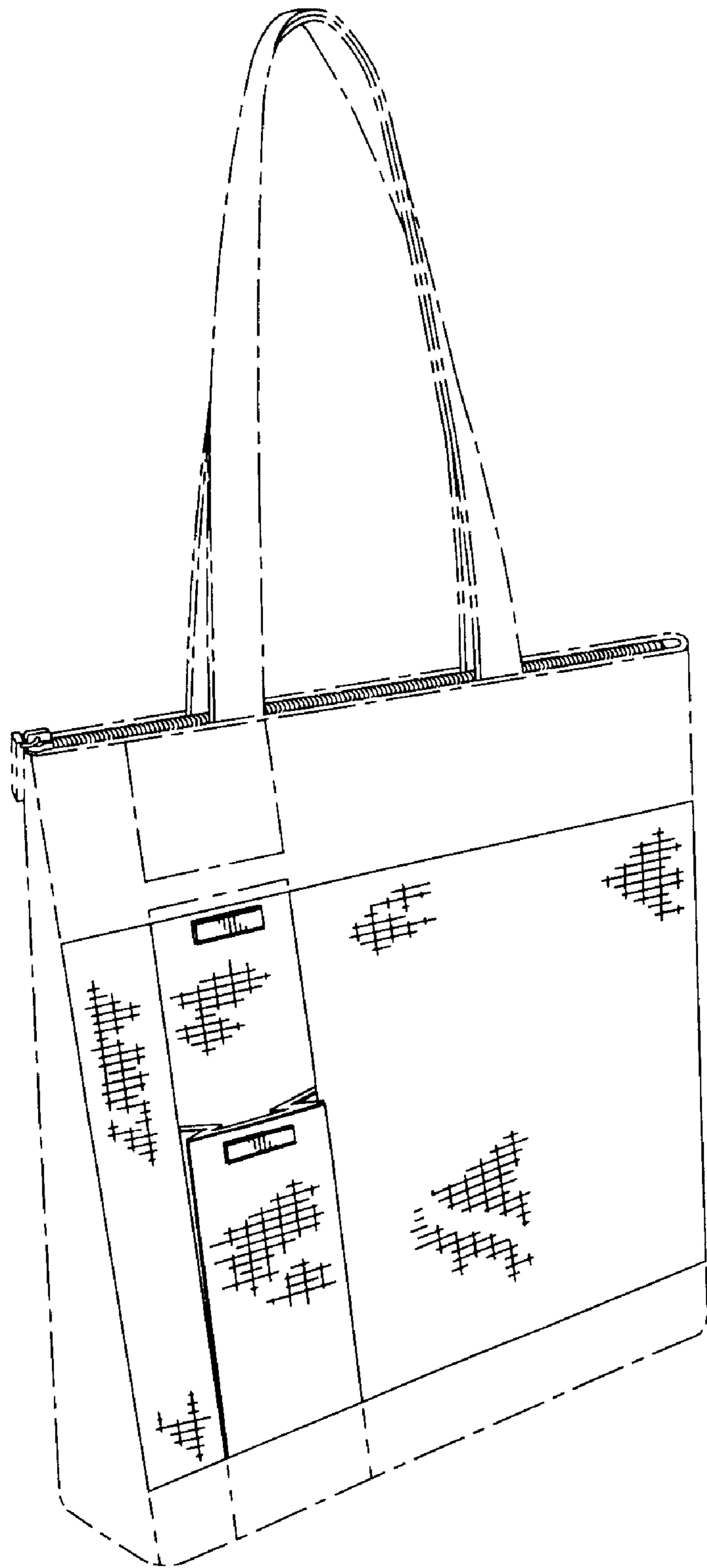

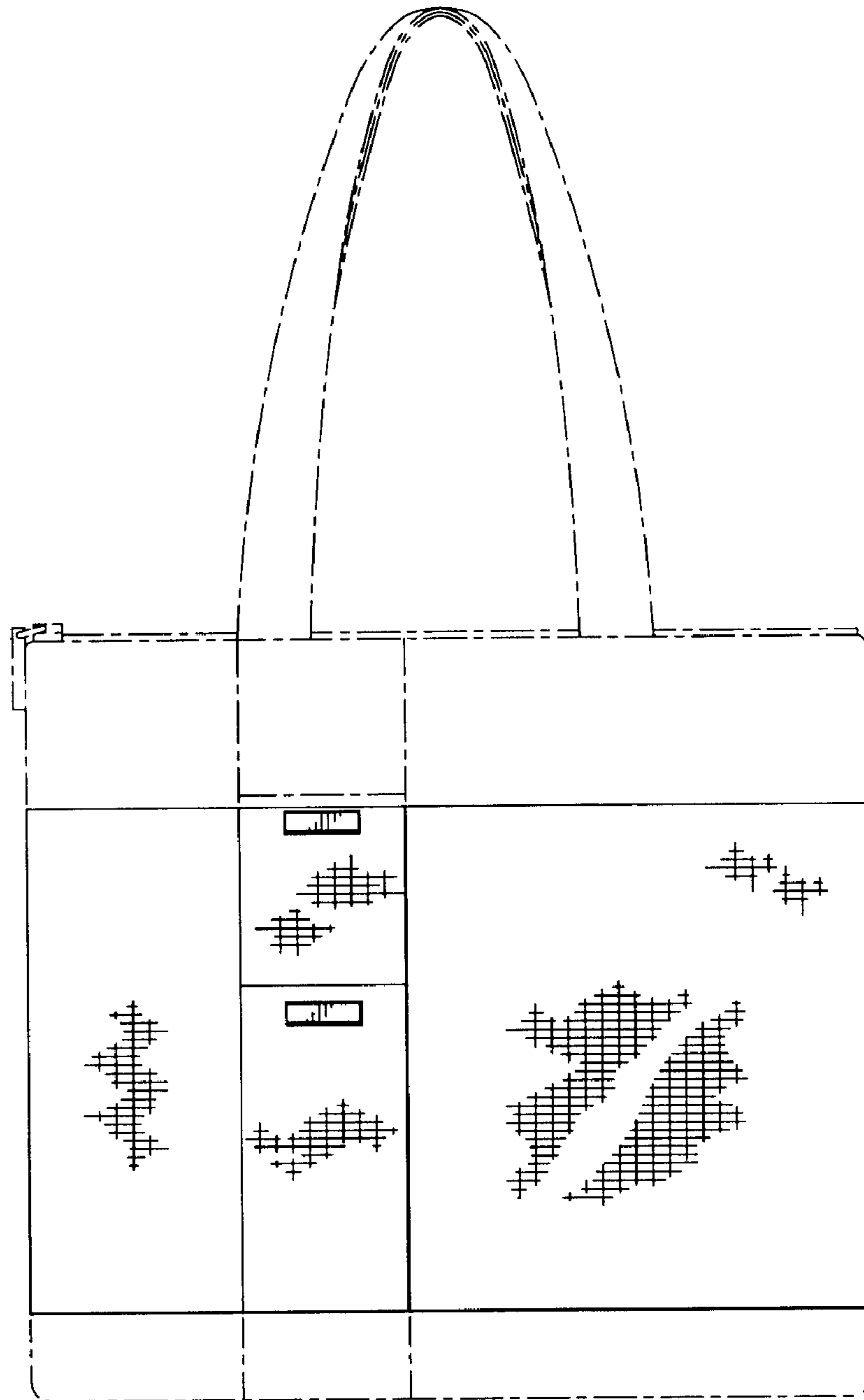

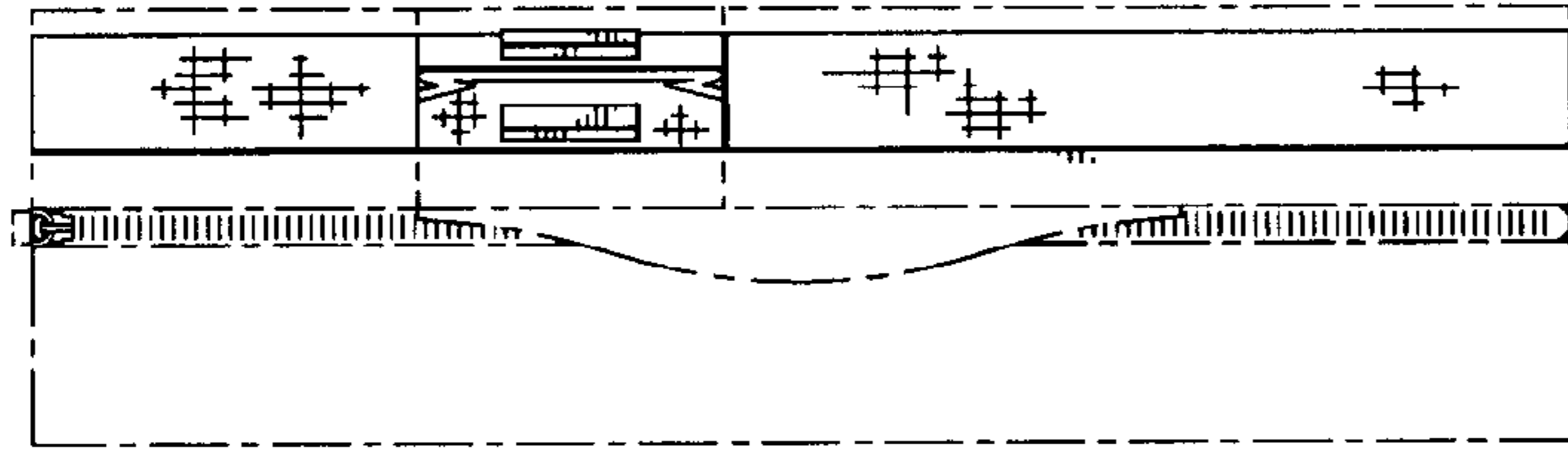

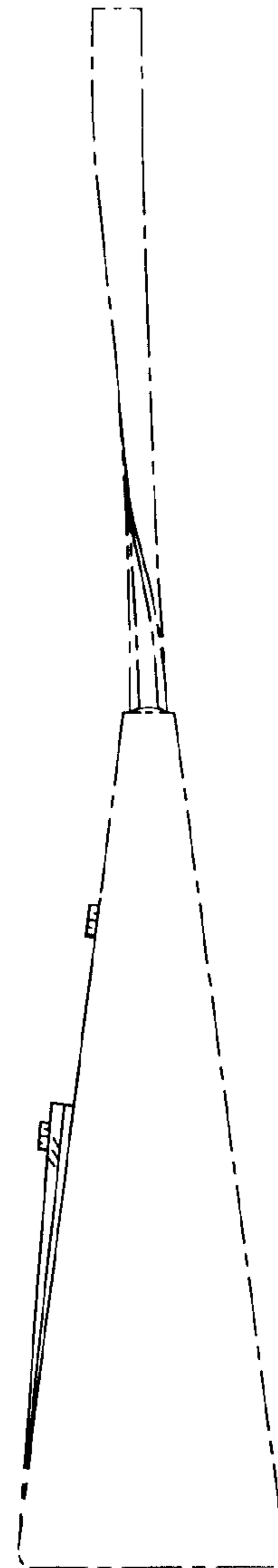

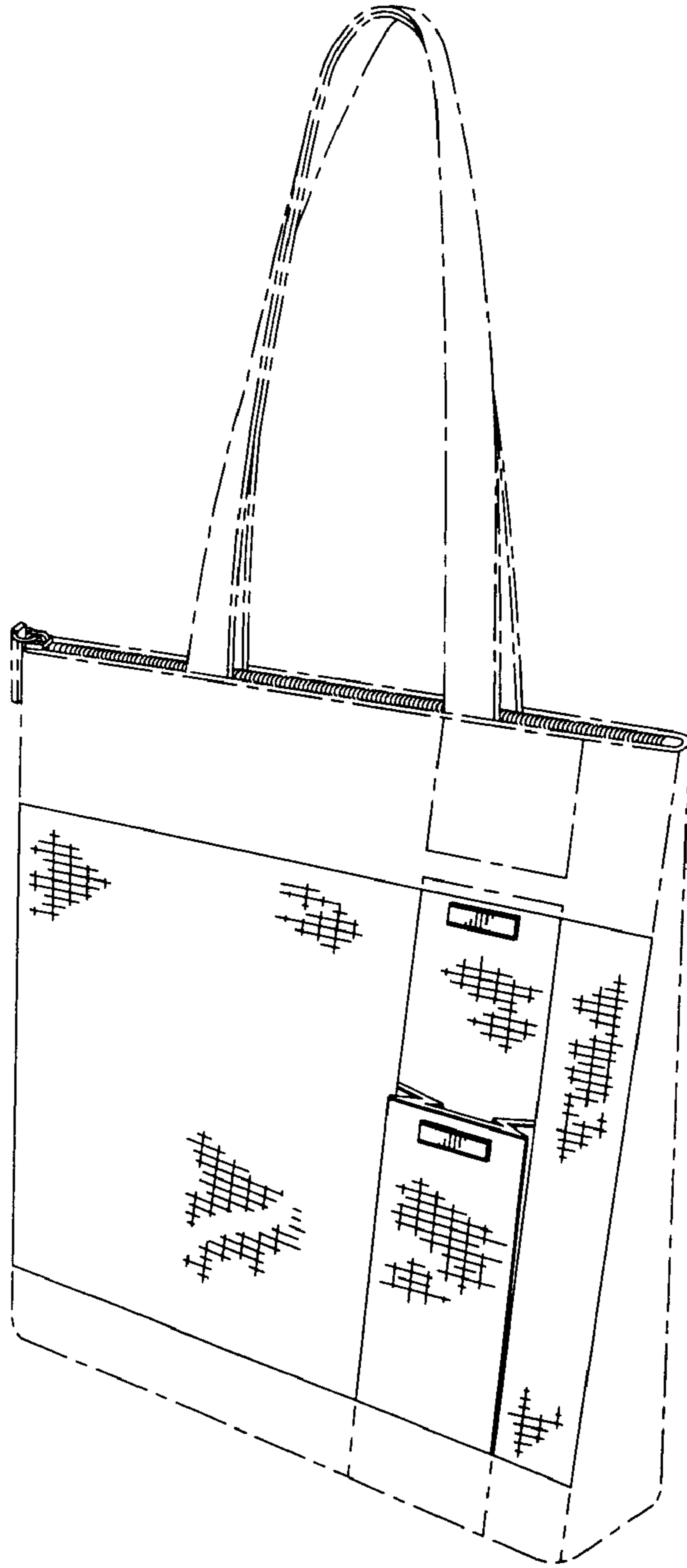

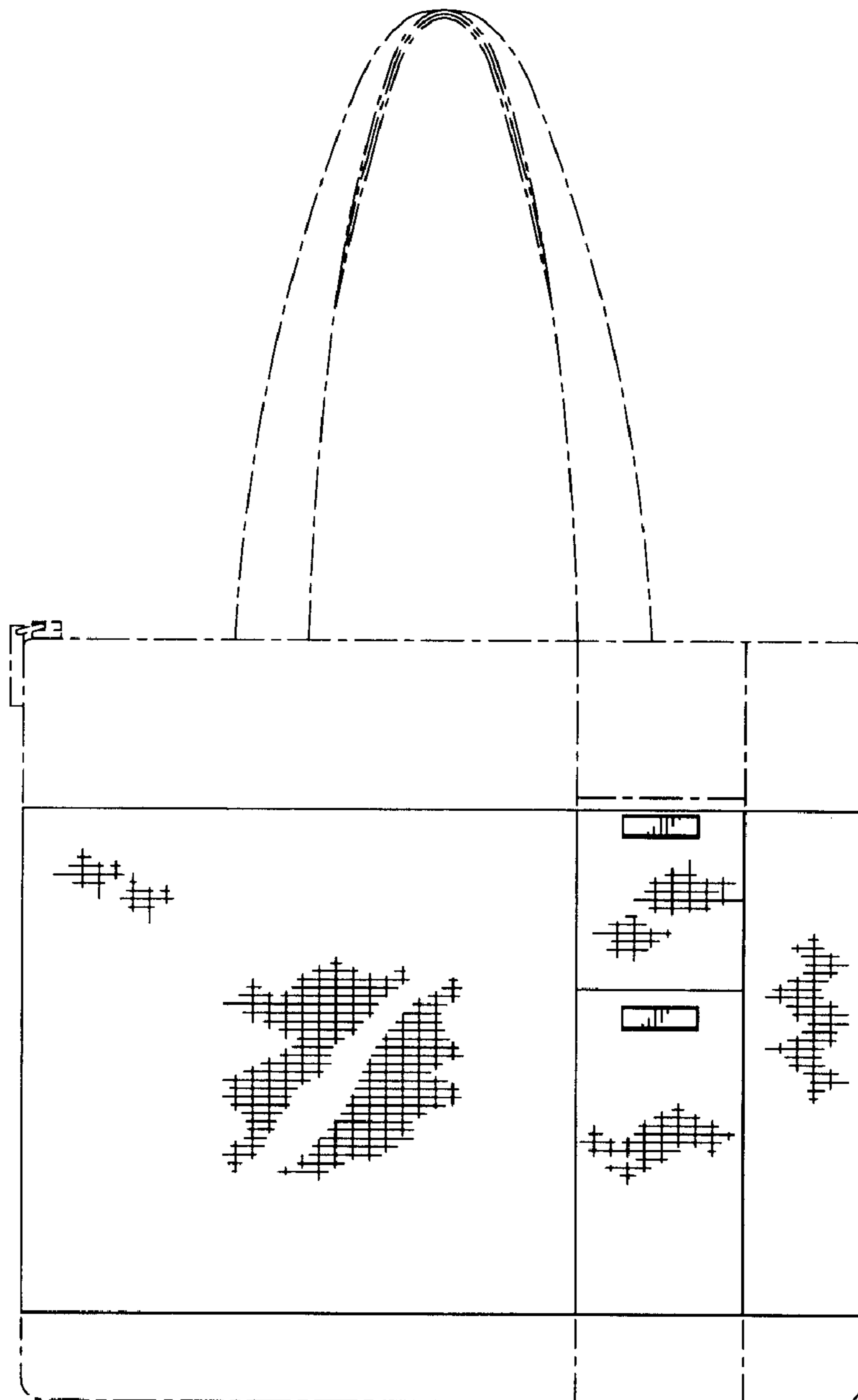

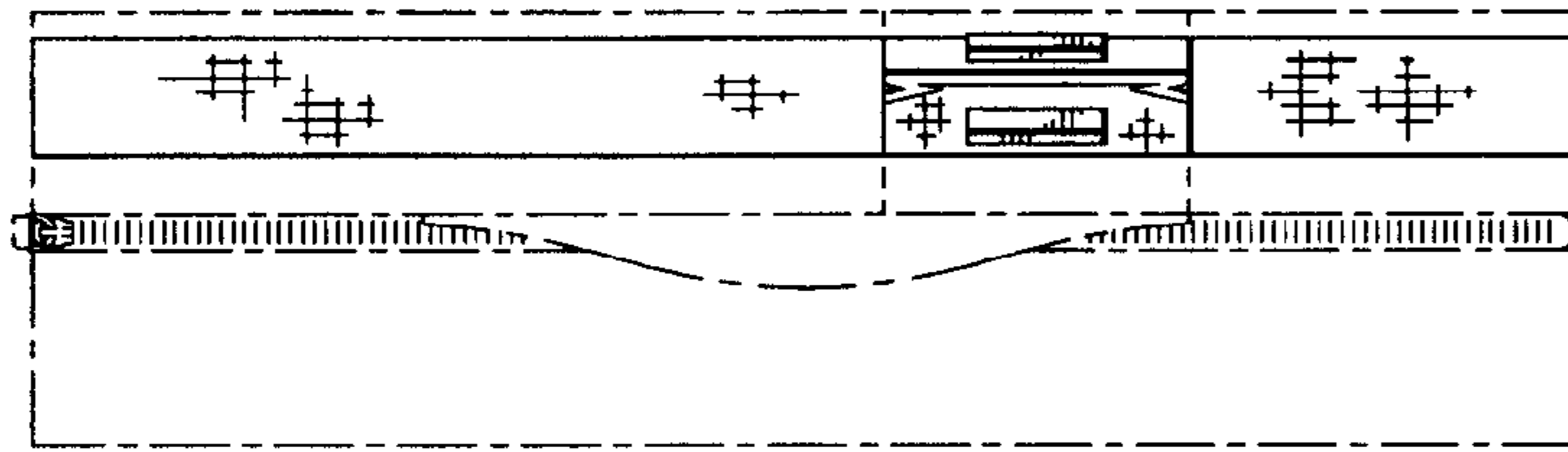

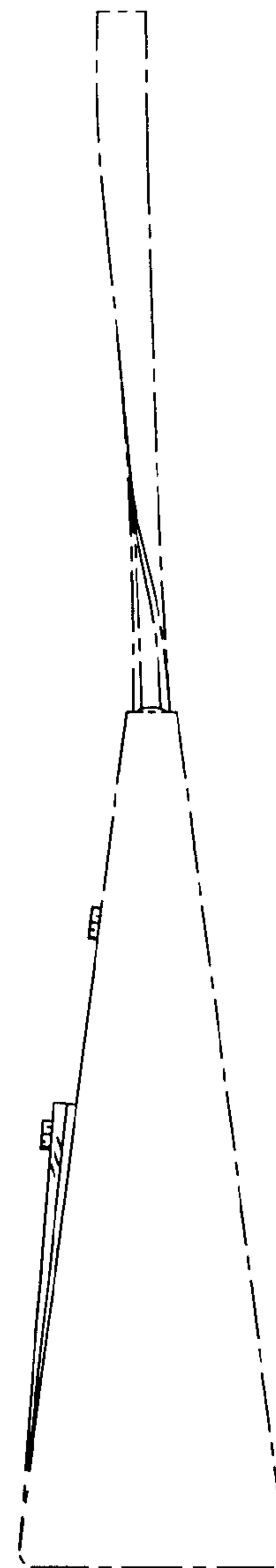
