(57) **CLAIM**

The ornamental design for a roller handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a roller handle attached in an offset orientation to a roller;

FIG. 2 is a perspective view of a roller handle attached in a central orientation to a roller;

FIG. 3 is a perspective view of a roller handle attached to an arched arm on a roller;

FIG. 4 is a left side view of the roller handle attached as depicted in FIG. 1;

FIG. 5 is a front view of the roller handle attached as depicted in FIG. 1, the rear view being a mirror image thereof;

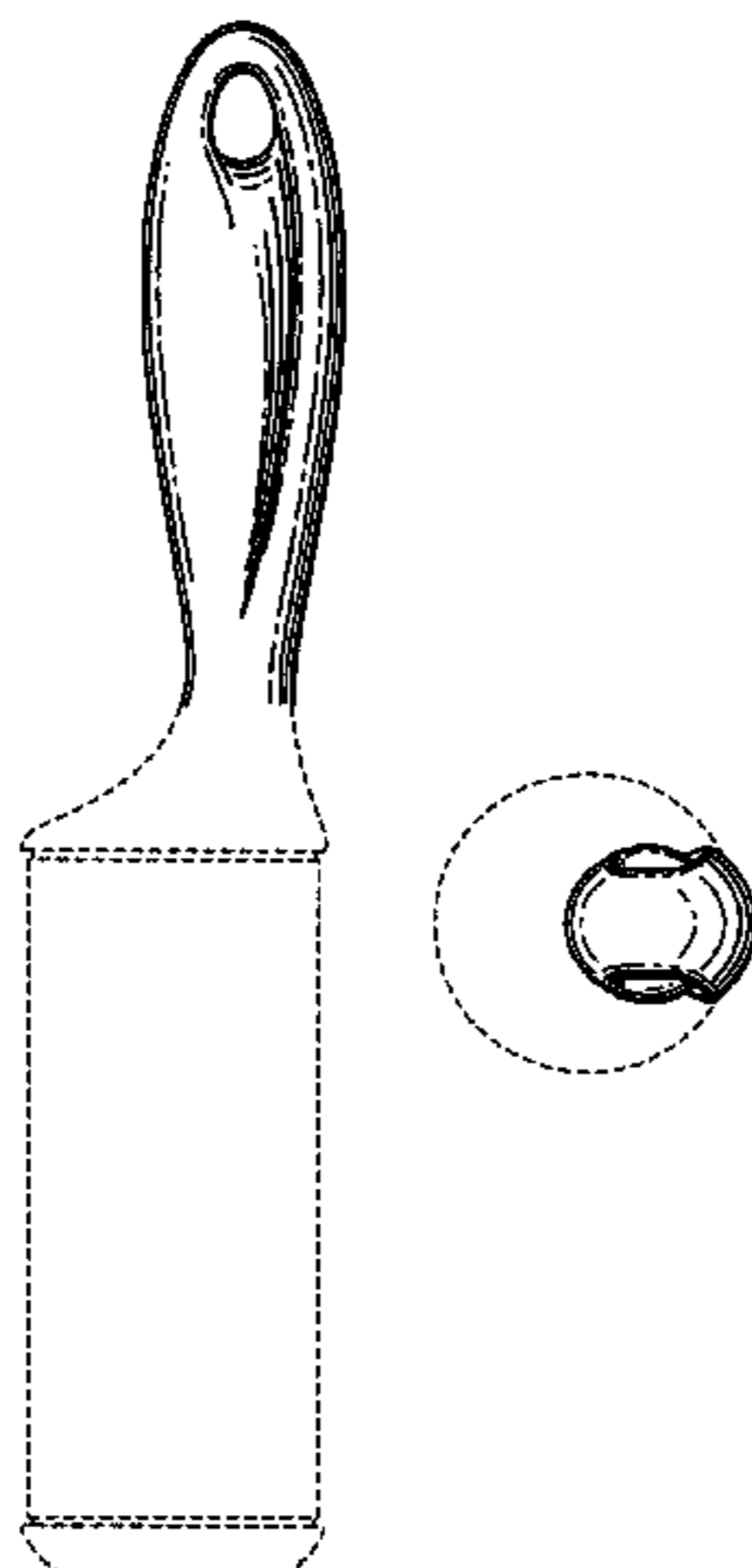
FIG. 6 is a right side view of the roller handle attached as depicted in FIG. 1;

FIG. 7 is a bottom view of the roller handle attached as depicted in FIG. 1; and,

FIG. 8 is a top view of the roller handle attached as depicted in FIG. 1.

The broken lines showing variations of rollers are included for the purpose of illustrating environmental structure and form no part of the claimed design.

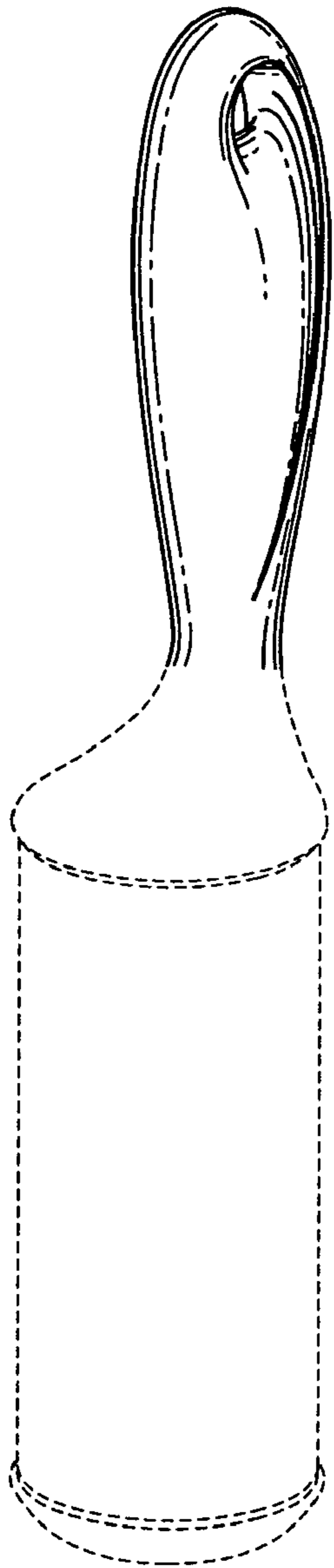

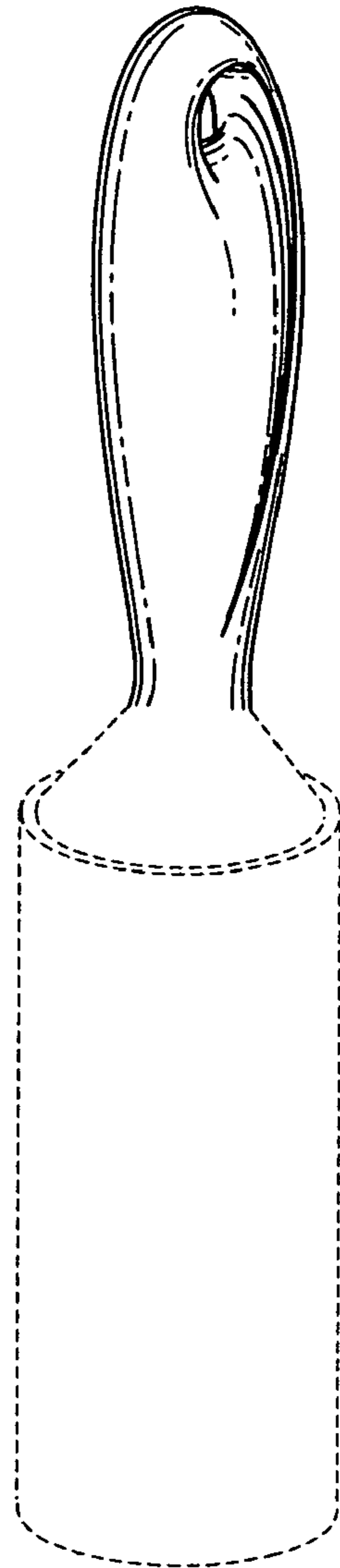

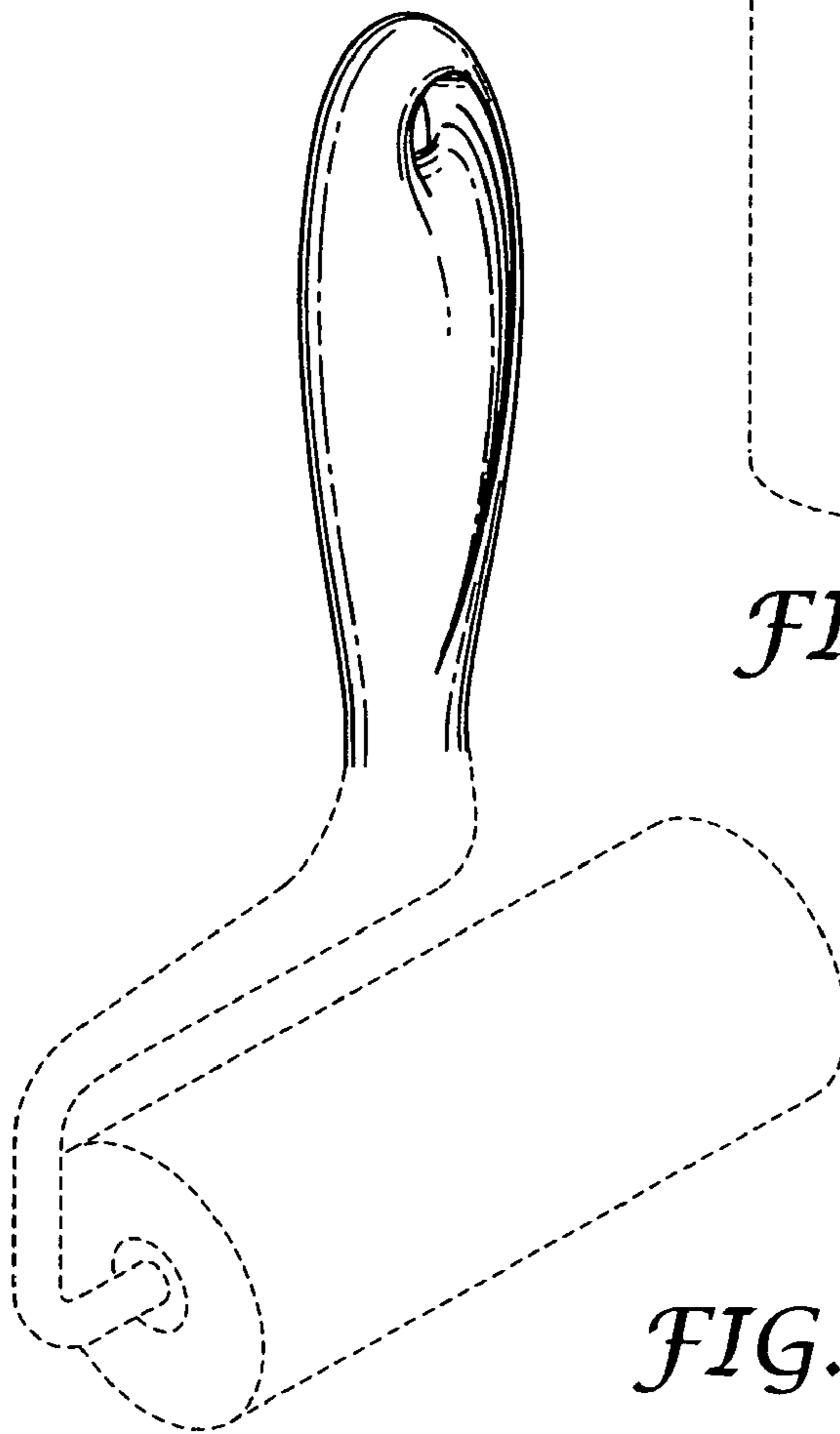

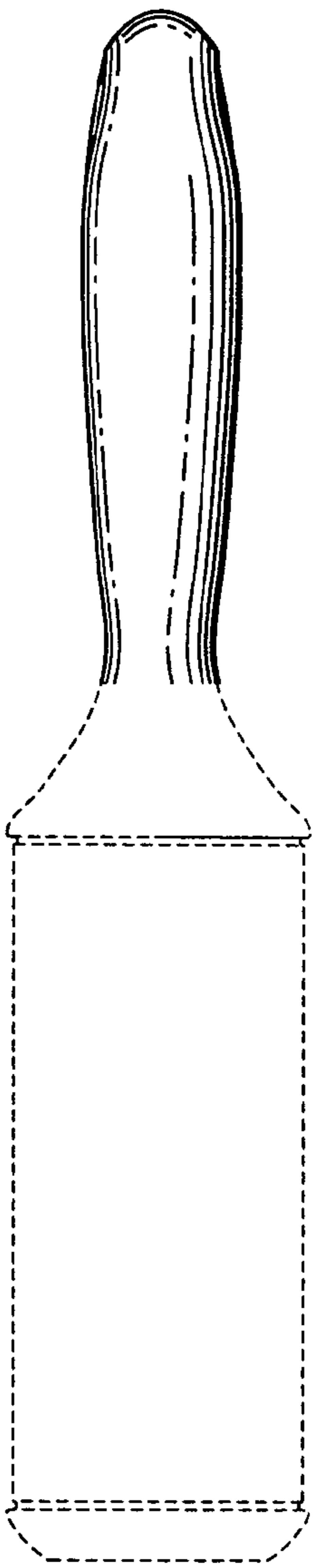

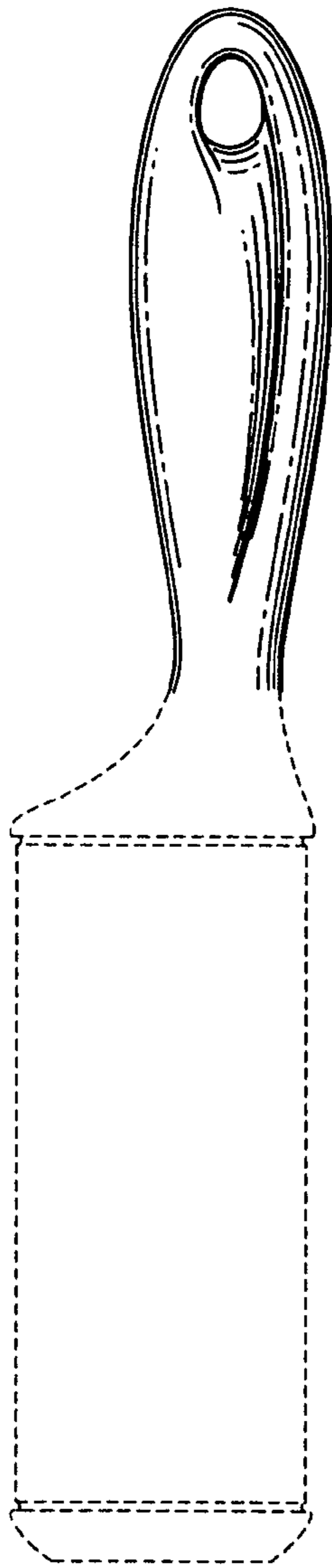

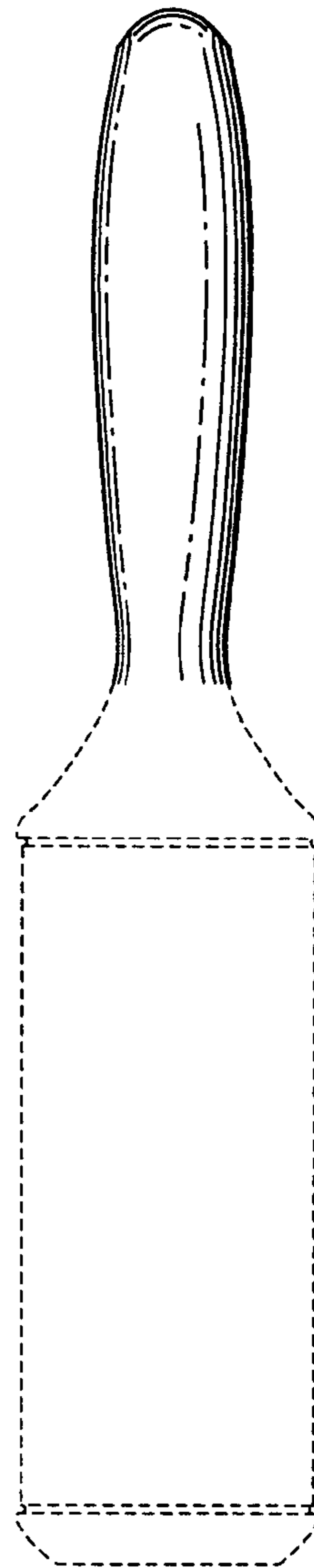

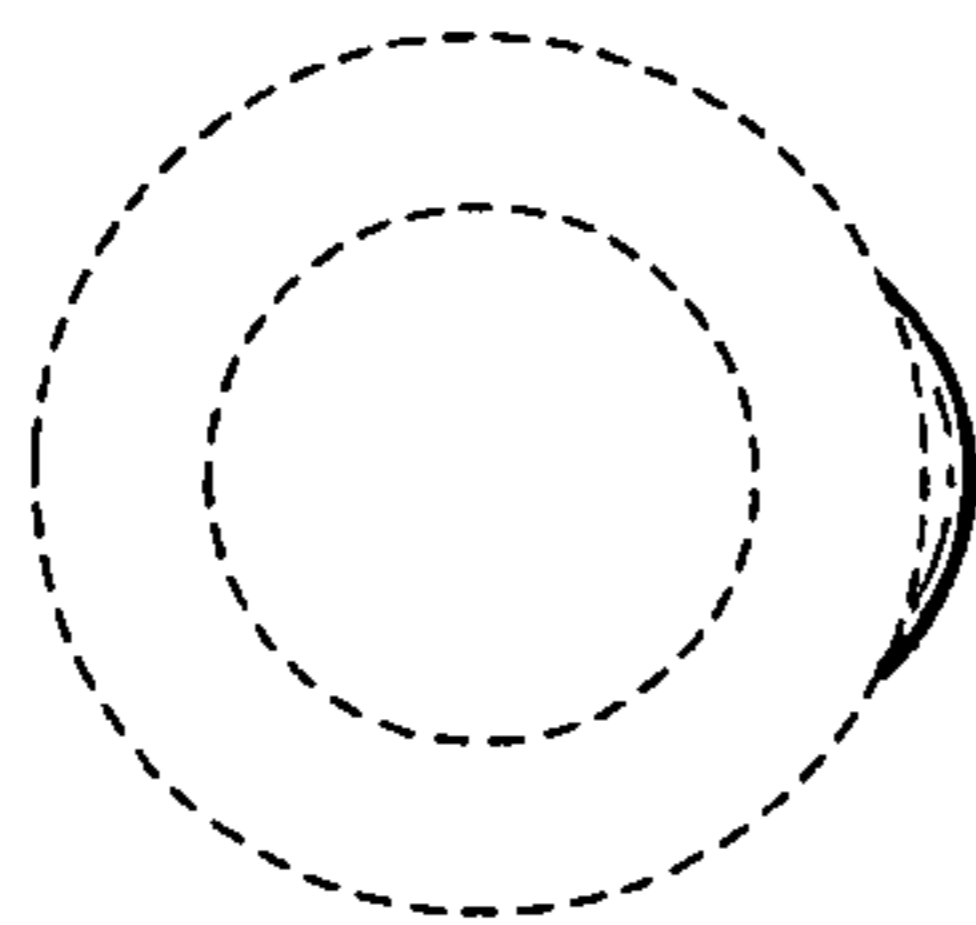

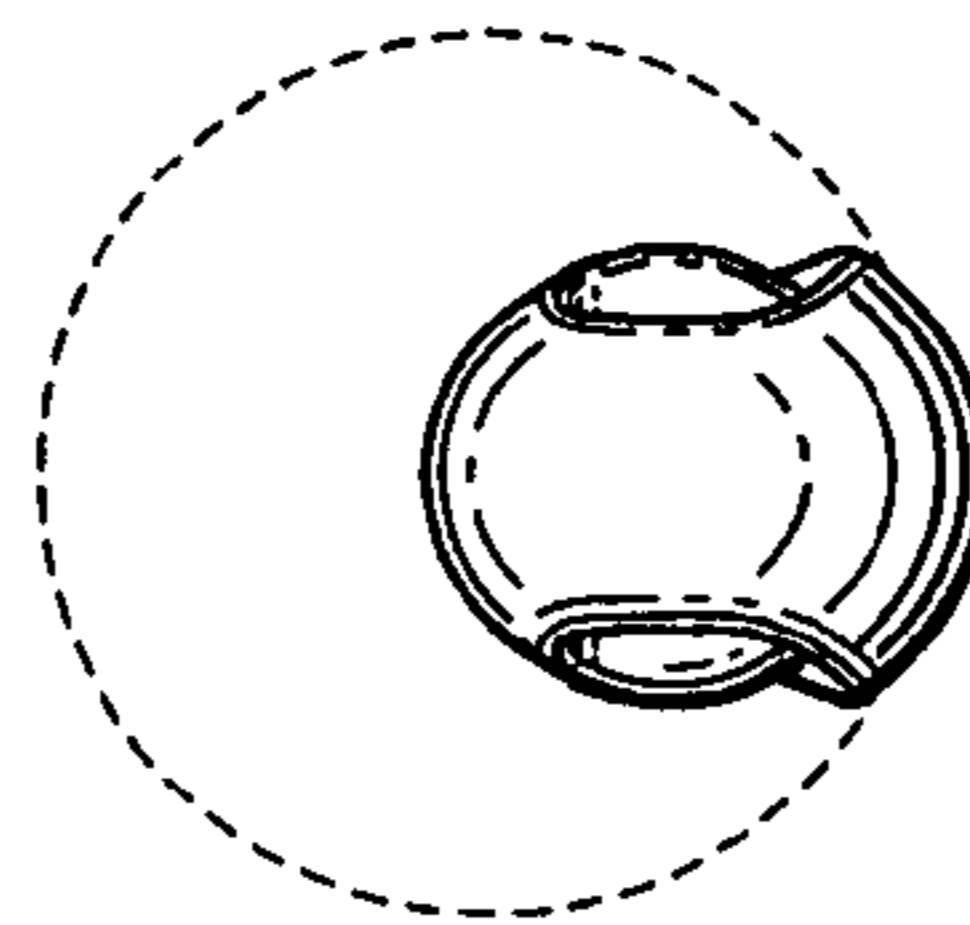
