(57) **CLAIM**

The ornamental design for an armoire with drawers, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an armoire with drawers, showing my new design, with the louvers of the upper section closed.

FIG. 2 is a right-side elevational view thereof, with the left-side elevational view thereof being a mirror image;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a front elevational view thereof, with the louvers of the upper section open;

FIG. 7 is a right-side elevational view thereof, with the left-side elevational view thereof being a mirror image;

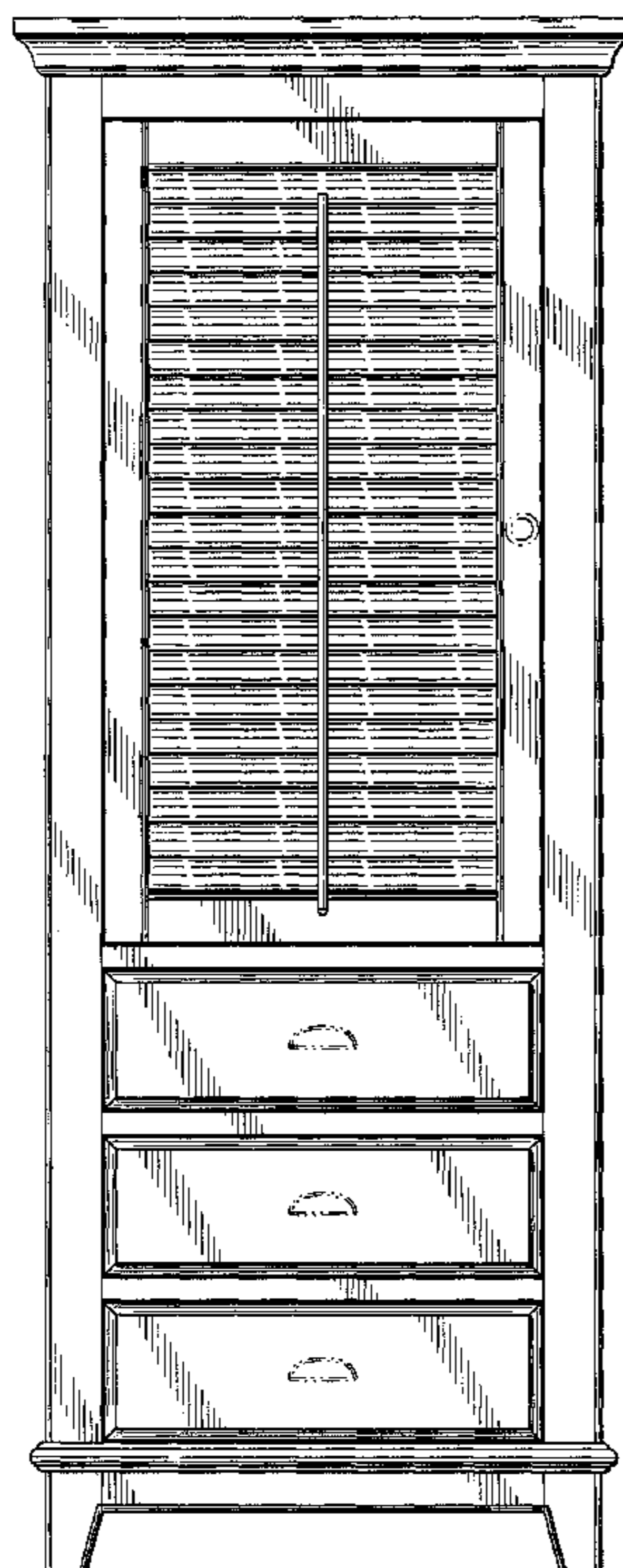
FIG. 8 is a rear elevational view thereof;

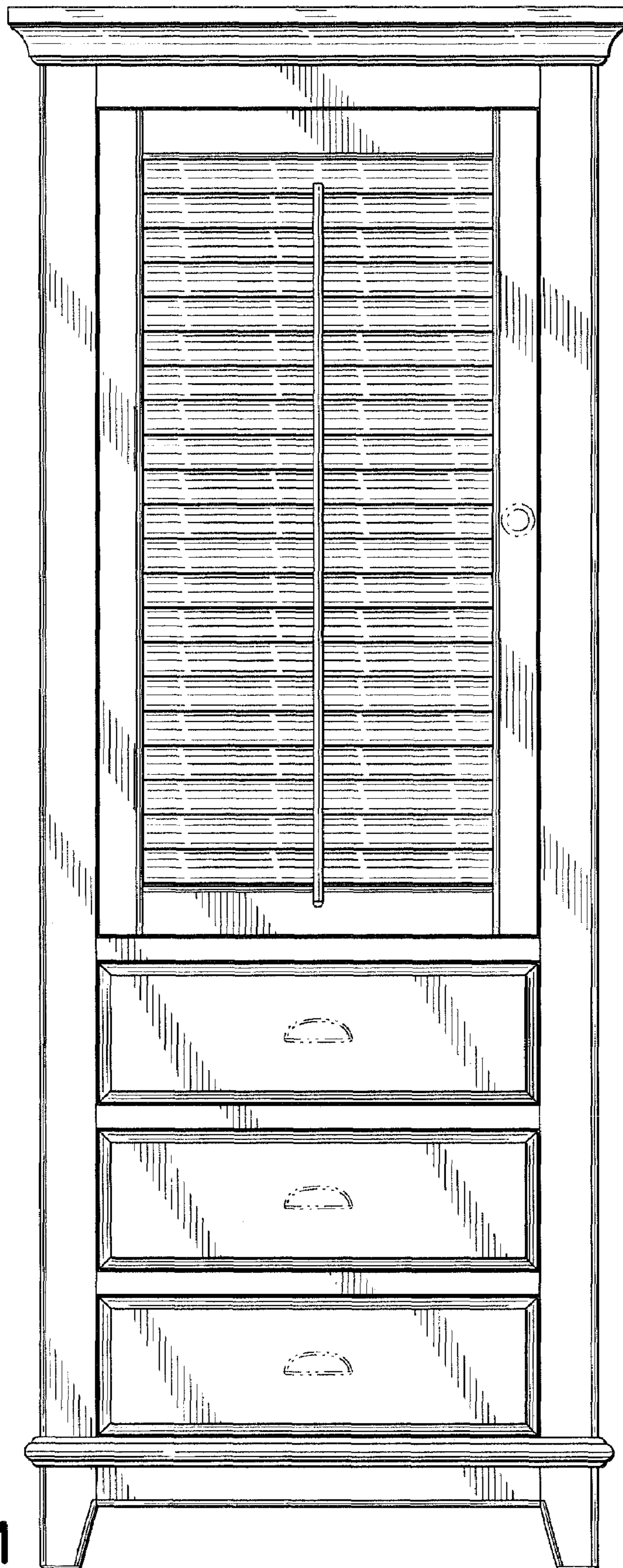

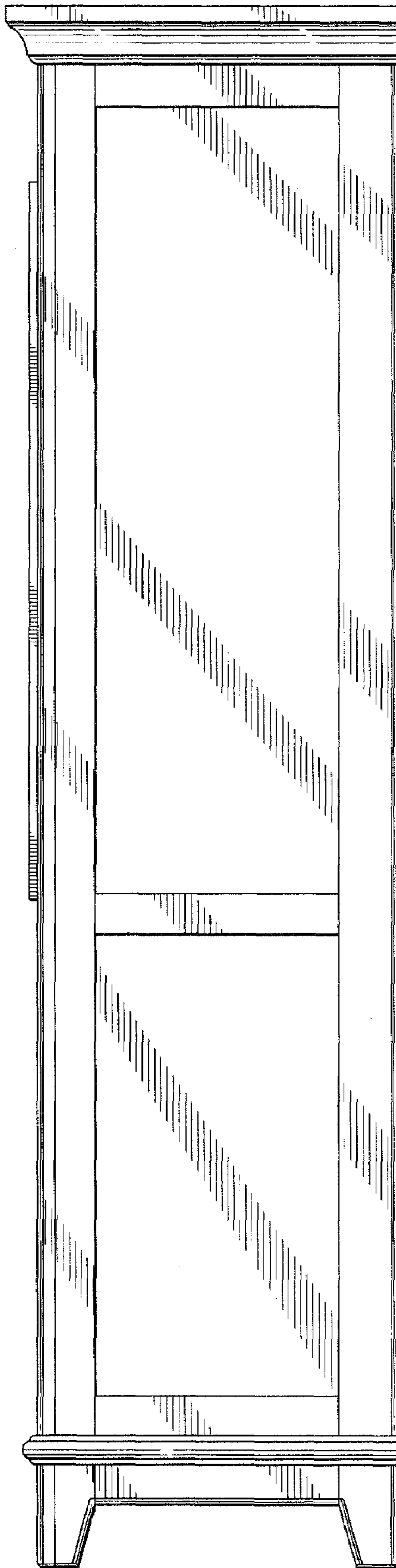

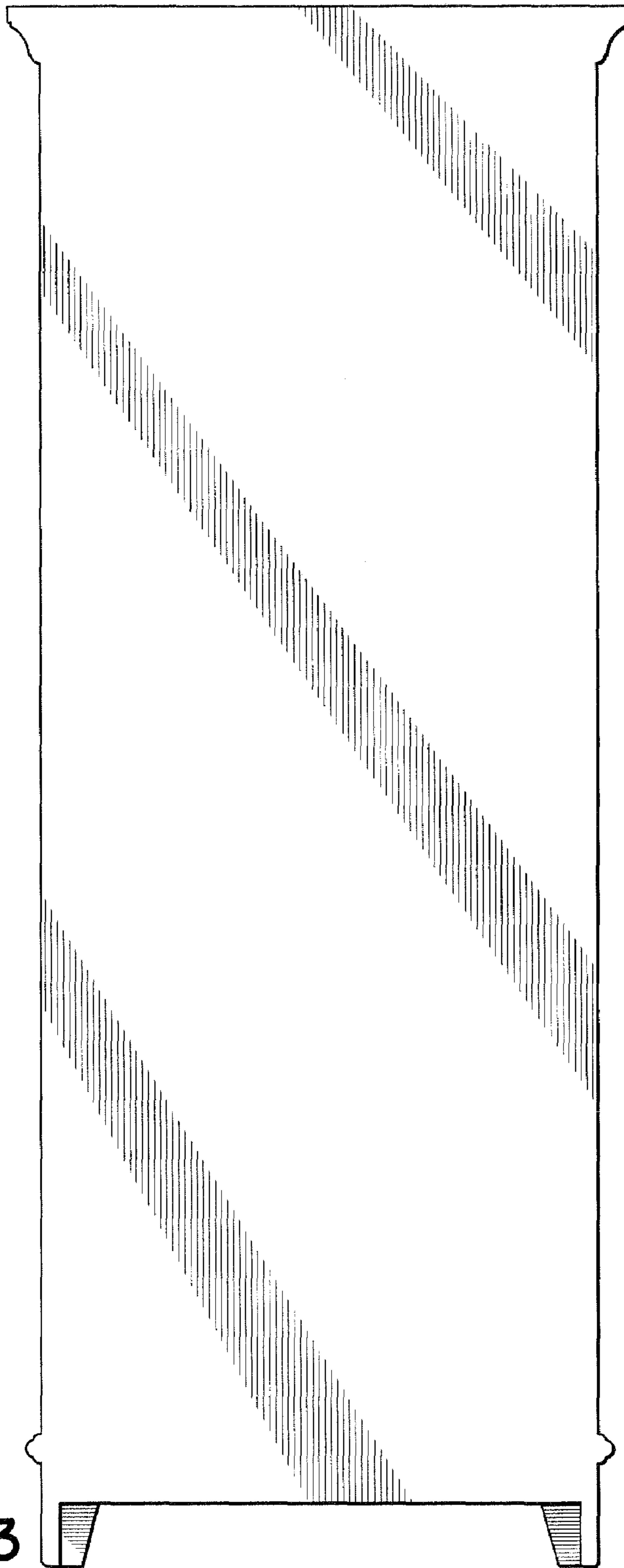

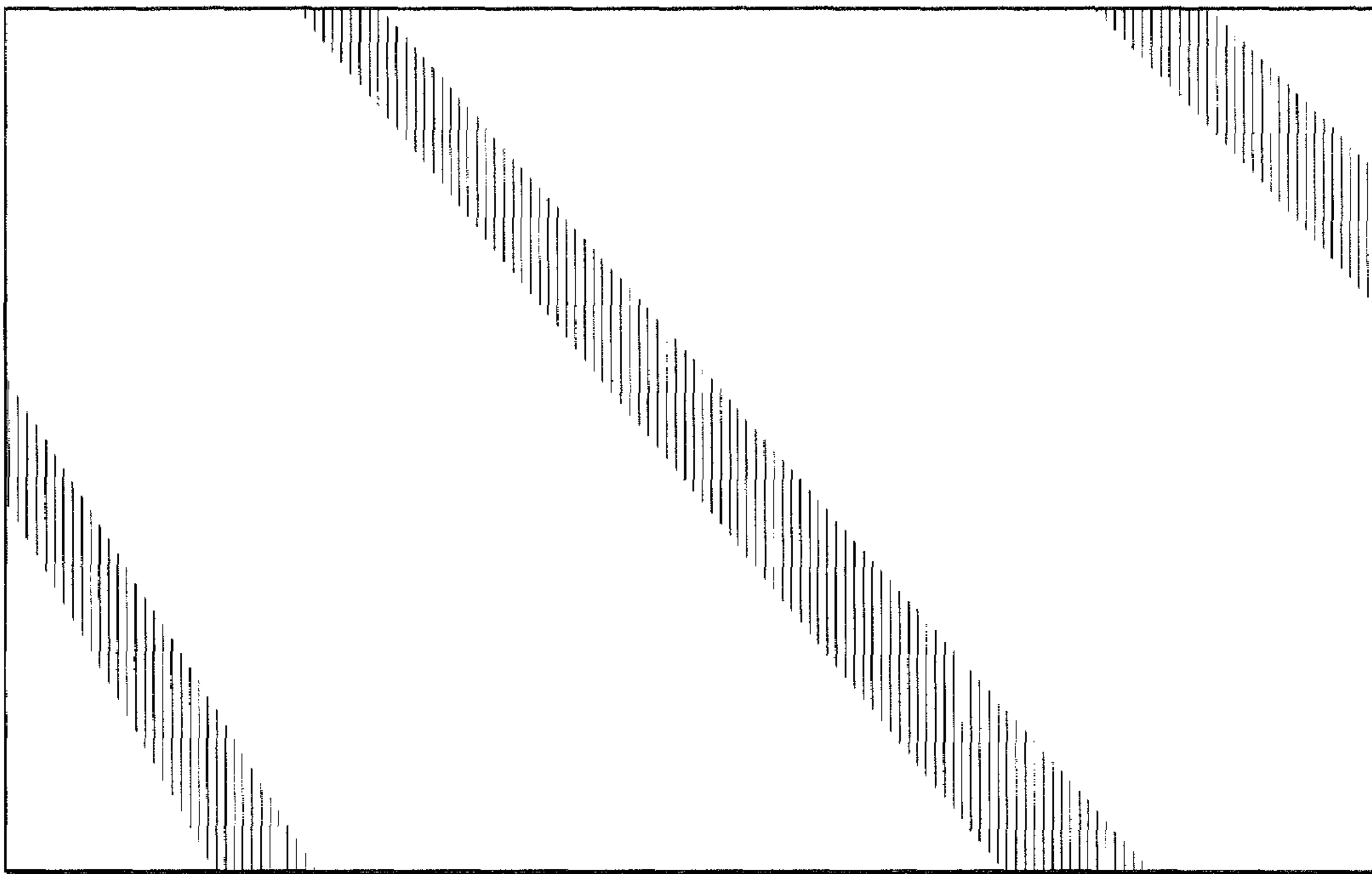

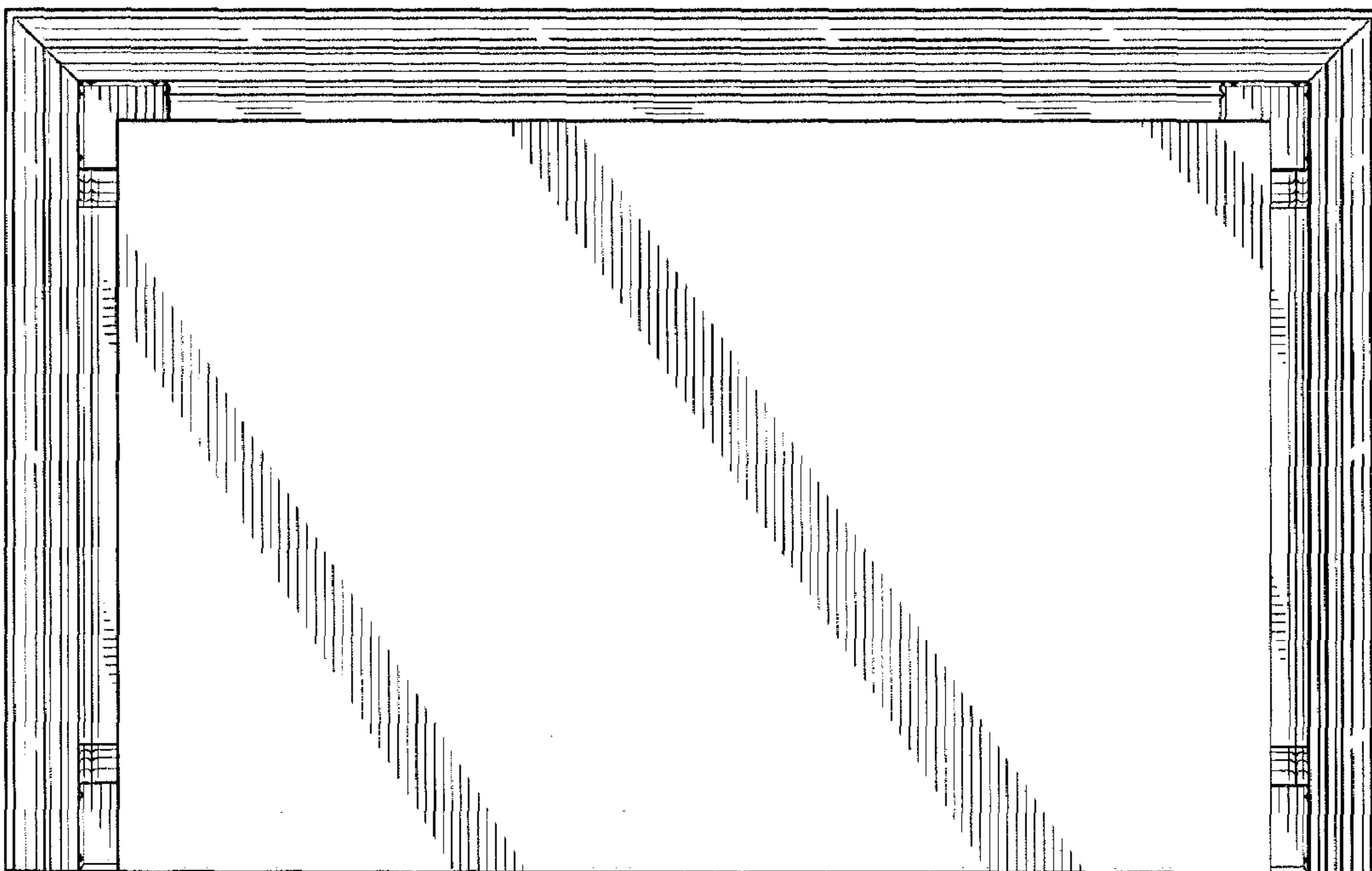

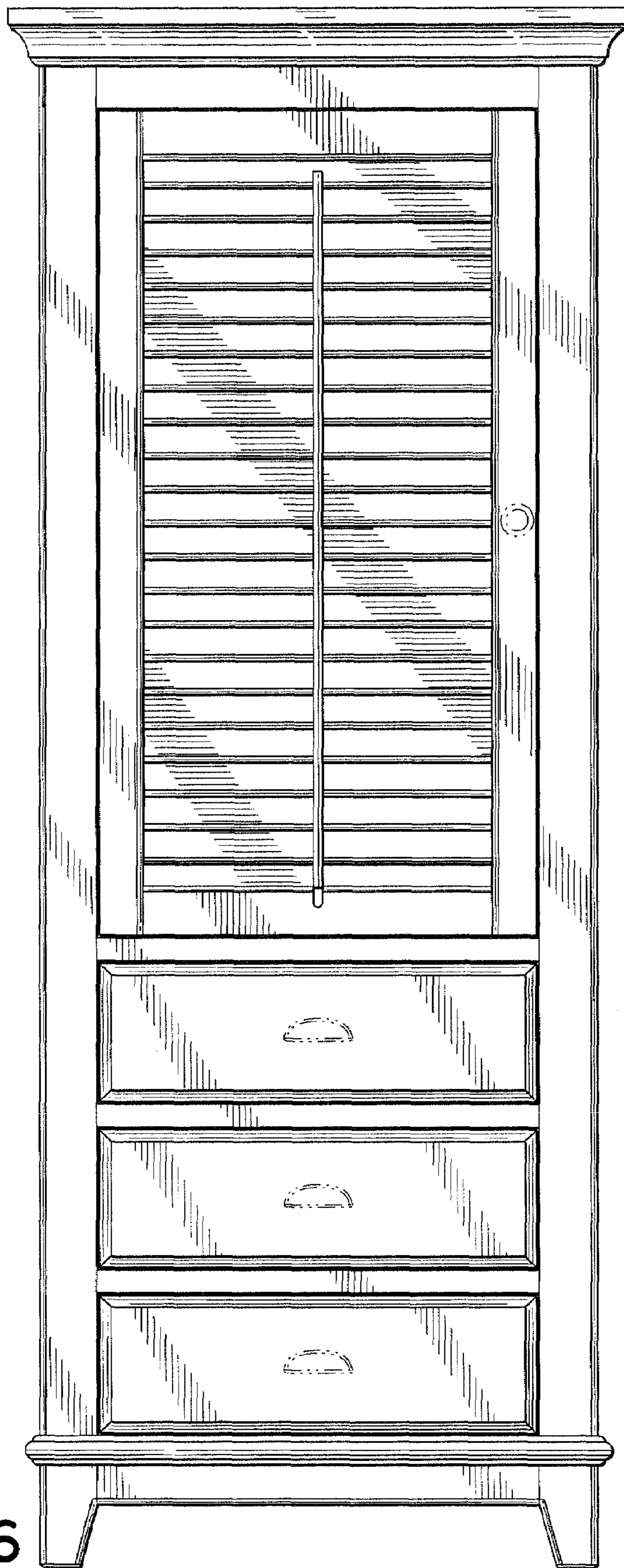

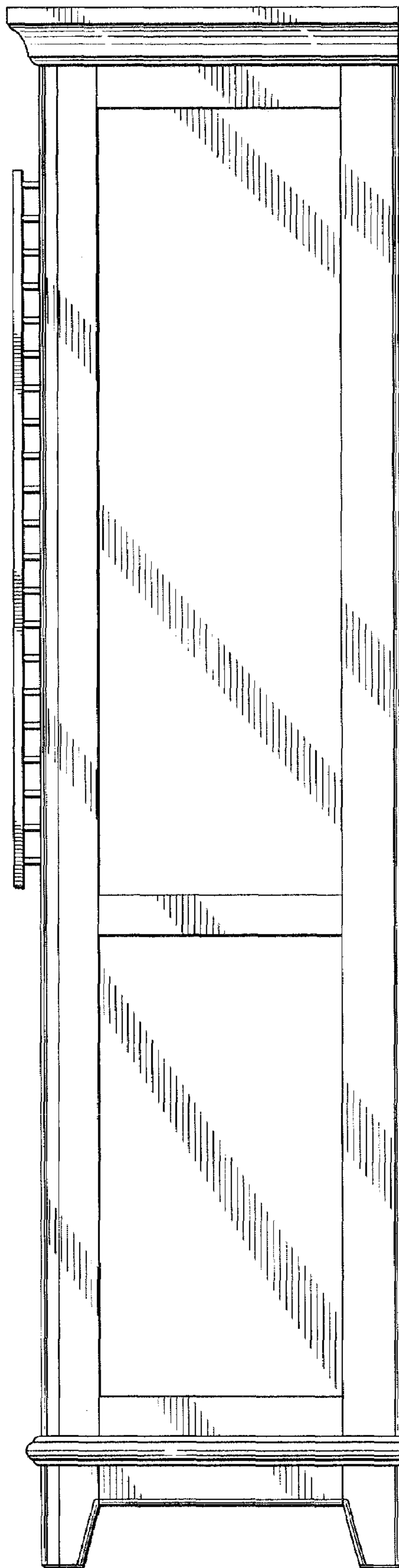

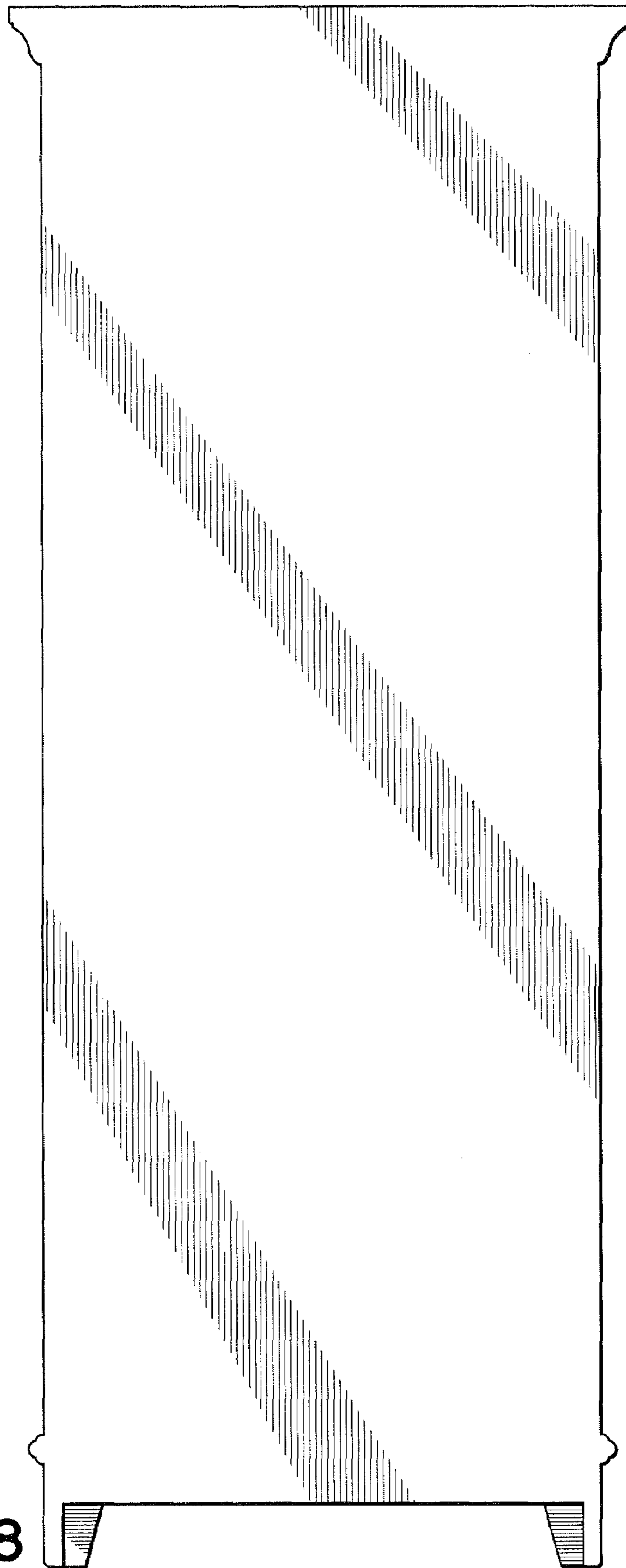

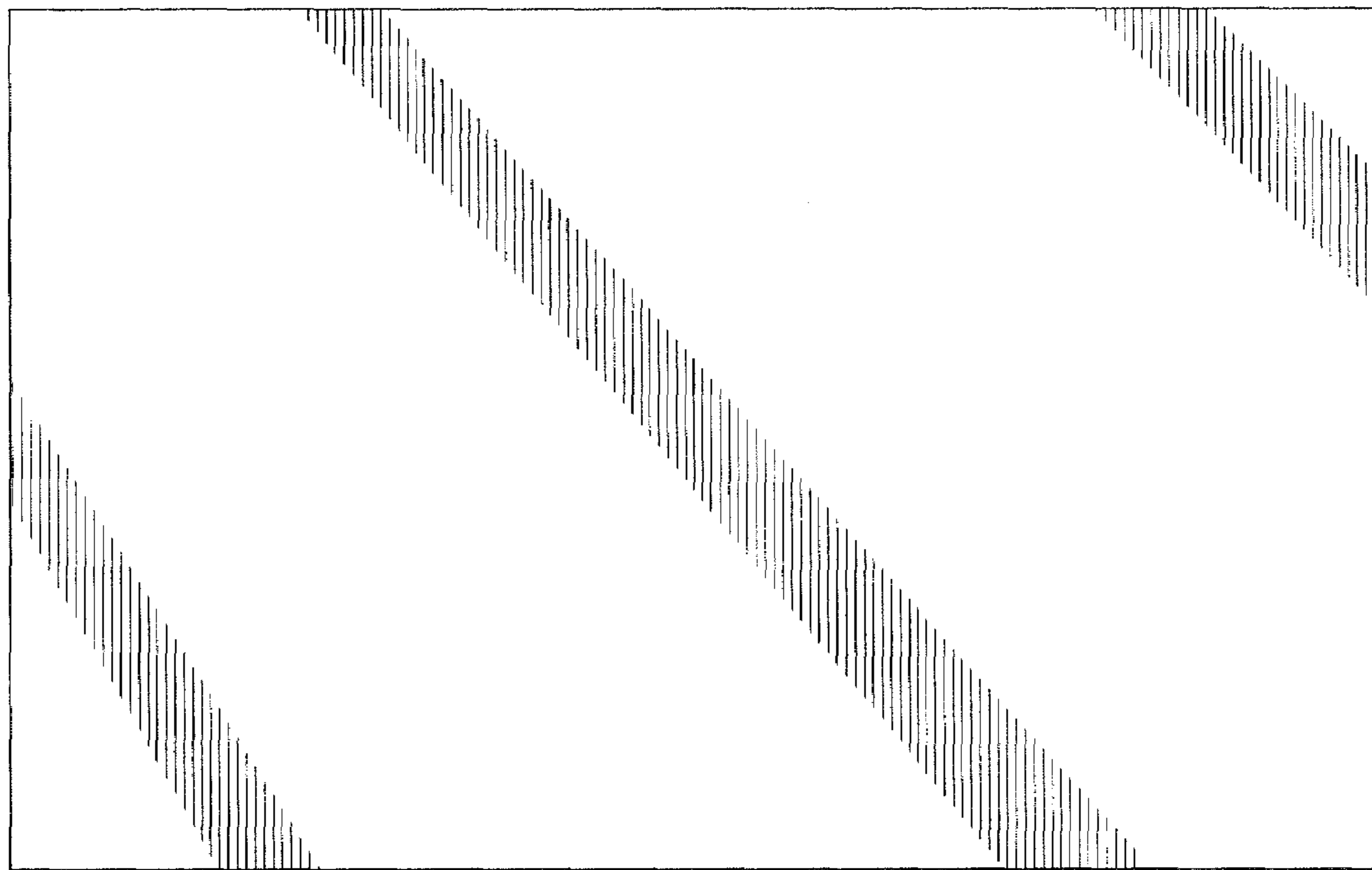

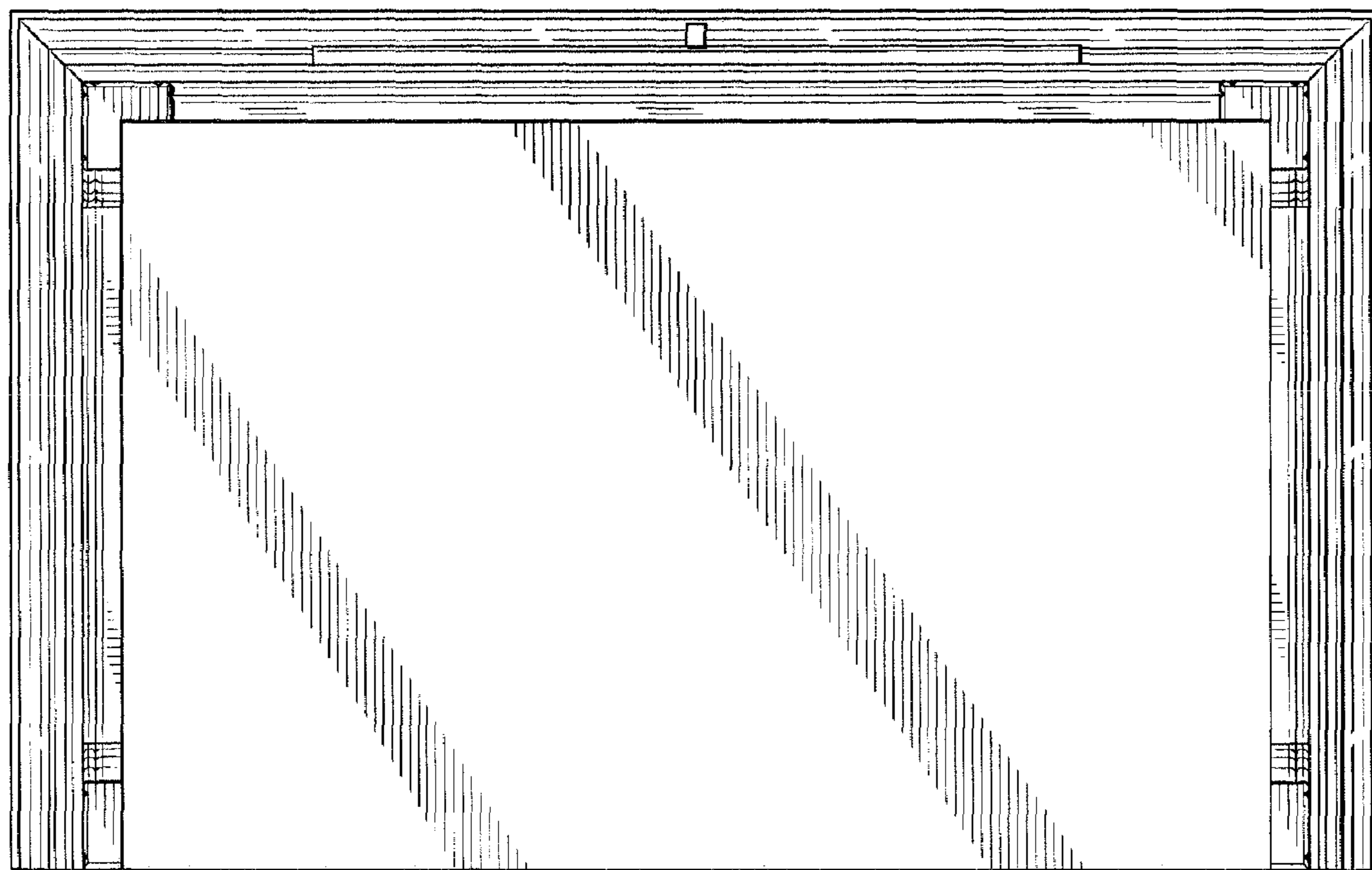
