FIG. 13 is an elevated rear view of the hub locking device shown in FIG. 9;

FIG. 14 is a bottom plan view of the hub locking device shown in FIG. 9;

FIG. 15 is a top plan view of the hub locking device shown in FIG. 9; and,

FIG. 16 is a cross sectional side view on line 16—16 of FIG. 15.

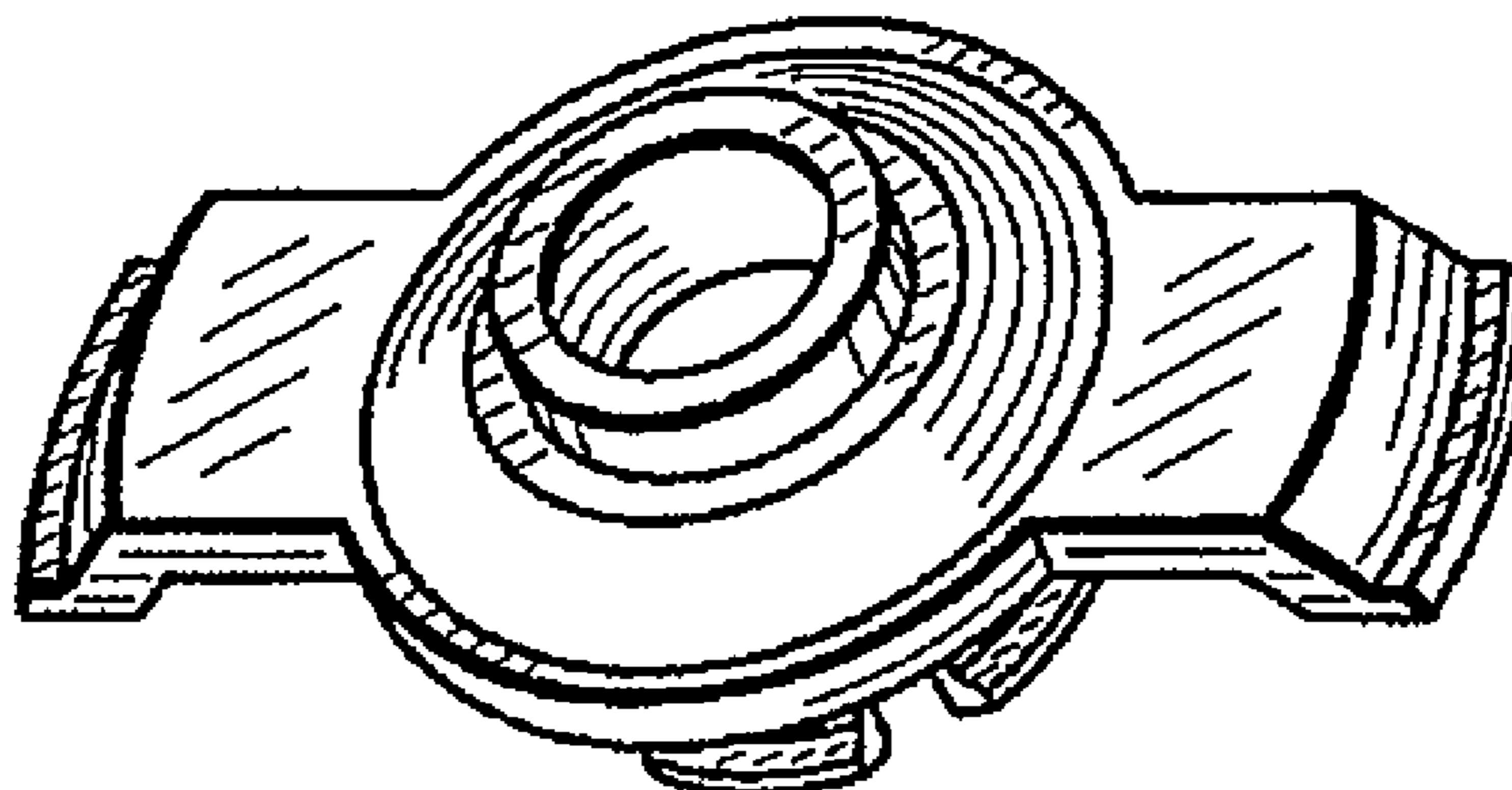

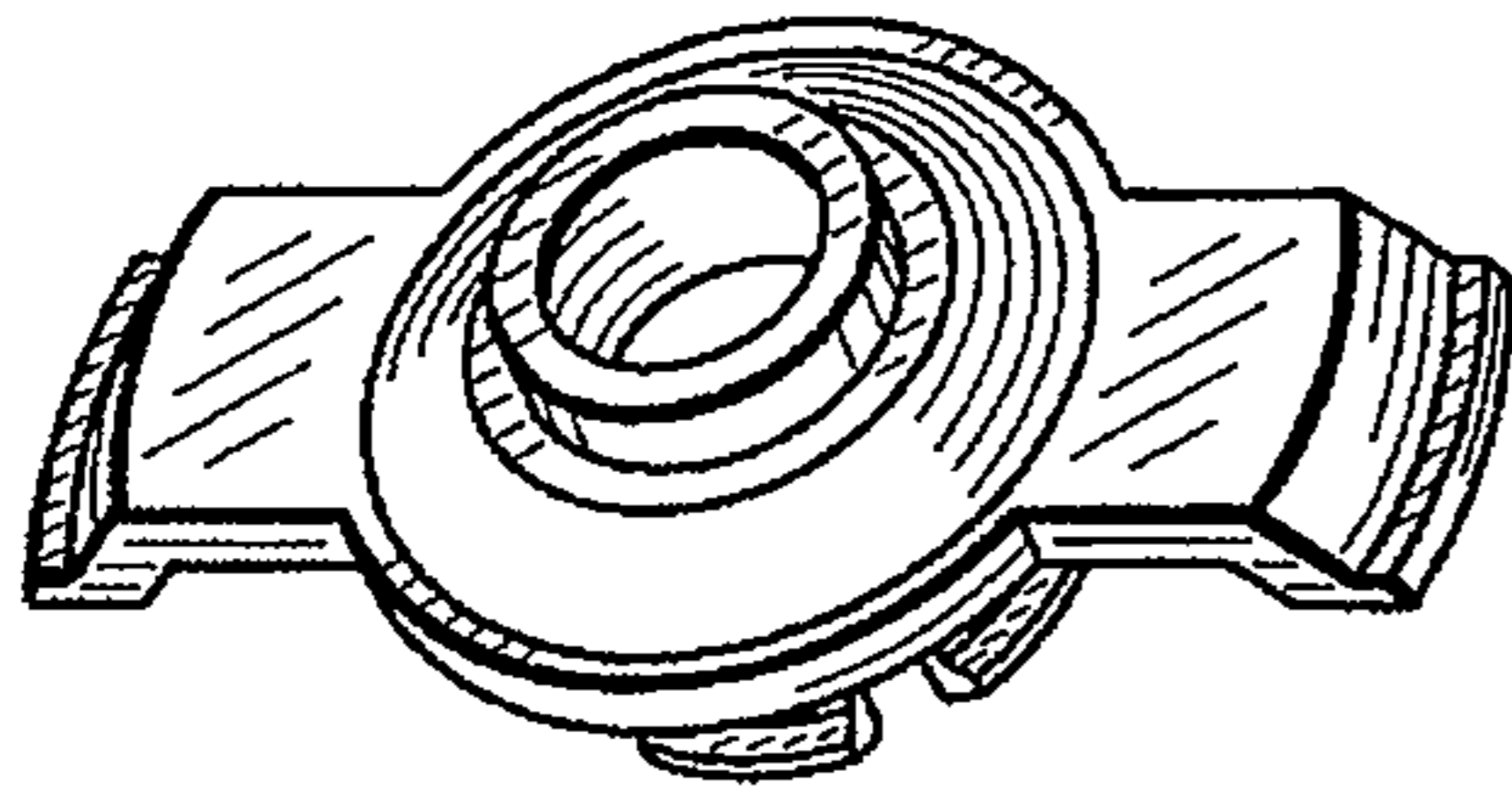

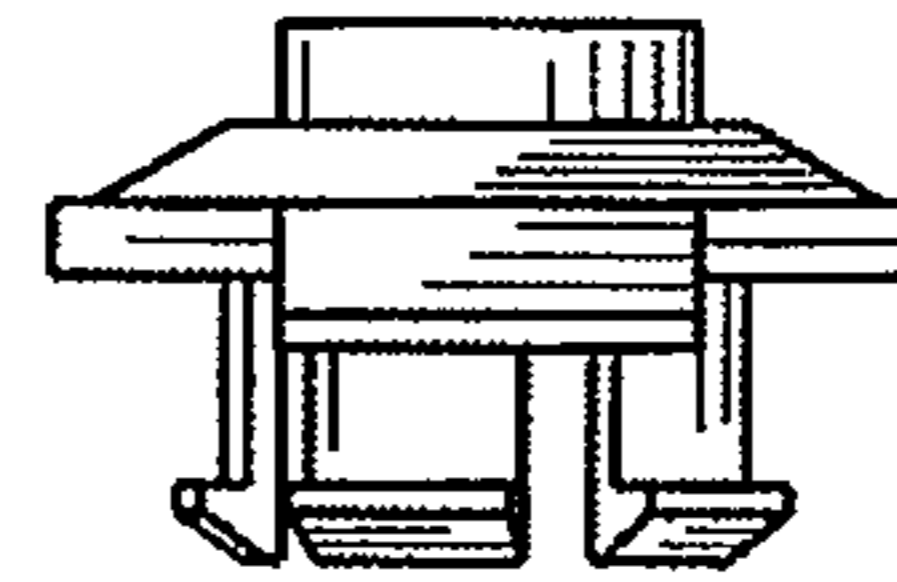

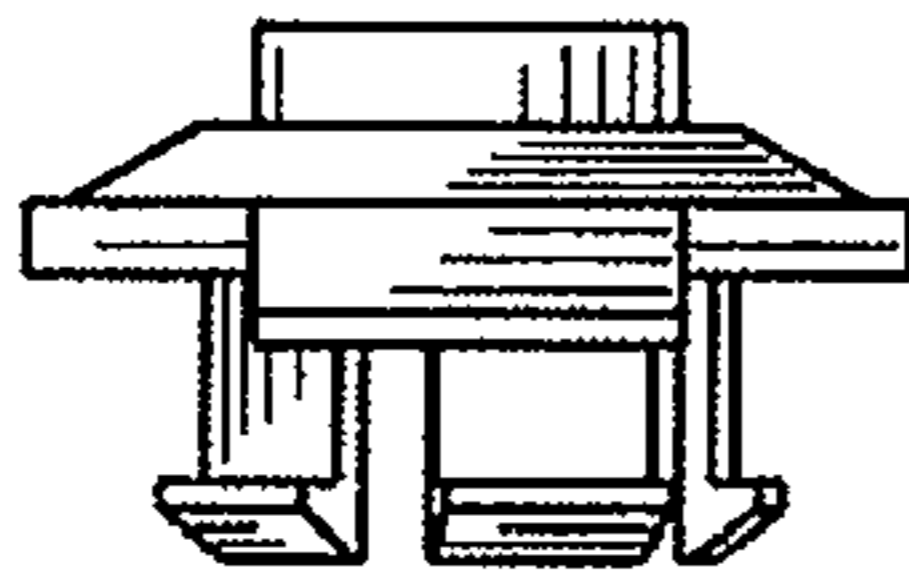




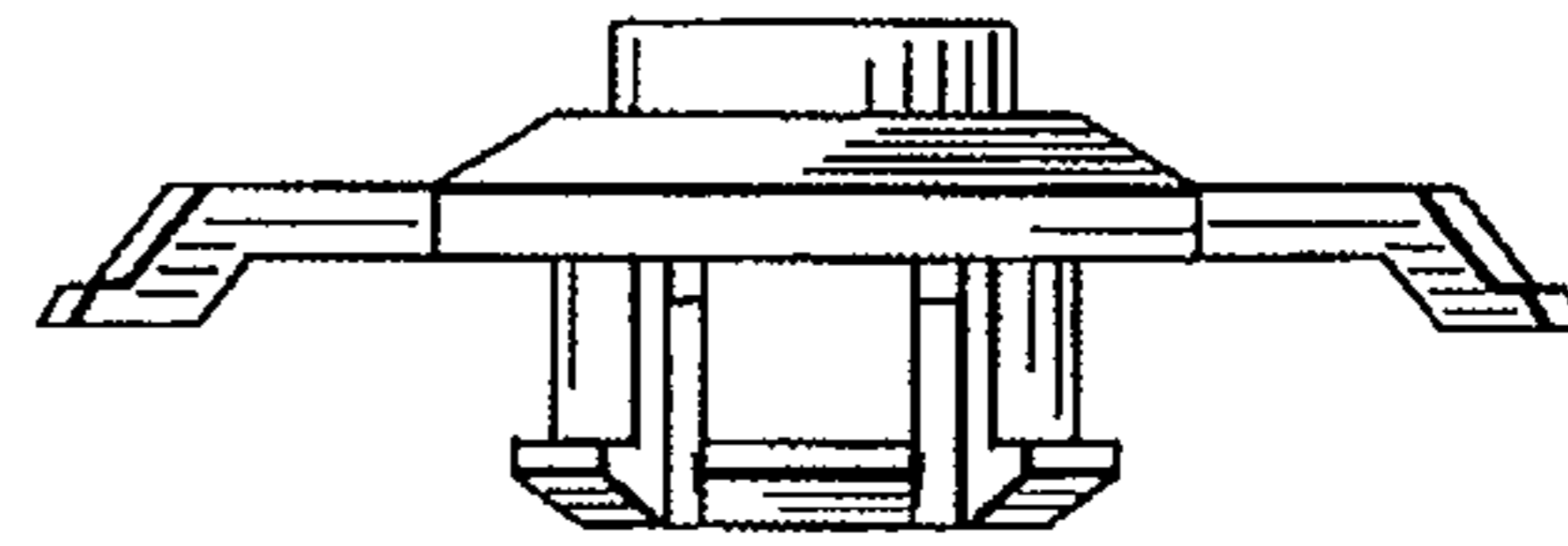

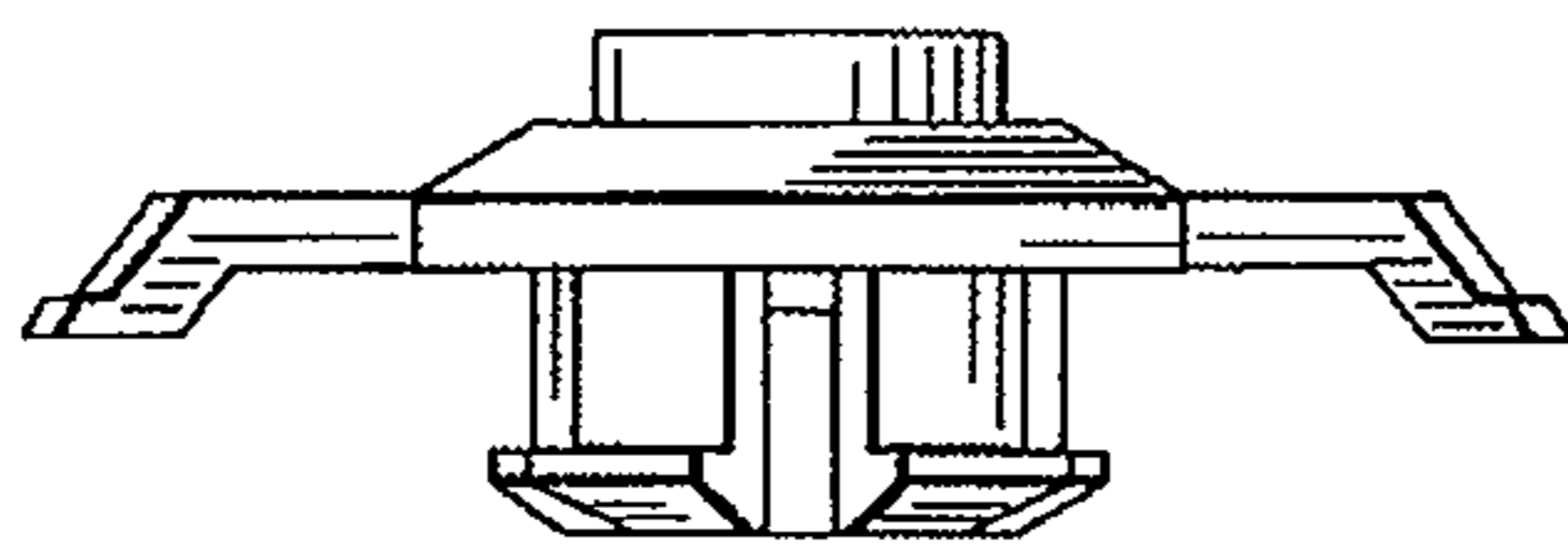

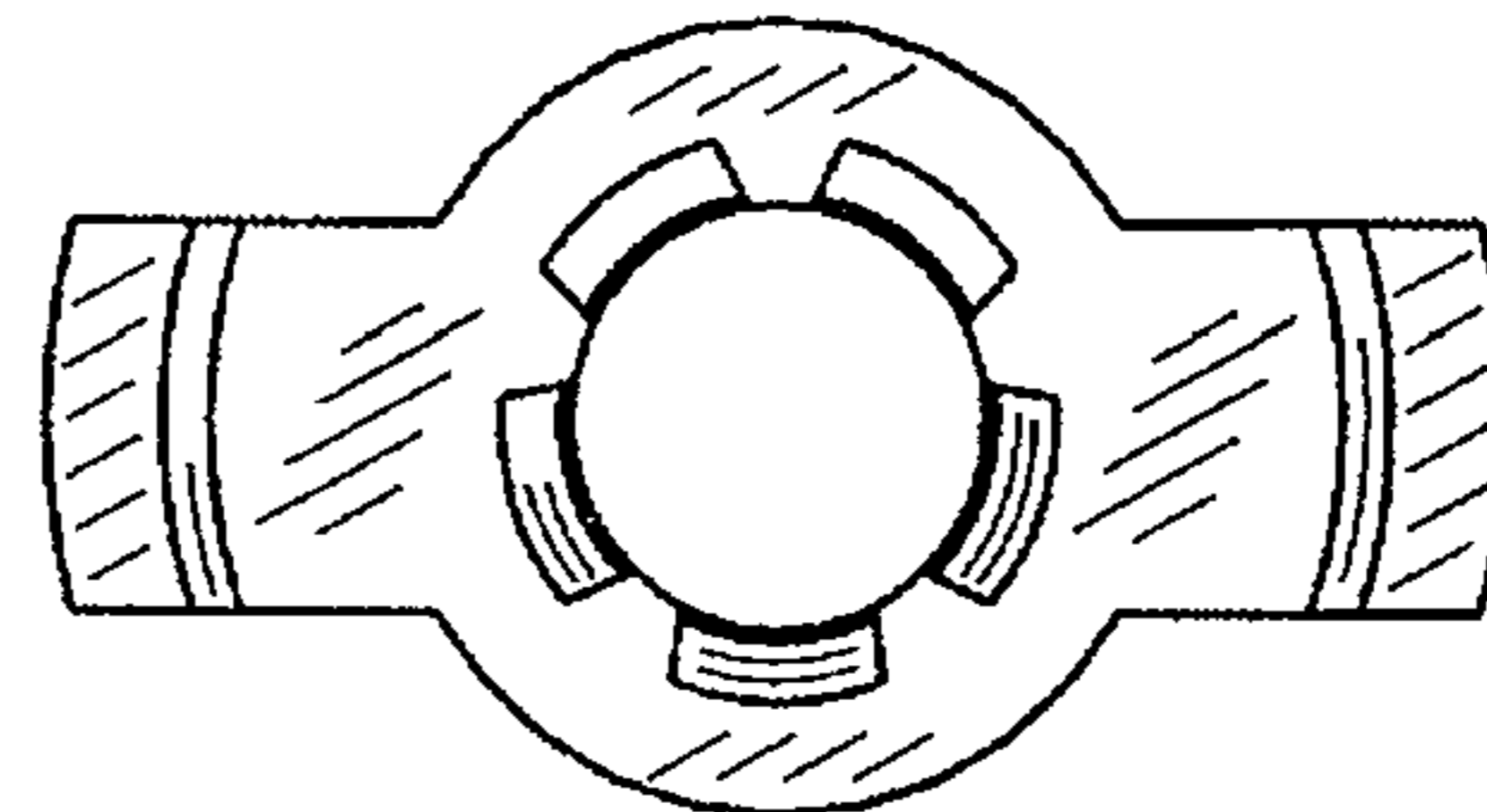

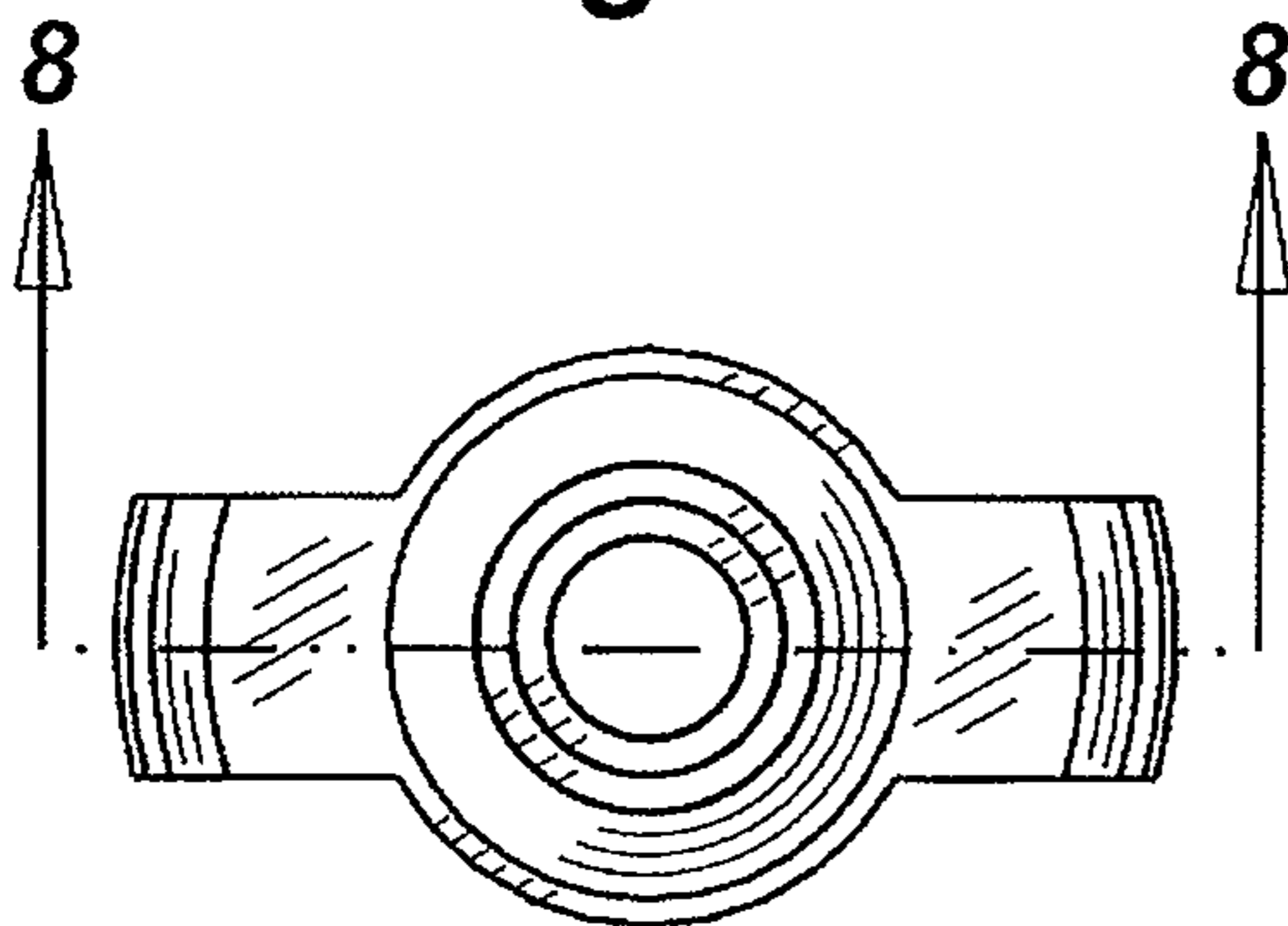

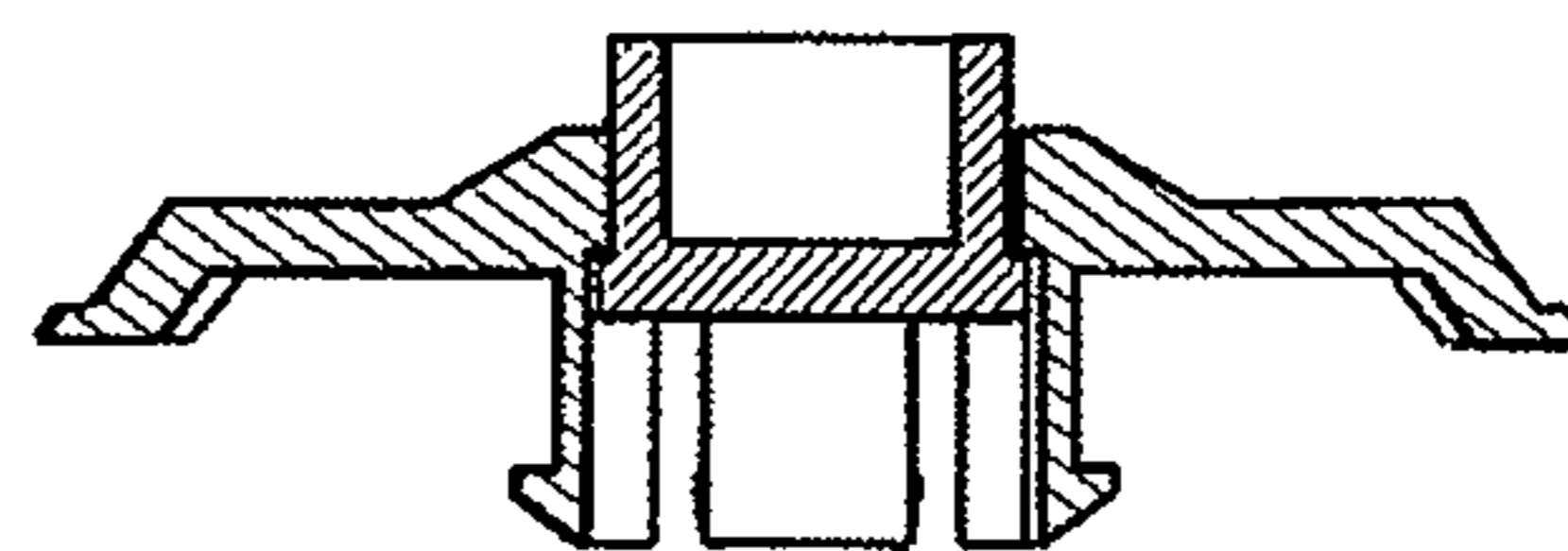

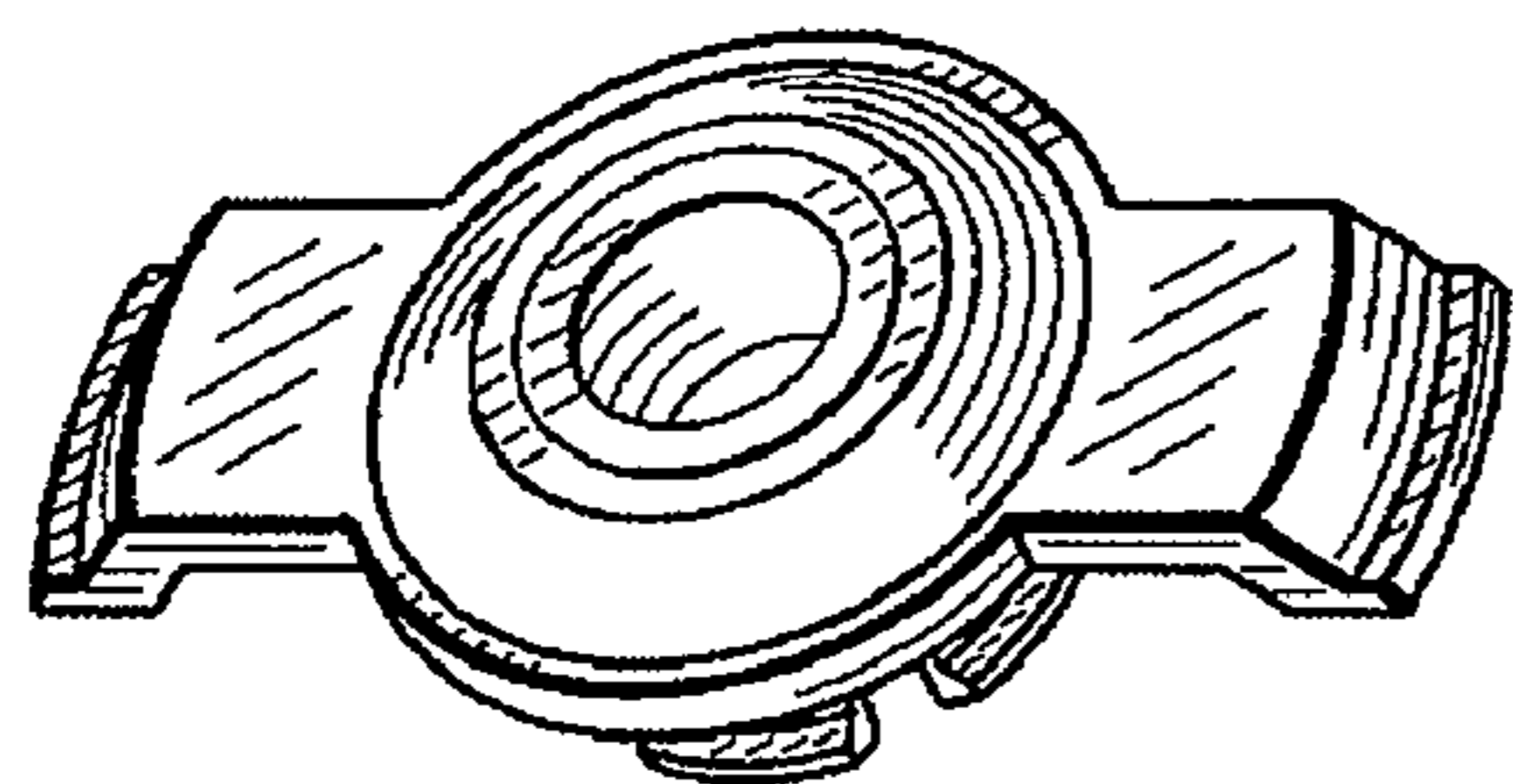

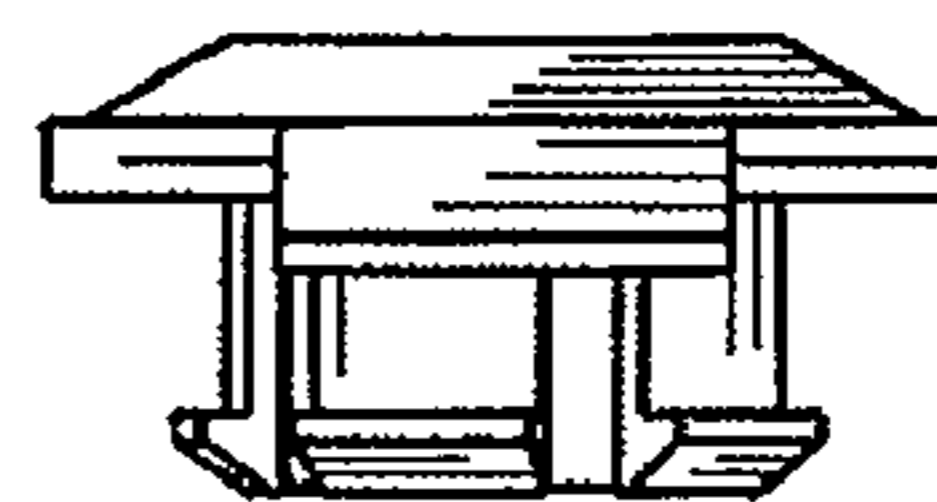

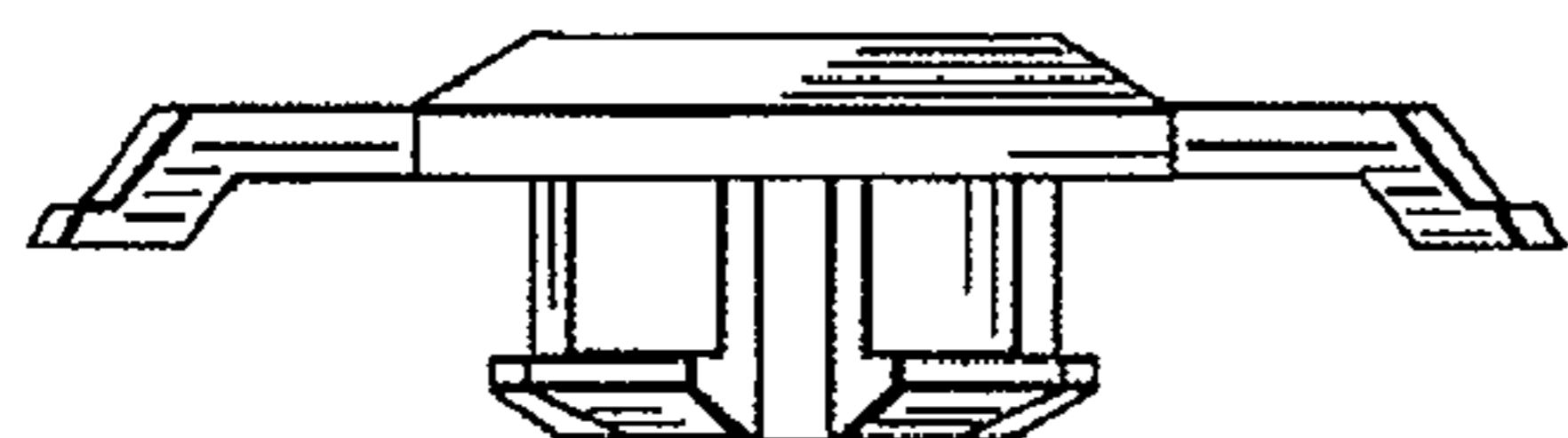

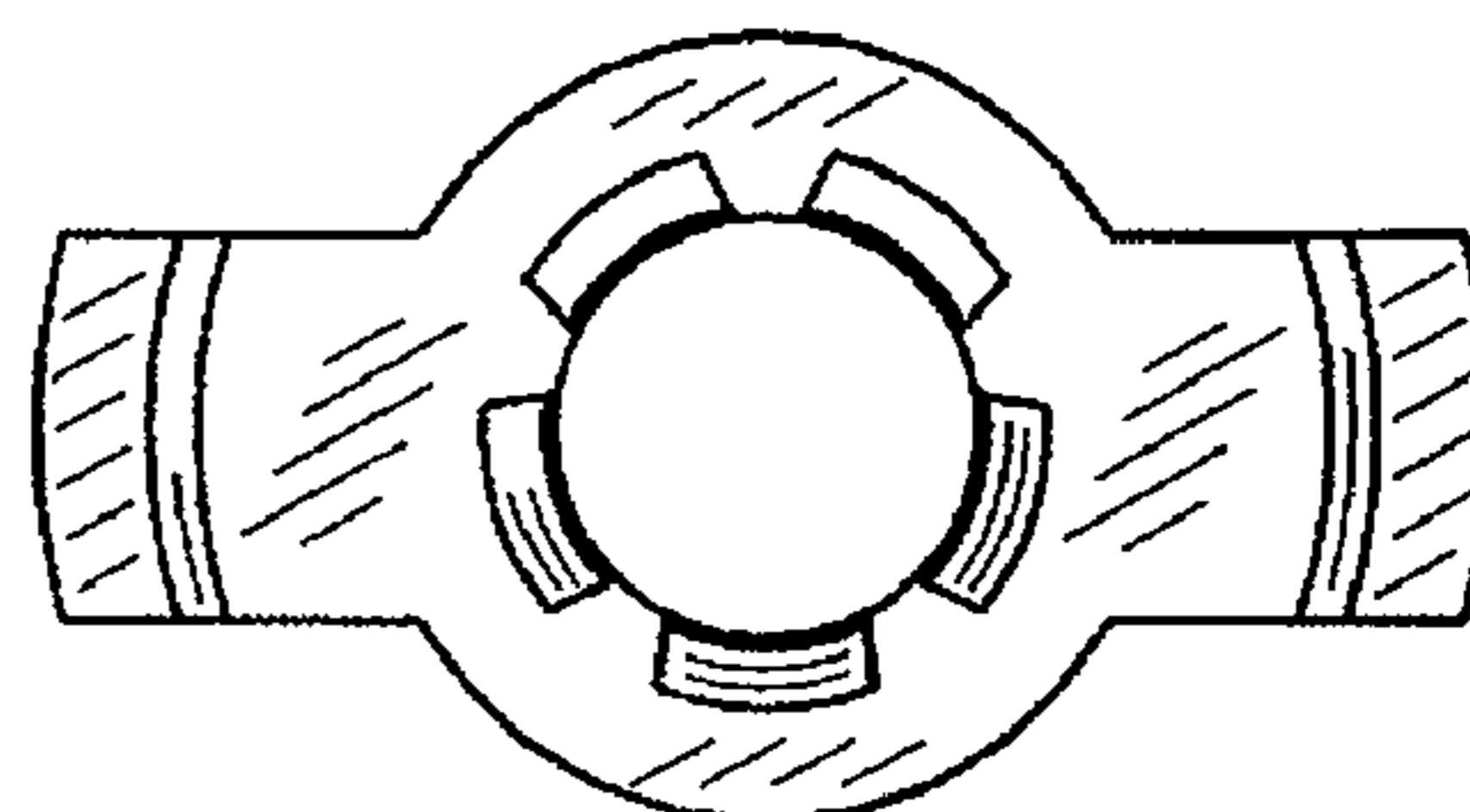

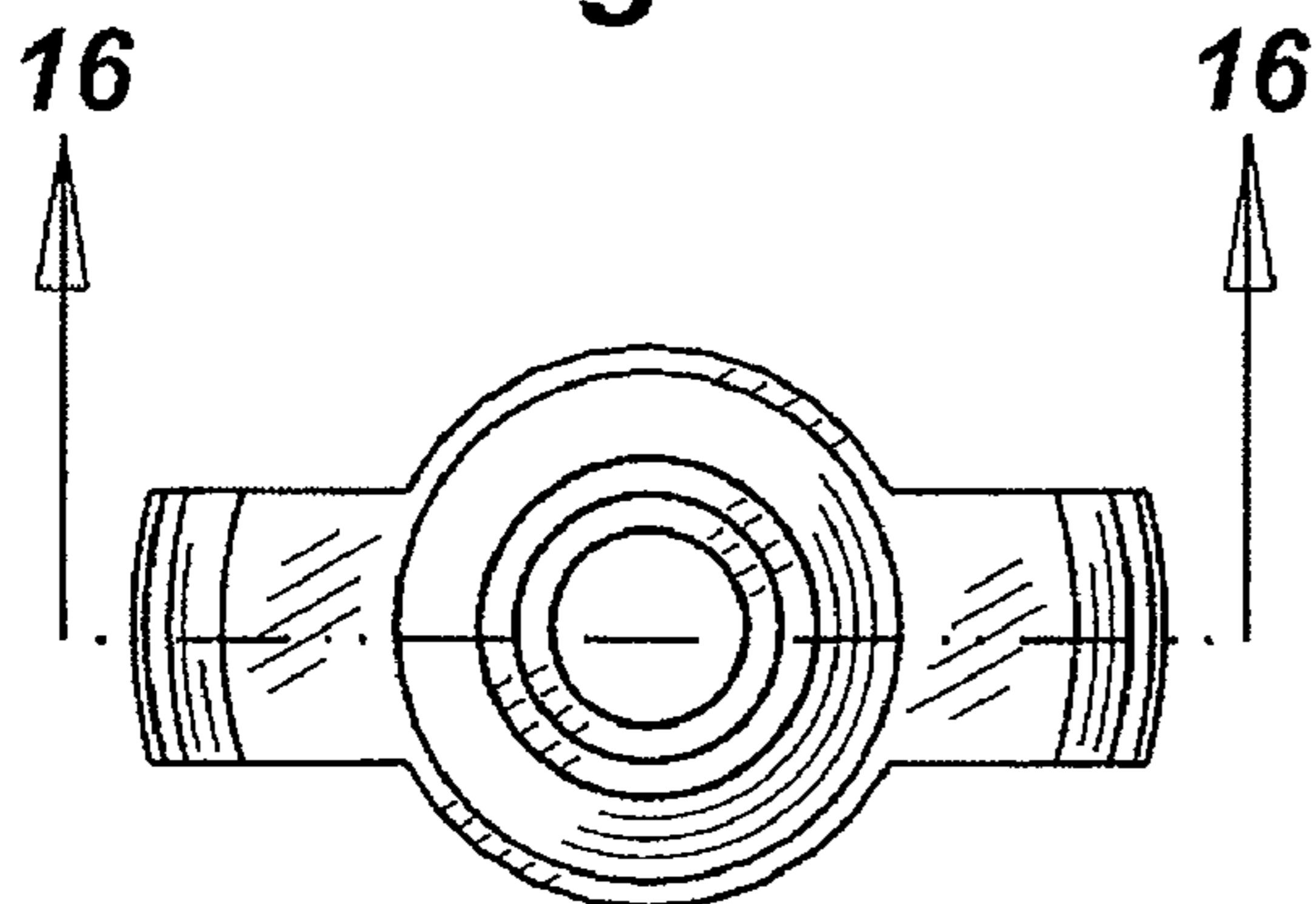

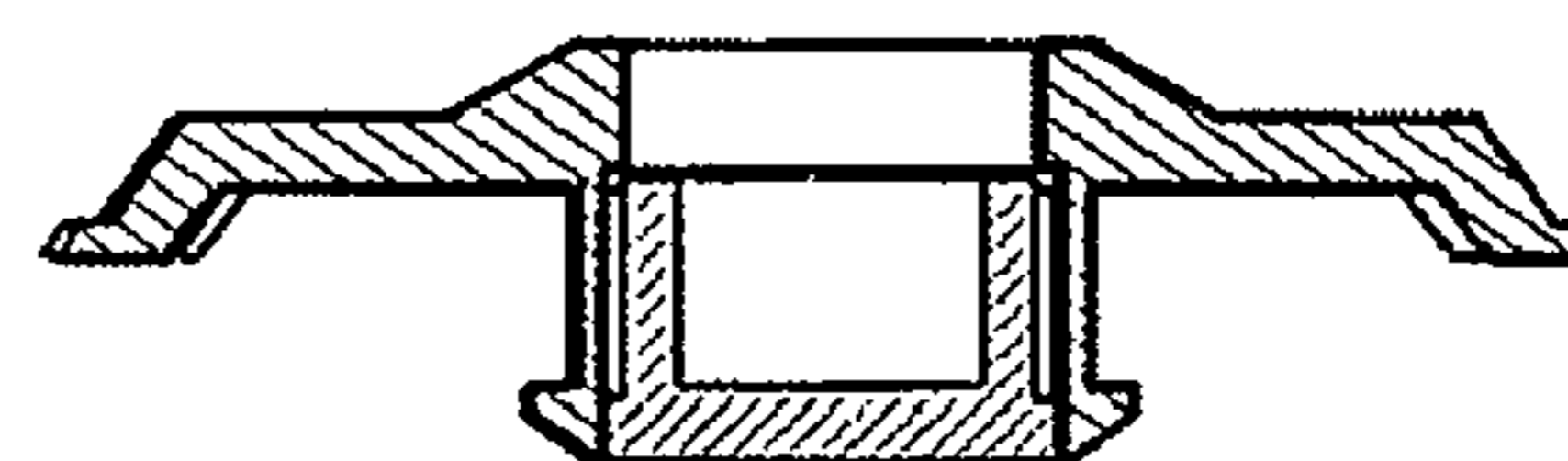
