FIG. 21 is a left side elevational view thereof;

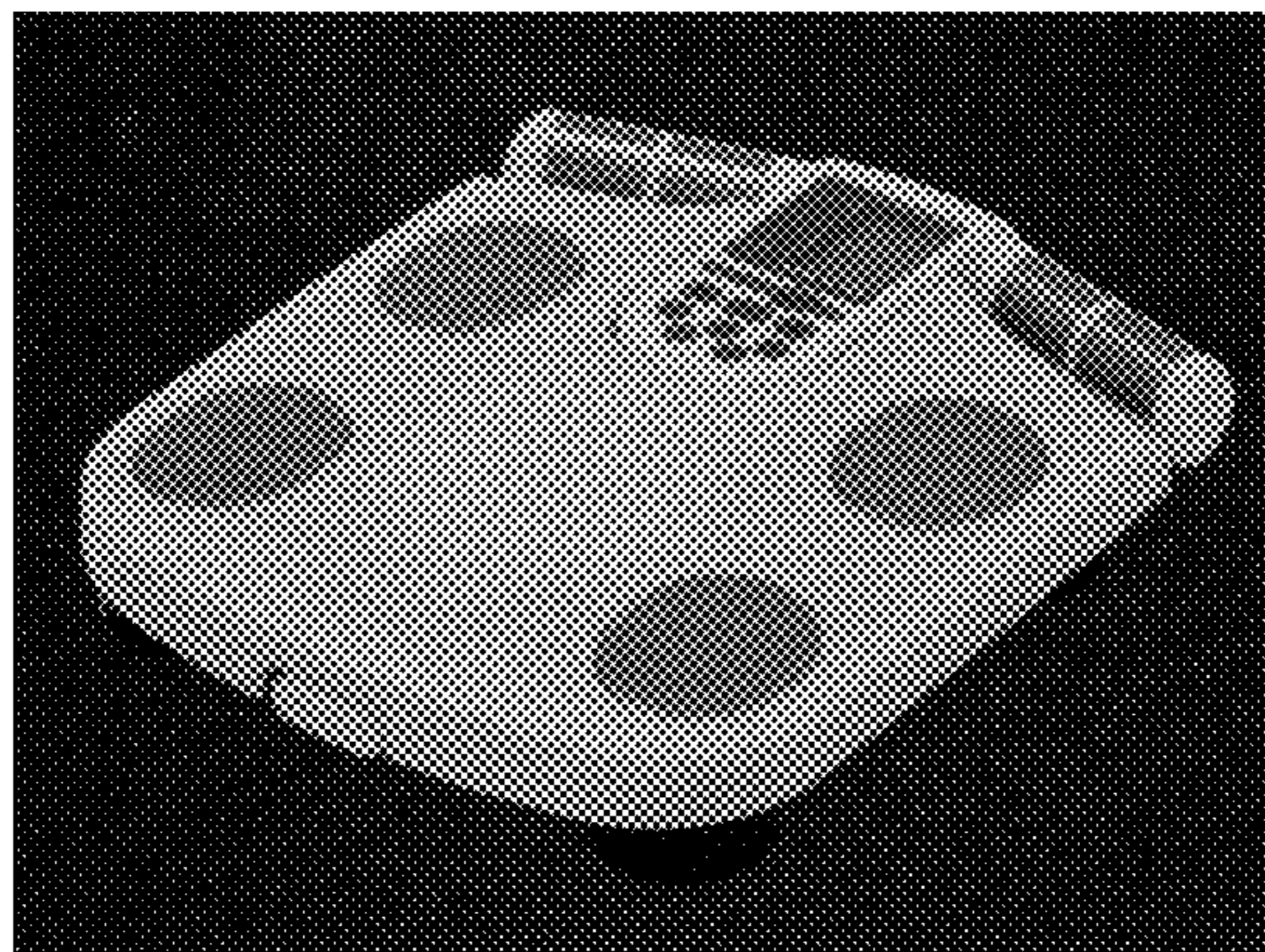


FIG. **22** is a perspective view showing a condition in which the handle is removed thereof;

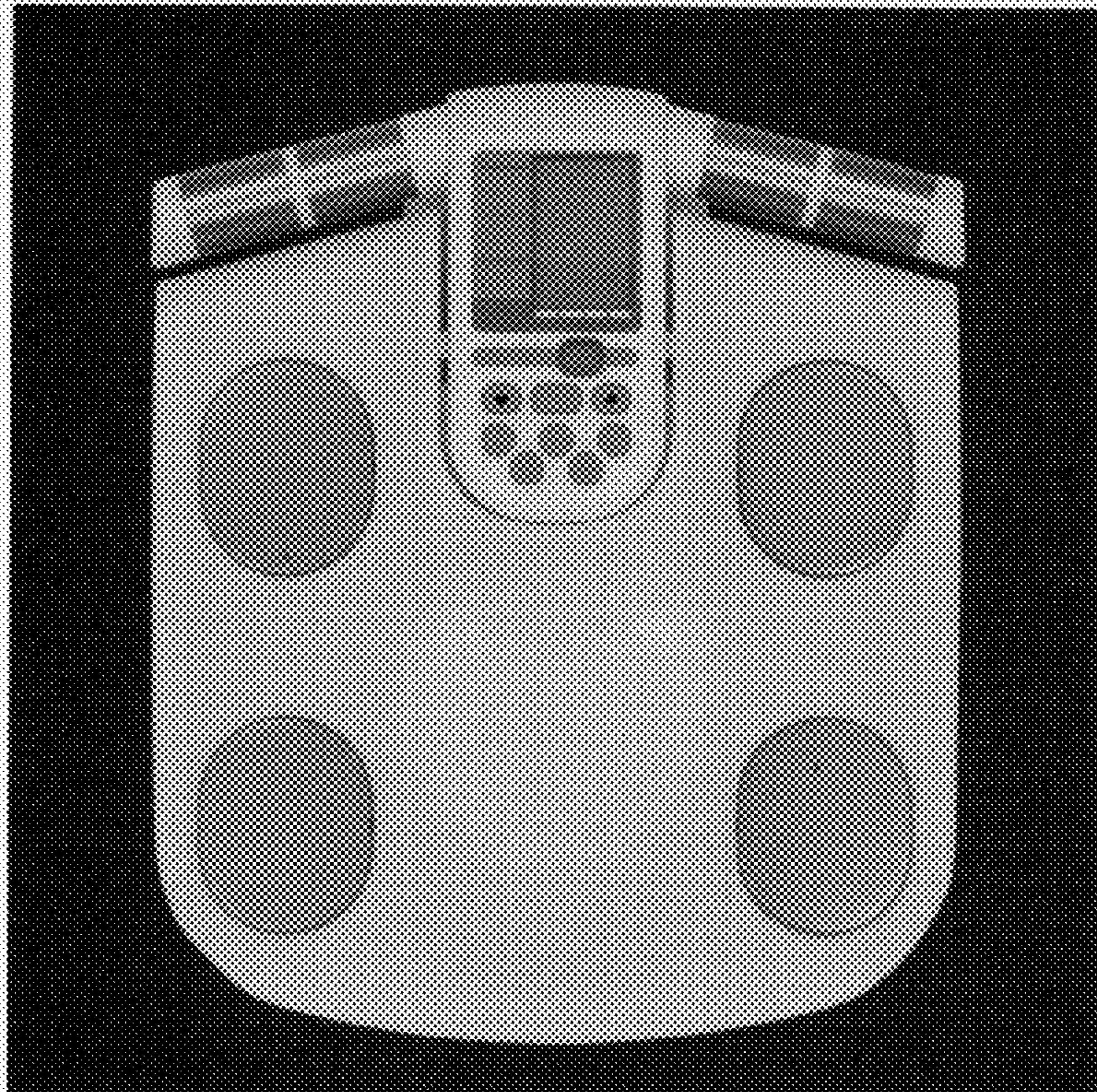

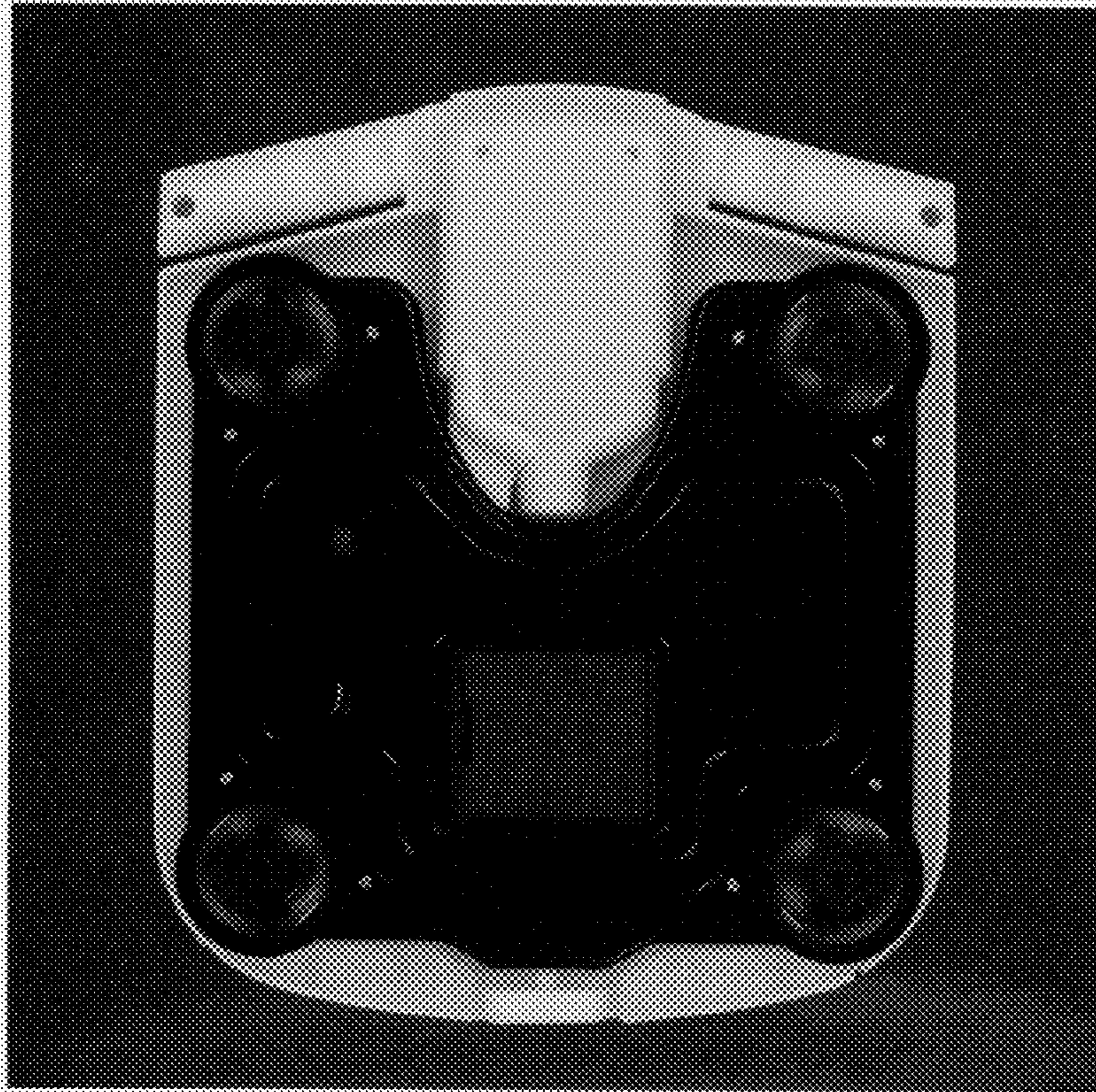

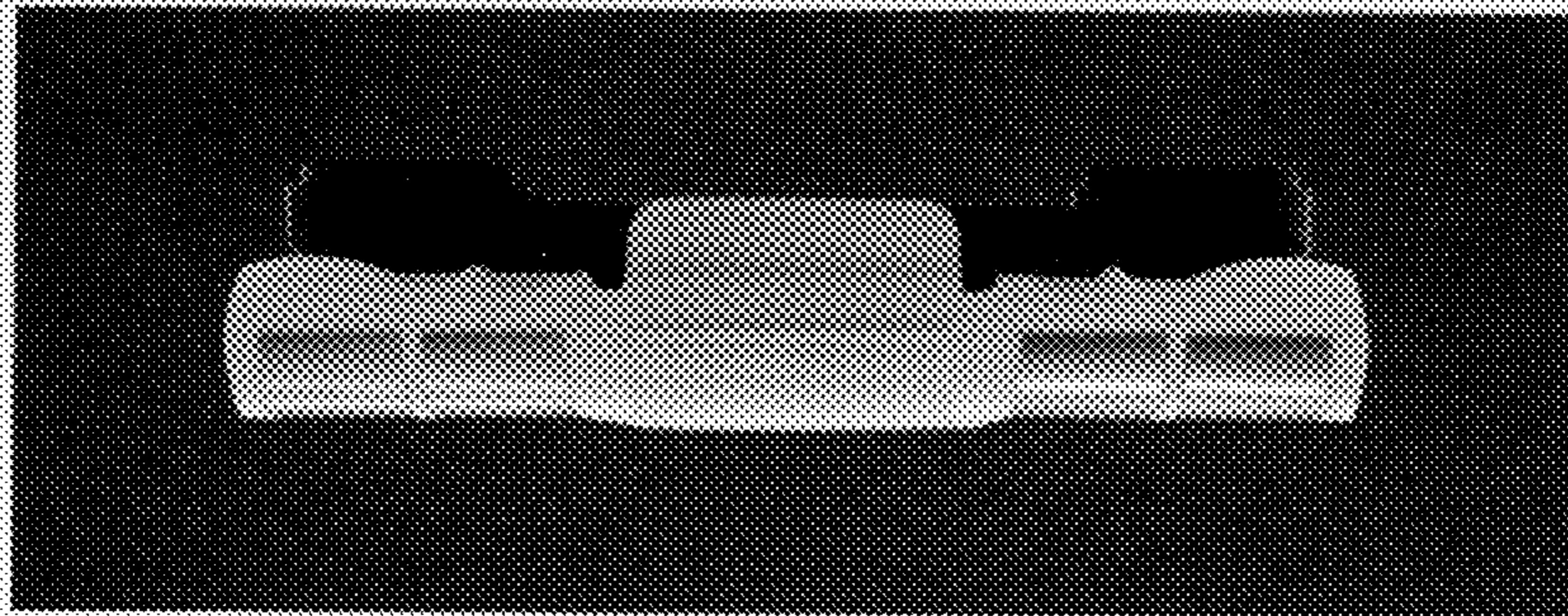

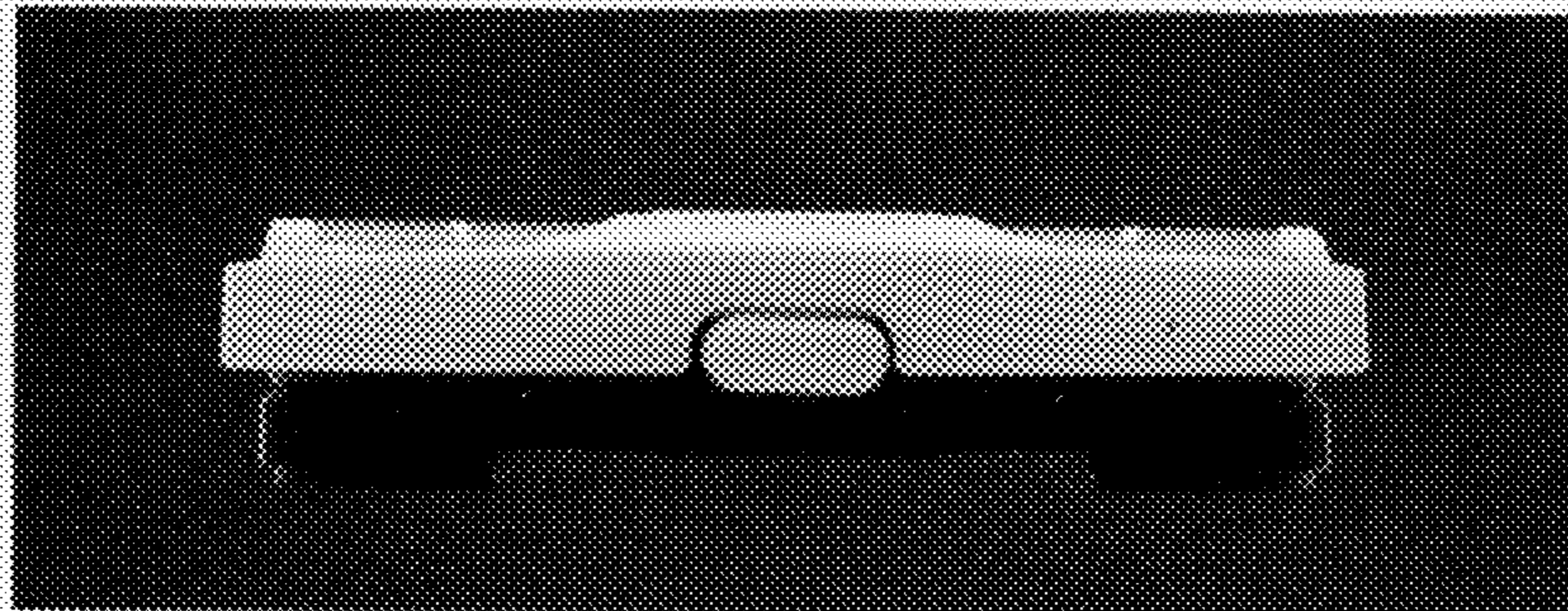

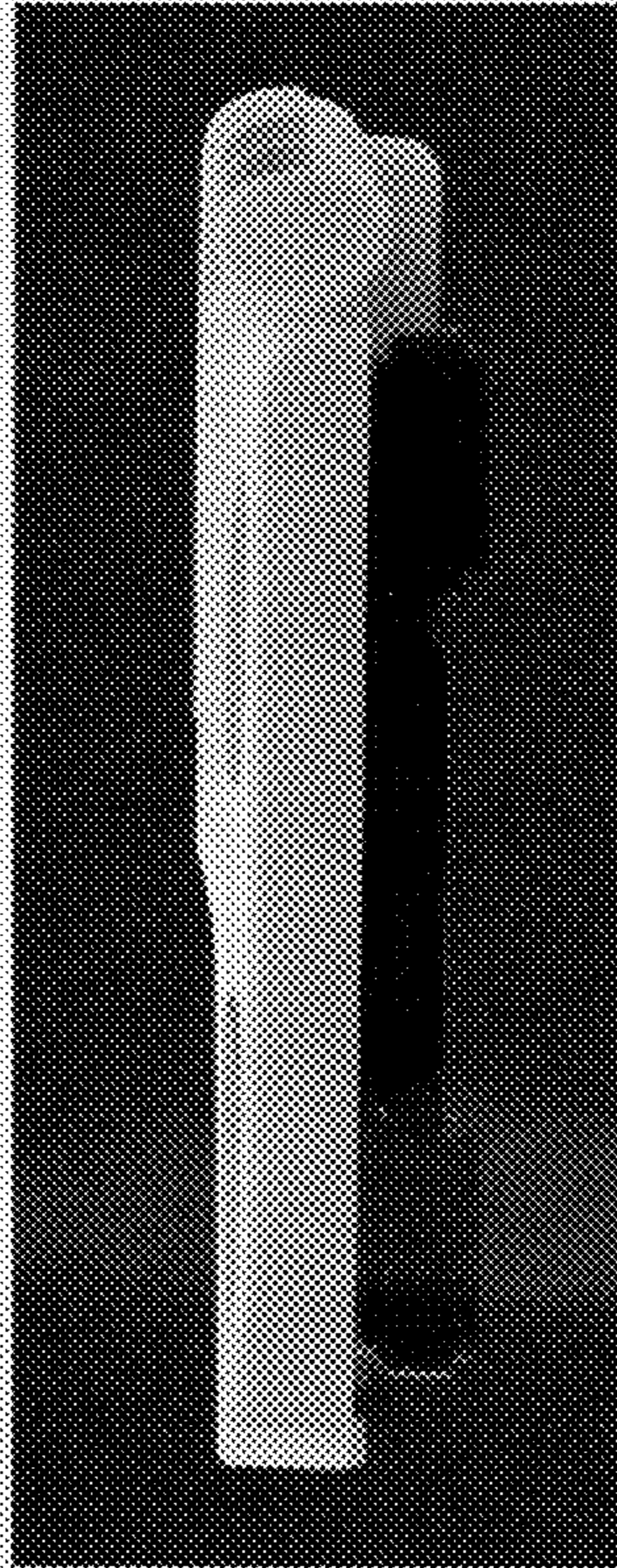

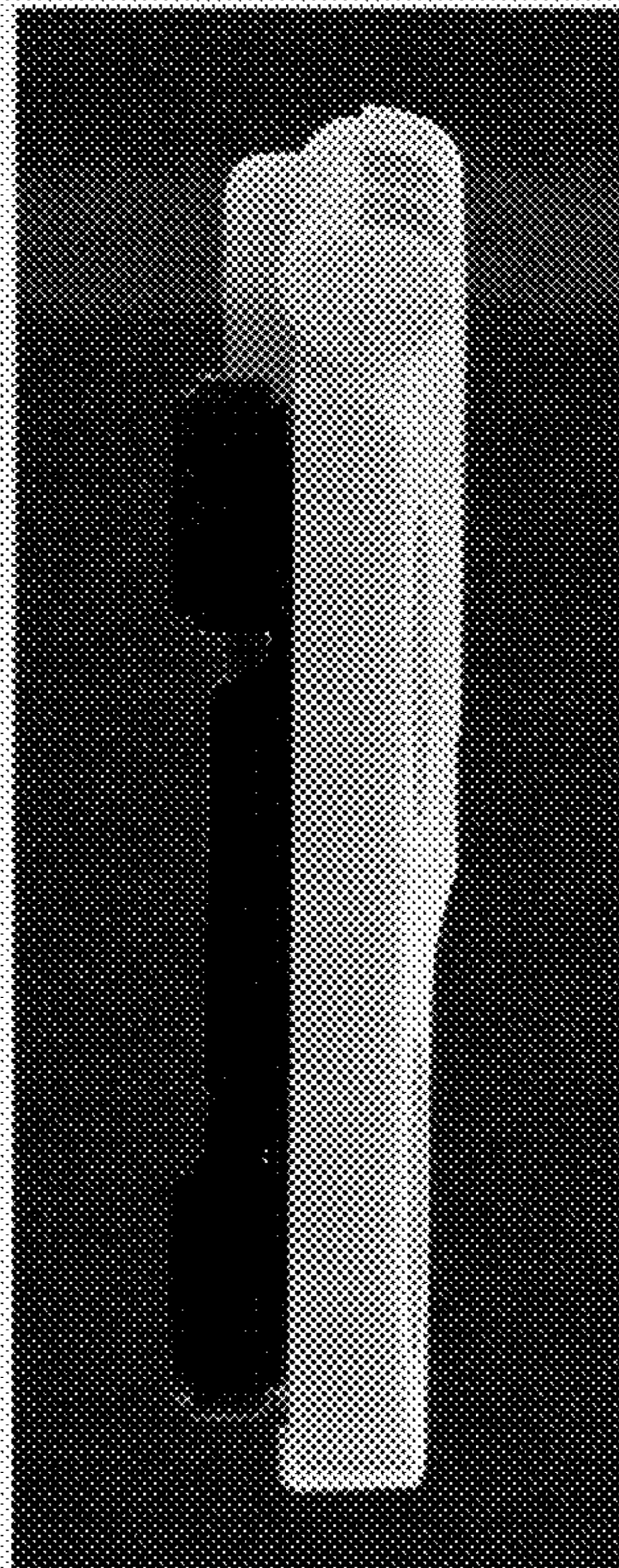

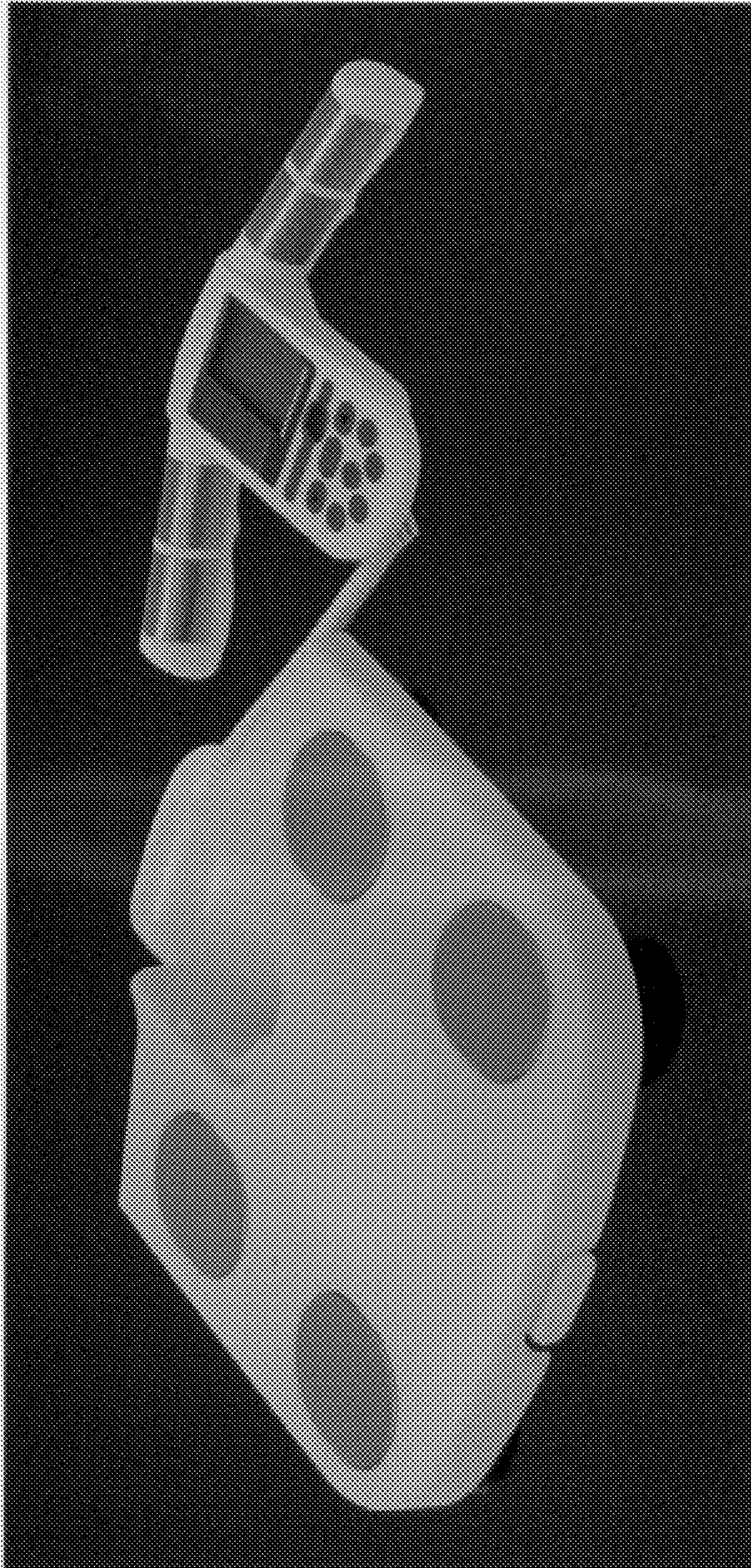

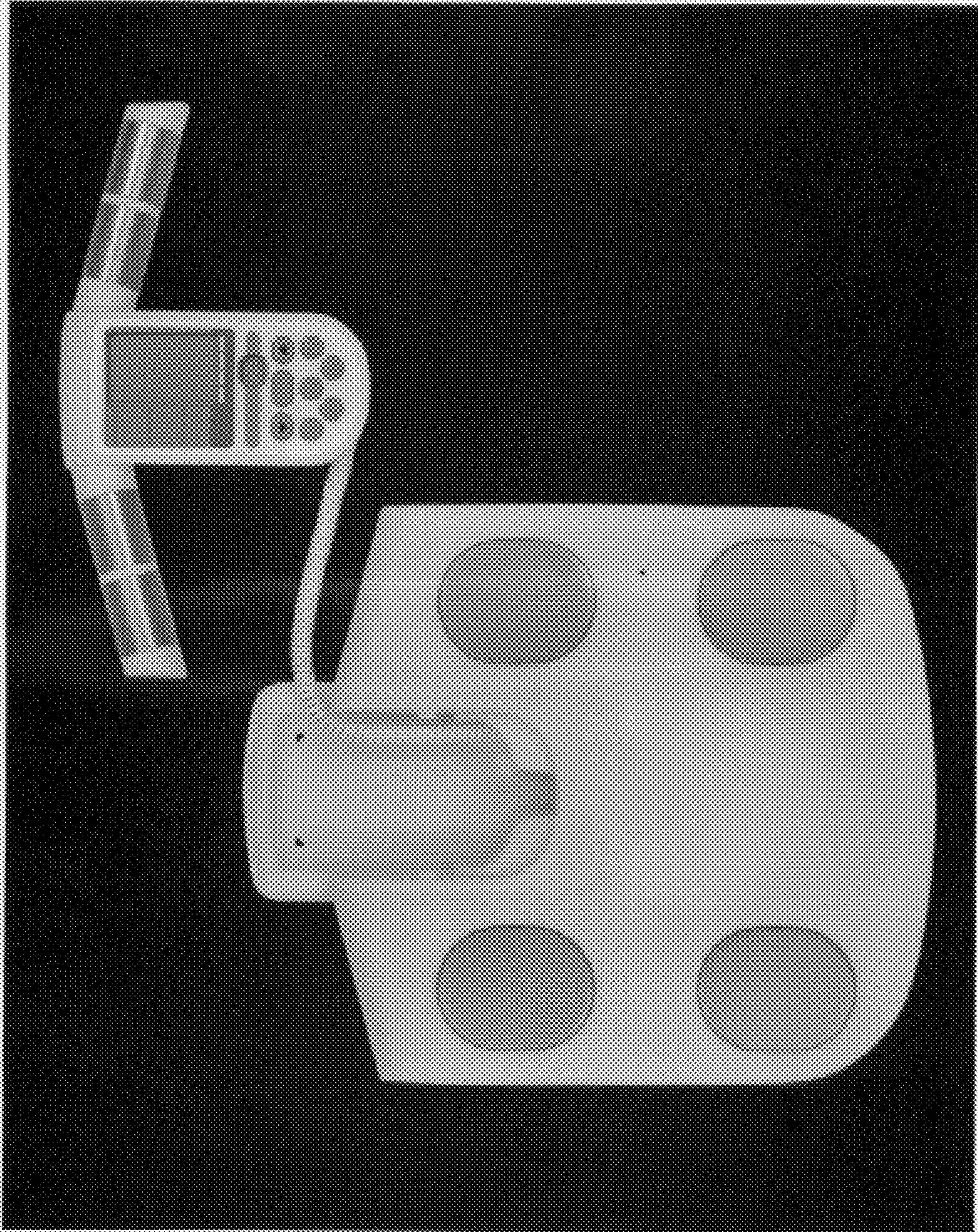

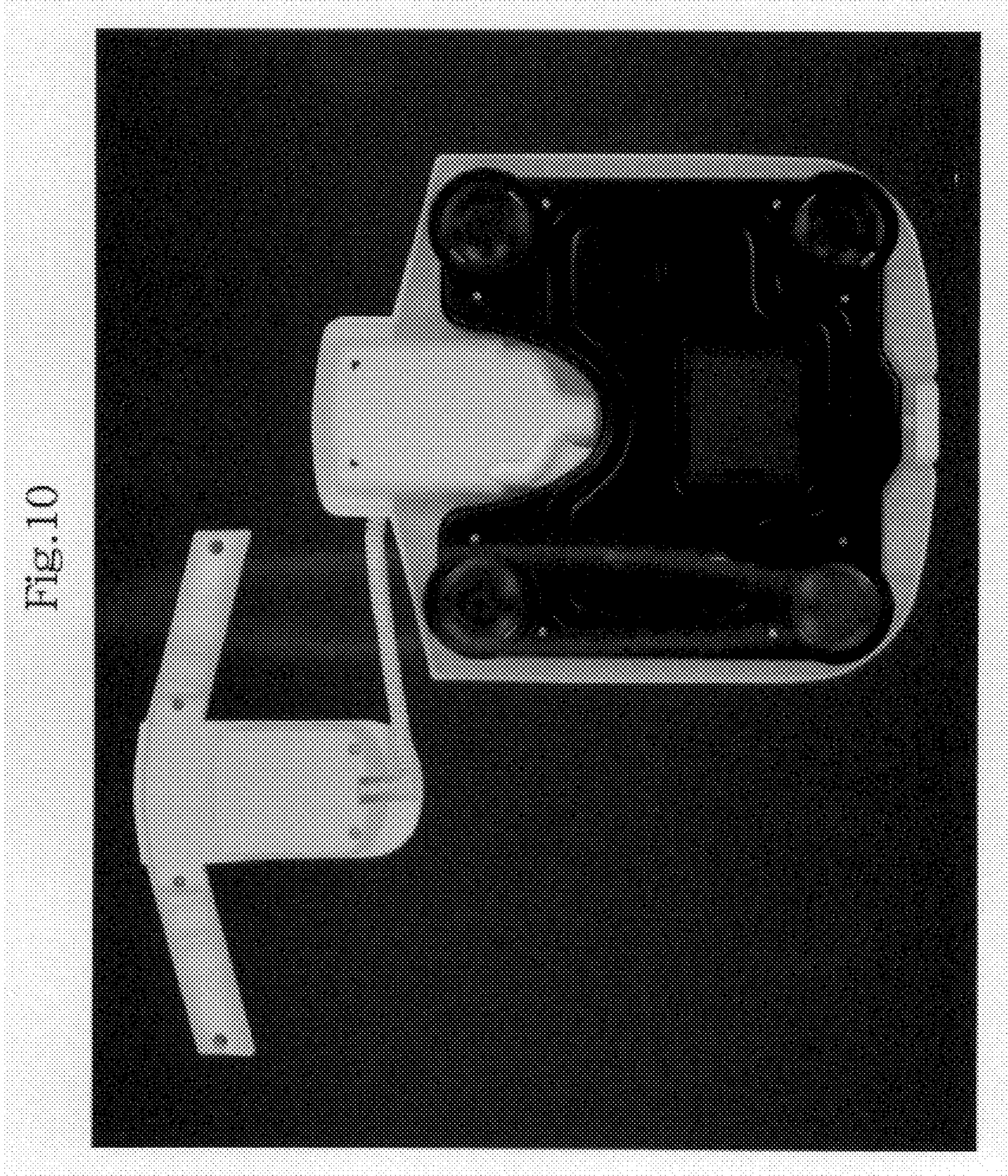

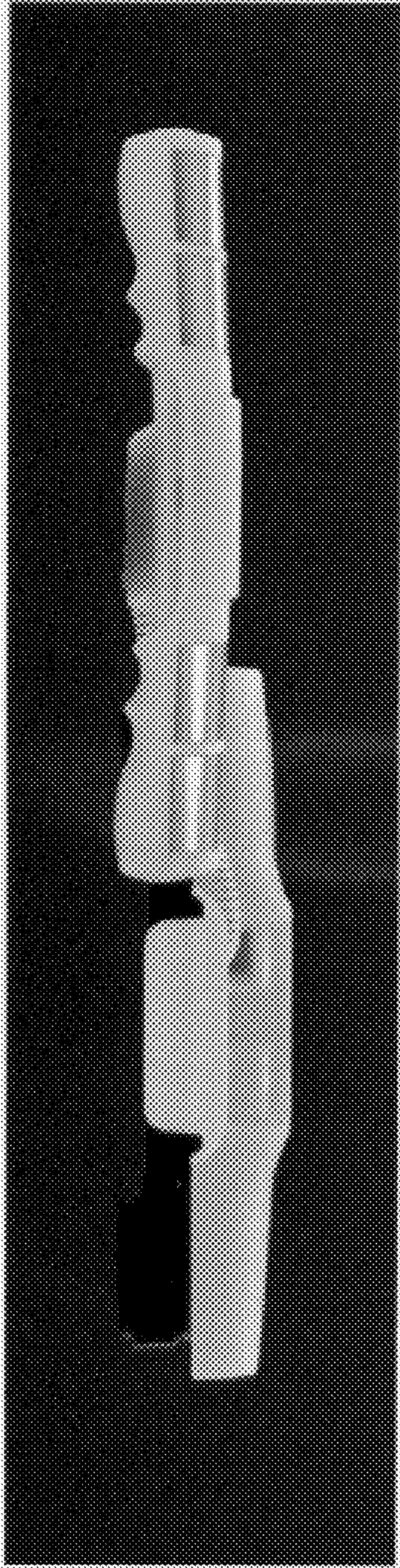

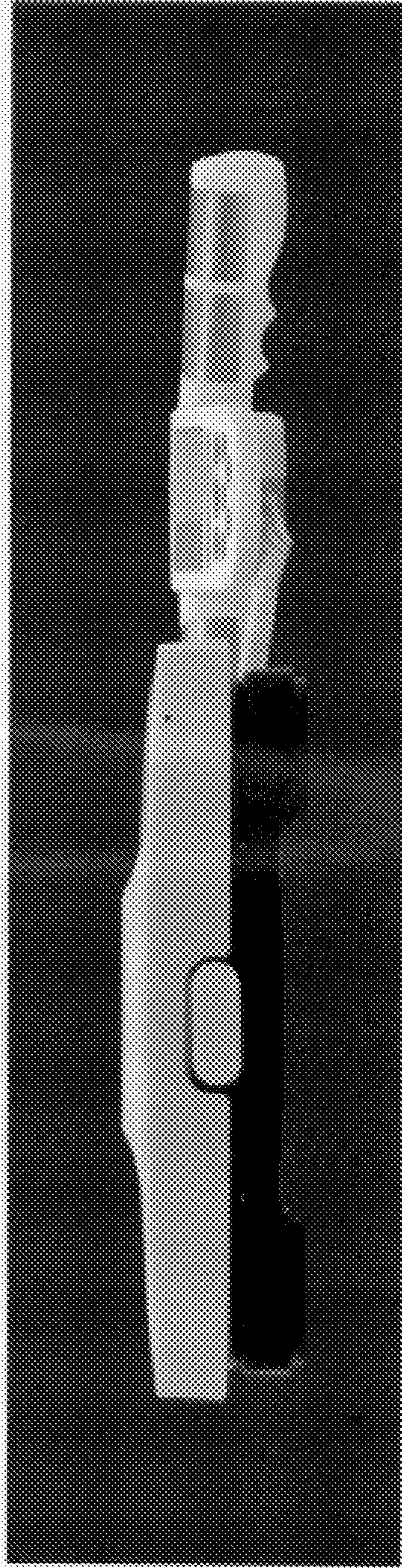

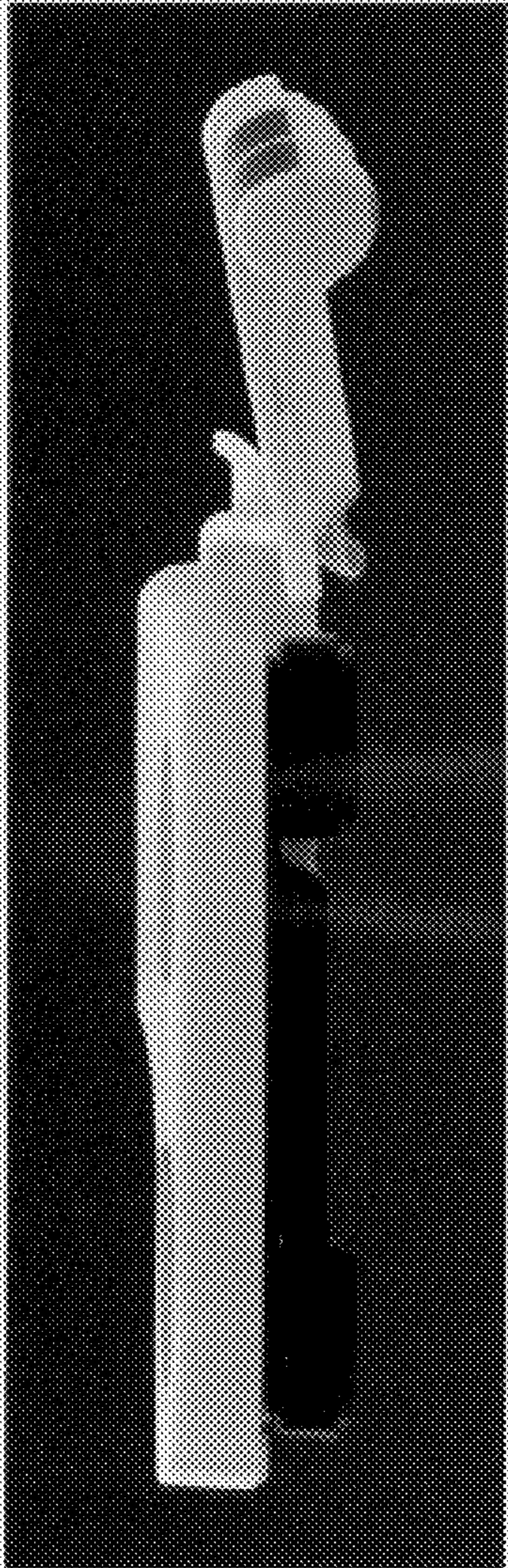

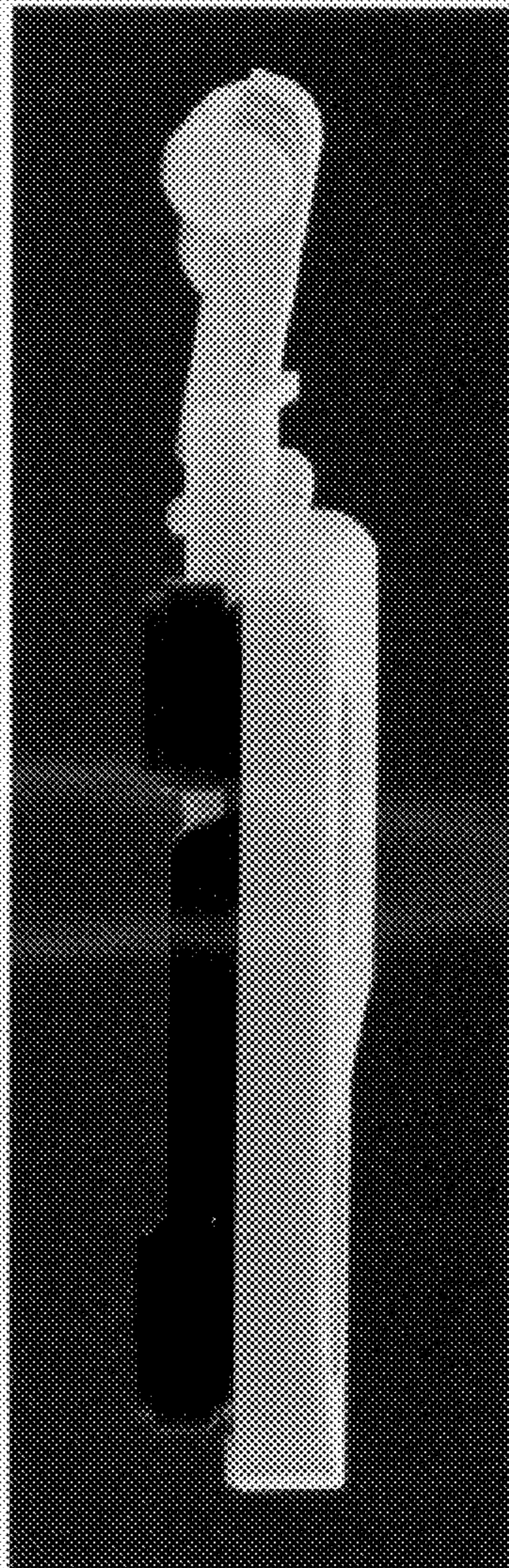

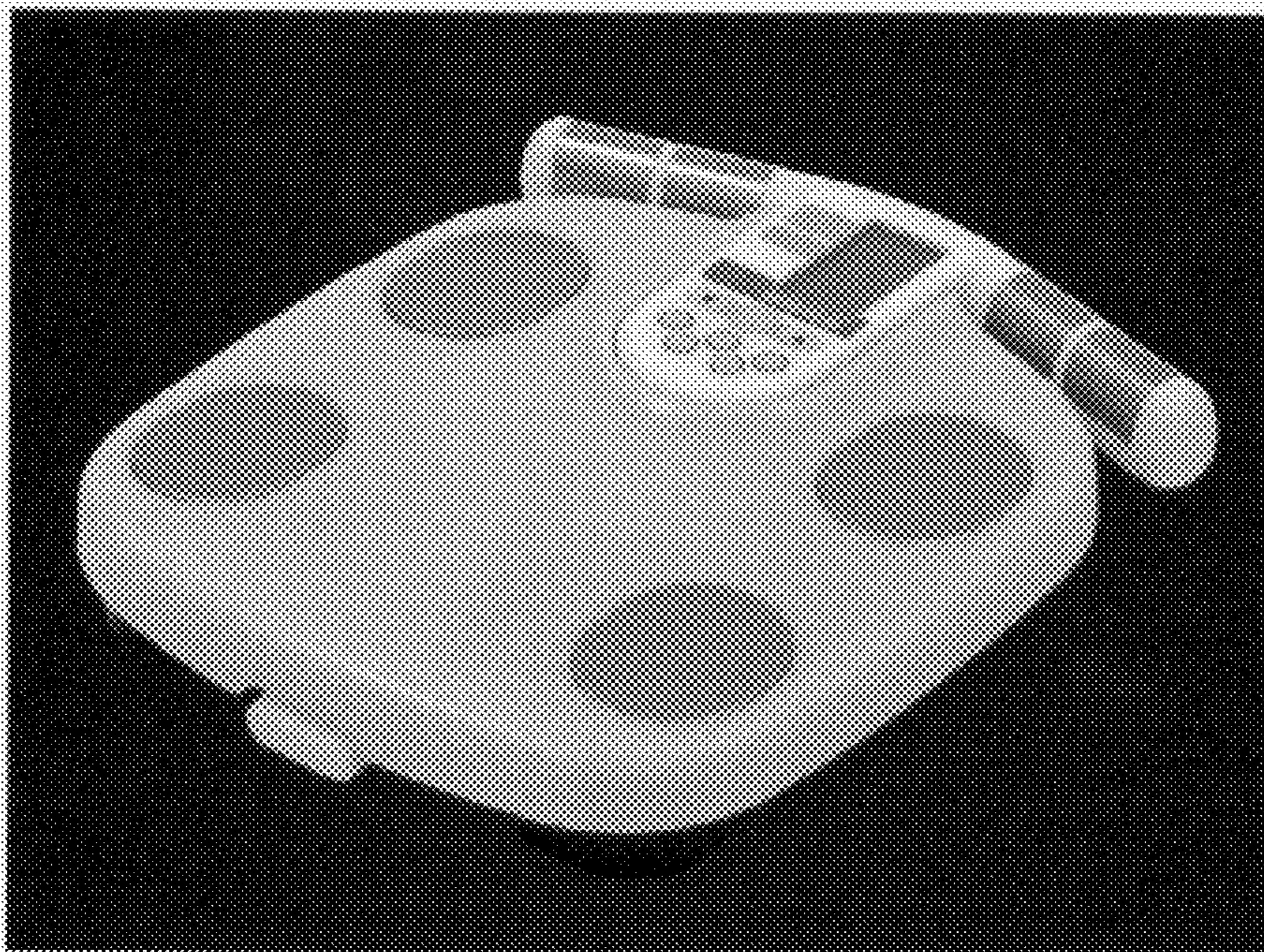

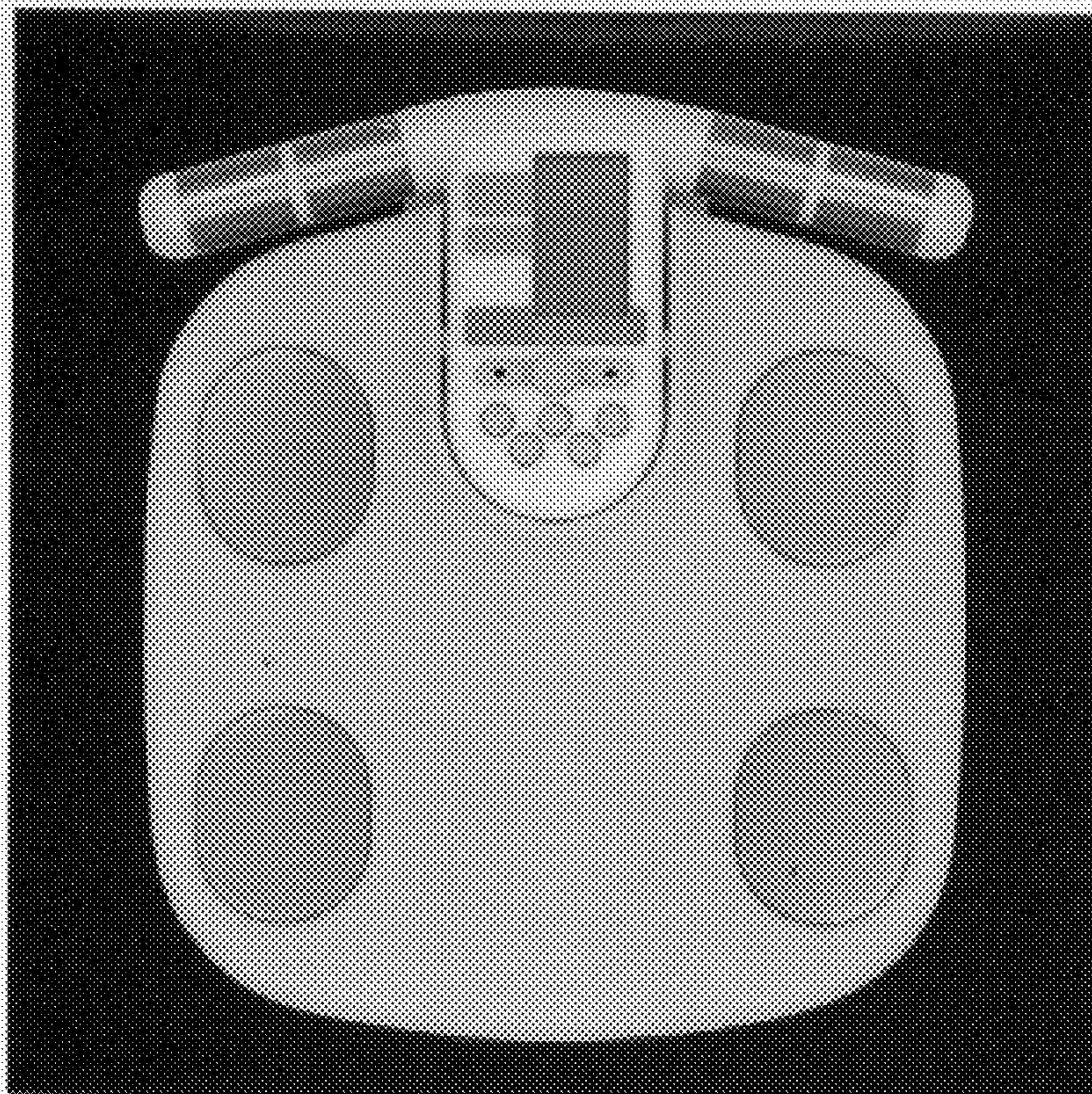

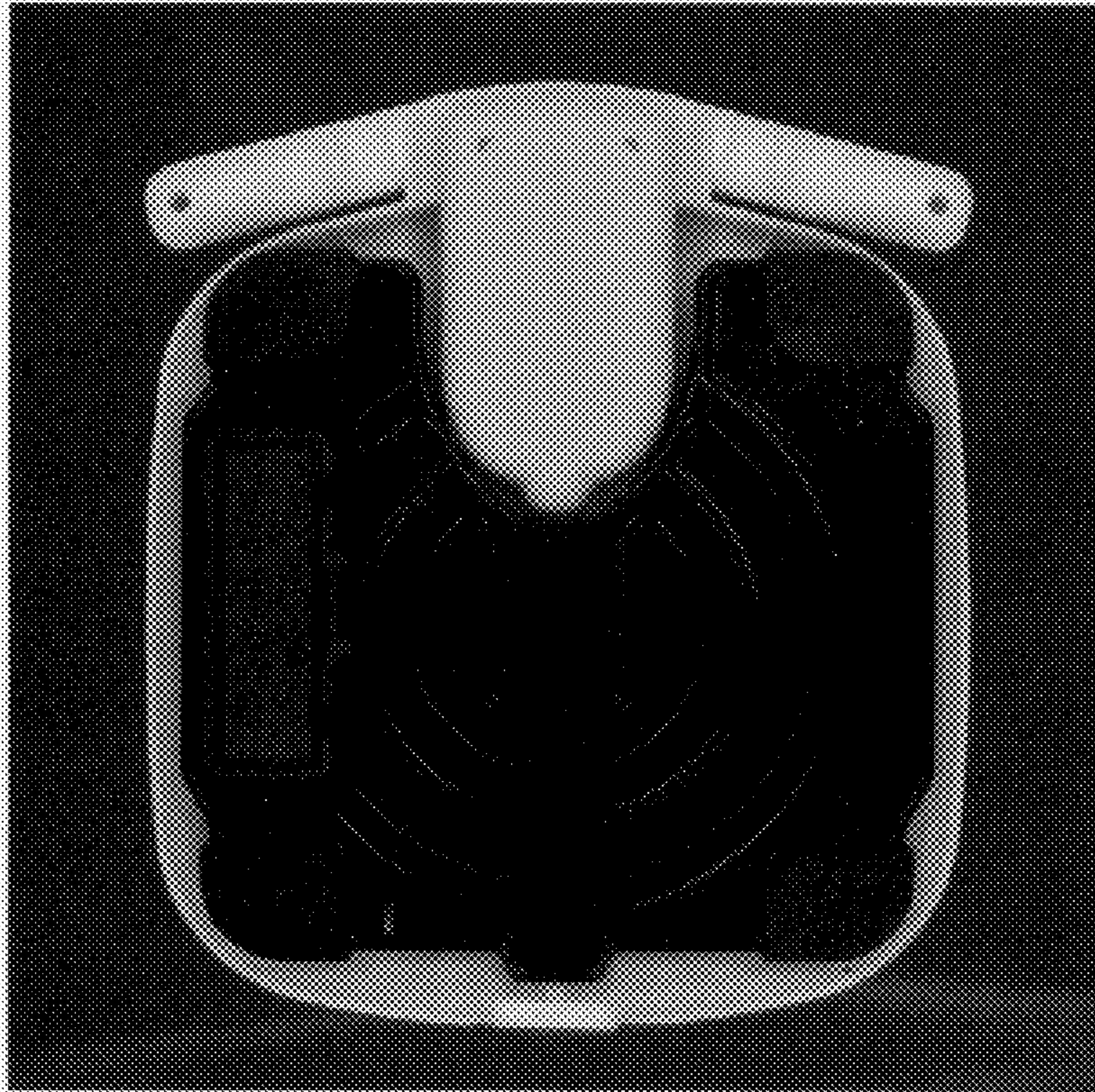

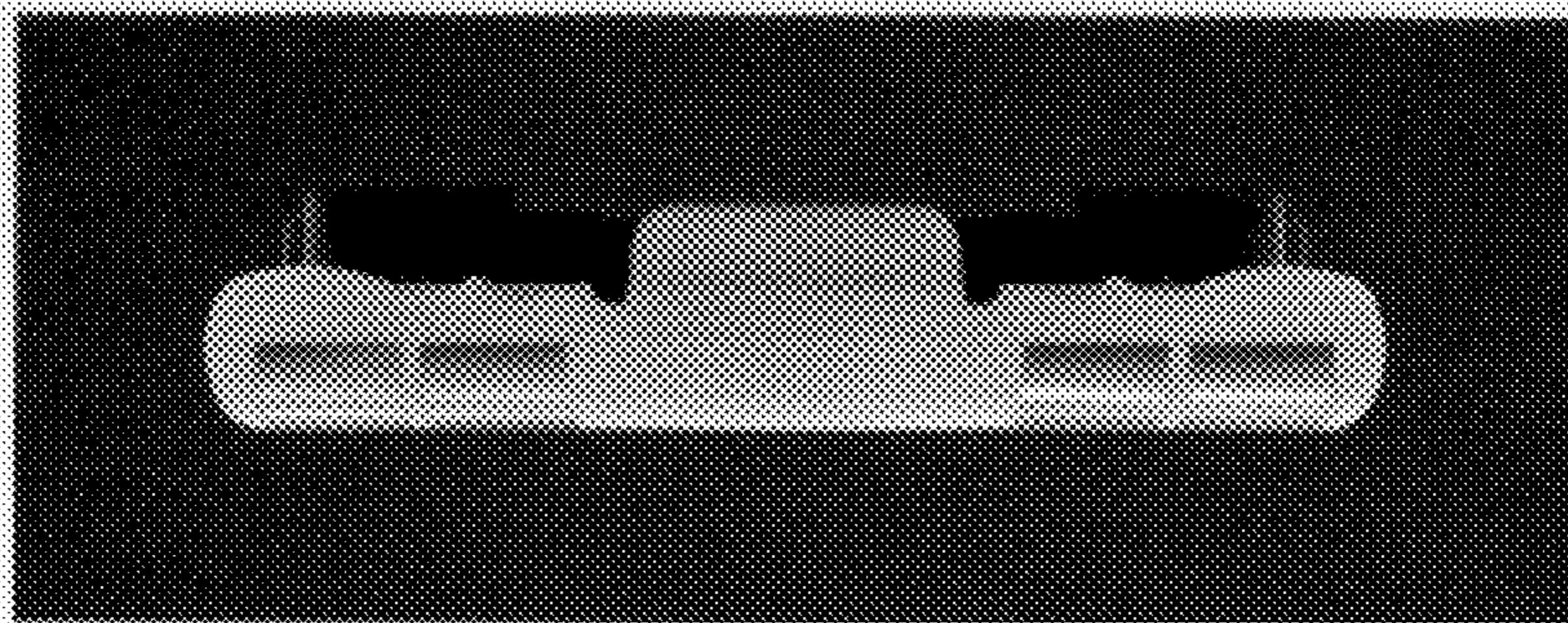

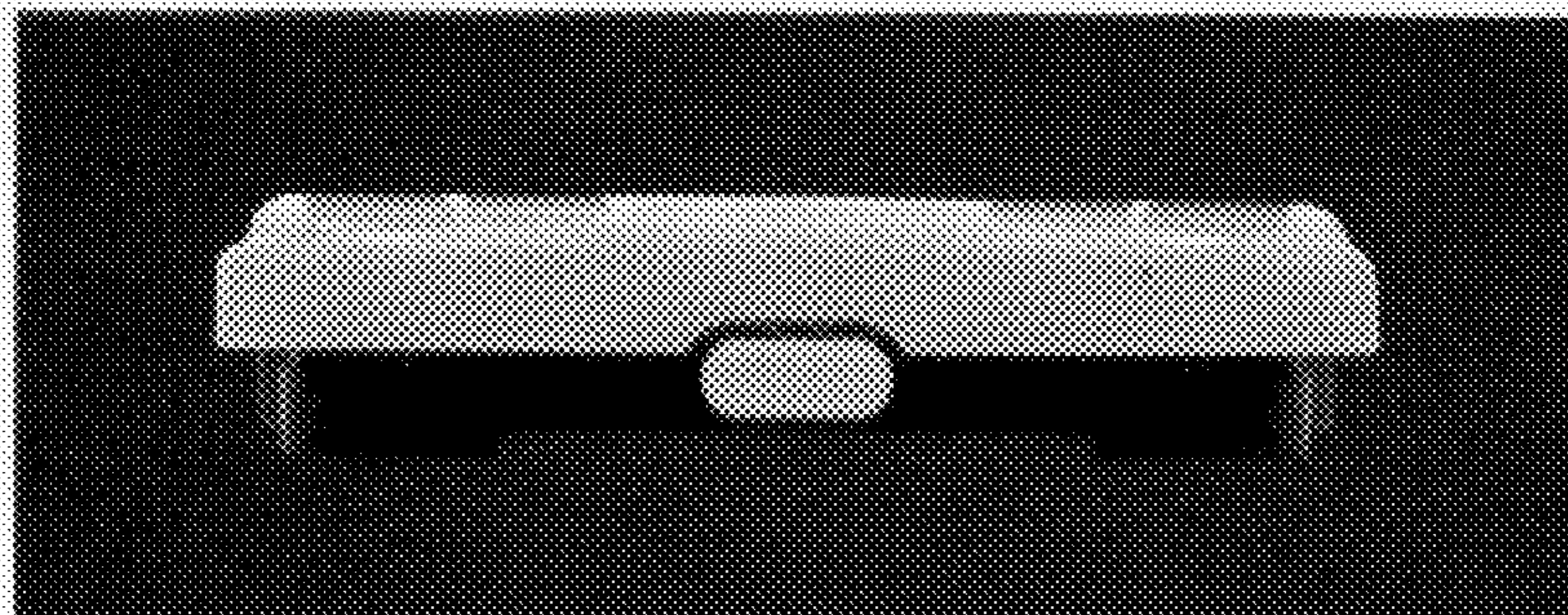

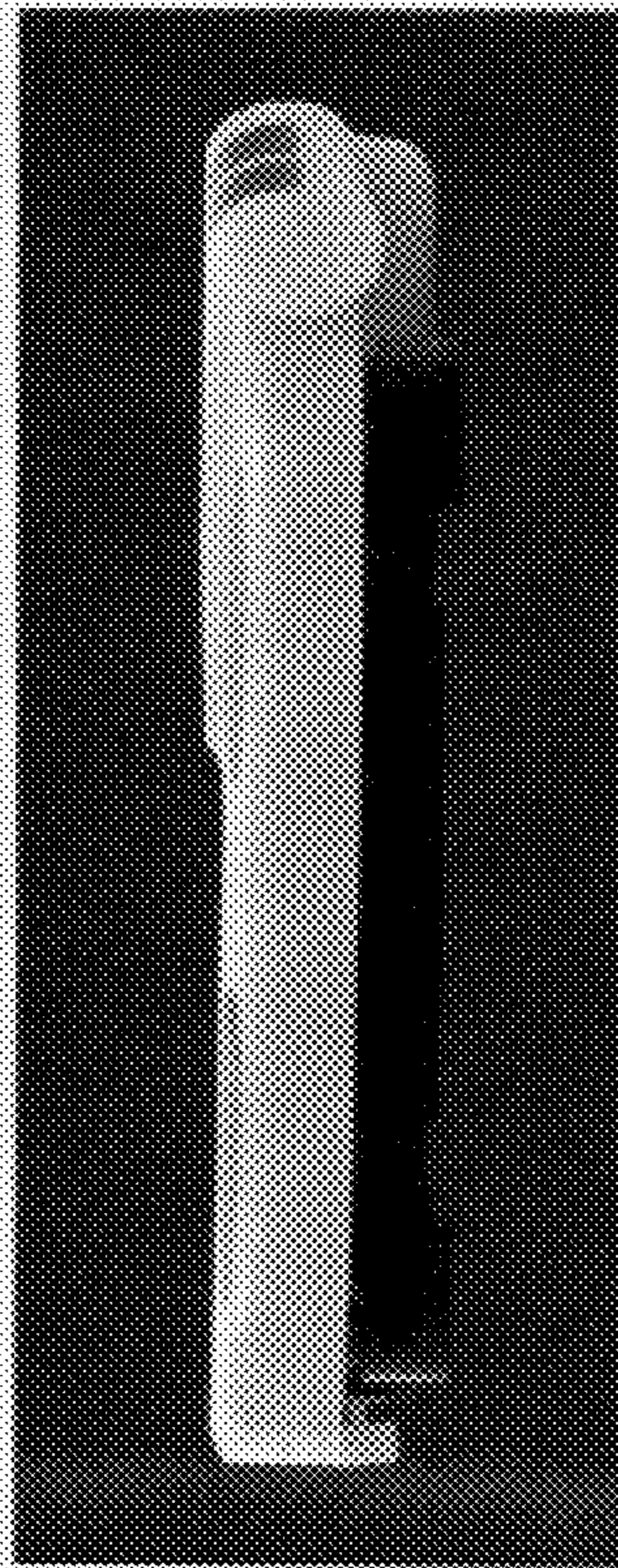

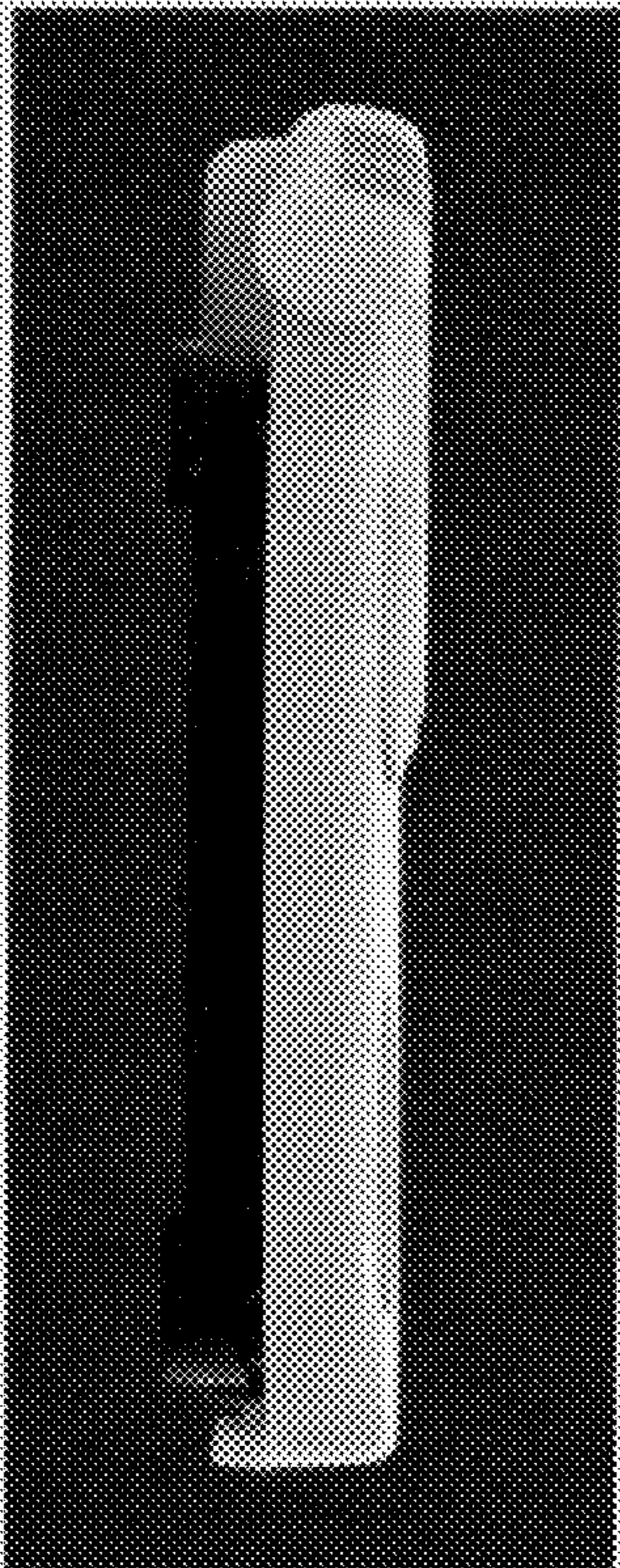

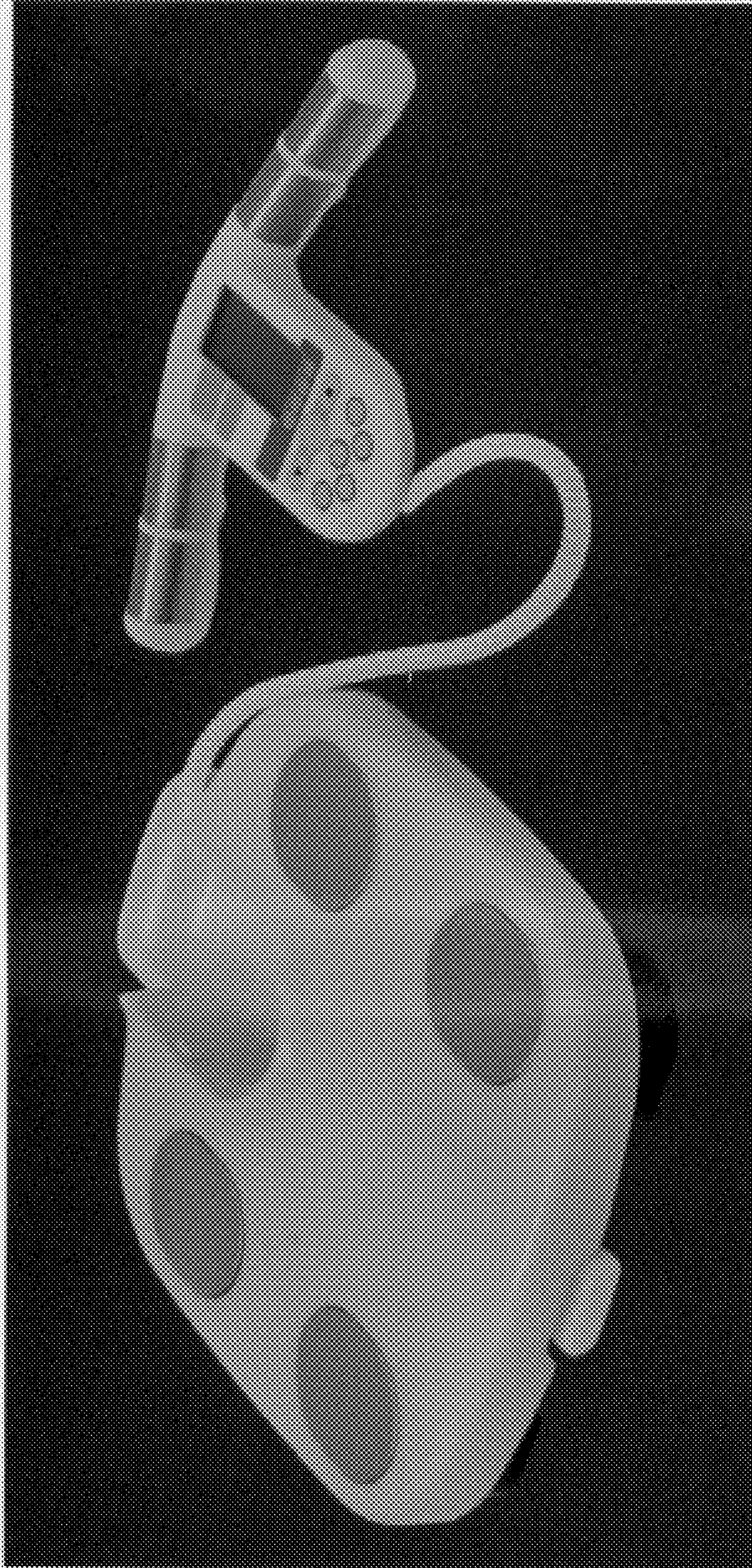

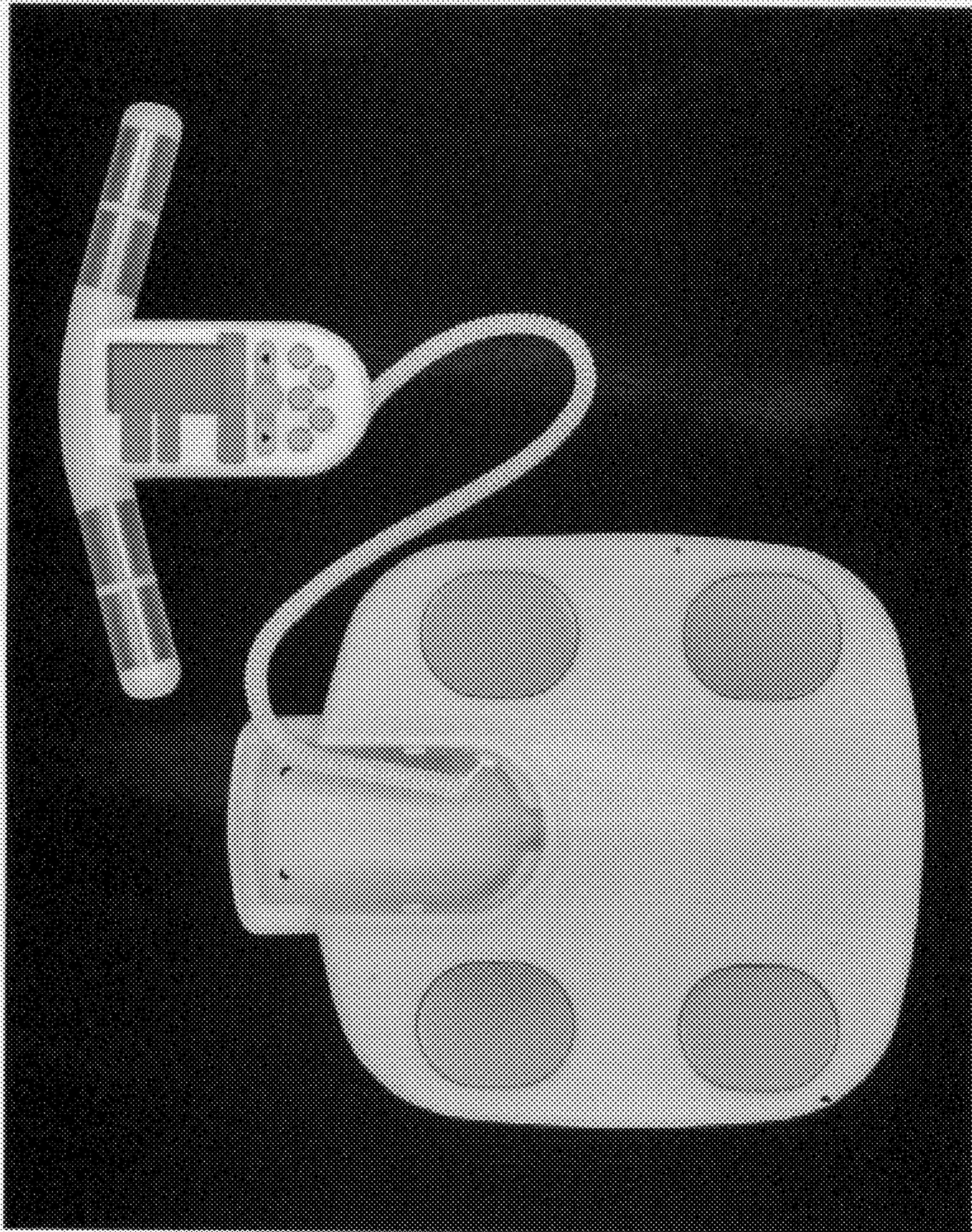

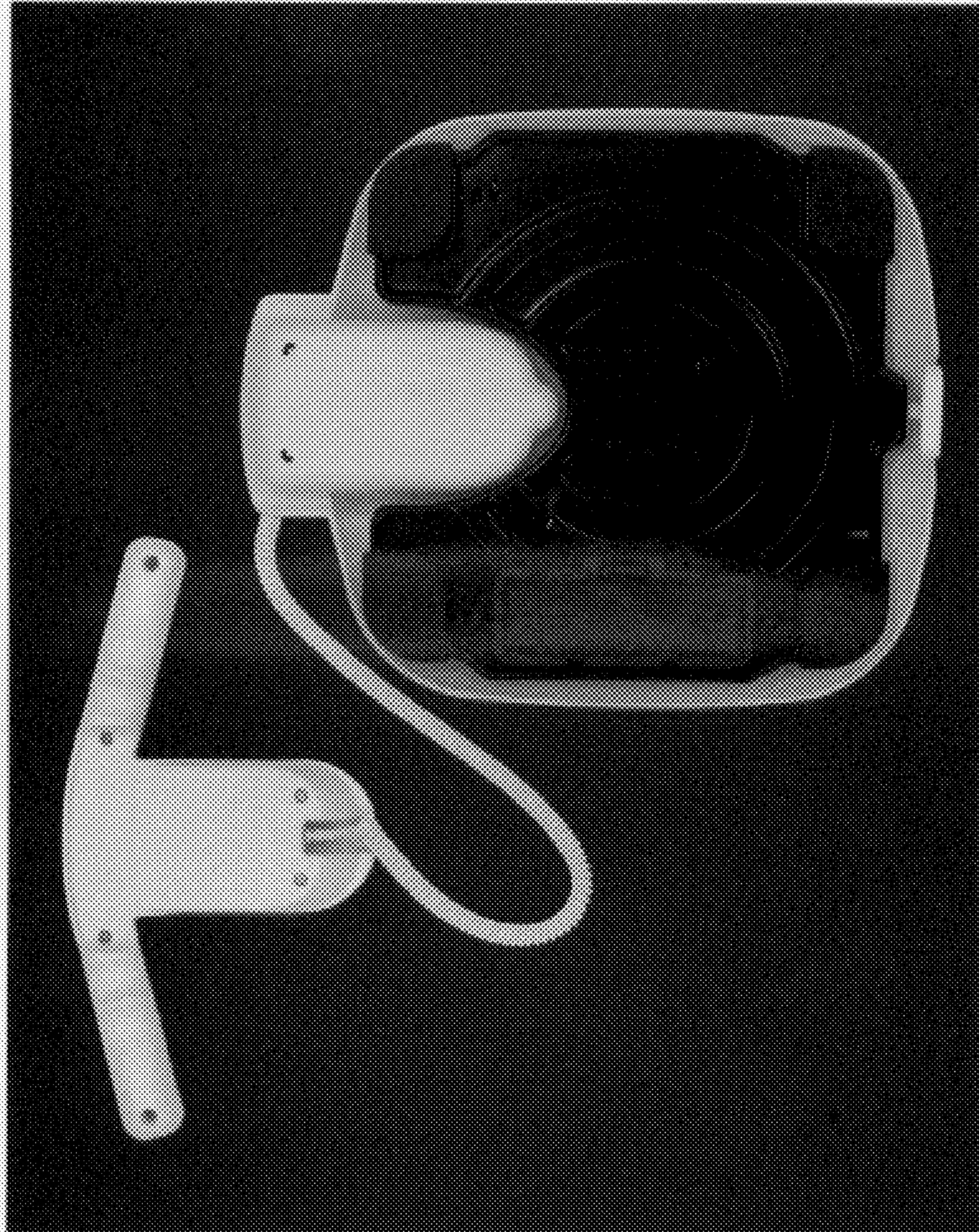

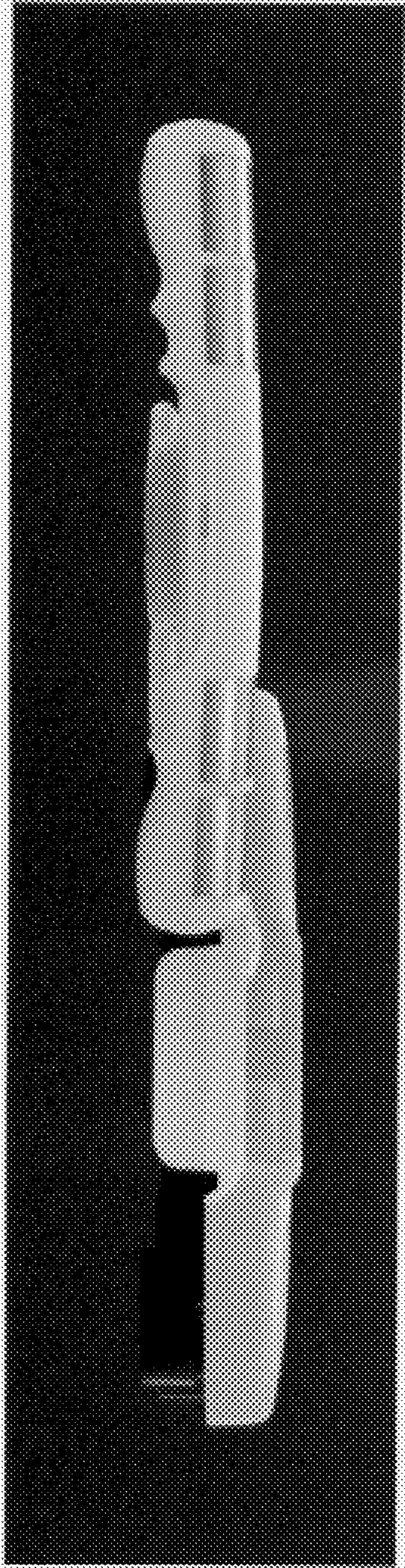

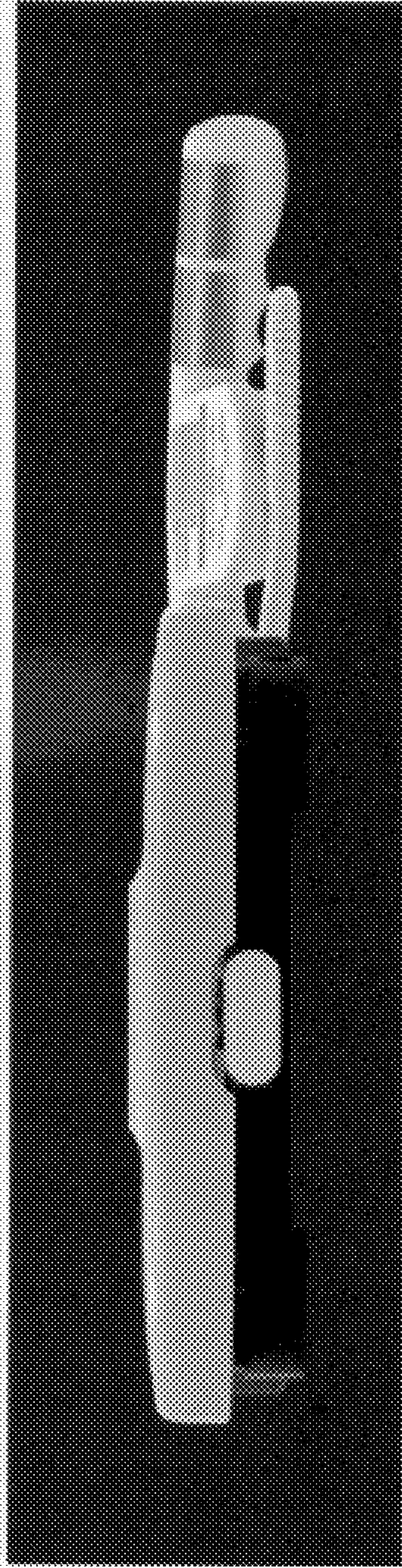

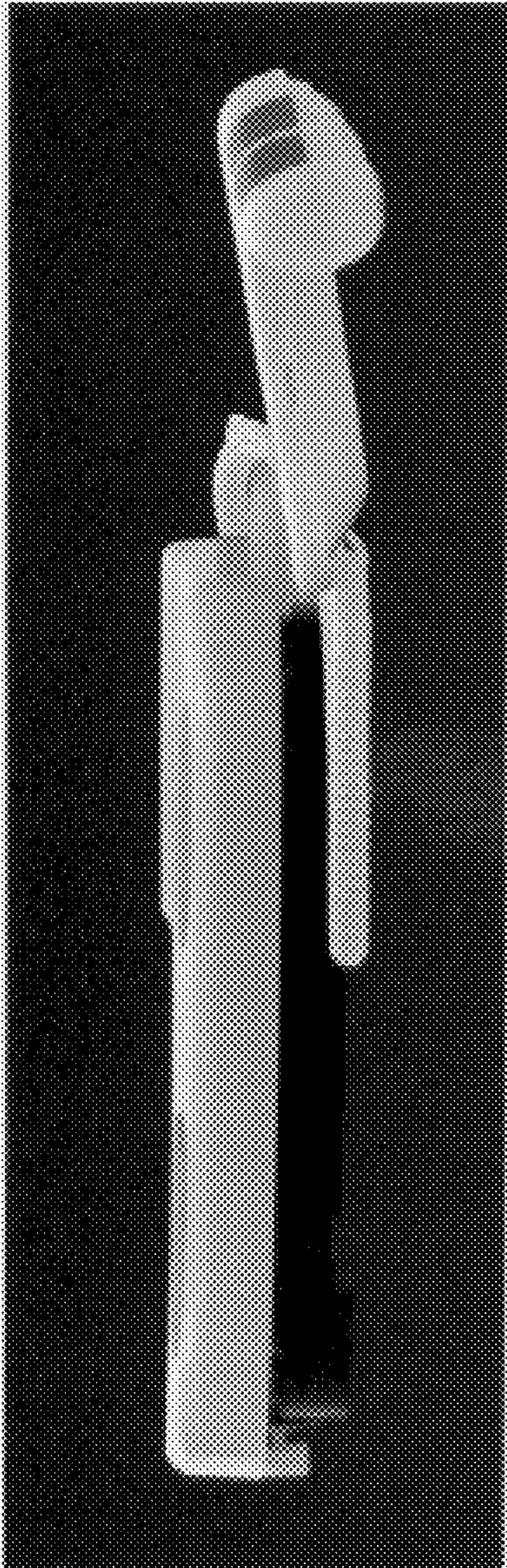
