FIG. 10 is a front view thereof shown in an open position;

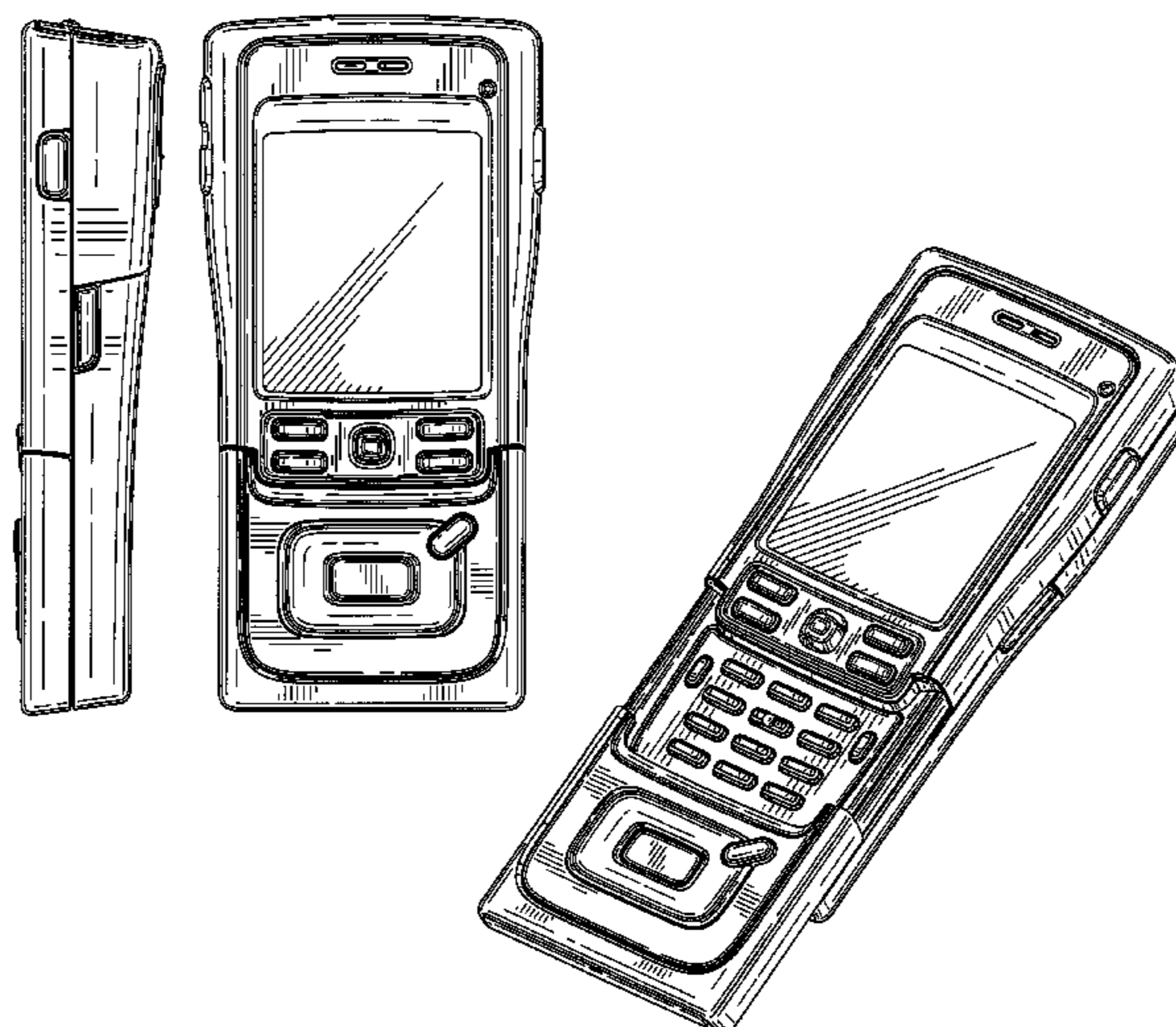
FIG. 11 is a left side view thereof shown in an open position;

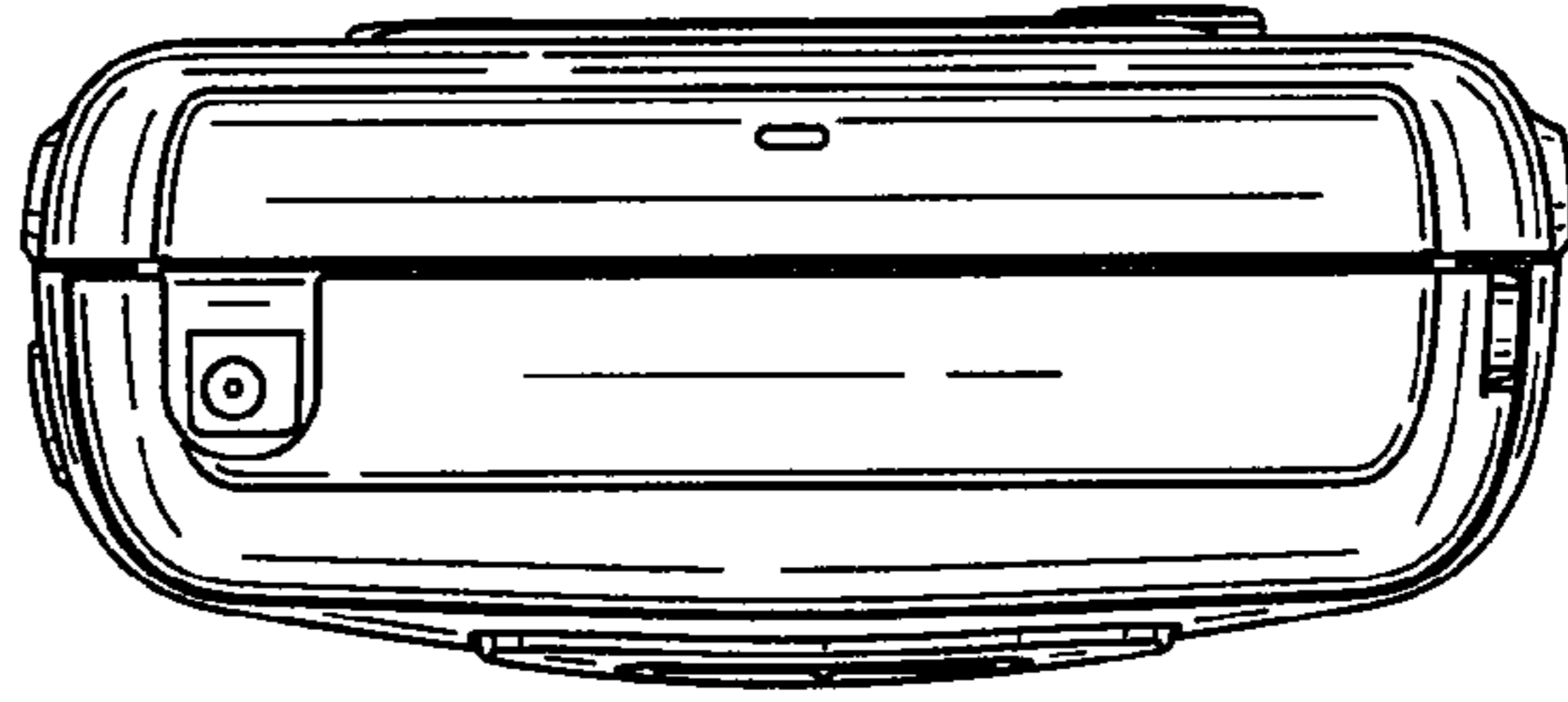

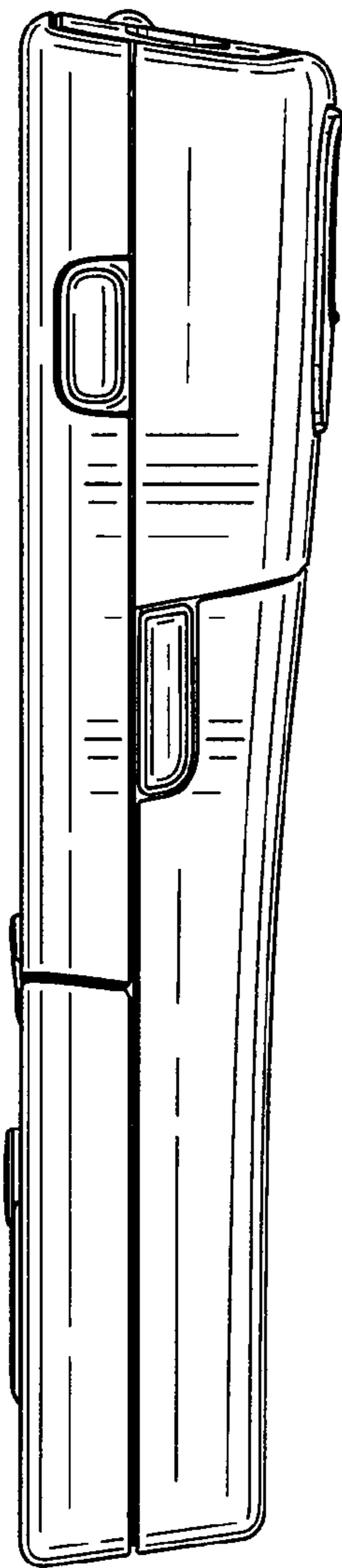

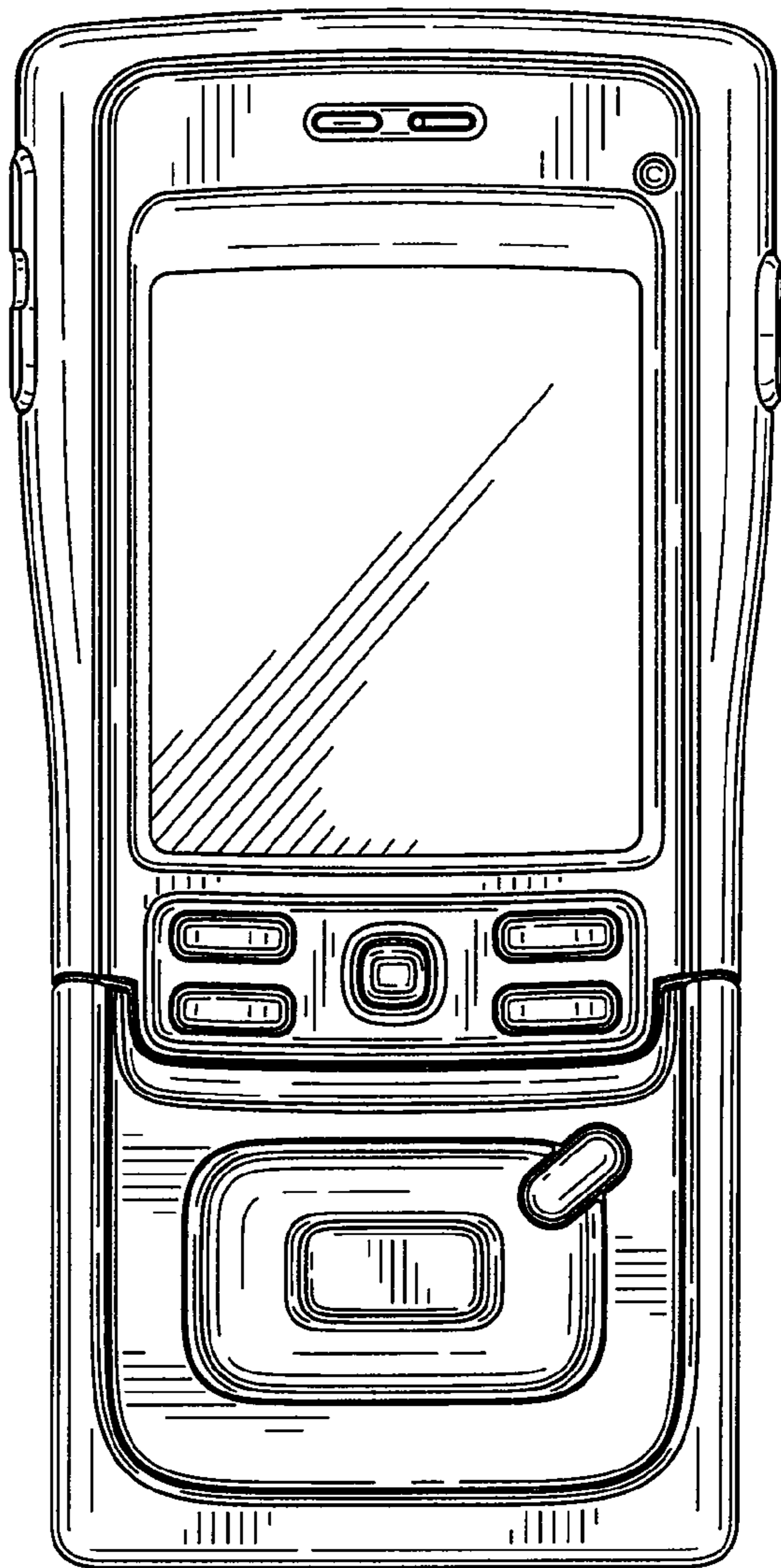

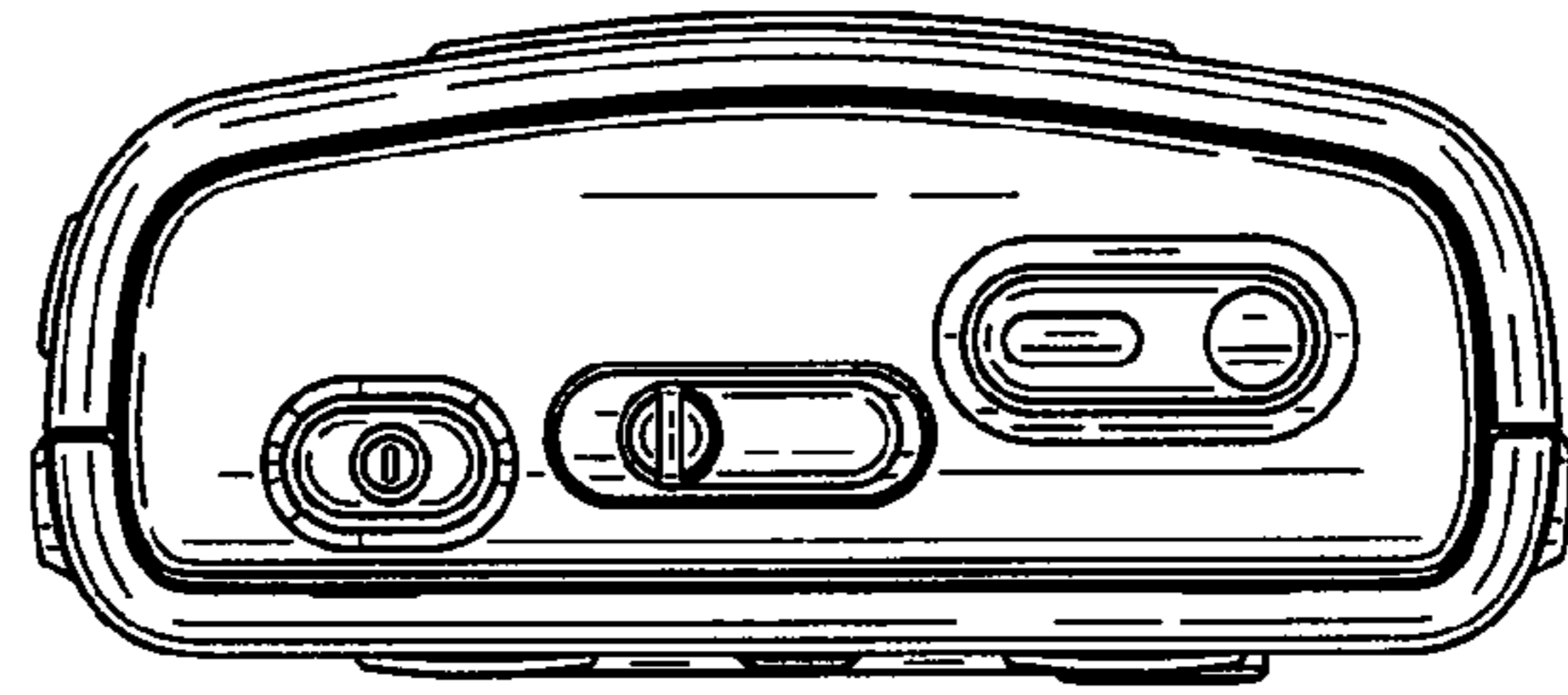

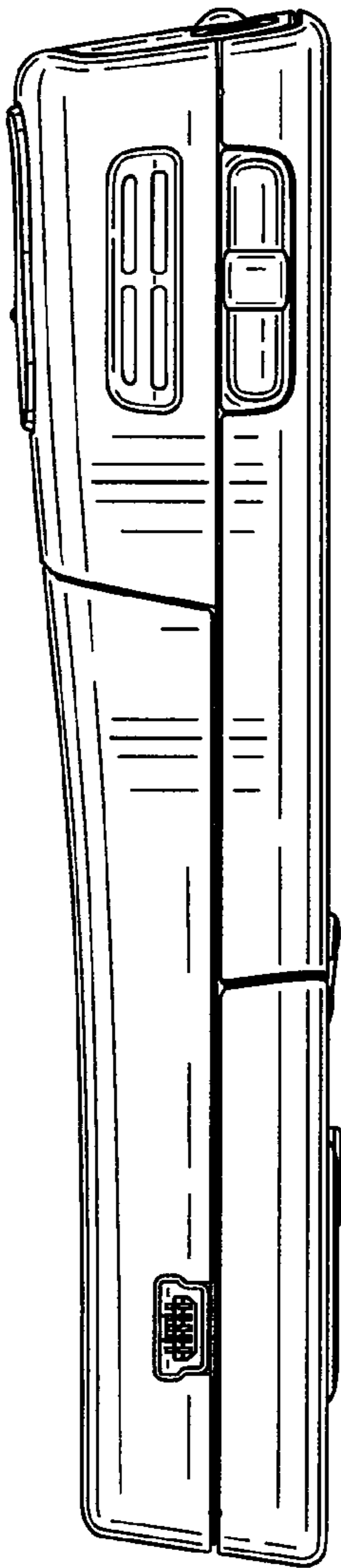

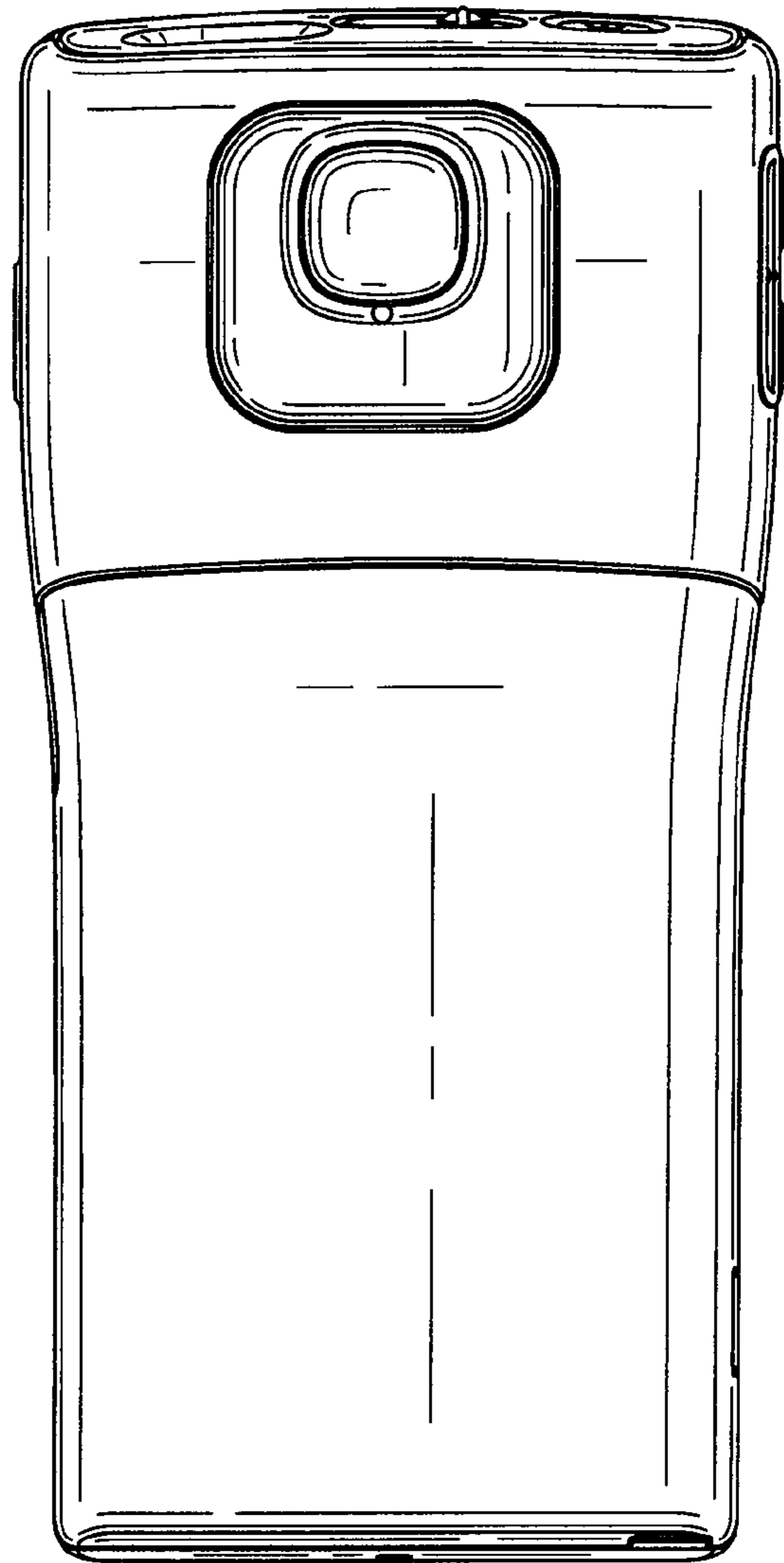

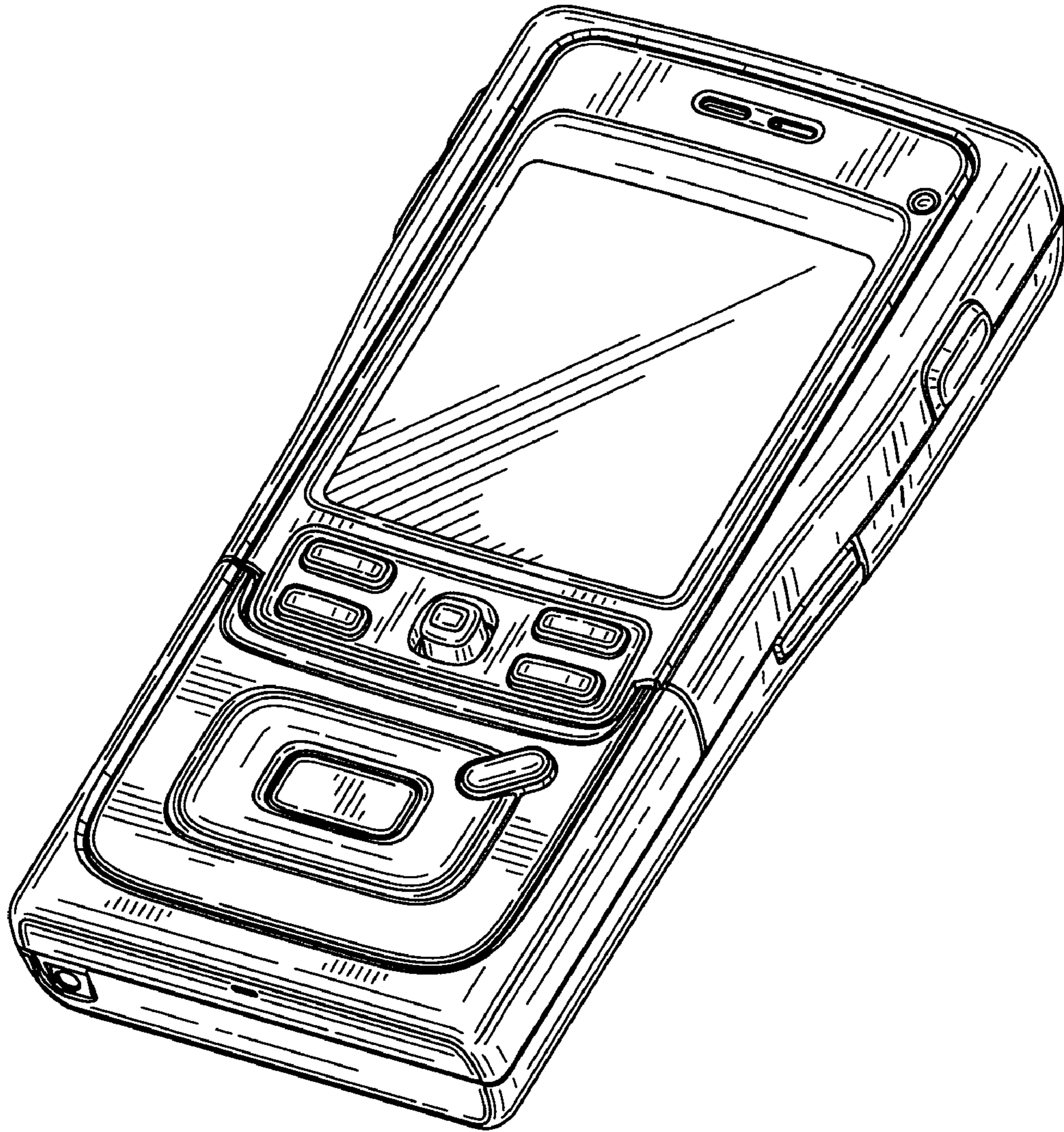

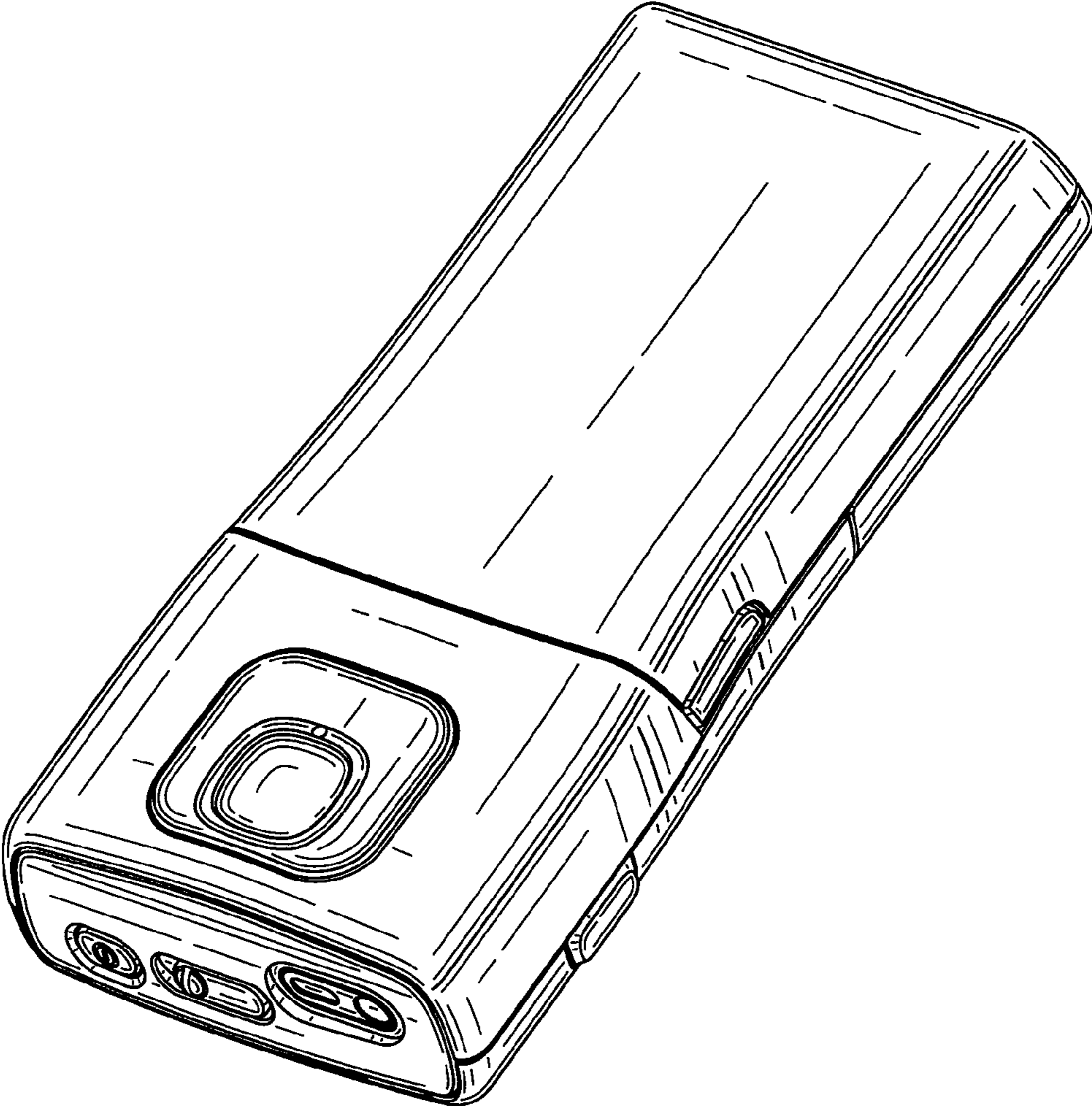

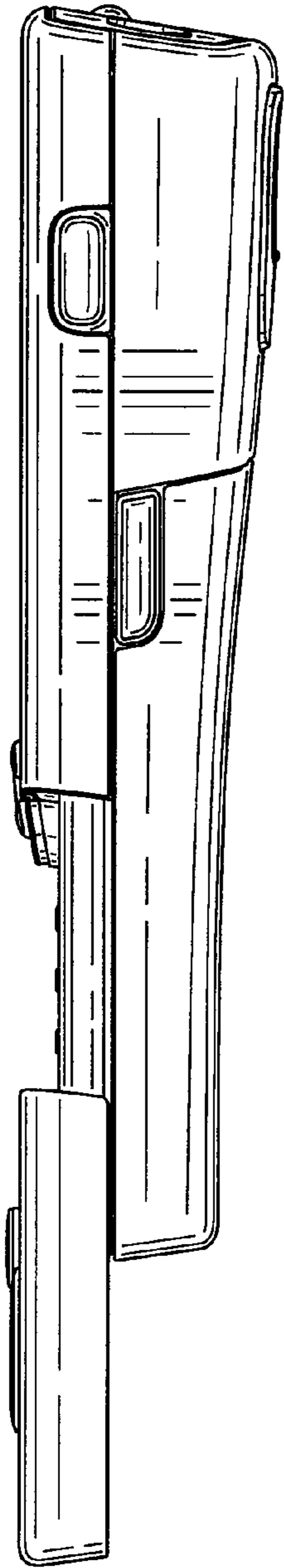

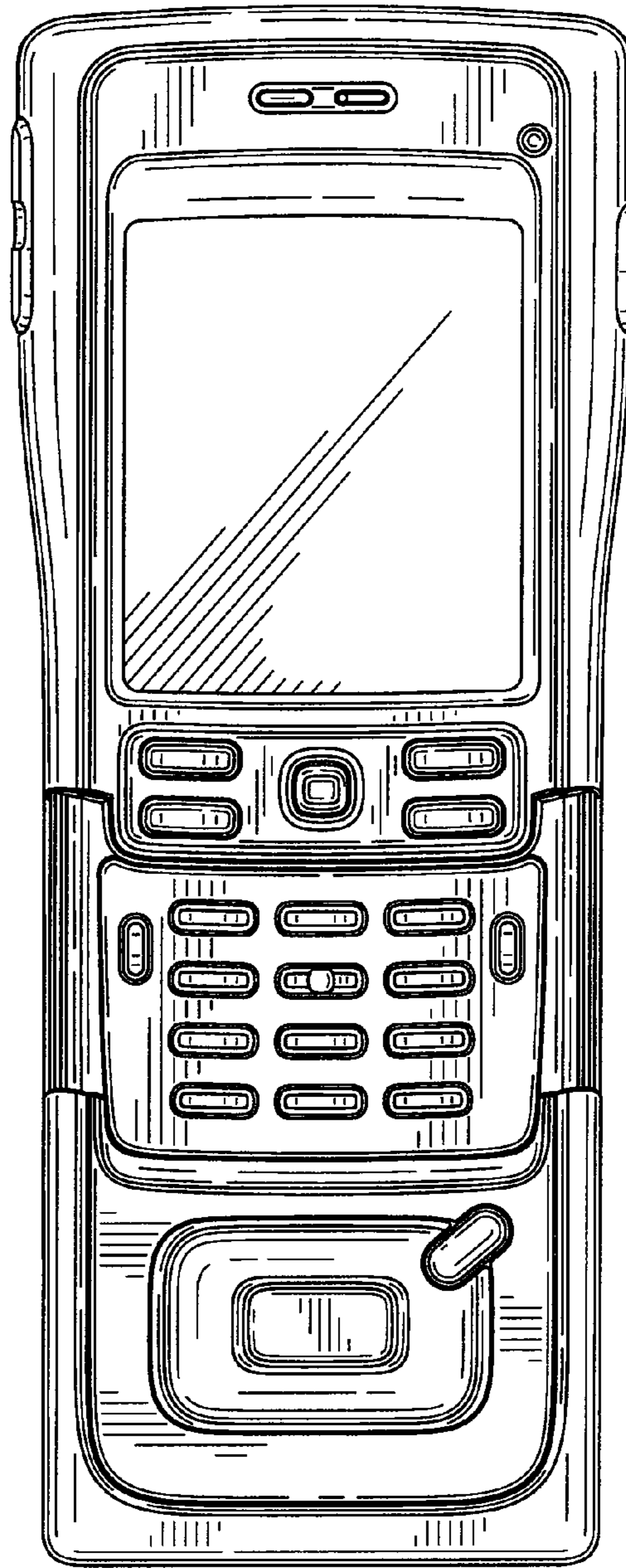

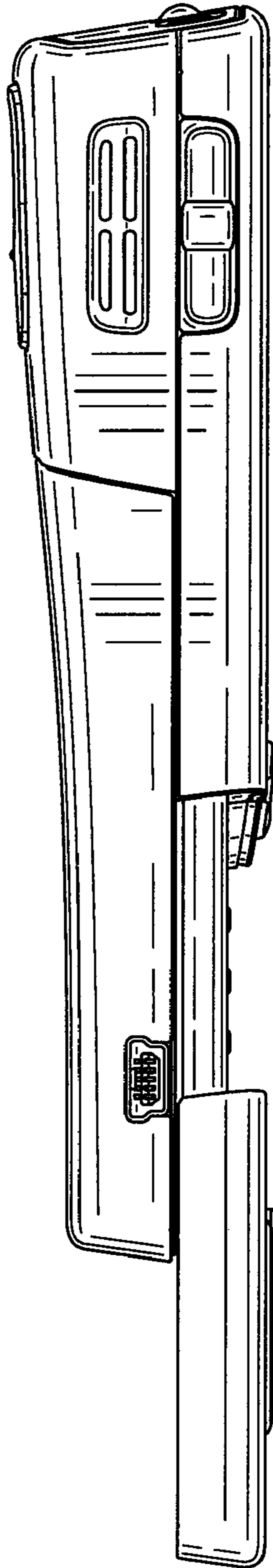

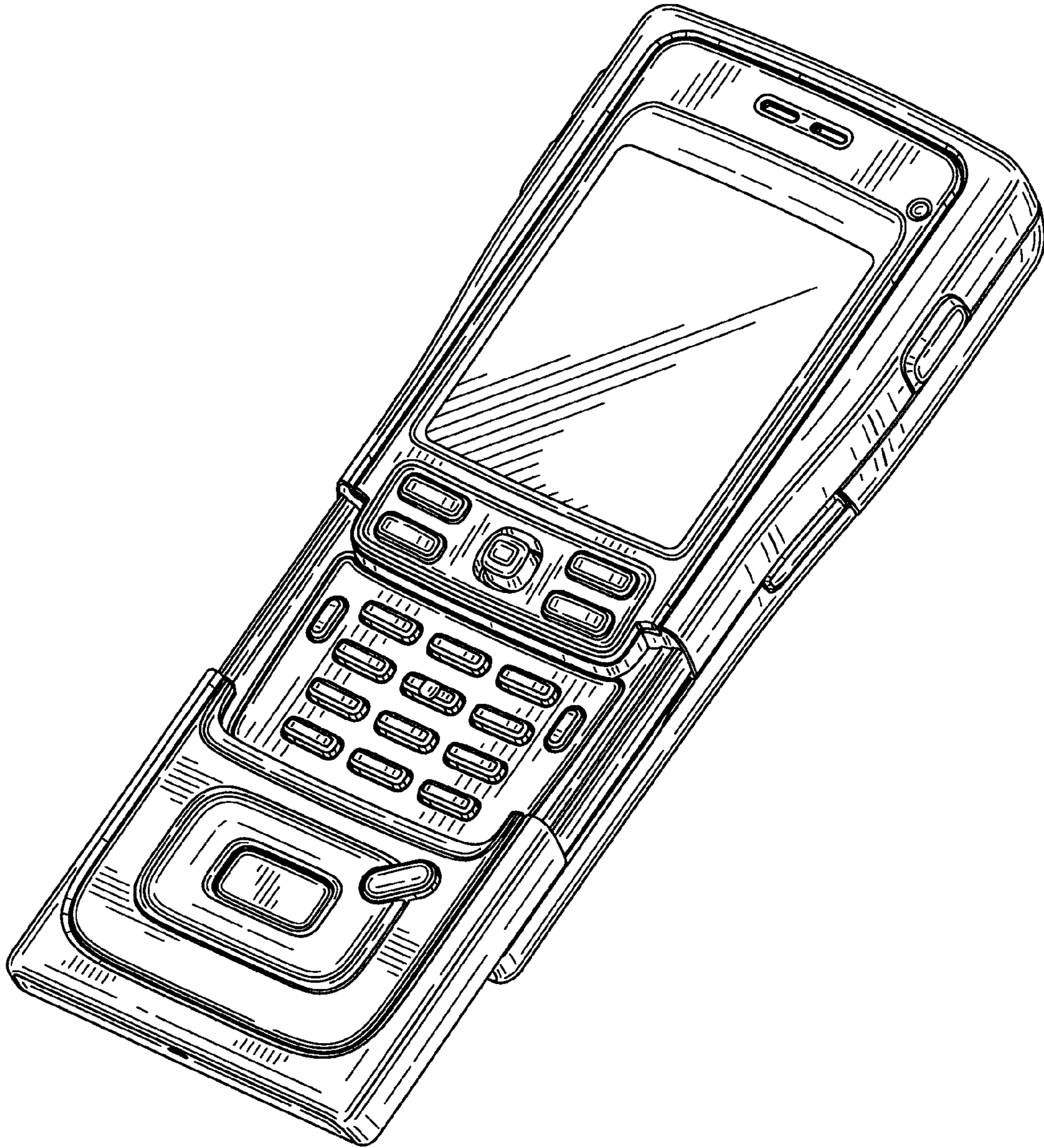

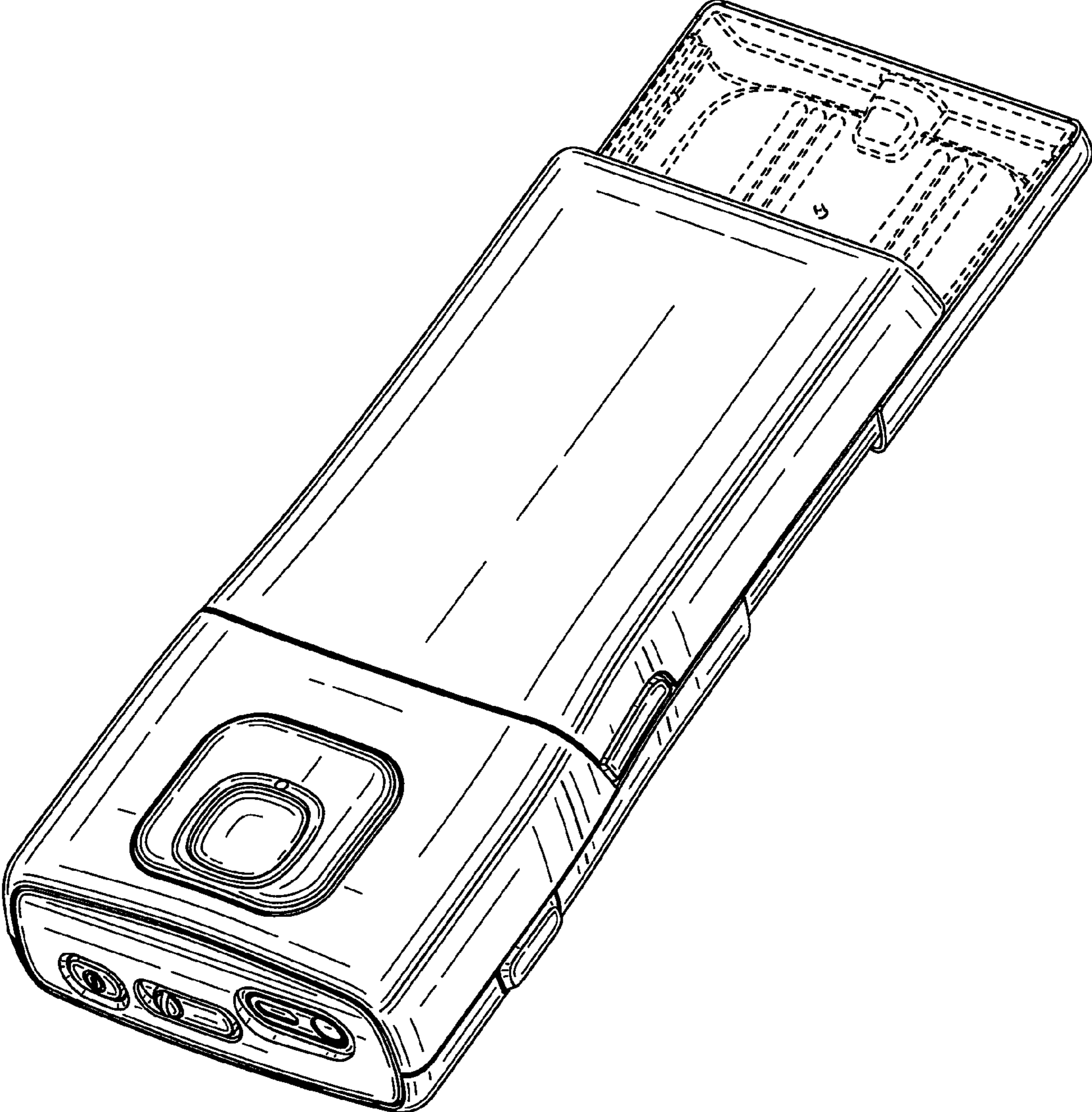
